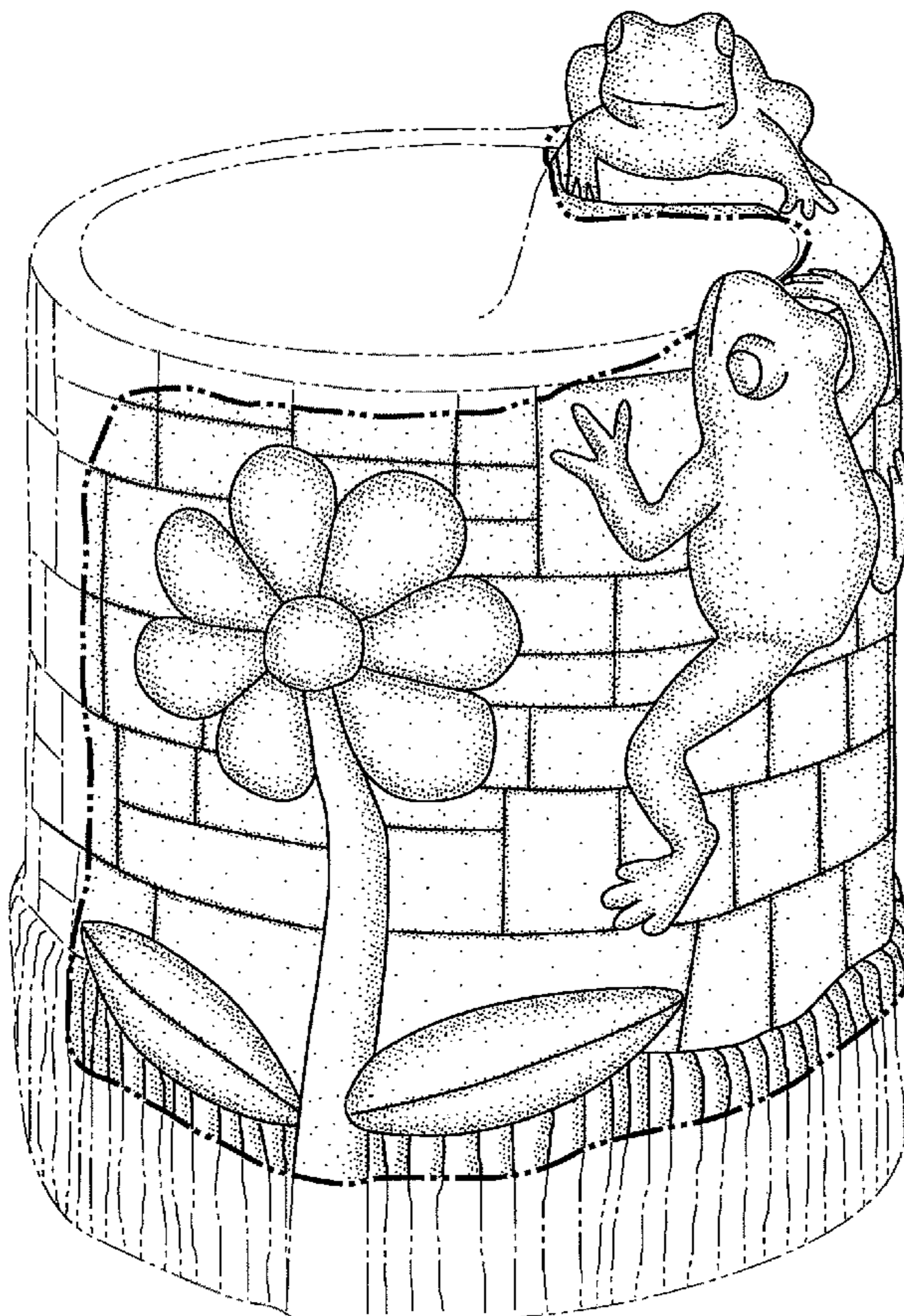
FIG. 7 is a bottom view of the scented fragrance warmer shown in FIG. 1.

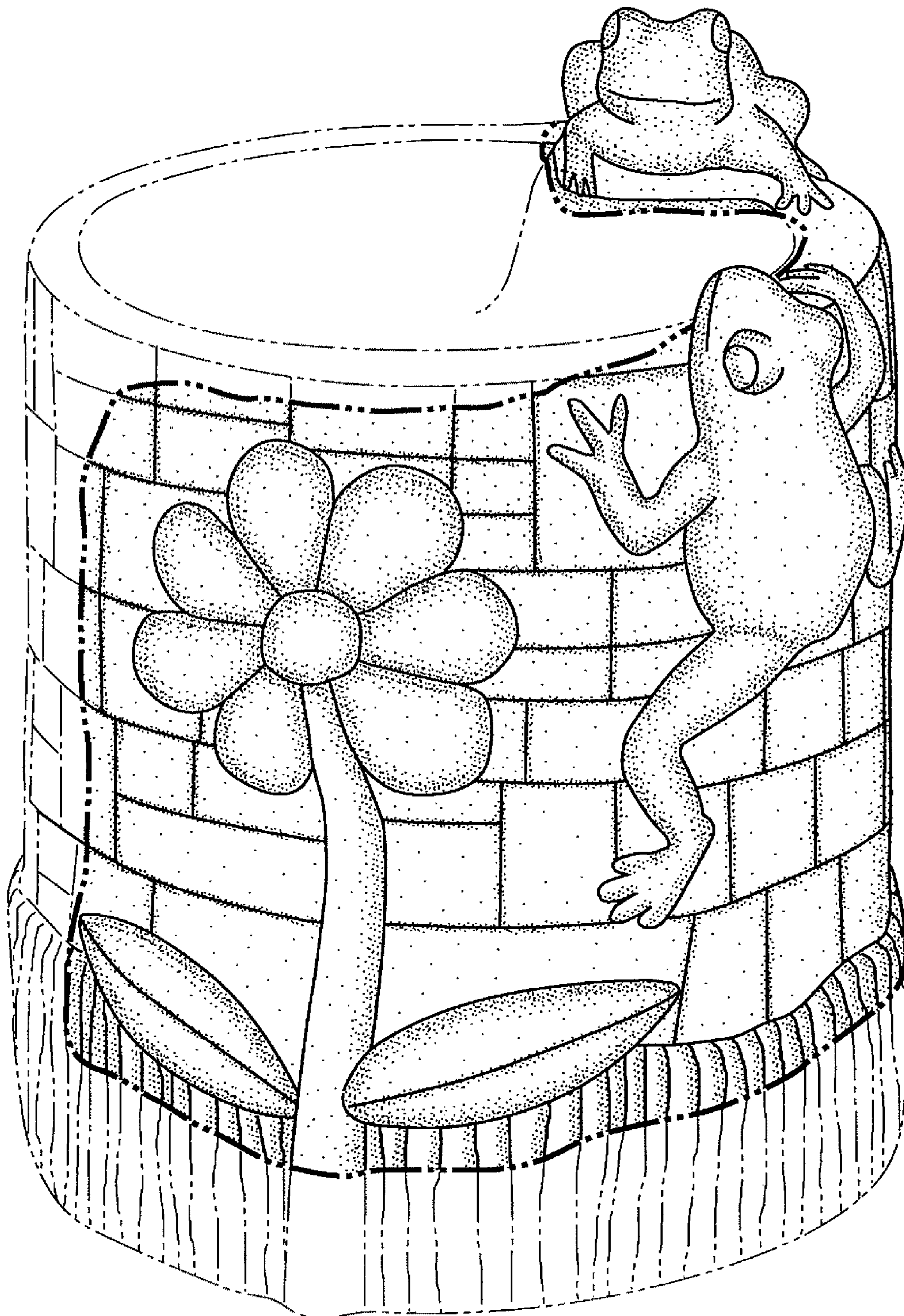

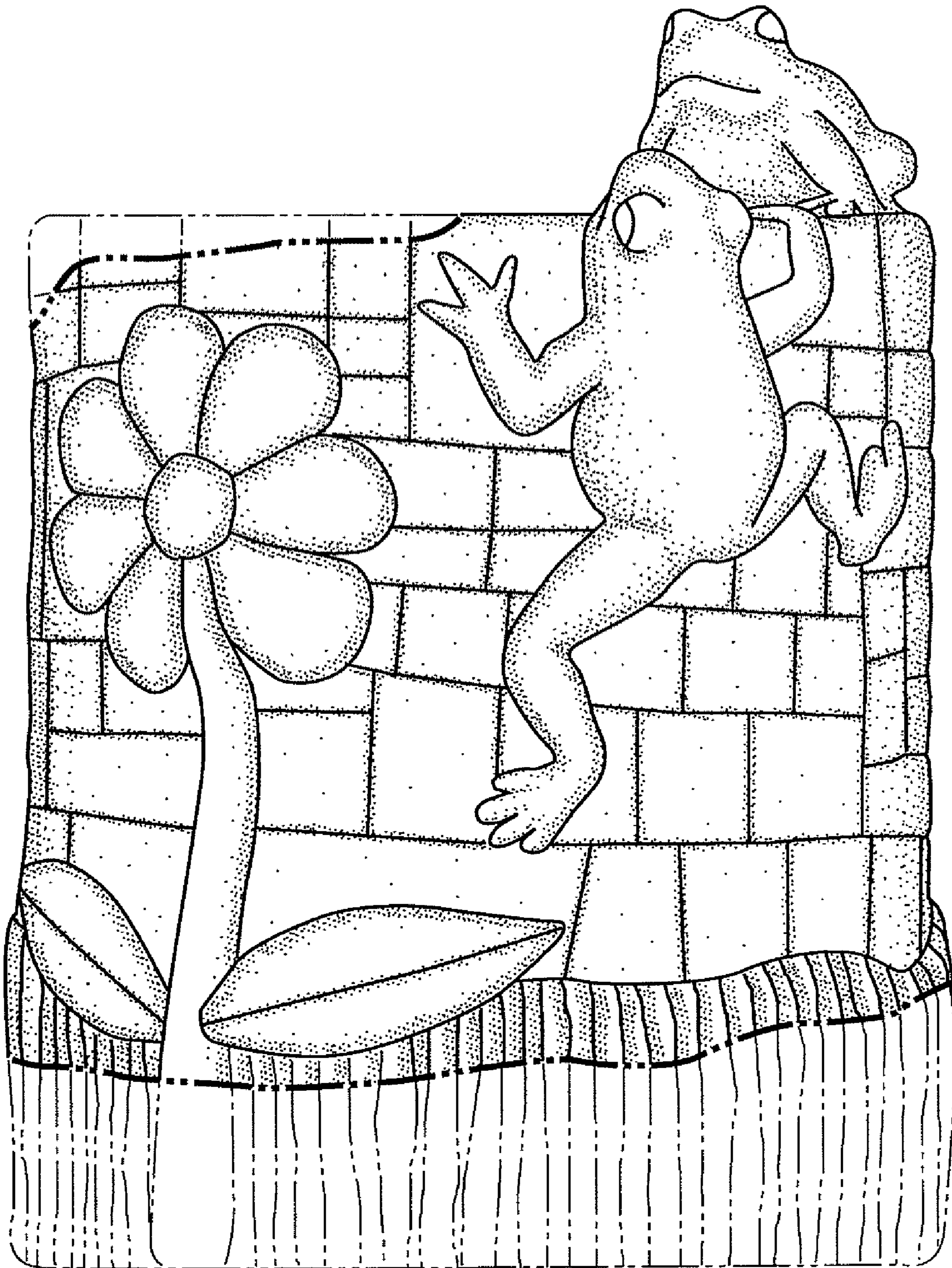

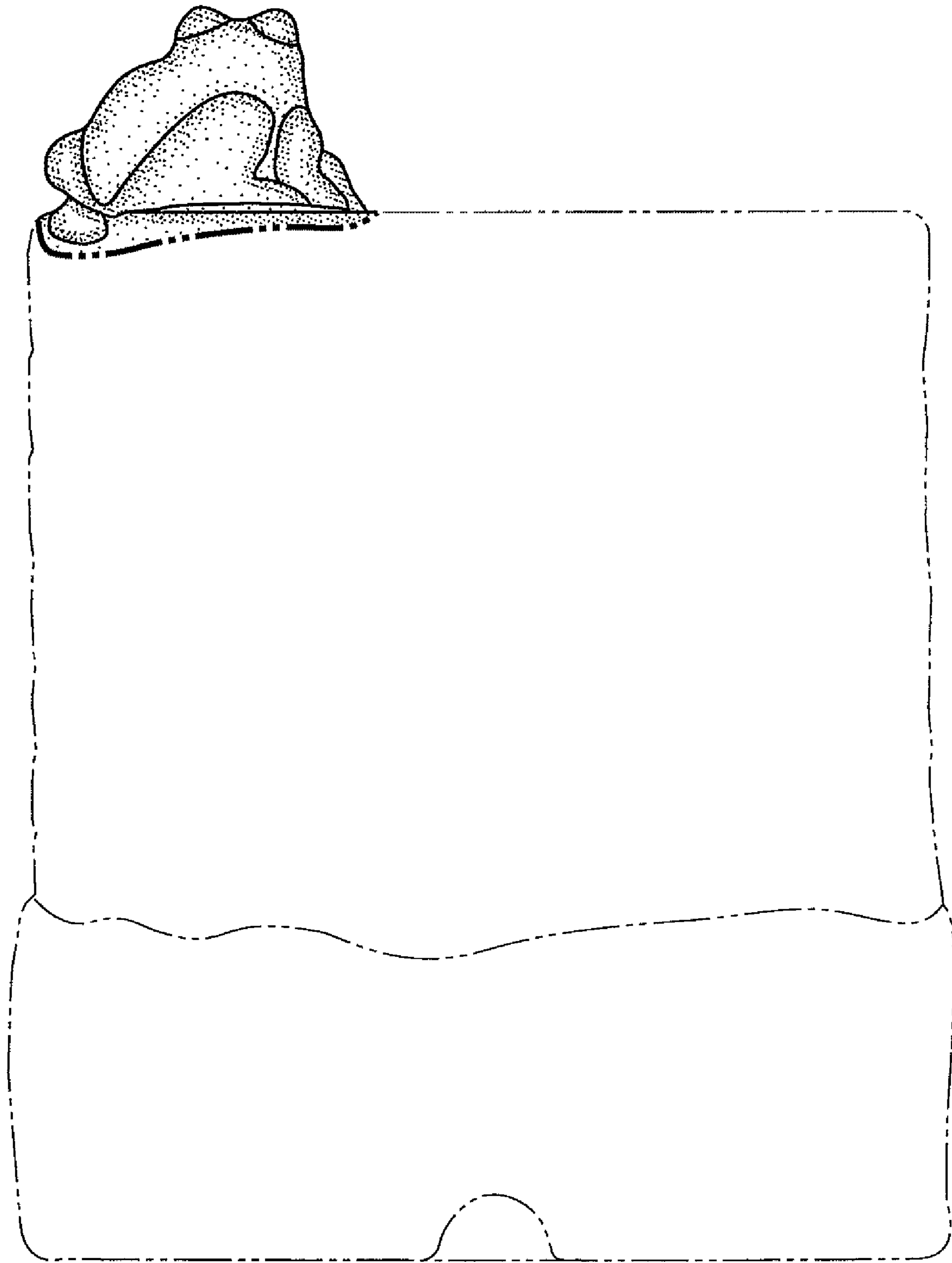

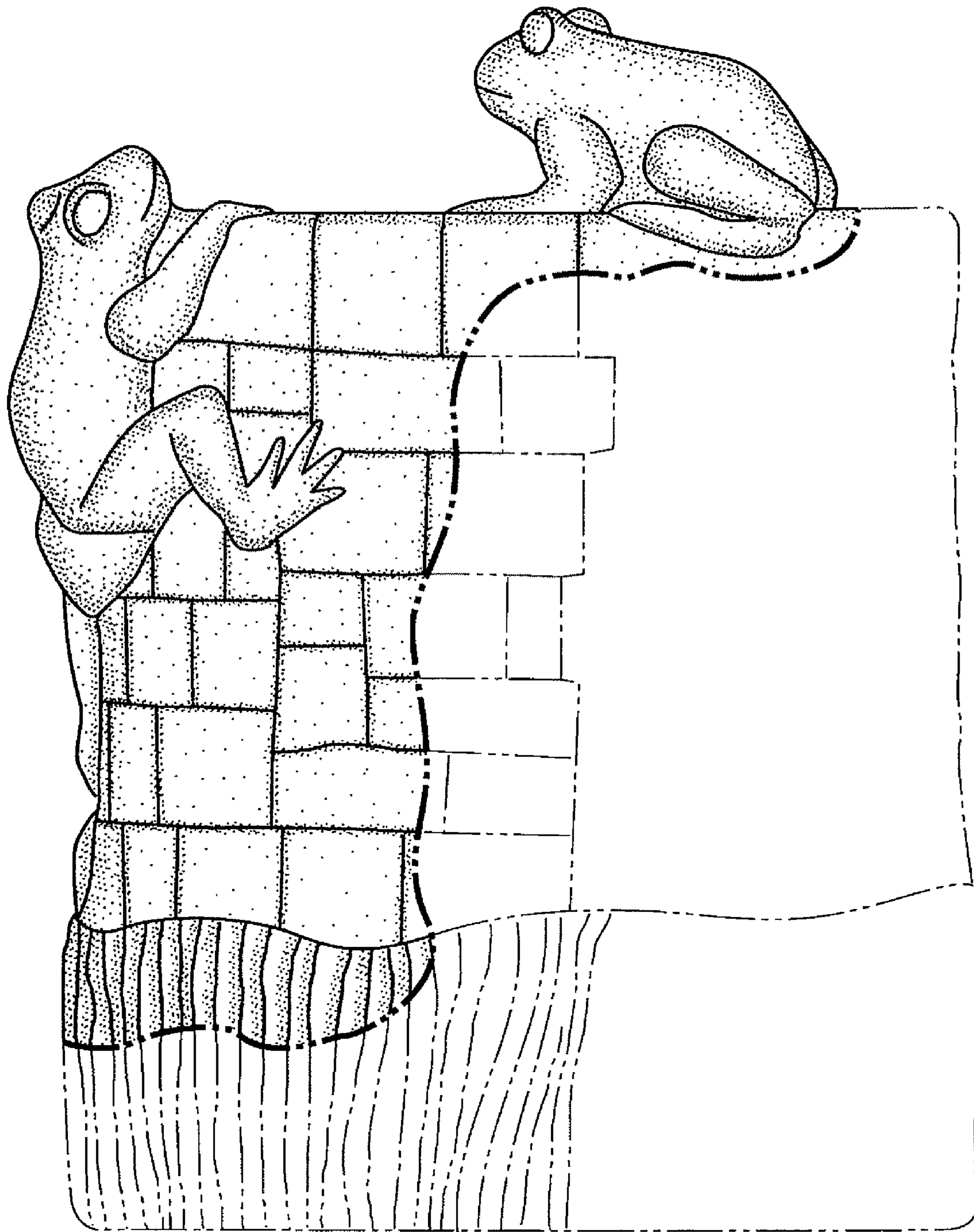

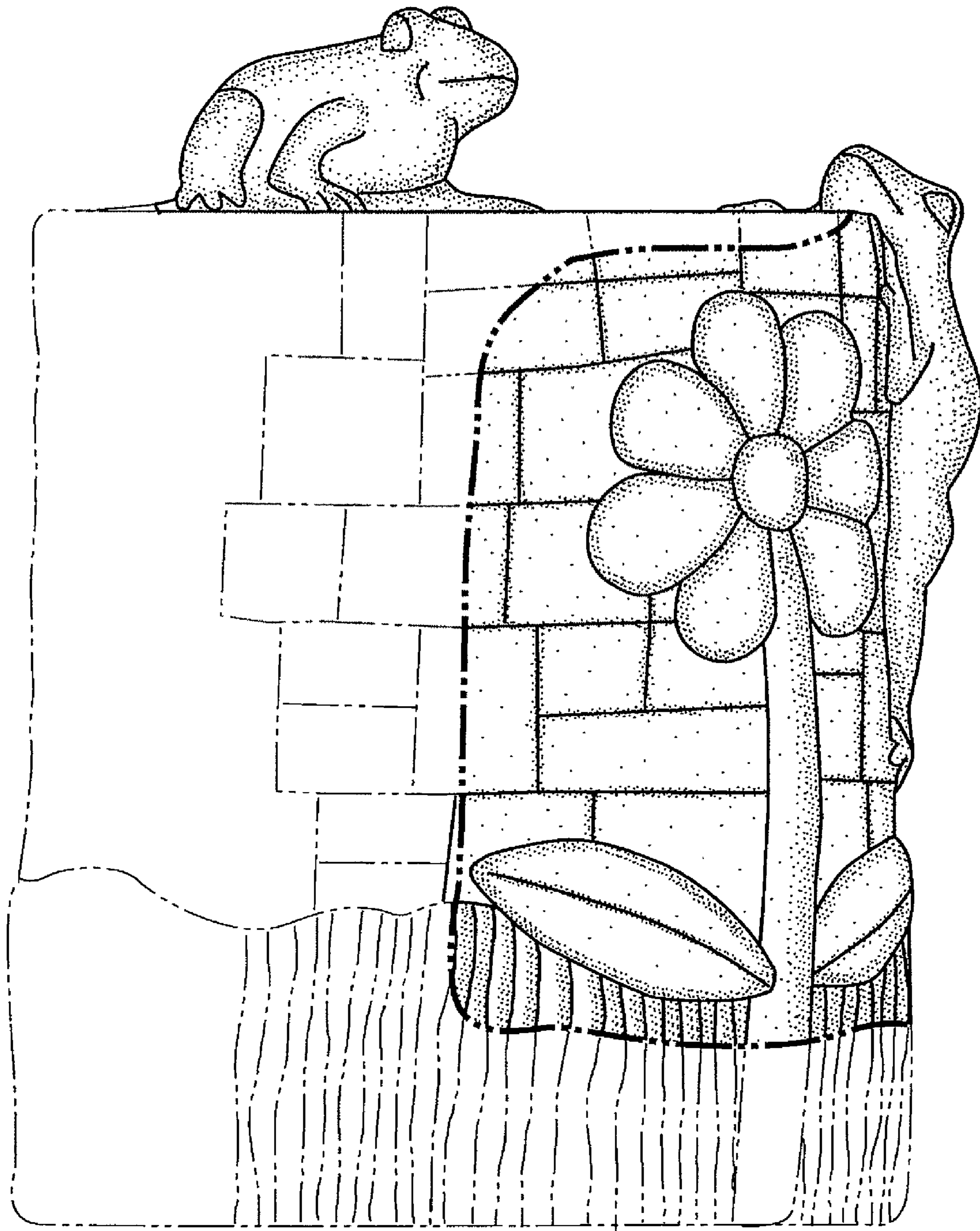

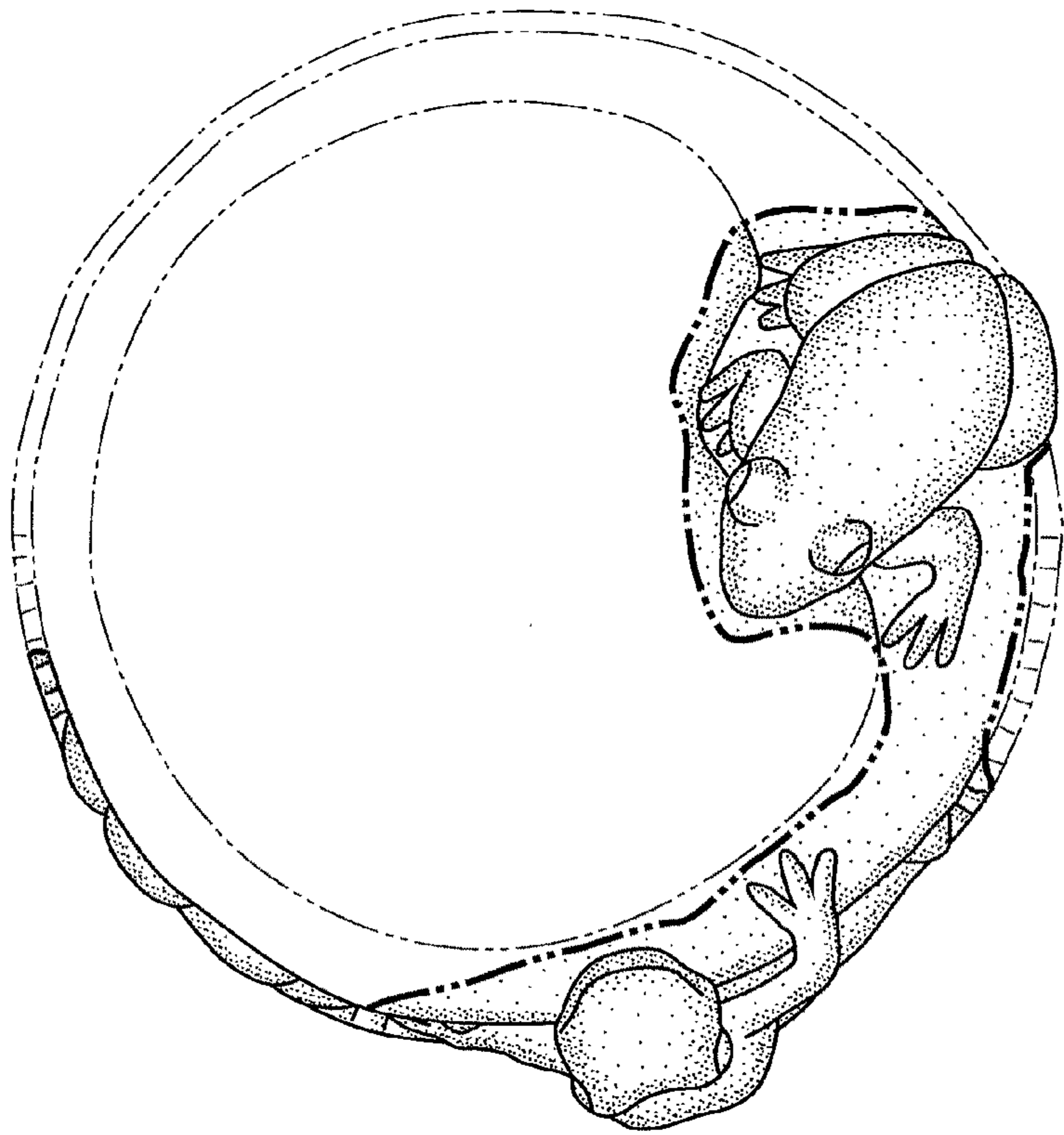

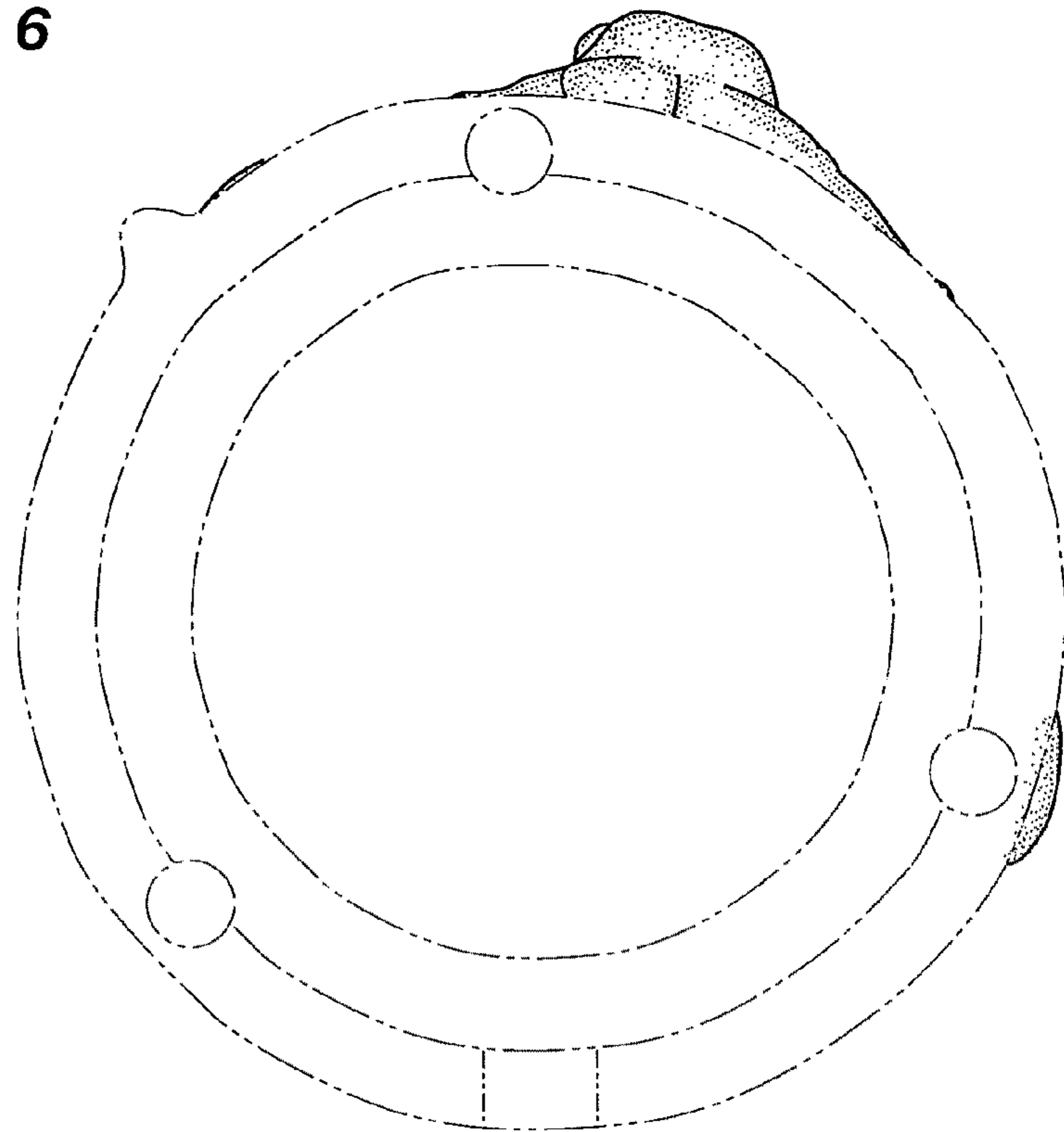
