(57) **CLAIM**

The ornamental design for a fluid collection container with lid, as shown and described.

**DESCRIPTION**

This application is related to United States Design Application entitled "Fluid Collection Container Lid" by James E. Burgess et al., U.S. Ser. No. 29/360,669, assigned to Medline Industries, Inc., and filed Apr. 29, 2010.

FIG. 1 is a front, left, top perspective view of a fluid collection container with lid, illustrating our new design;

FIG. 5 is a left side elevation view thereof;

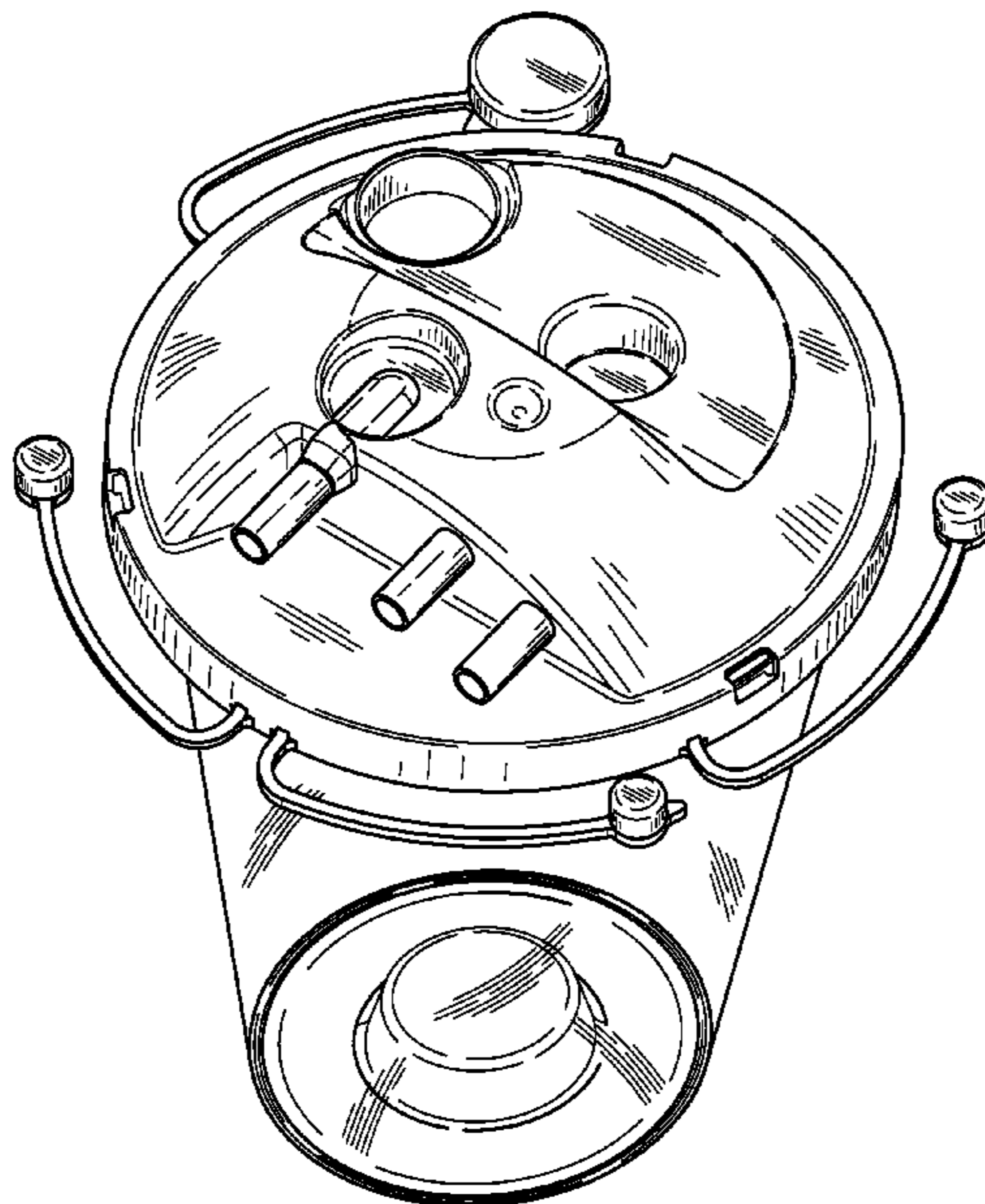
FIG. 6 is a right side elevation view thereof;

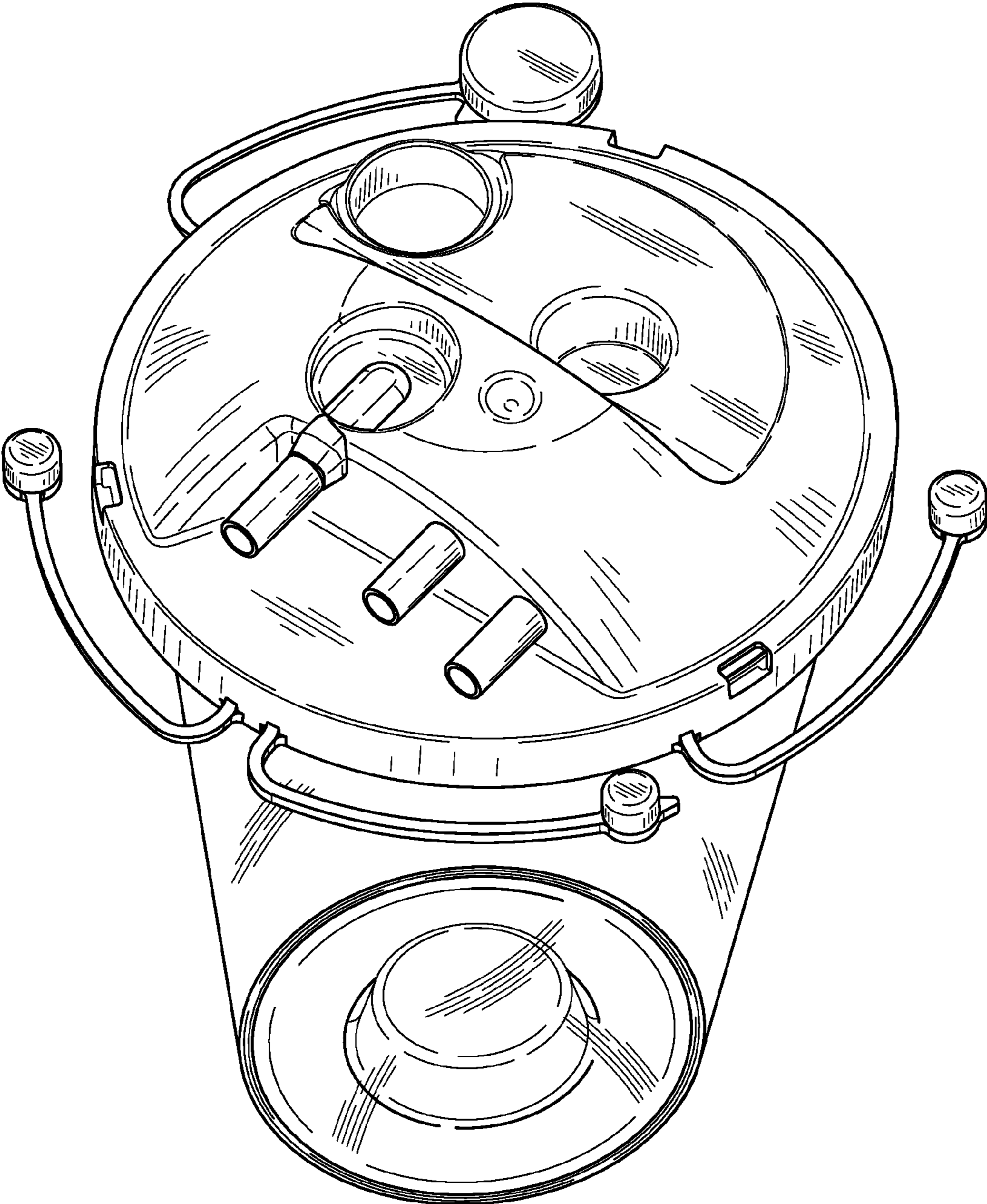
FIG. 7 is a front elevation view thereof; and,

The broken line showing of parts of the drawings is included for the purpose of illustrating use and environment and forms no part of the claimed design.

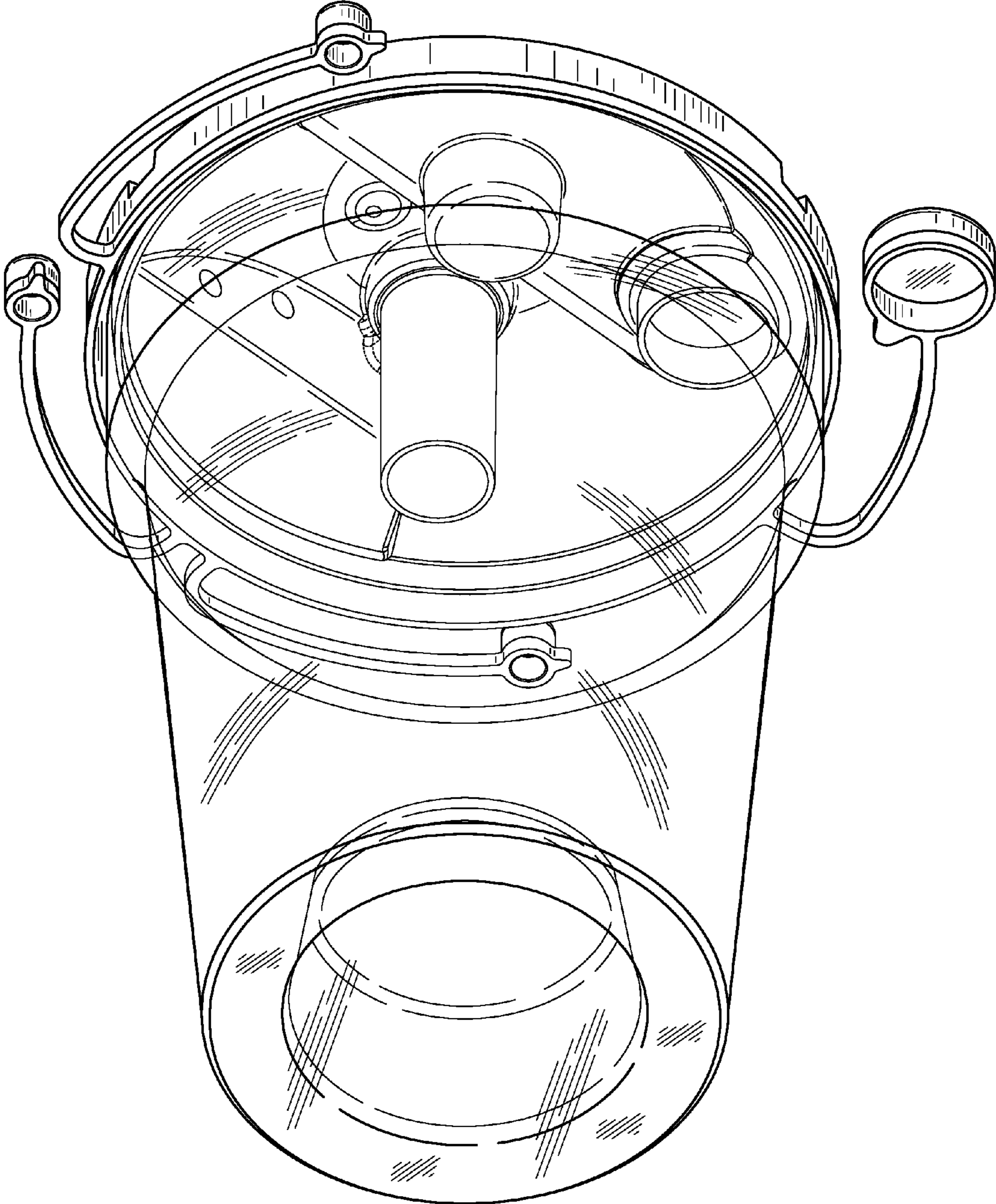

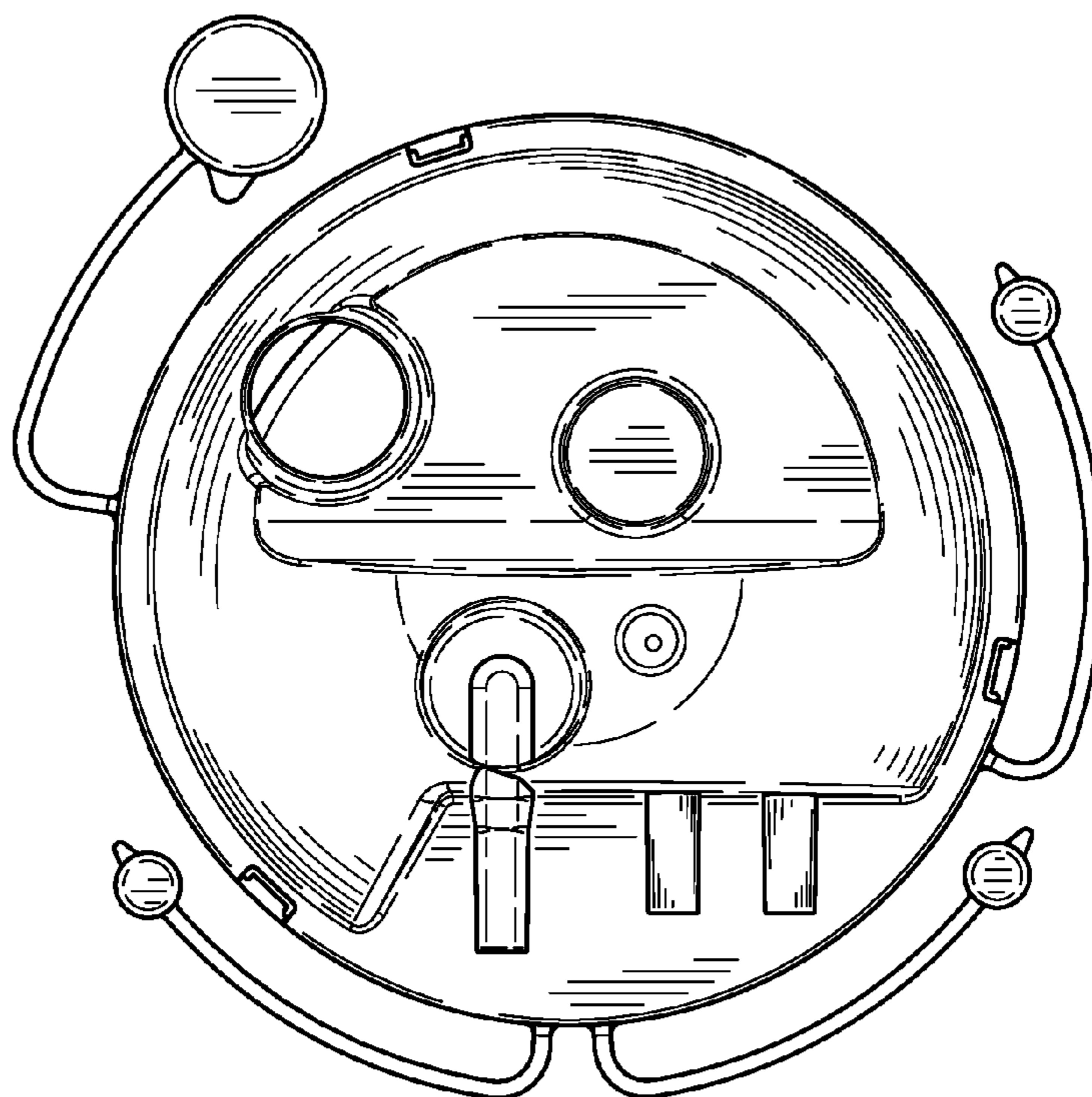

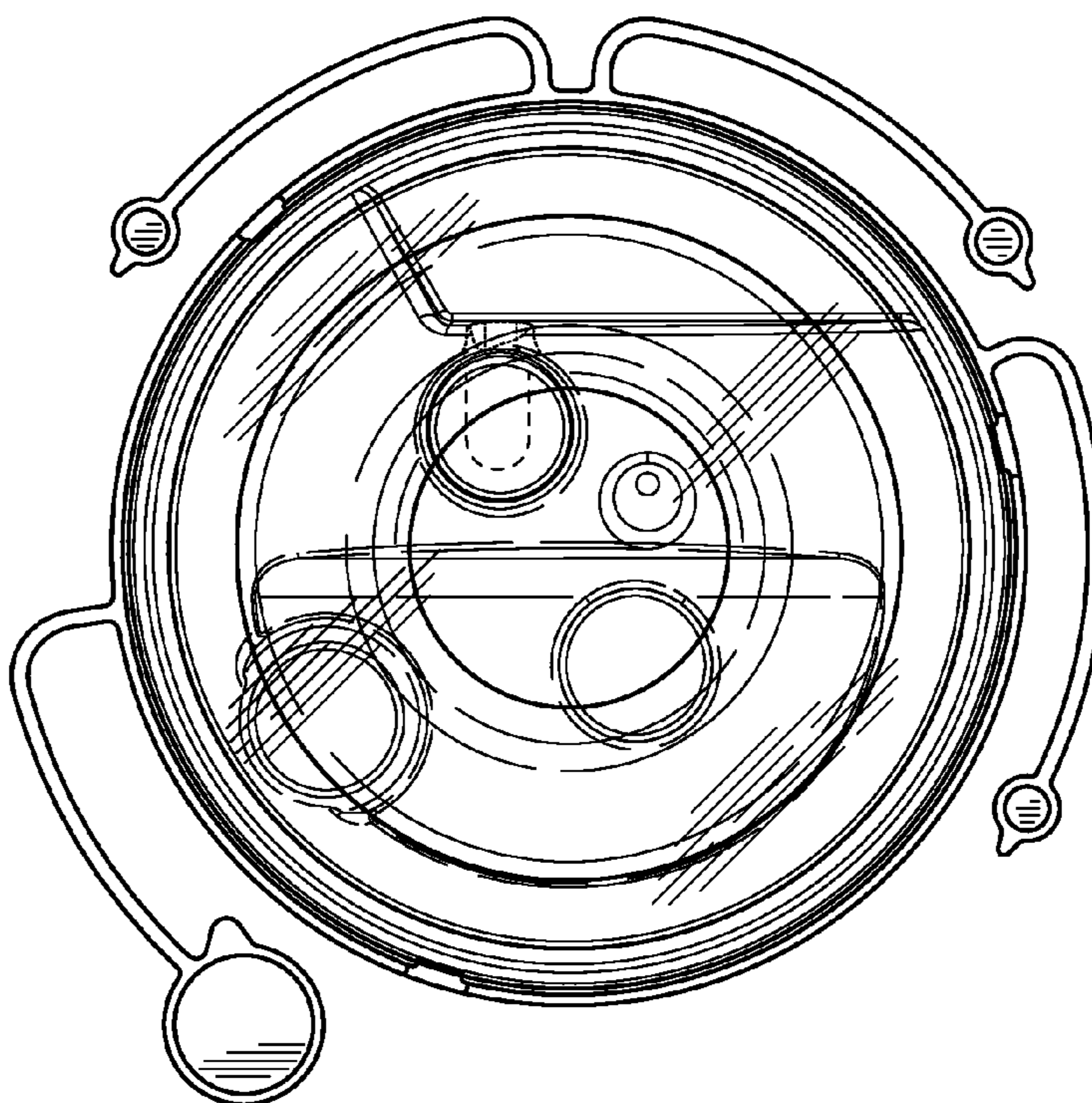


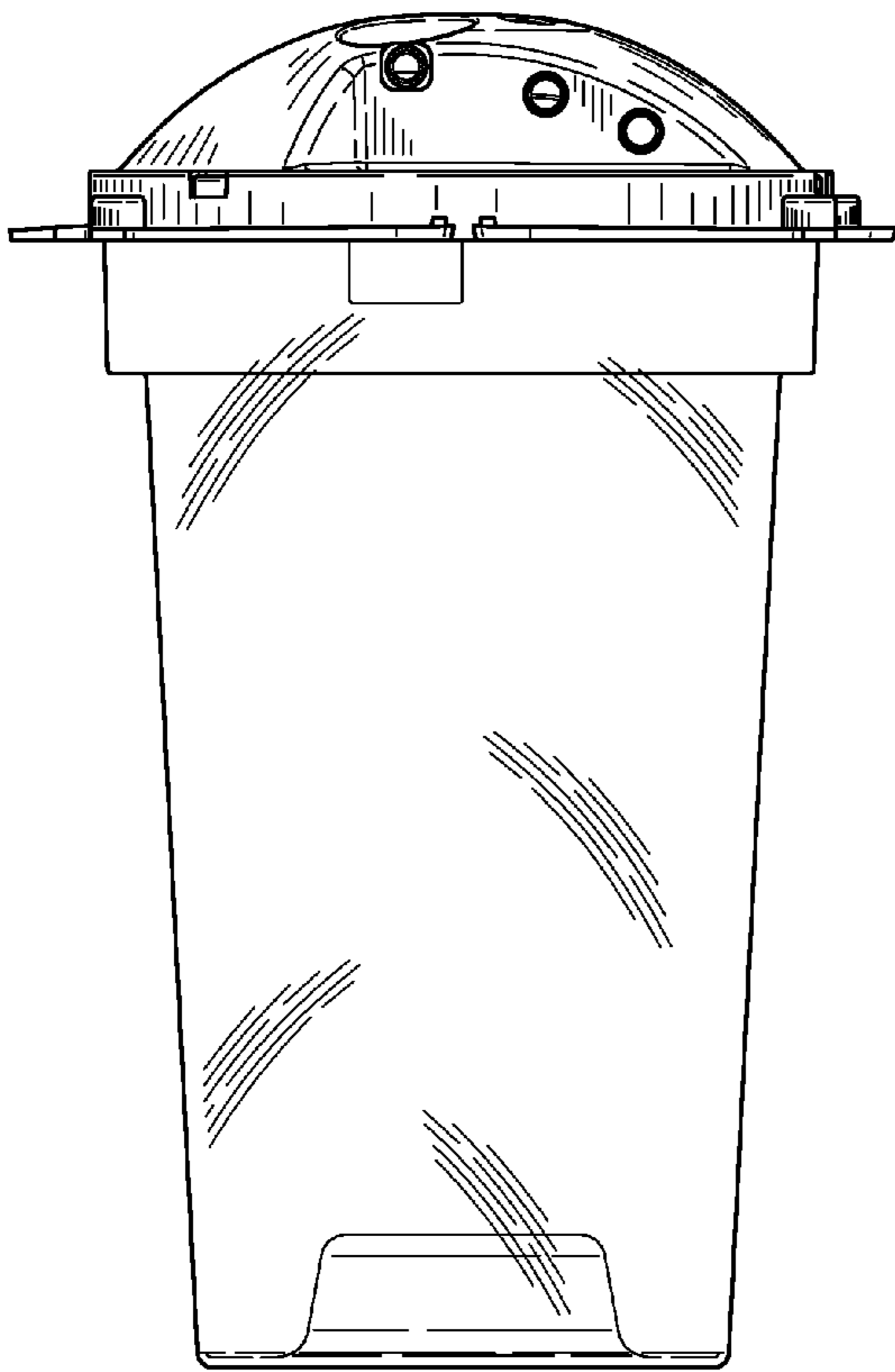

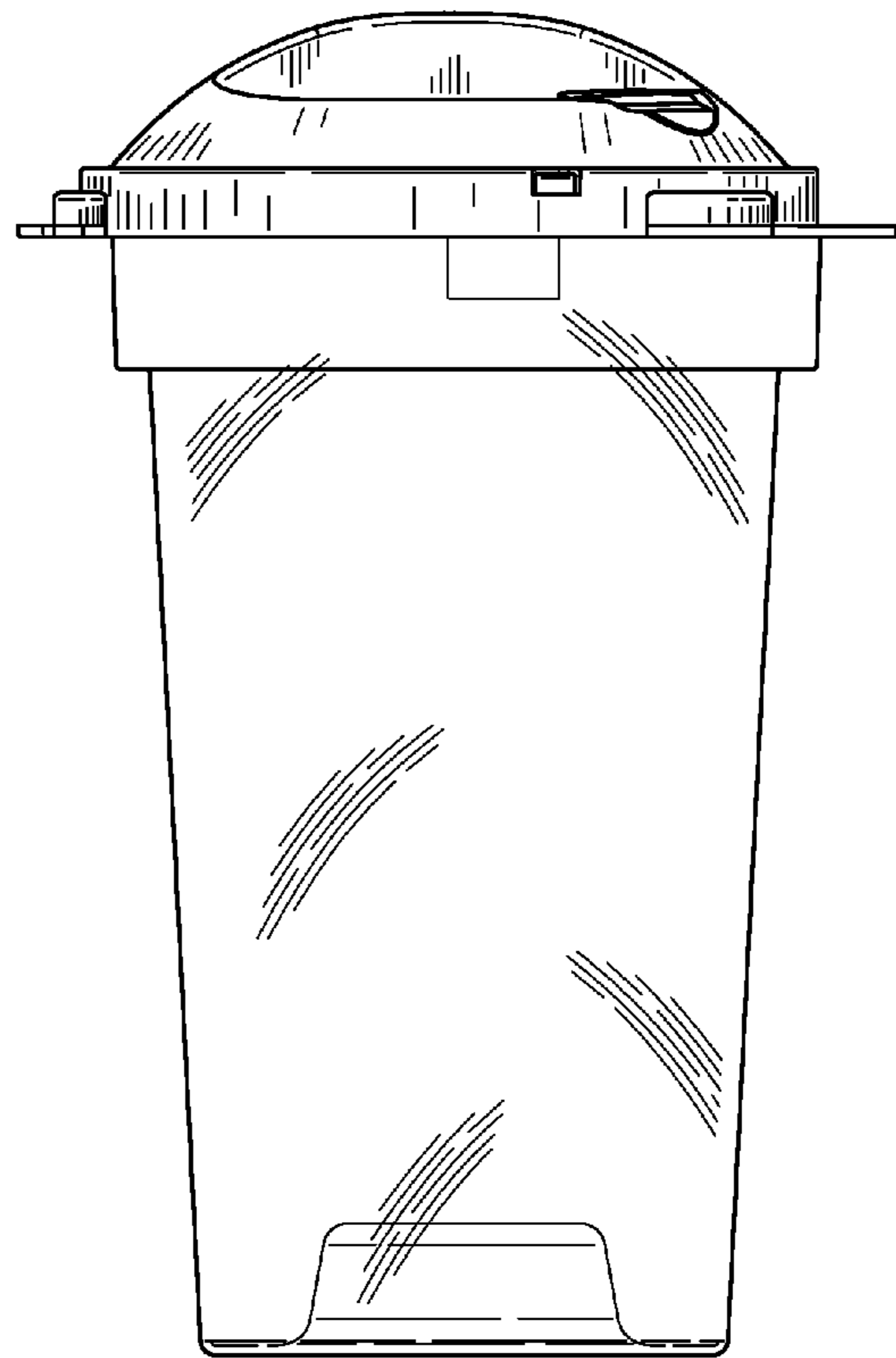

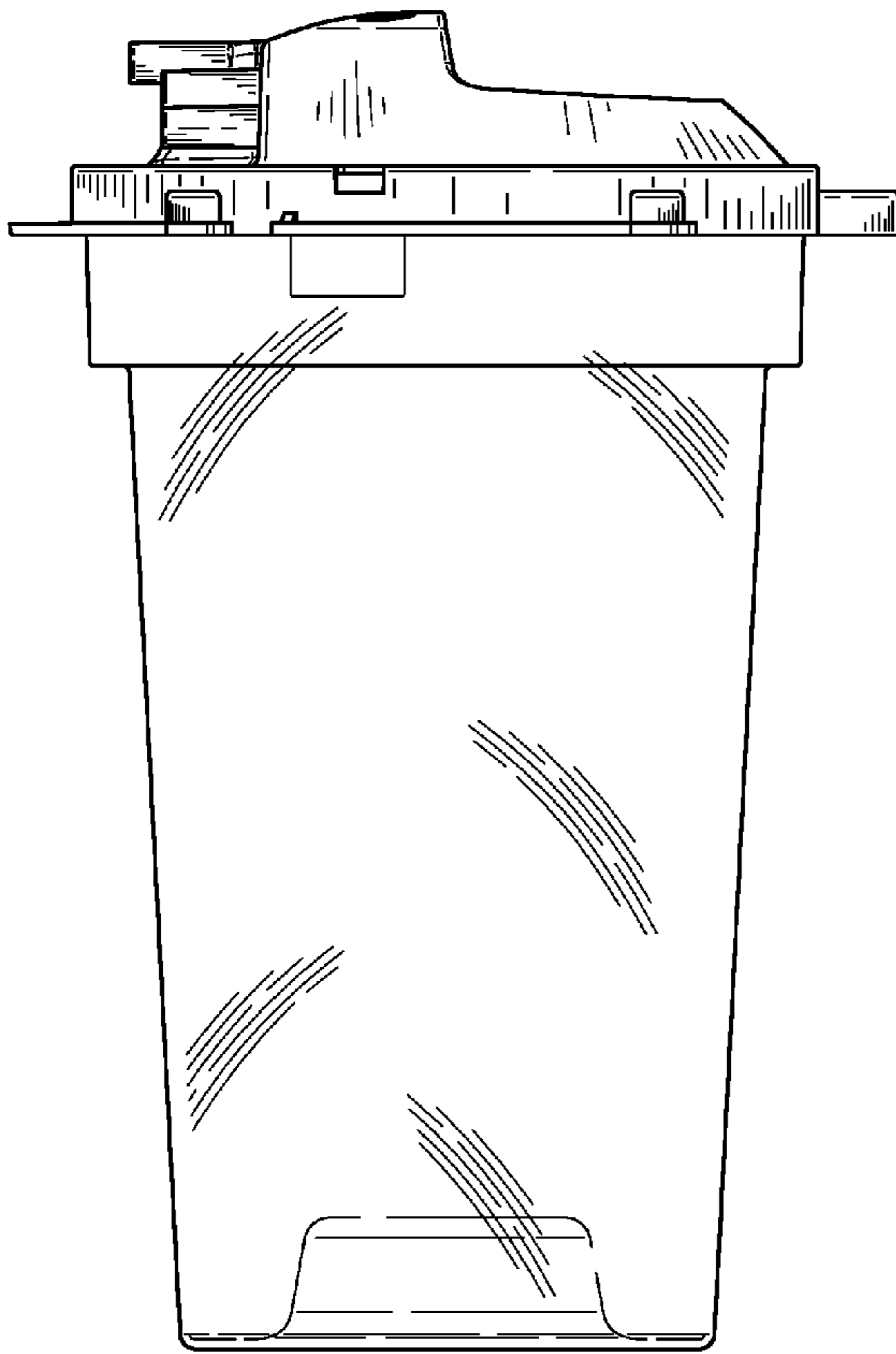




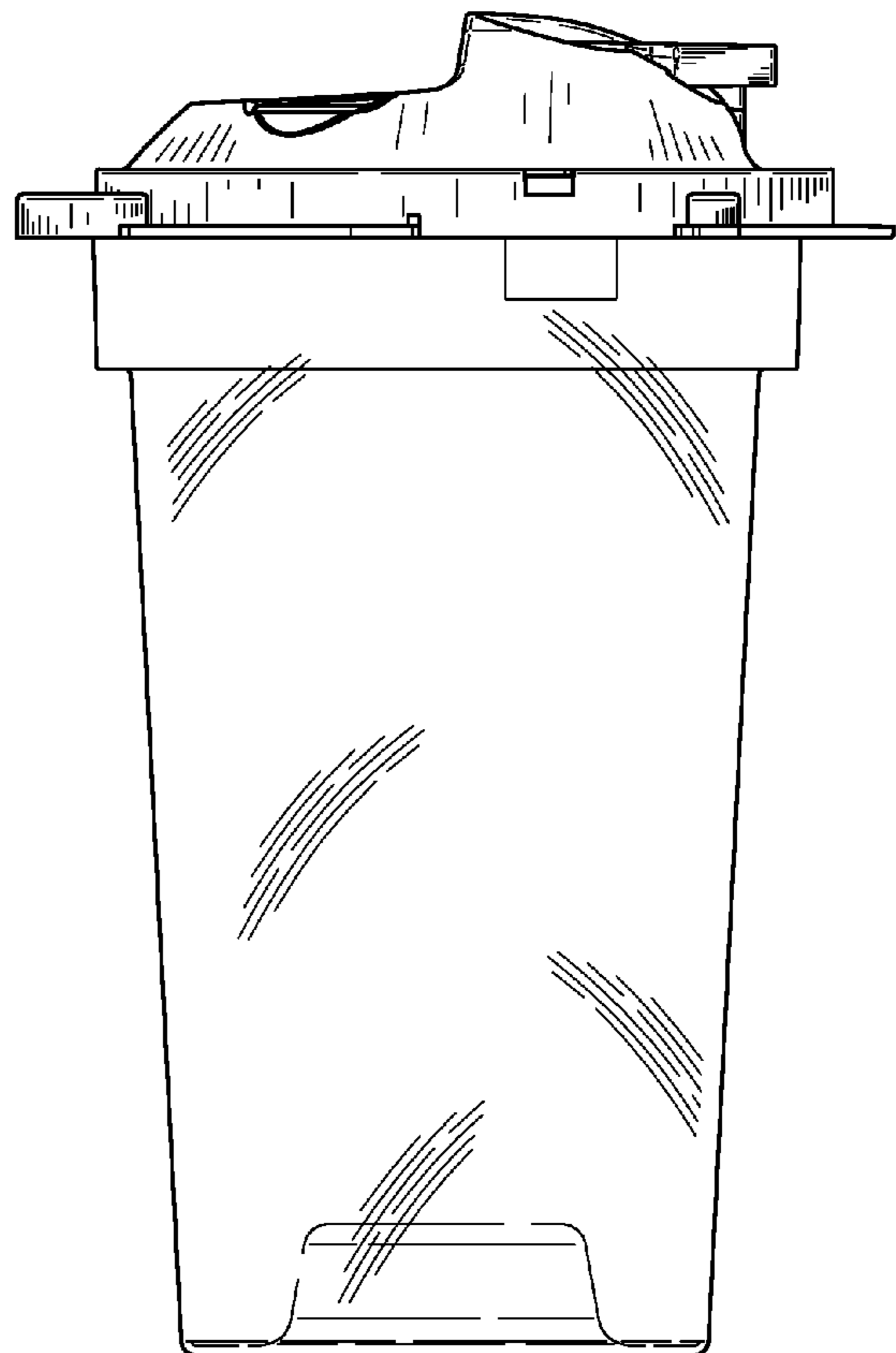
