The ornamental design for a cosmetic facial tool, as shown and described.

**DESCRIPTION**

FIG. 5 is a right side elevational view thereof;

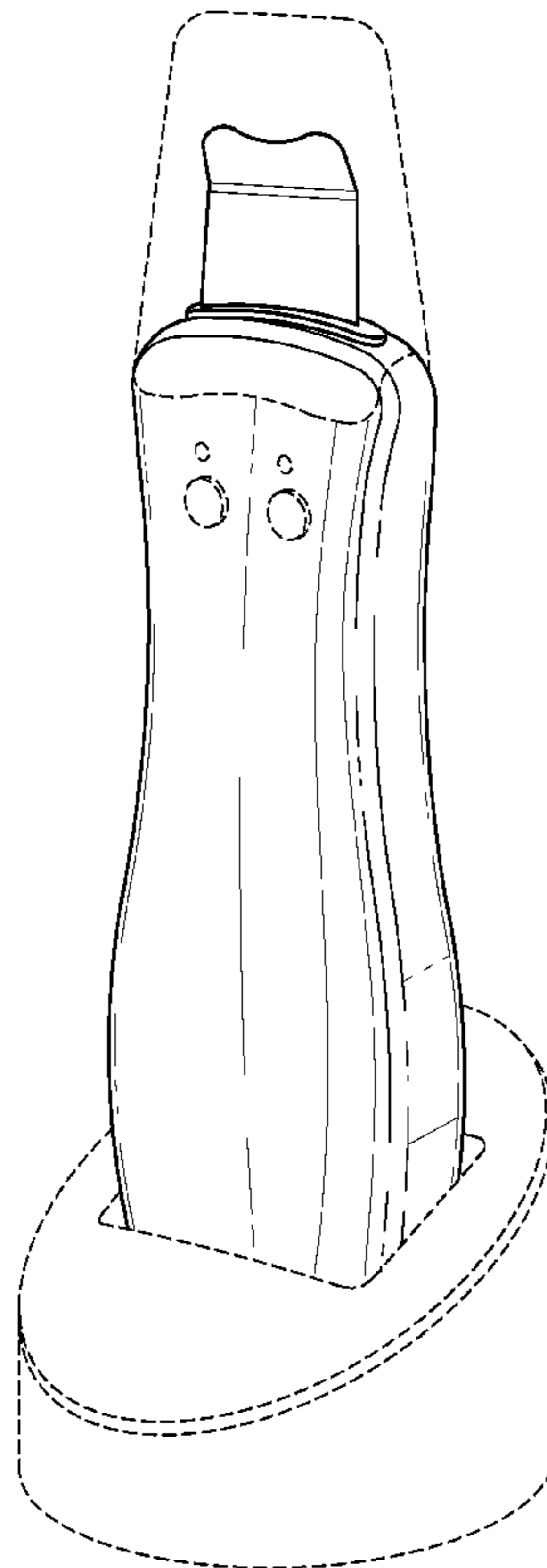
FIG. 6 is a left side elevational view thereof;

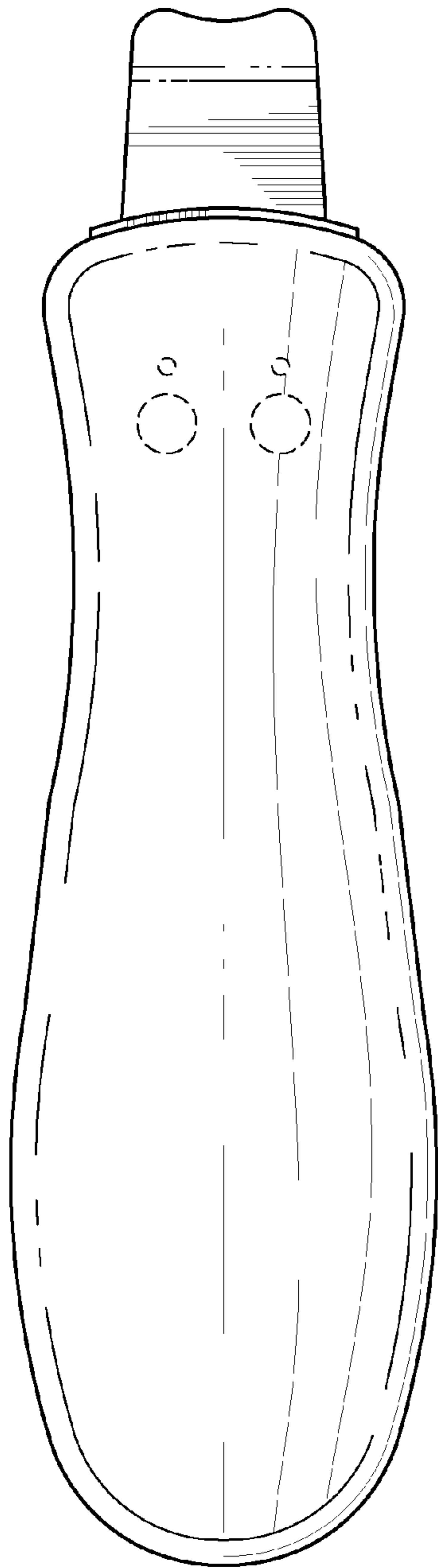

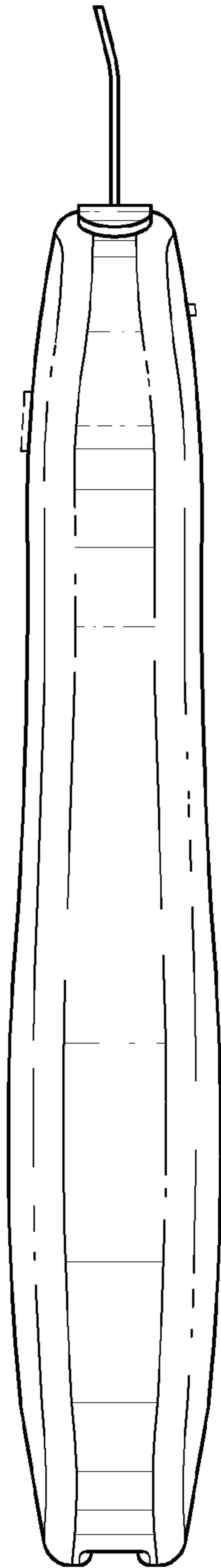

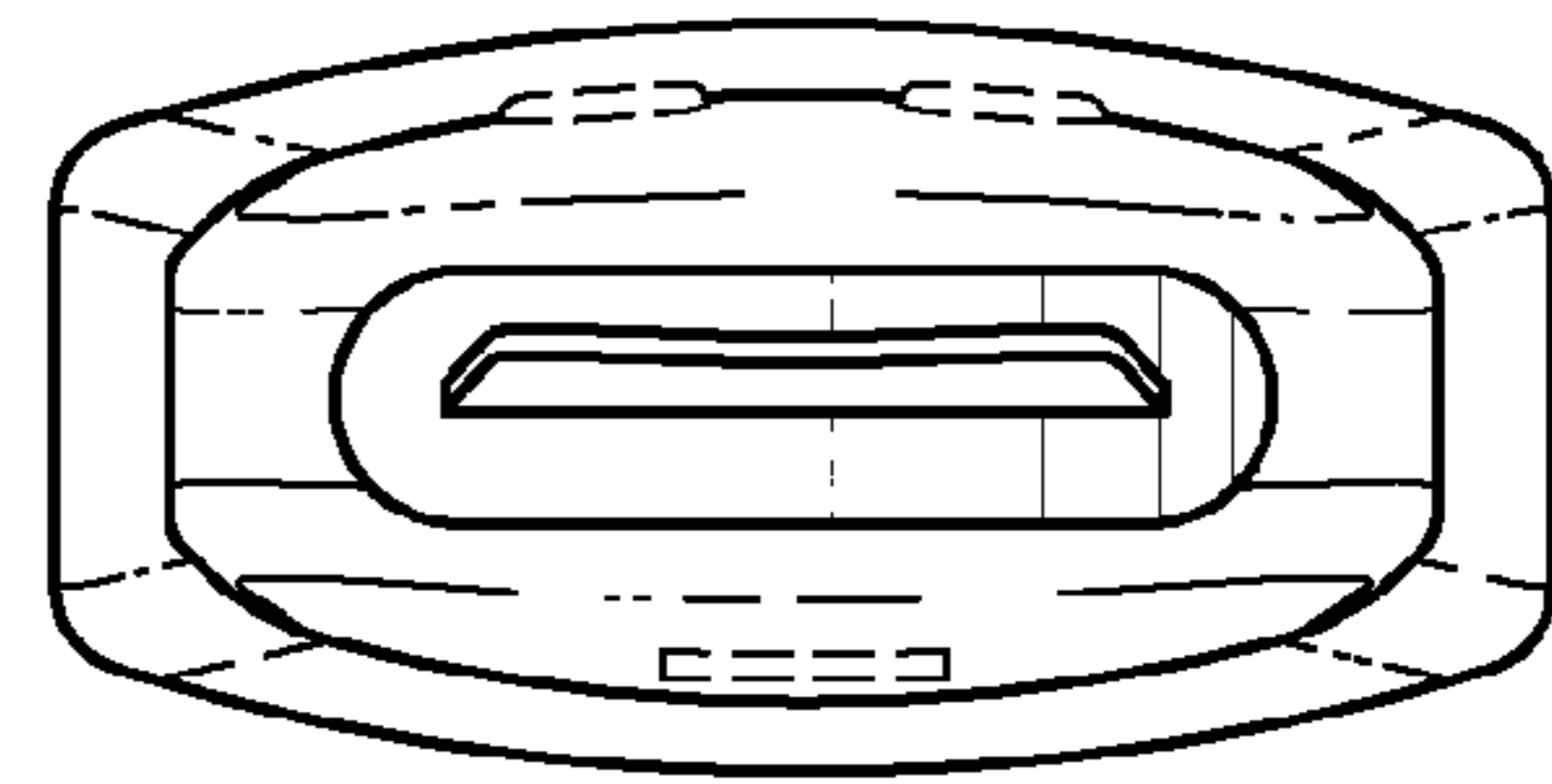
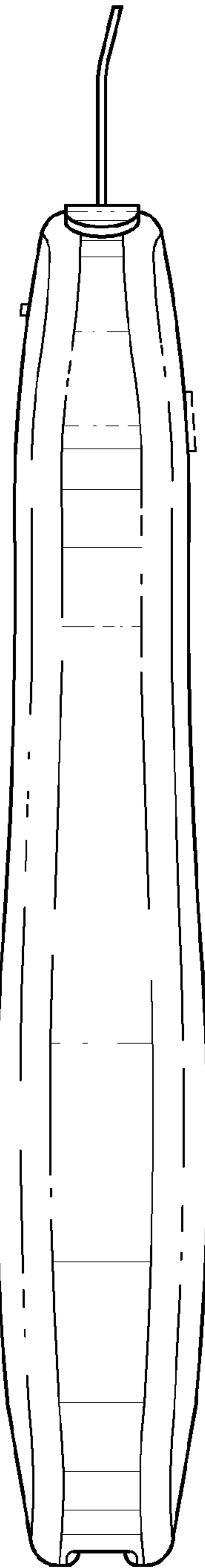

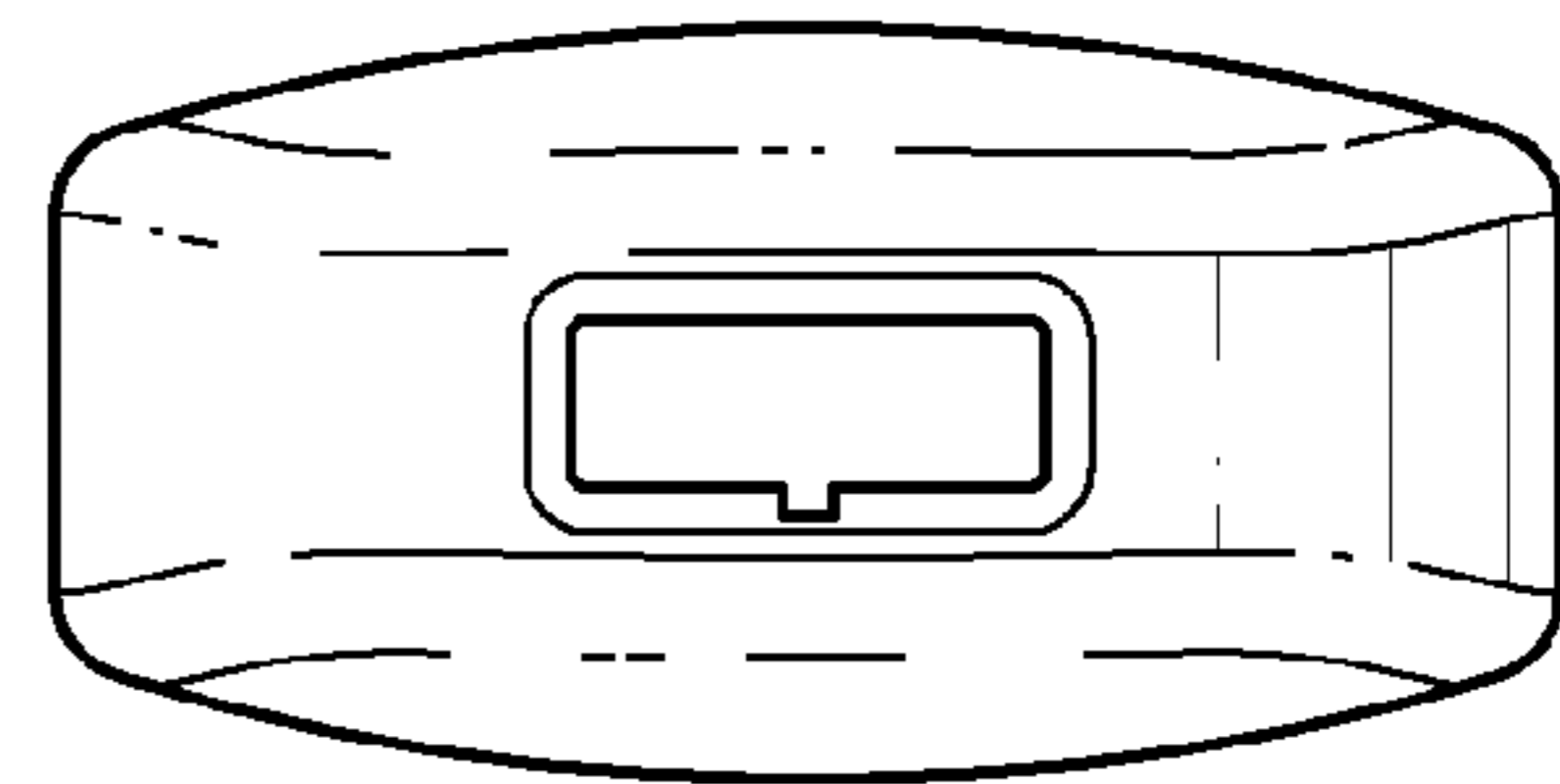
