FIG. 3 is a front view of the abutment according to the claimed design;

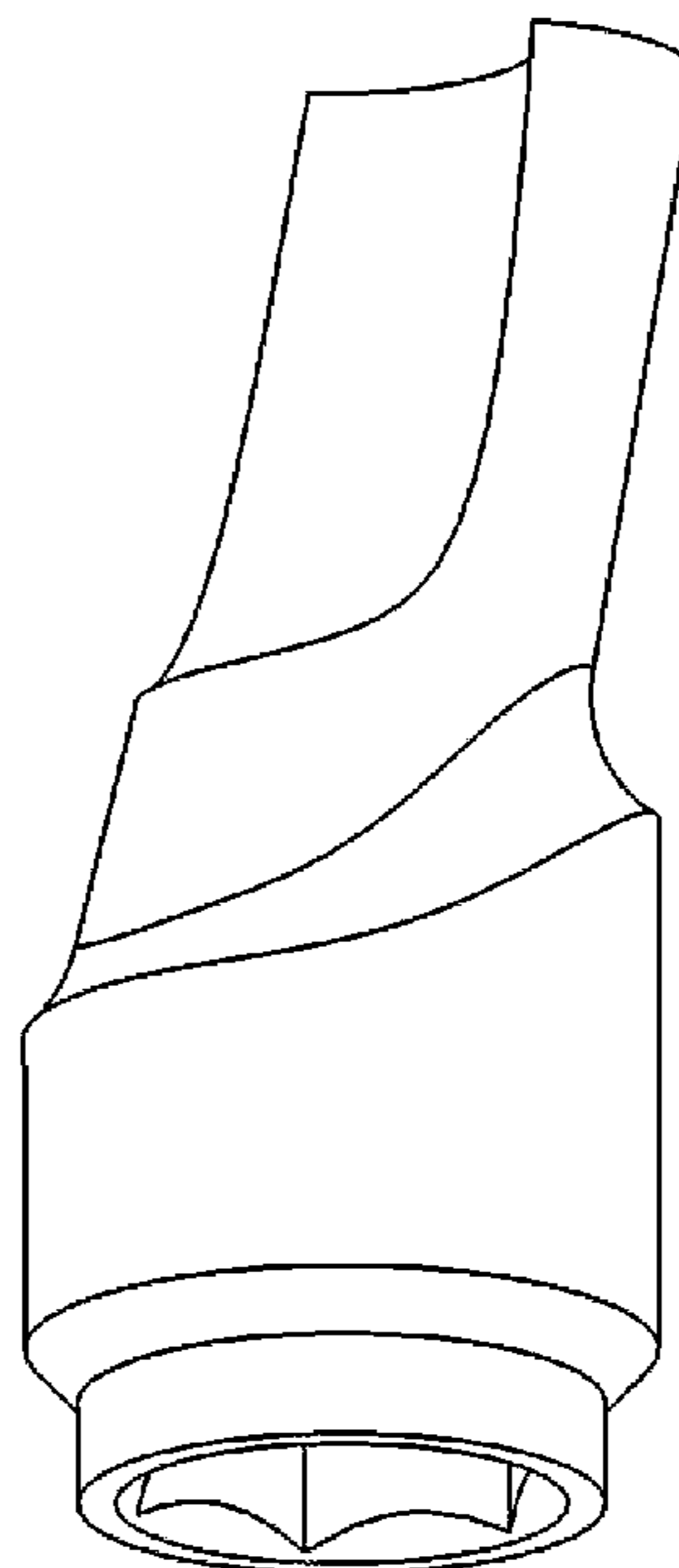
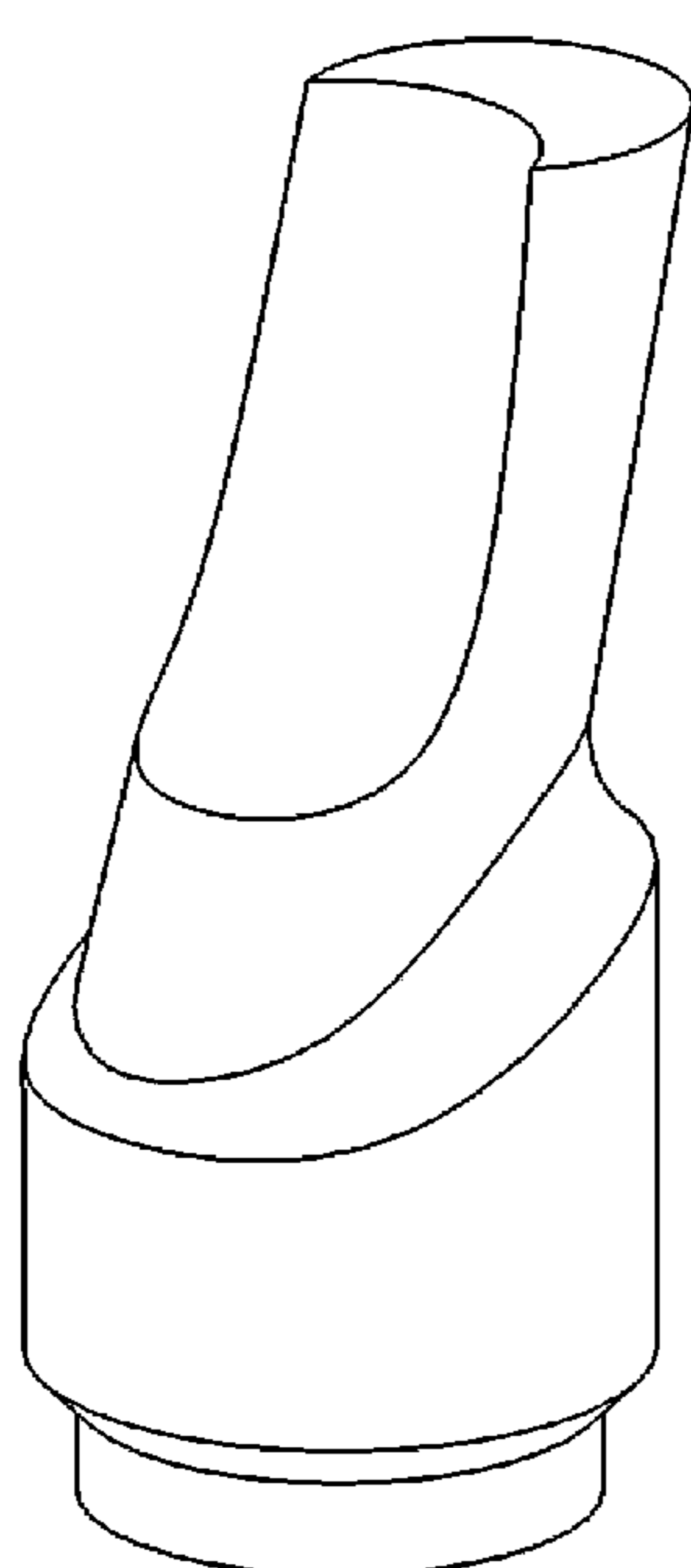
FIG. 4 is a rear view of the abutment according to the claimed design;

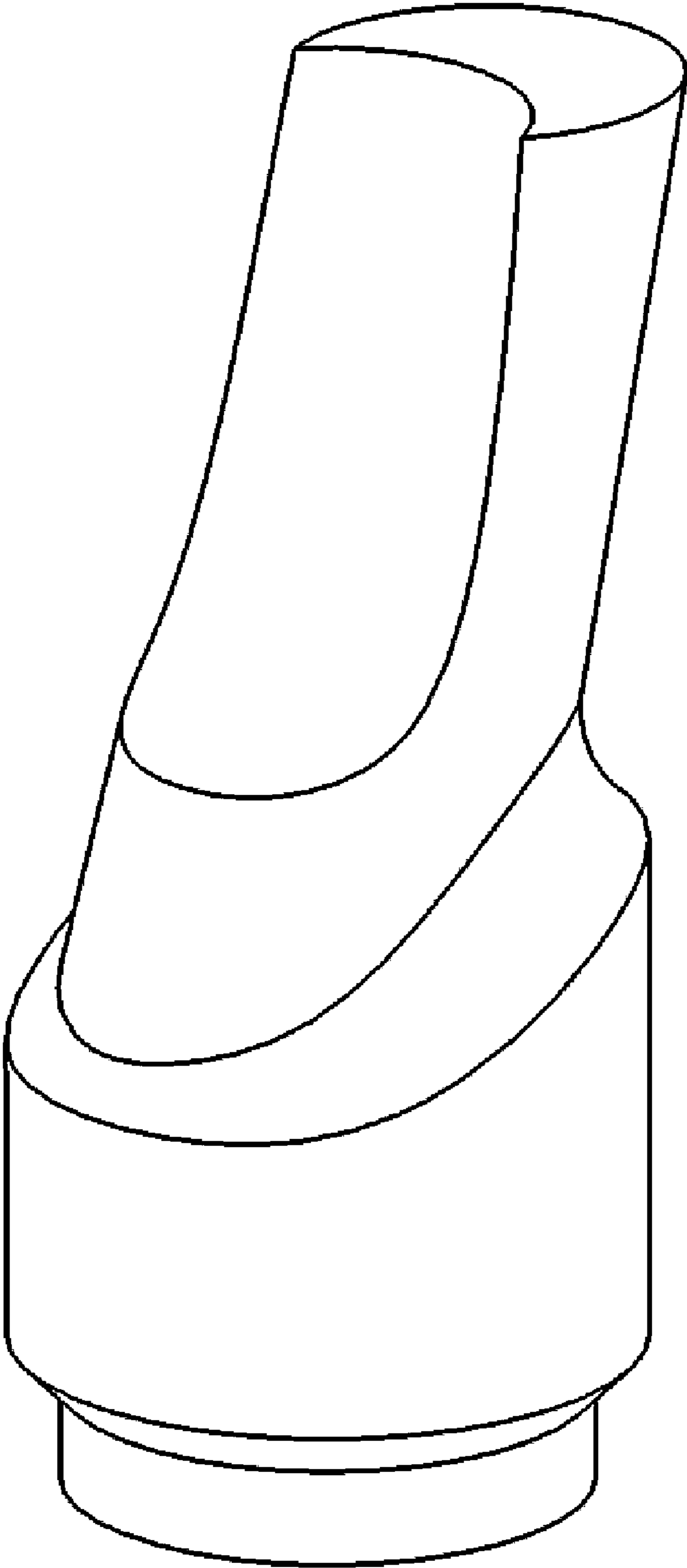

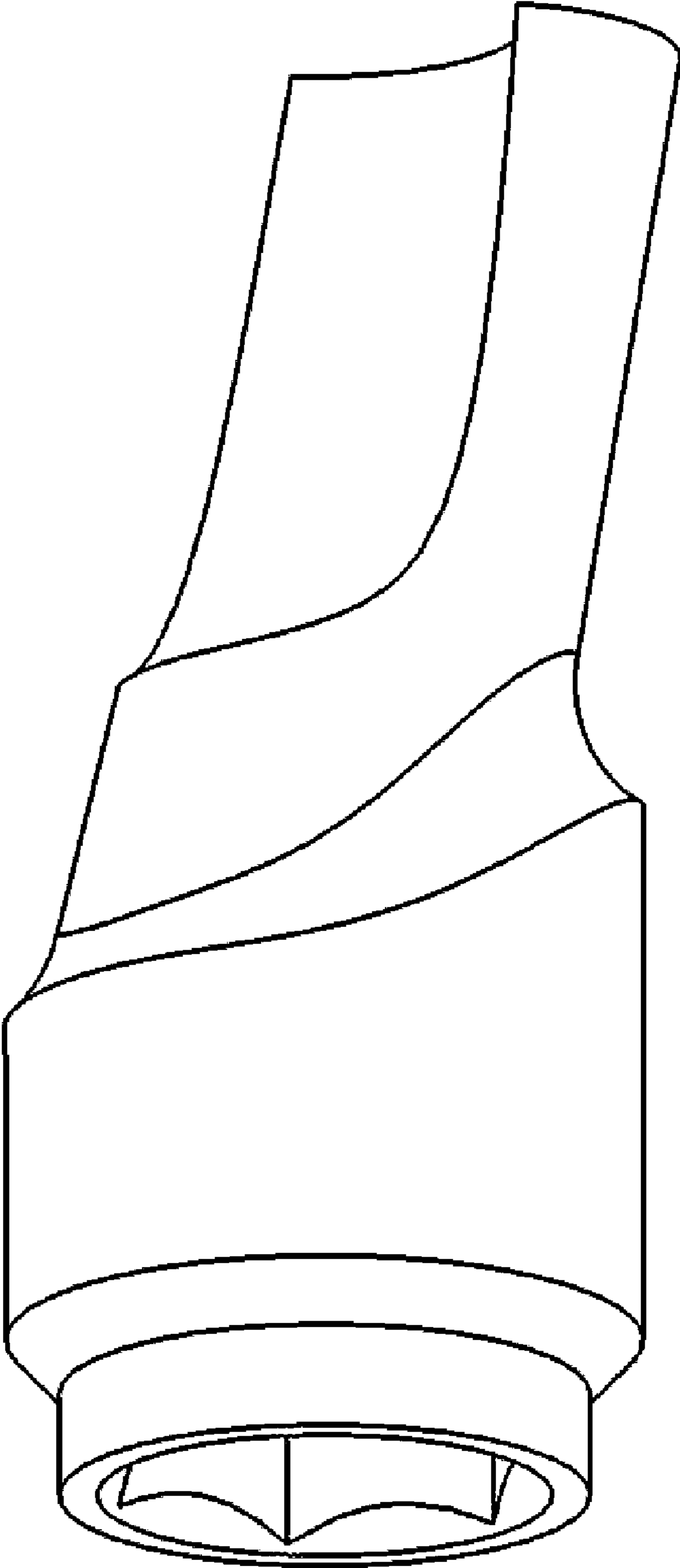

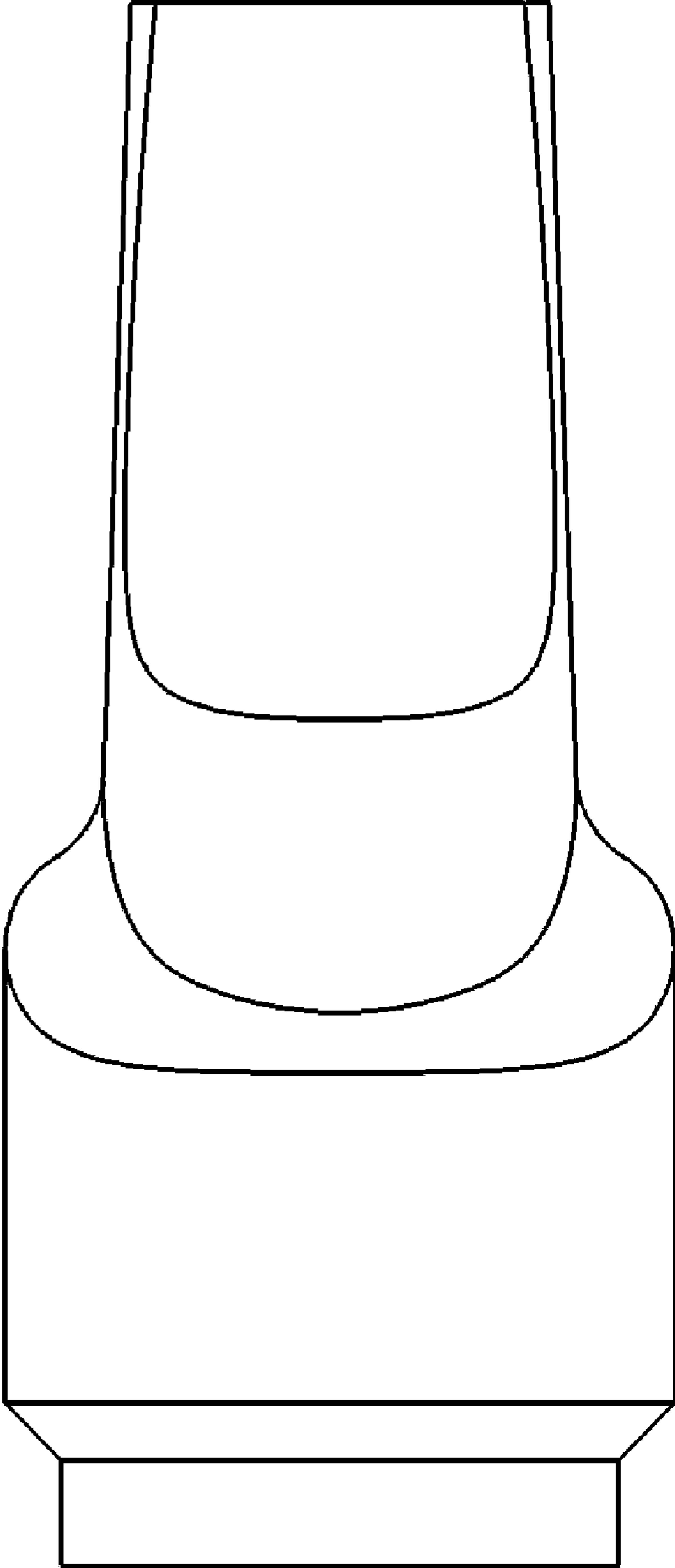

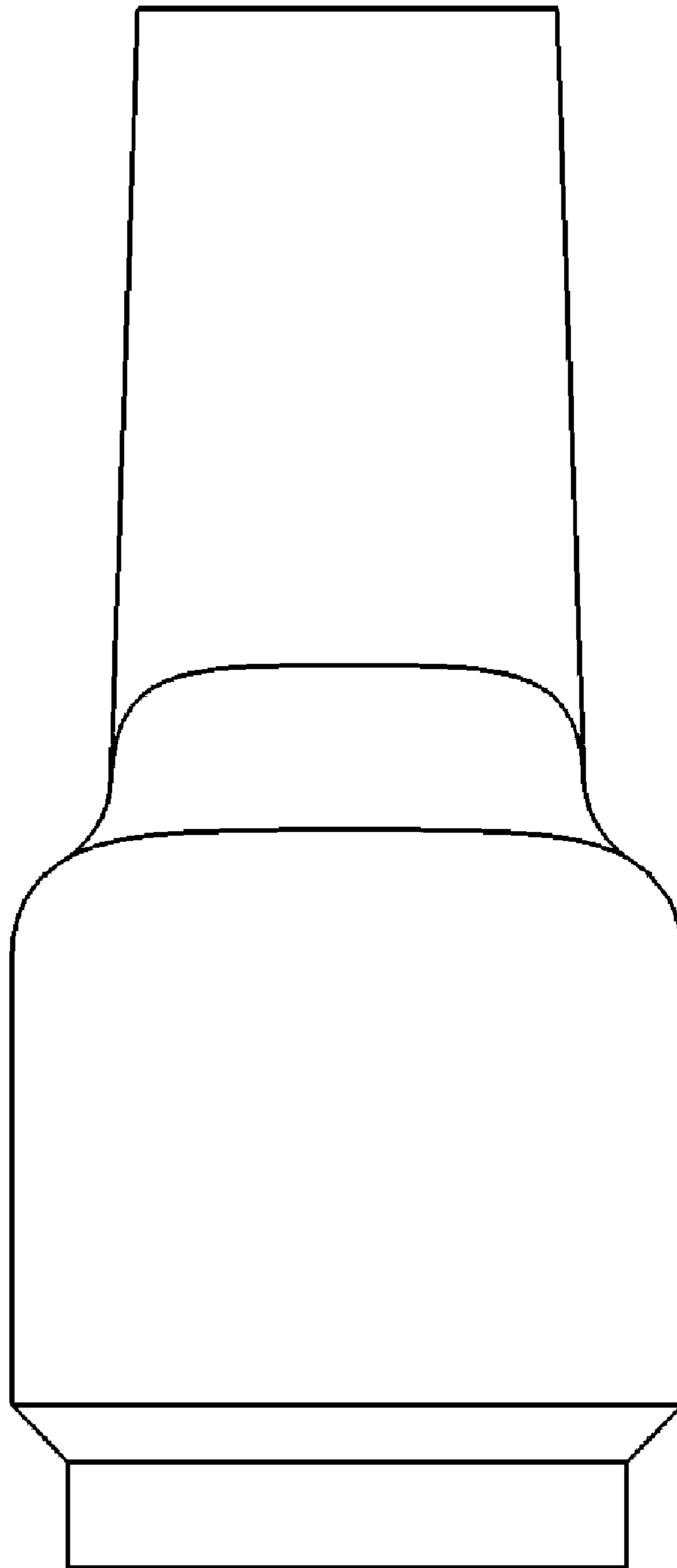

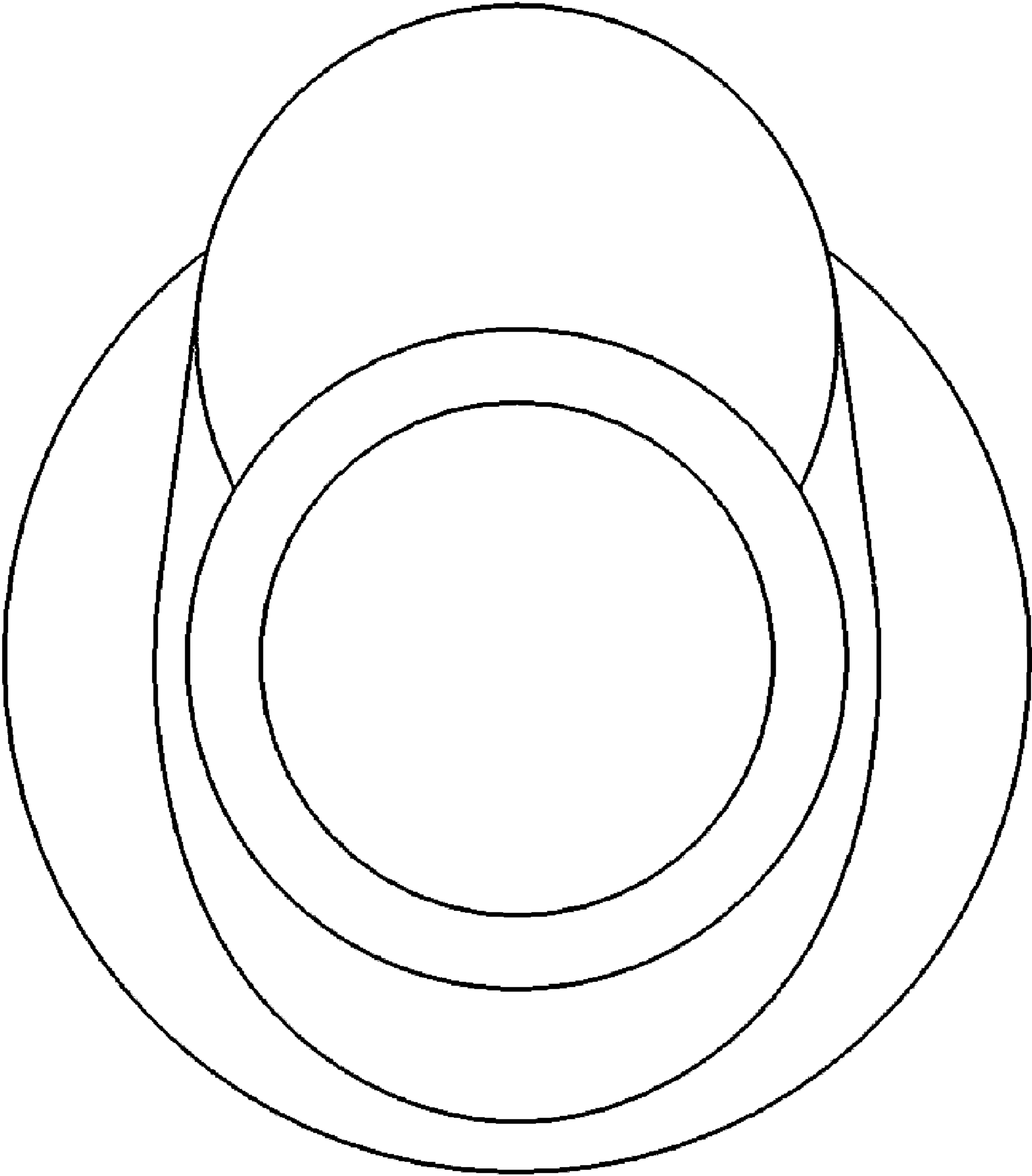

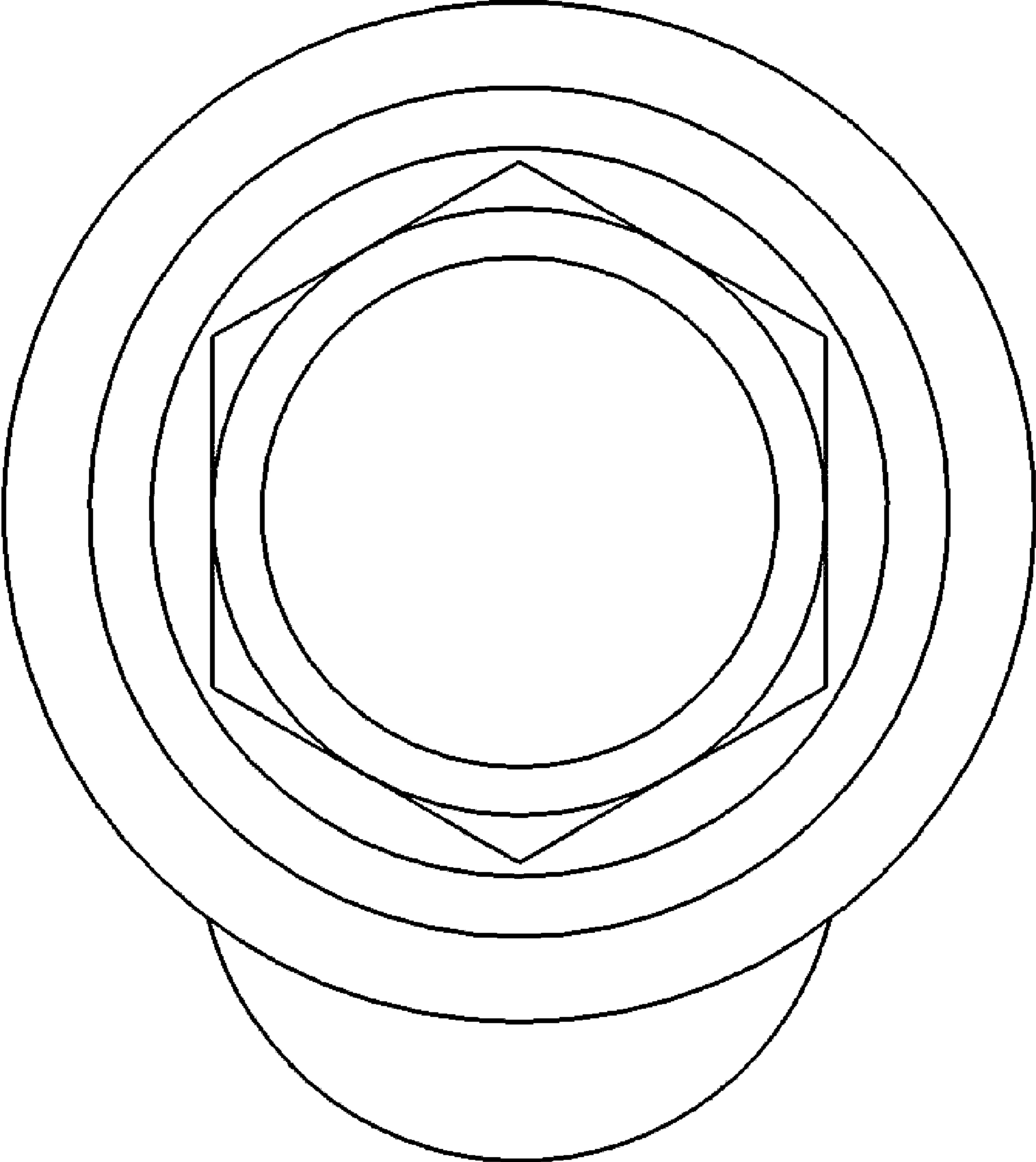

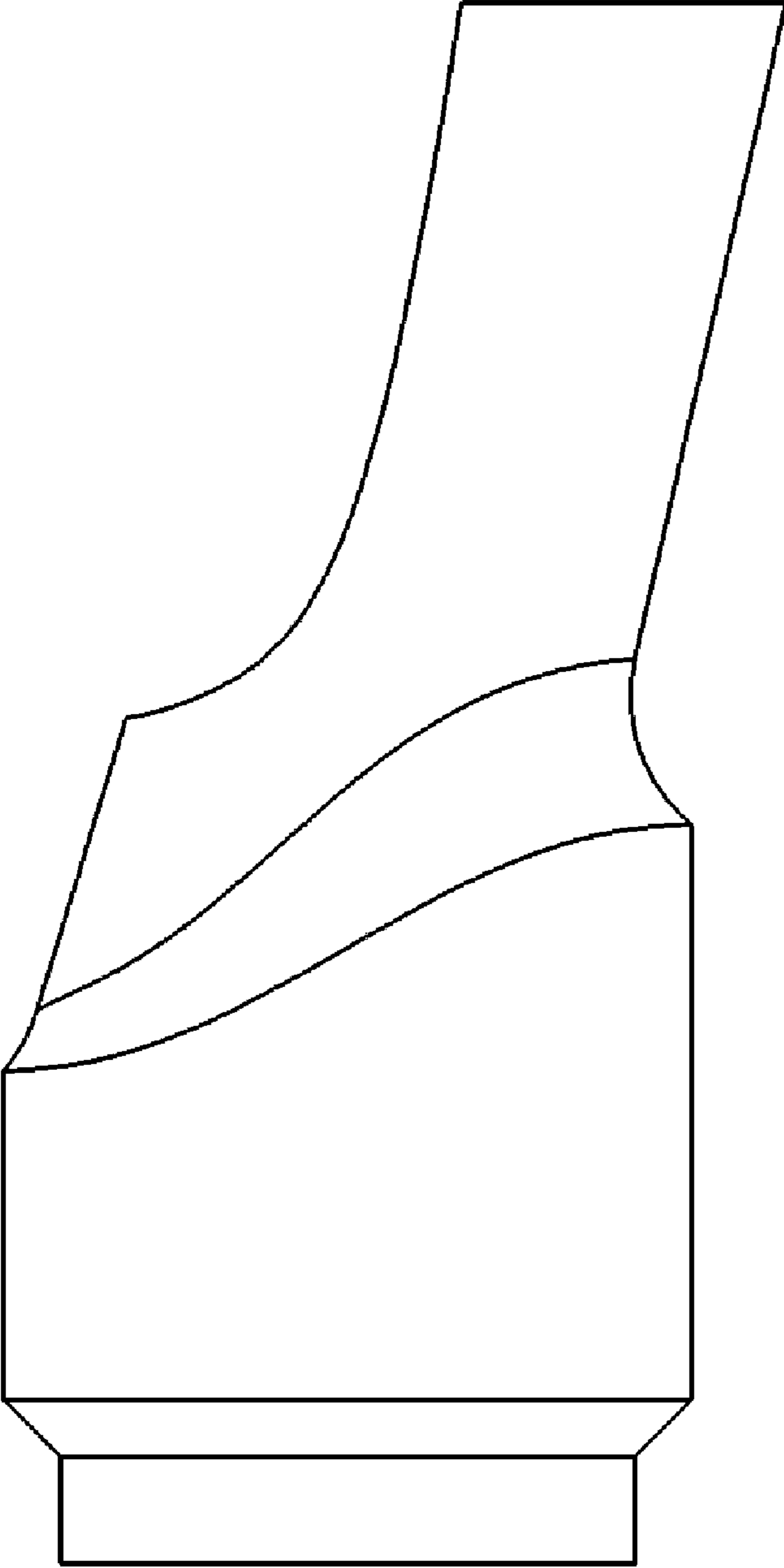
