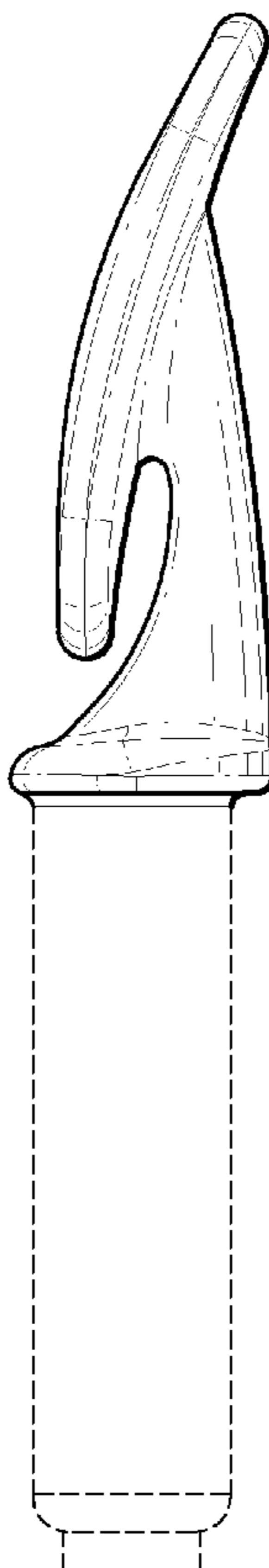
(57) **CLAIM**

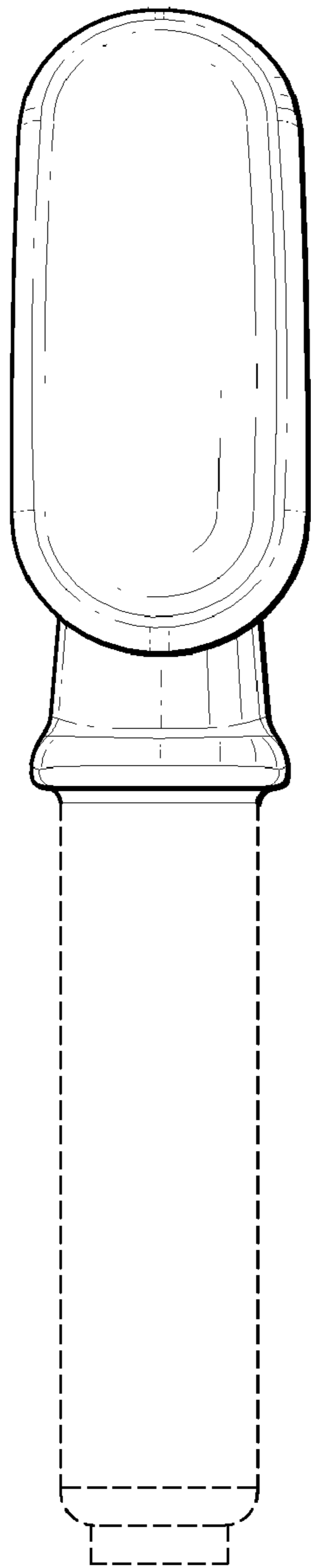
The ornamental design for an applicator for lip cosmetics, as shown and described.

**DESCRIPTION**

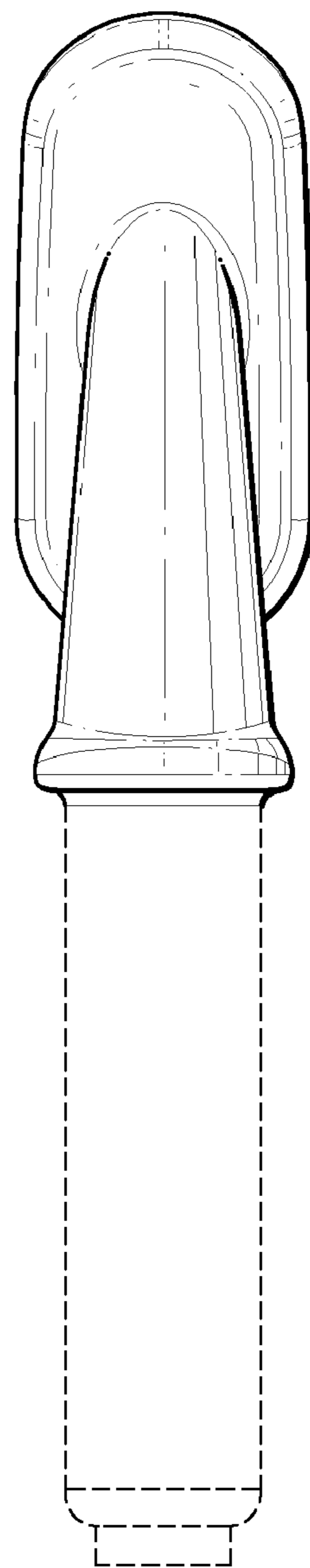
FIG. 1 is a front elevational view of an applicator for lip cosmetics, showing my new design;  
FIG. 2 is a rear elevational view thereof;

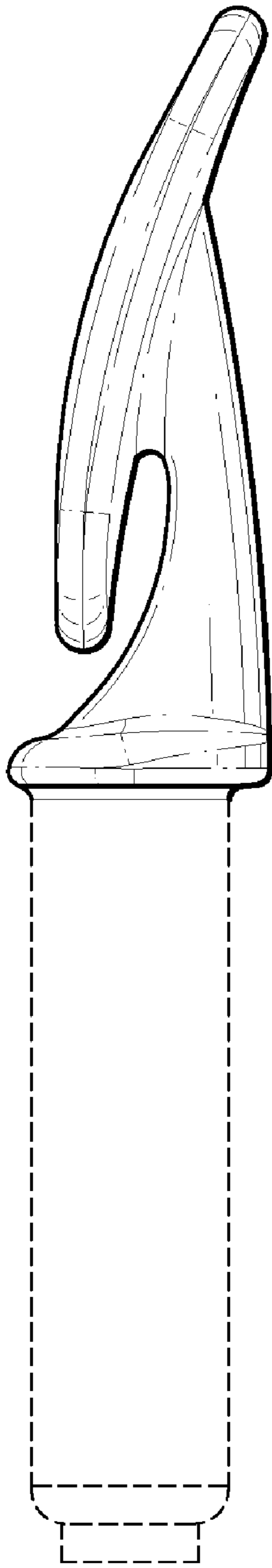




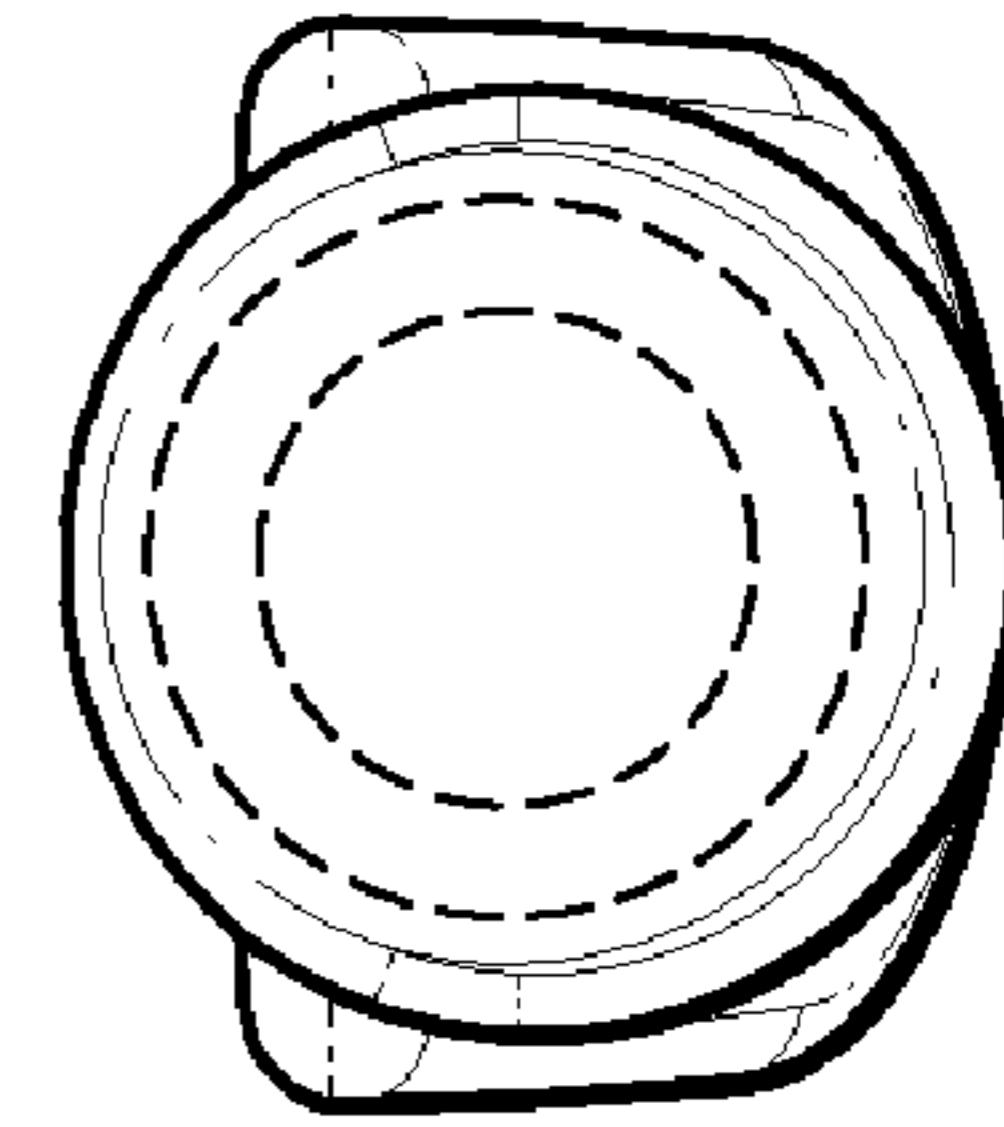

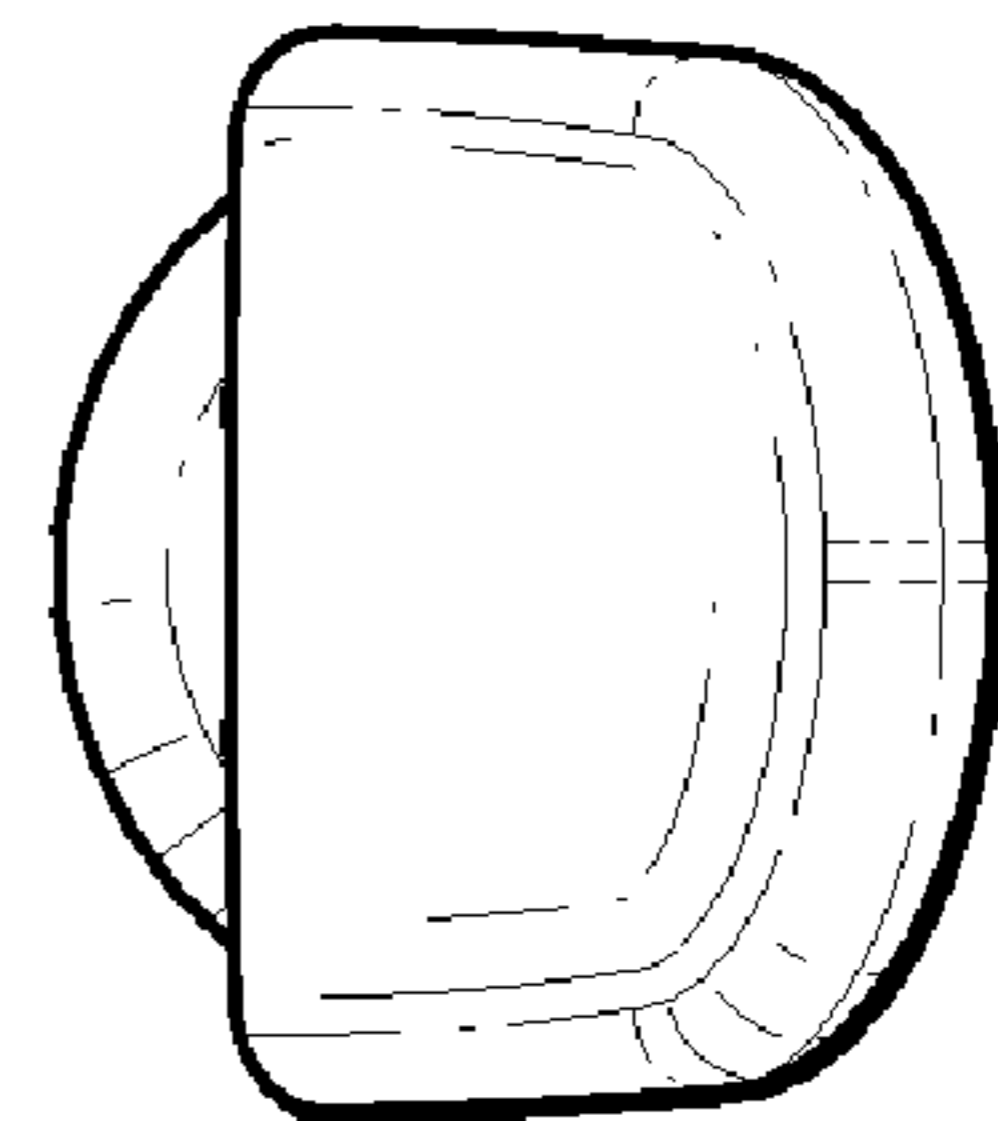

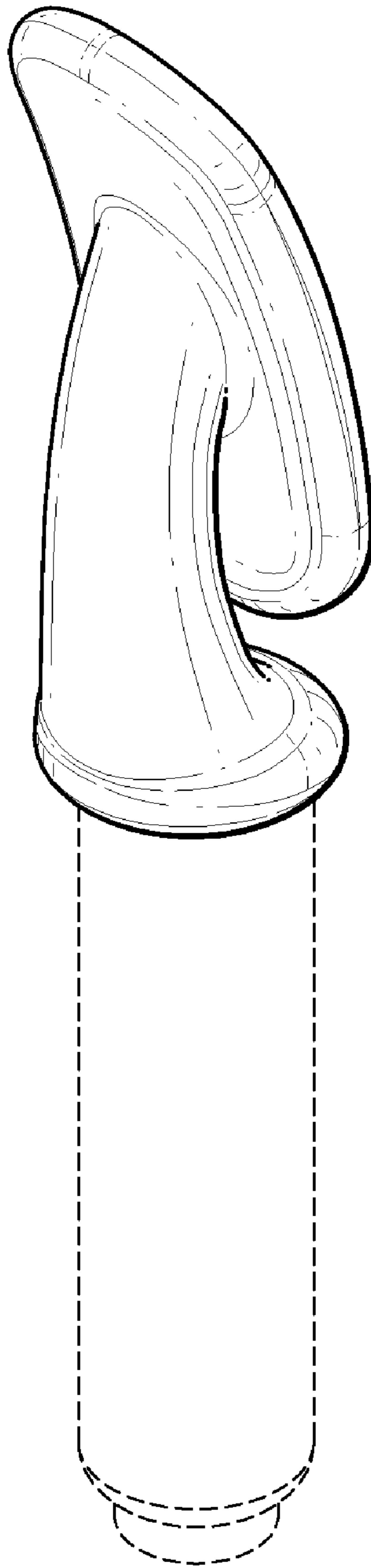
