(57) **CLAIM**

The ornamental design for underpants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of an underpants in accordance with a first embodiment of my new design;

FIG. 2 is a rear and right side perspective view of the underpants;

FIG. 3 is a front elevation view of the underpants;

FIG. 4 is a rear elevation view of the underpants;

FIG. 5 is a left side view of the underpants, a right side view being a mirror image thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front and right side perspective view of an underpants in accordance with a second embodiment of my new design;

FIG. 9 is a rear and right side perspective view of the underpants;

FIG. 10 is a front elevation view of the underpants;

FIG. 11 is a rear elevation view thereof;

FIG. 12 is a left side view thereof, a right side view being a mirror image thereof;

FIG. 13 is a top plan view thereof; and,

FIG. 14 is a bottom plan view thereof.

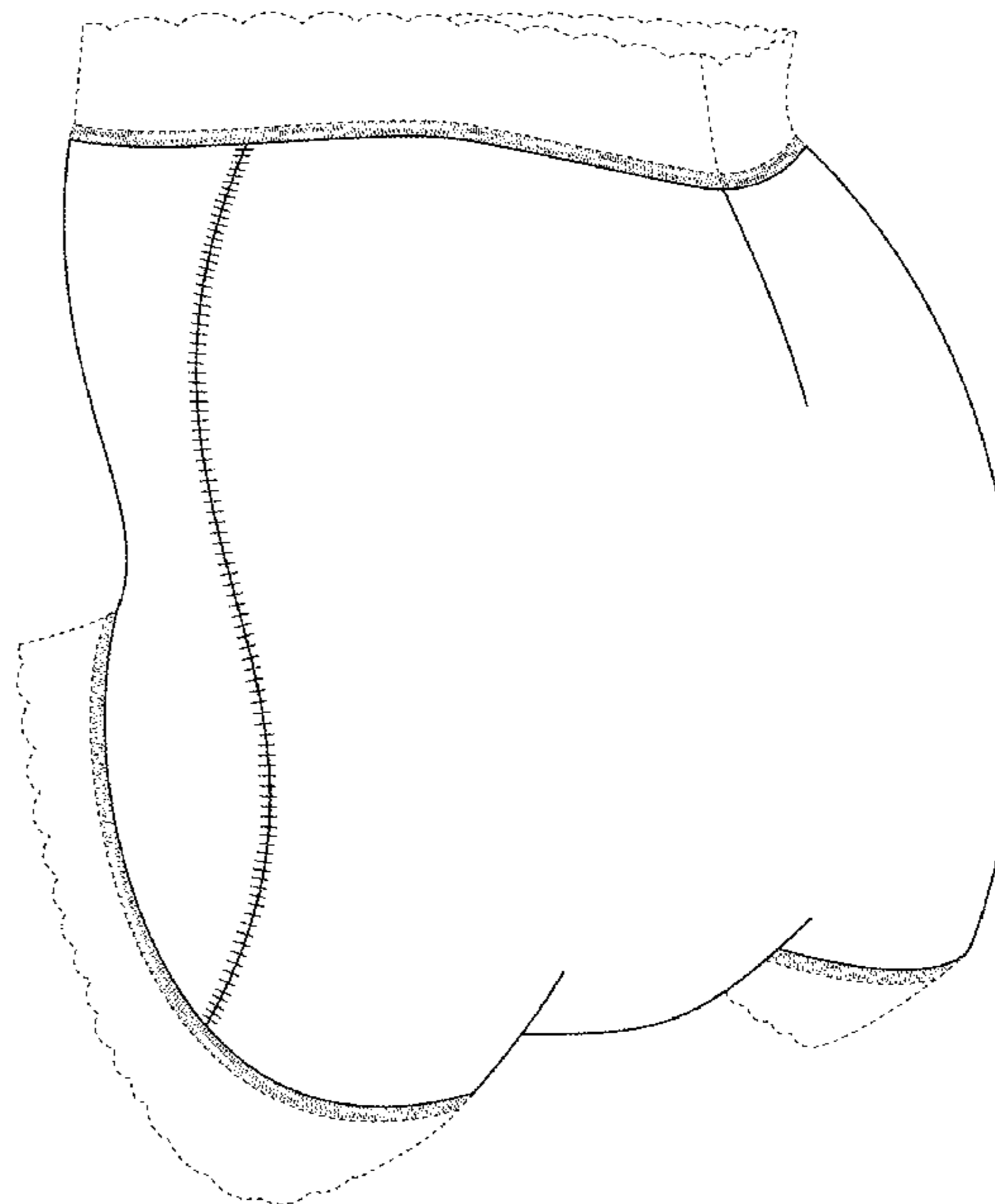
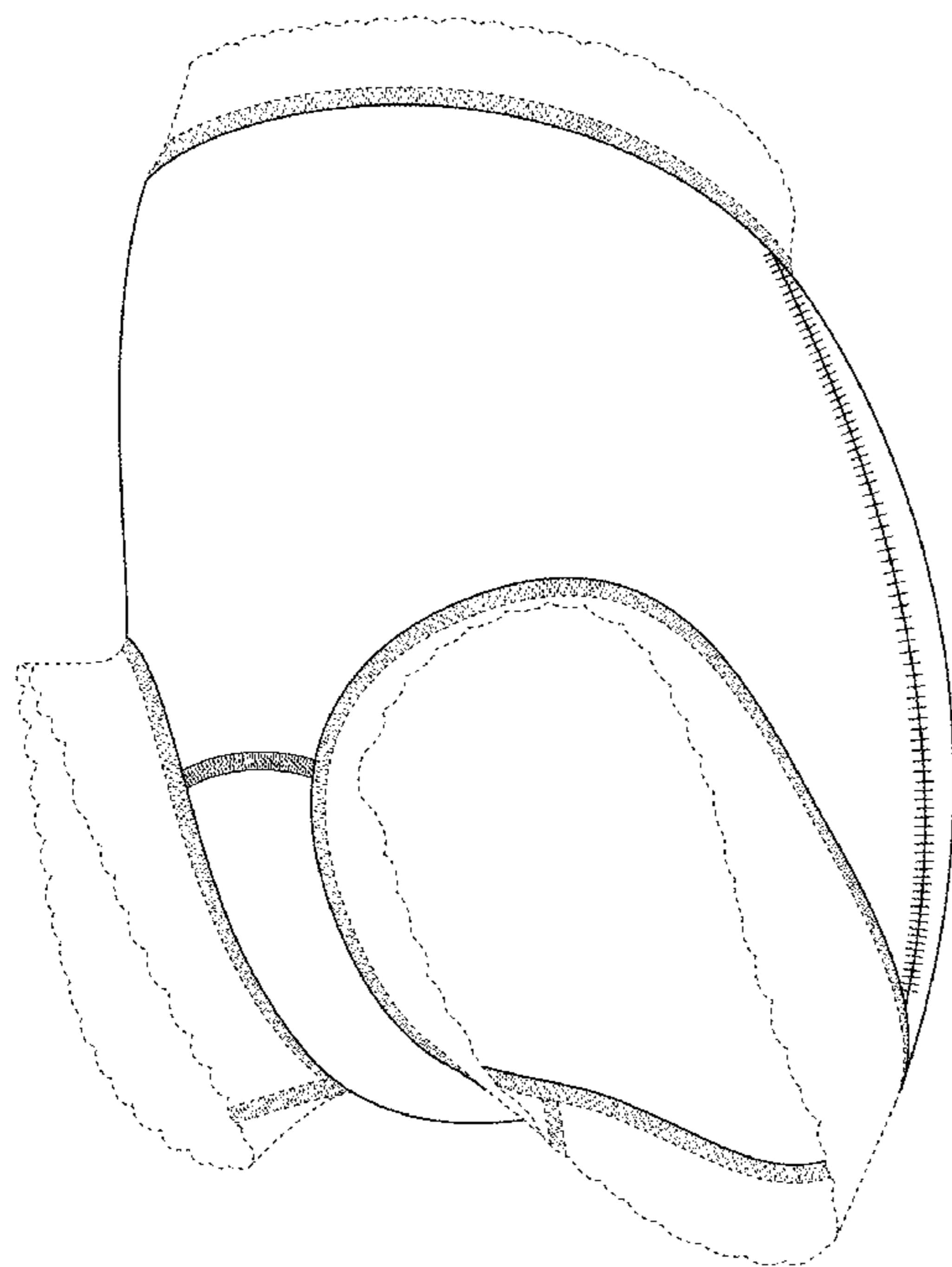

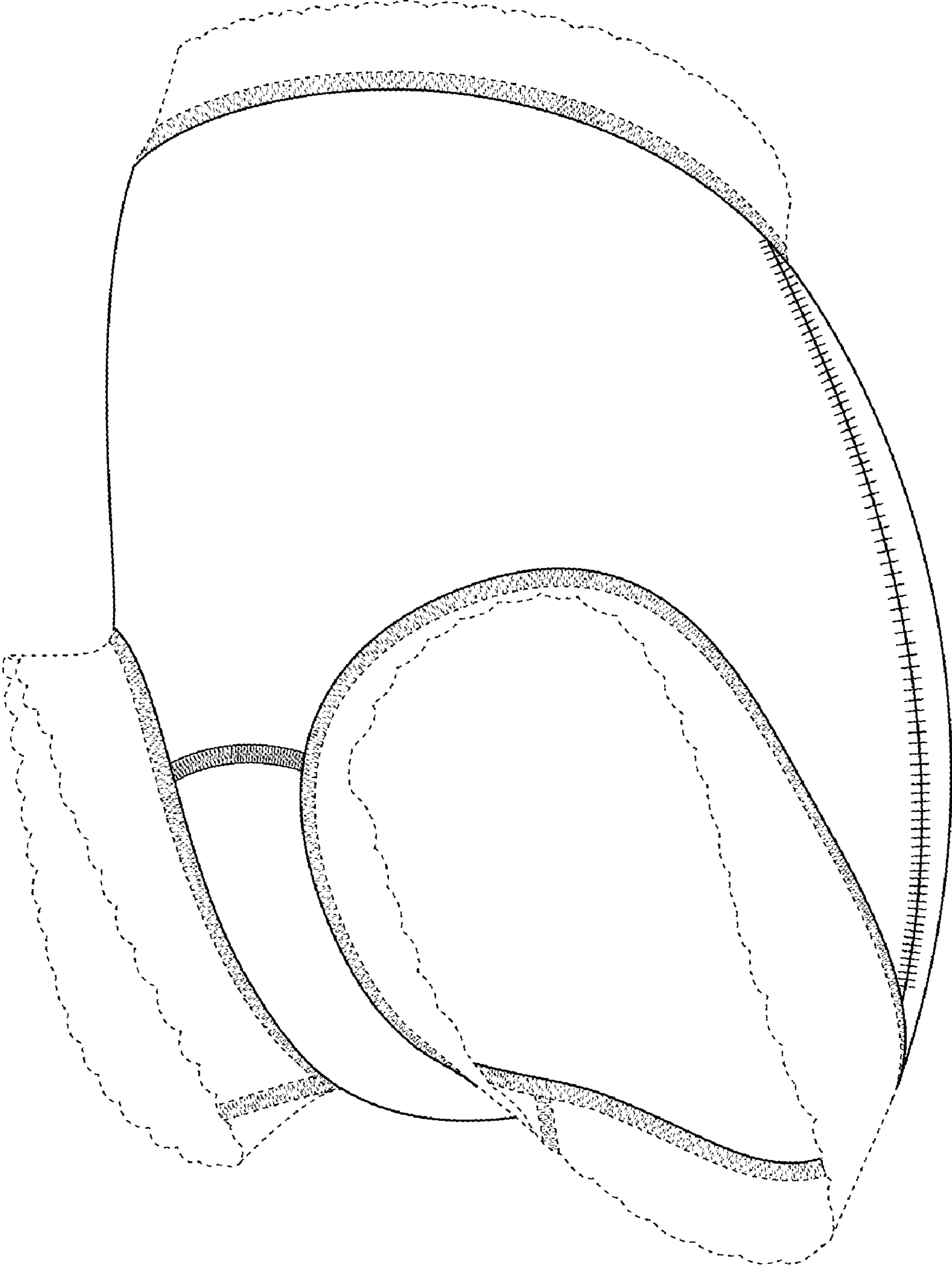

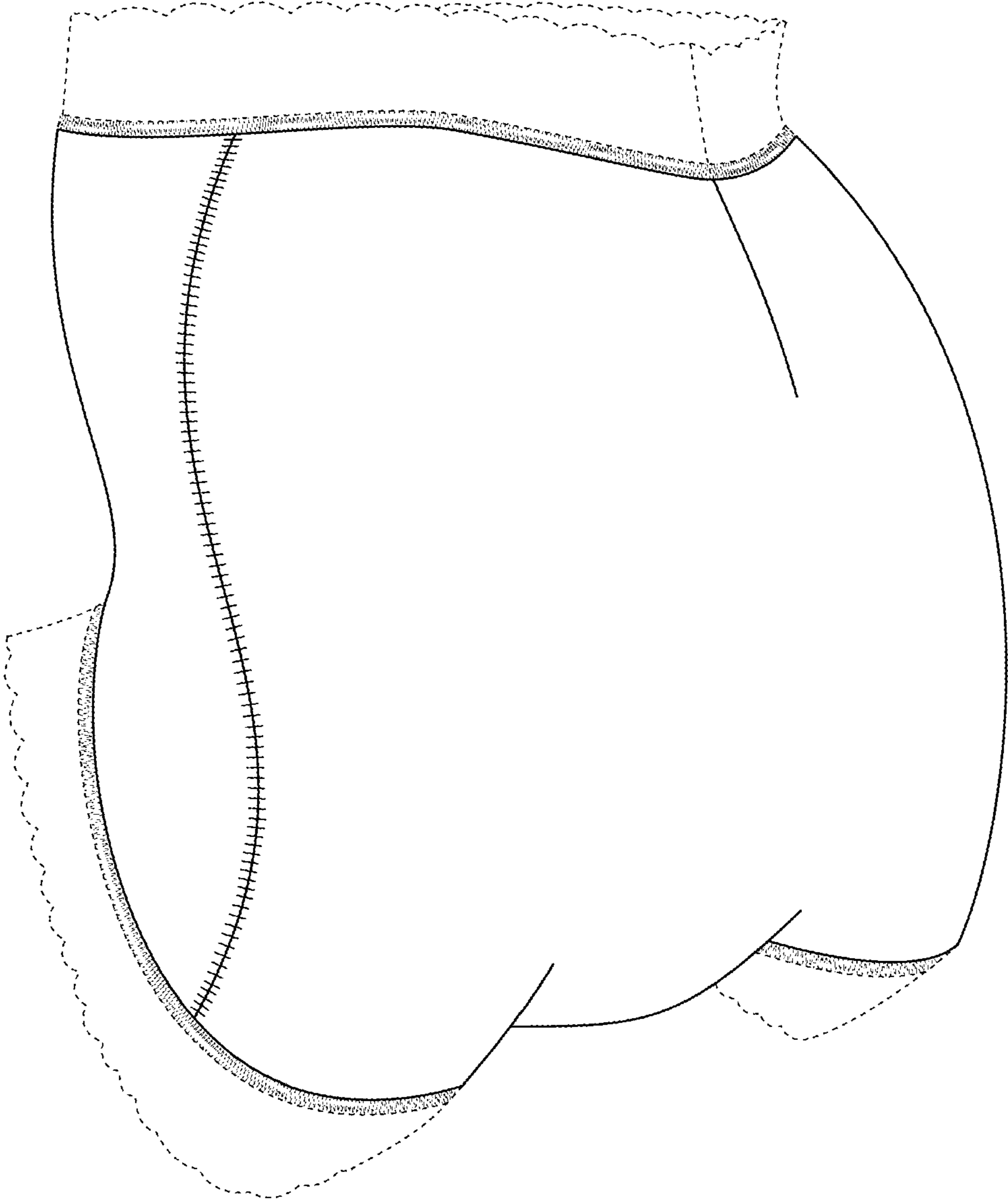

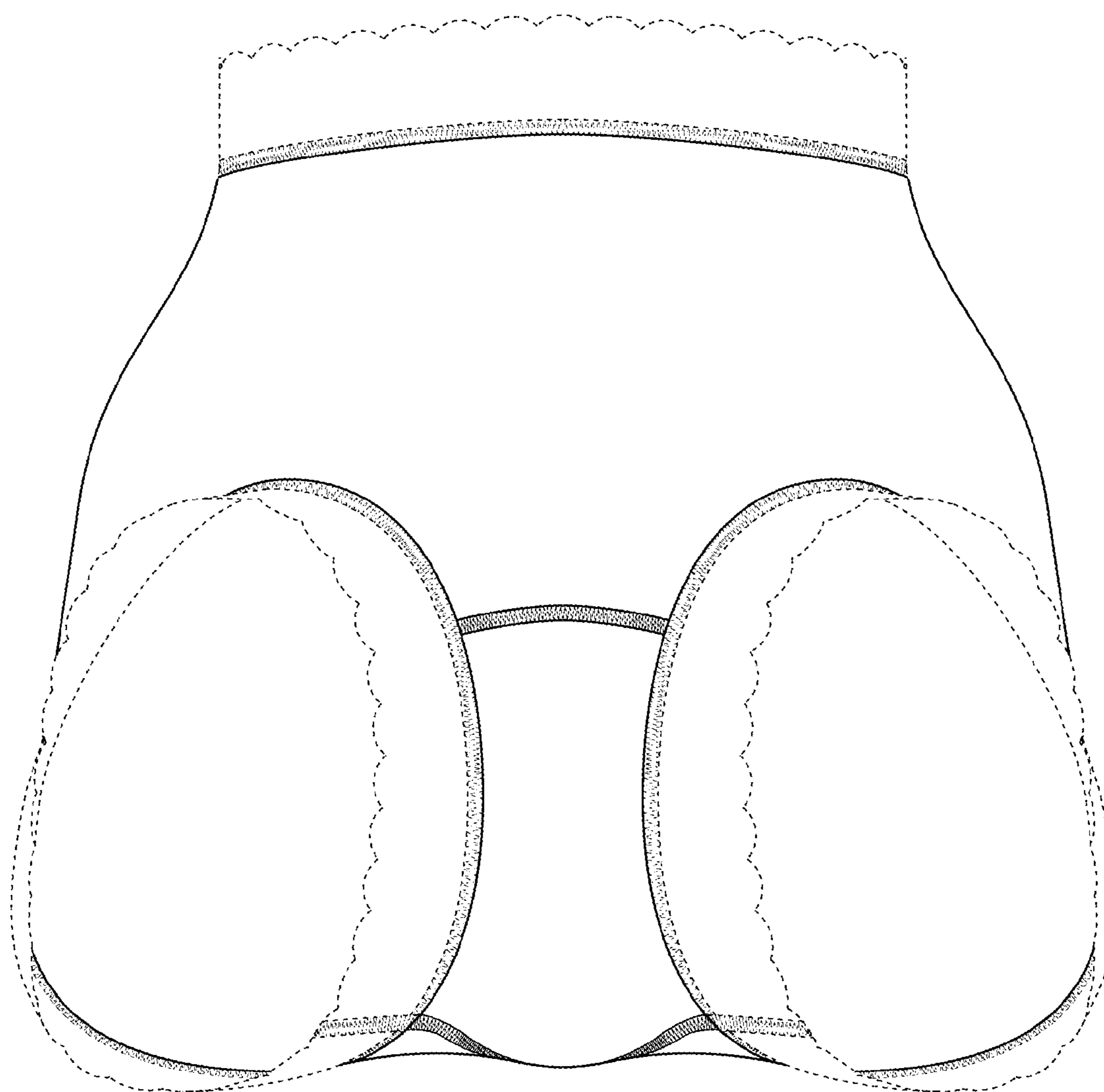

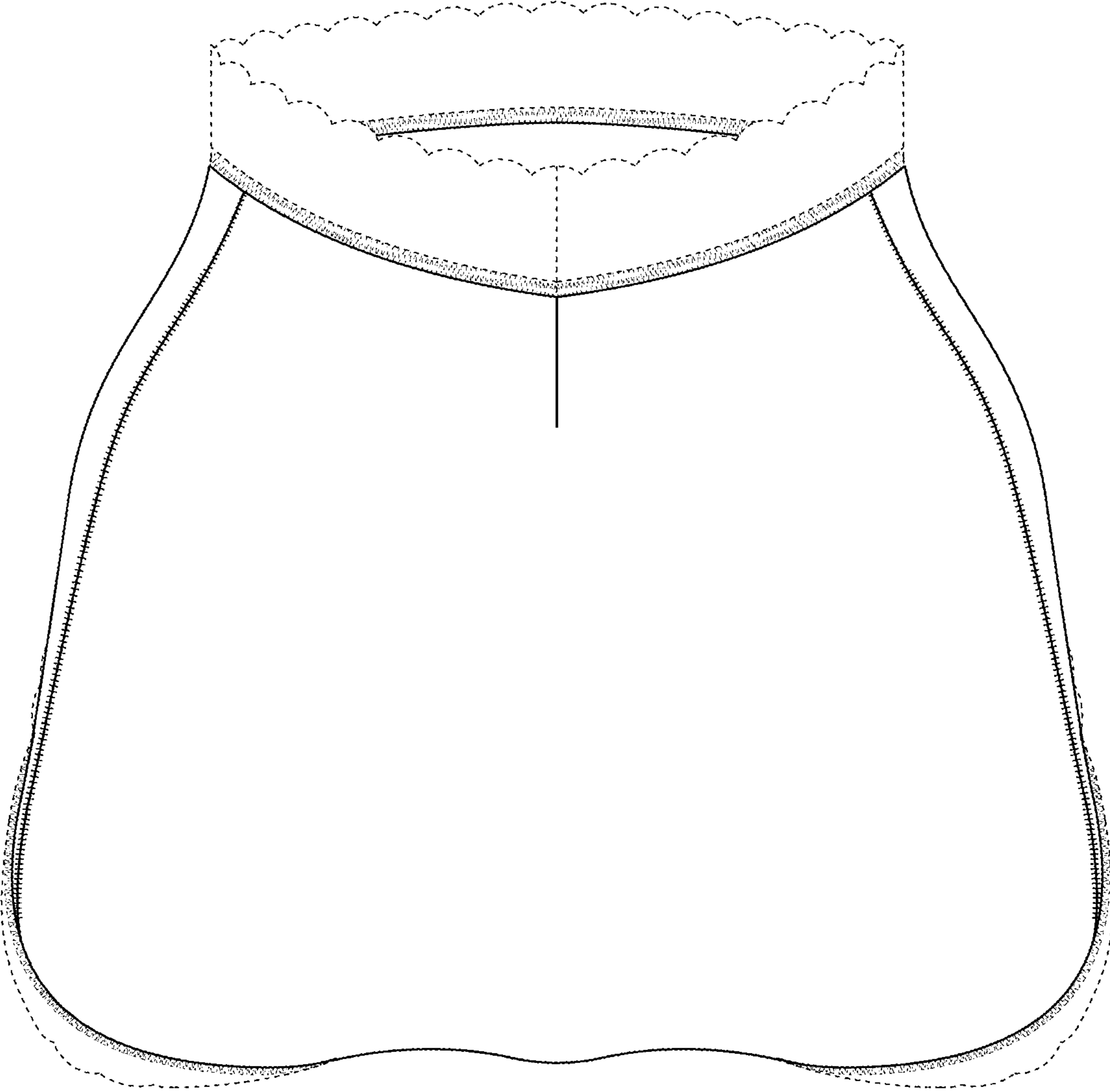

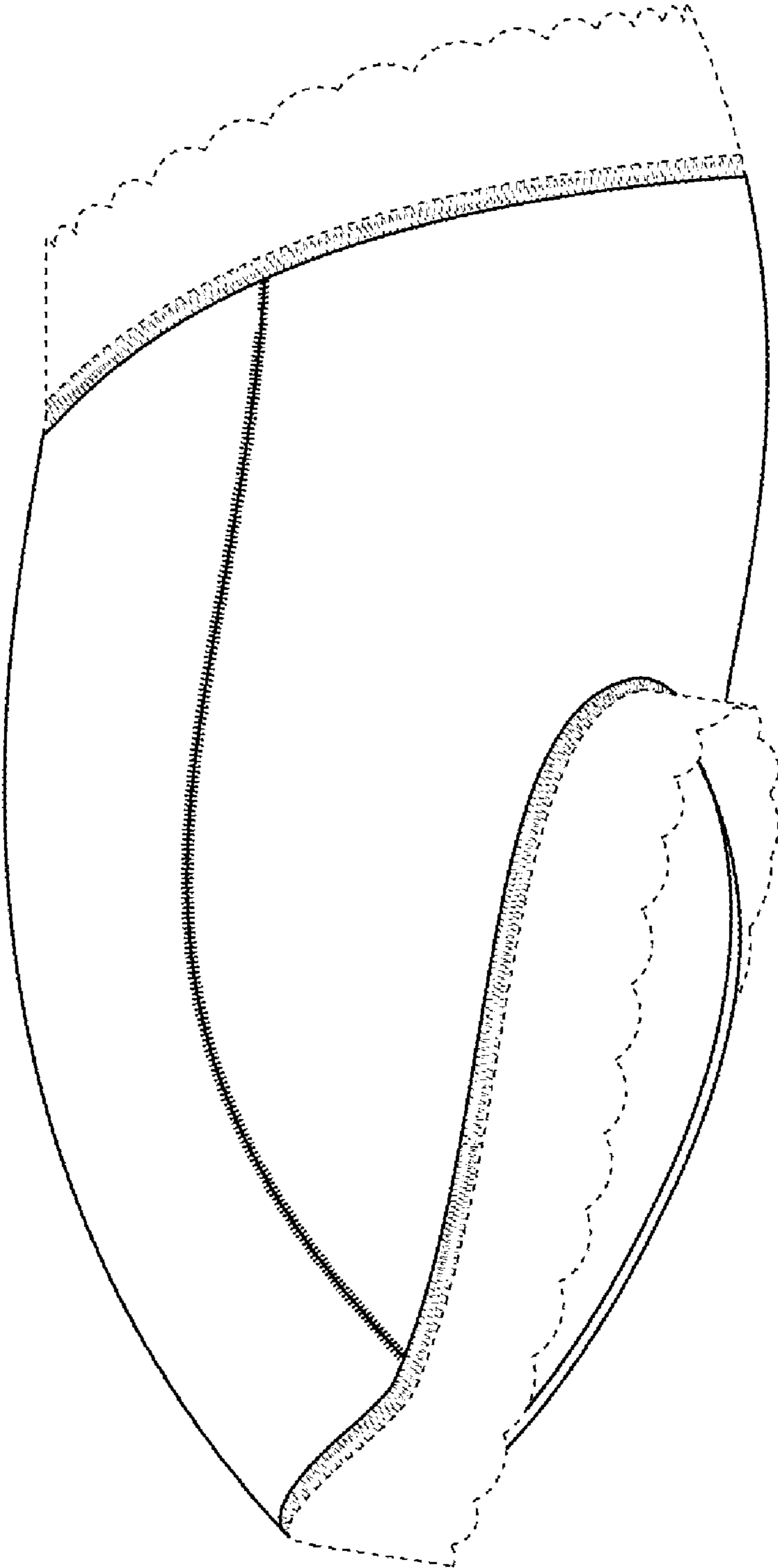

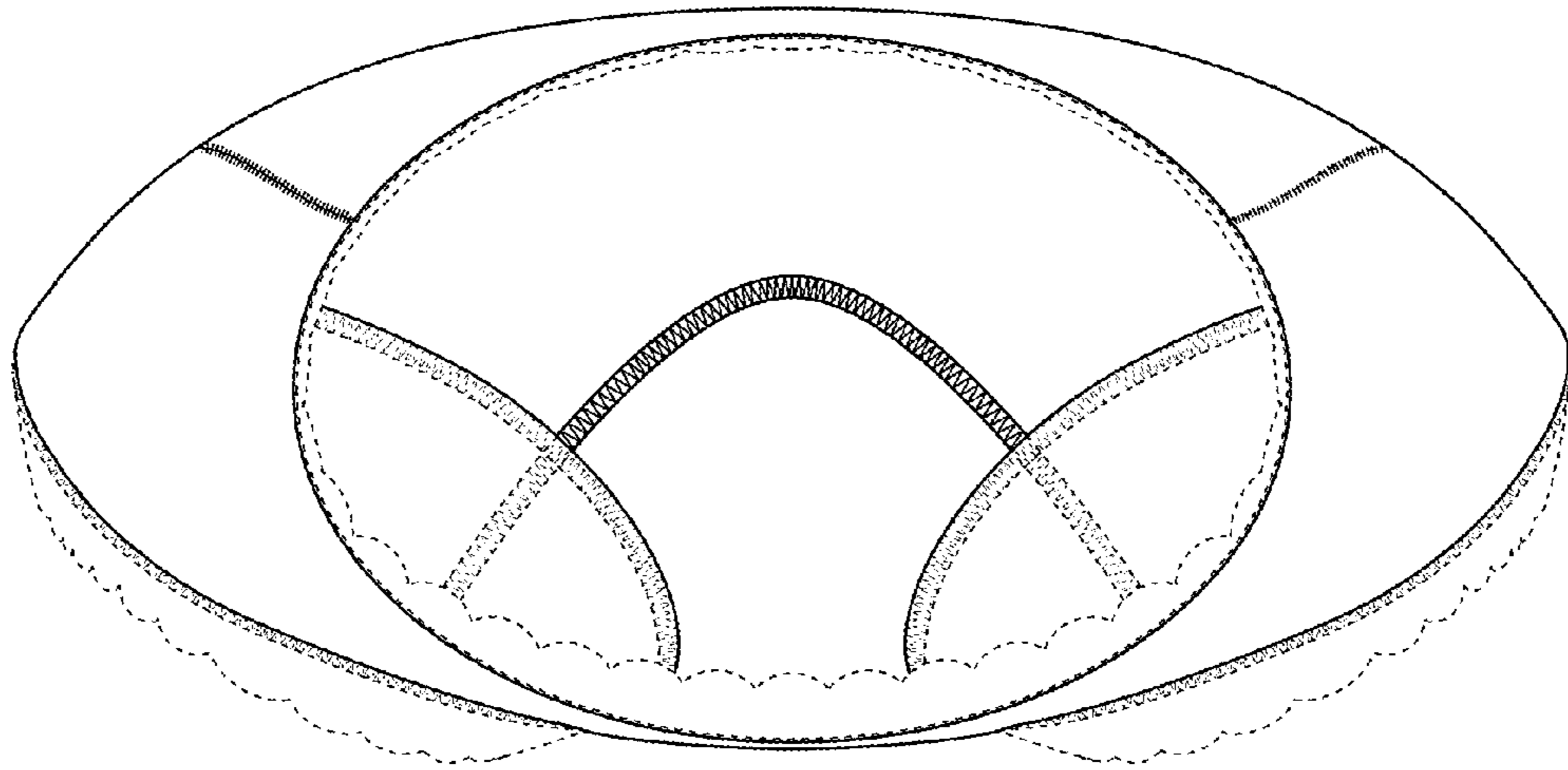

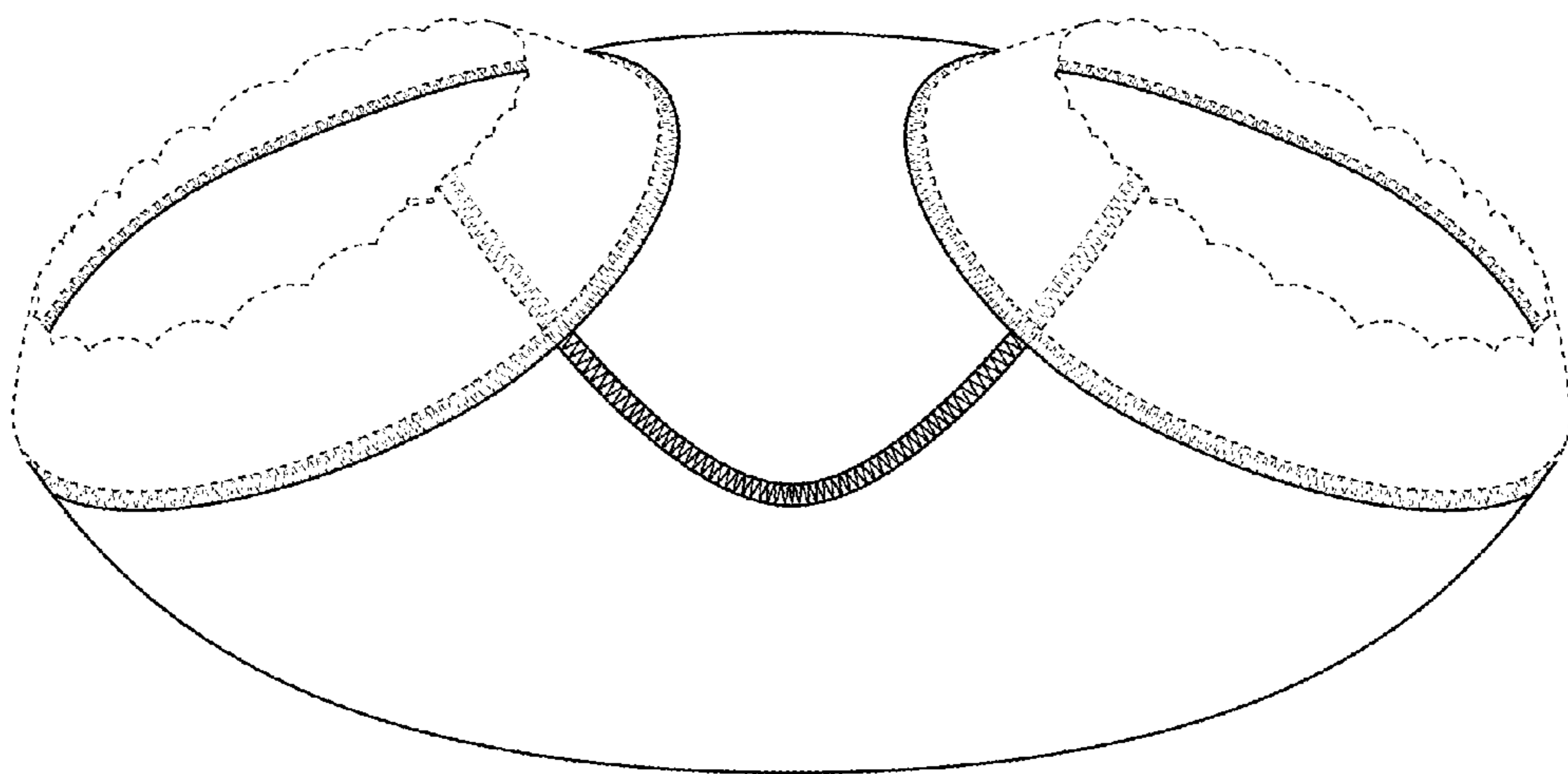

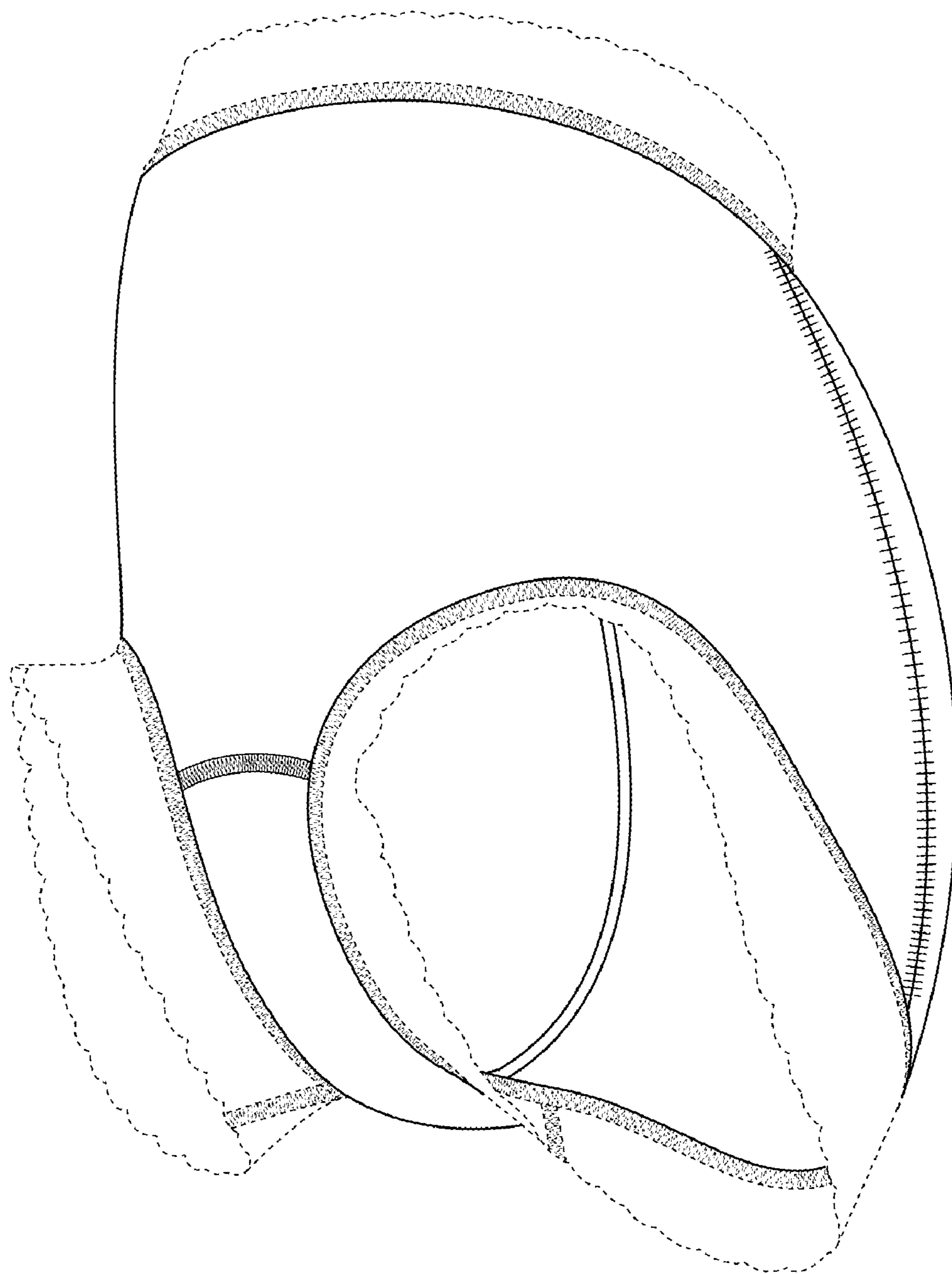

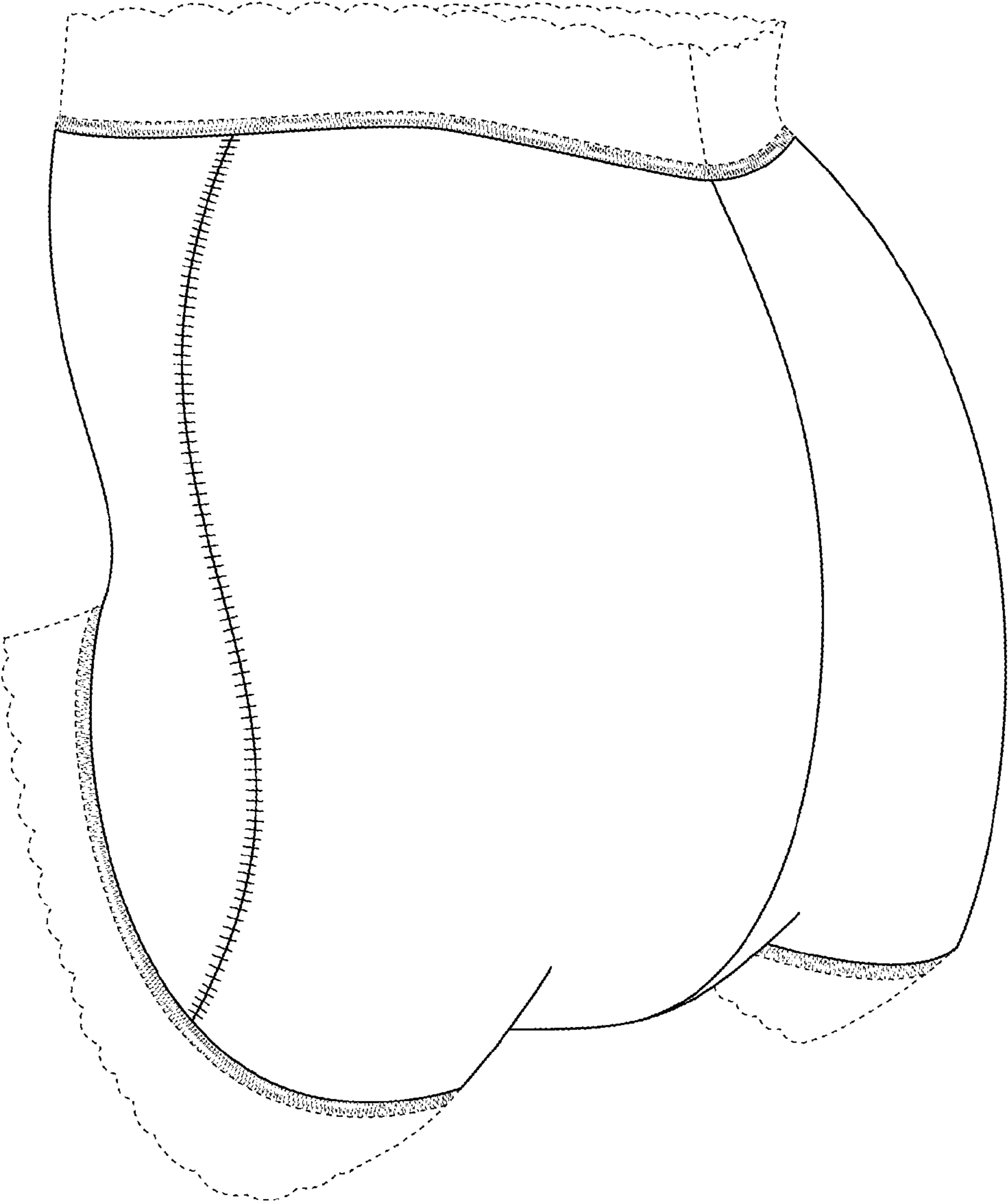

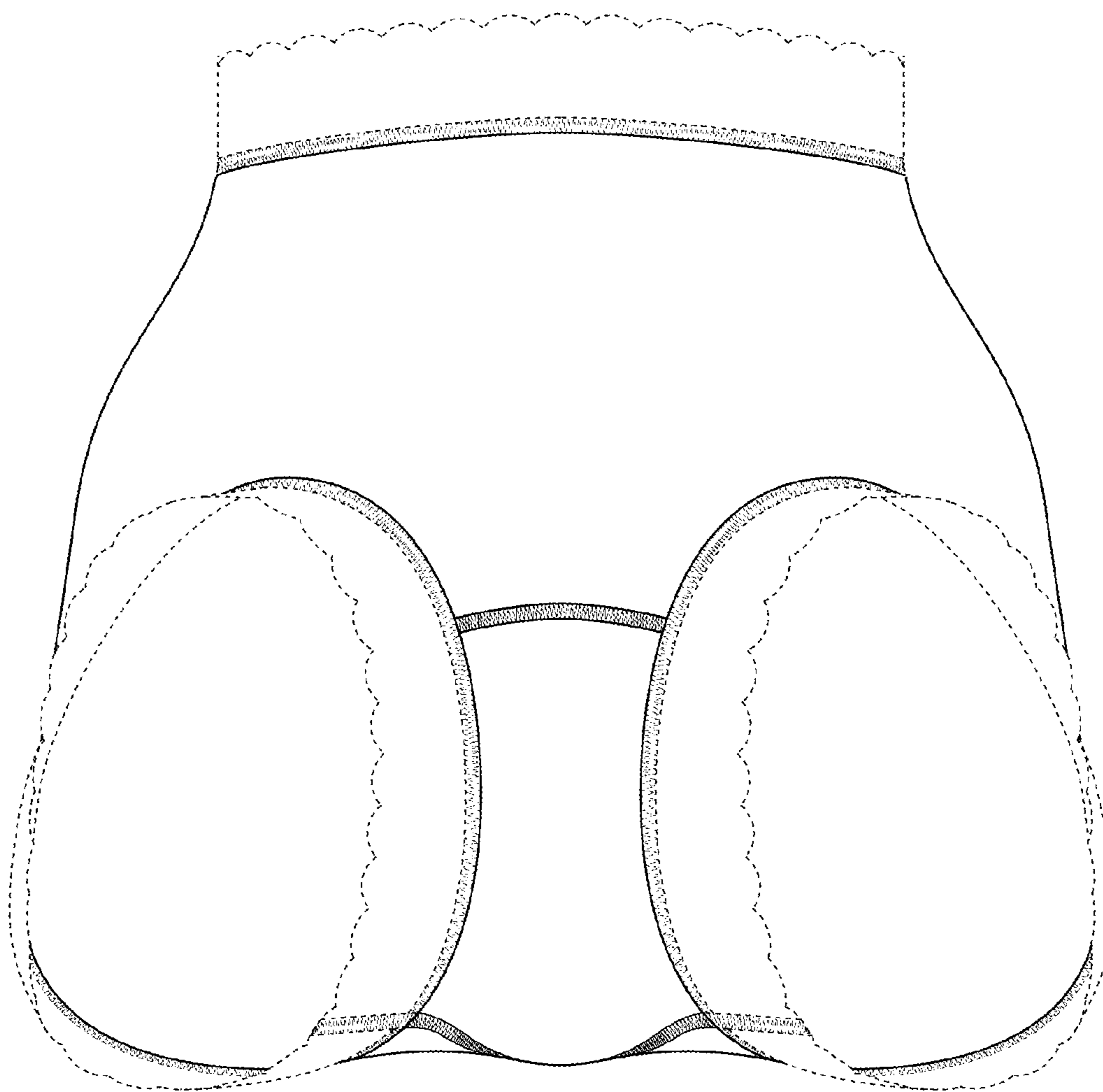

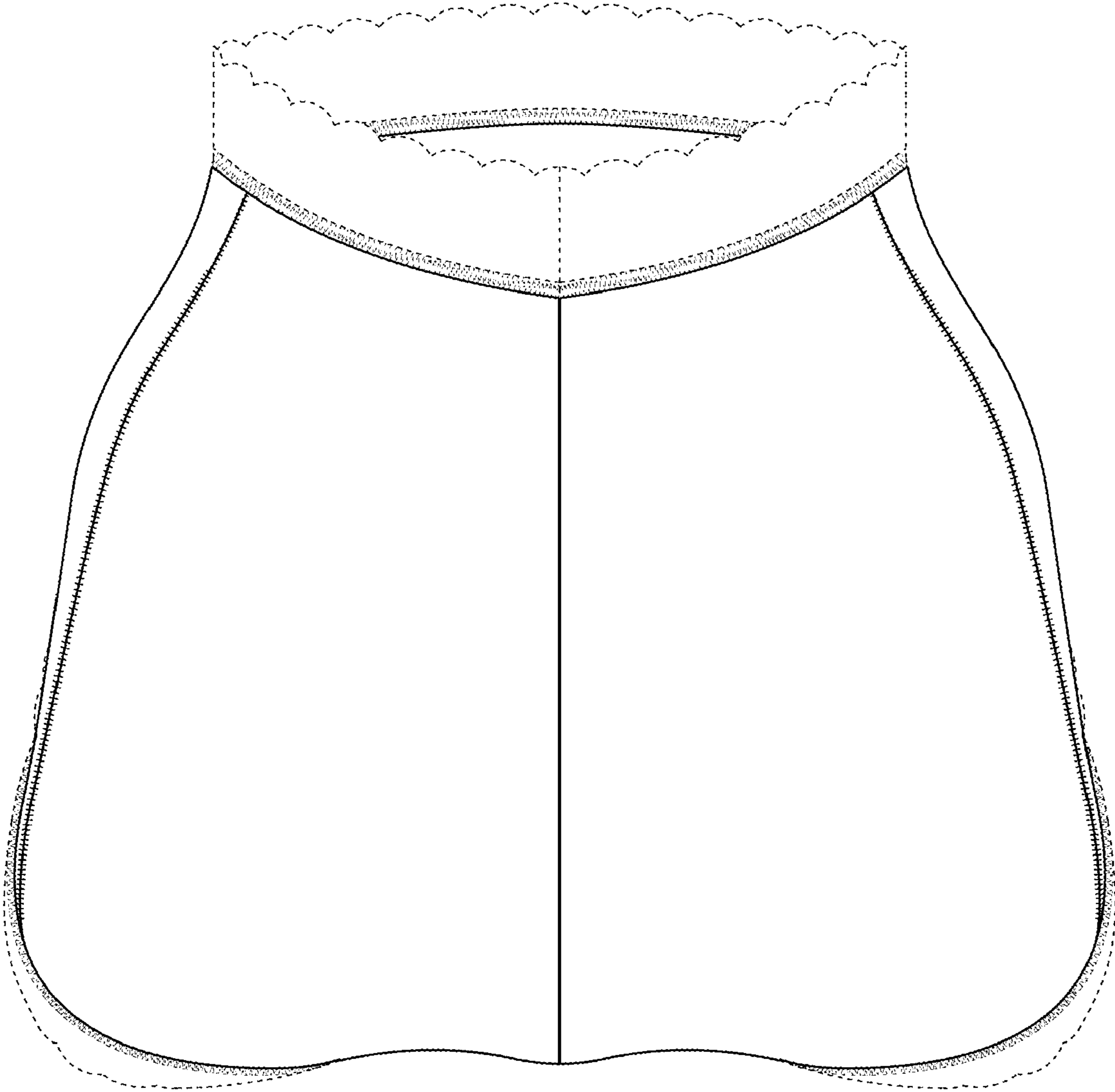

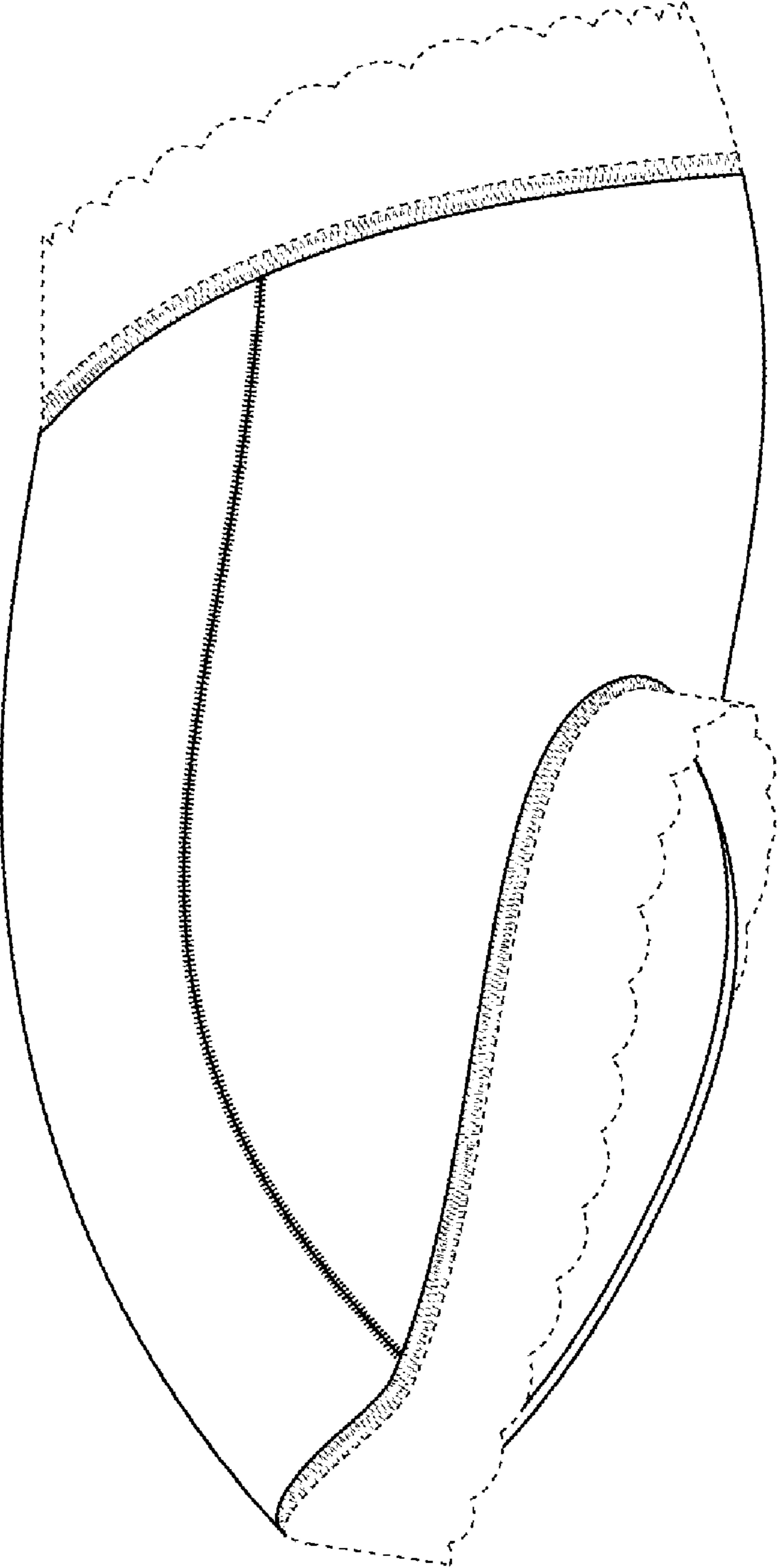

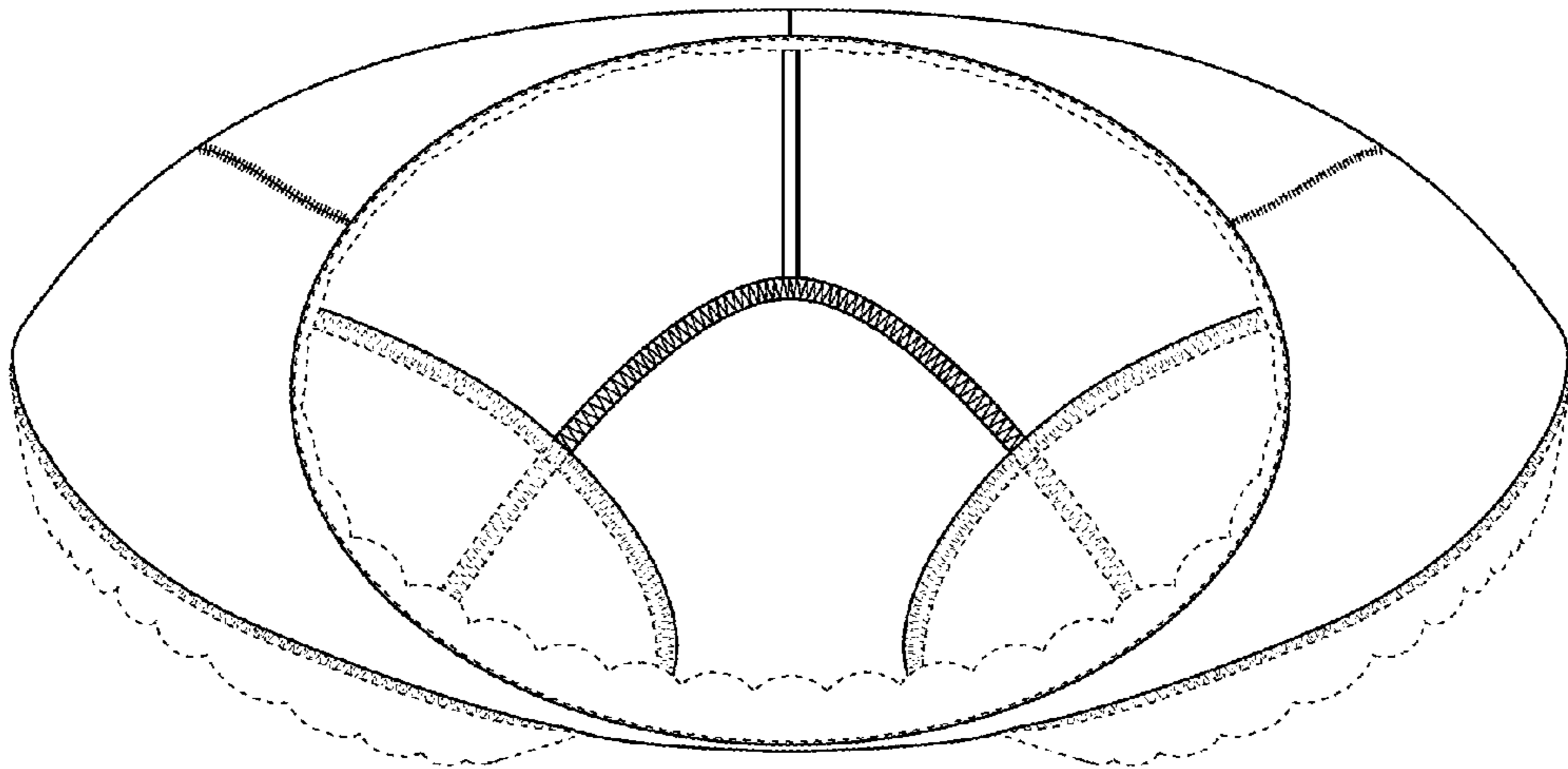
