**DESCRIPTION**

FIG. 7 is a rear elevational view thereof;

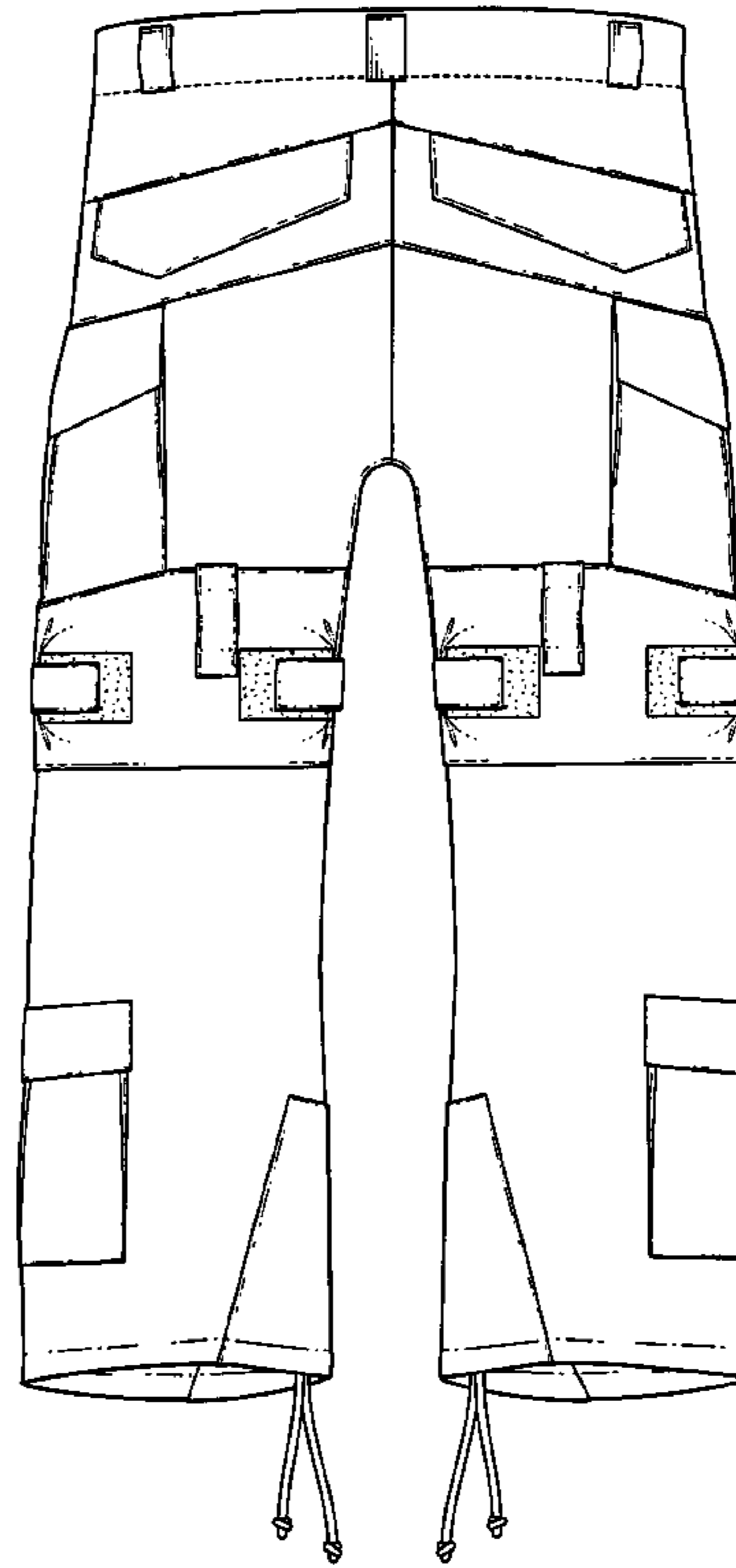
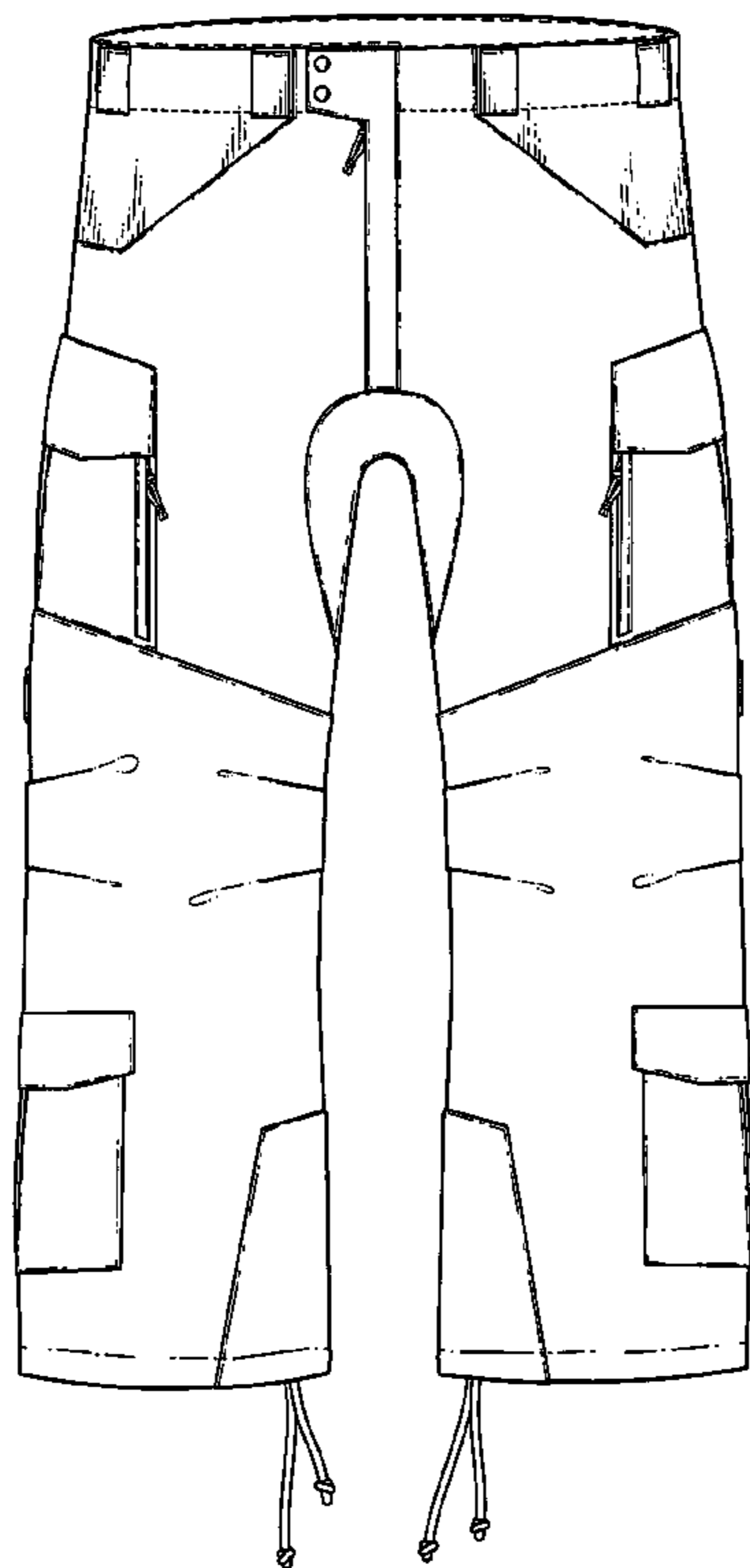
FIG. 8 is a left side elevational view thereof;

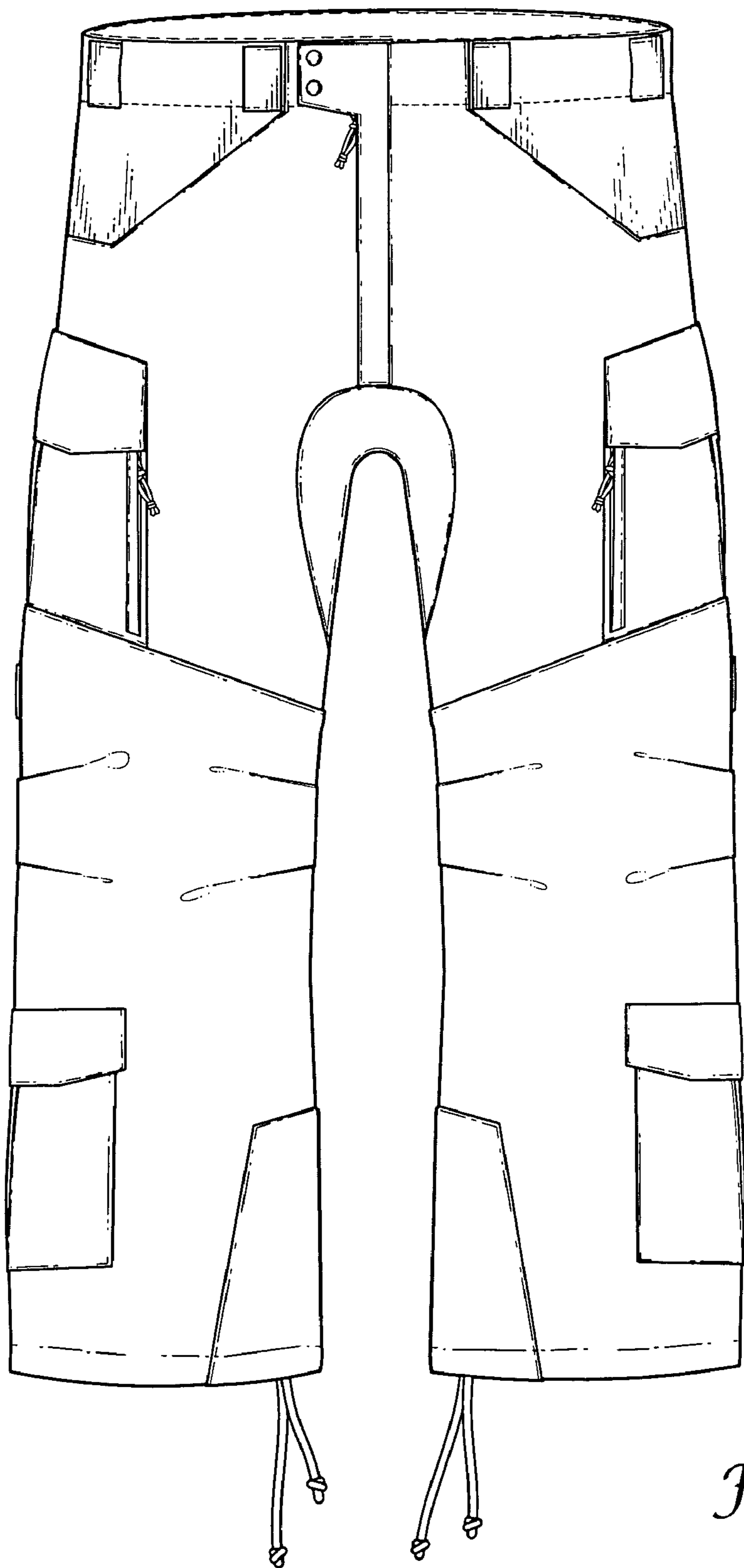
FIG. 9 is a right side elevational view thereof; and,

FIG. 10 is a partial left side elevational thereof.

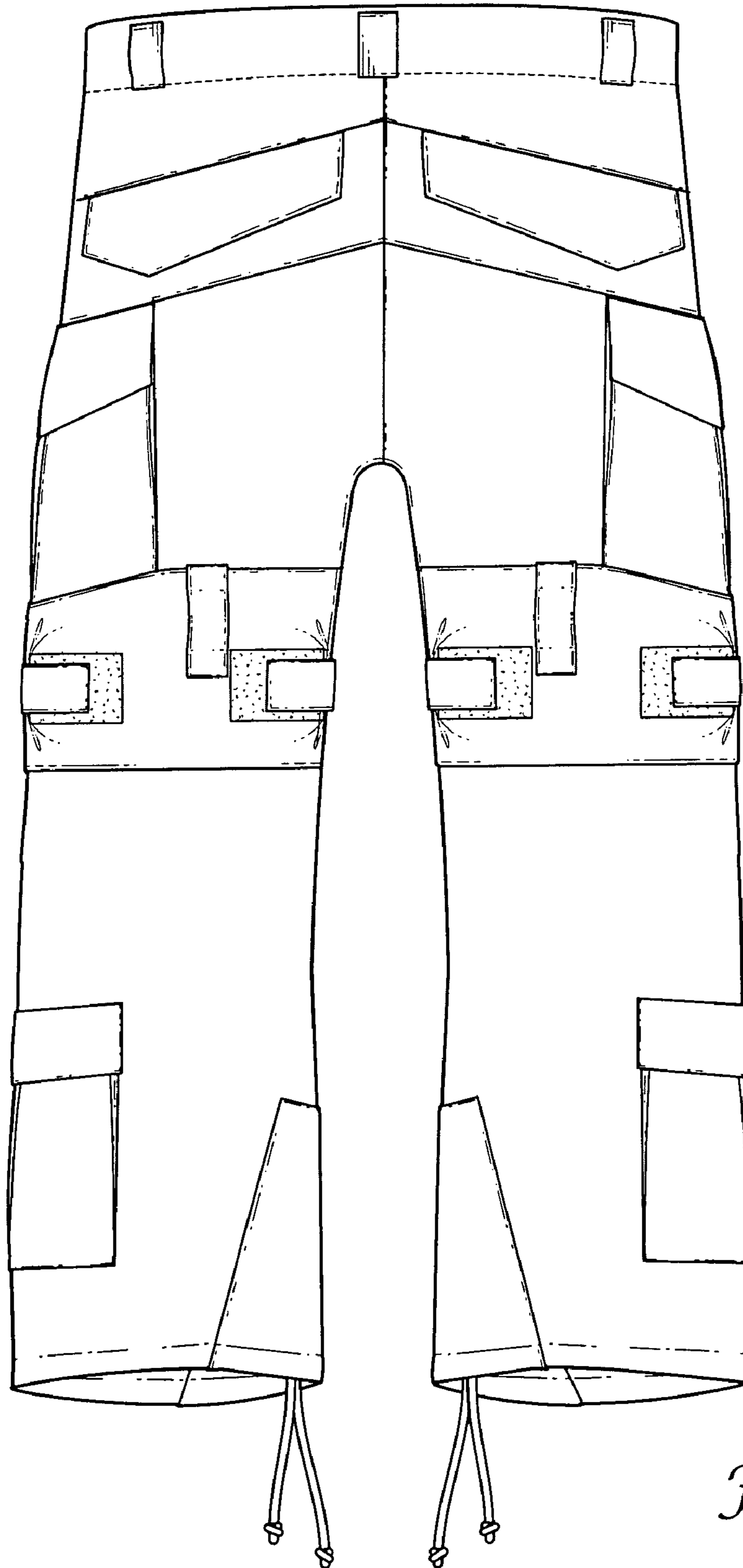
Throughout the views, the broken lines represent the portions of the pants, which form no part of the claimed design.

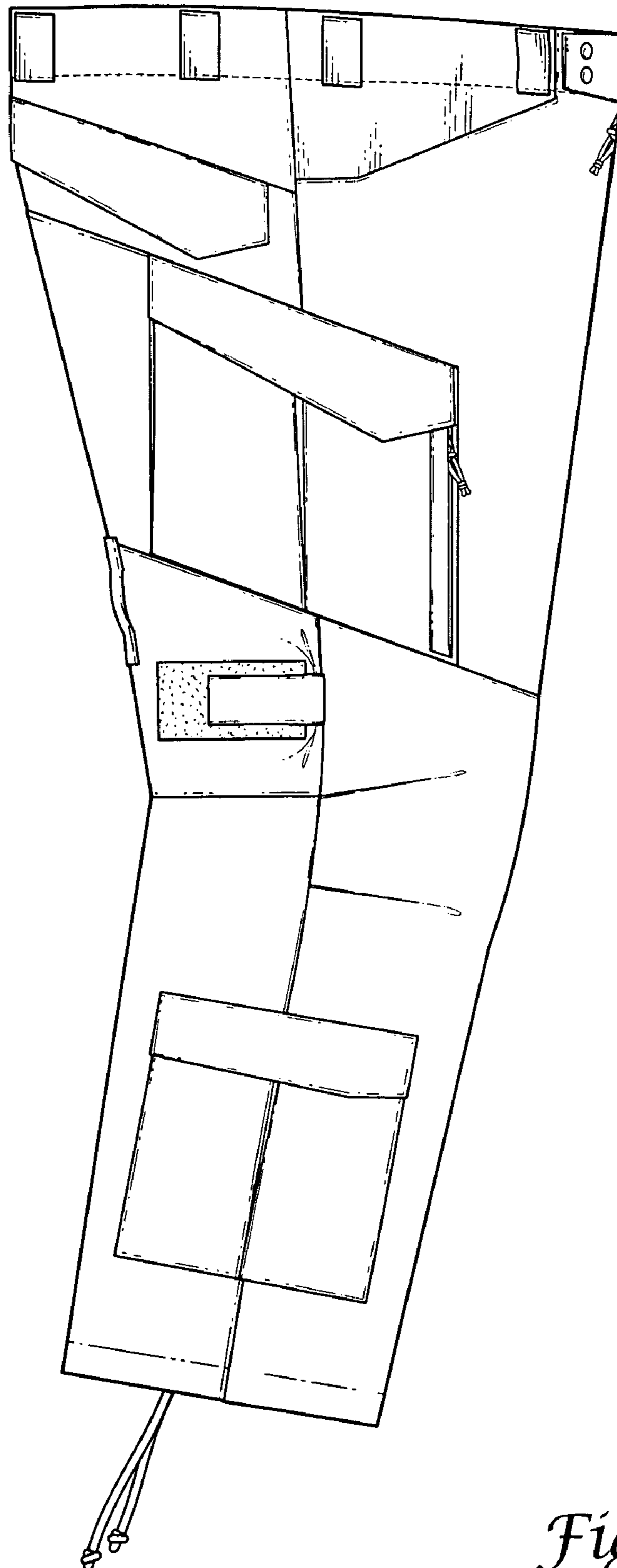




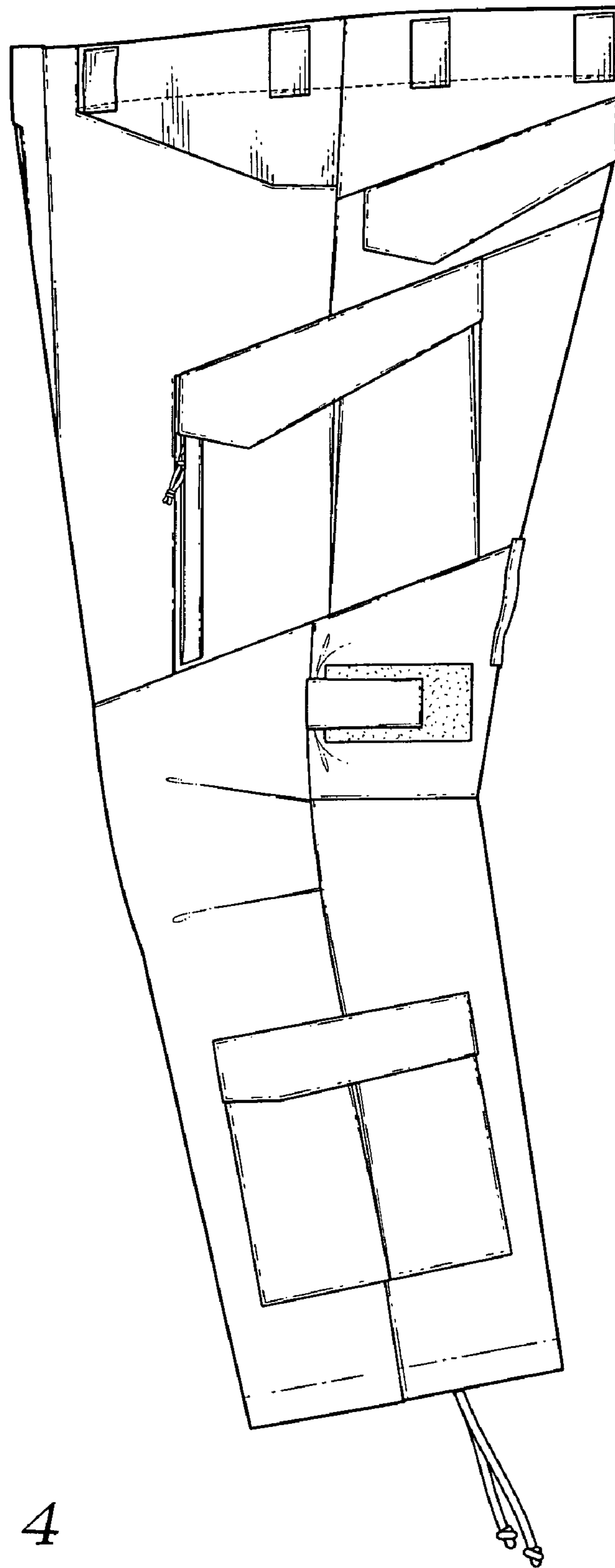

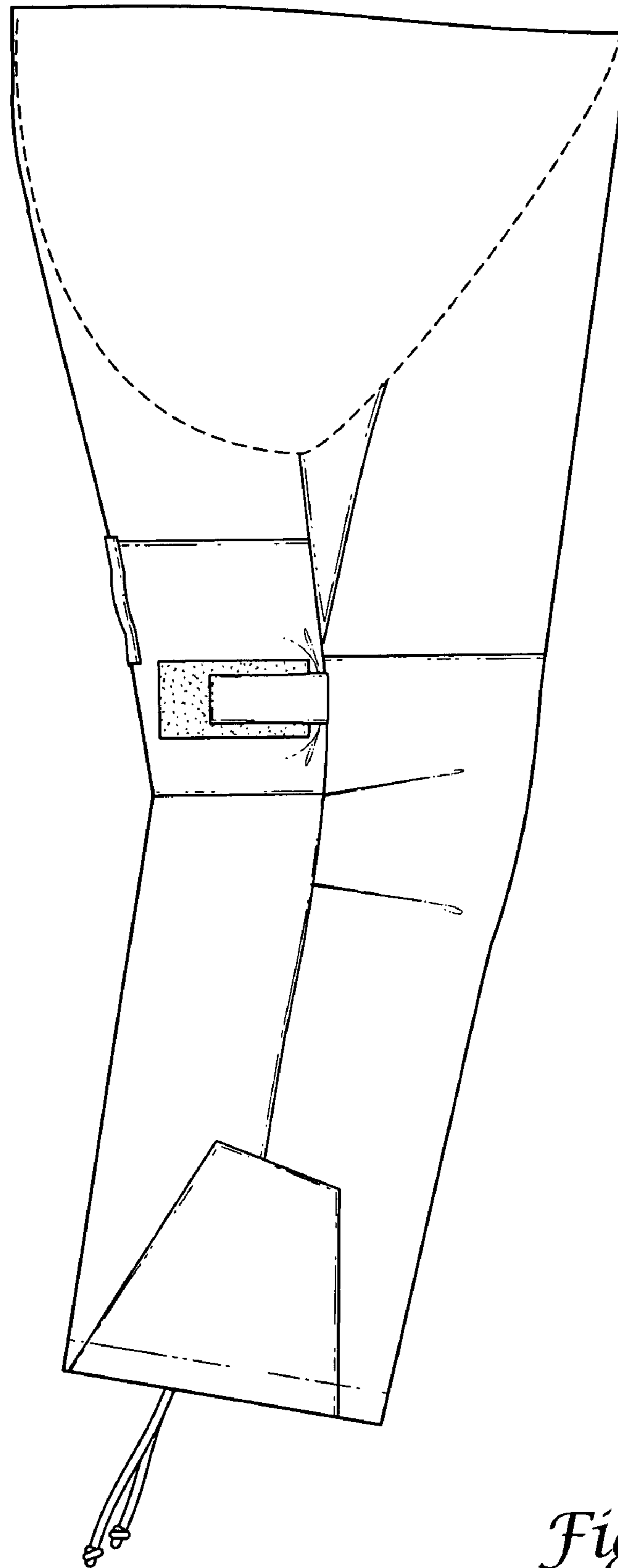

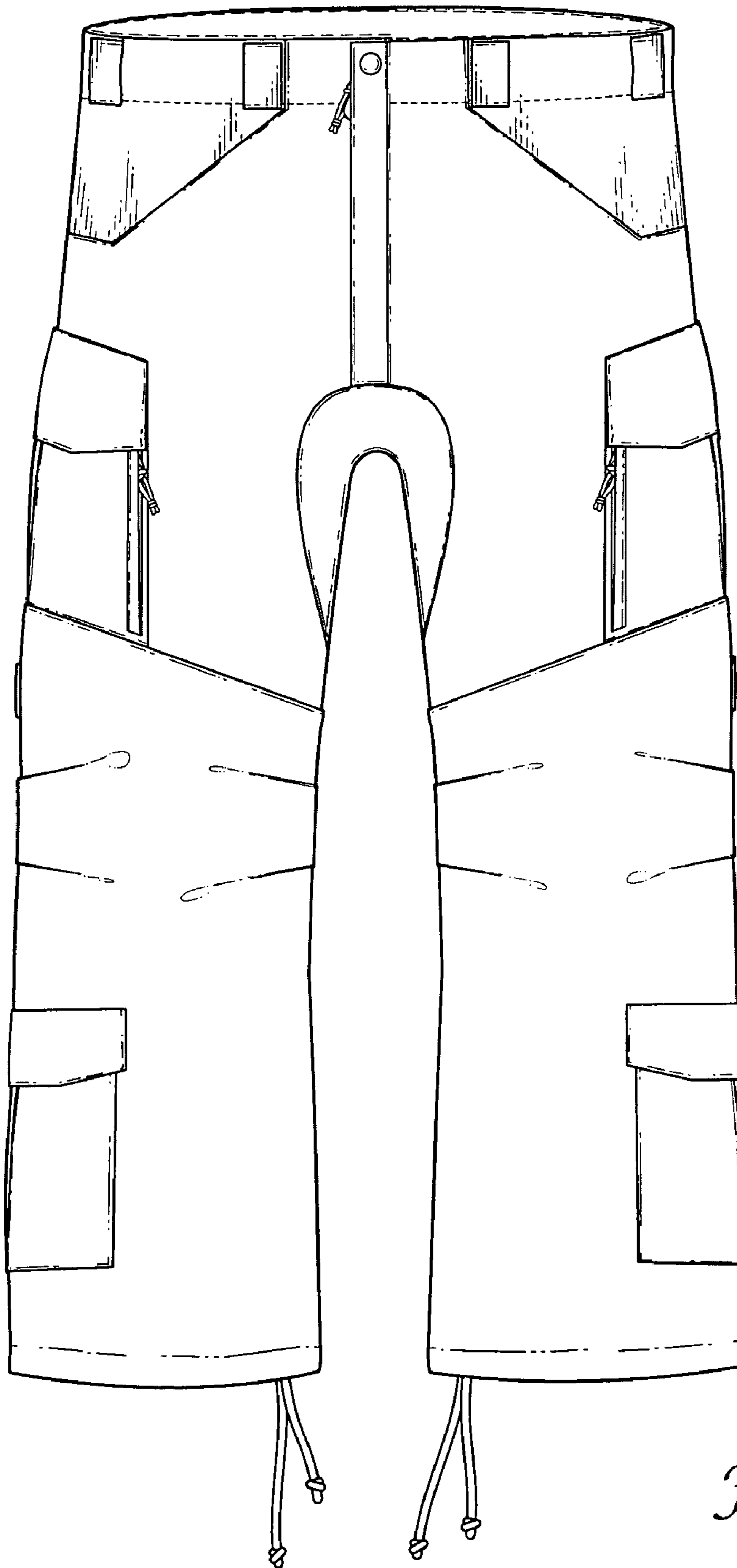

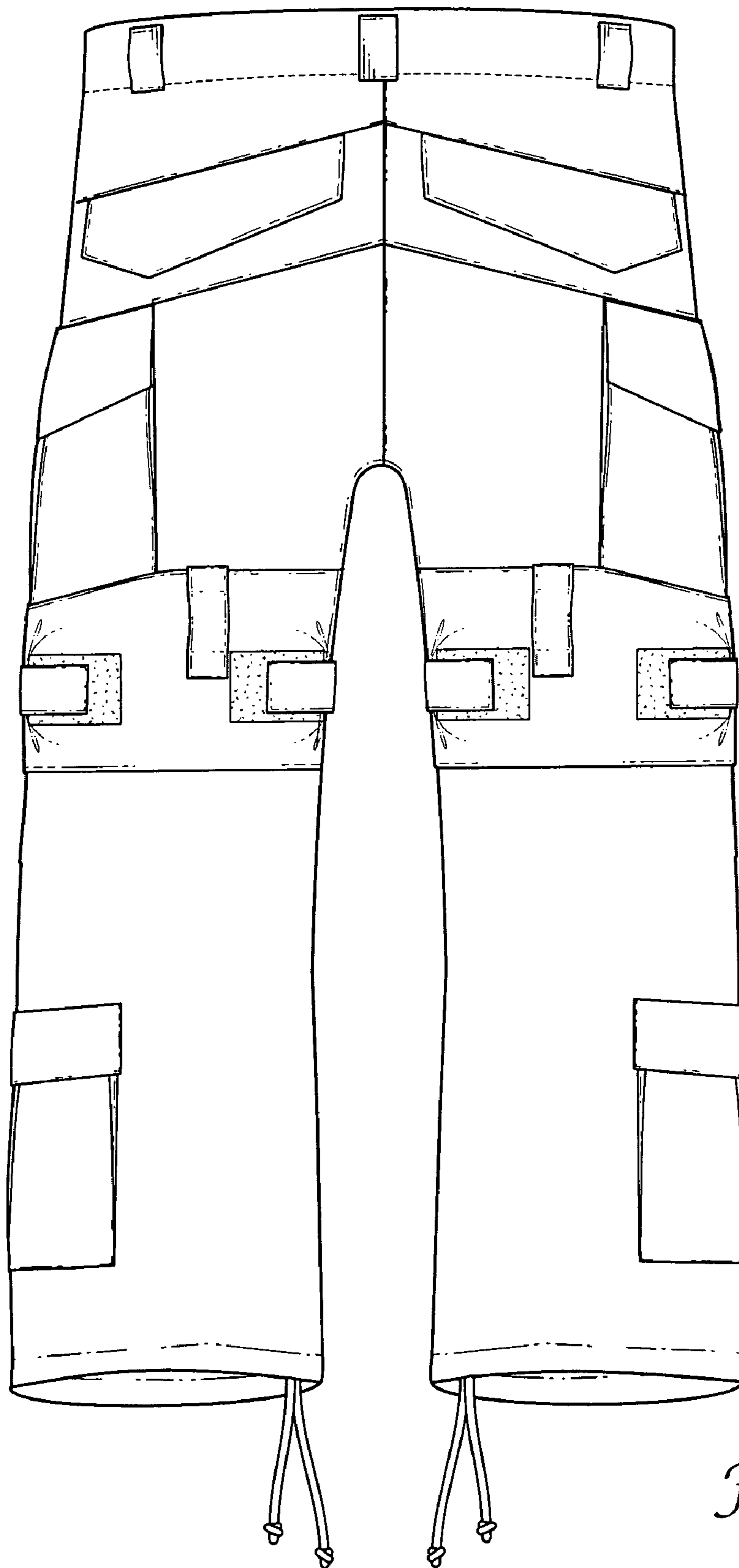

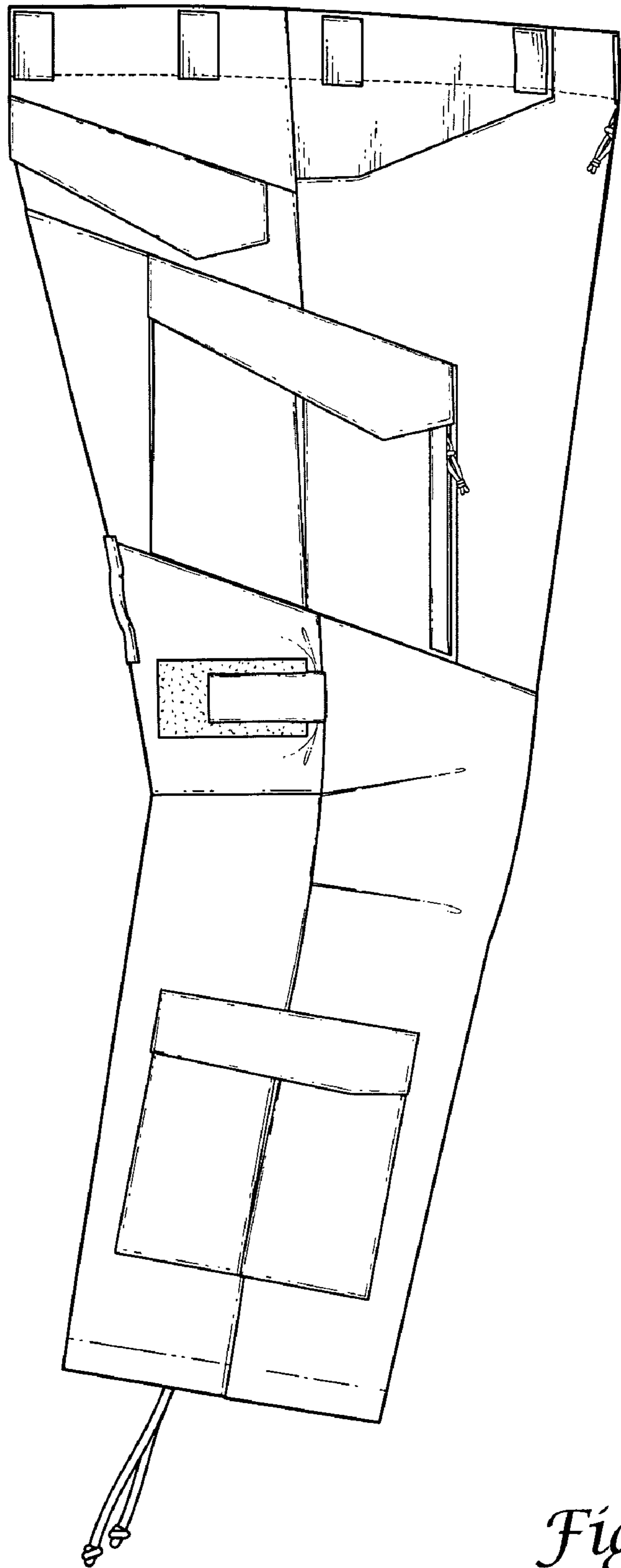

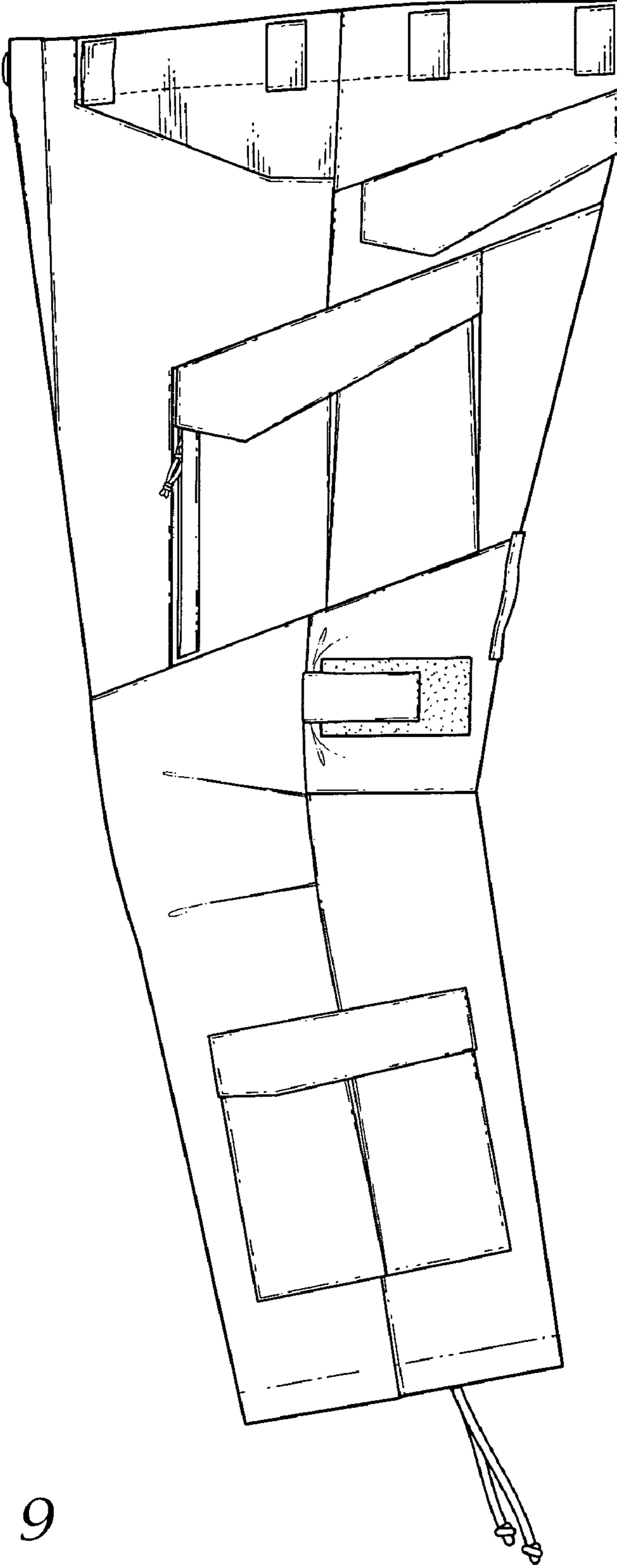

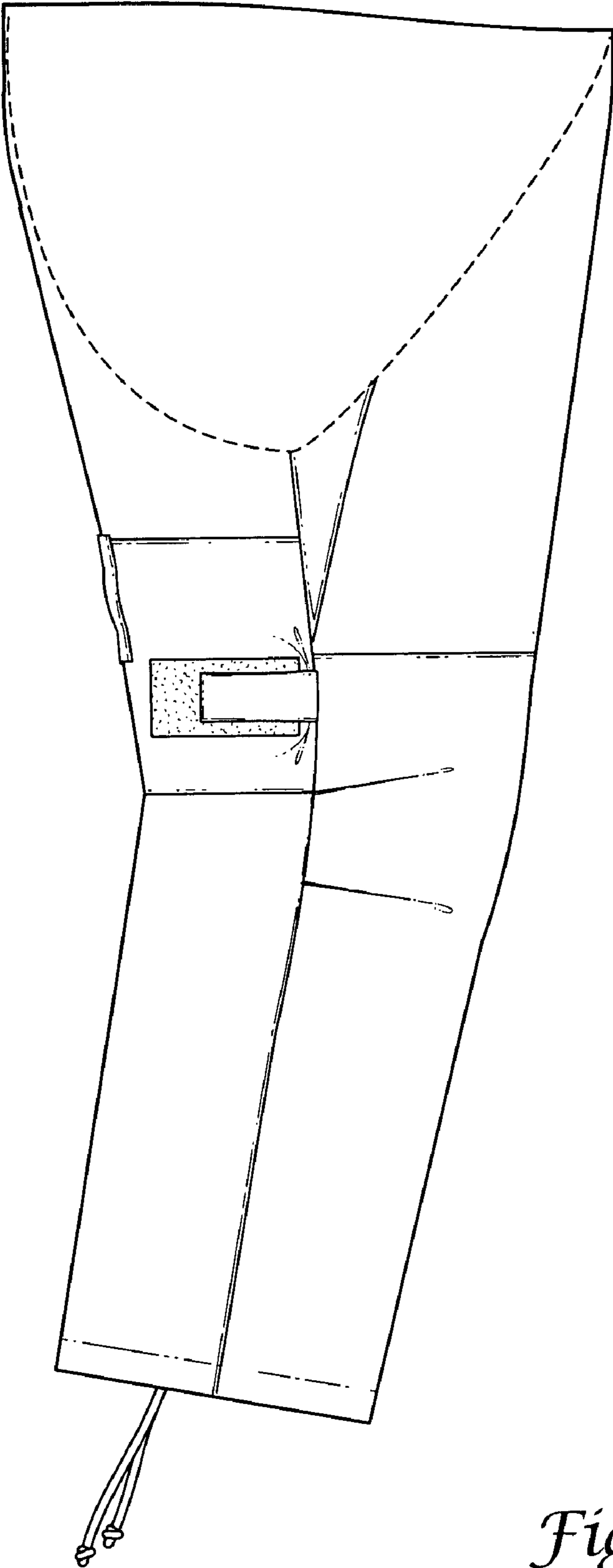
