(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a new design for a shoe; and,

FIG. 2 is a left elevation view thereof.

The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are included for the purpose of illustrating the unclaimed portions of the article; the broken lines form no part of the claimed design.

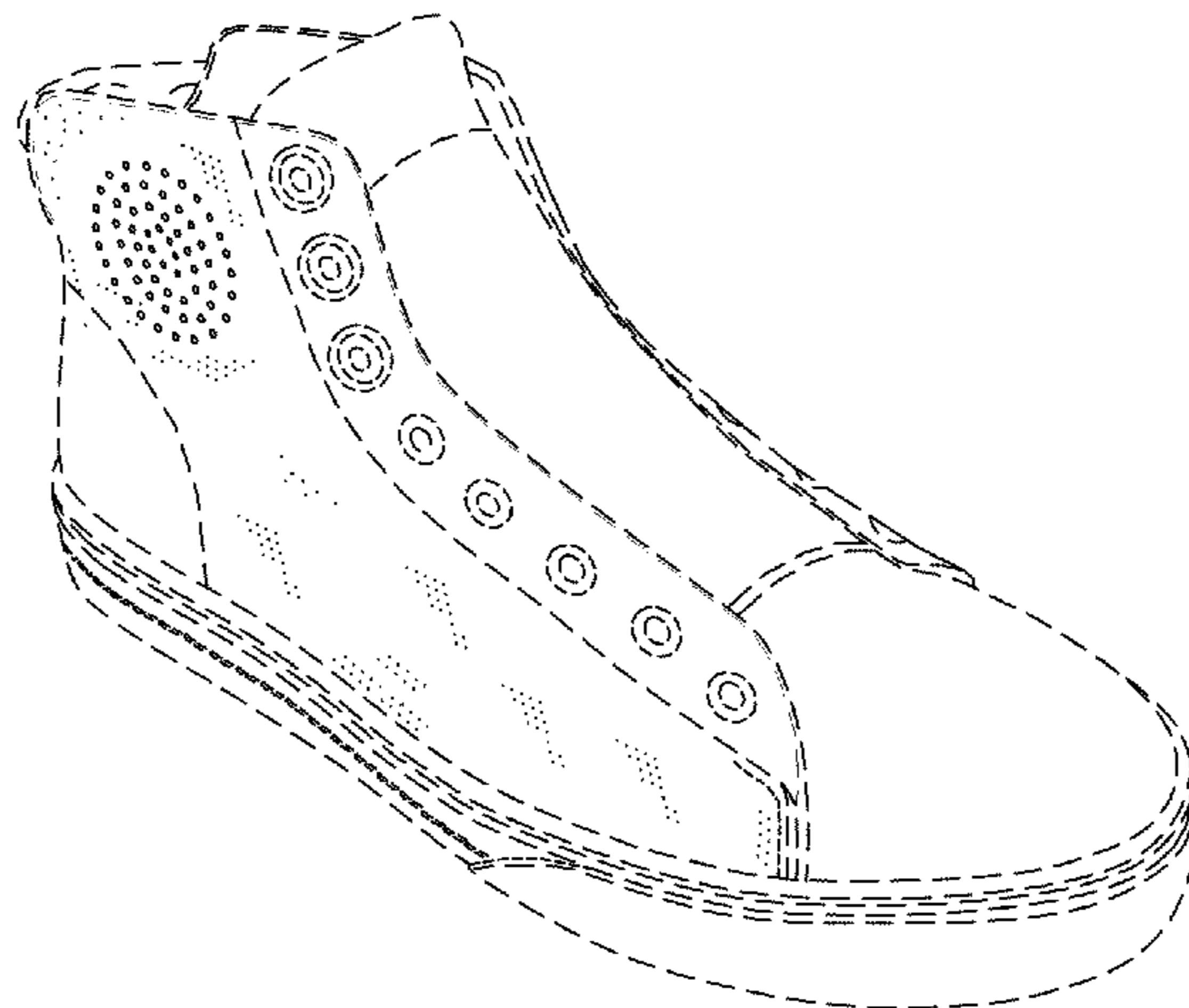

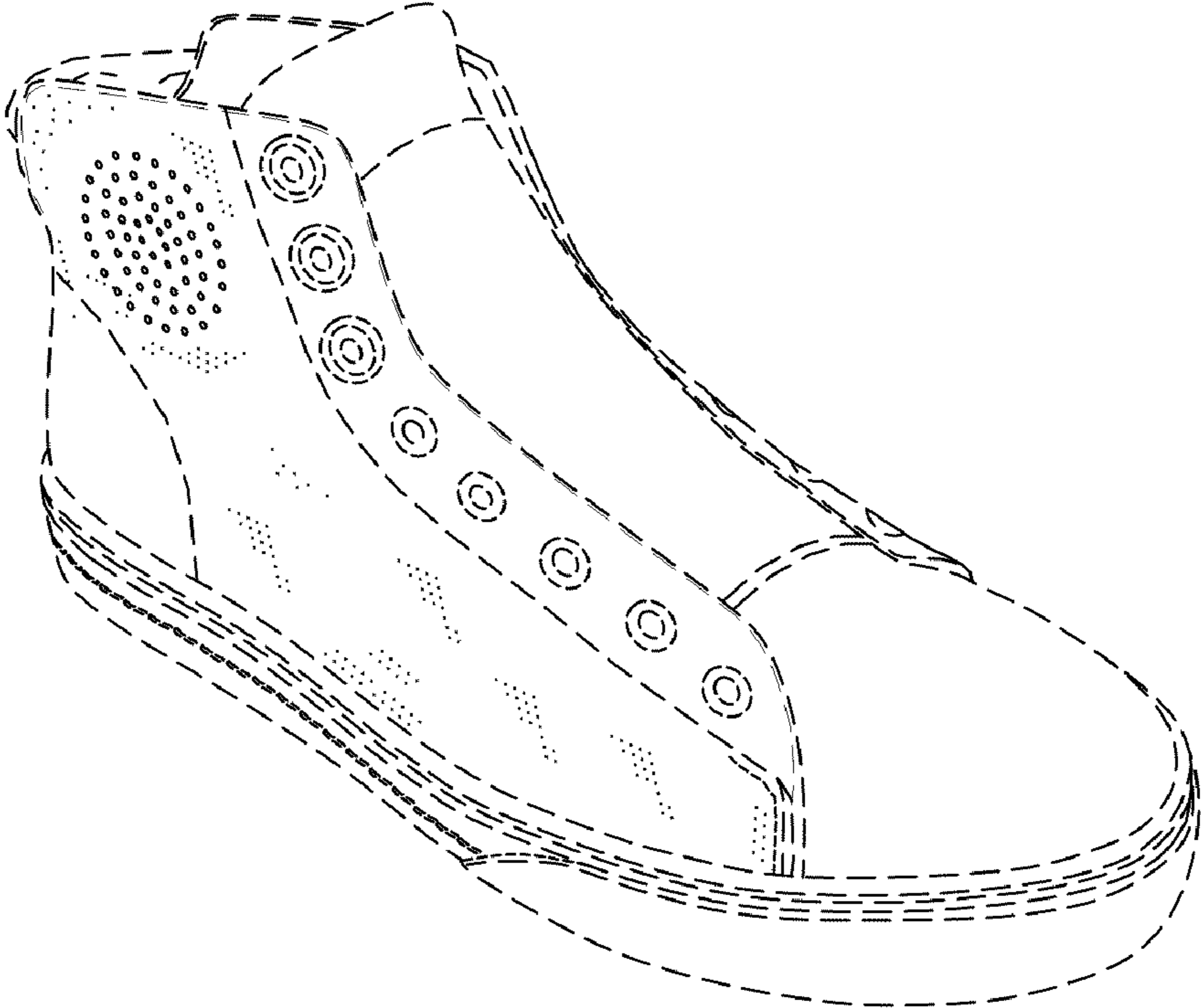
