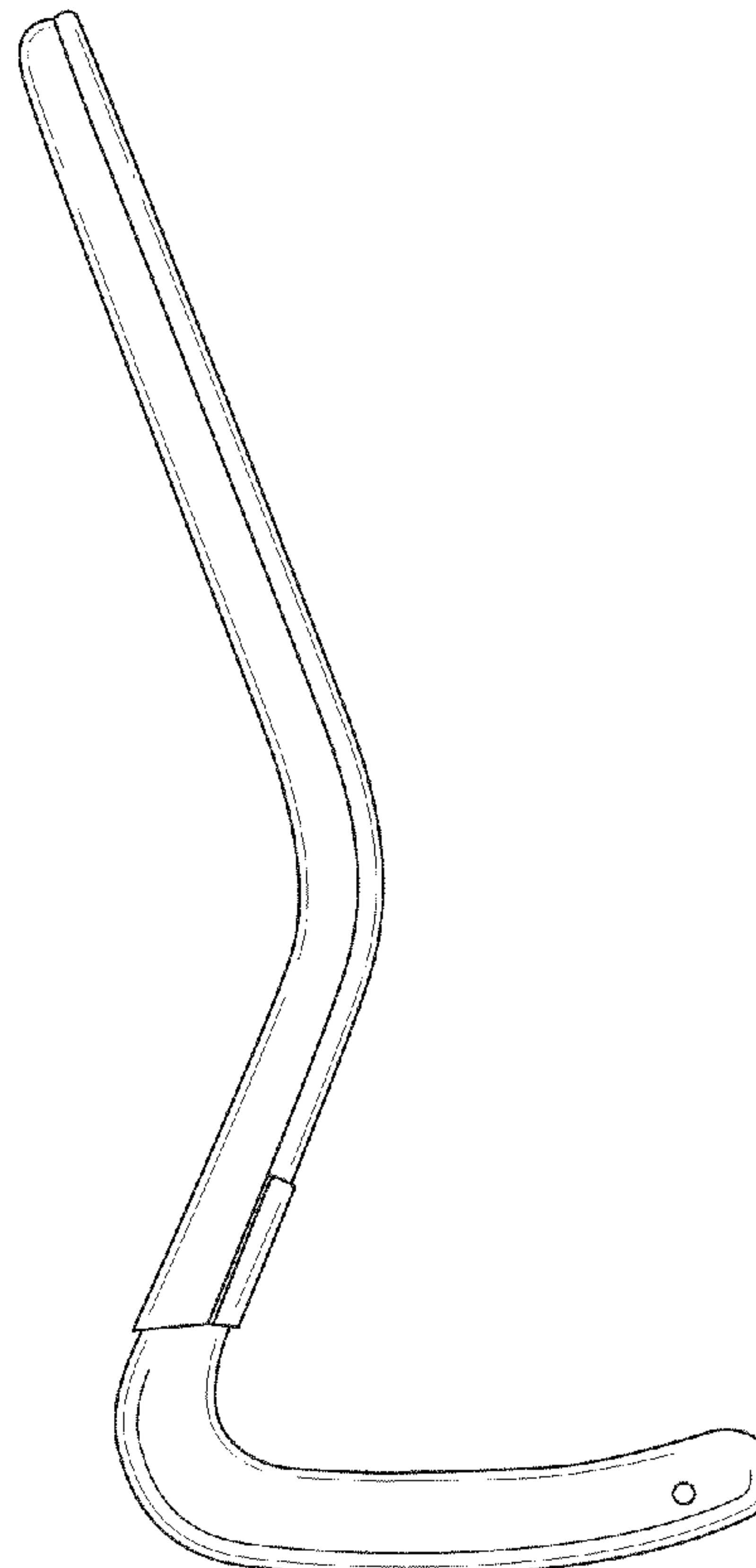
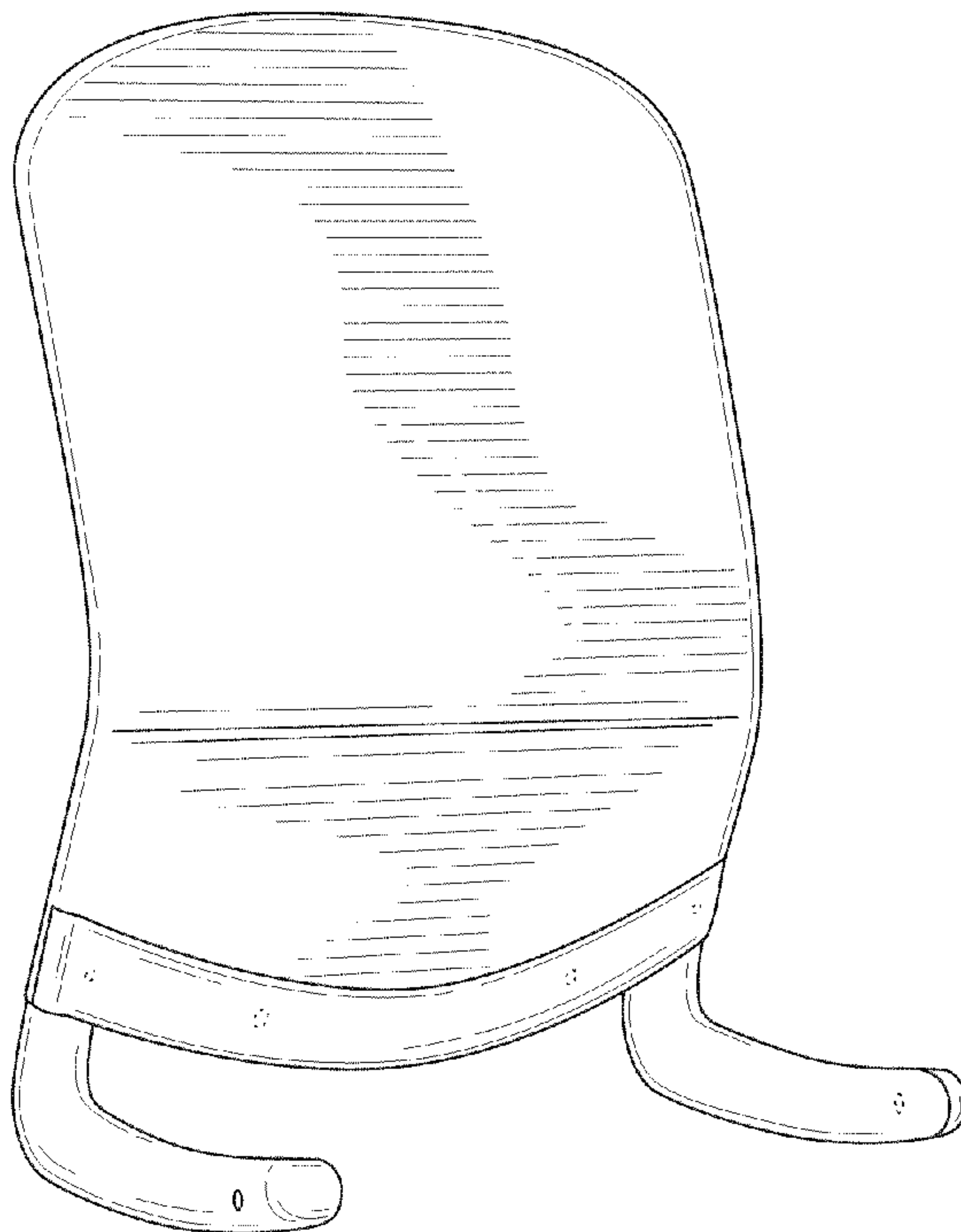
The ornamental design for chair back, as shown and described.

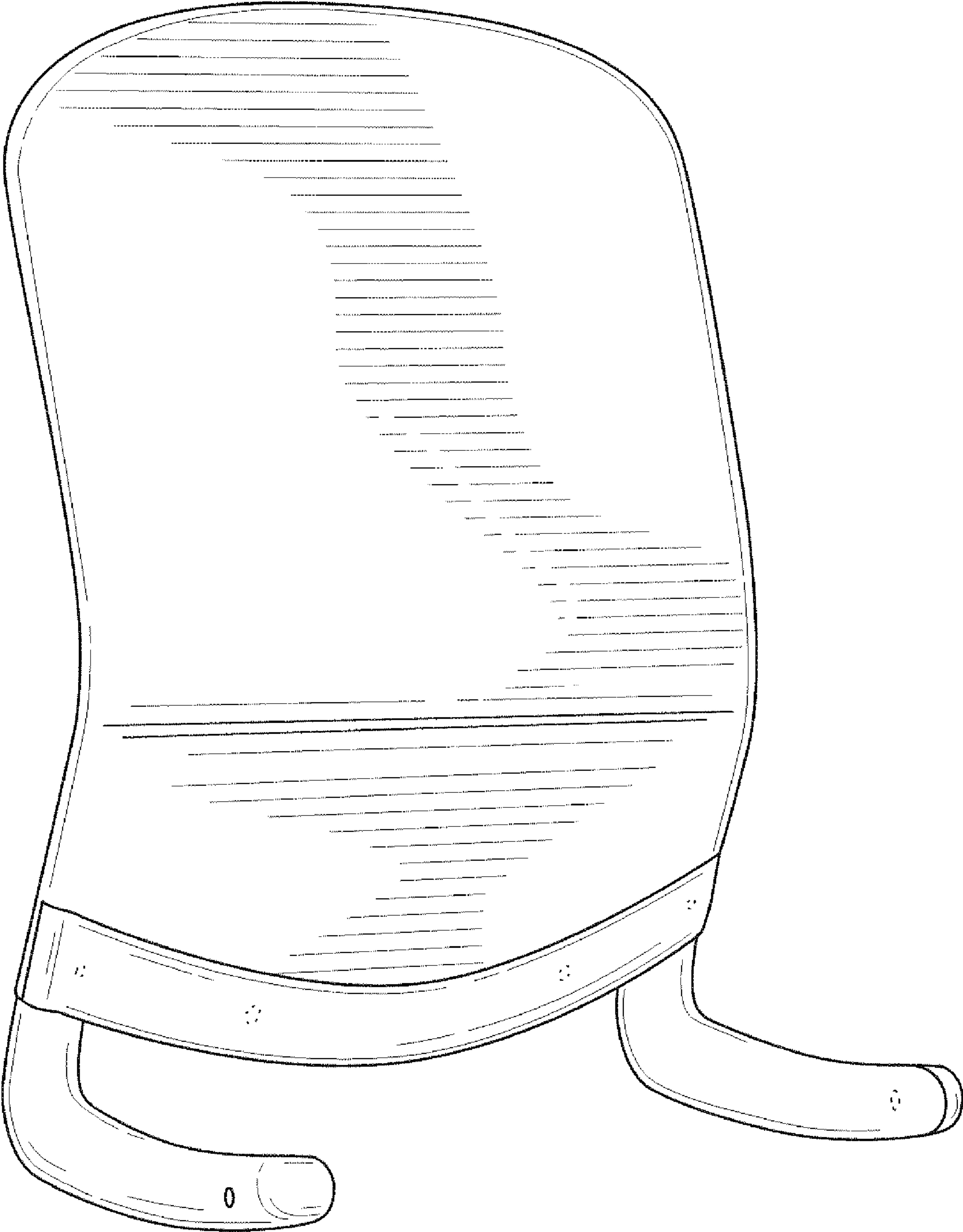

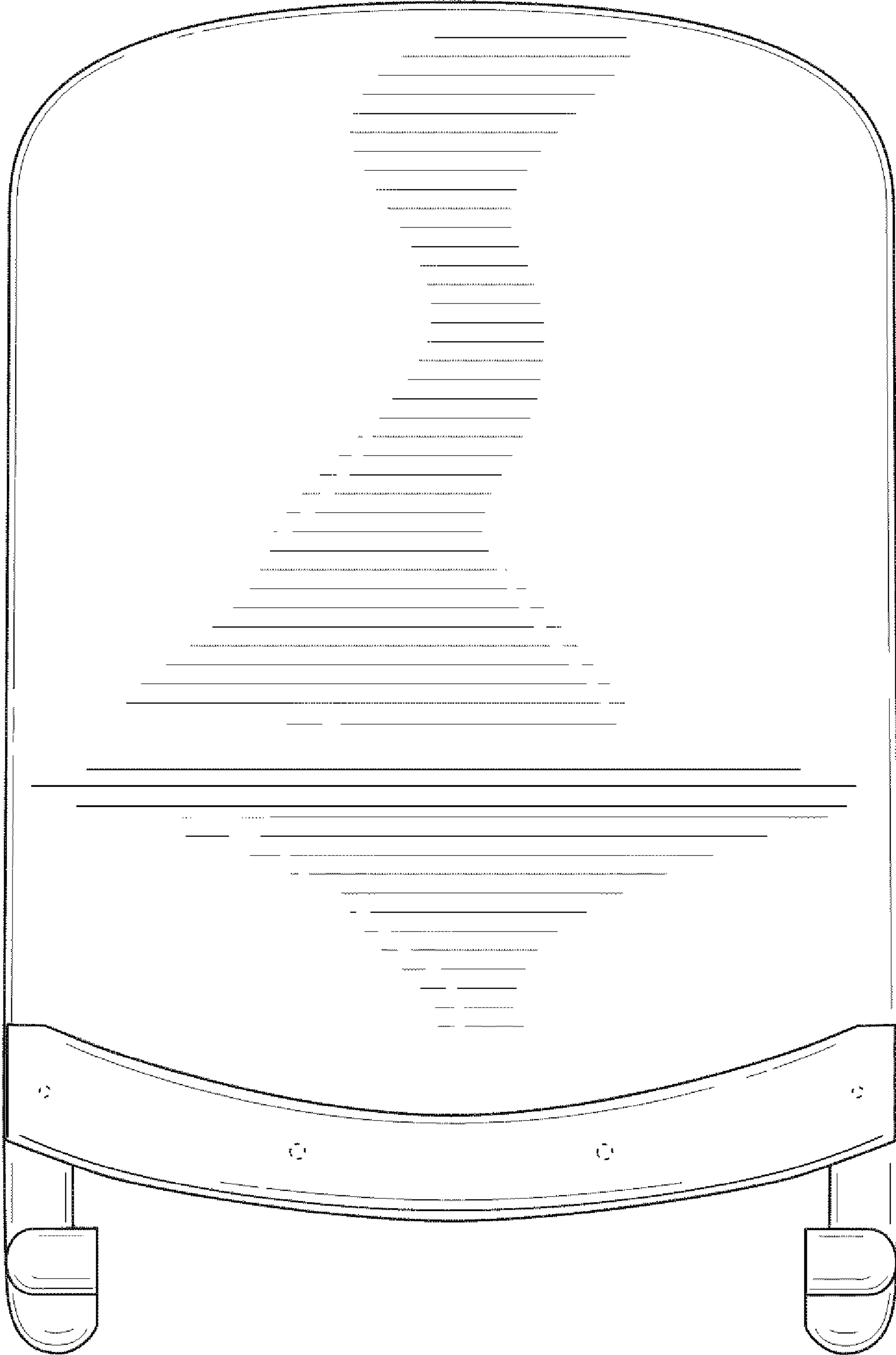

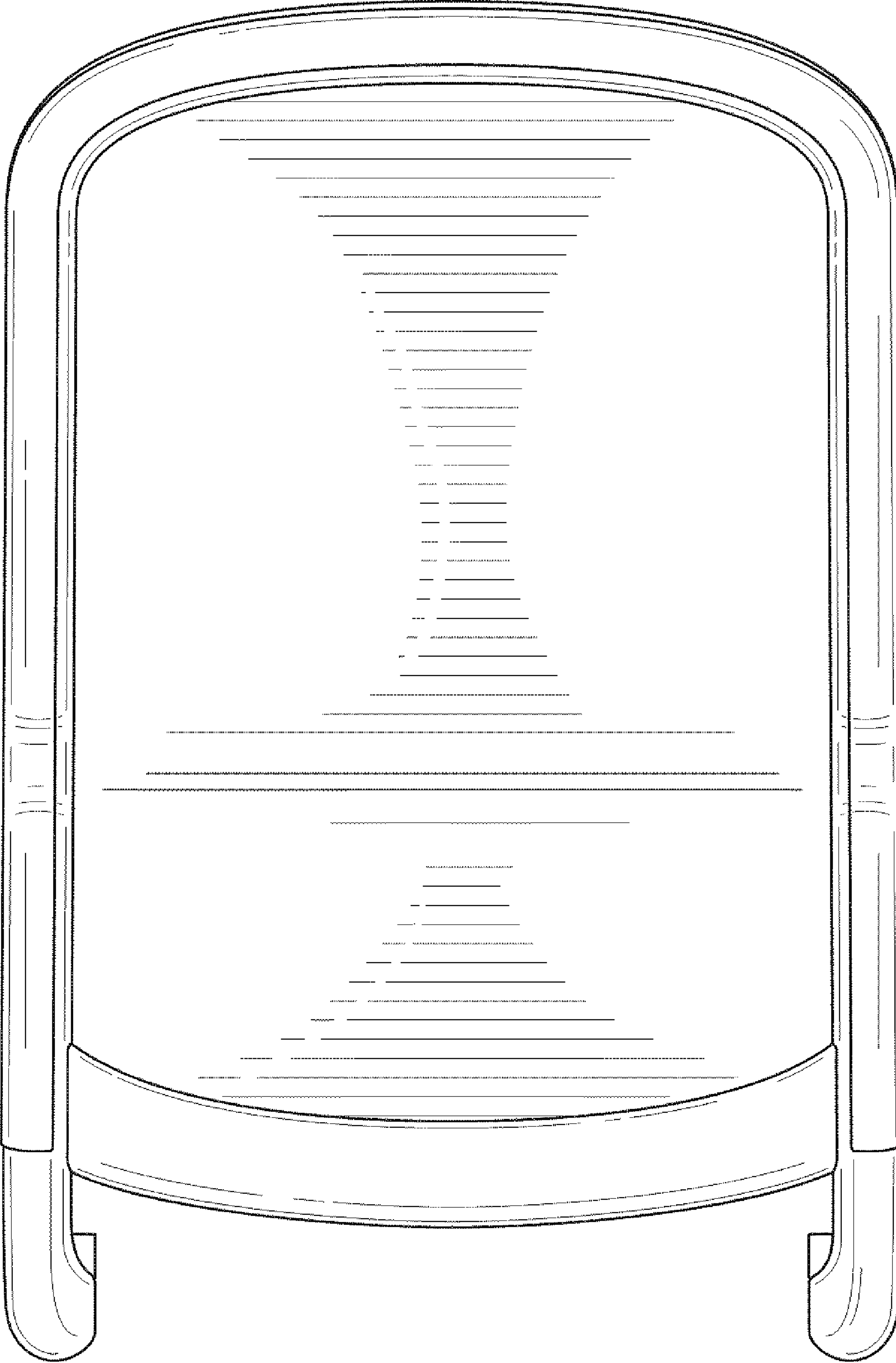

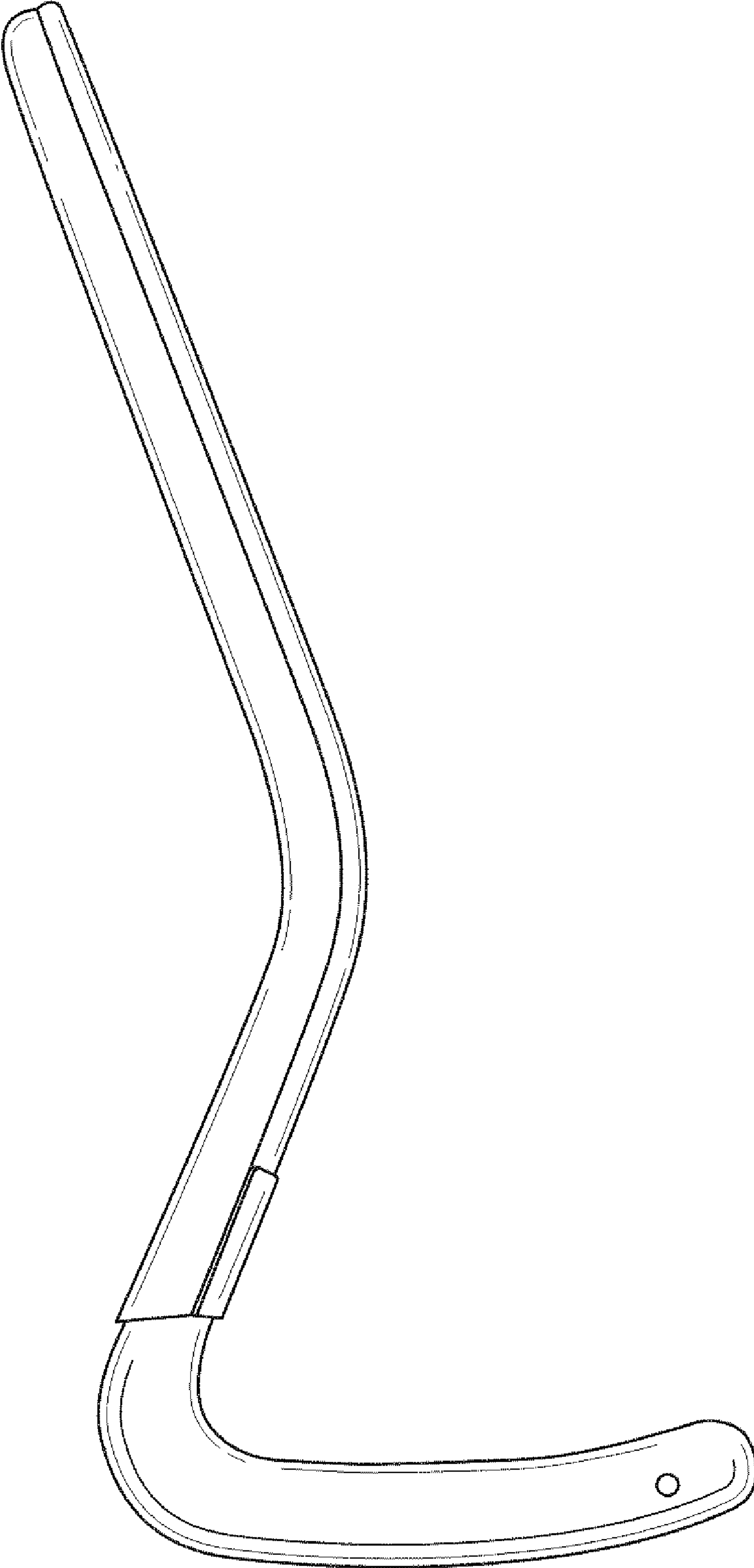

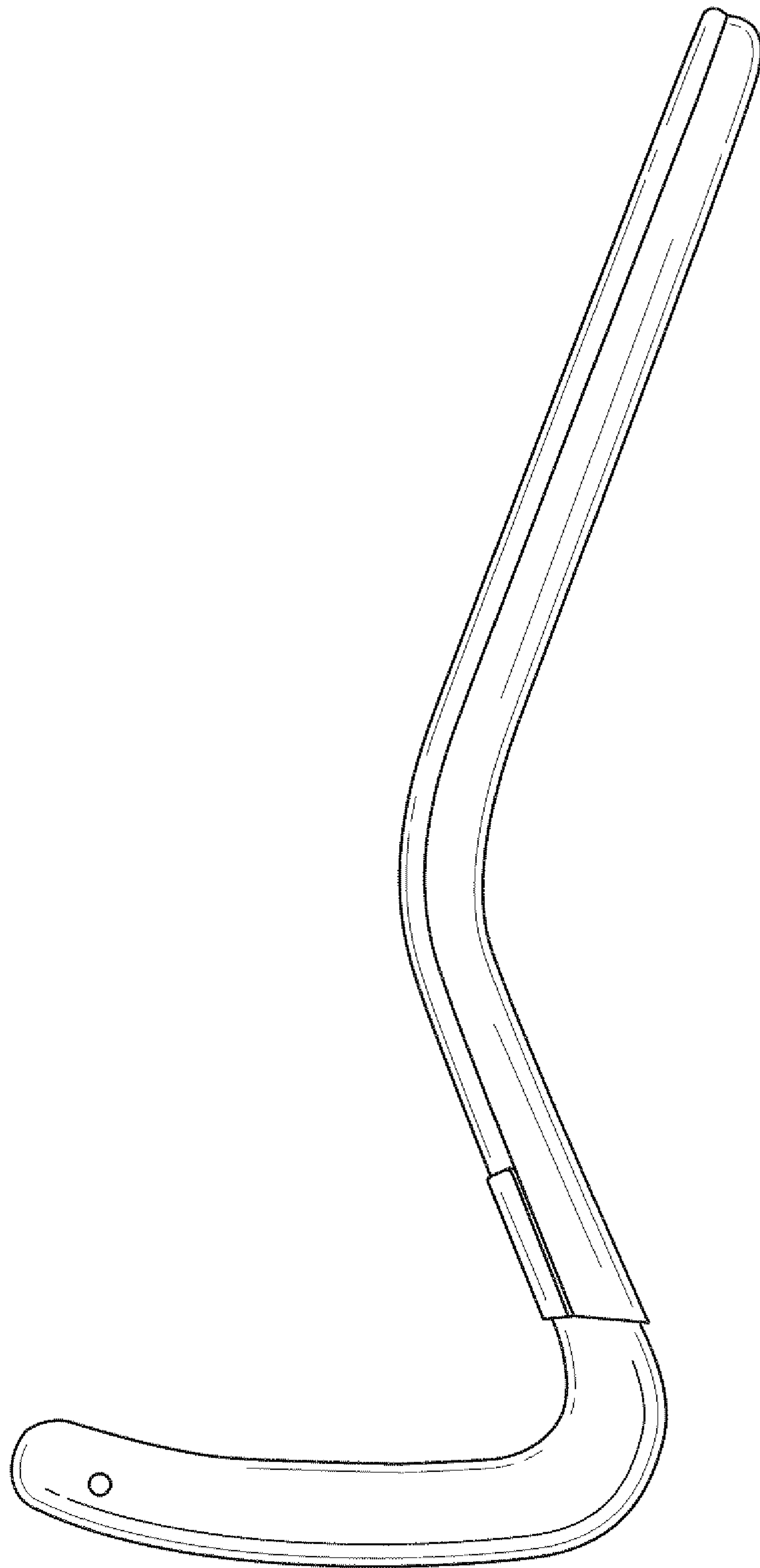

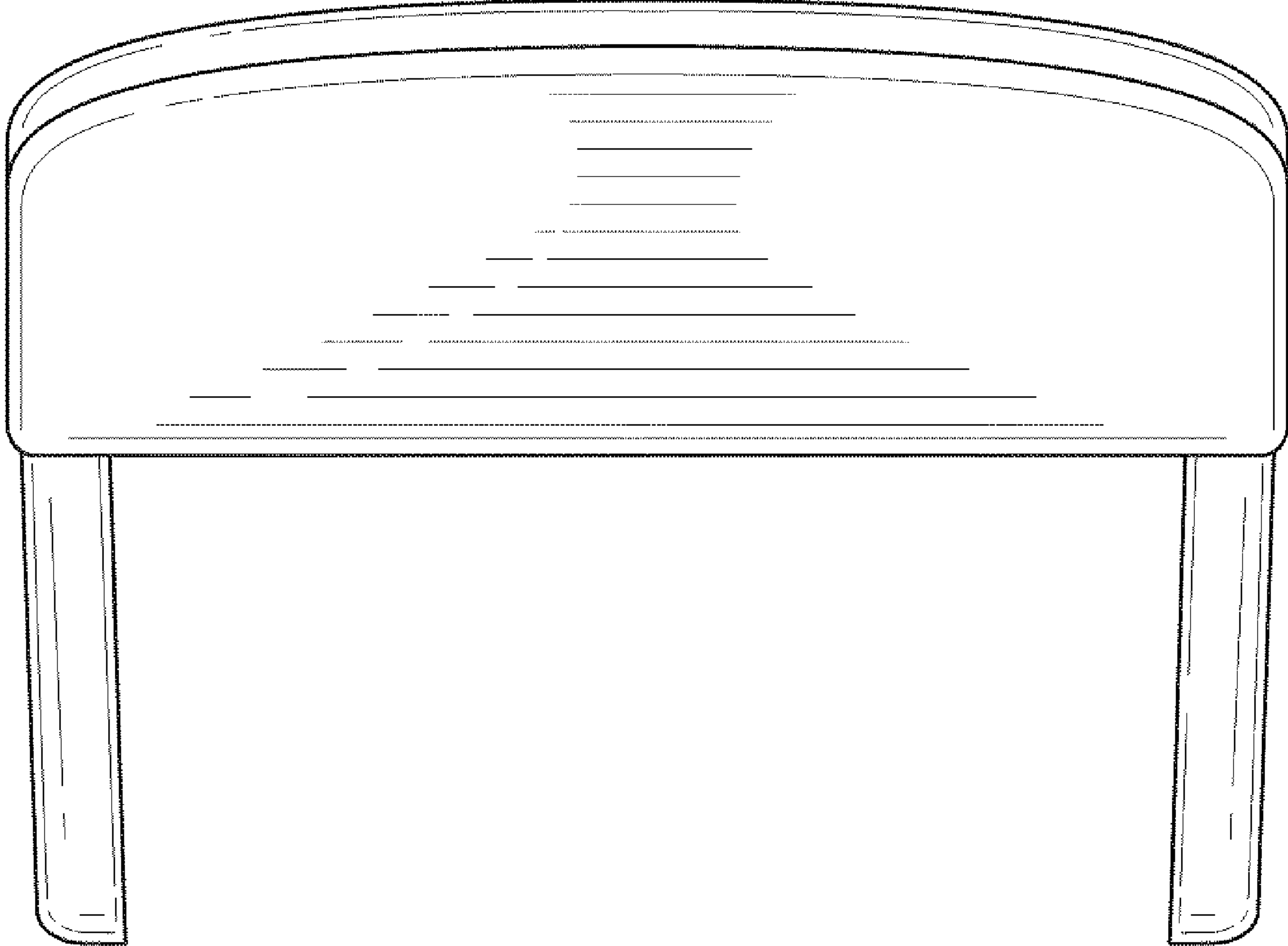

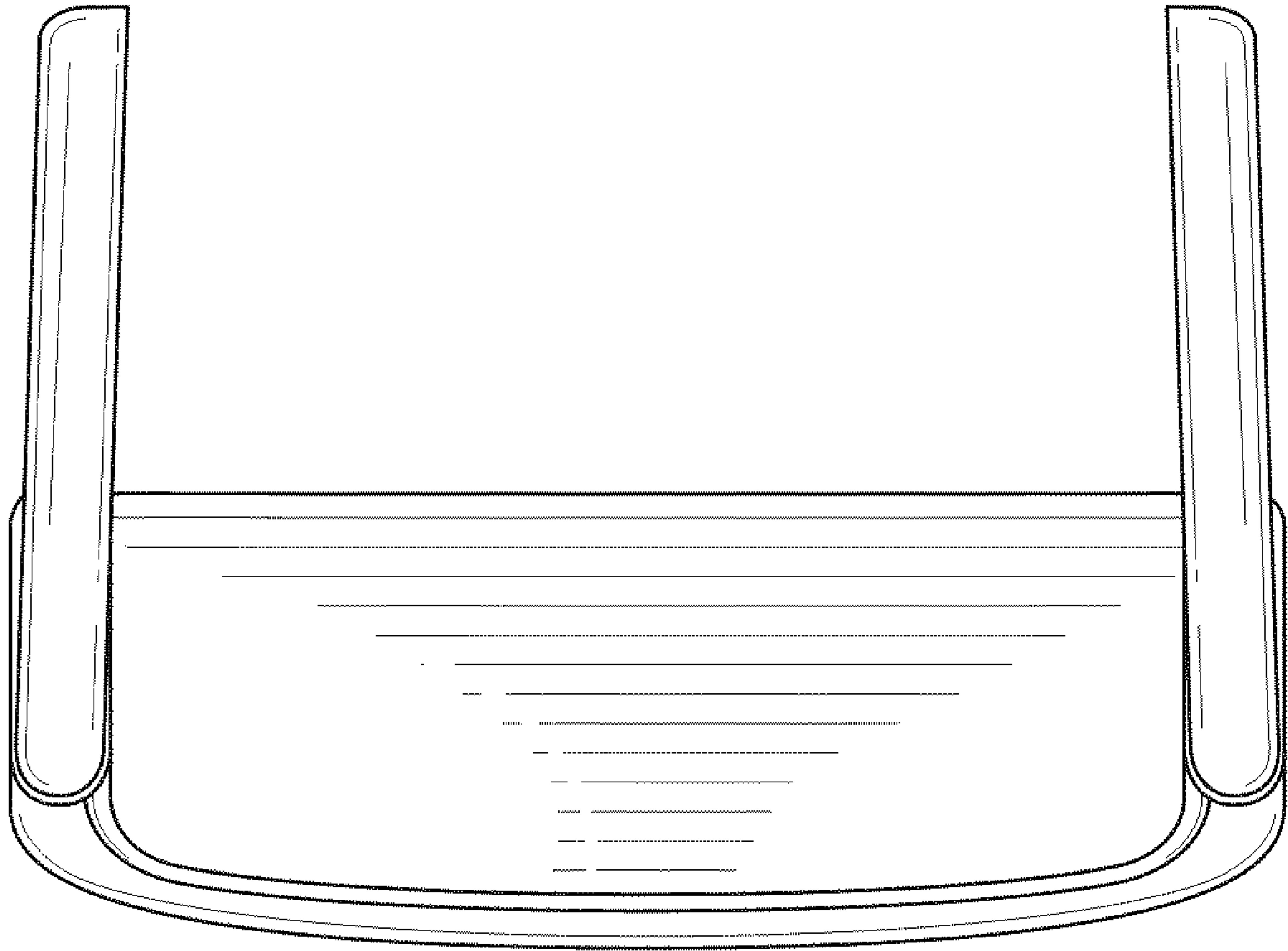
