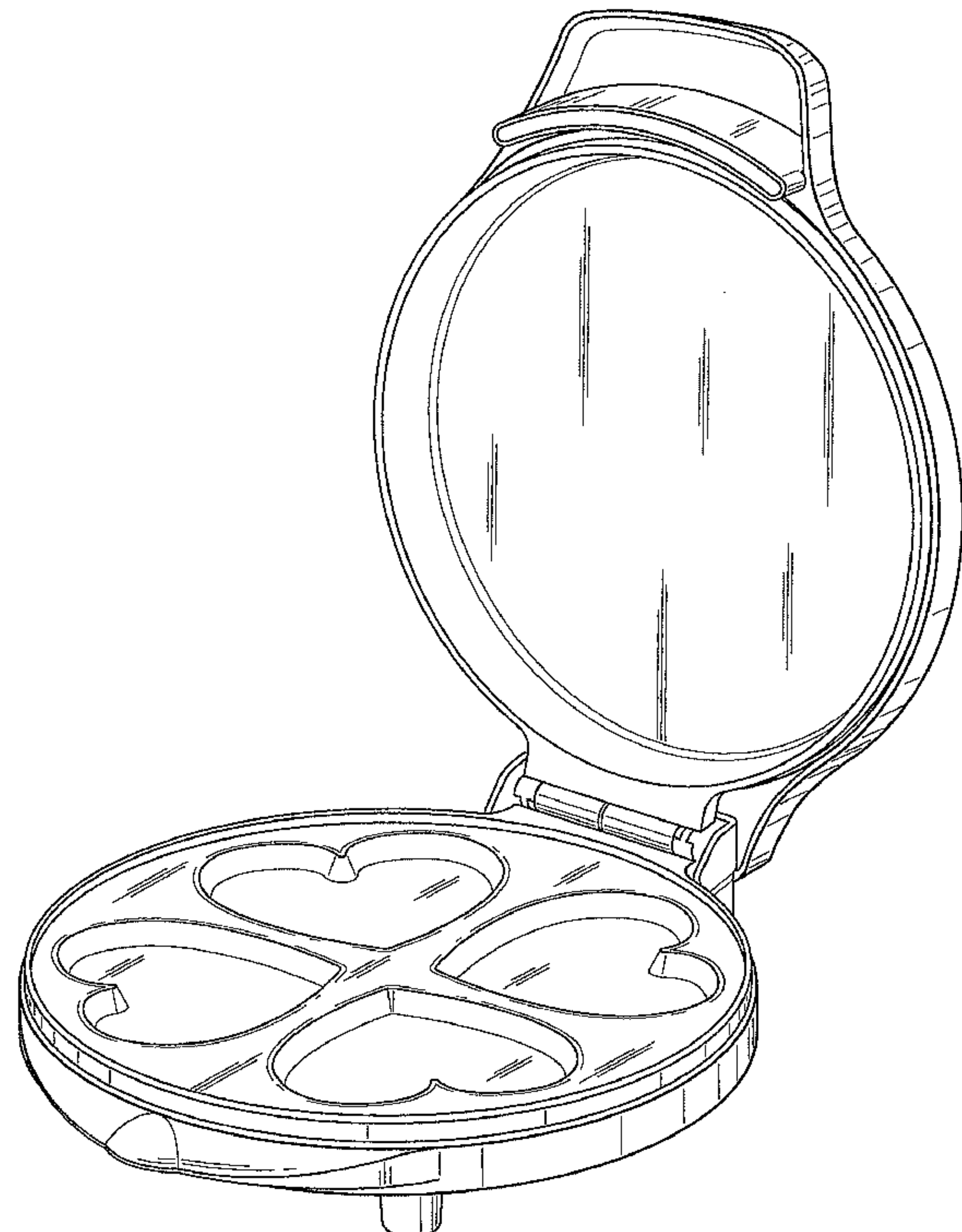
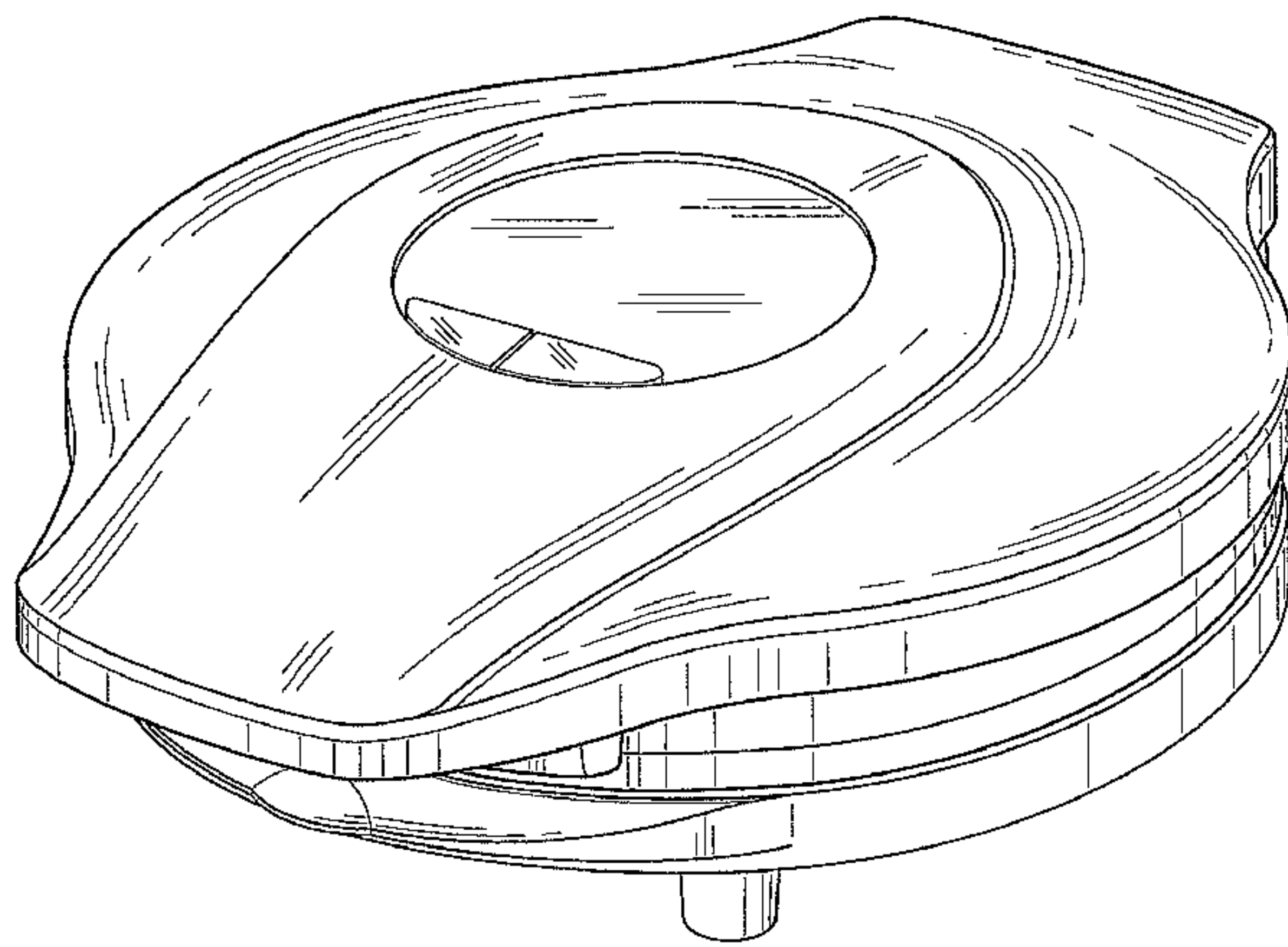
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the cooker in a closed position in accordance with the present invention;

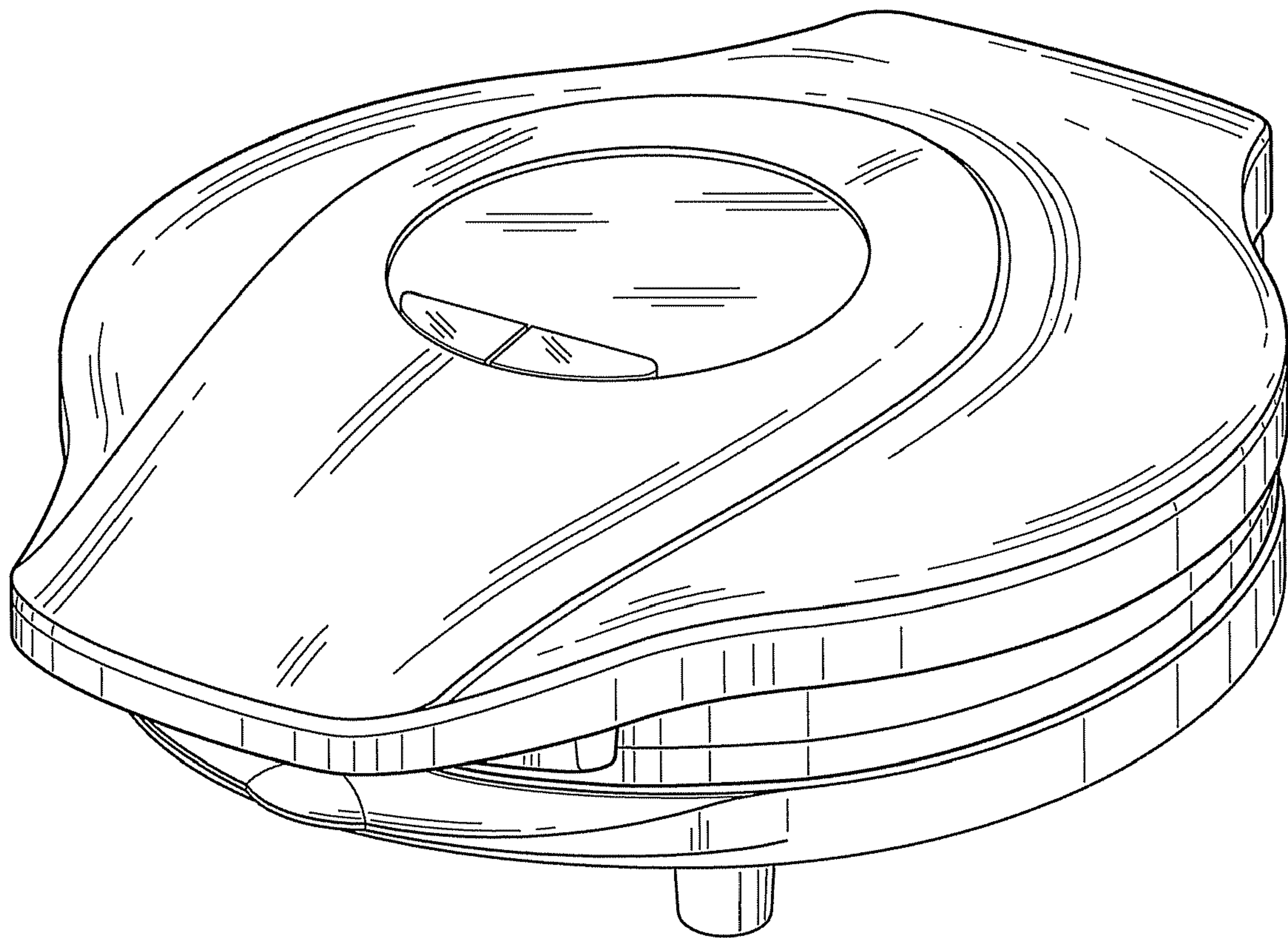

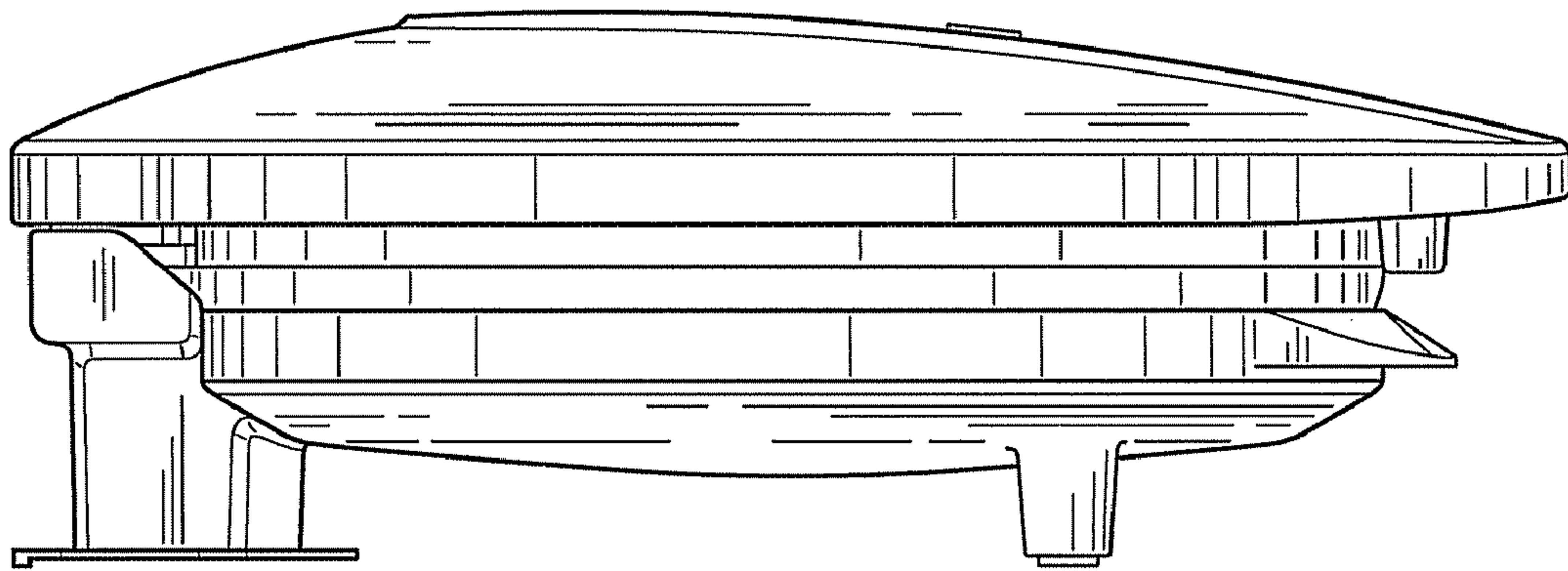

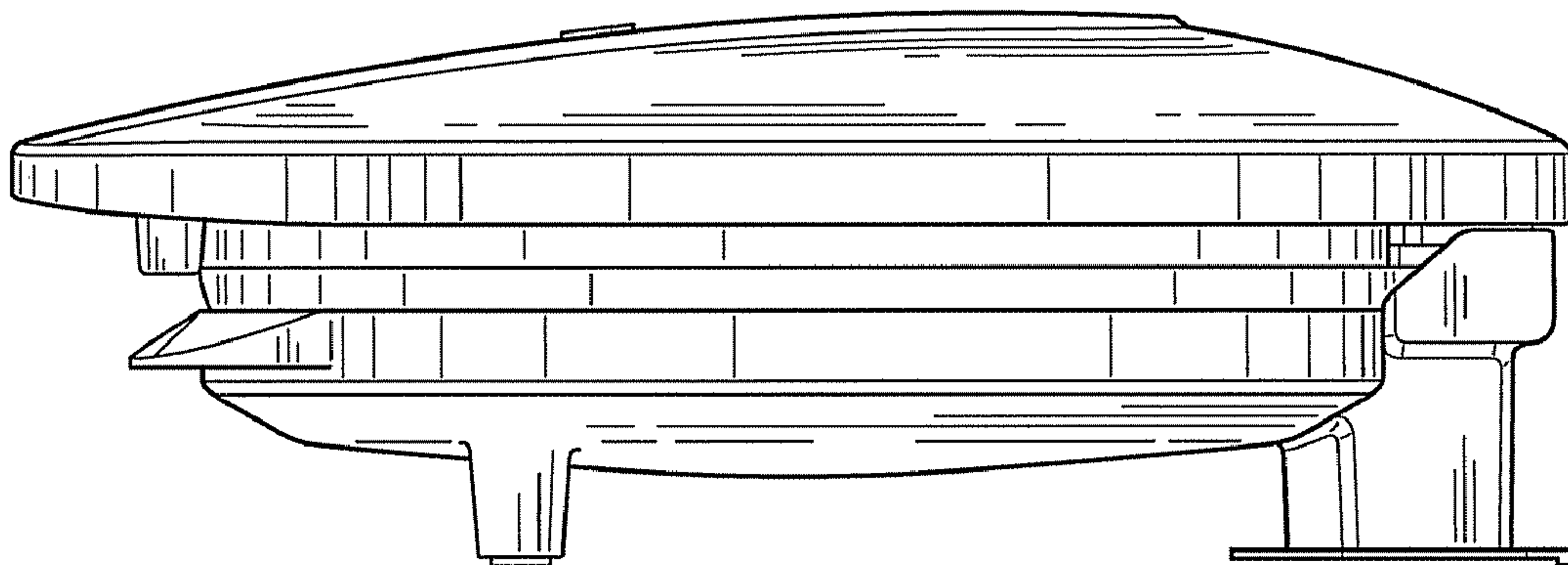

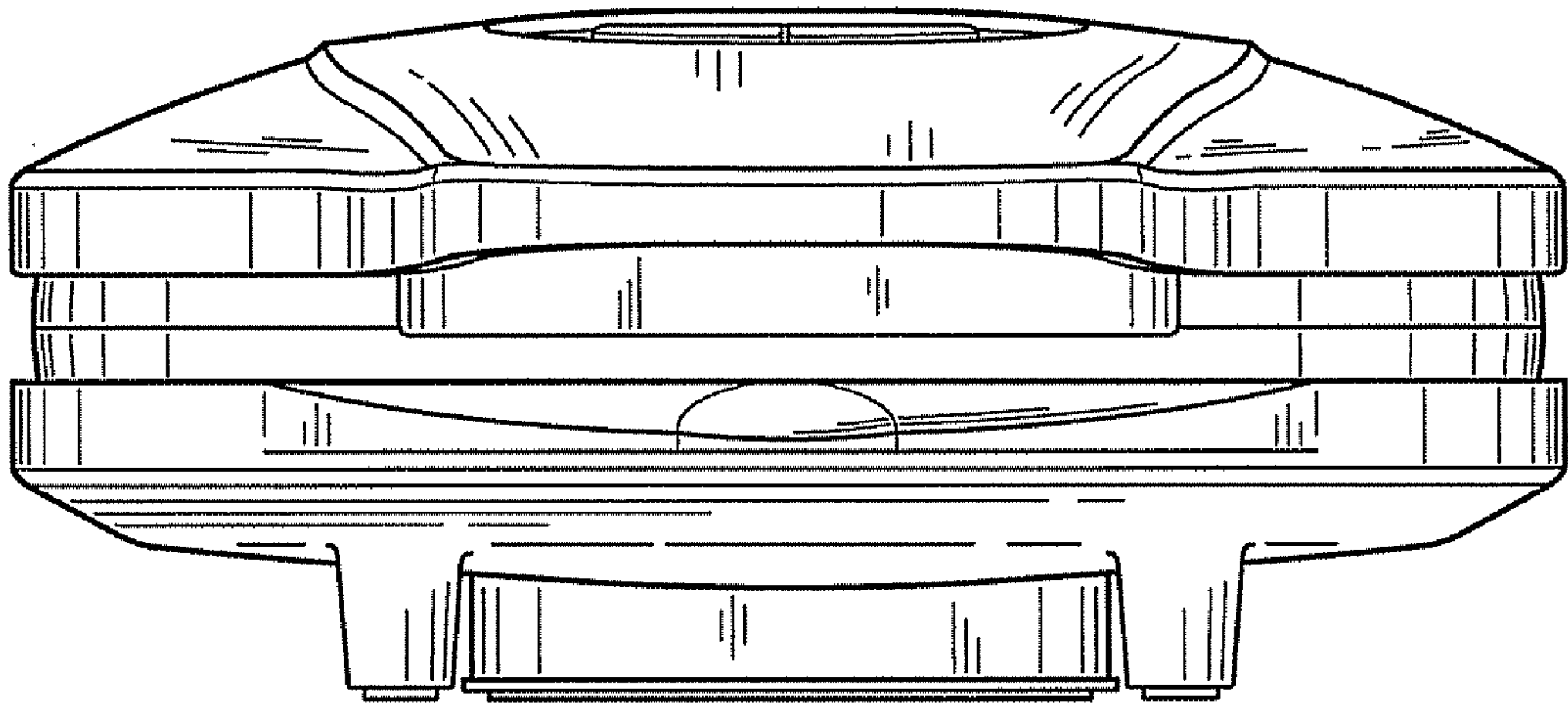

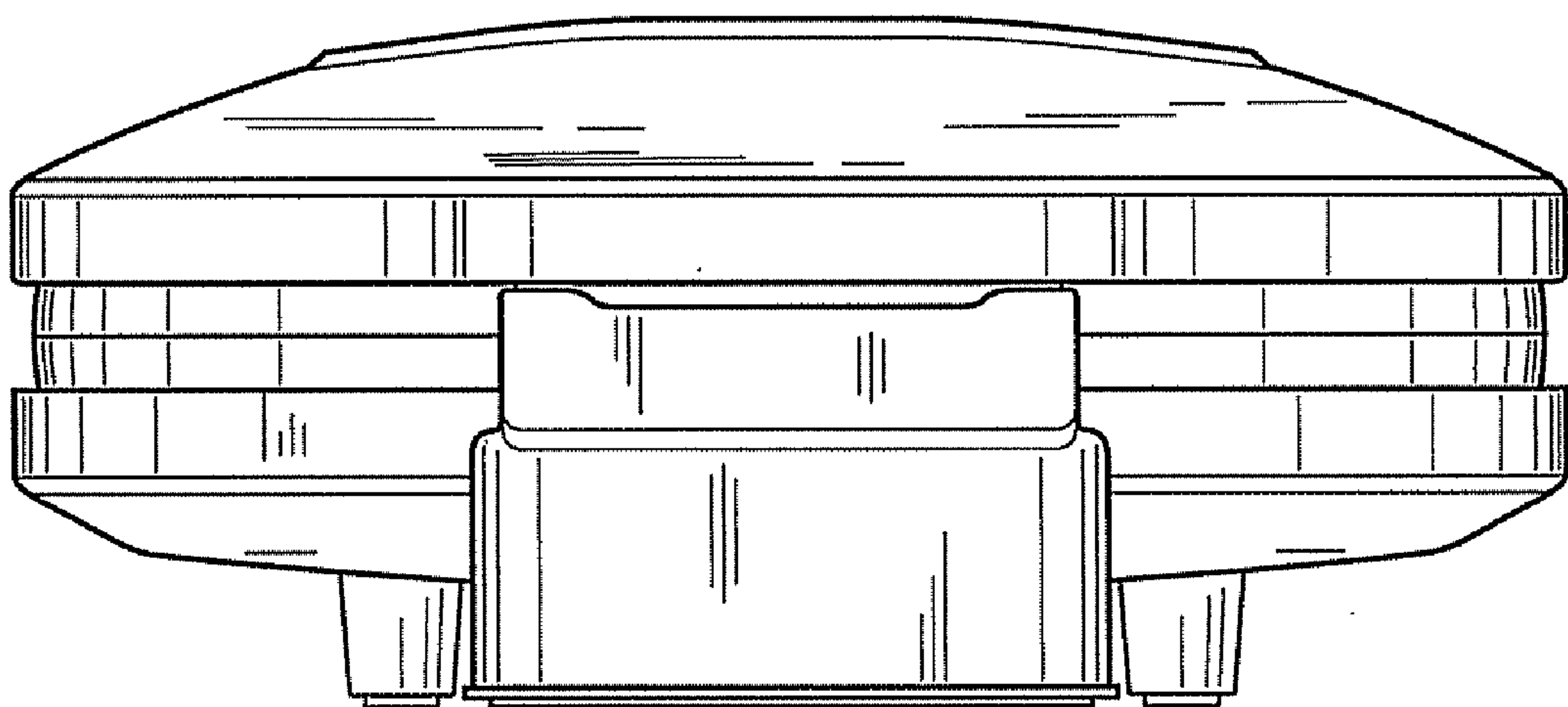

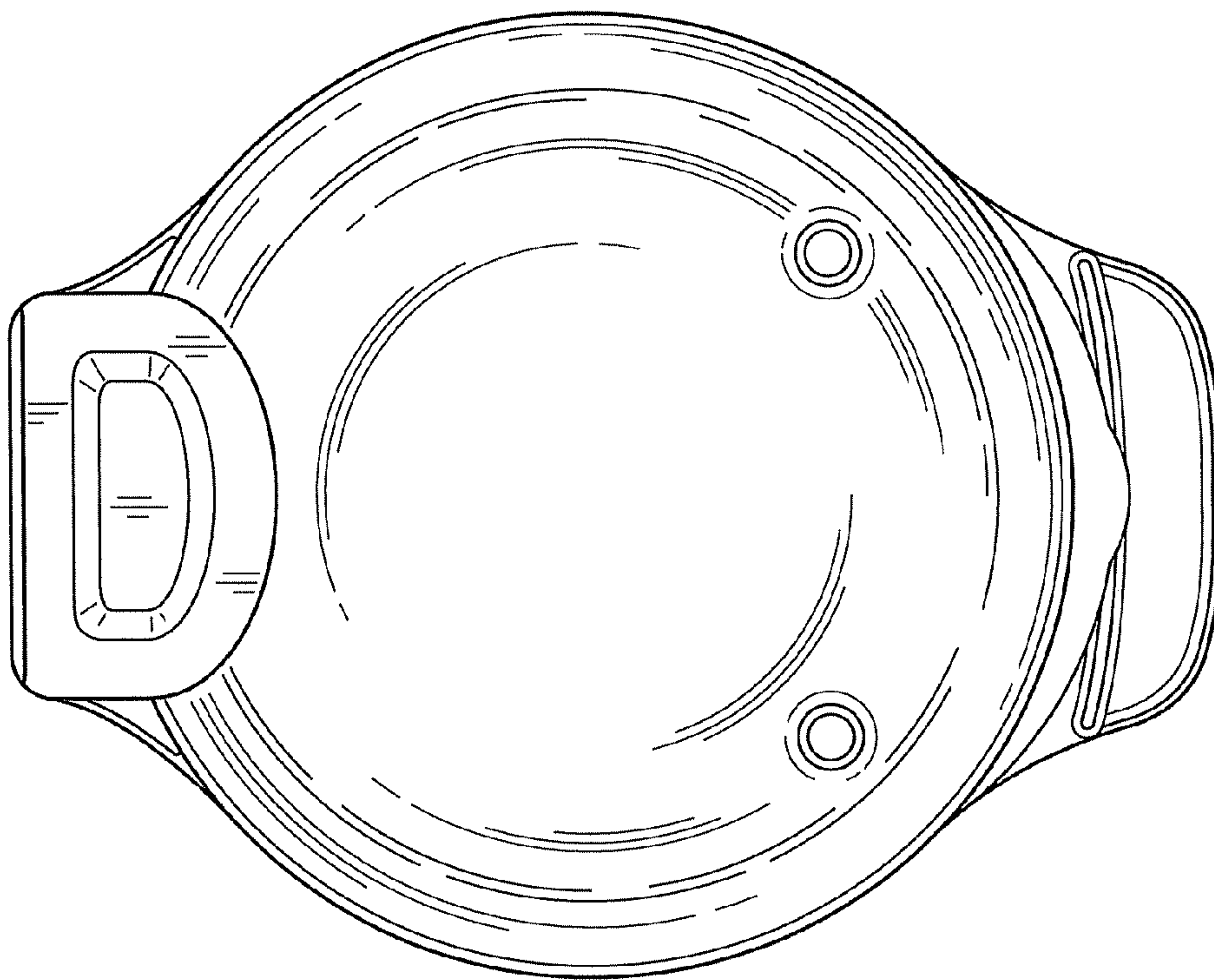

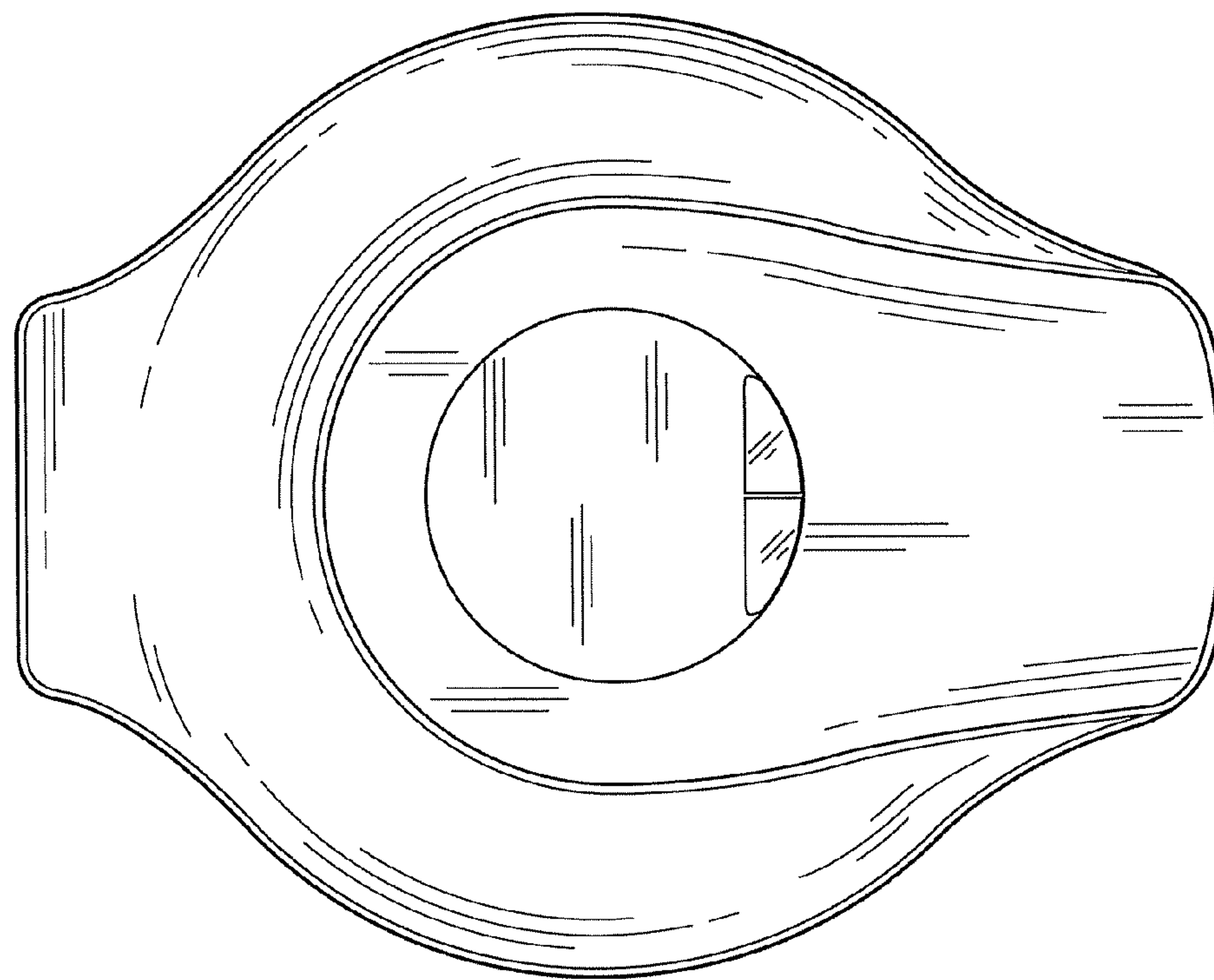

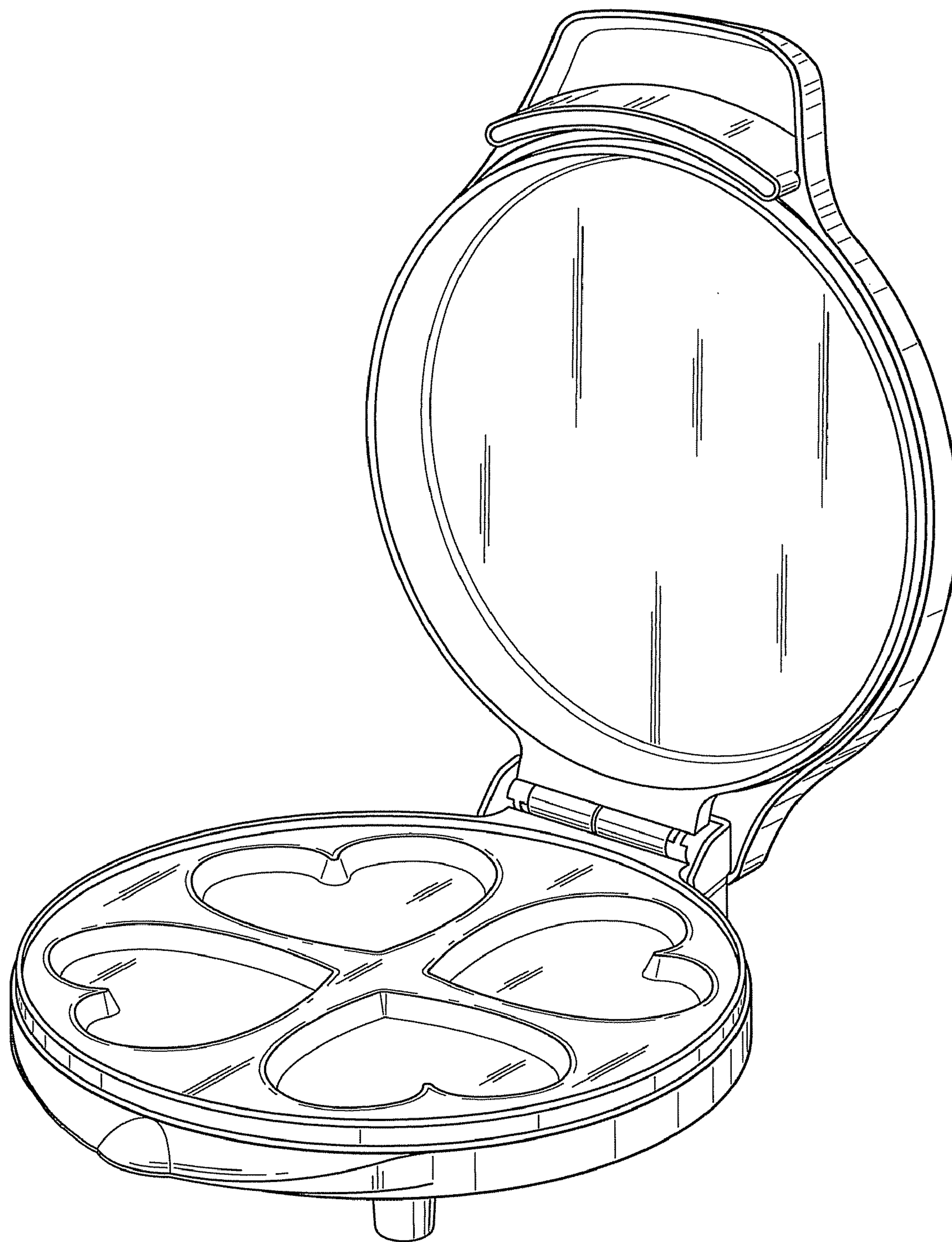

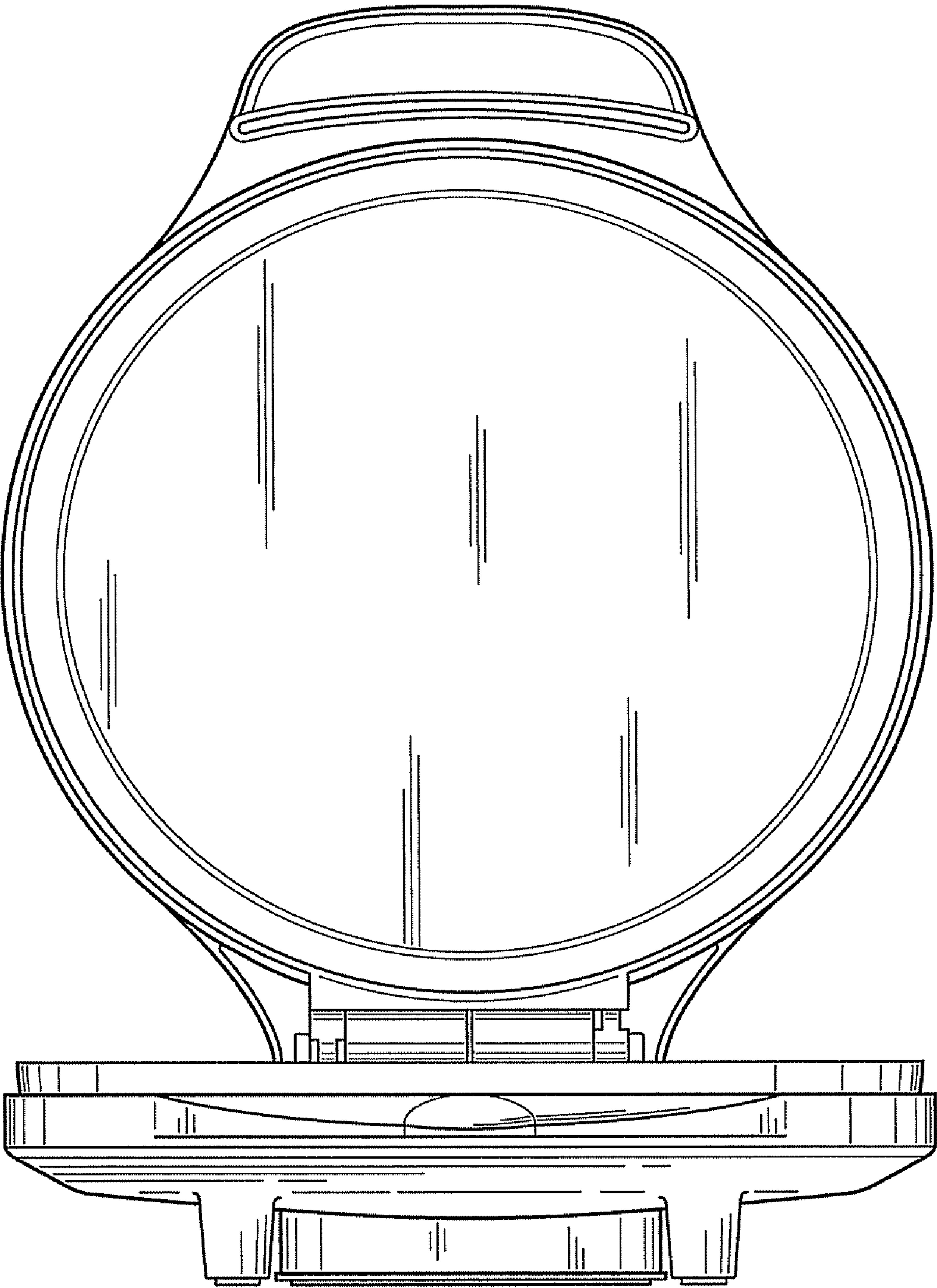

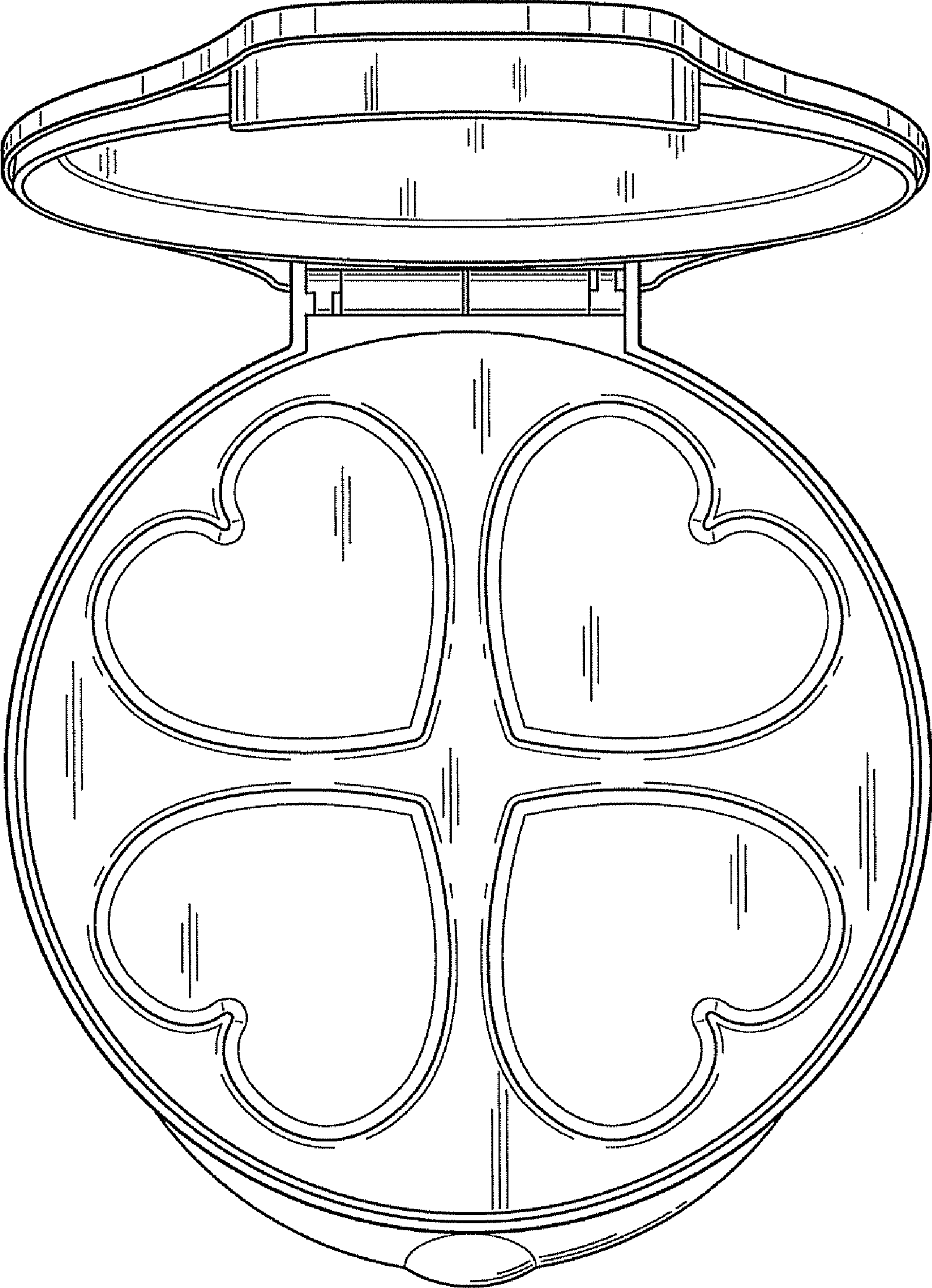
