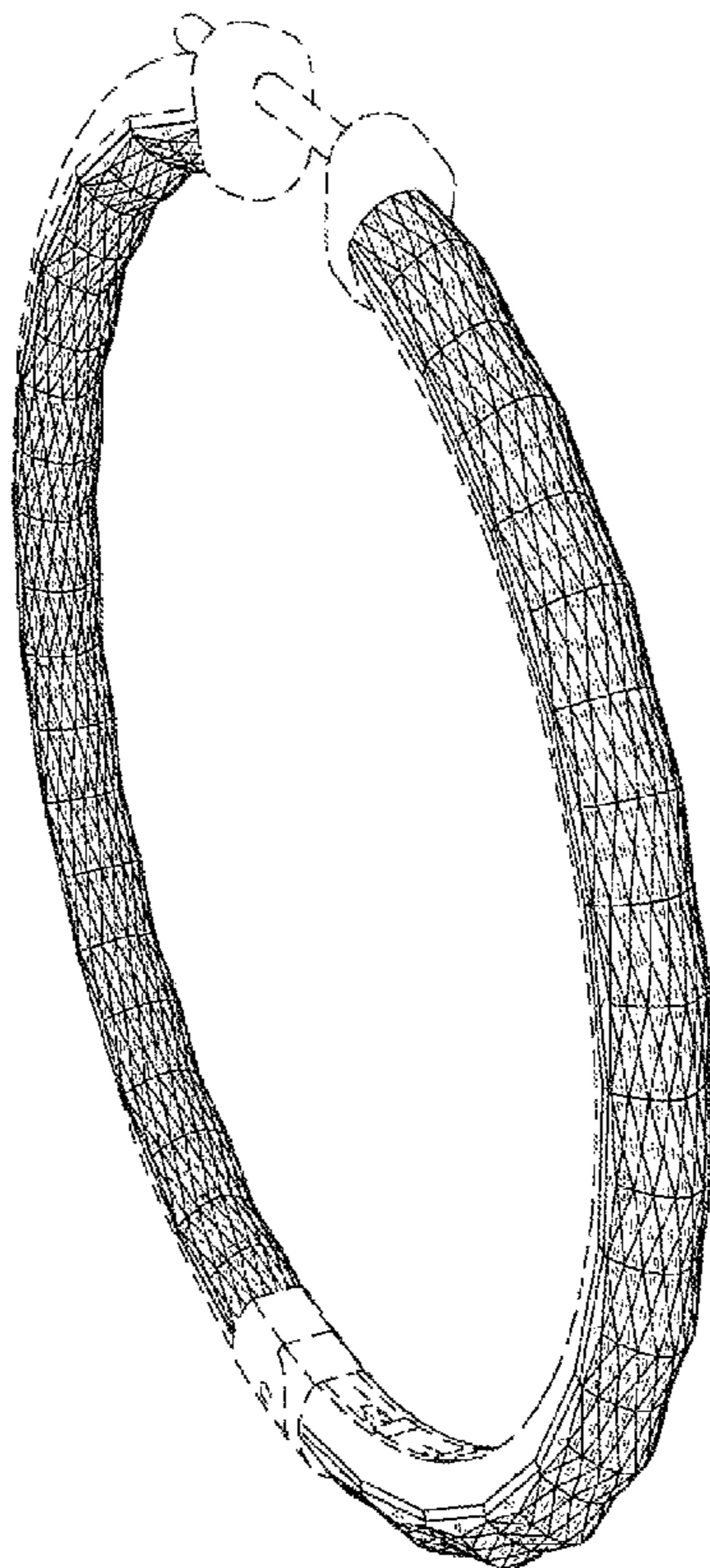
(57) **CLAIM**

The ornamental design for an earring, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing my new design; FIG. 2 is a left side elevational view thereof (the right side elevational view being substantially identical thereto); FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines shown in the drawings represent unclaimed portions of the earring and form no part of the claimed design.

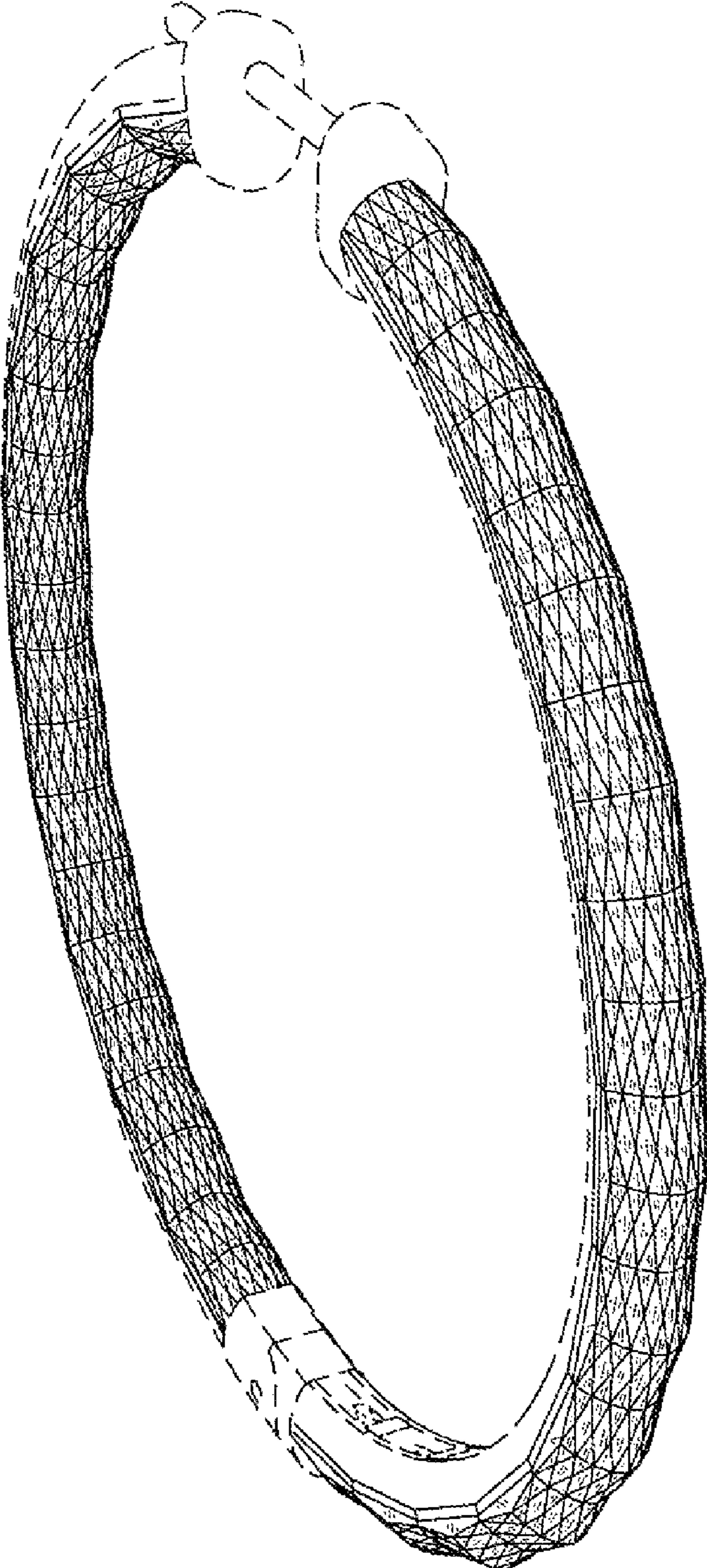

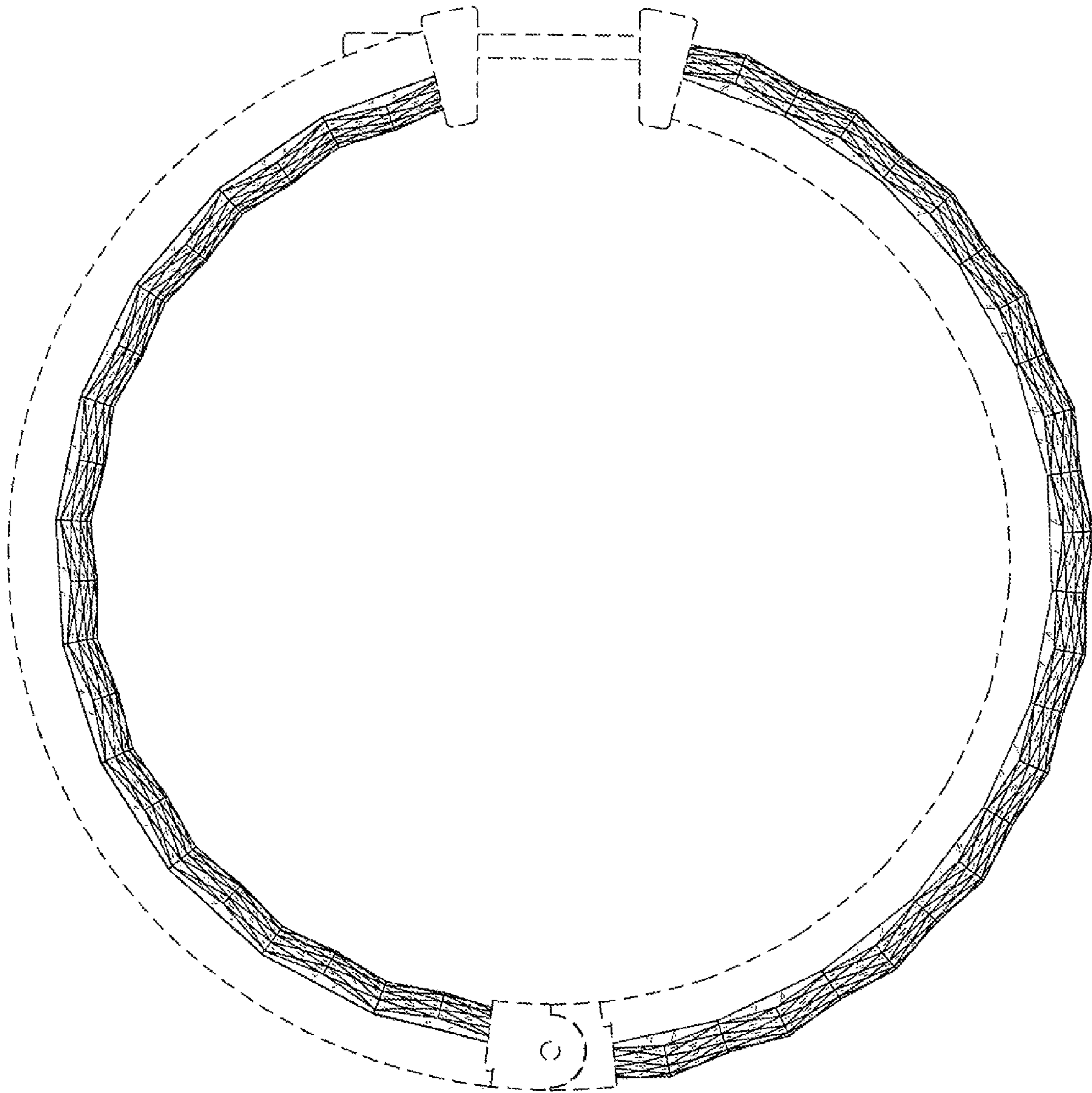

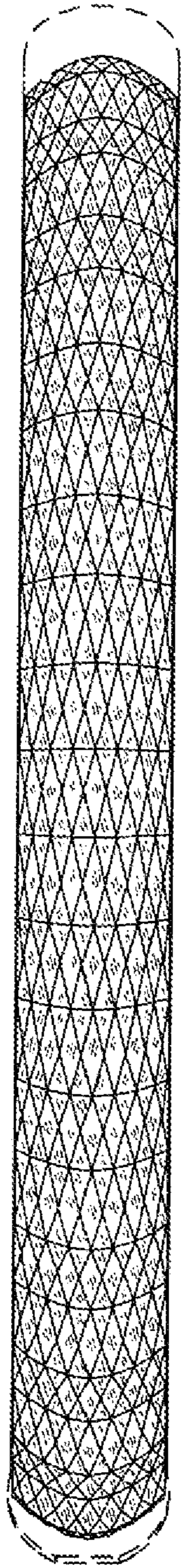

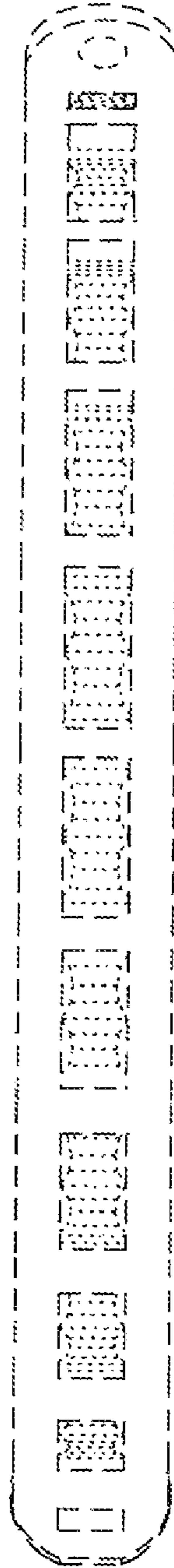

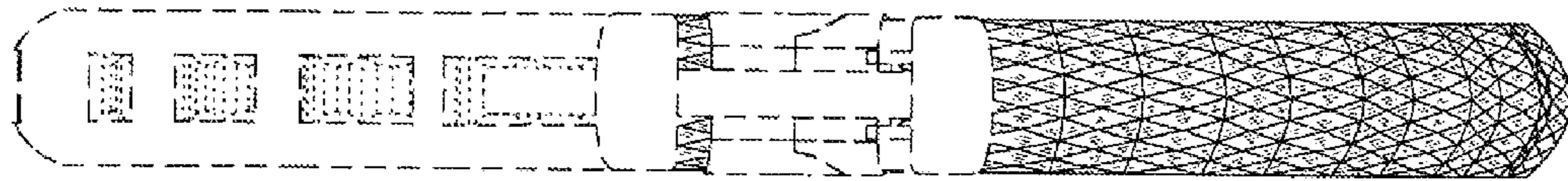

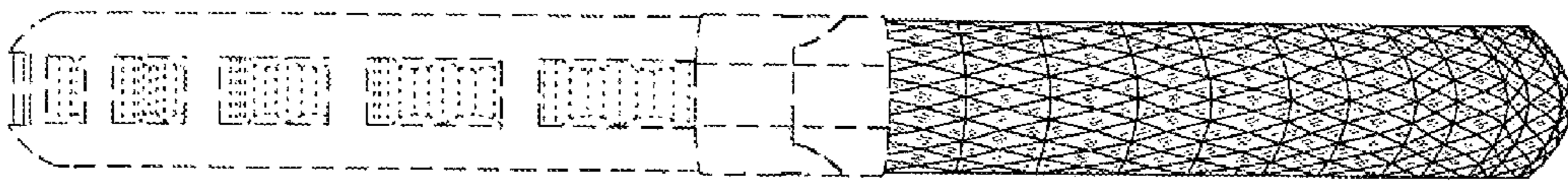
