The ornamental design for a tire, as shown and described.

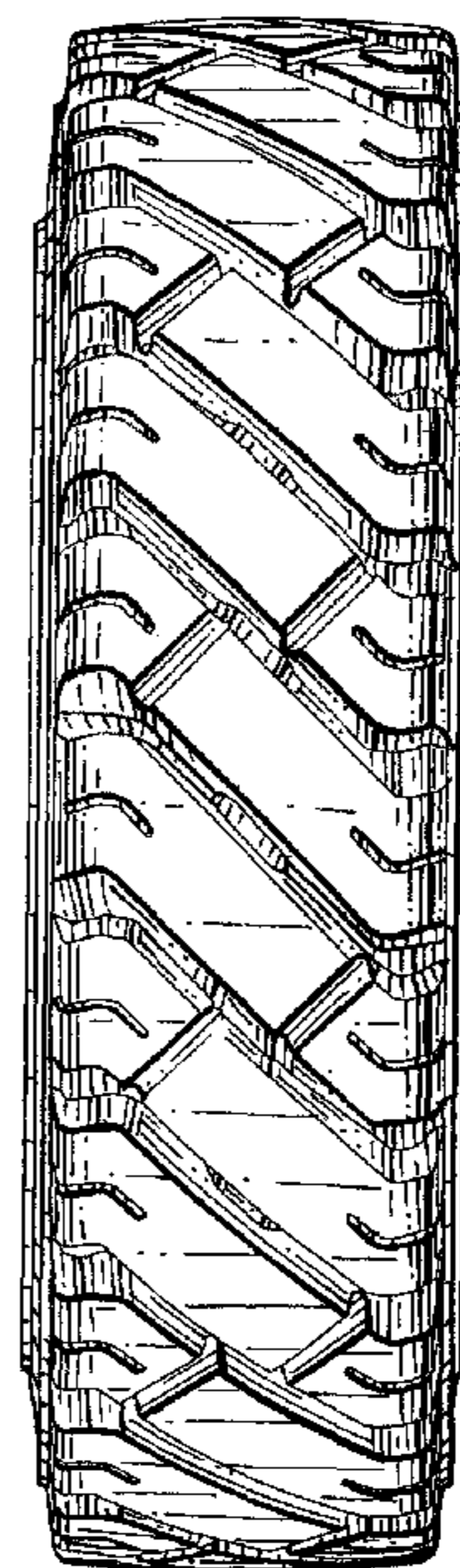
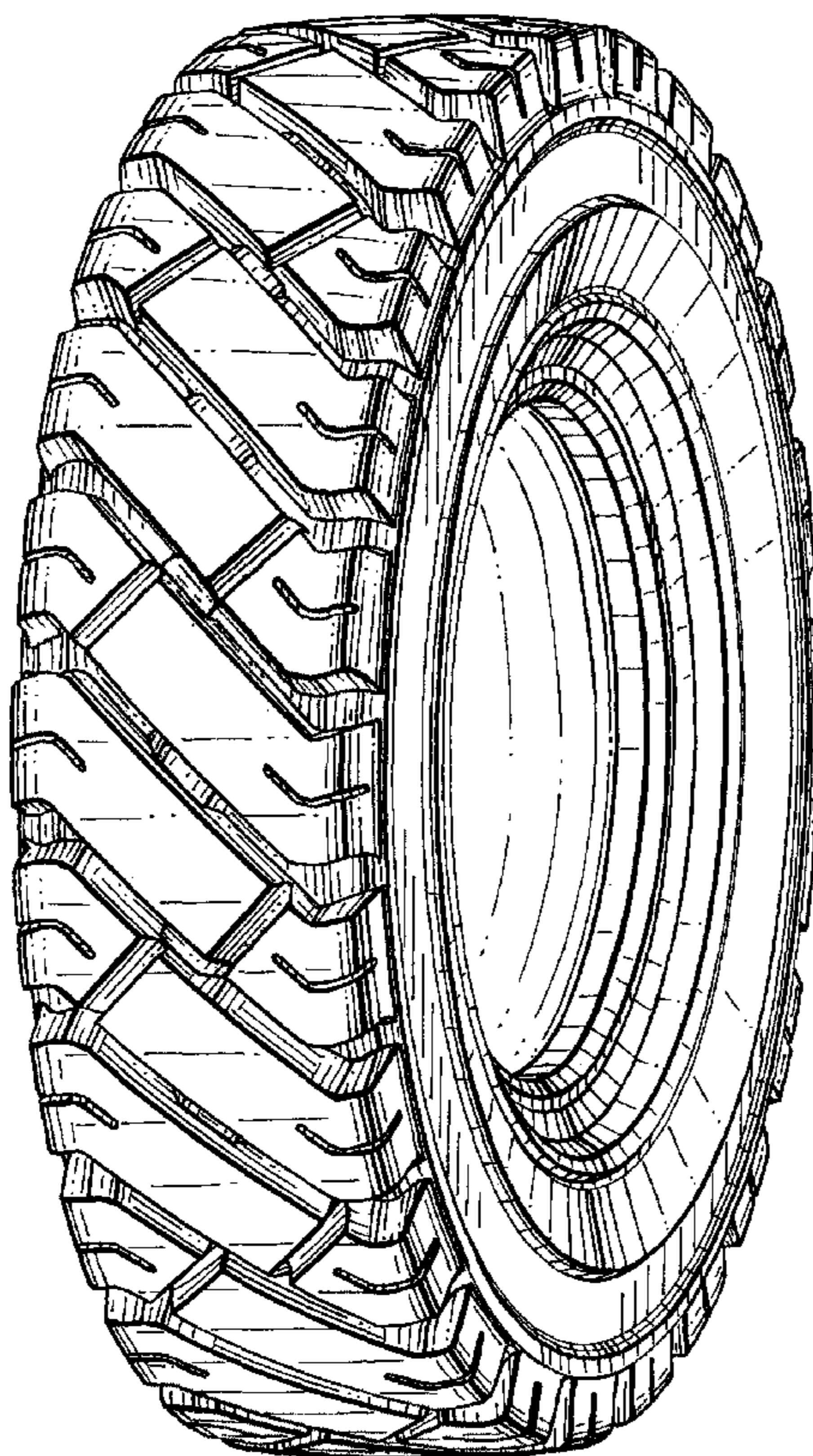
**DESCRIPTION**

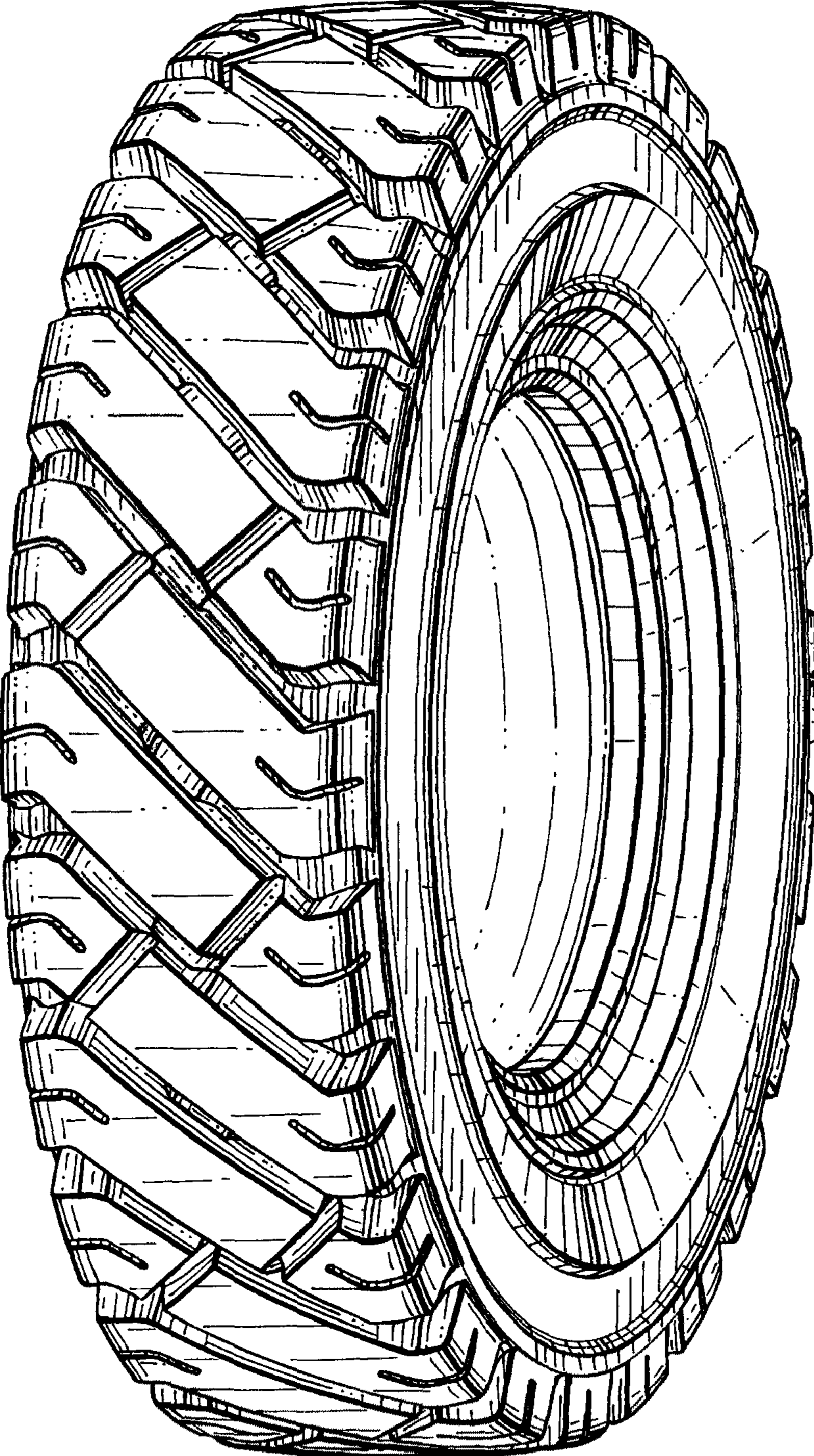

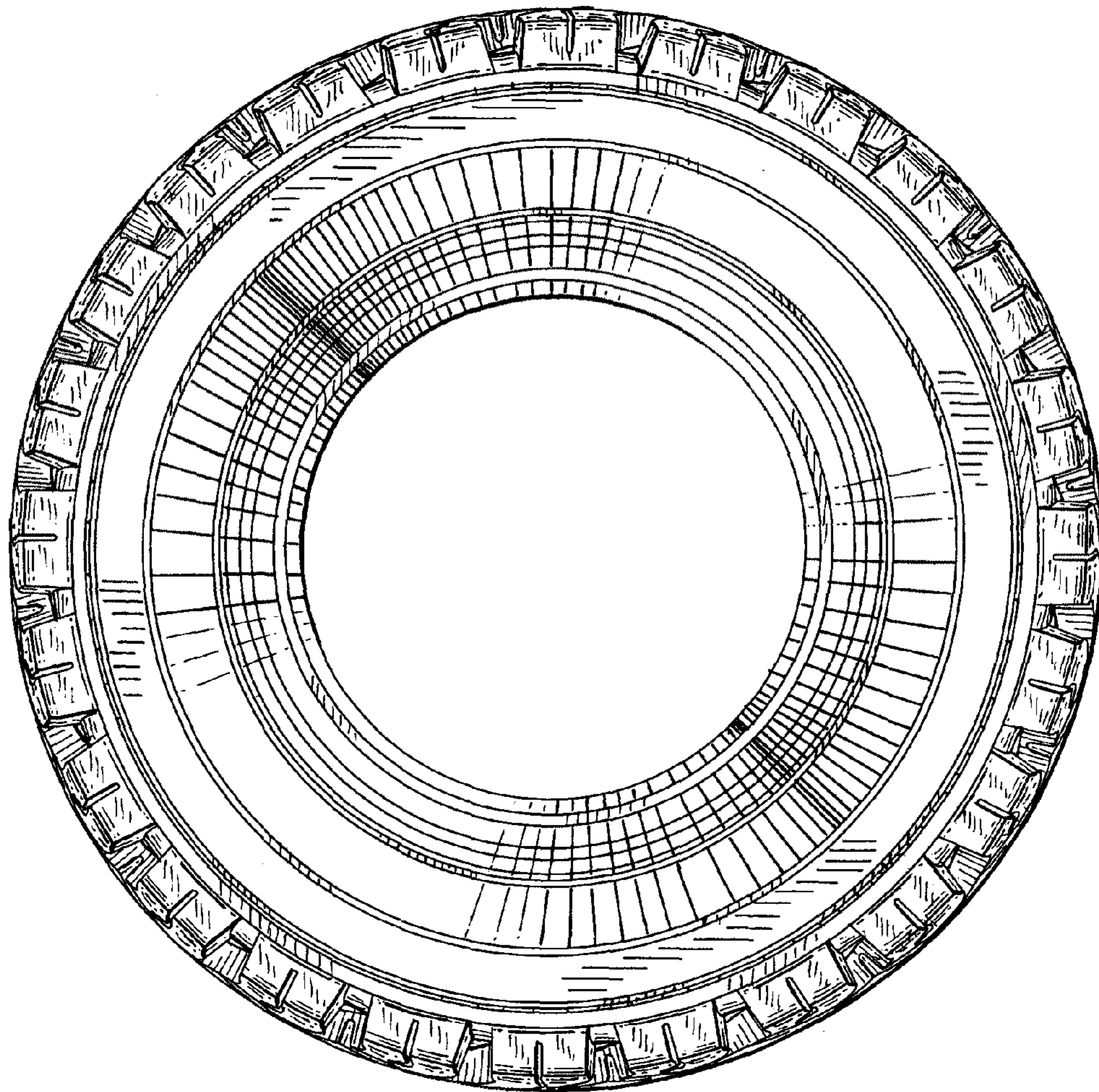
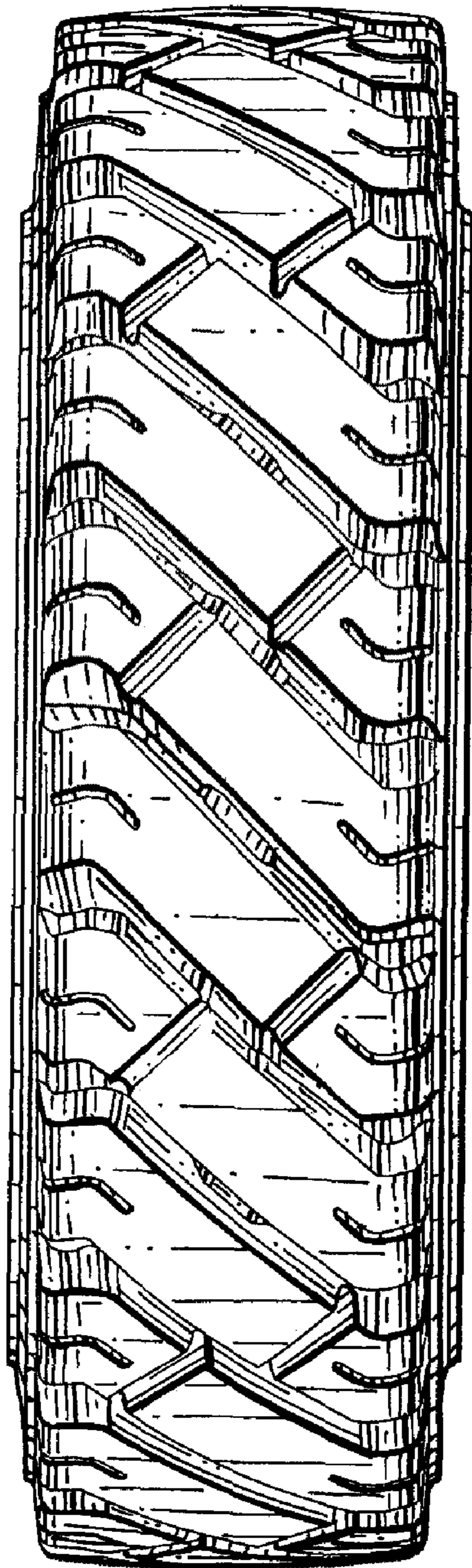
