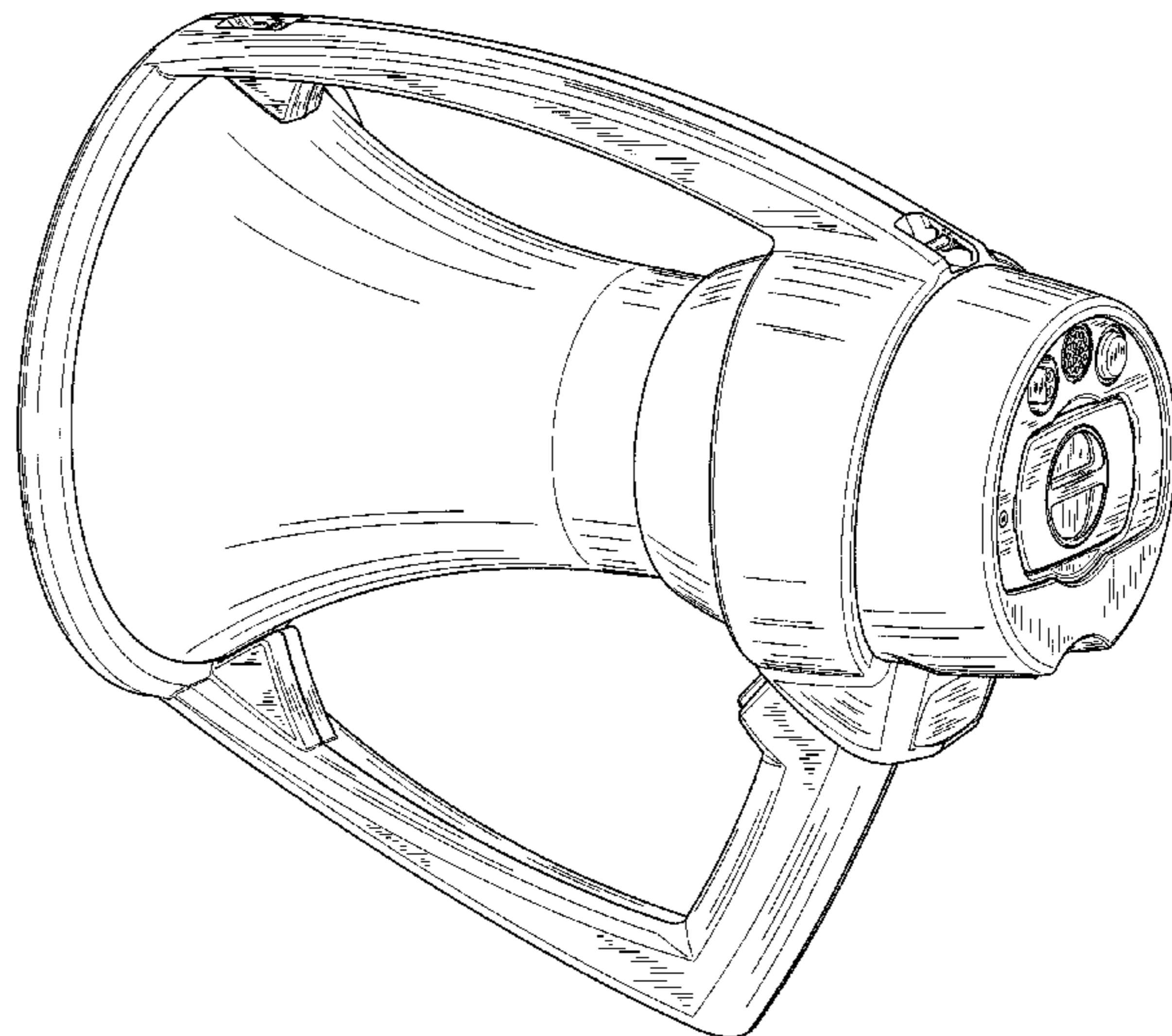
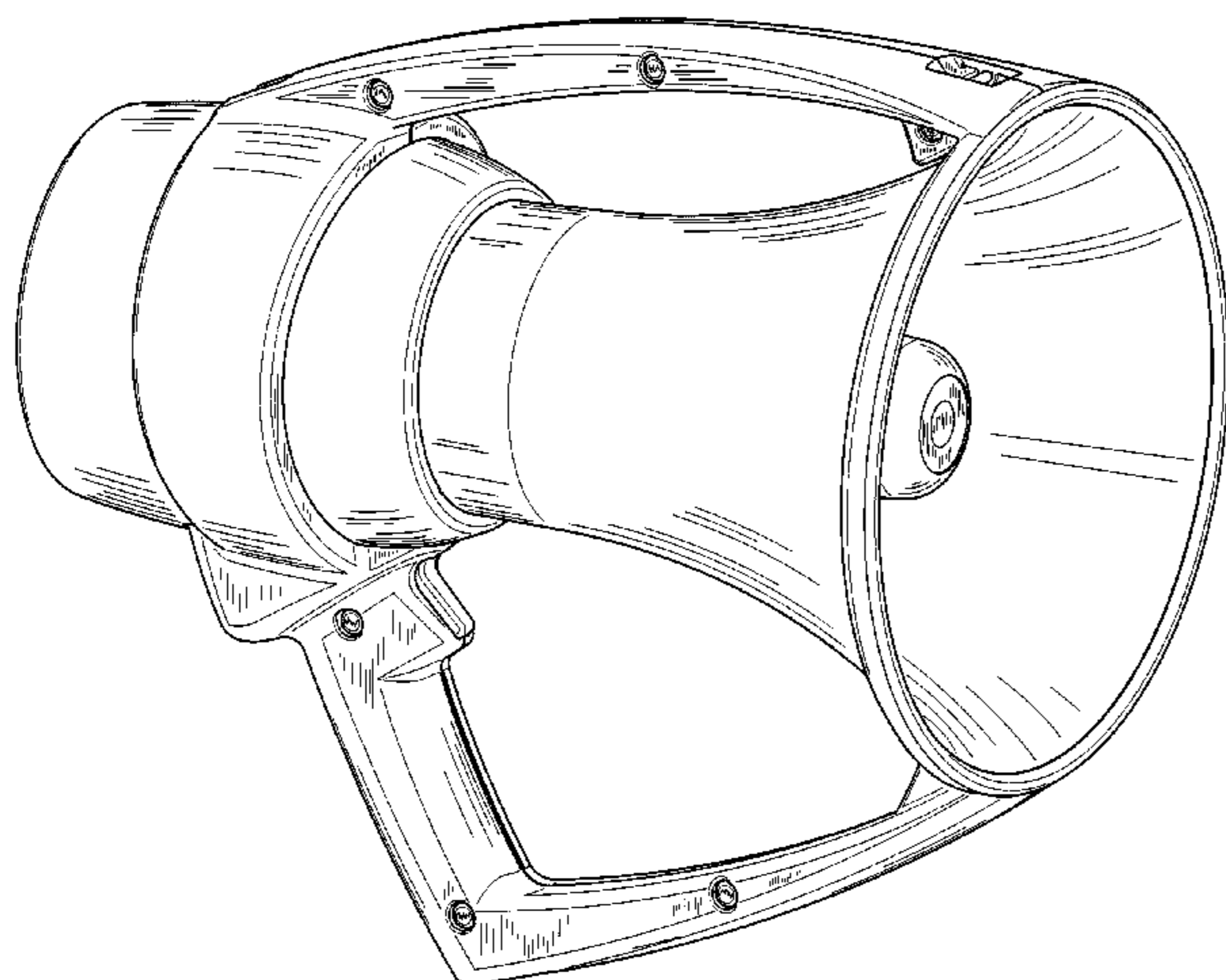
(57) **CLAIM**

We claim the ornamental design for a megaphone, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a mega-  
phone embodying our new design;  
FIG. 2 is a front and left side perspective view thereof;  
FIG. 3 is a rear and left side perspective view thereof;  
FIG. 4 is a rear and right side perspective view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a rear elevation view thereof;

FIG. 8 is a left side elevation view thereof;

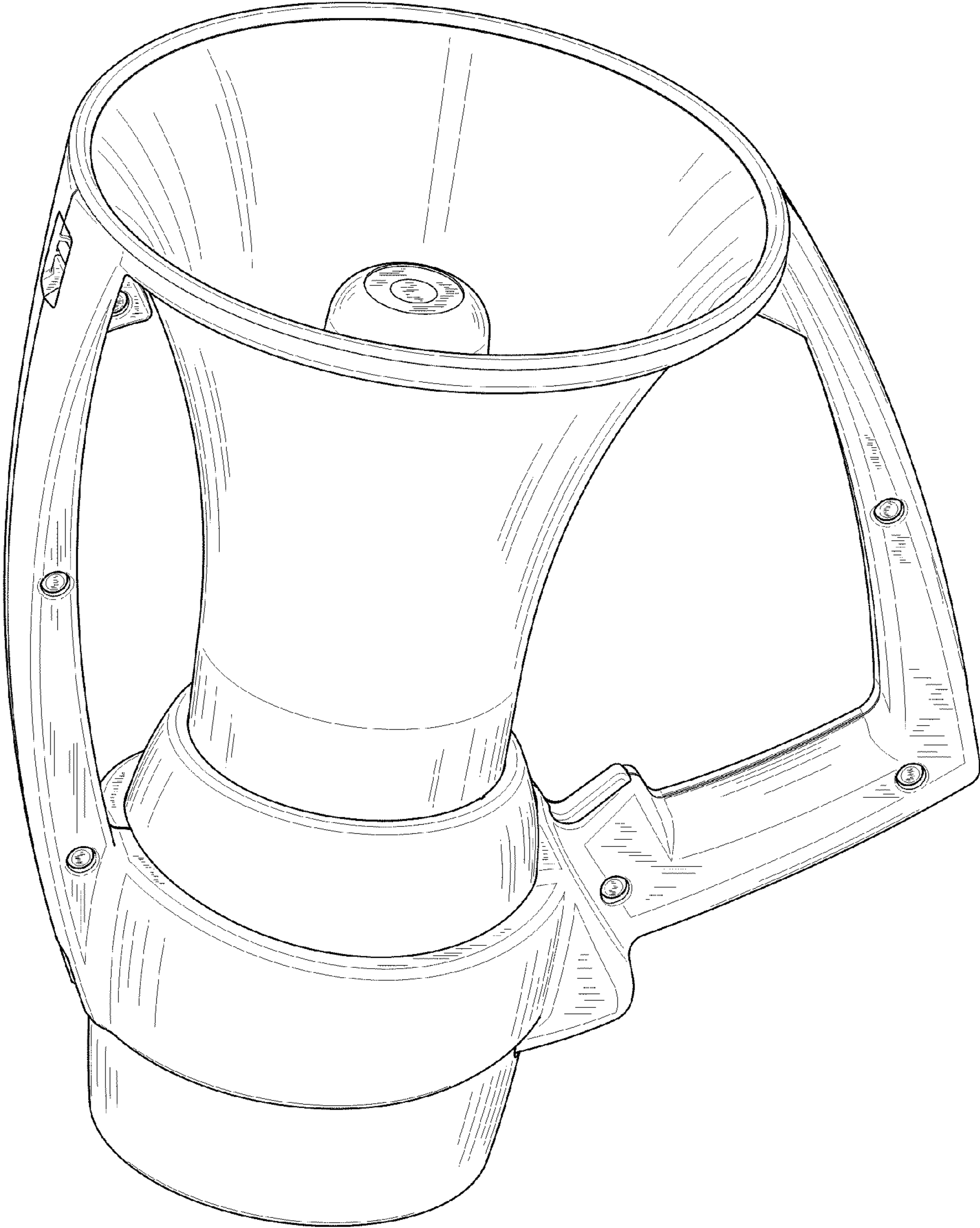

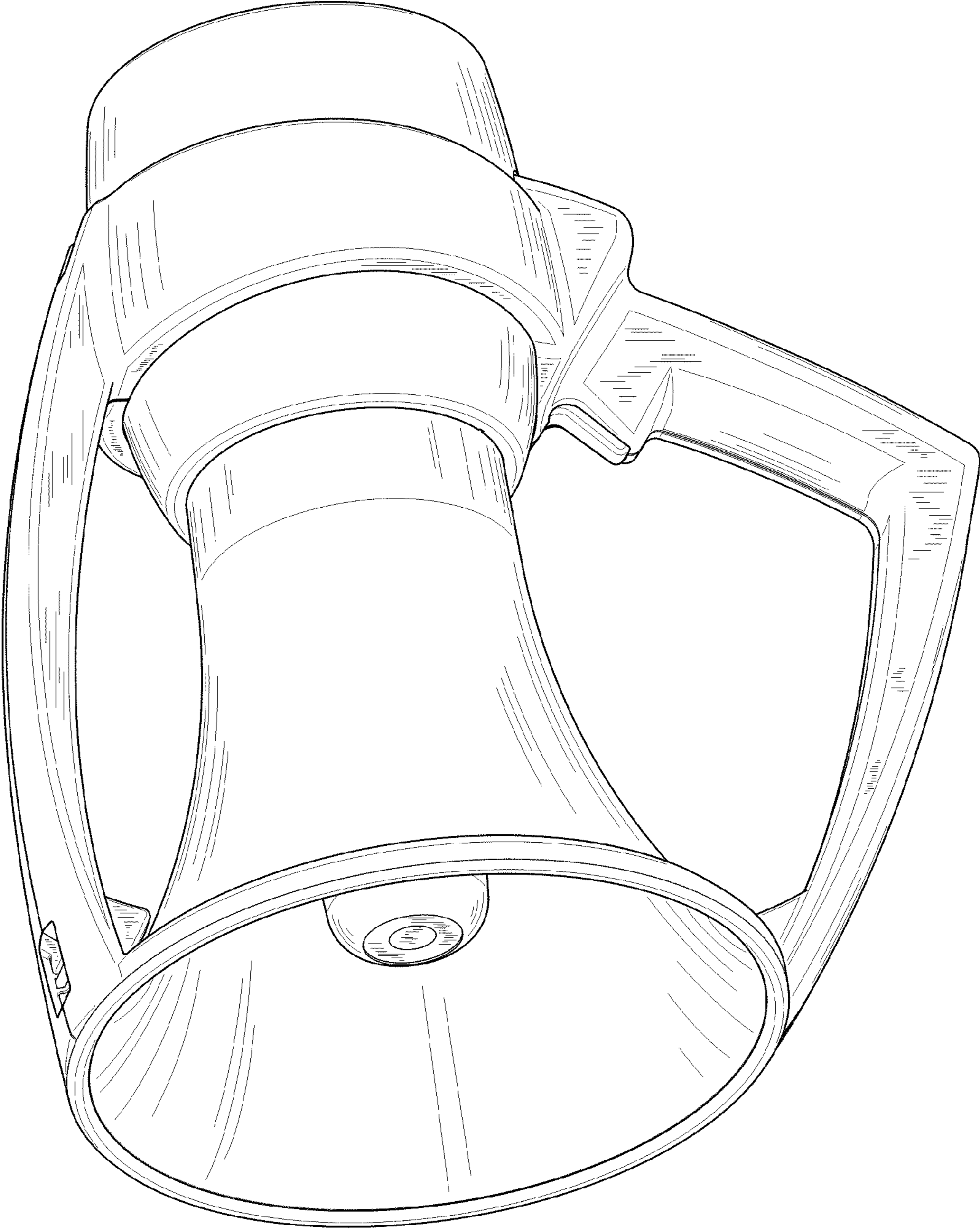

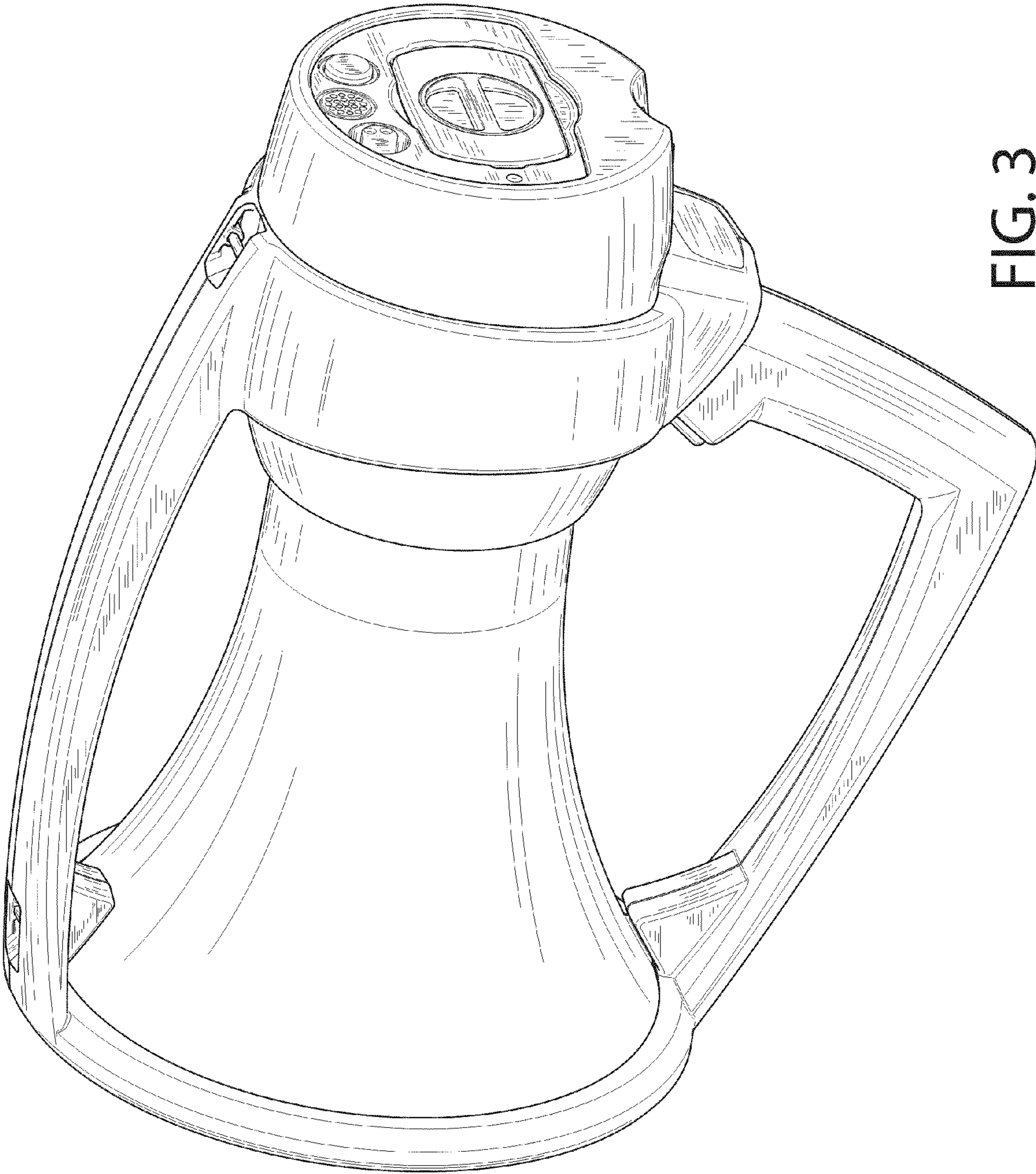

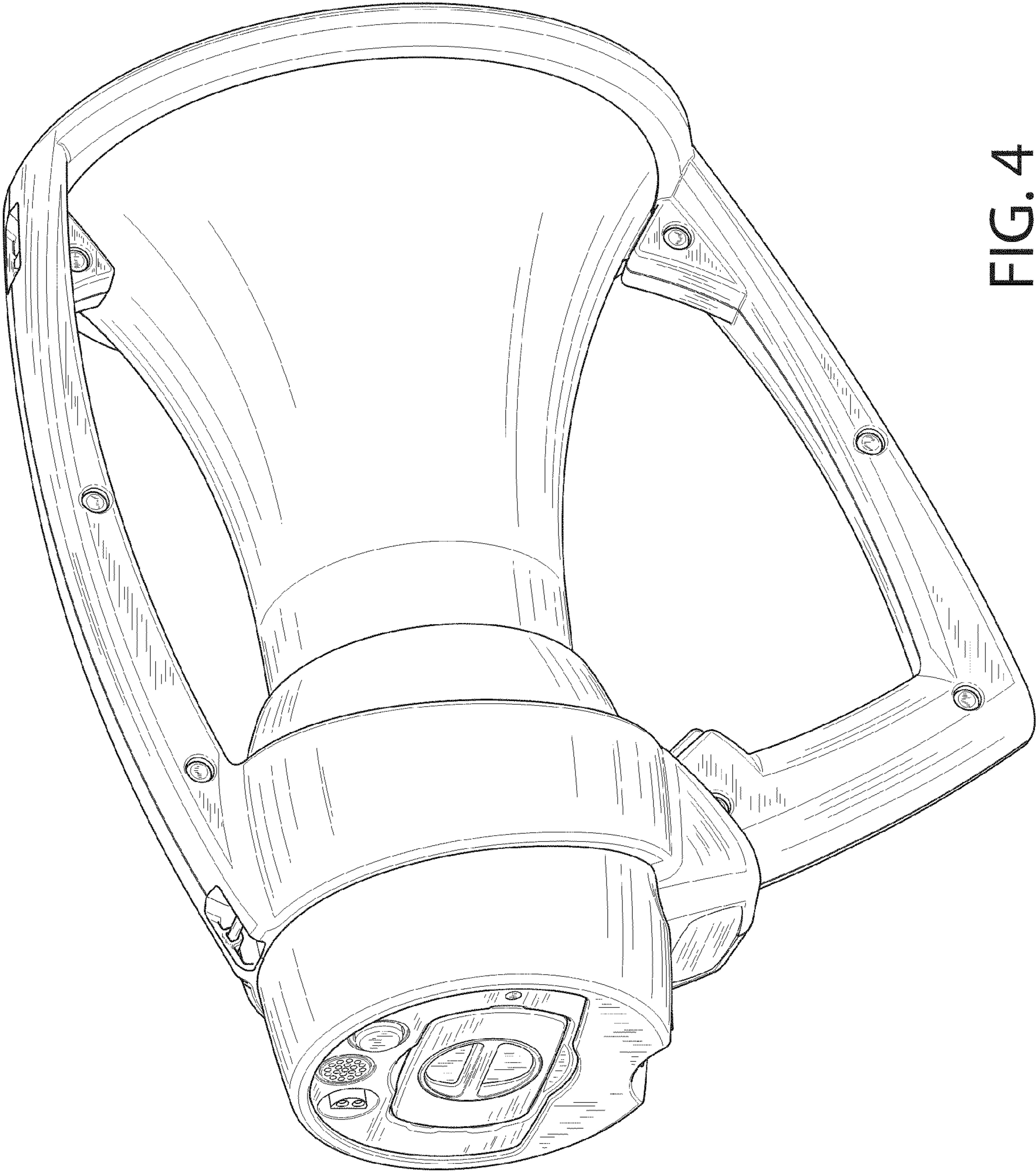

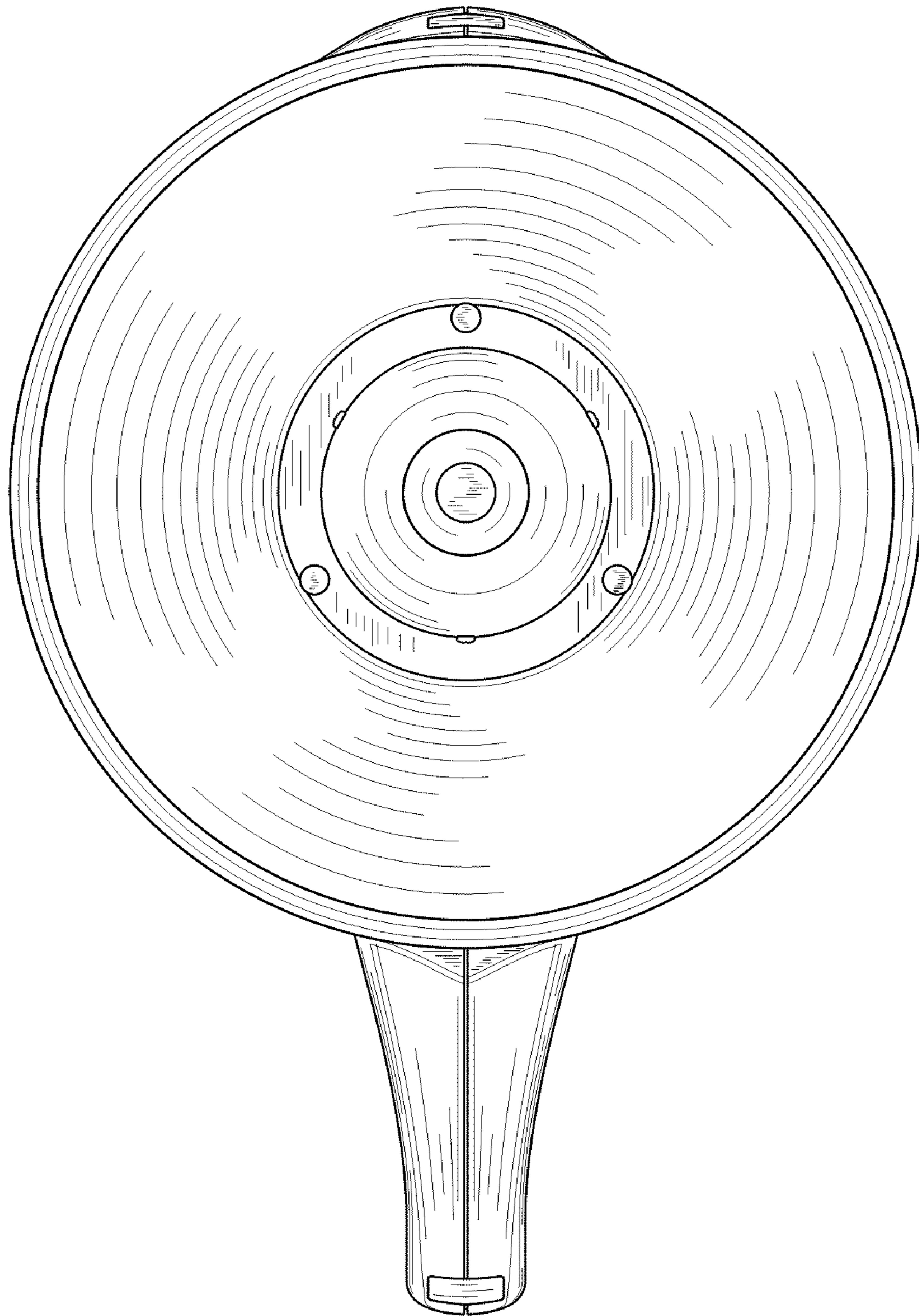

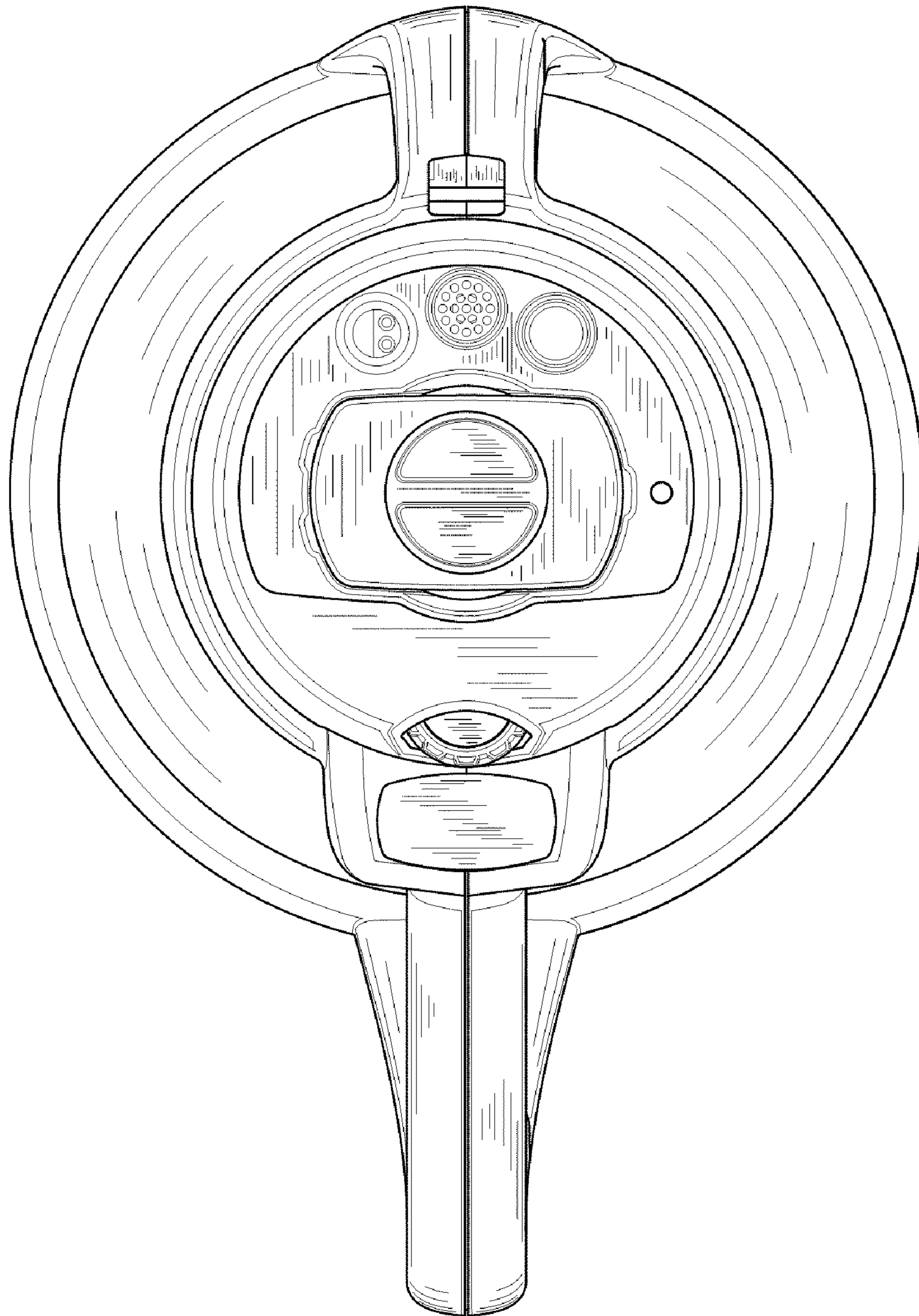

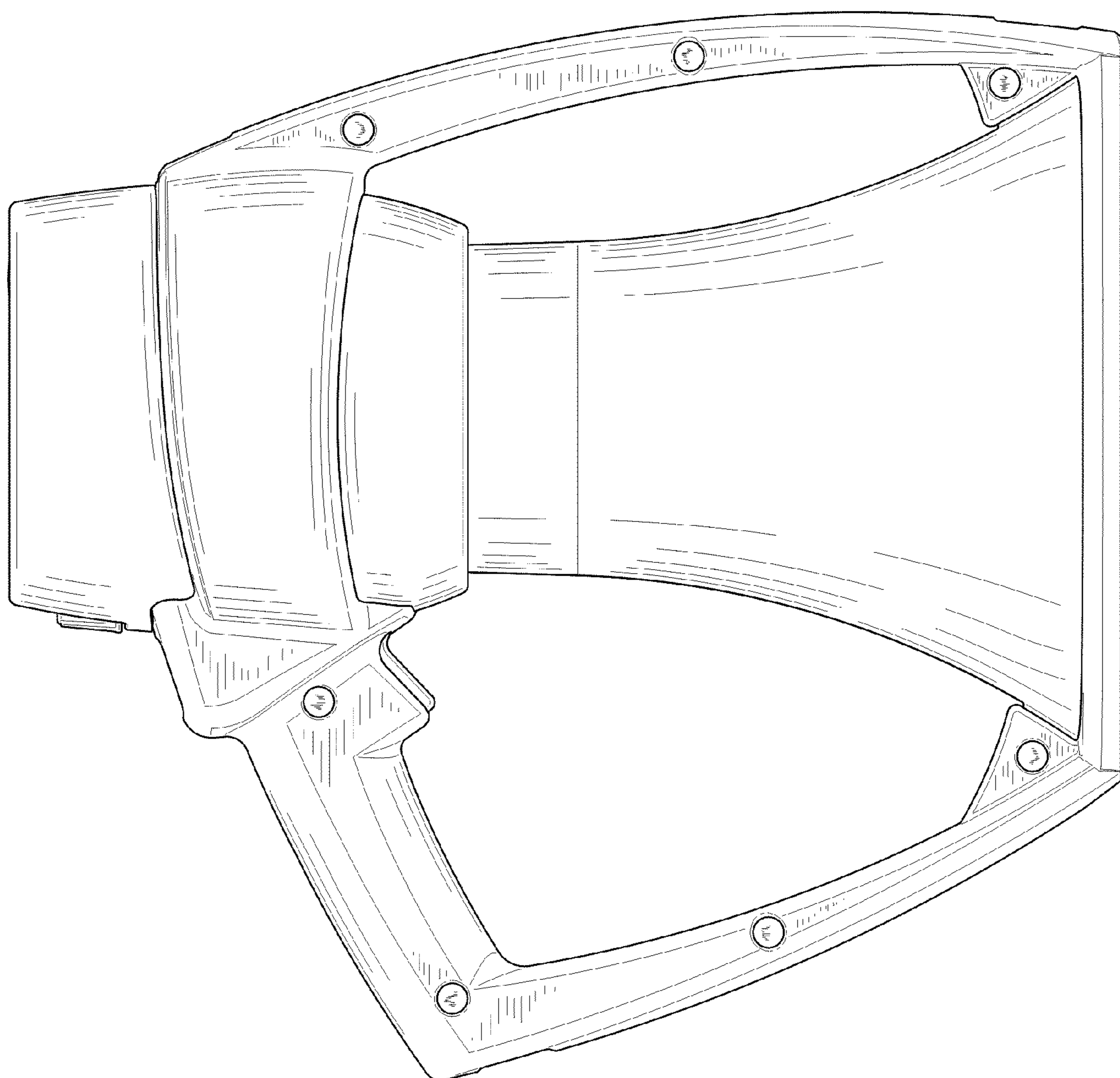

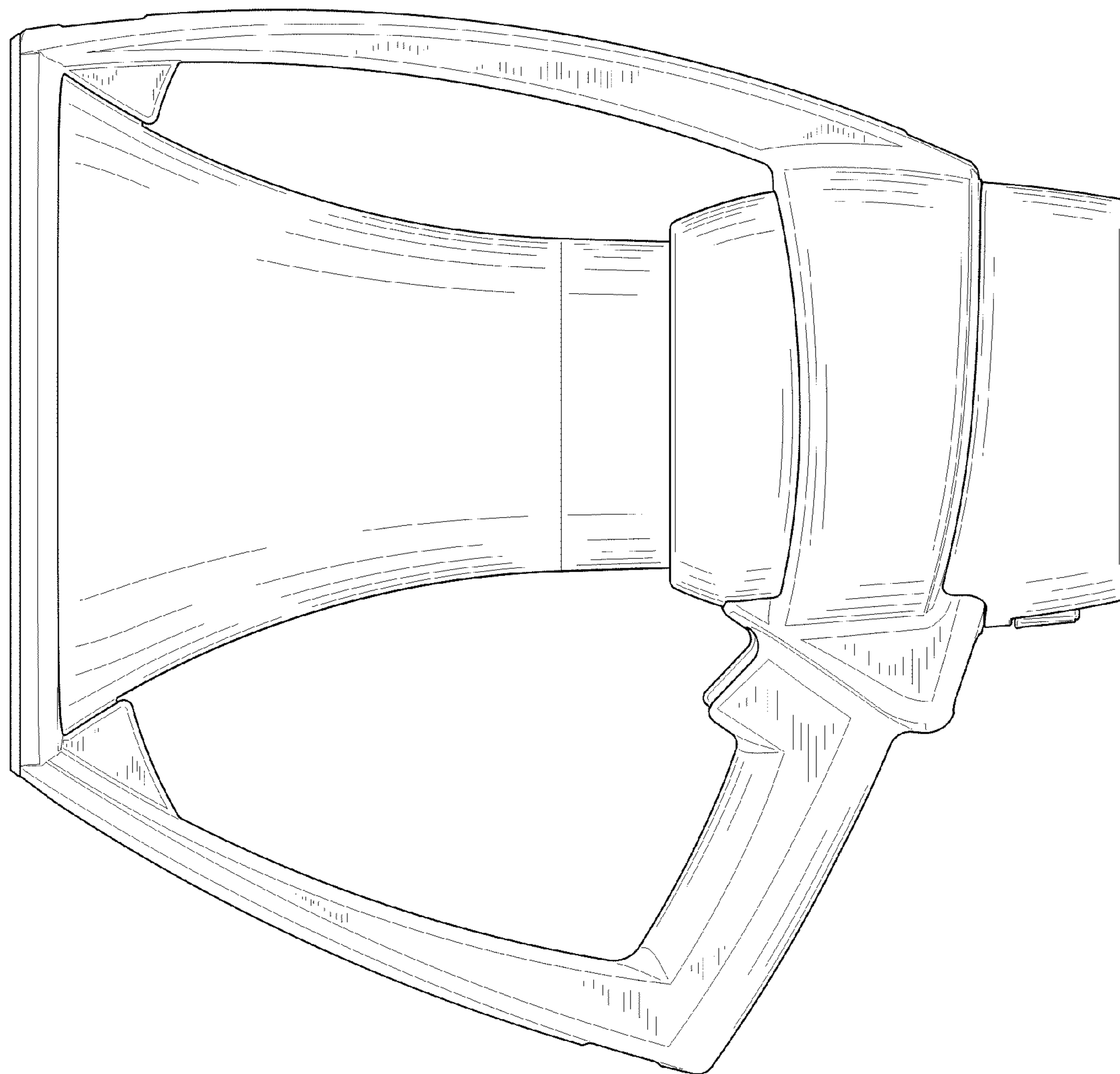

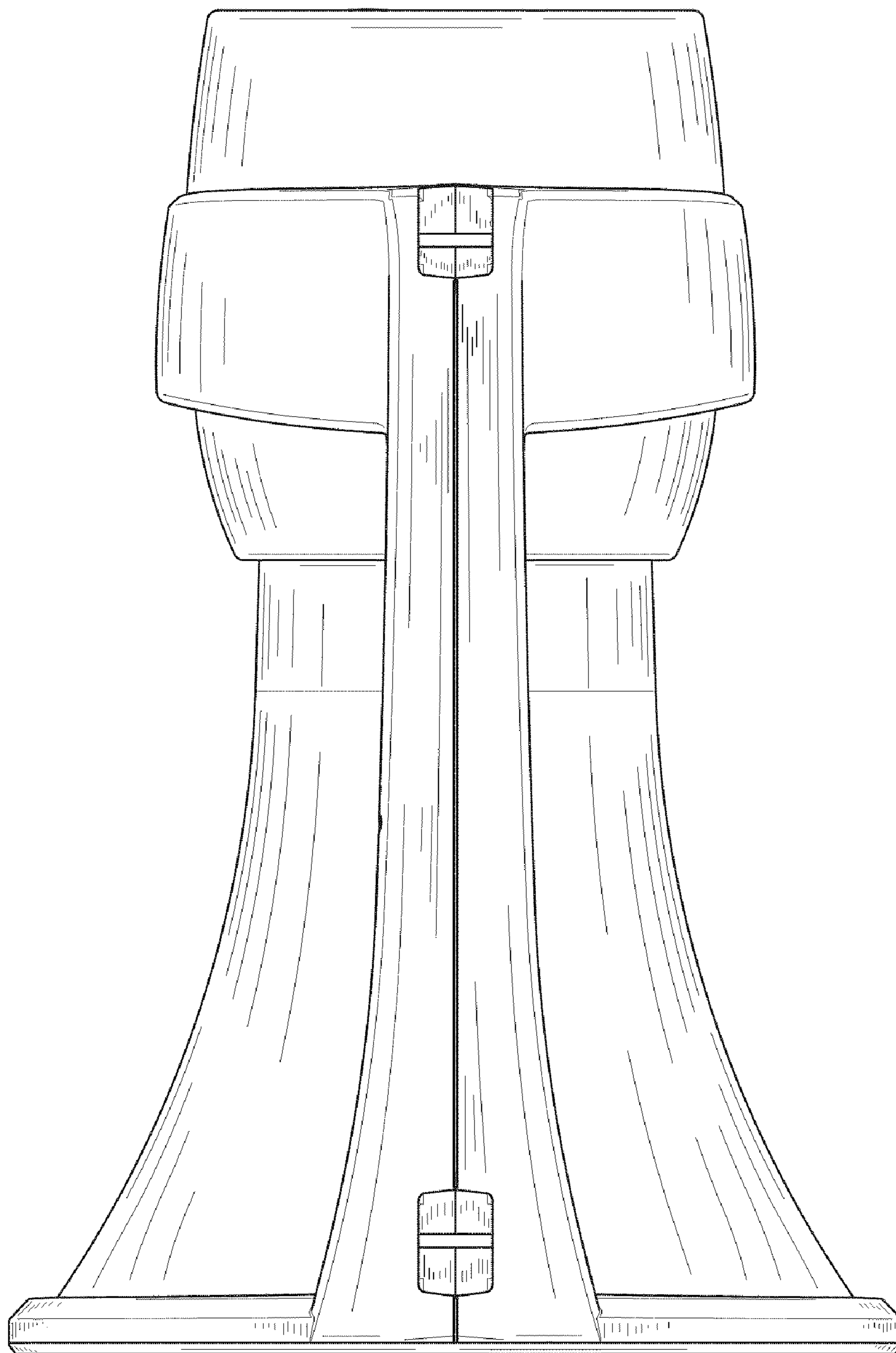

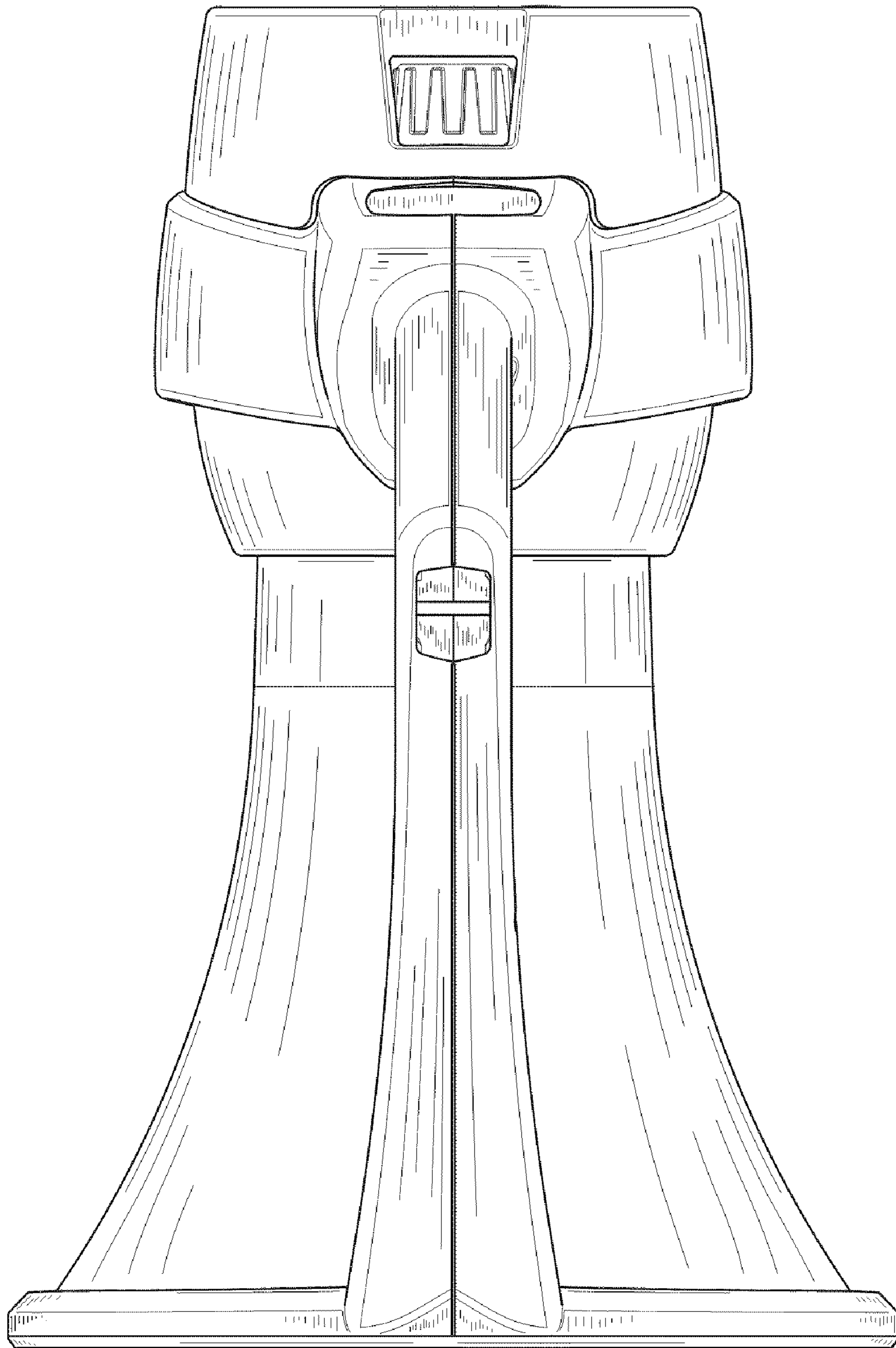
