(57) **CLAIM**

The ornamental design for a cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cover showing our new design with an environmental electronic device shown removed from the cover;

FIG. 2 is another front perspective view thereof, shown without the environmental electronic device;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof;

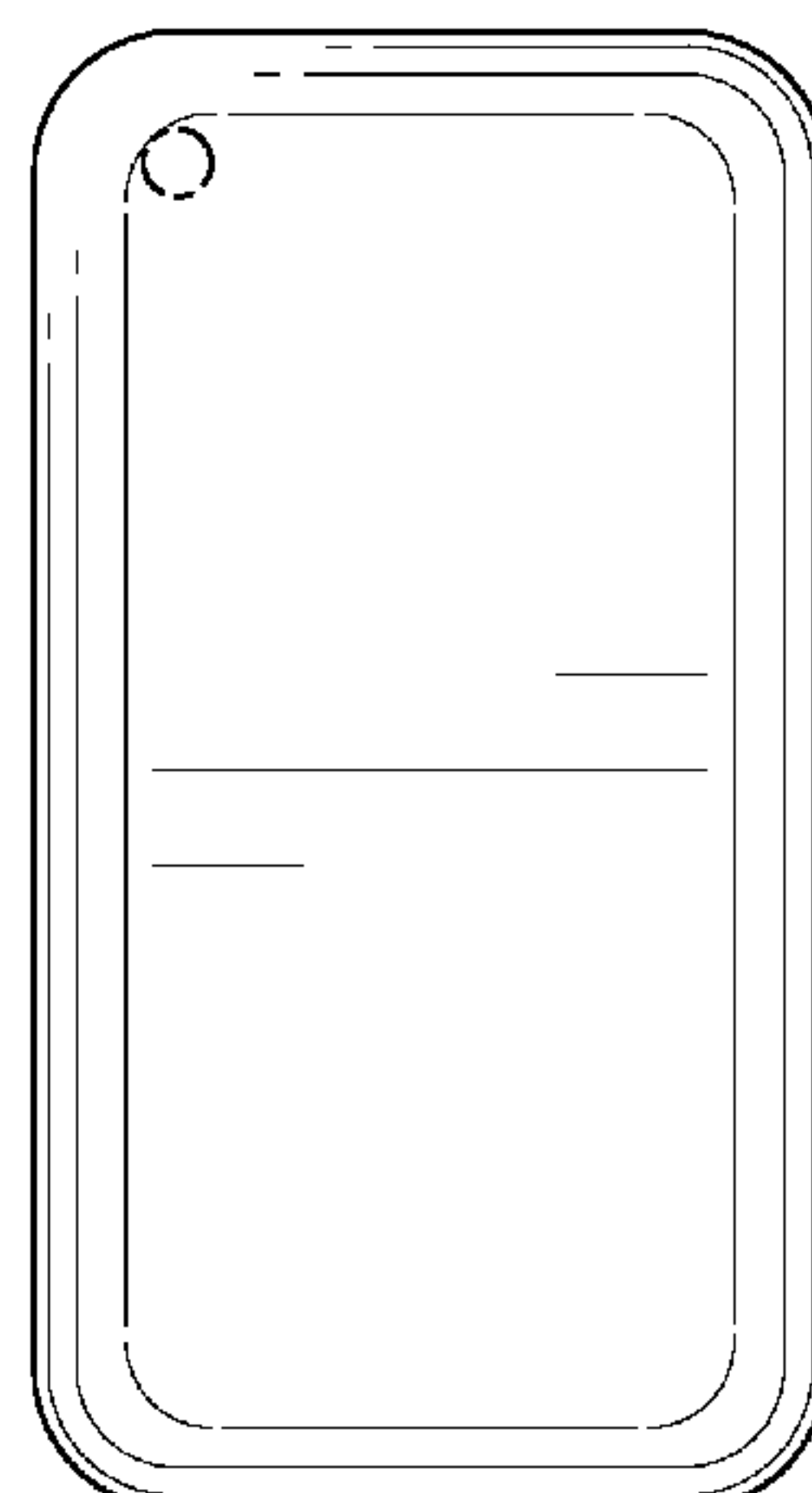
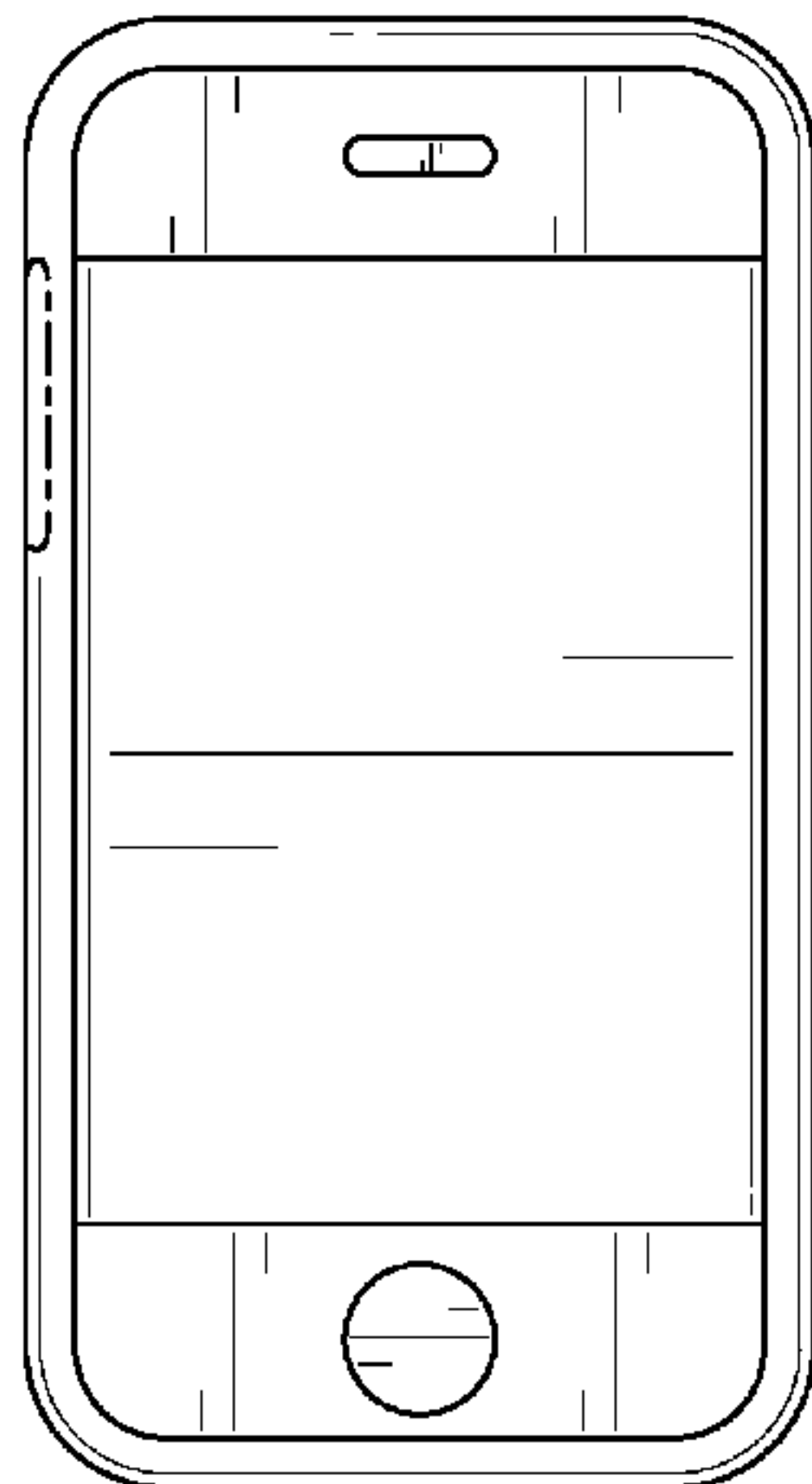
FIG. 7 is right side view thereof;

FIG. 8 is a top plan view thereof; and,

FIG. 9 is a bottom plan view thereof.

Examples of an electronic device with which the cover may be used are a computer, a portable or hand-held device, a personal digital assistant, a communication device (e.g., cellular telephone), a novelty item, toy, and/or the like.

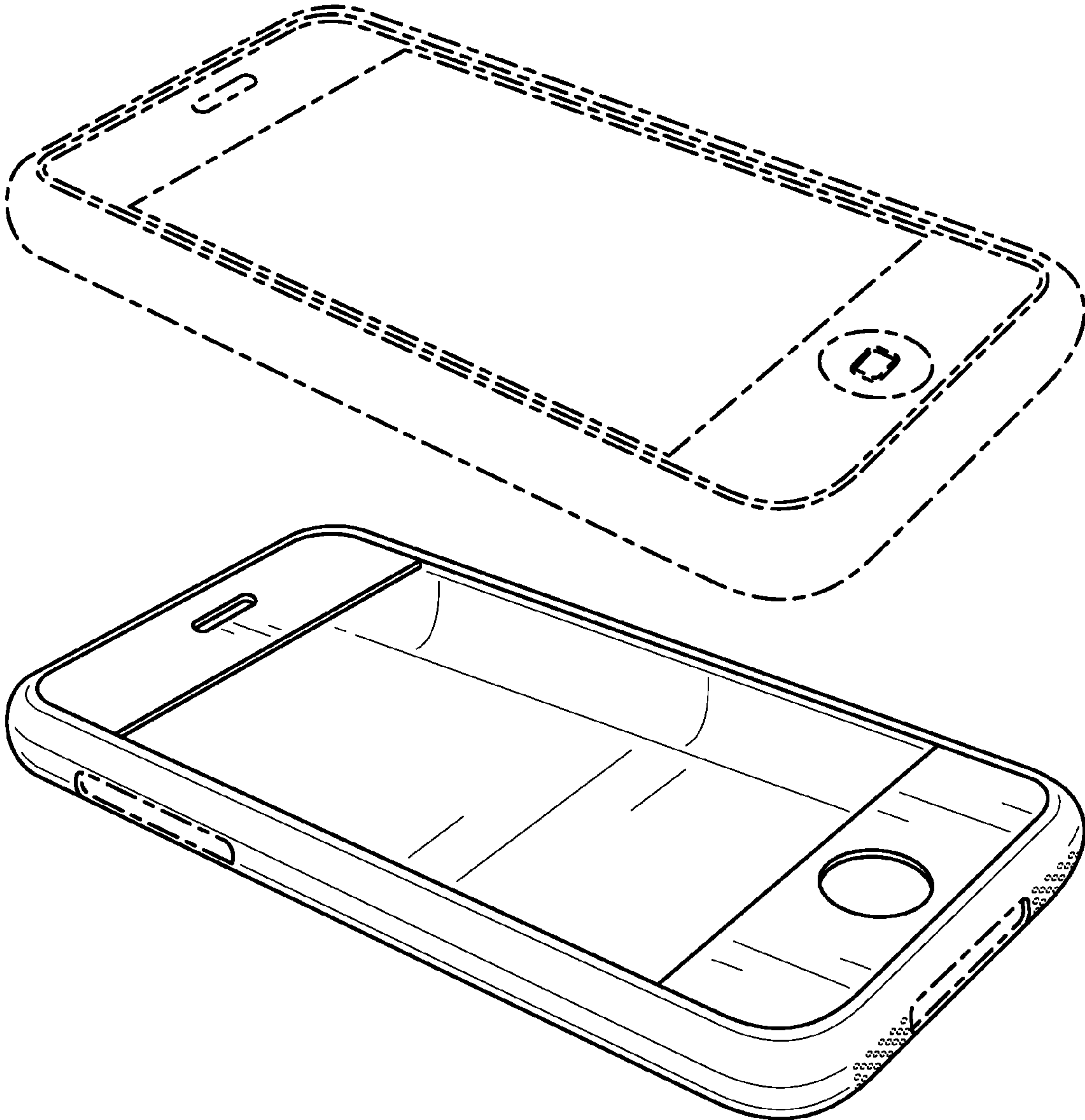

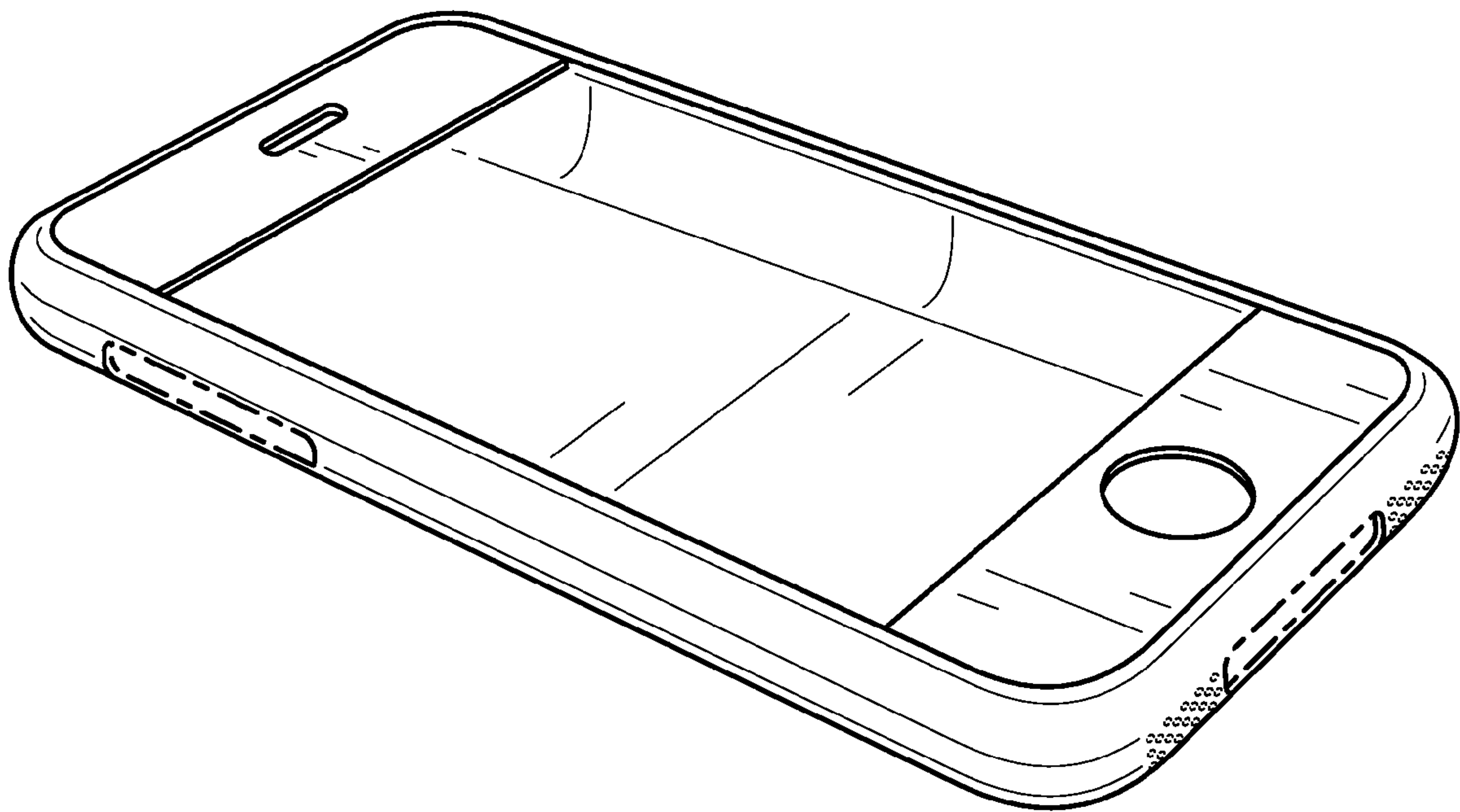

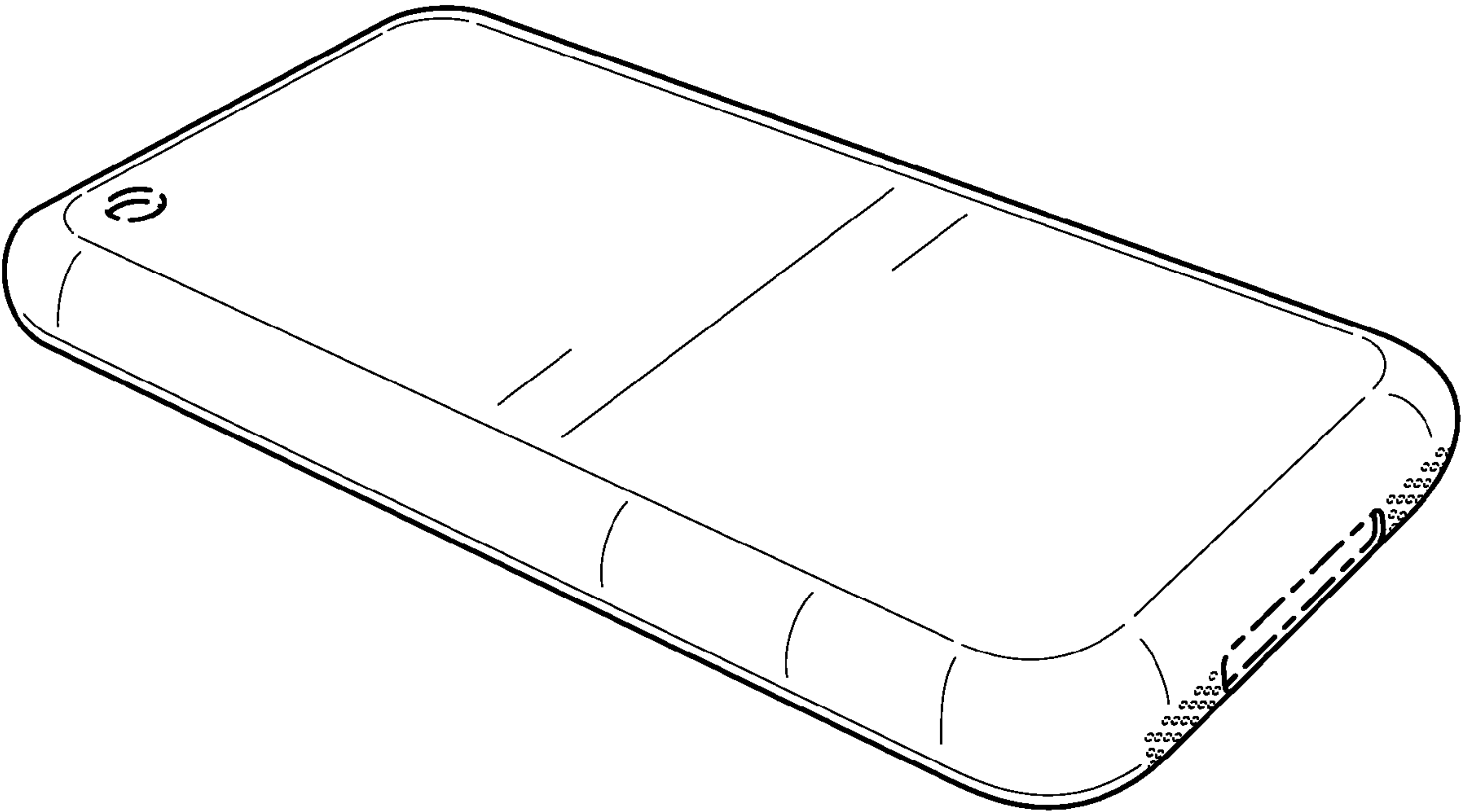

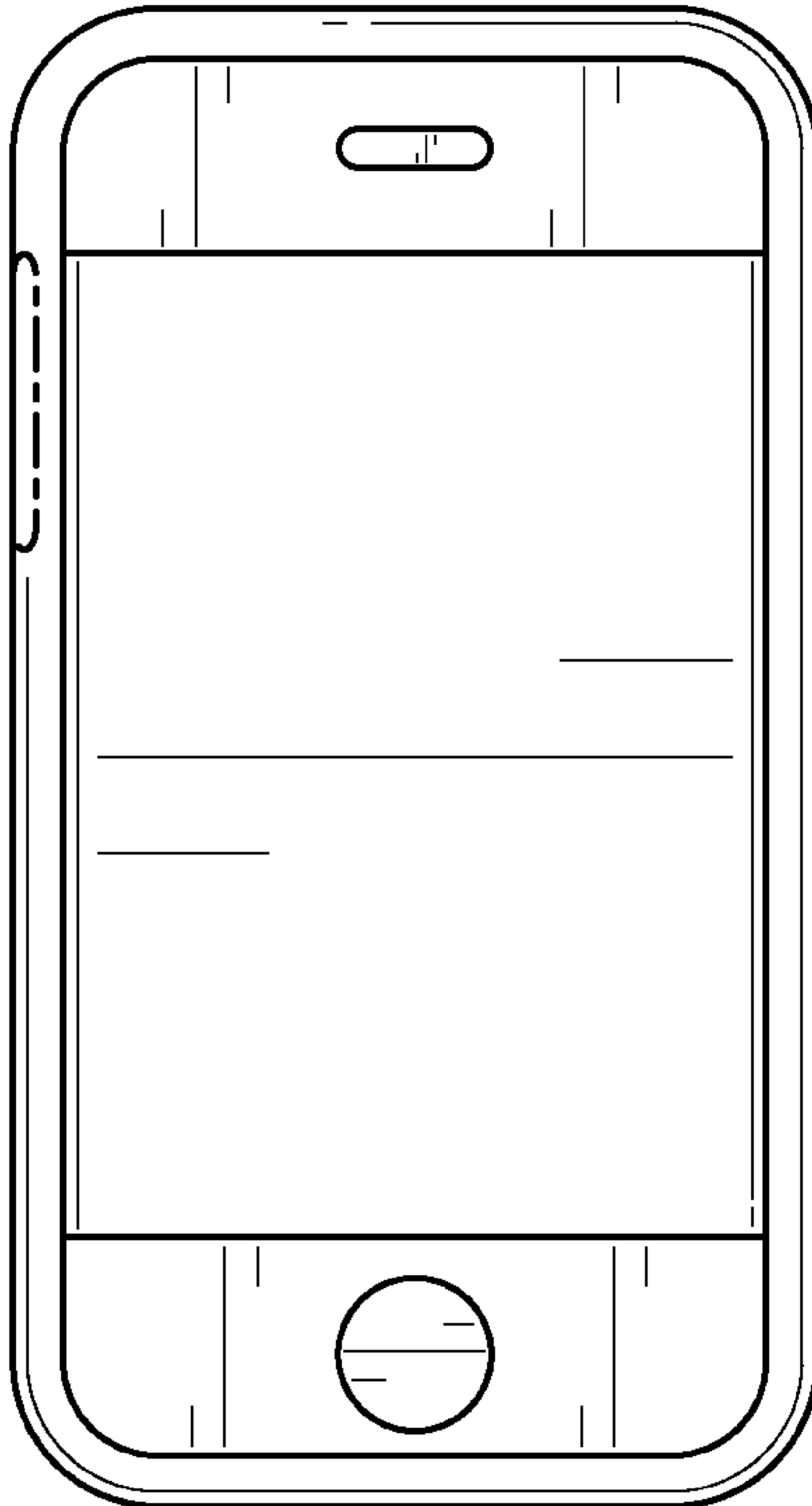

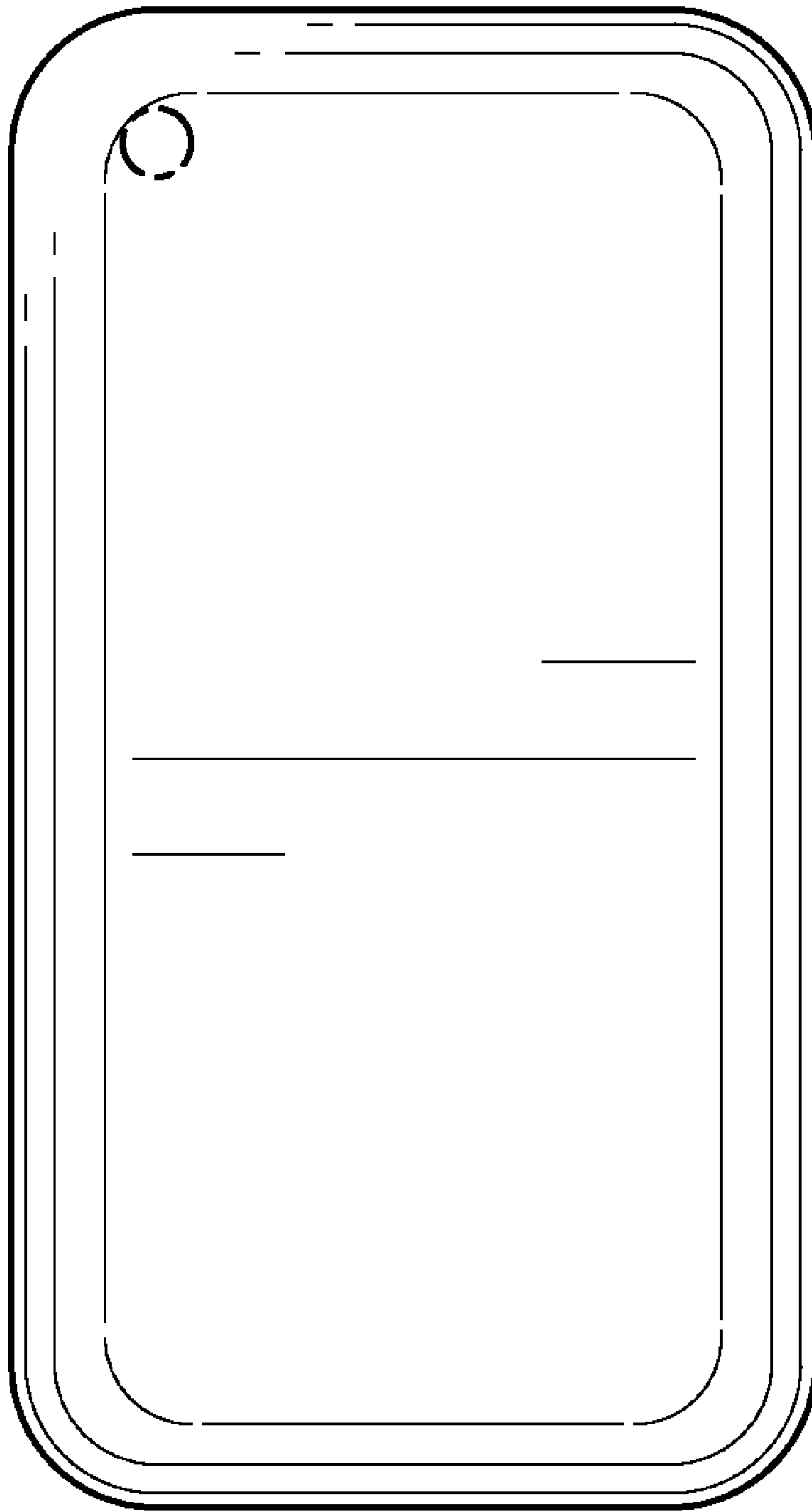

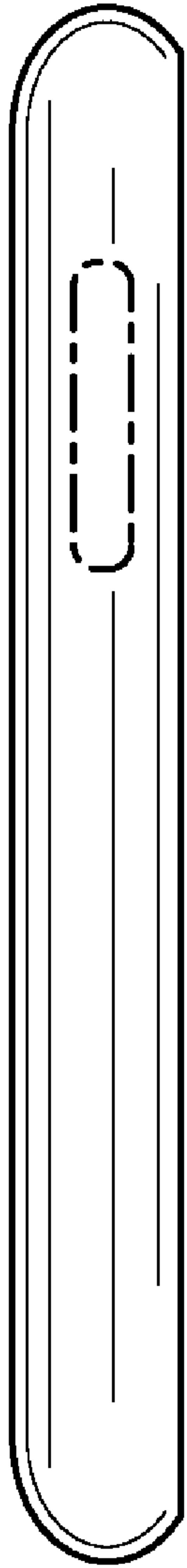

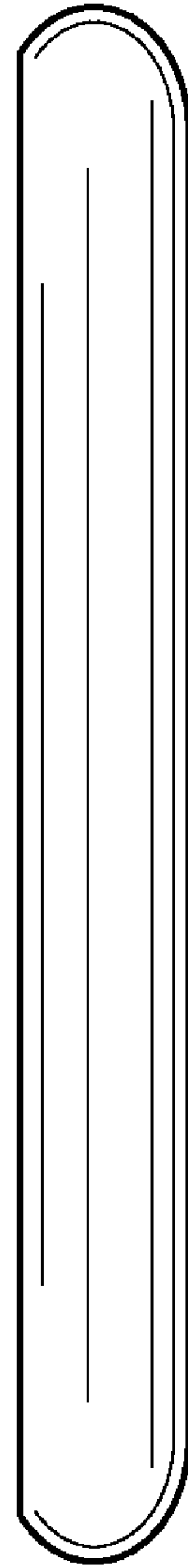

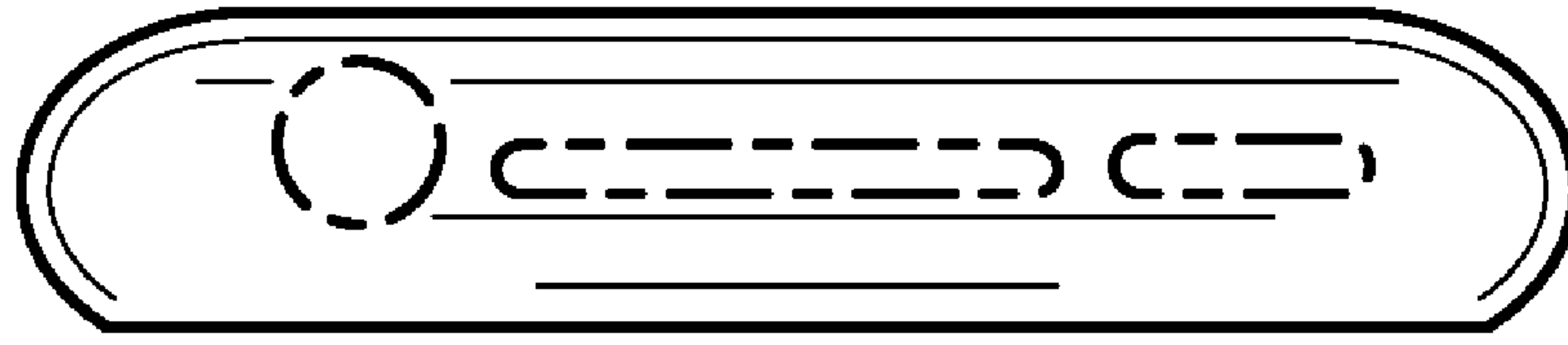

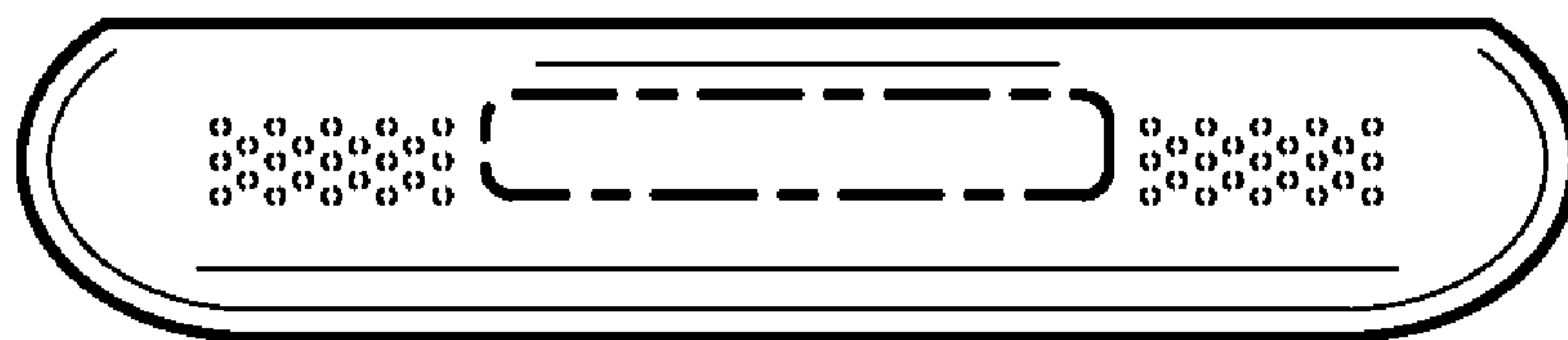
