(57) **CLAIM**

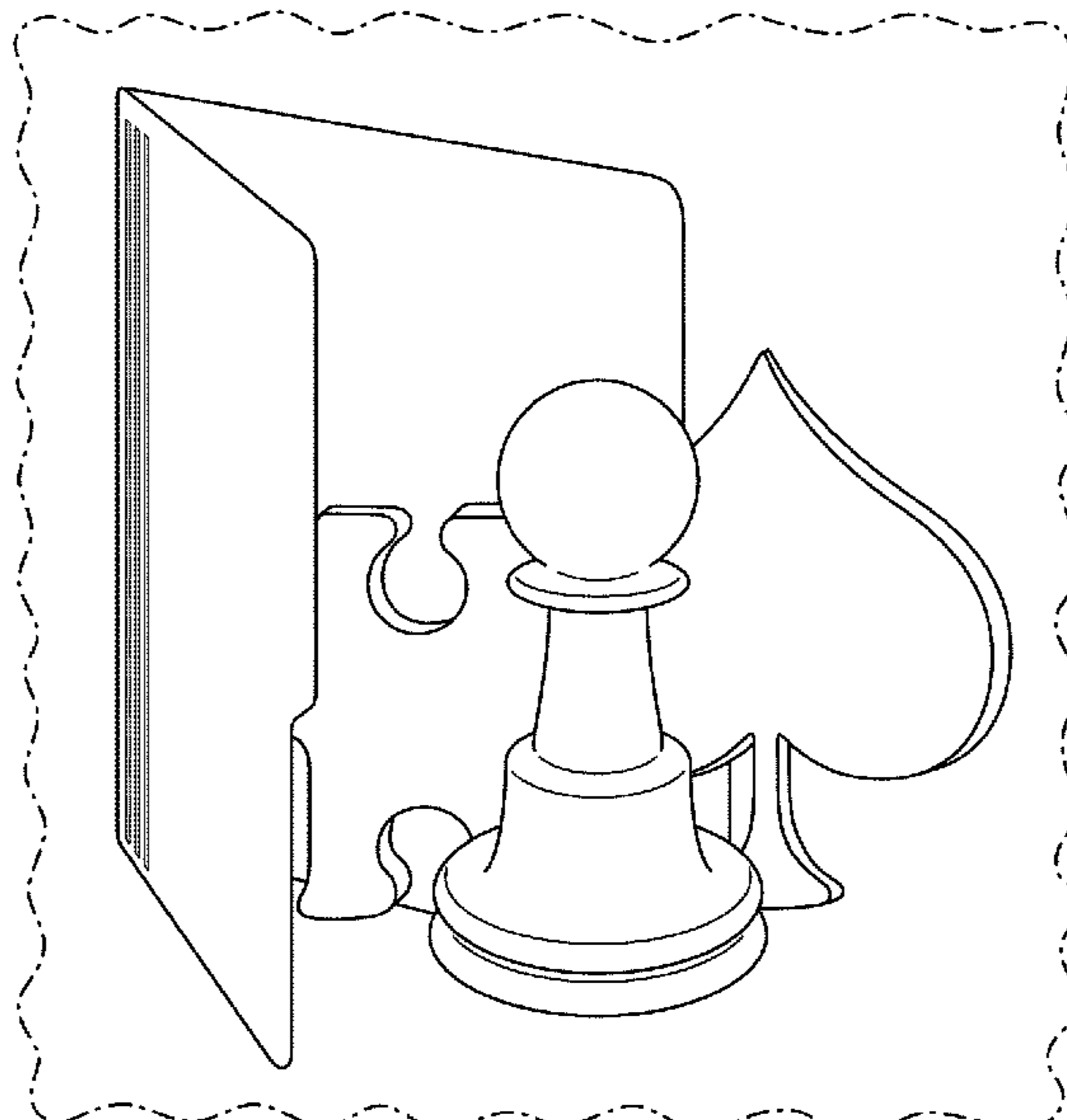
The ornamental design for a portion of a display screen with an icon, as shown and described.

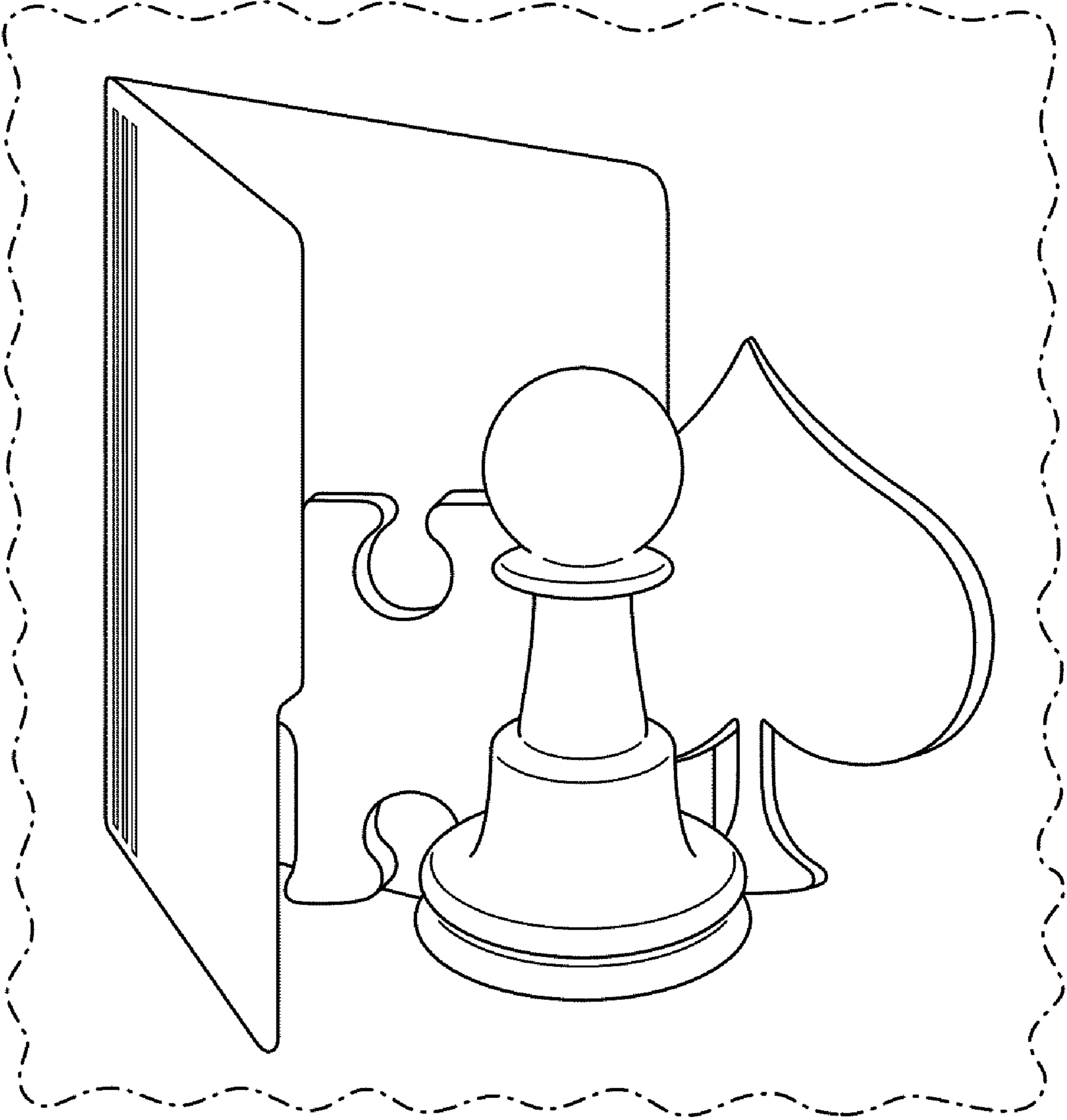
