An ornamental design for a notepaper dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a notepaper dispenser showing my new design;

FIG. 4 is a right side view thereof;

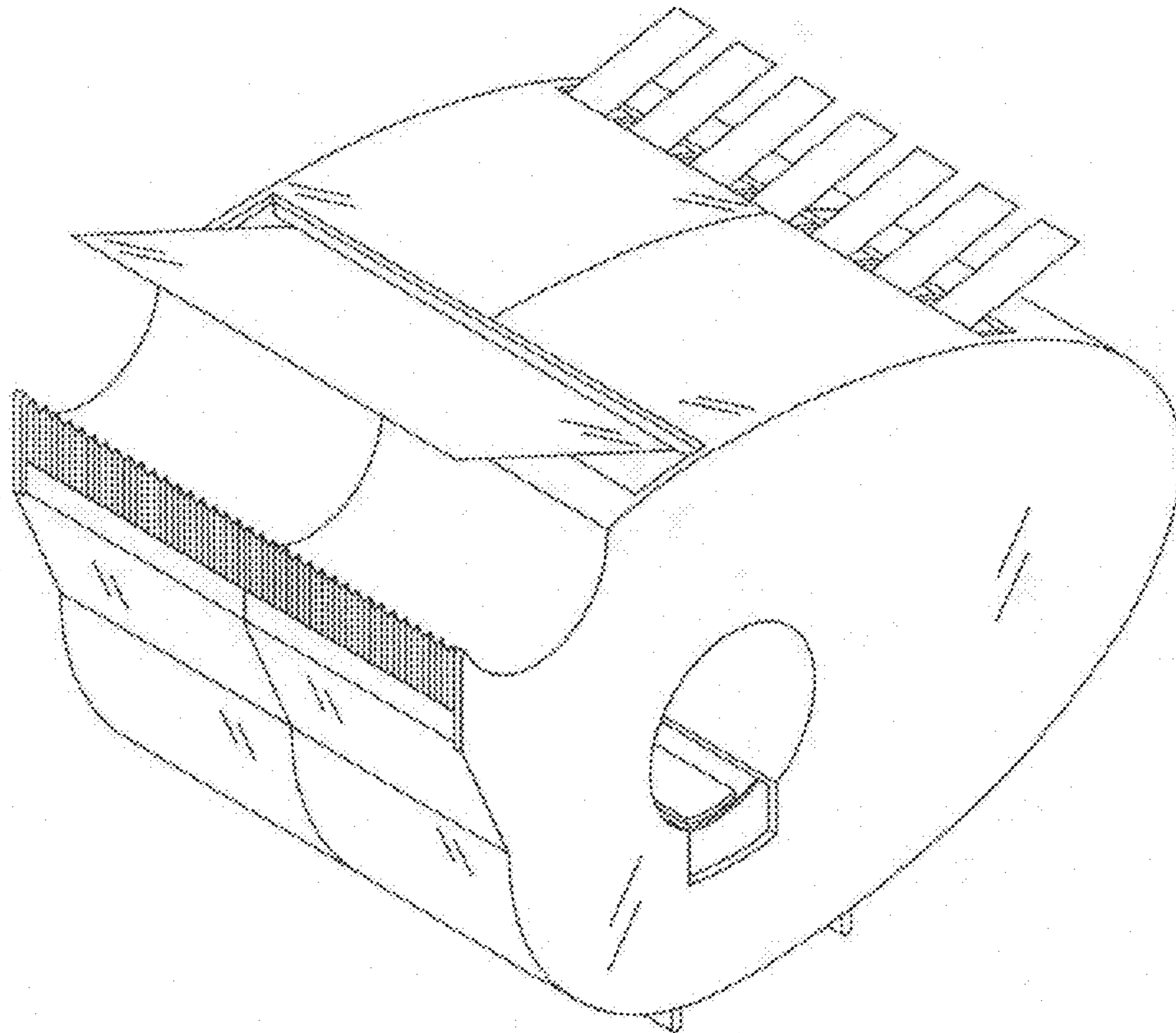
FIG. 5 is a top plan view thereof;

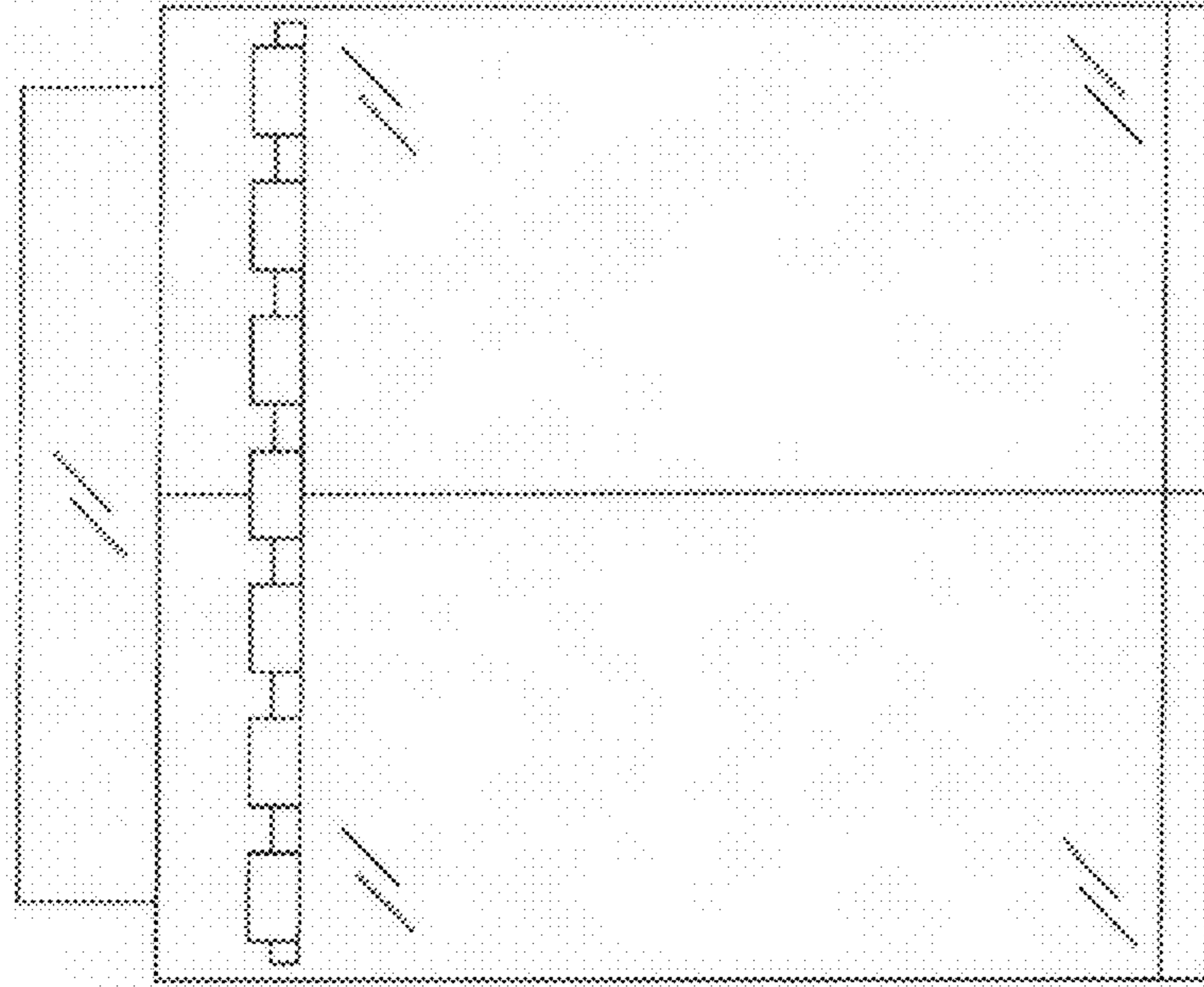

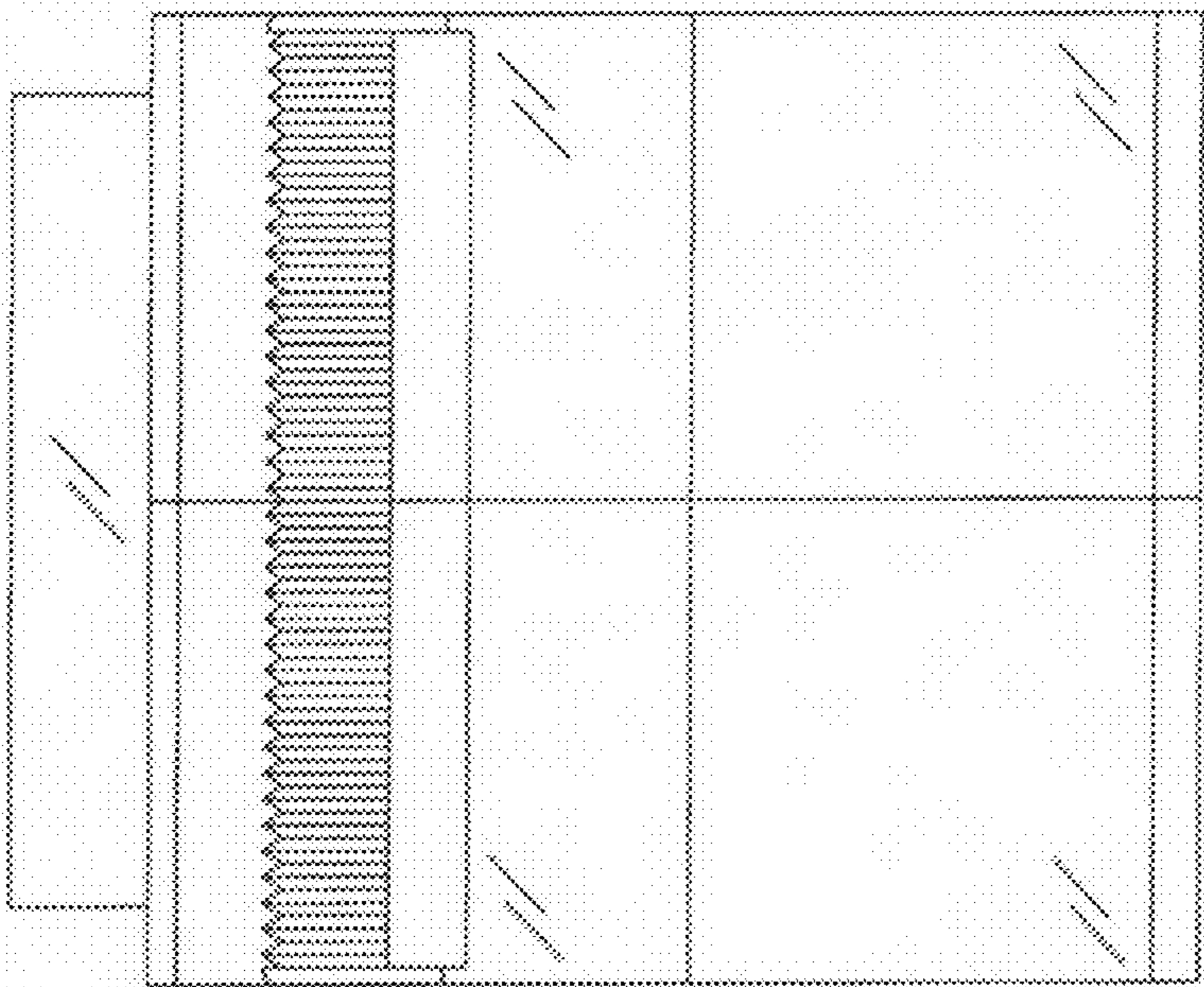

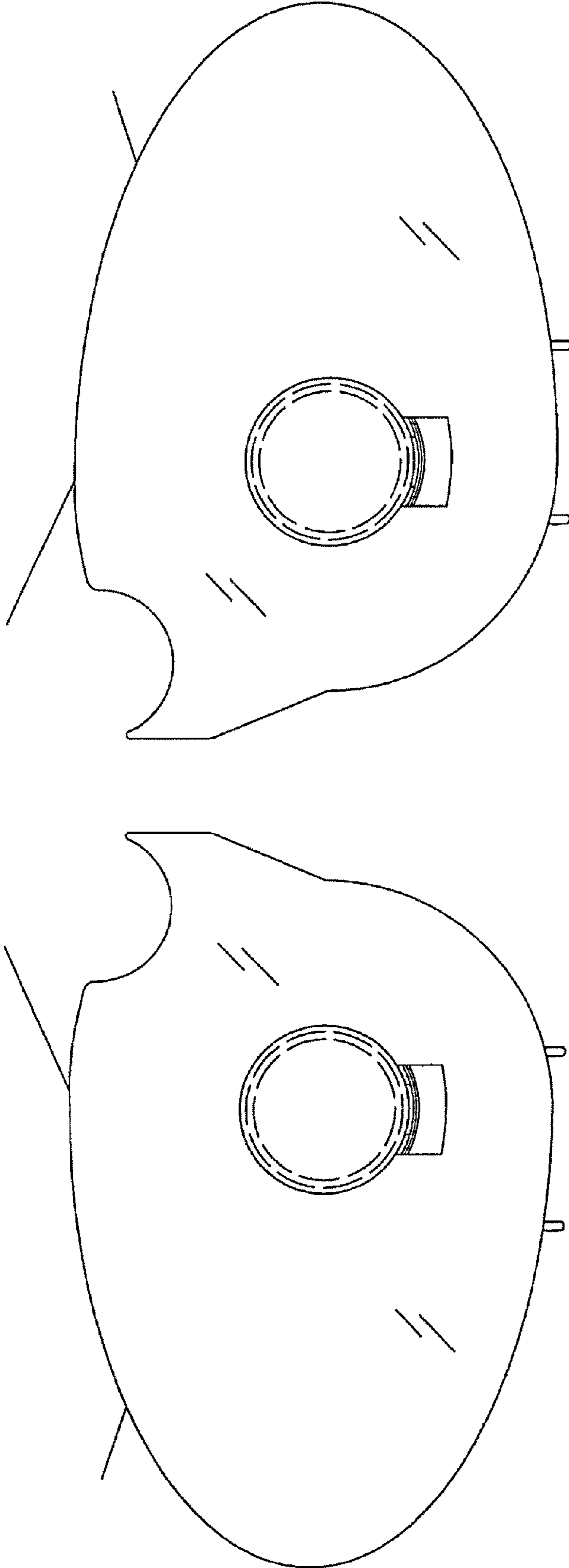

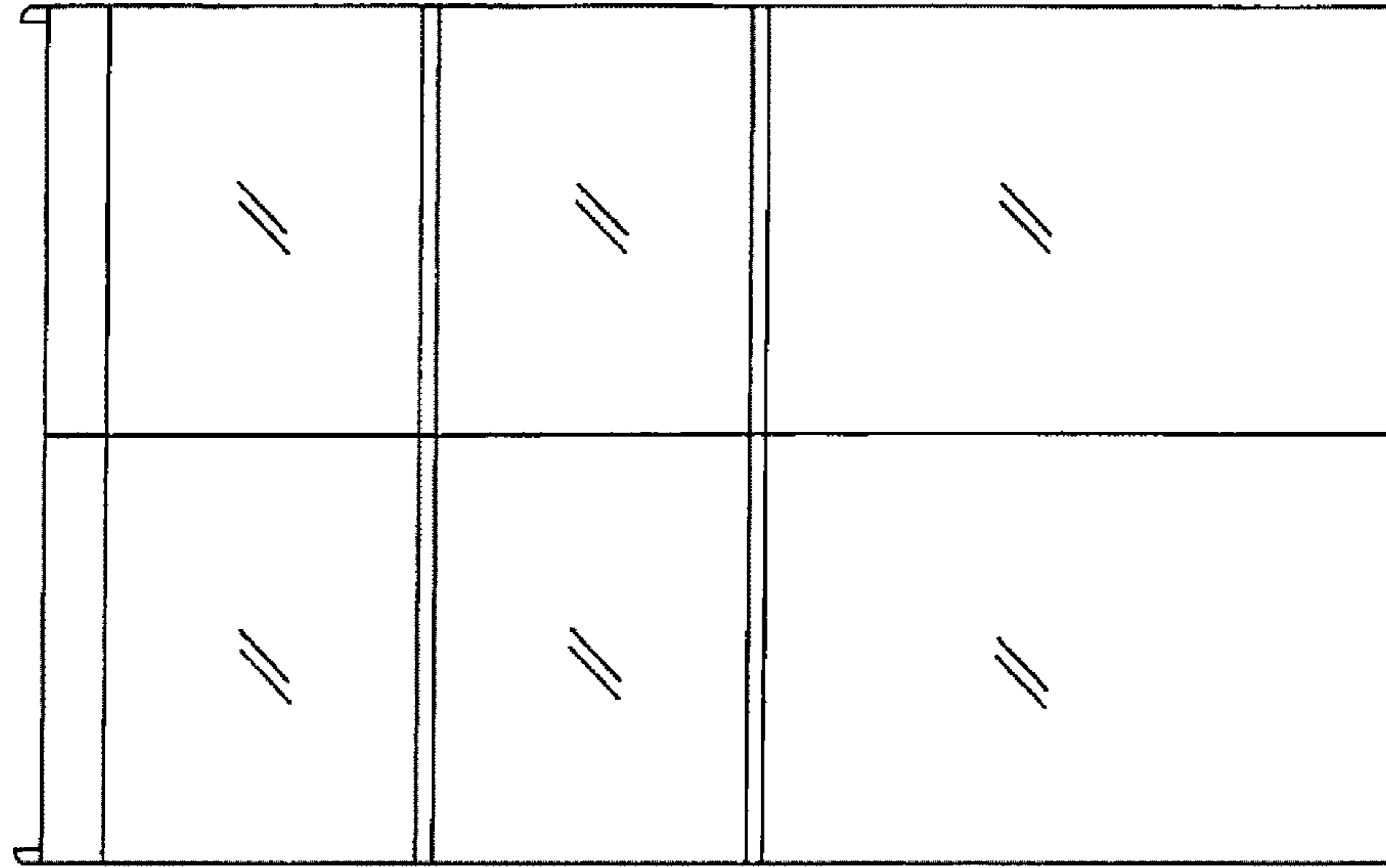

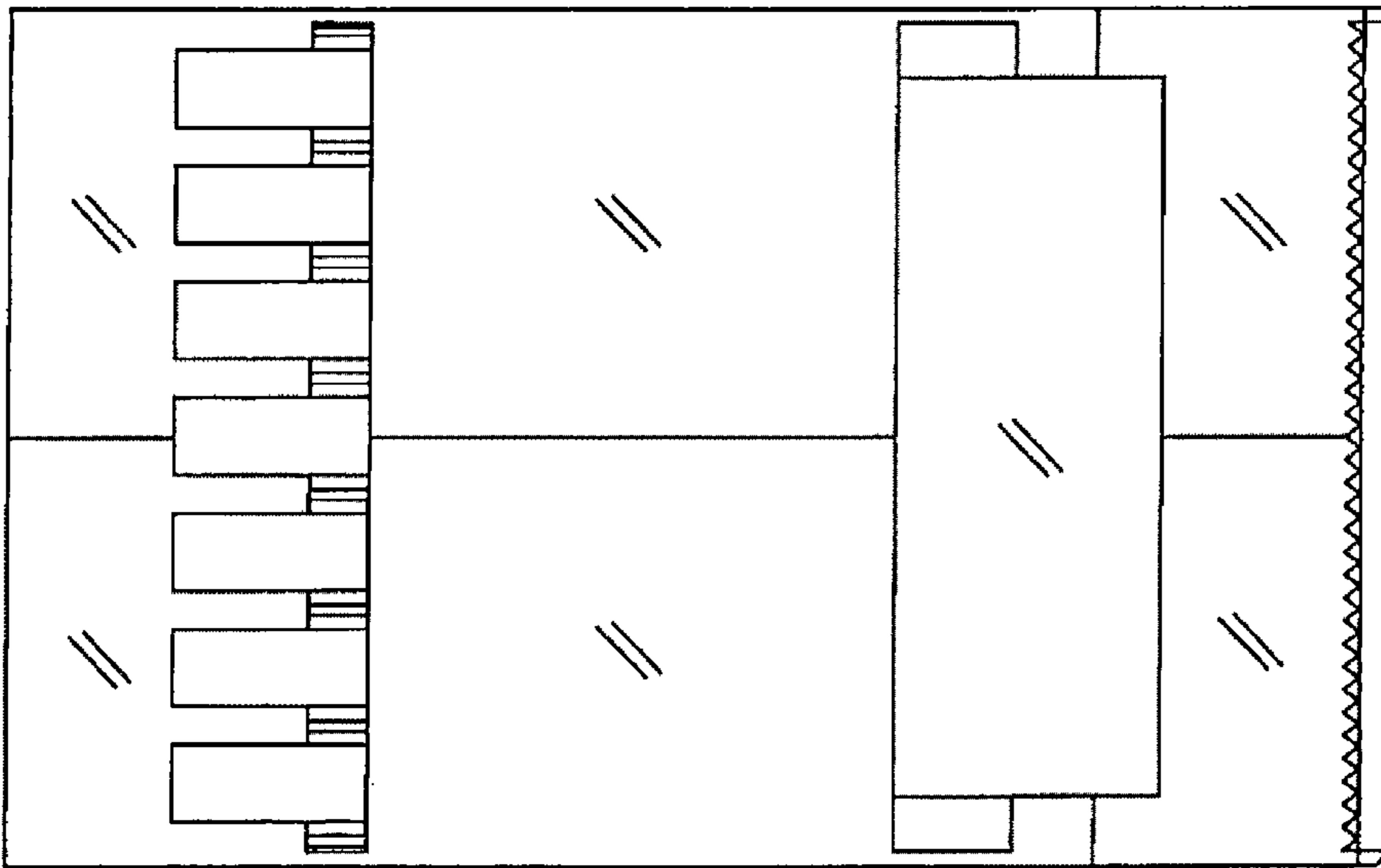

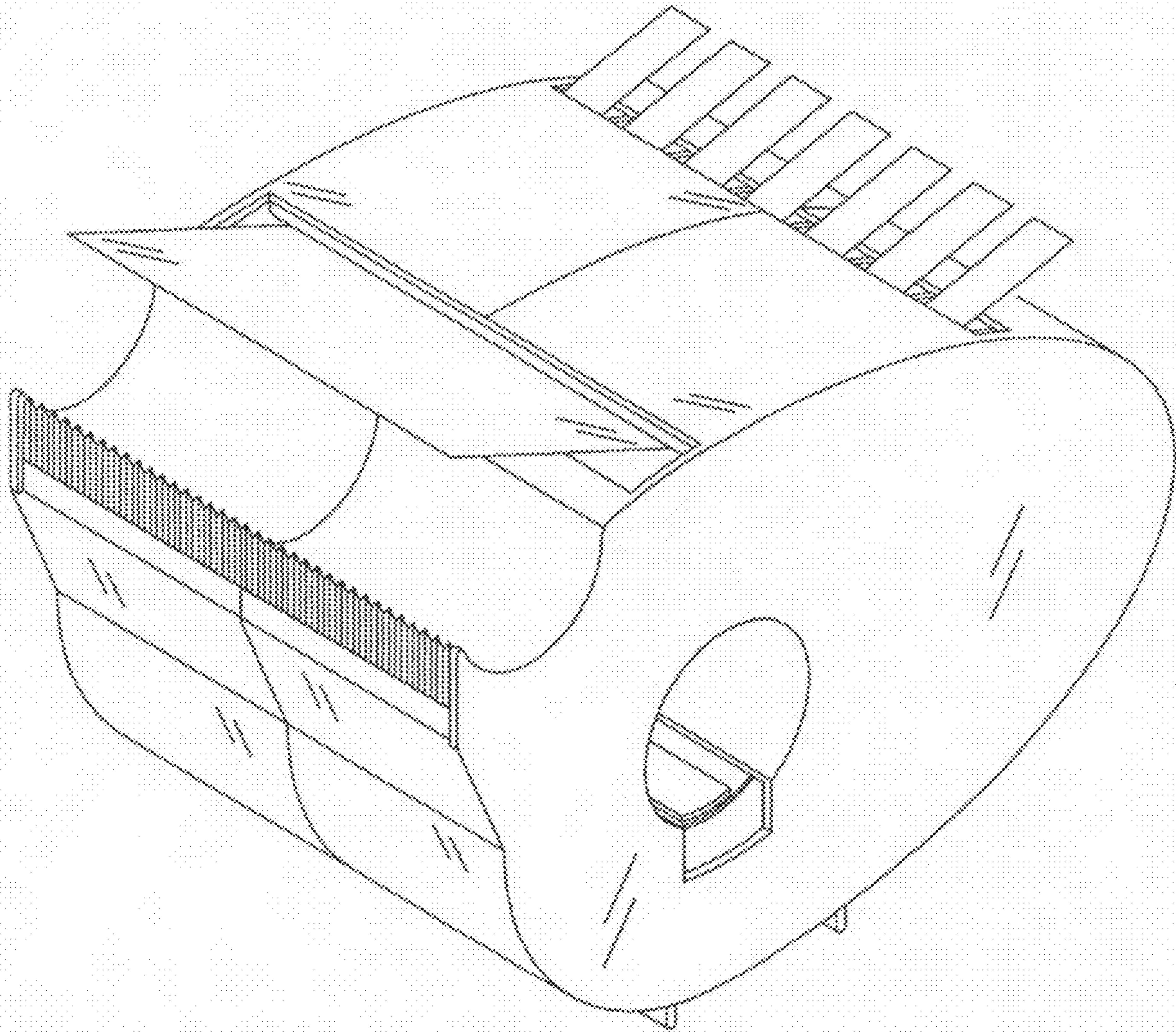
