The ornamental design for a magazine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the first embodiment of the magazine embodying our new design as claimed herein. FIG. 2 is rear perspective view of the magazine shown in FIG. 1.

FIG. 3 is a left side view of the magazine shown in FIG. 1.

FIG. 4 is a right side view of the magazine shown in FIG. 1.

FIG. 5 is a rear elevational view of the magazine shown in FIG. 1.

FIG. 6 is a front elevational view of the magazine shown in FIG. 1.

FIG. 7 is a top plan view of the magazine shown in FIG. 1.

FIG. 8 is a bottom plan view of the magazine shown in FIG. 1.

FIG. 9 is a front perspective view of a second embodiment of the magazine shown in FIG. 1.

FIG. 10 is a left side view of the magazine shown in FIG. 9.

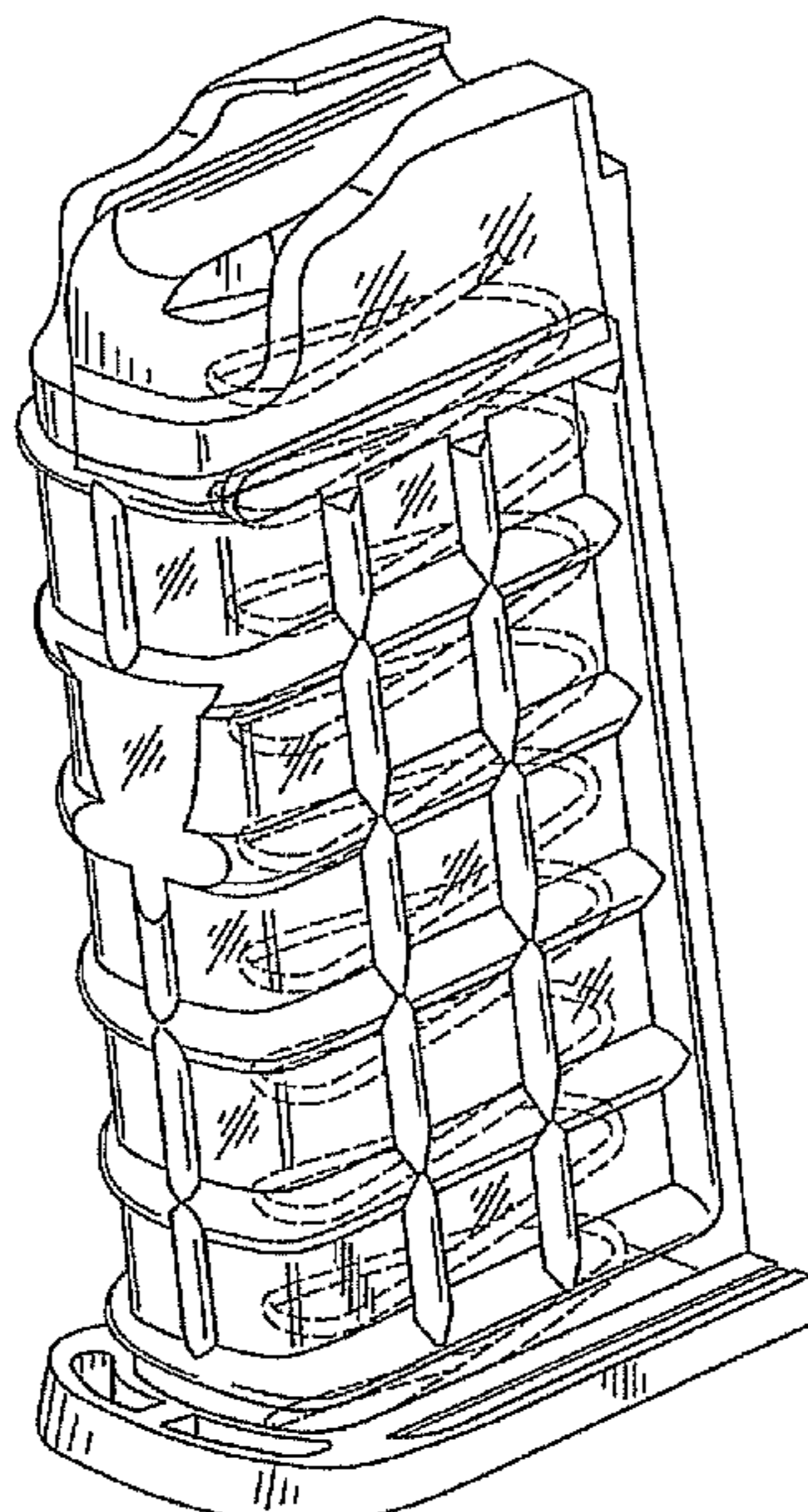
FIG. 11 is a front perspective view of an alternate embodiment of the magazine shown in FIG. 1.

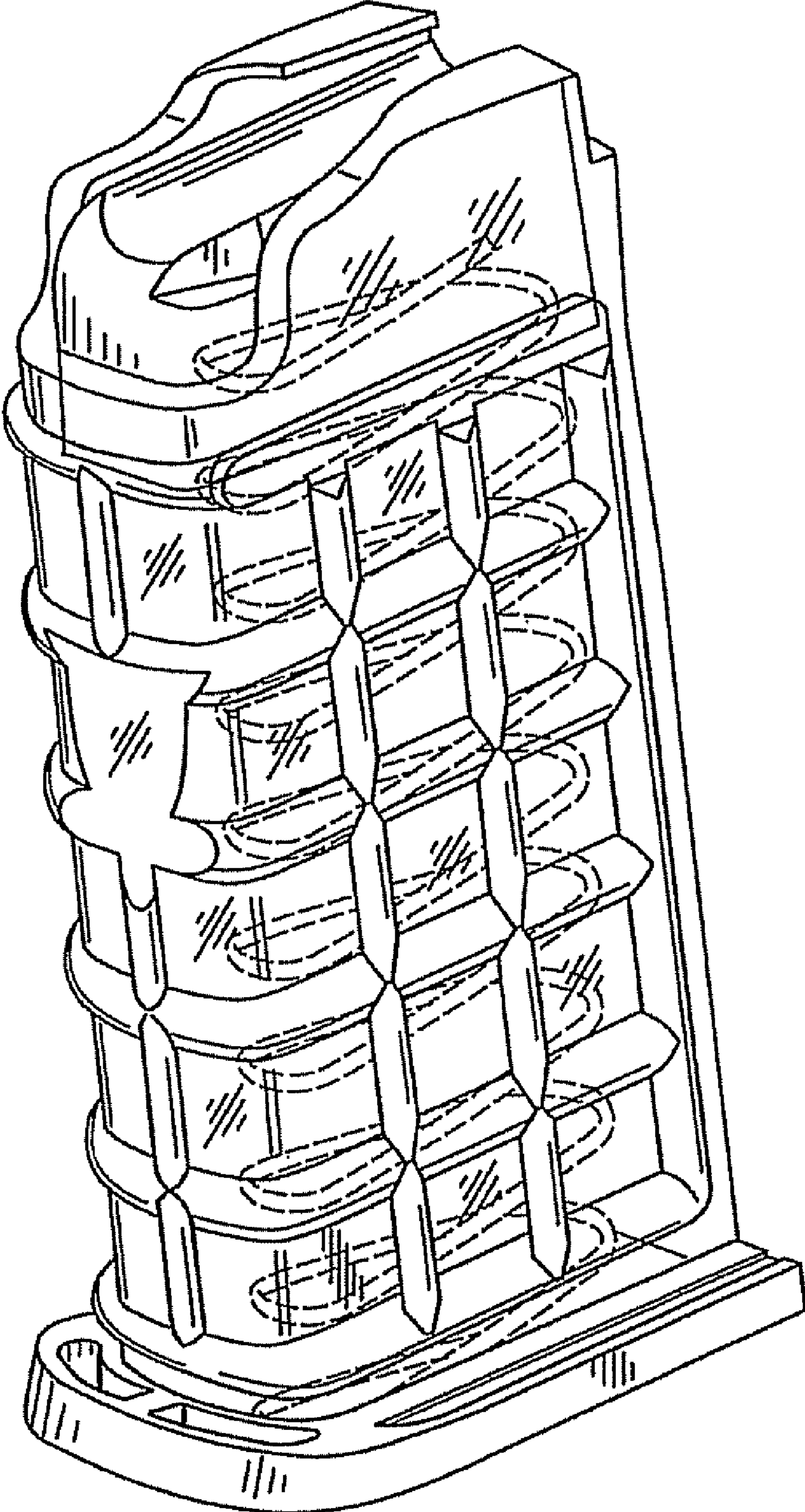

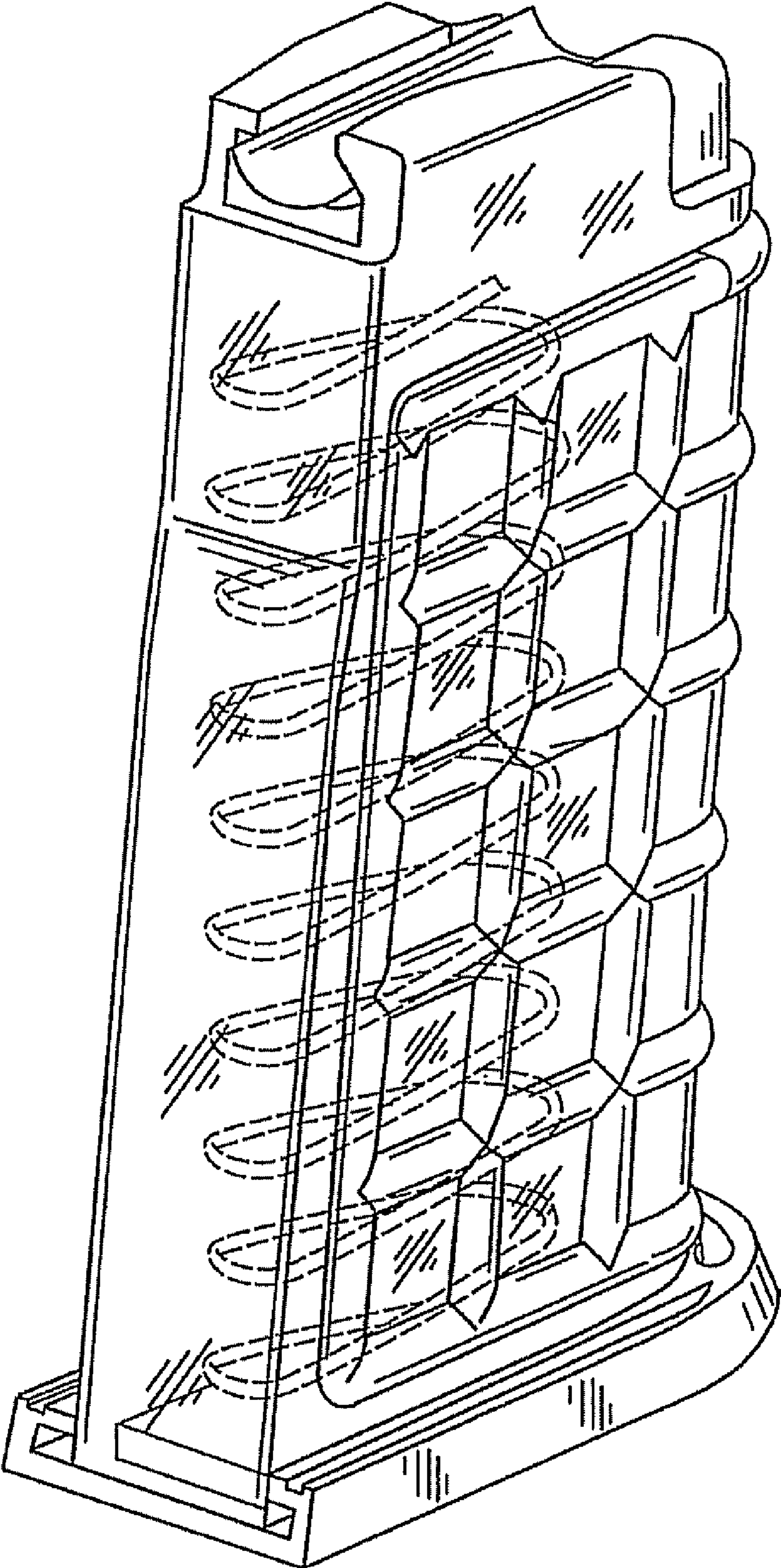

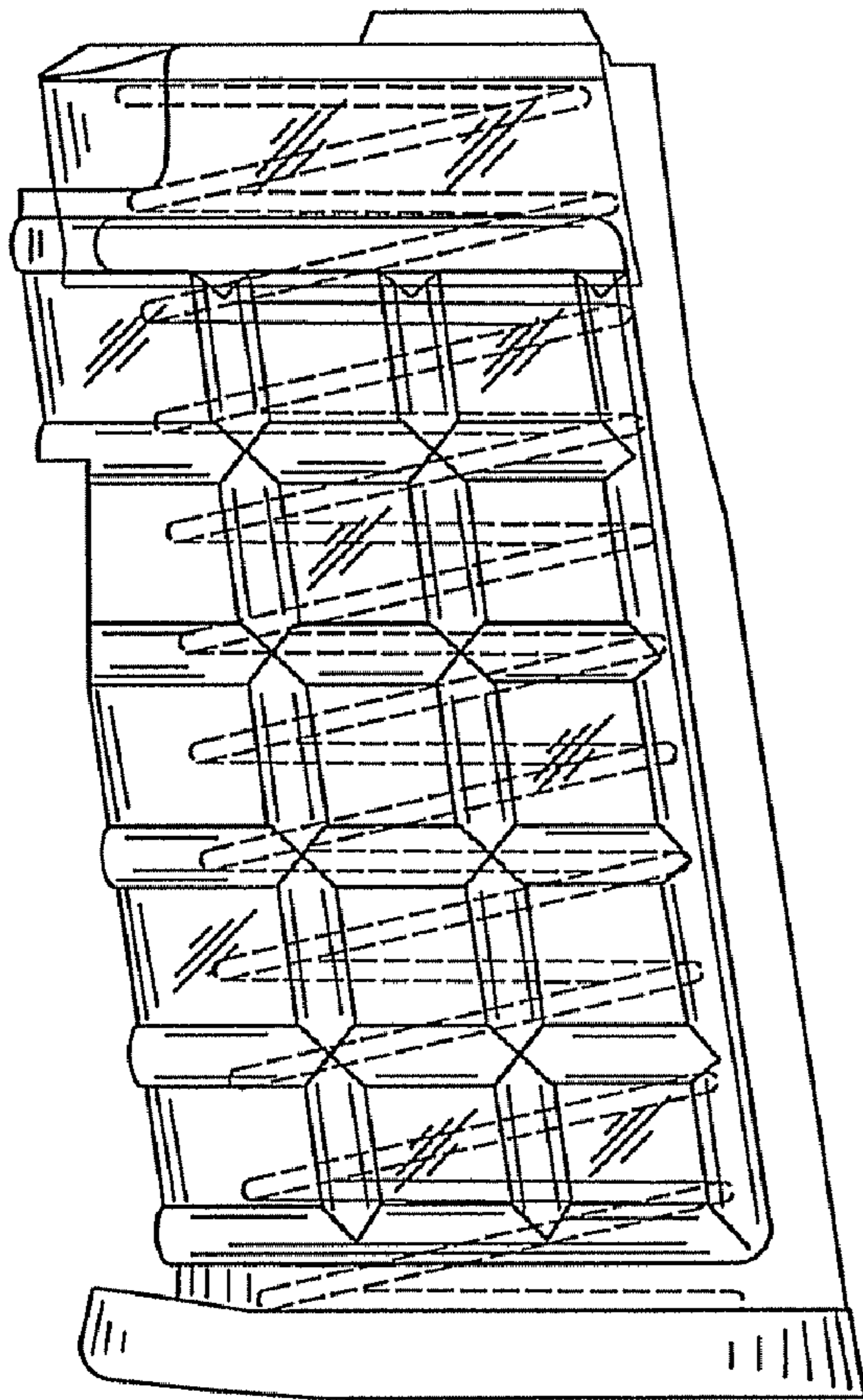

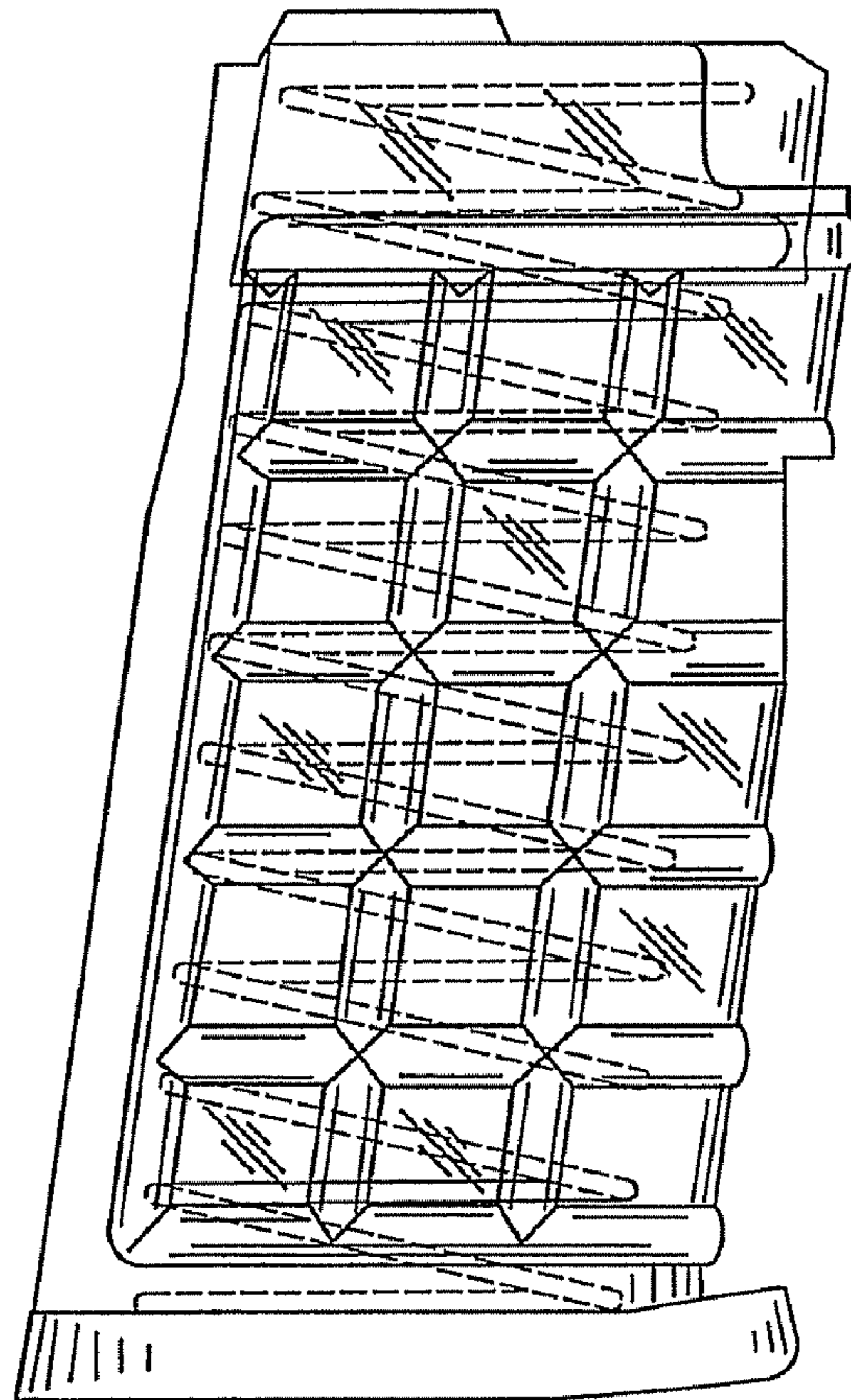

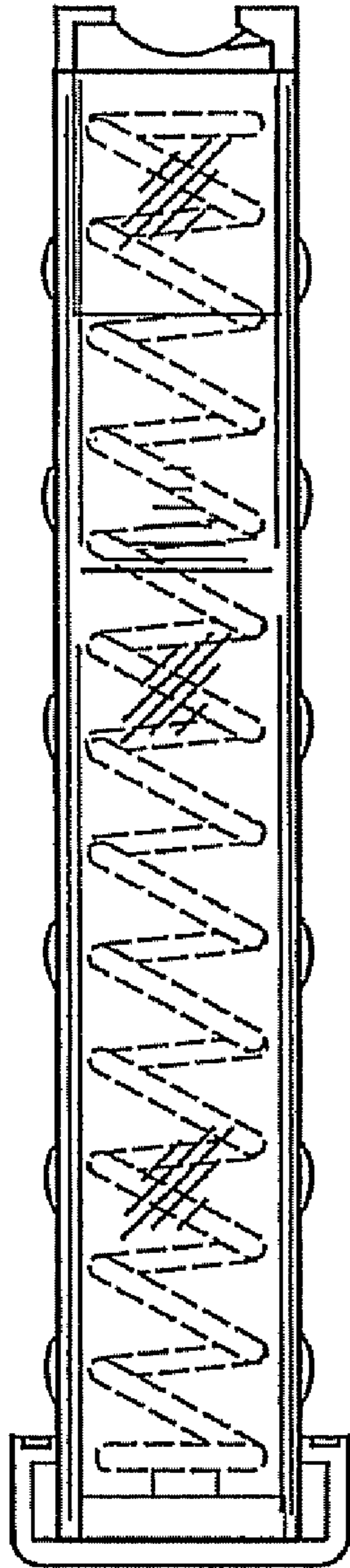

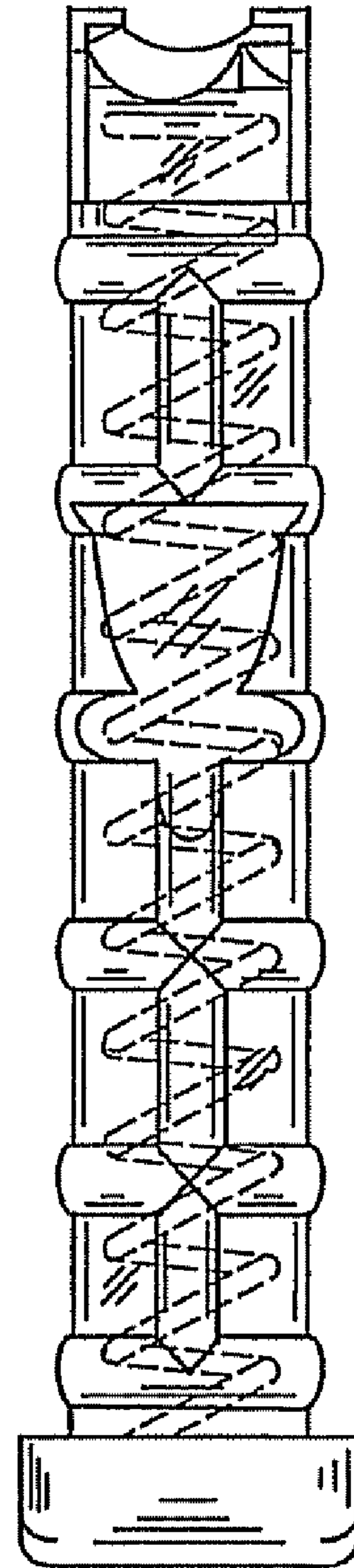

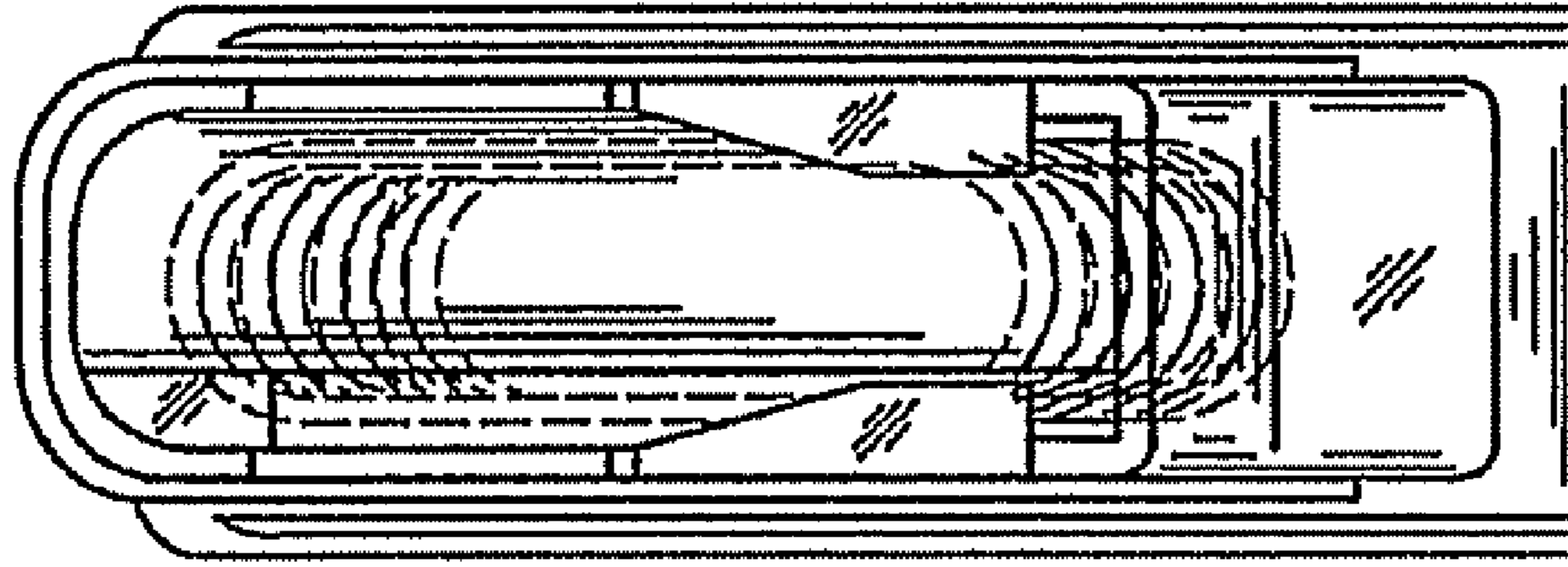

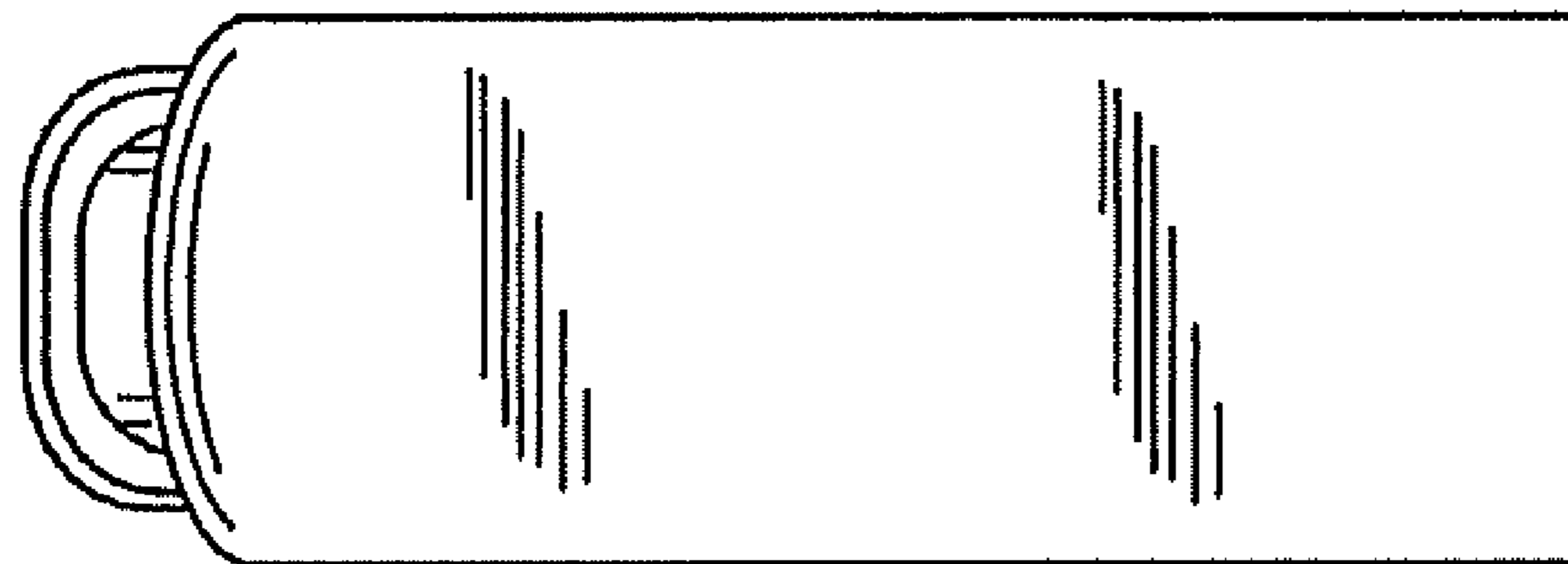

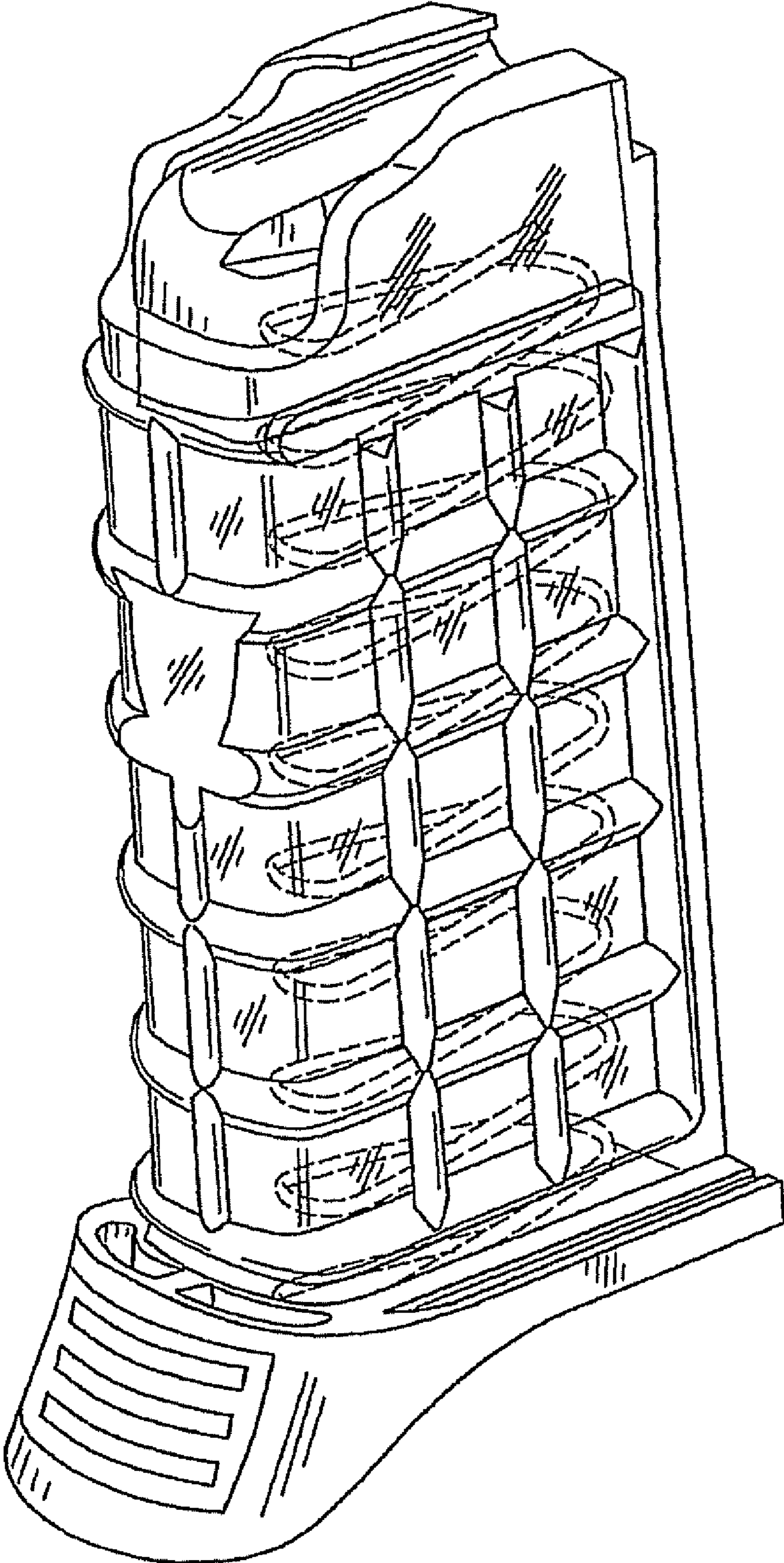

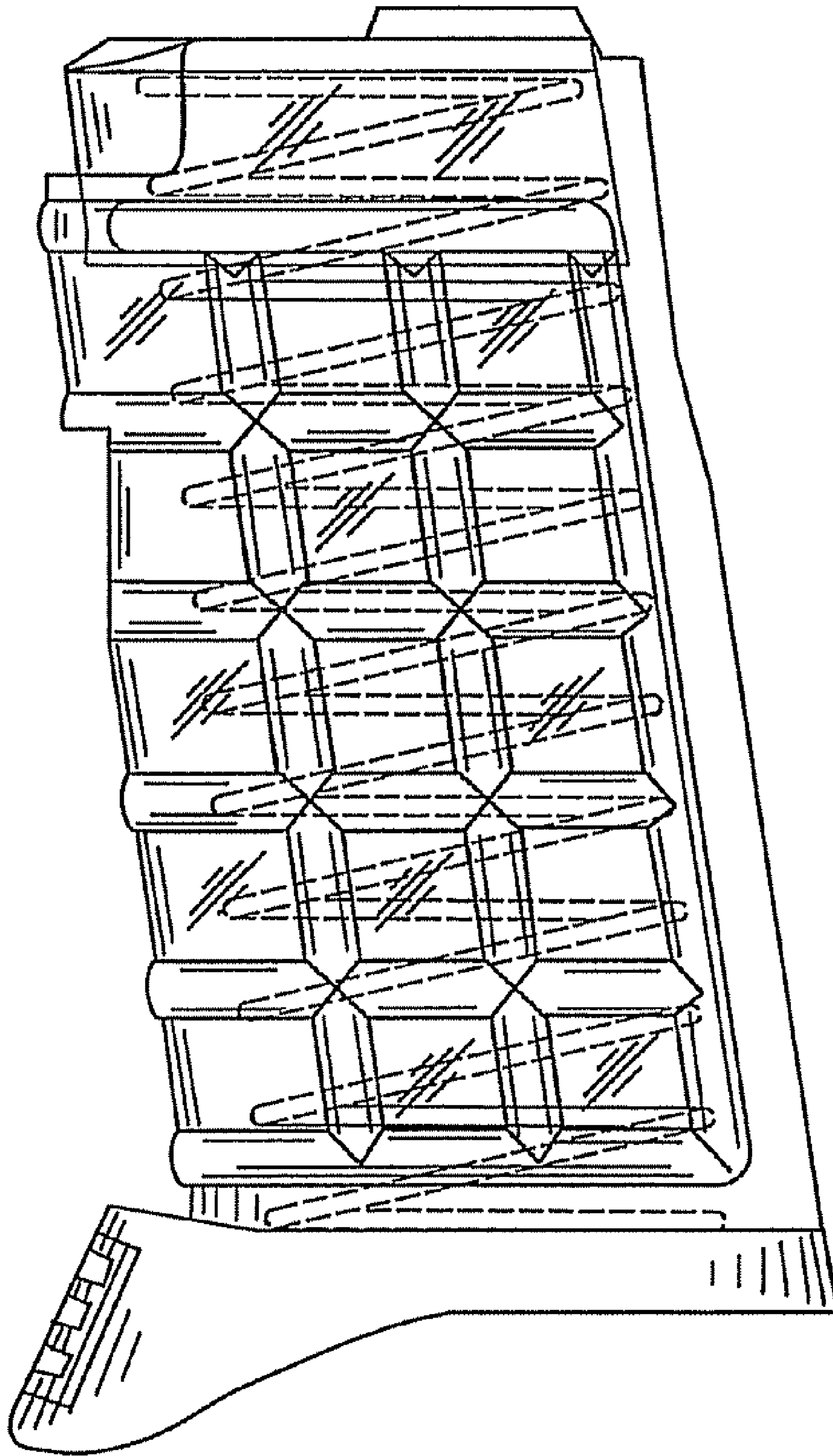

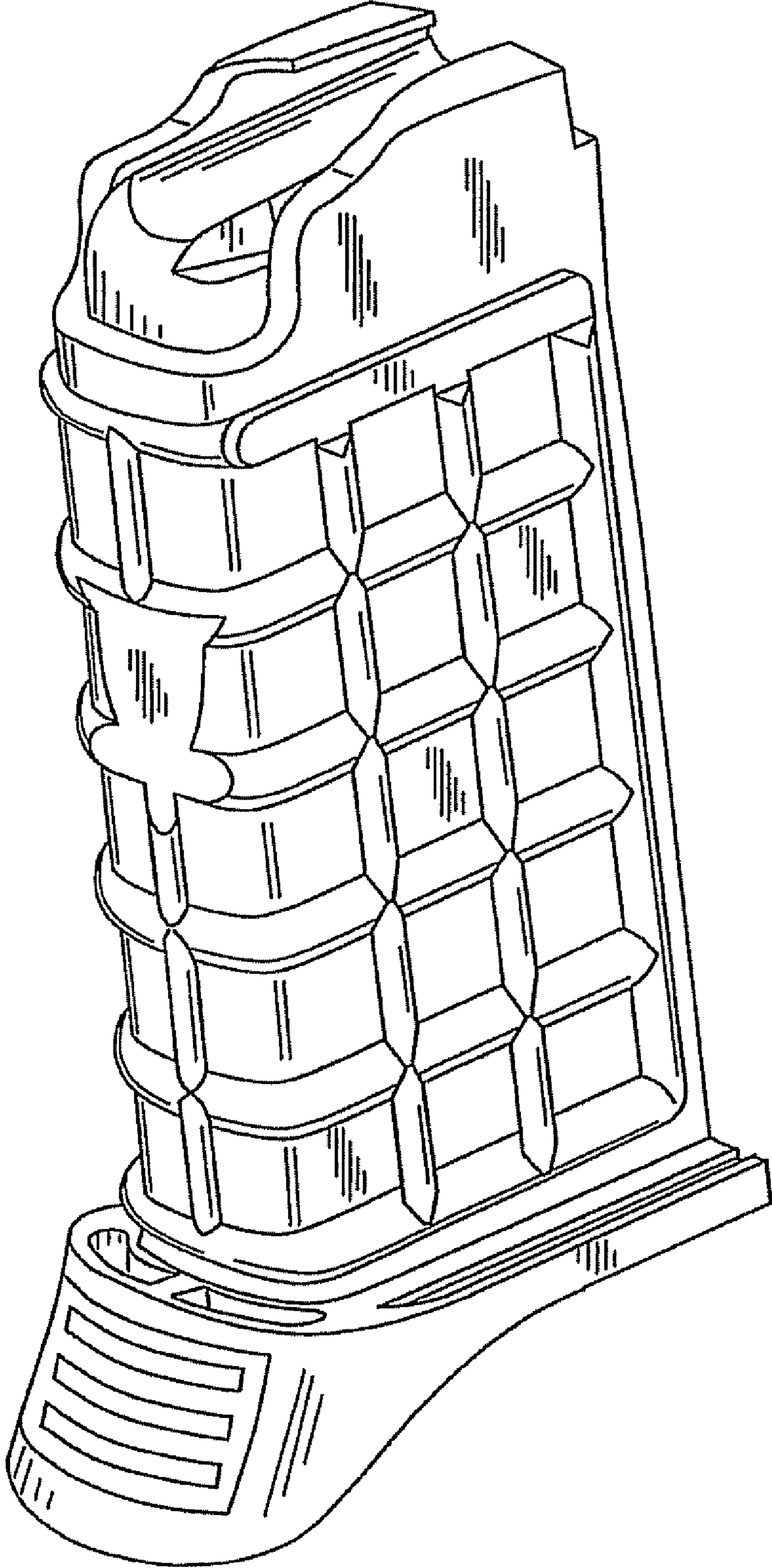

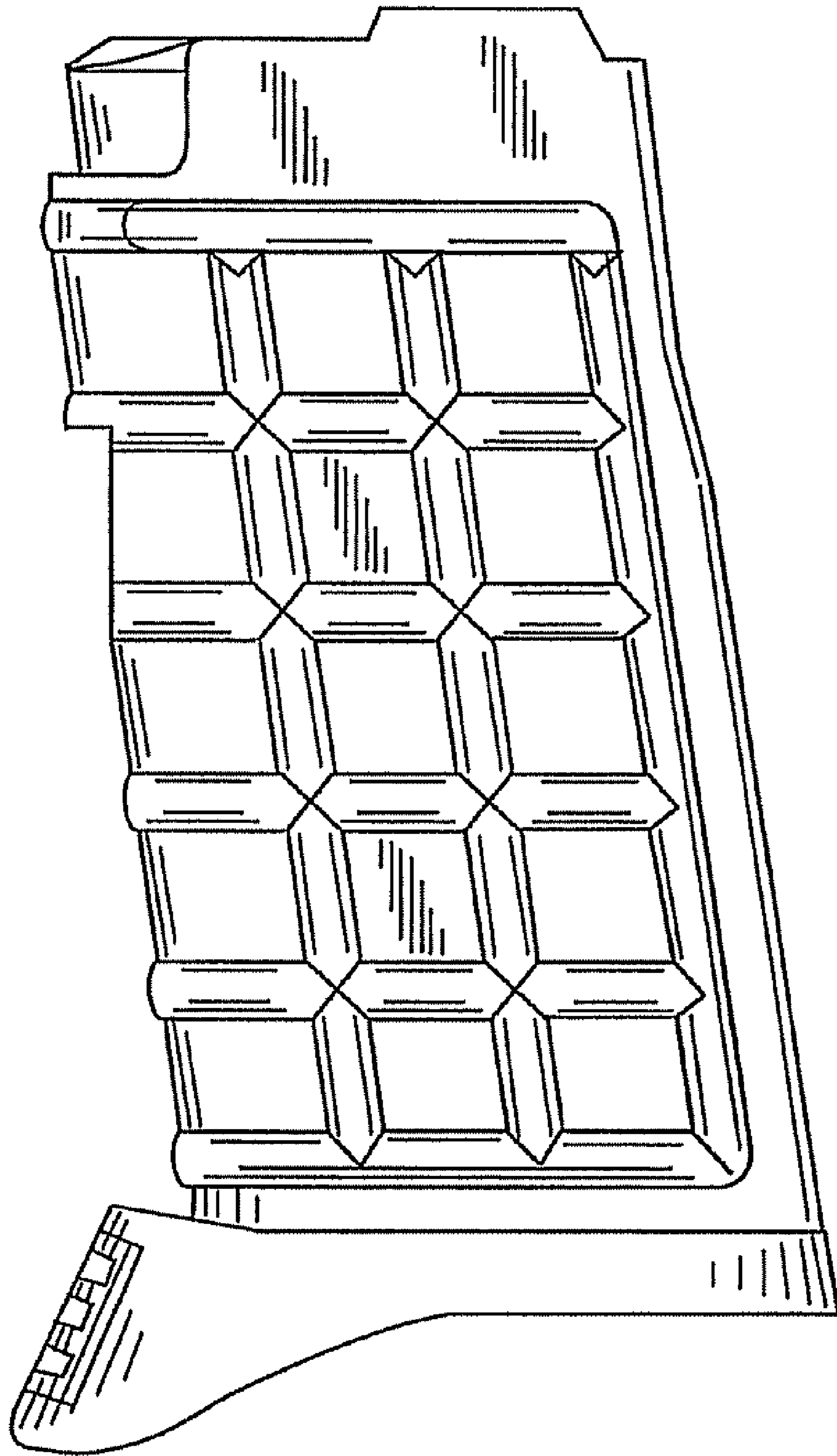

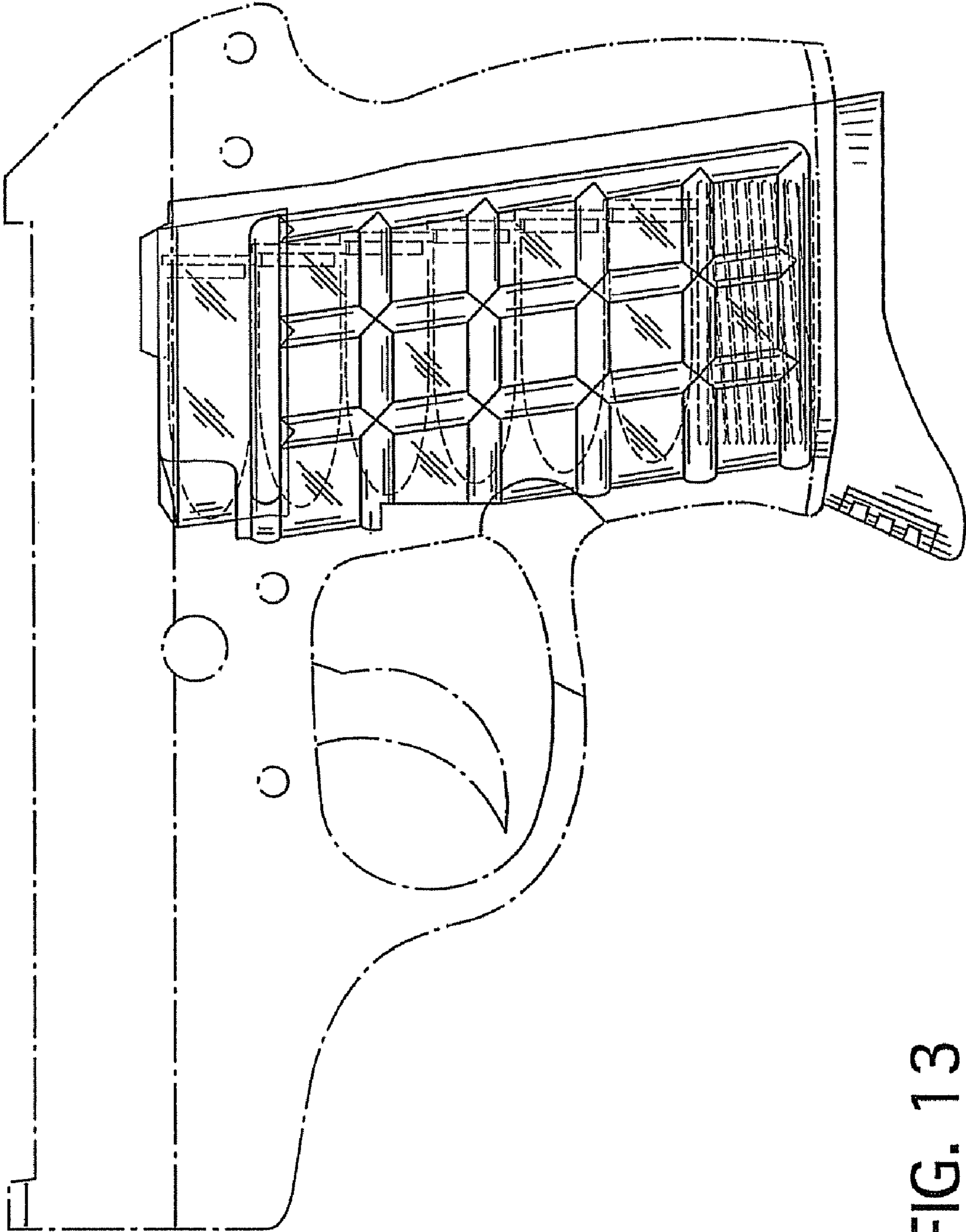
