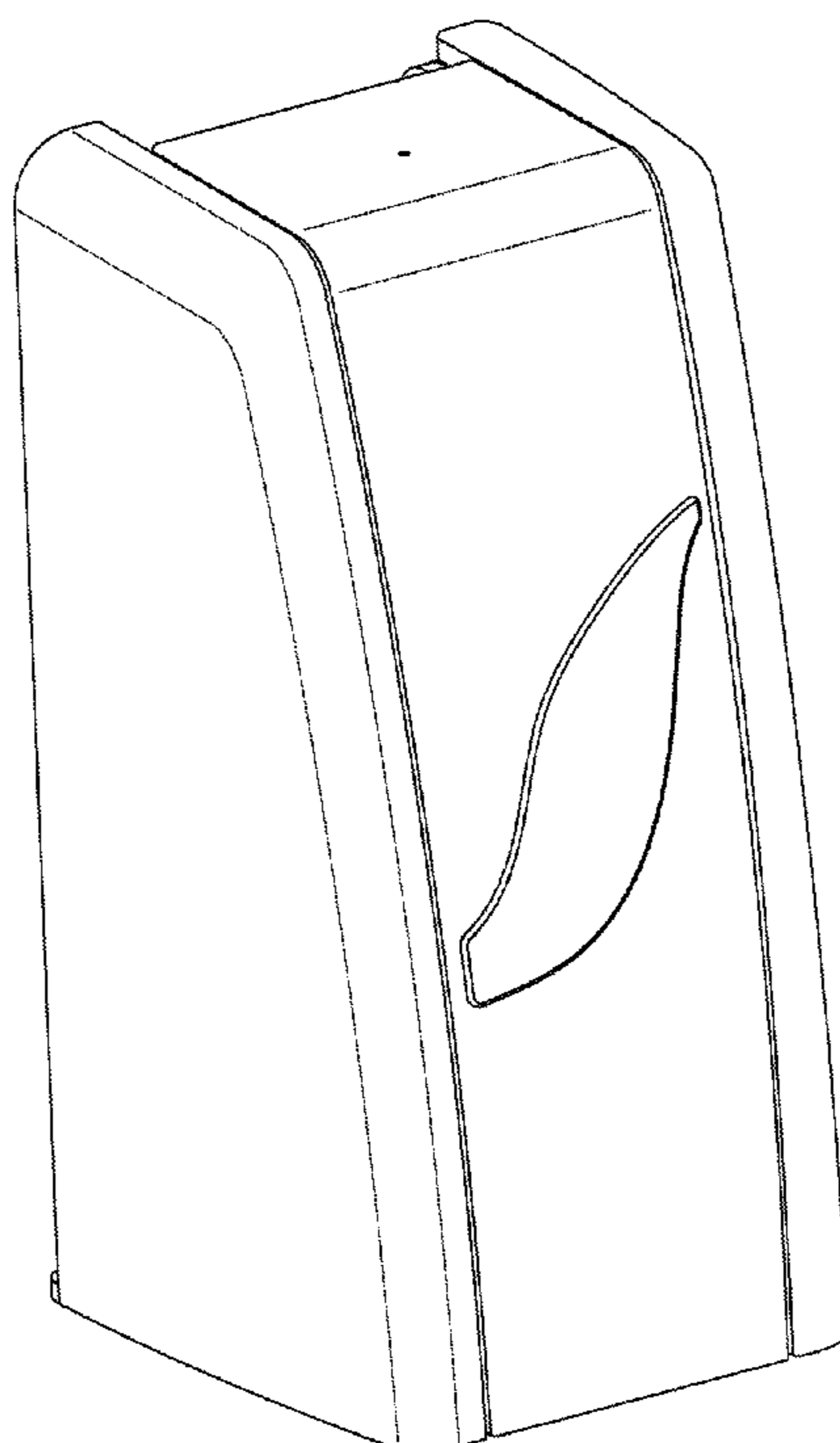
(57) **CLAIM**

The ornamental design for a diffusing evaporator of active substances, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a diffusing evaporator of active substances, showing our new design;
FIG. 2 is a side elevation view thereof taken from the right of FIG. 3;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a side elevation view thereof taken from the left of FIG. 3.

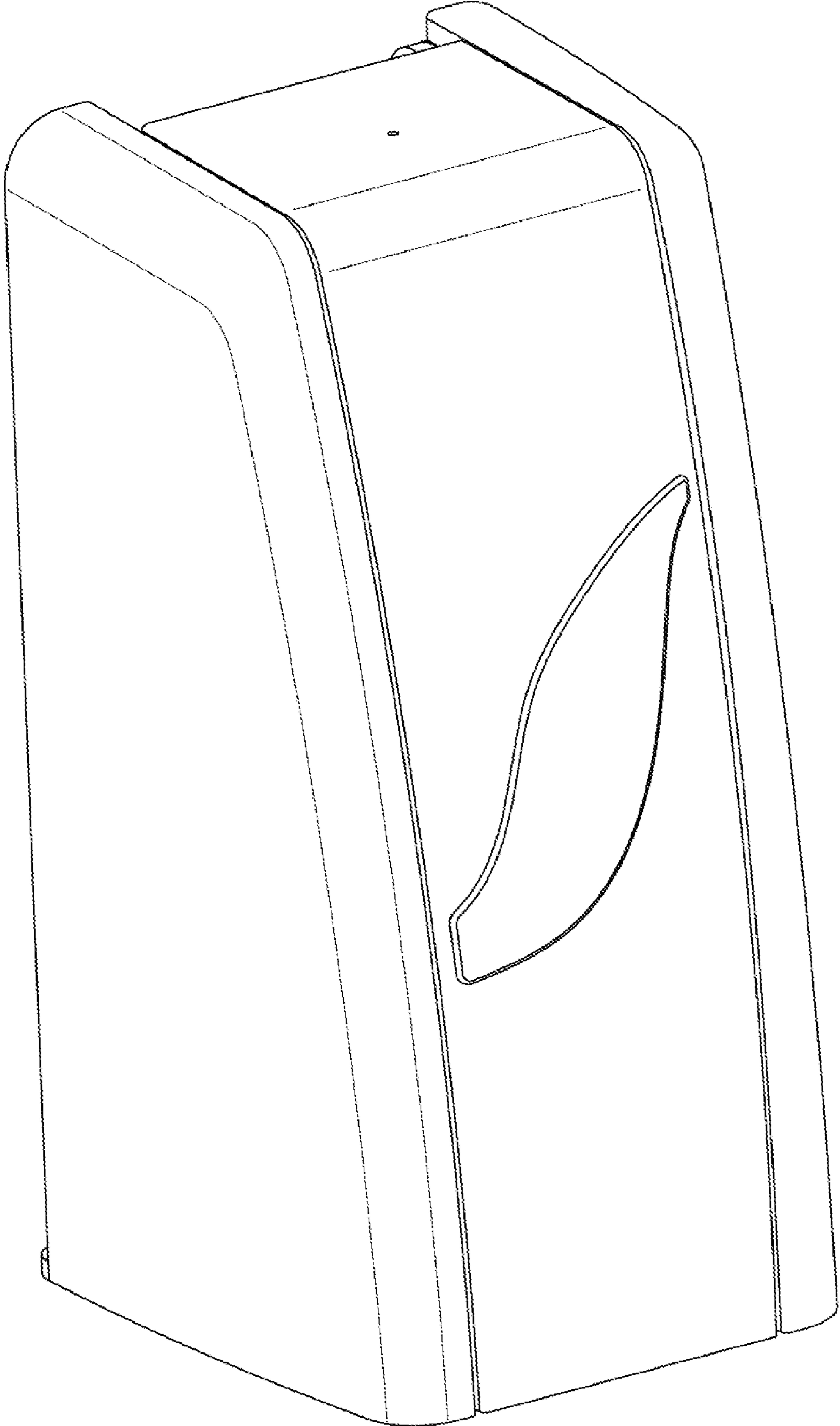
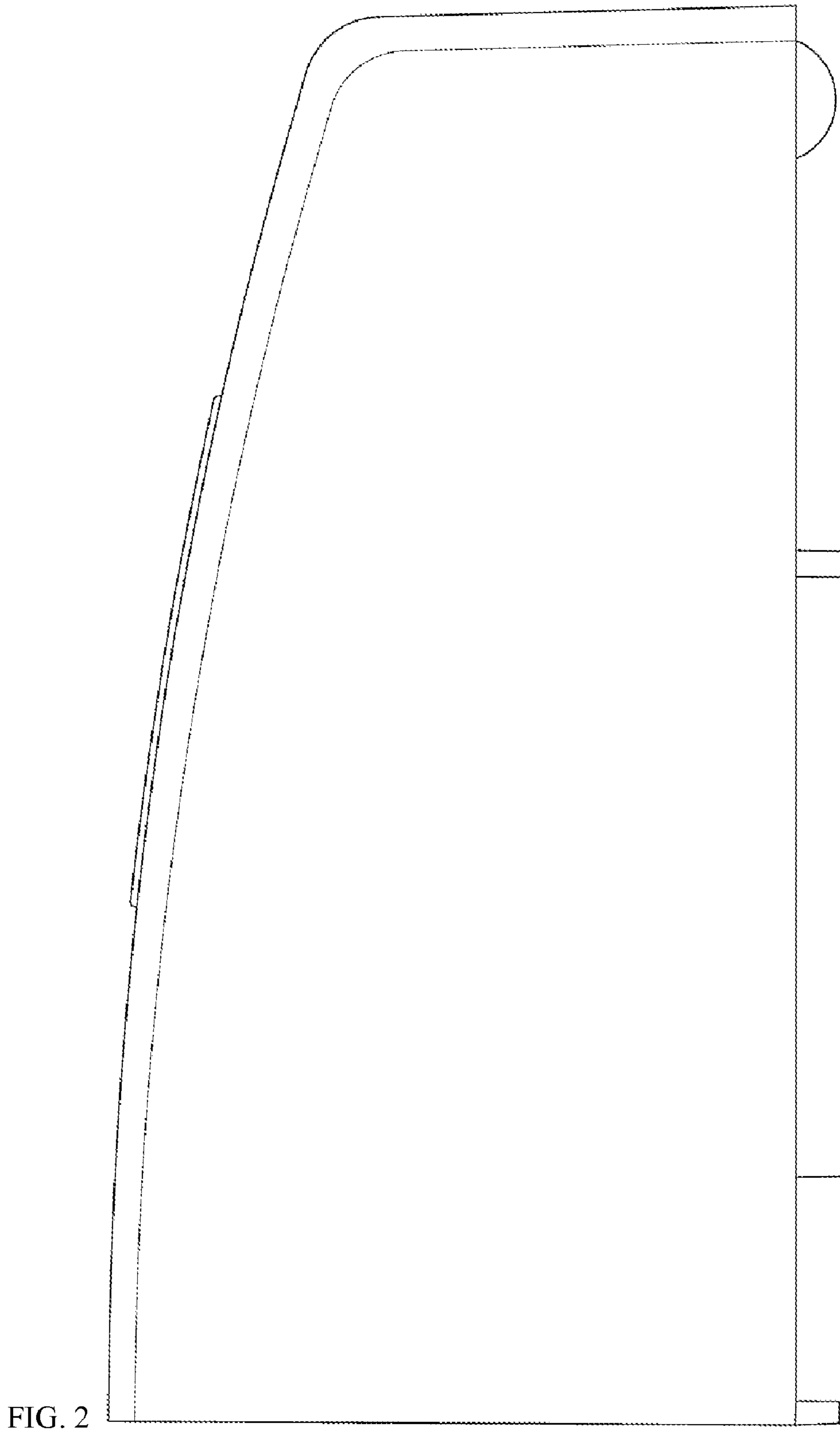

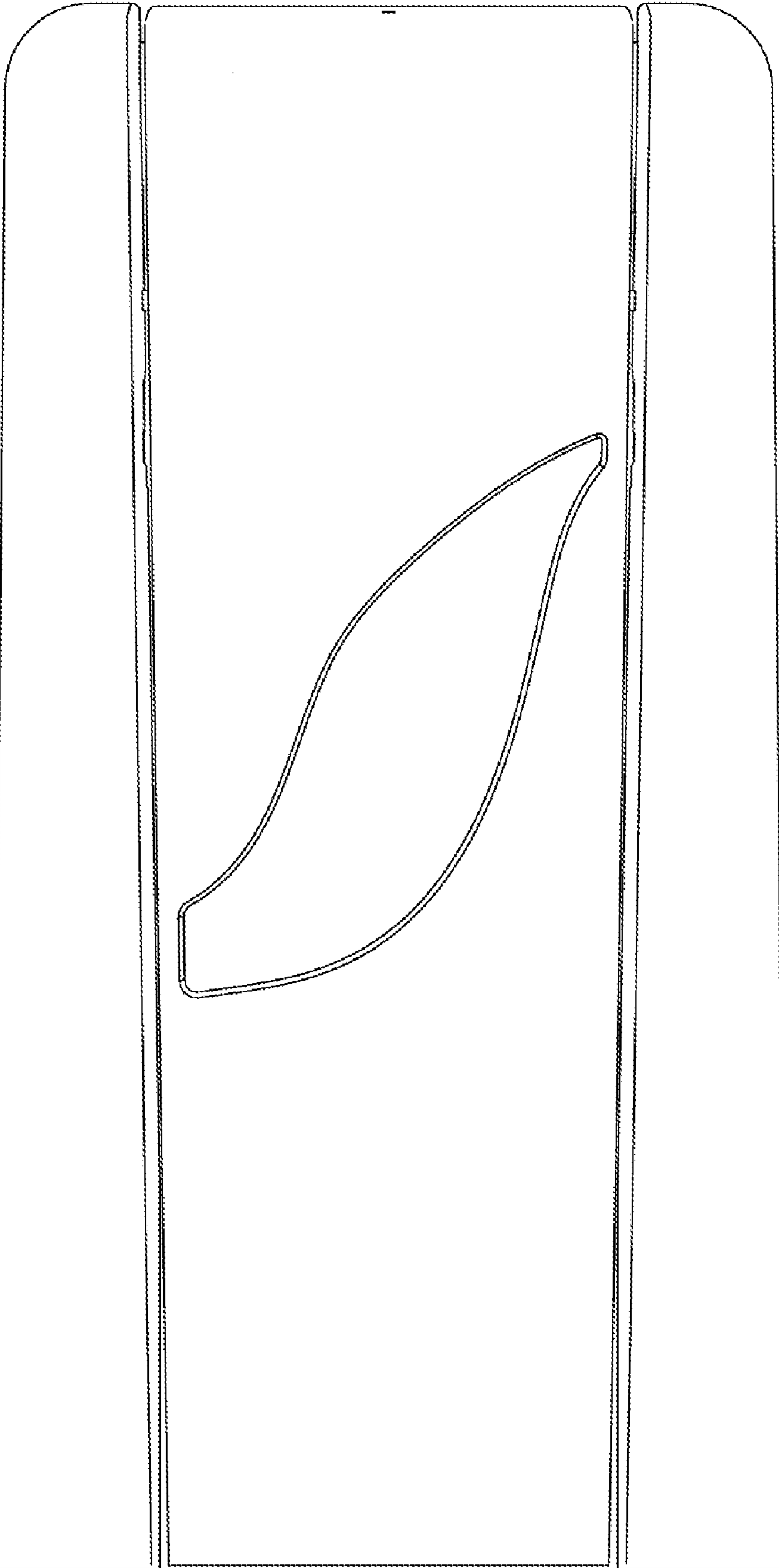

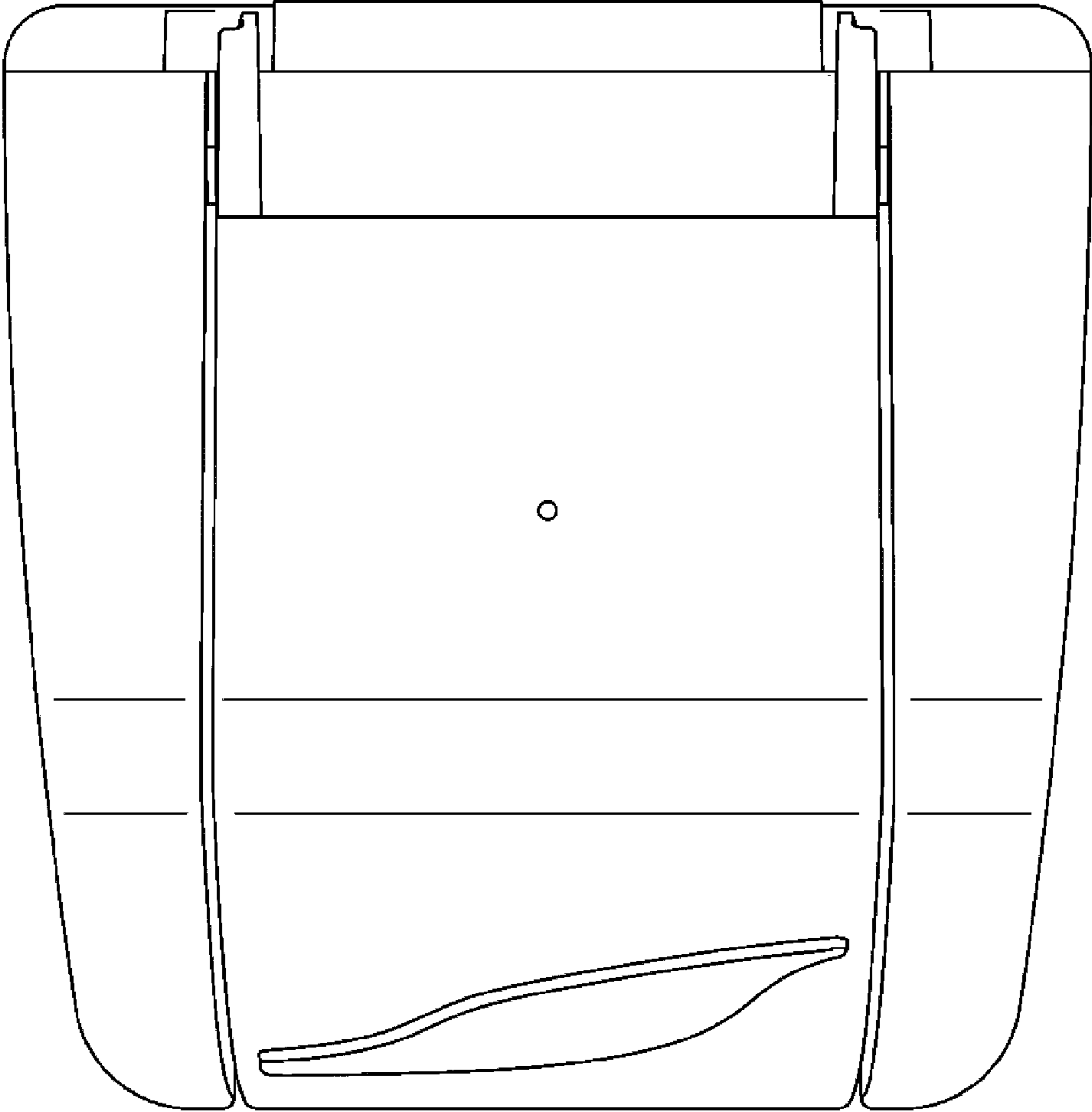

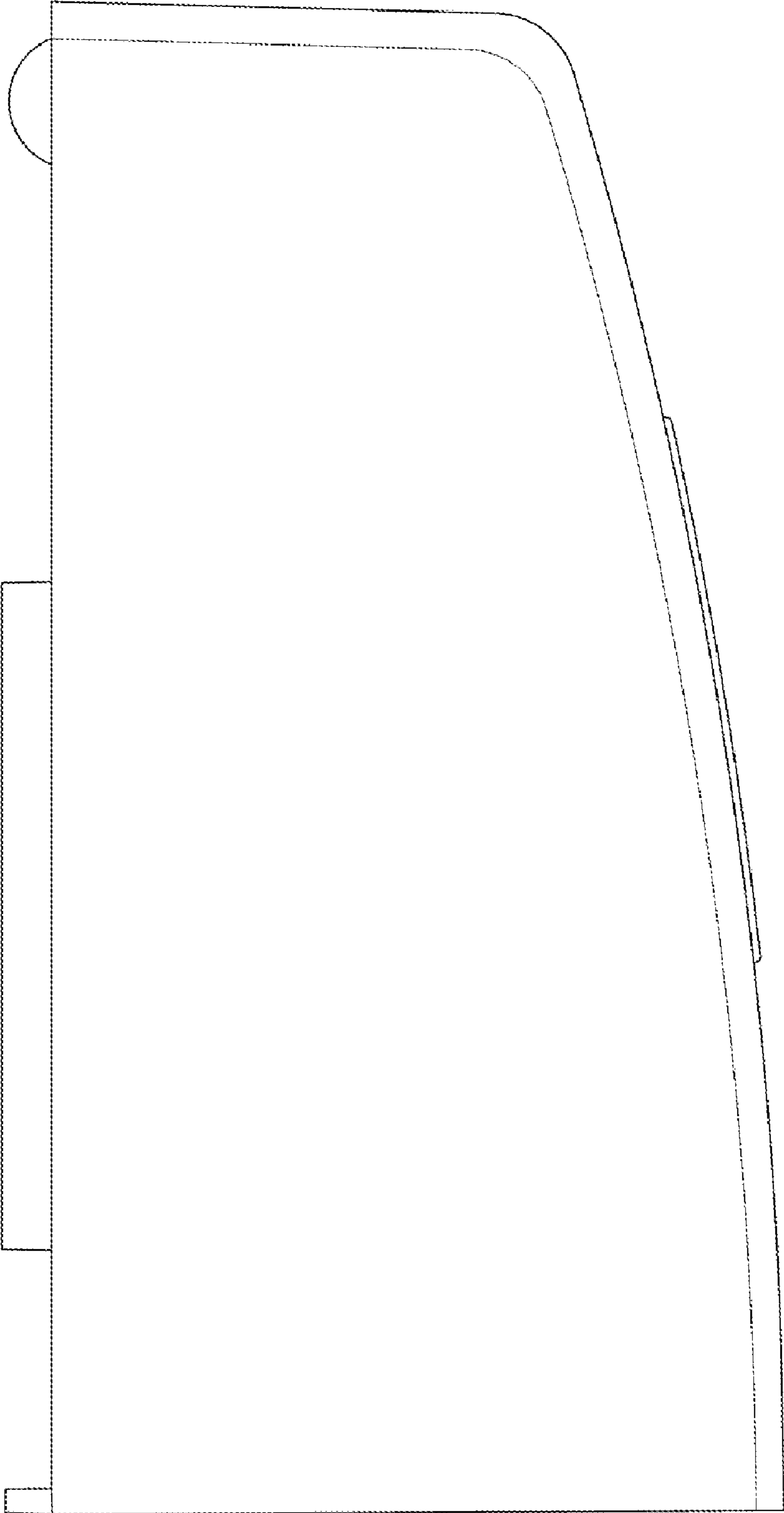
