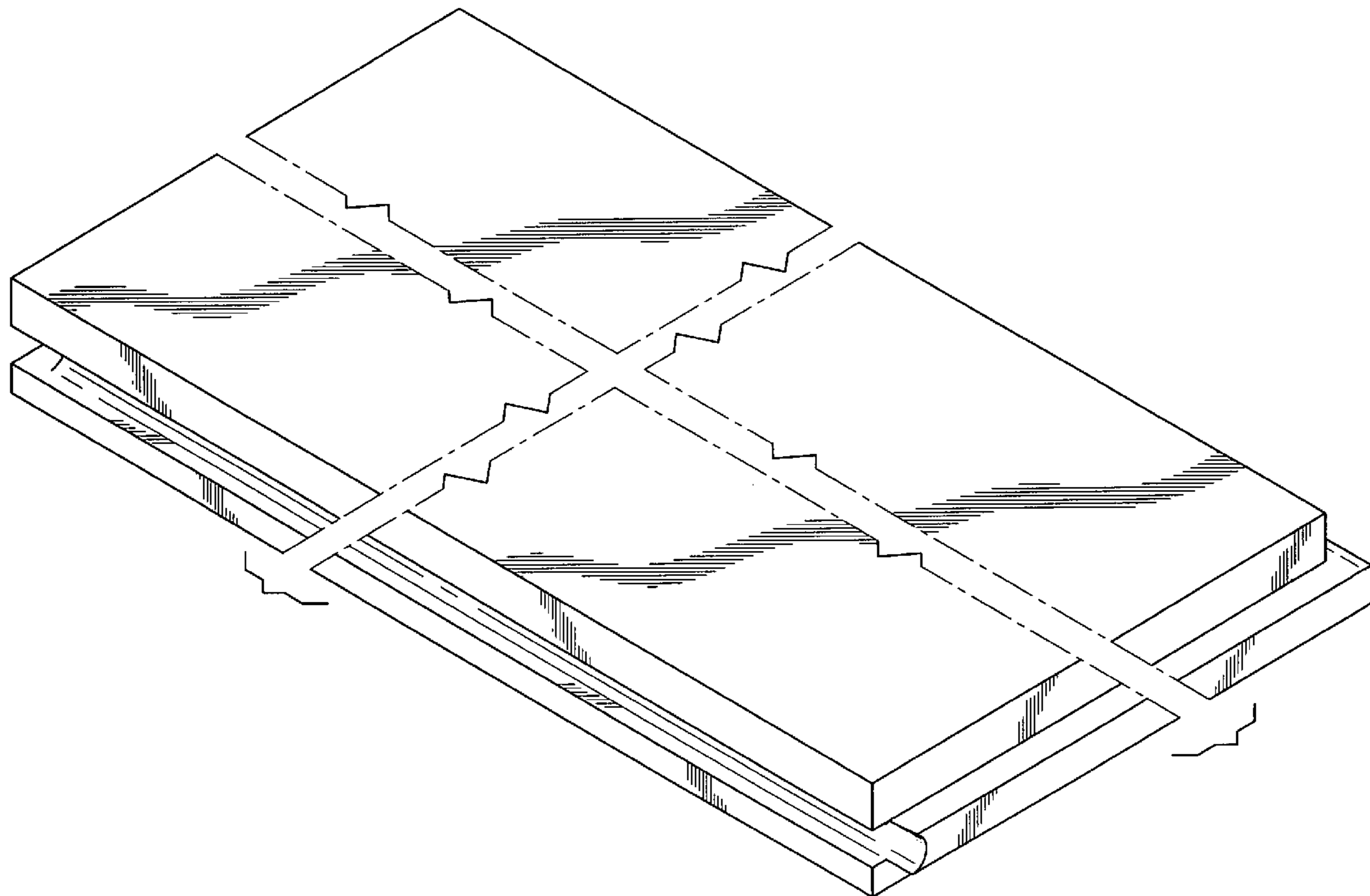
(57) **CLAIM**

I claim the ornamental design for a tongue and groove flooring tile, as shown and described.

**DESCRIPTION**

FIG. 1 is a side and top perspective view of a tongue and groove flooring tile showing my new design;  
FIG. 2 is a side and bottom perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a side view thereof showing the groove;  
FIG. 5 is the opposite side view showing the tongue;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is an end view showing the tongue; and,  
FIG. 8 is the opposite end view showing the groove.  
The broken lines are disclosed to show indeterminate width and length of the claimed design.

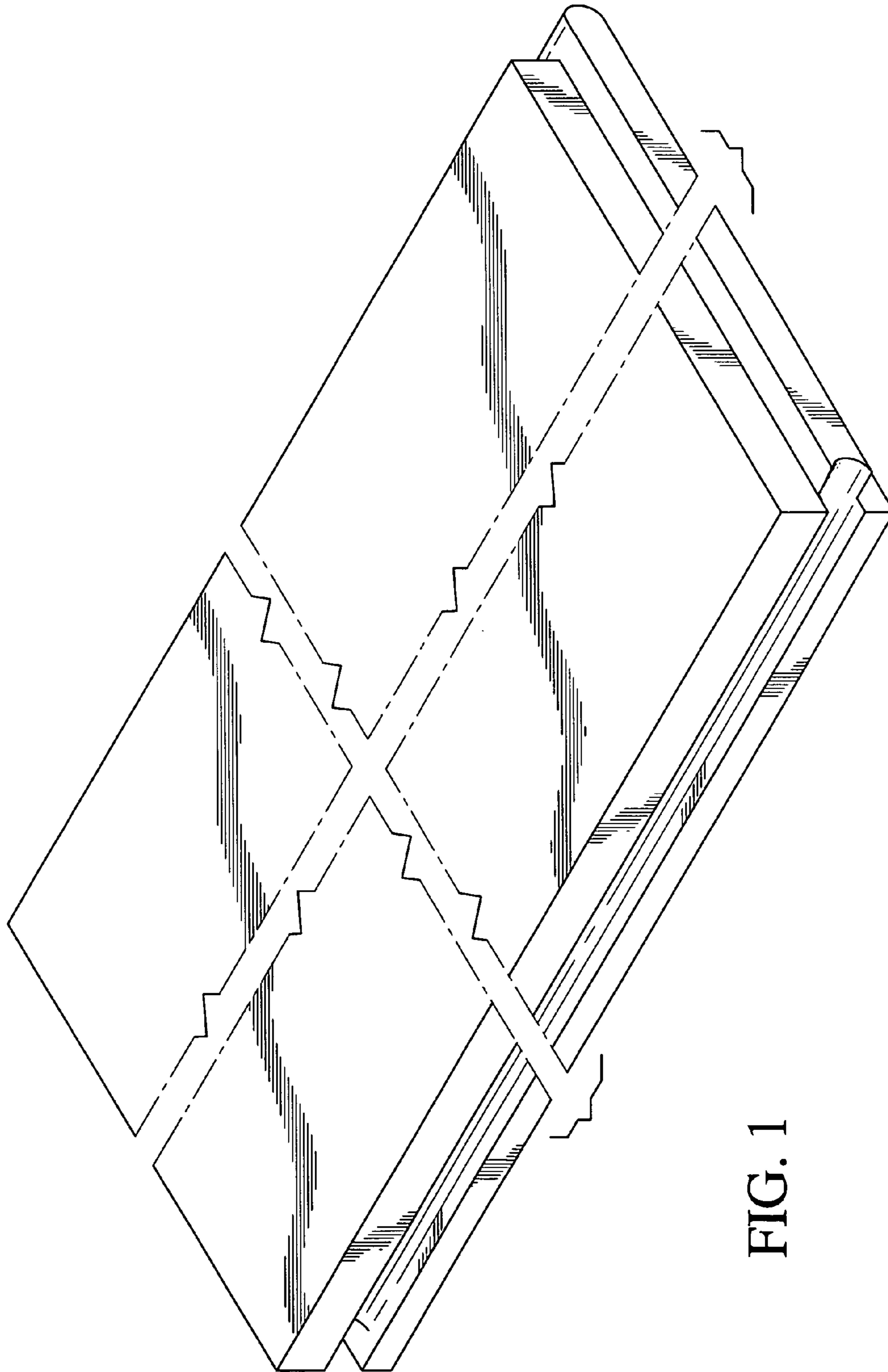

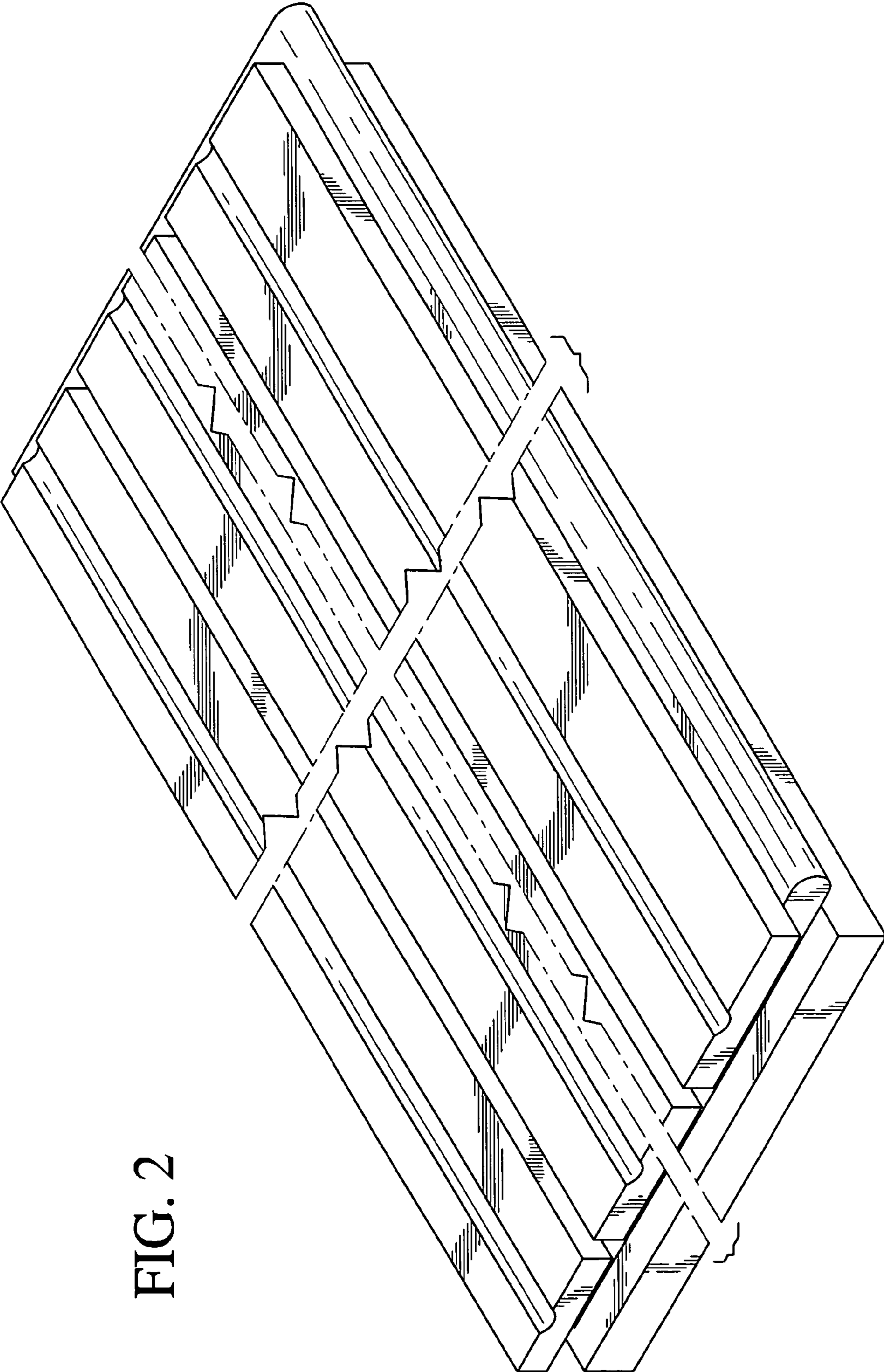

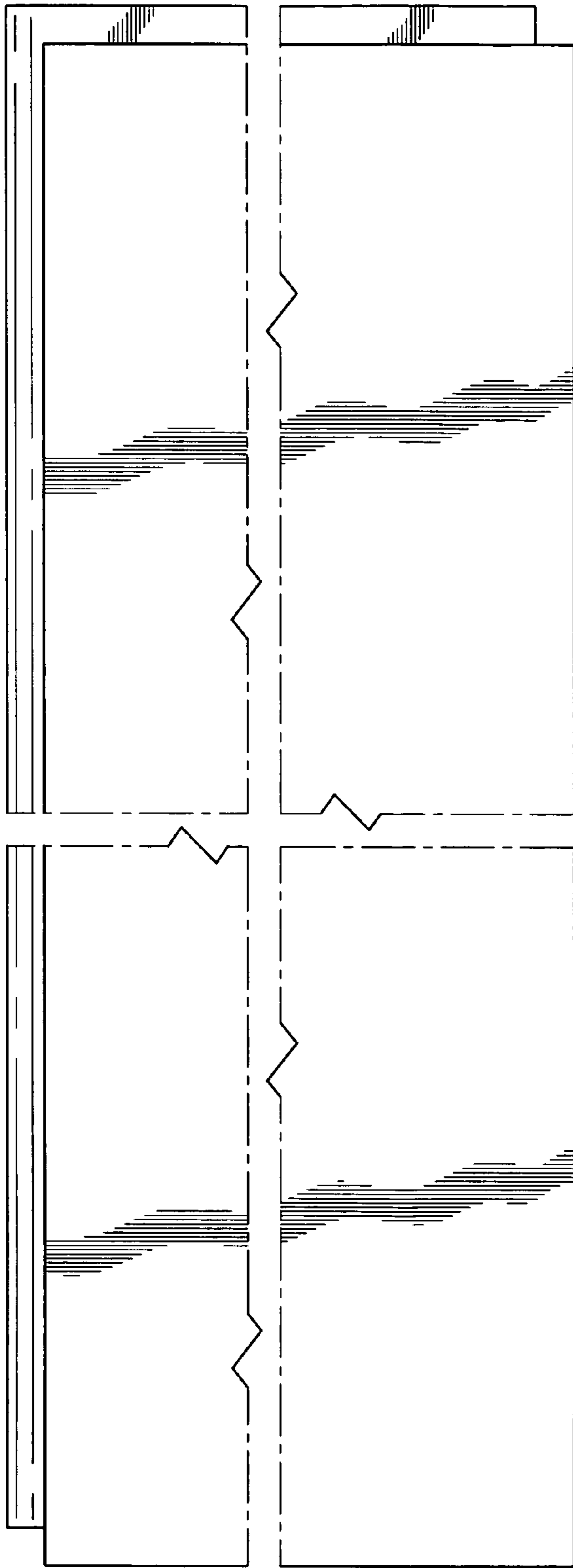

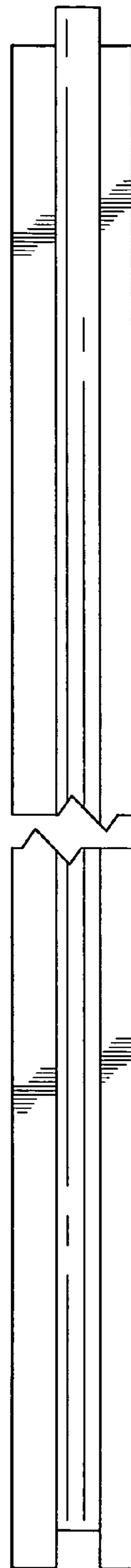

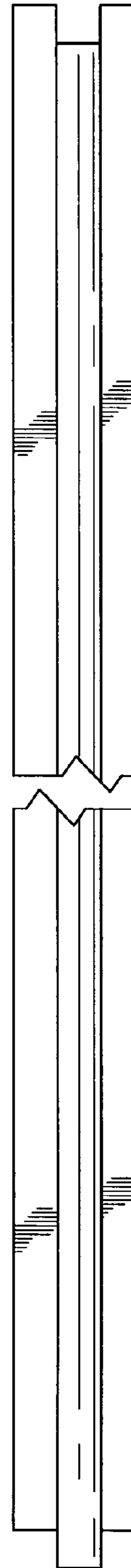

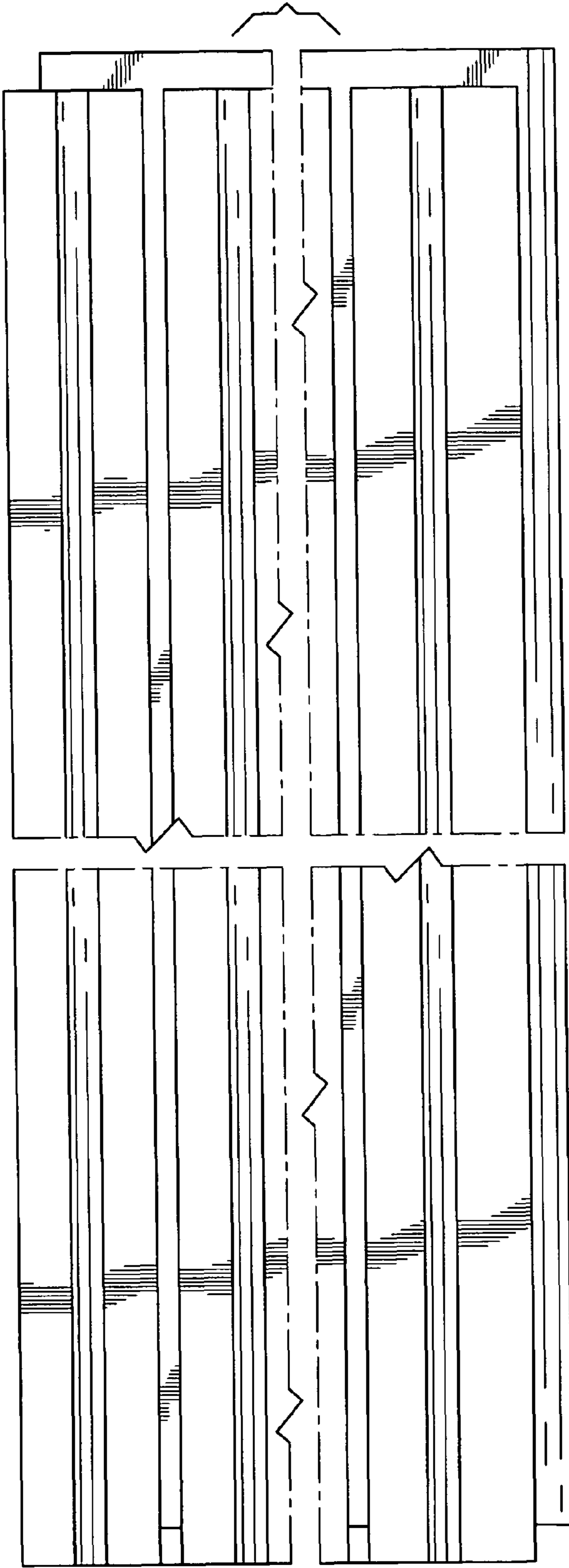

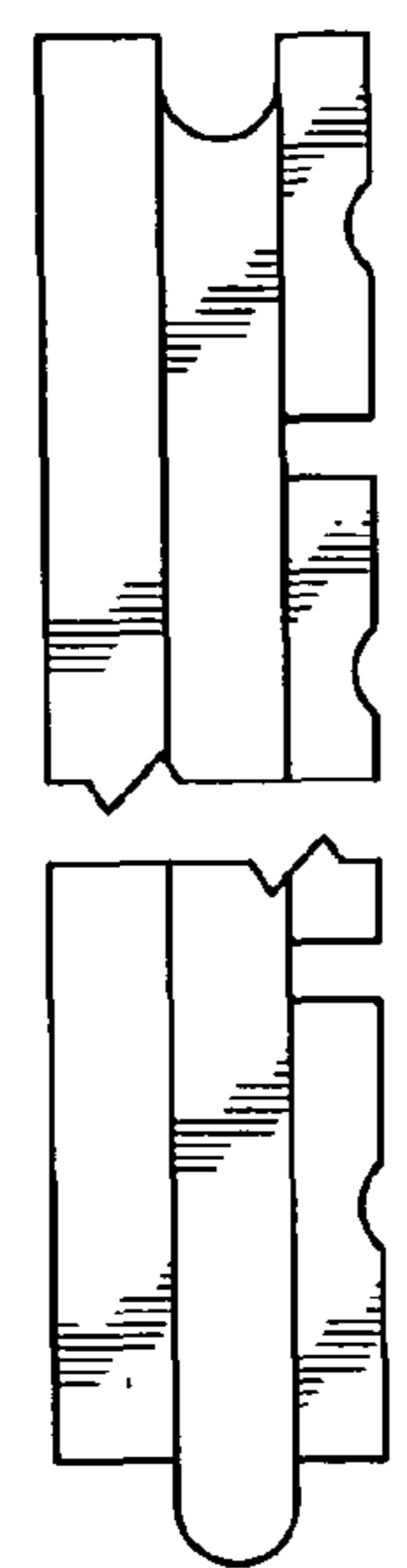

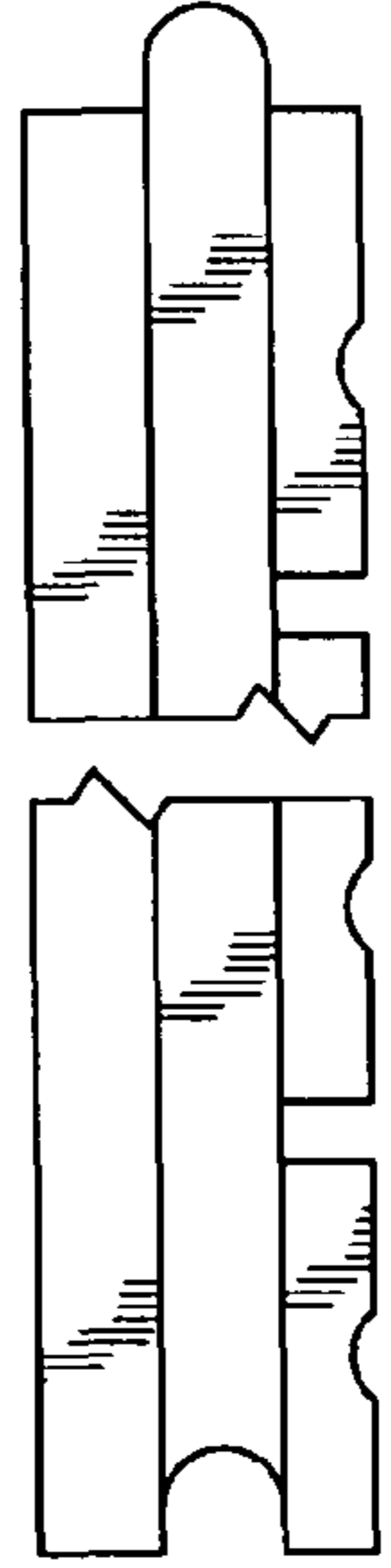
