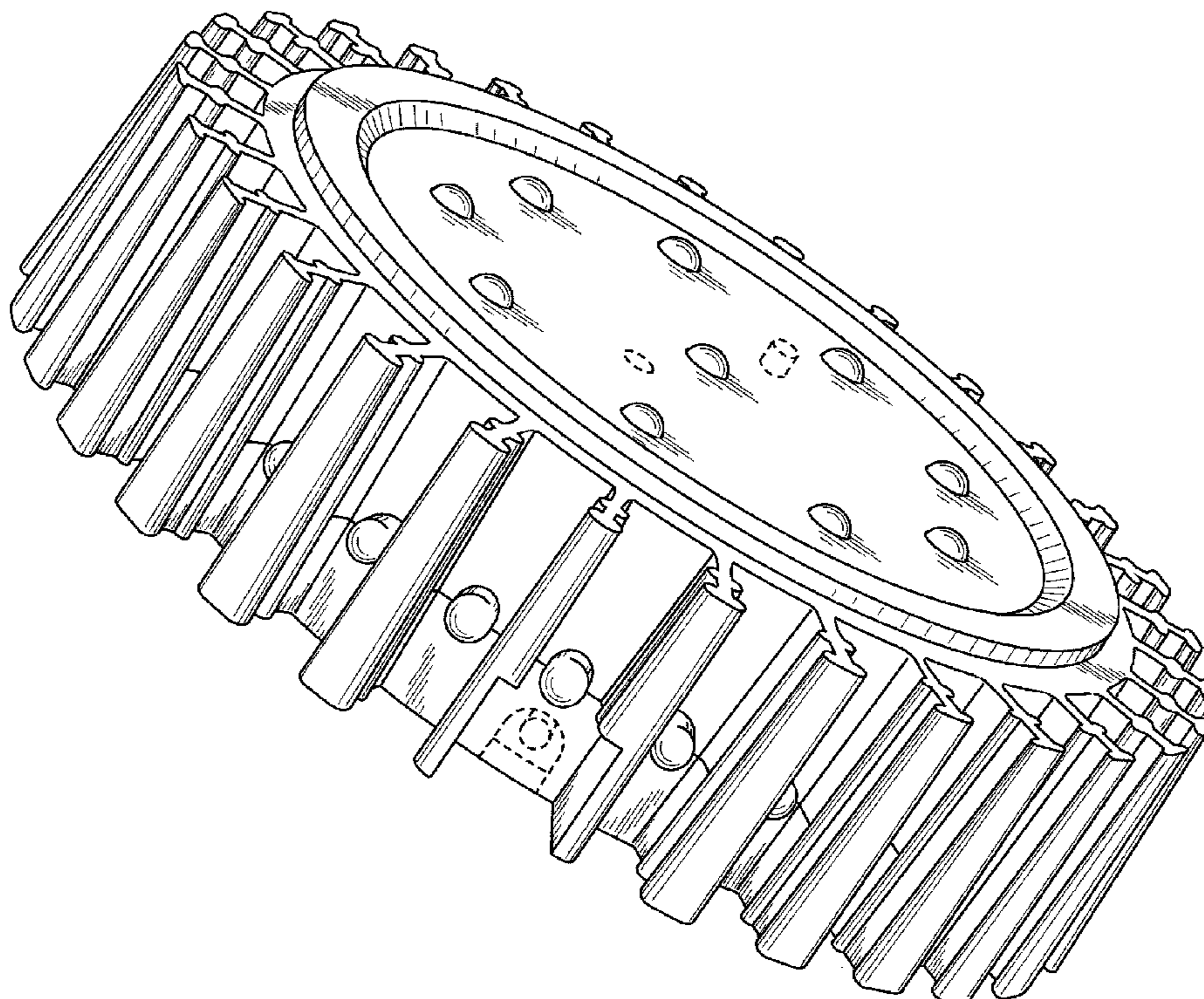
(57) **CLAIM**

The ornamental design for a decorative lighting fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a decorative light fixture. FIG. 2 is a front side view of a decorative light fixture. FIG. 3 is a back side view of a decorative light fixture. FIG. 4 is a right side view of a decorative light fixture. FIG. 5 is a left side view of a decorative light fixture. FIG. 6 is a top side view of a decorative light fixture; and, FIG. 7 is a bottom side view of a decorative light fixture. The portions of the decorative lighting fixture shown in broken lines form no part of the claimed design.

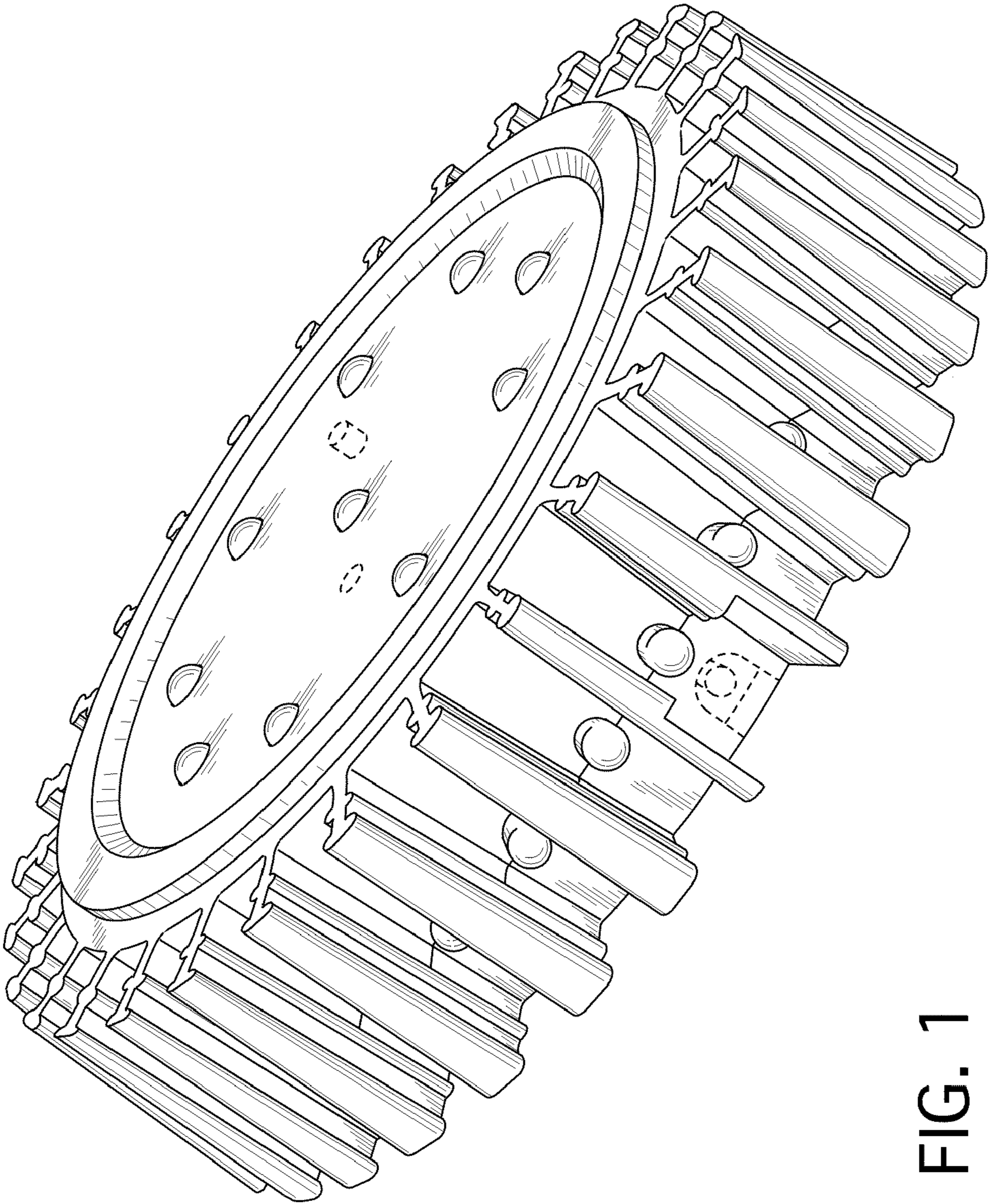

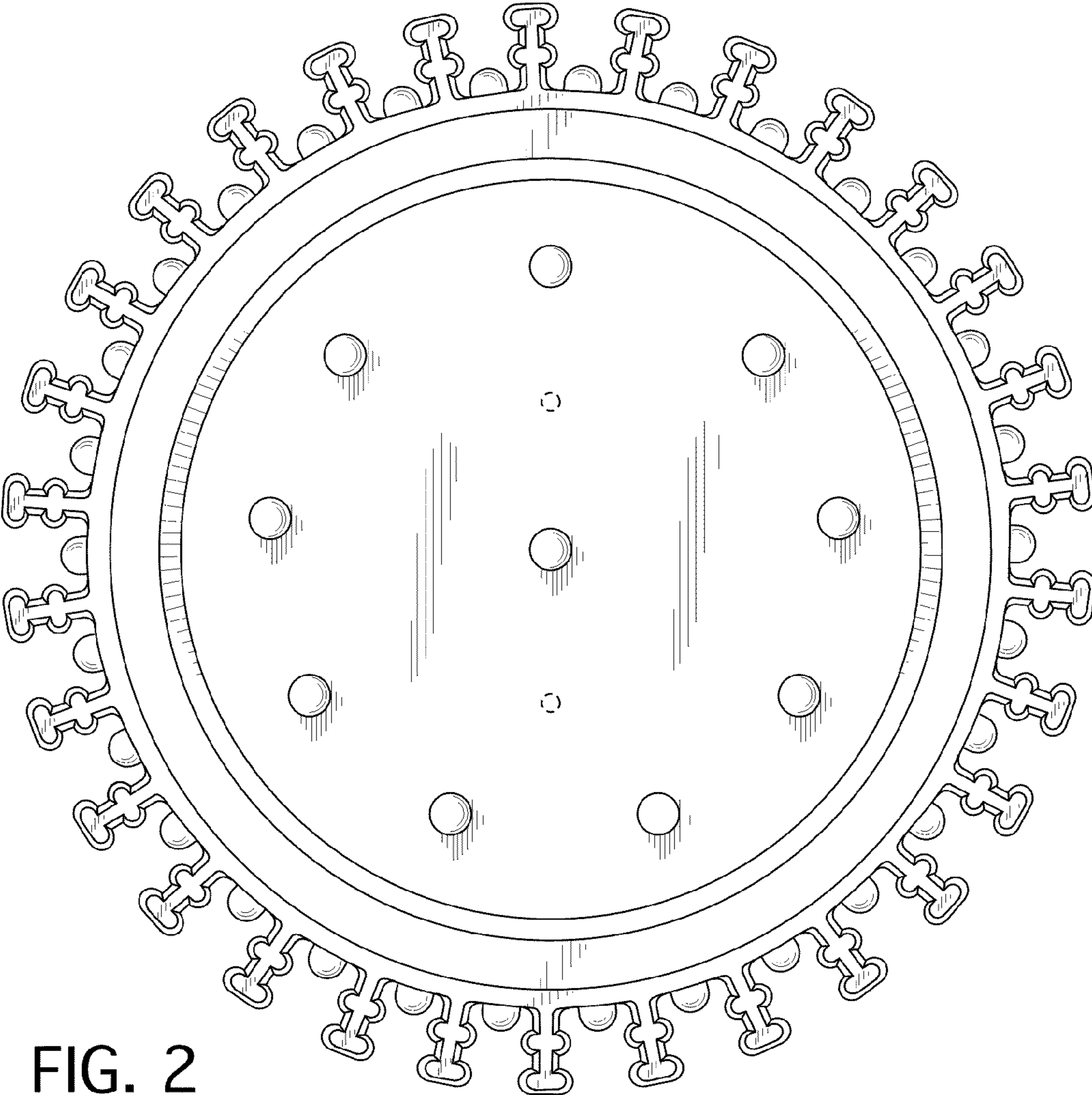

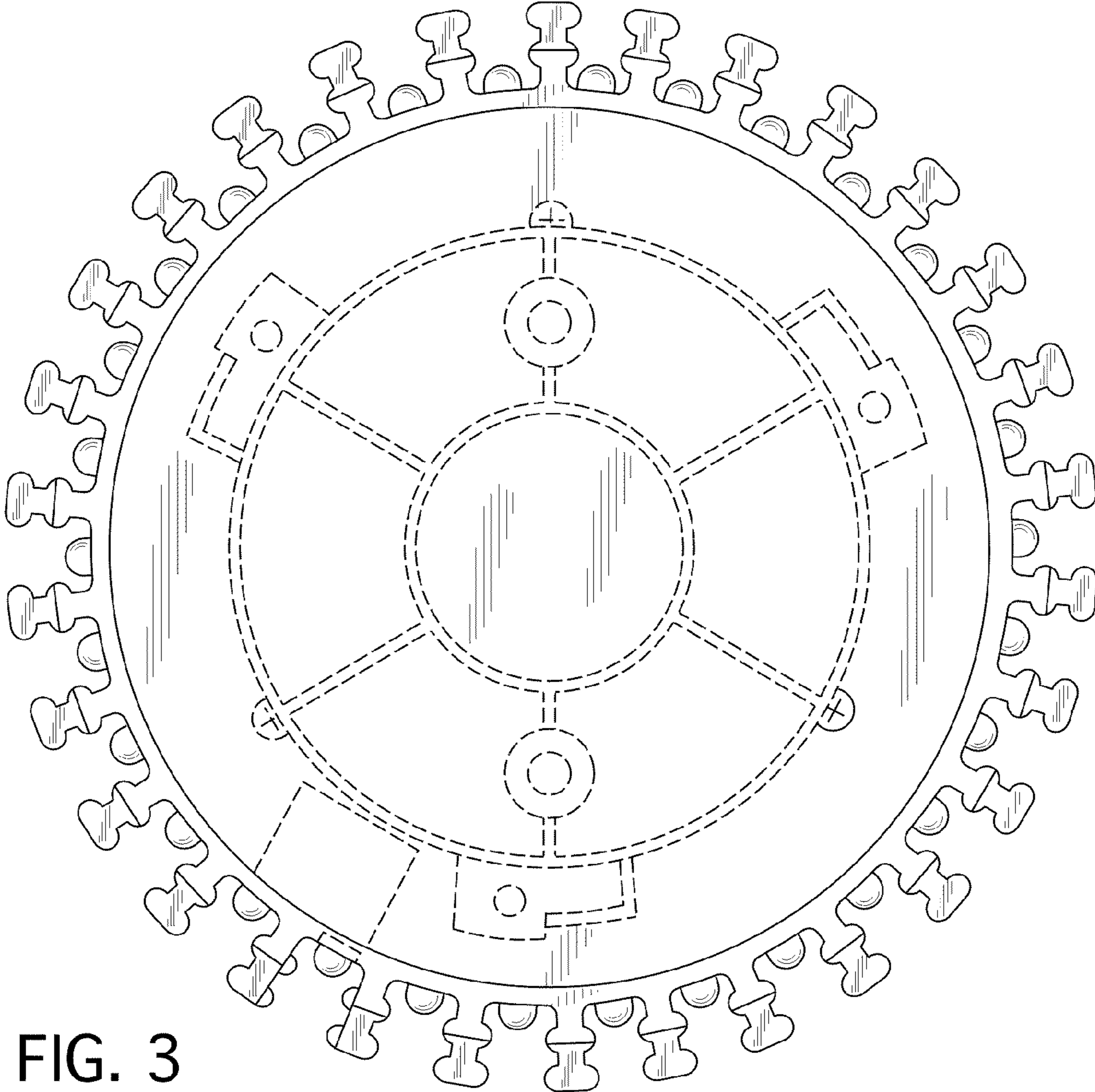

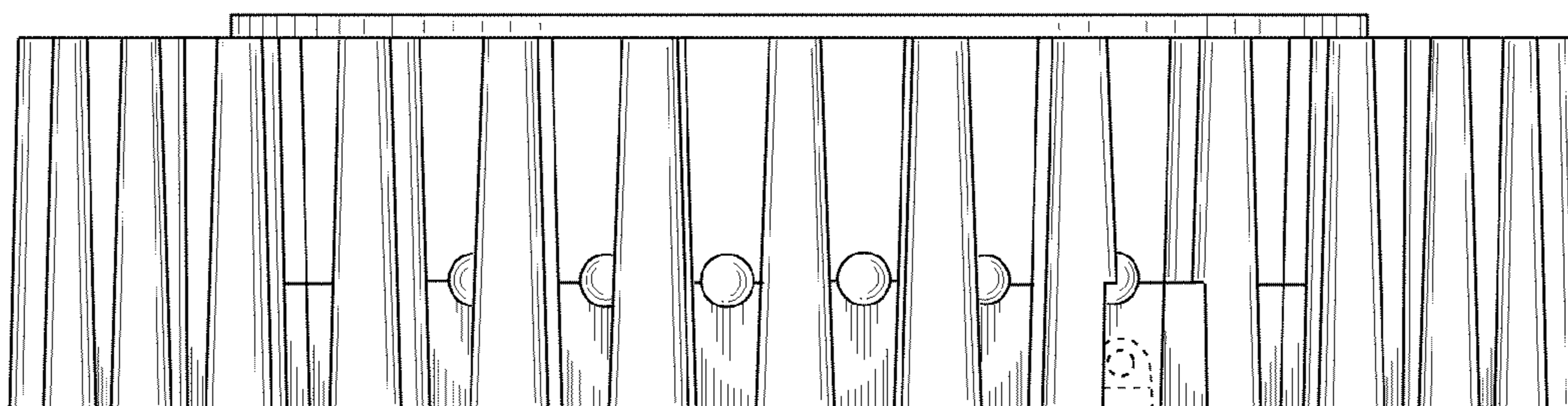

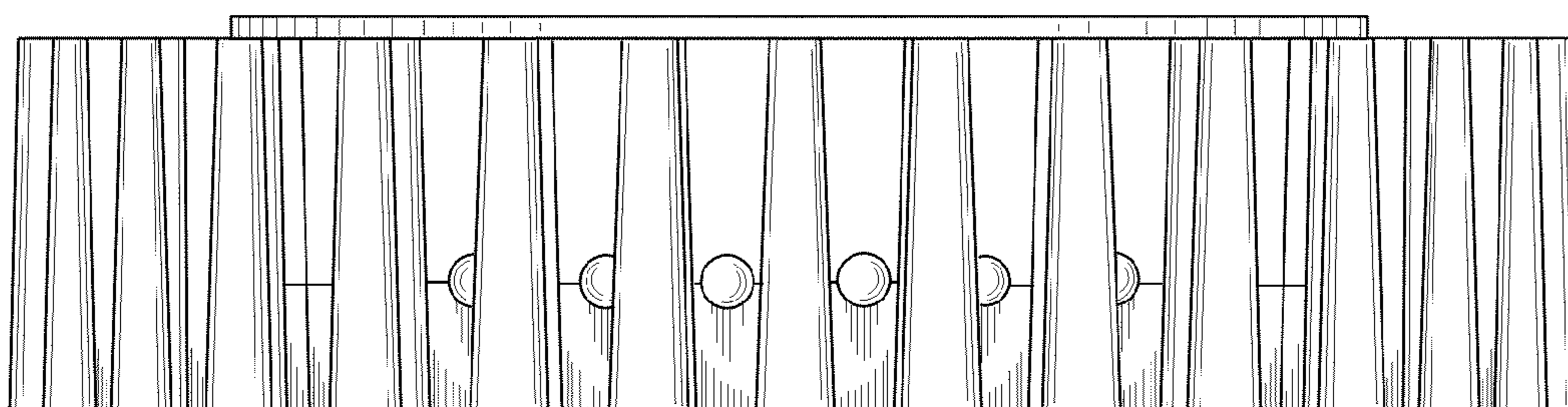

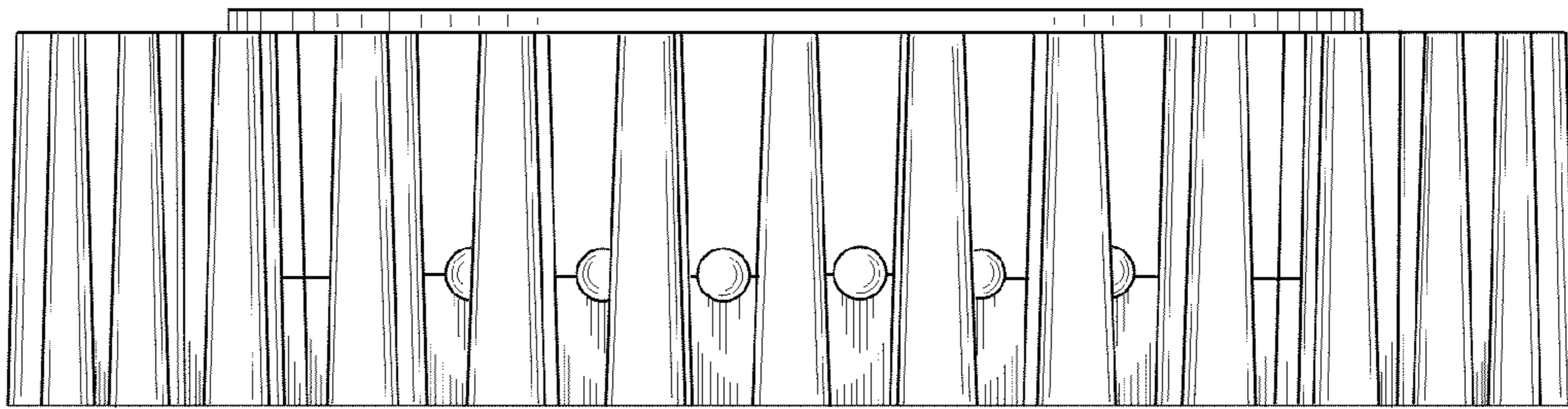

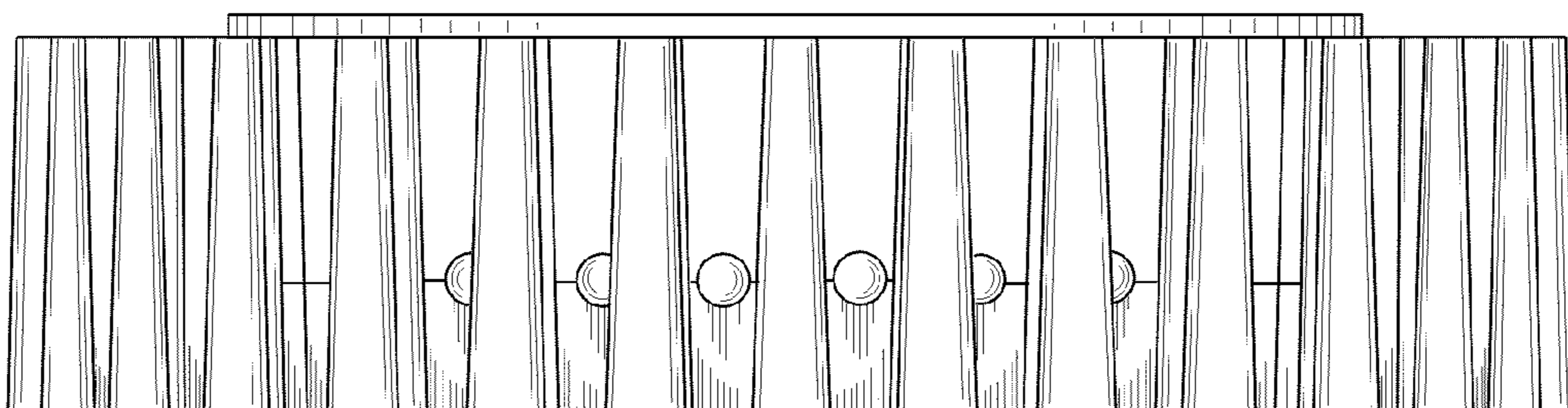
