(57) **CLAIM**

I claim the ornamental design for bathing suit with rear openings, as shown and described.

DESCRIPTION

The sole FIGURE is a rear elevational view of a bathing suit with rear openings showing my new design.

The uniformly spaced broken lines on the surface of the bathing suit represent stitching. The remaining broken lines, showing a waistband and portions of the human form, form no part of the claimed design.
