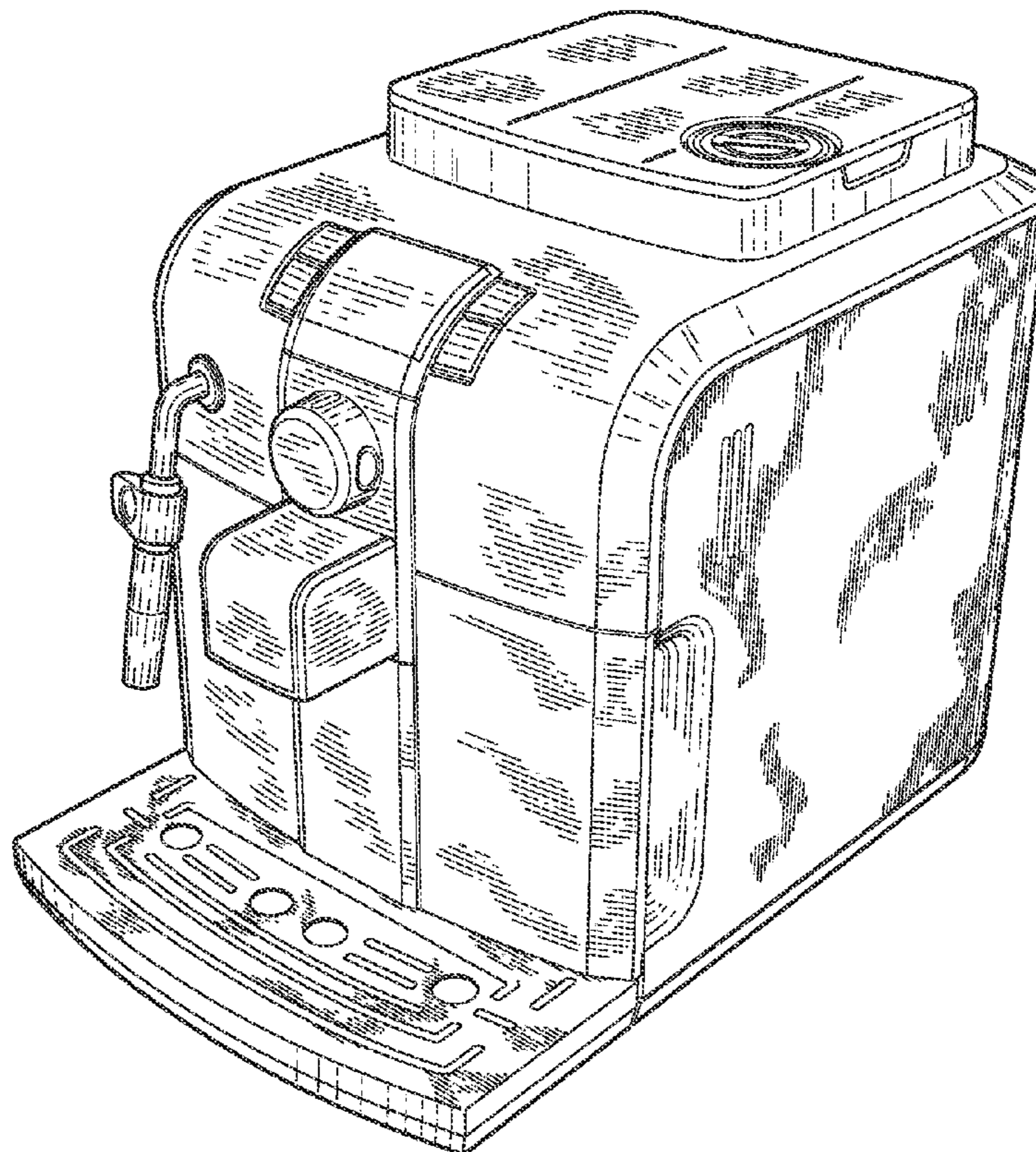
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top left perspective view of a coffee percolator showing my new design;

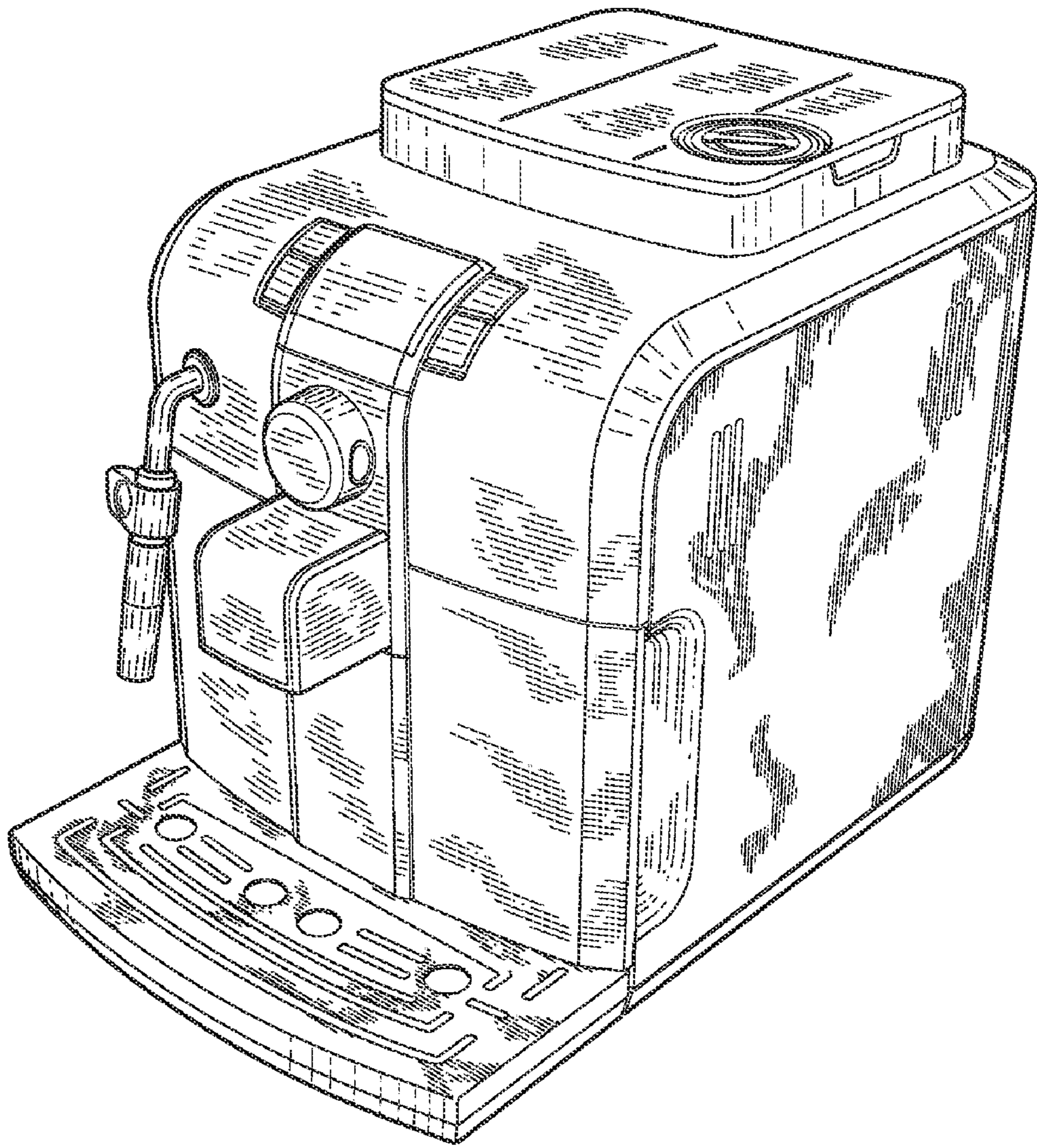

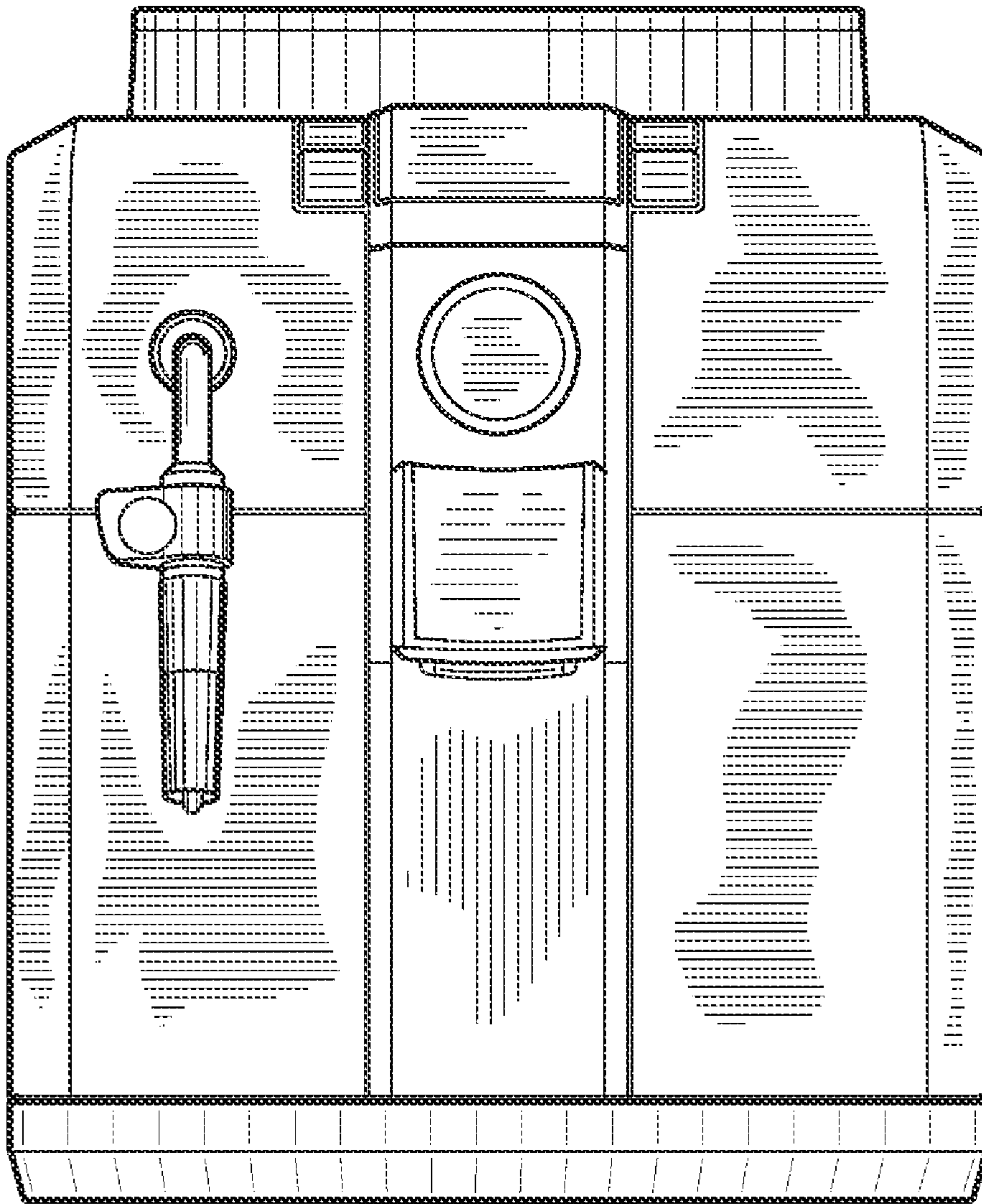

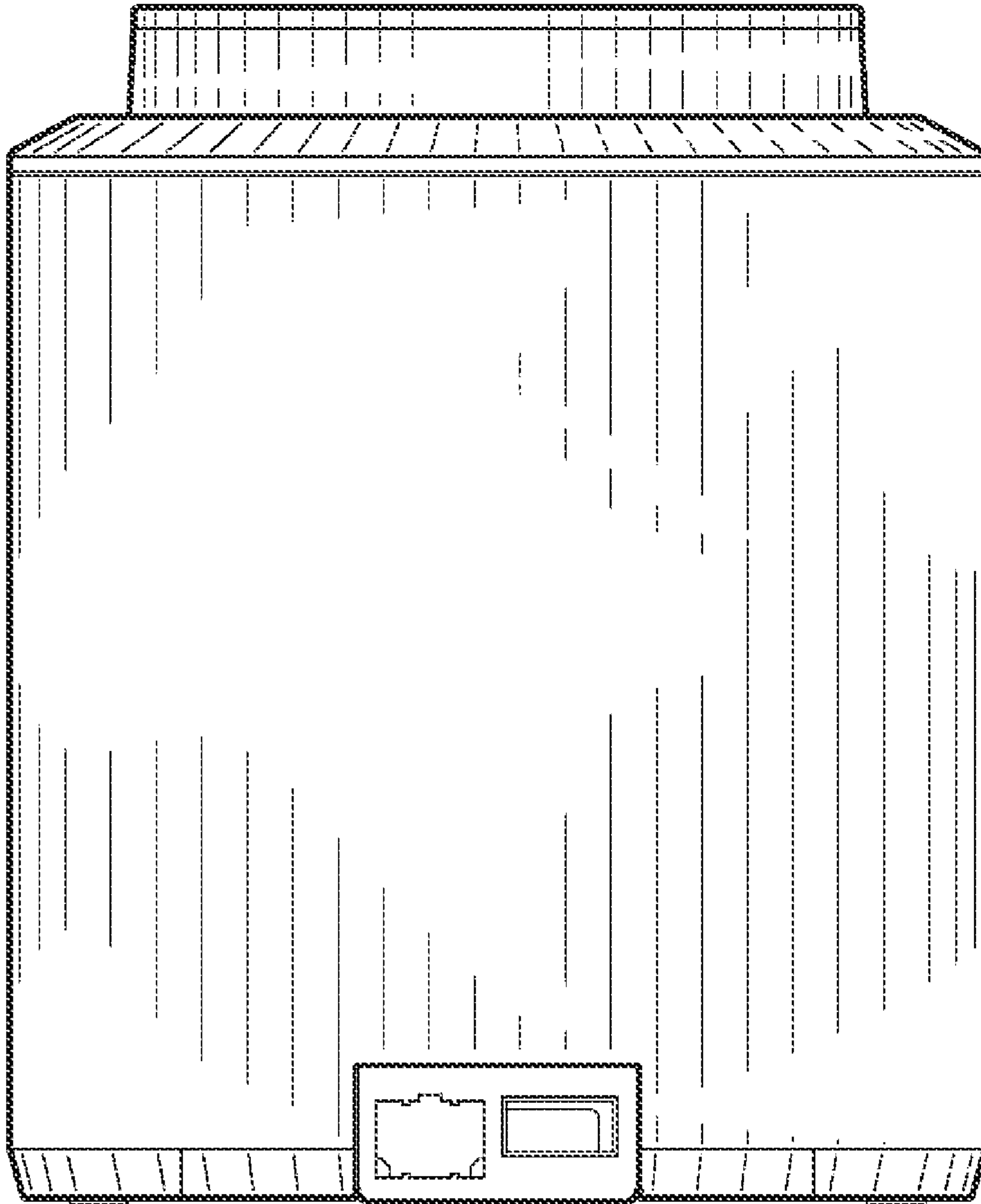

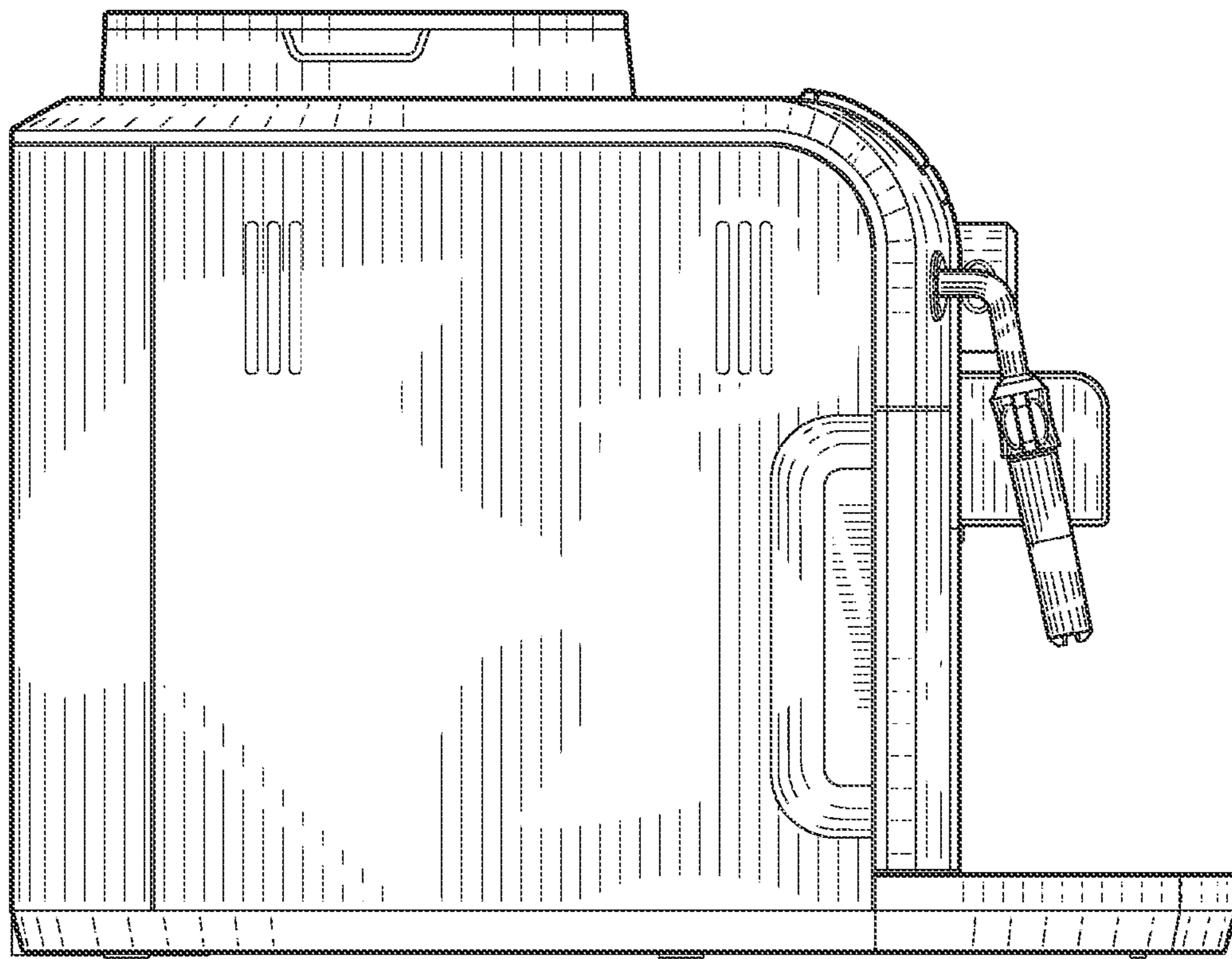

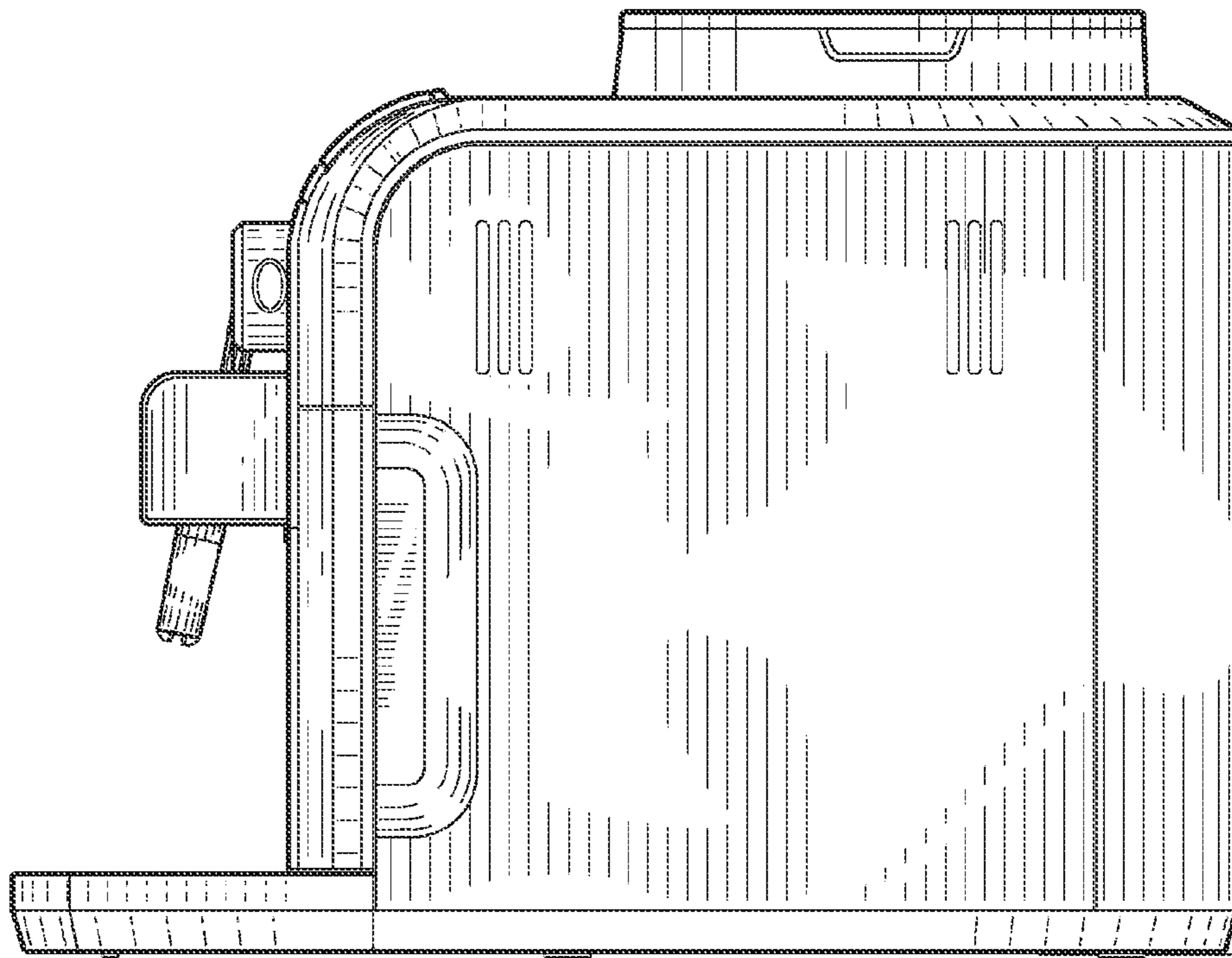

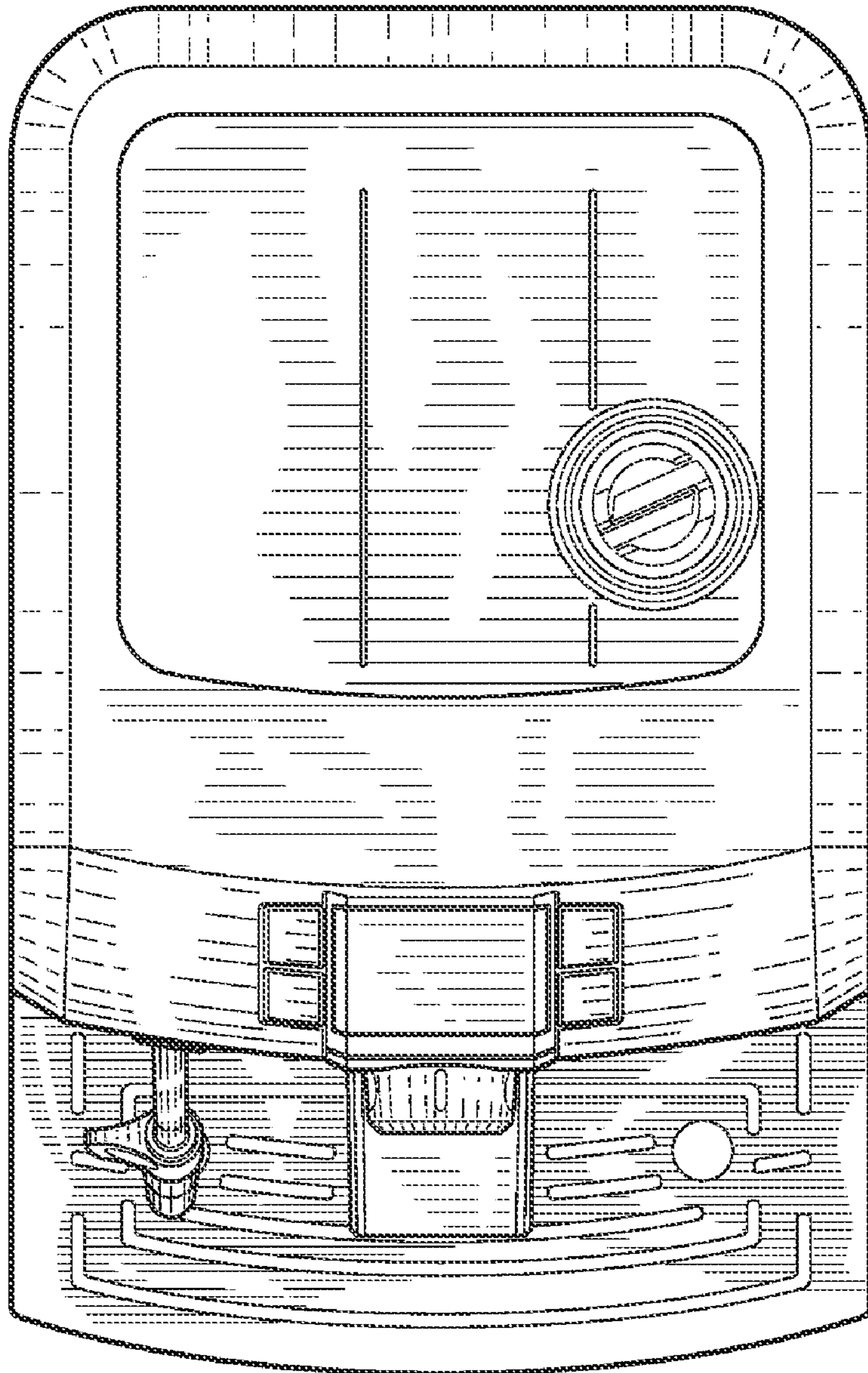

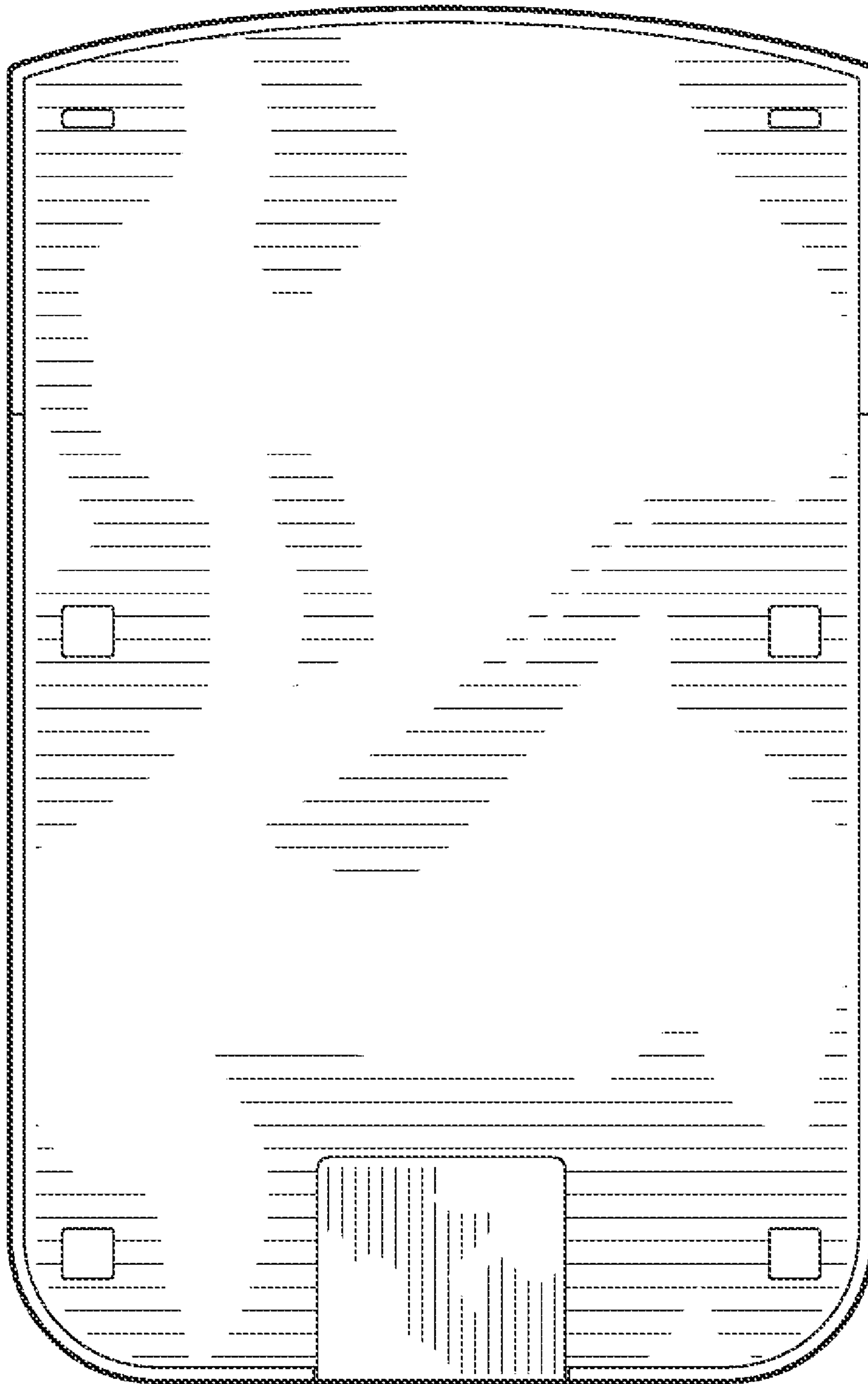
