(57) **CLAIM**

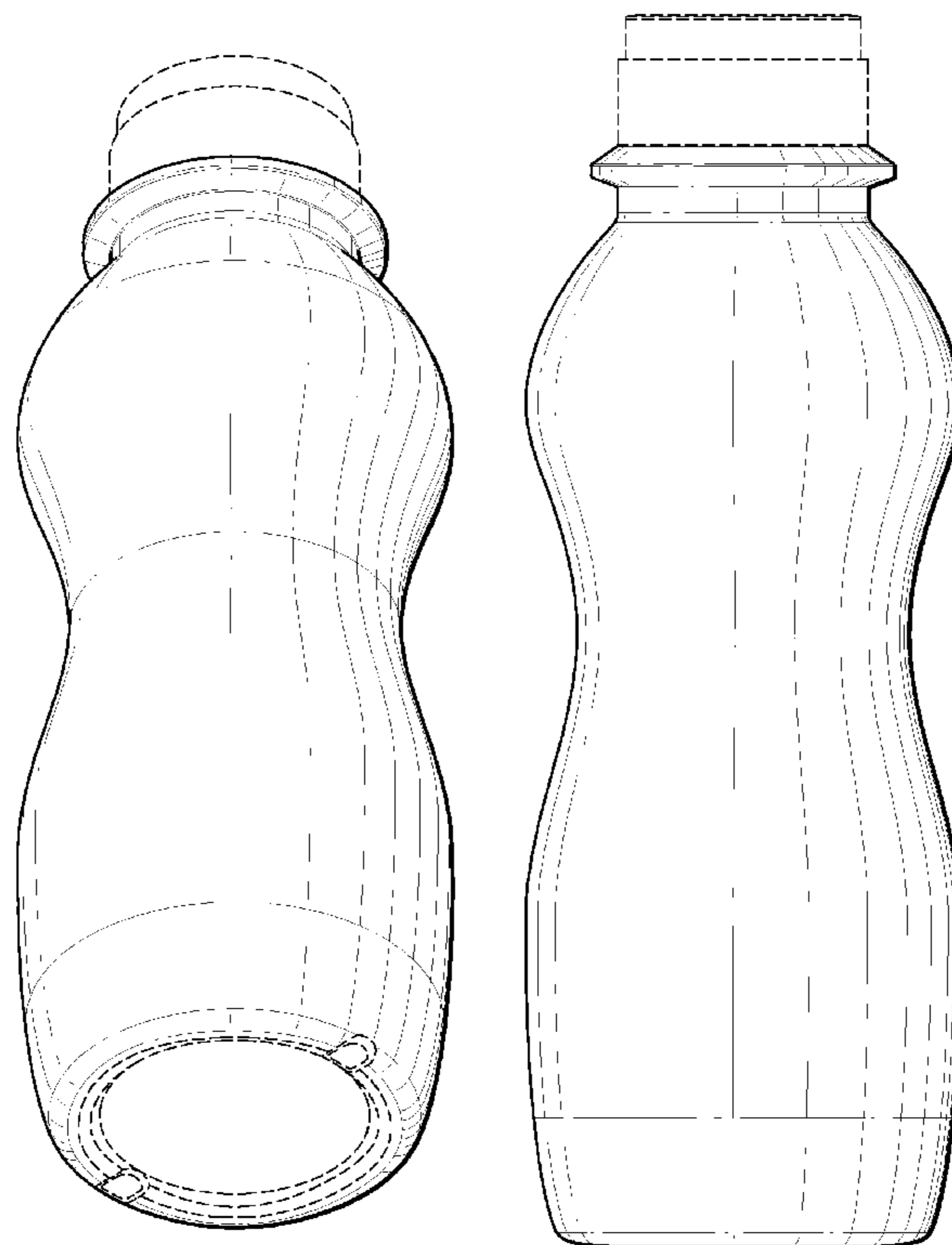
The ornamental design for a plastic container, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view showing my new design;

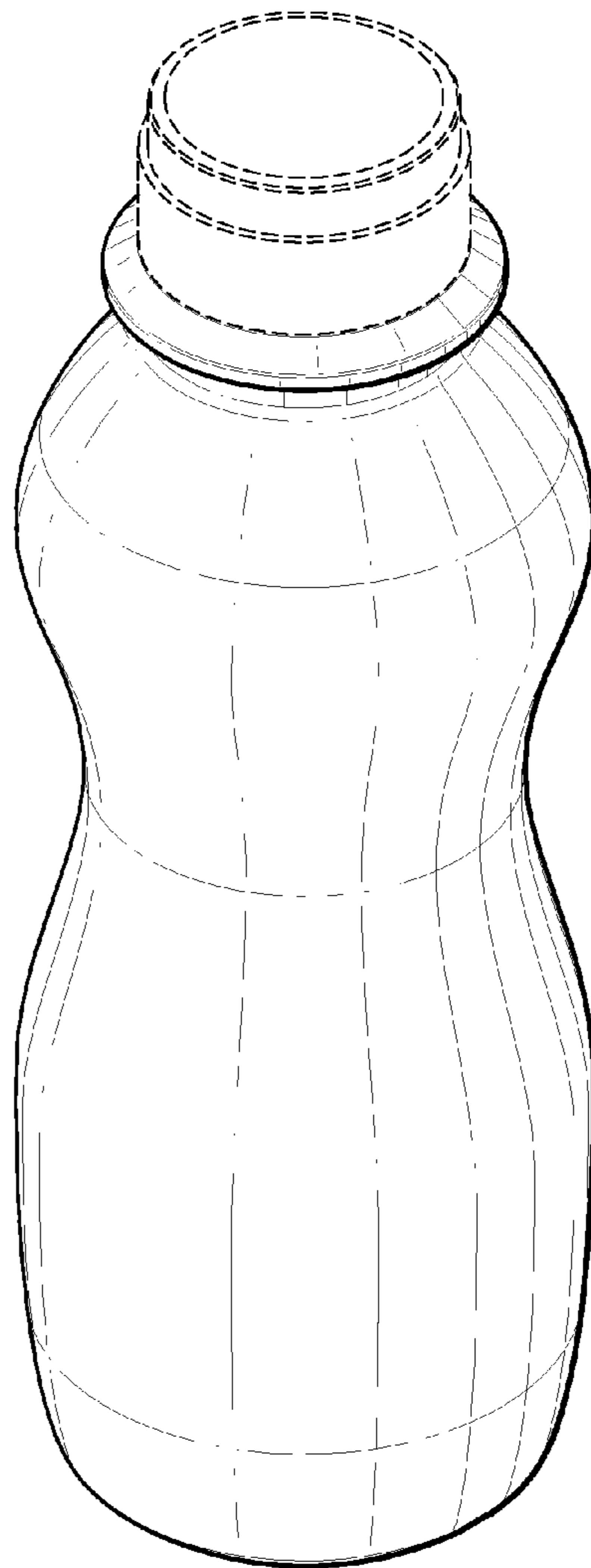

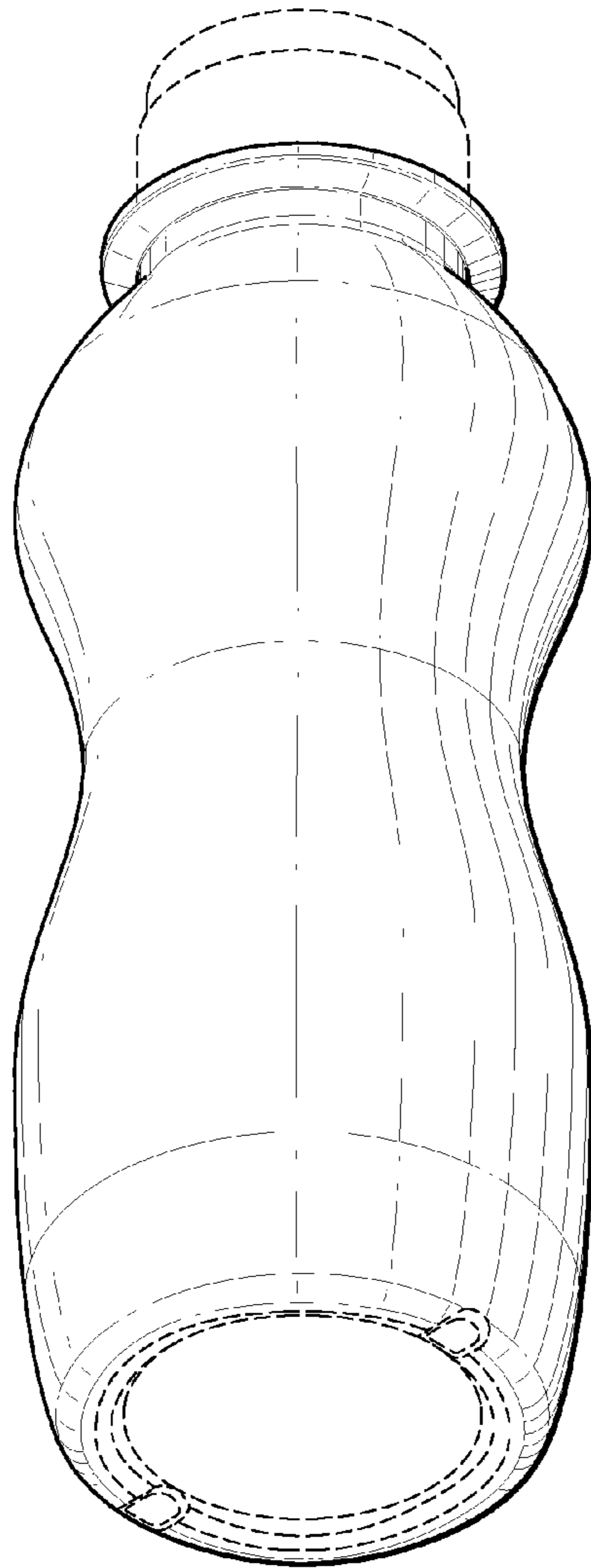

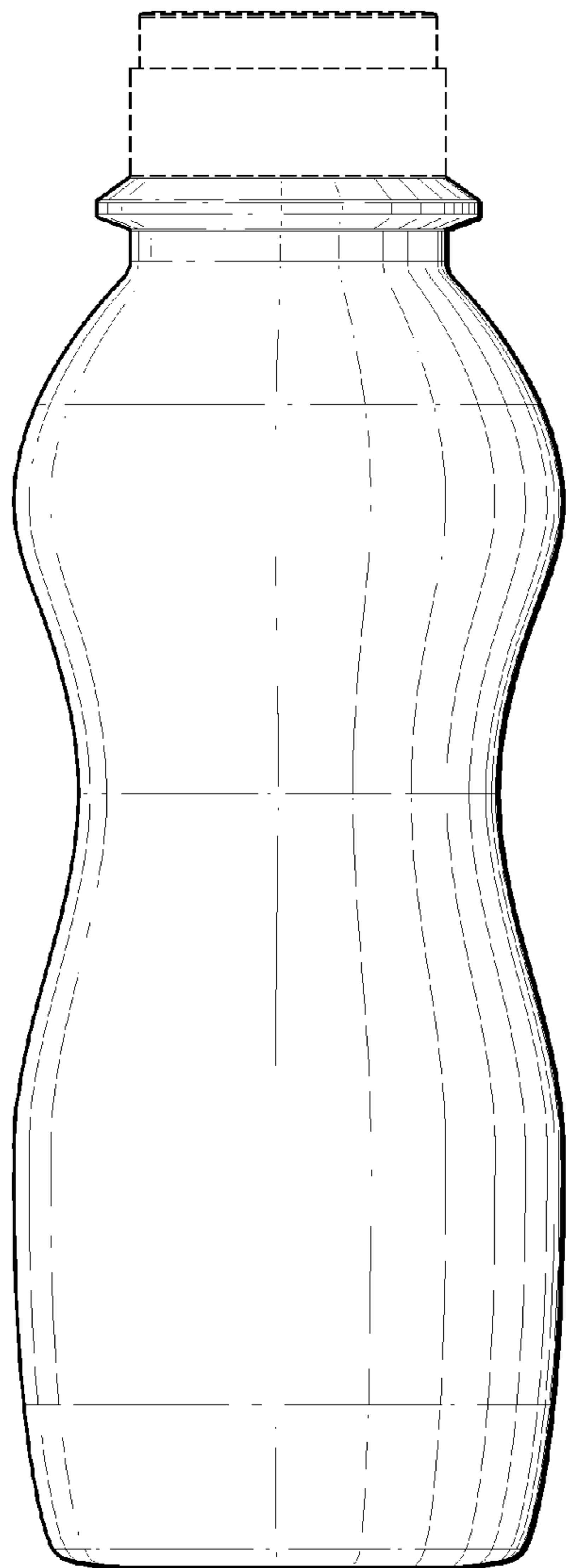

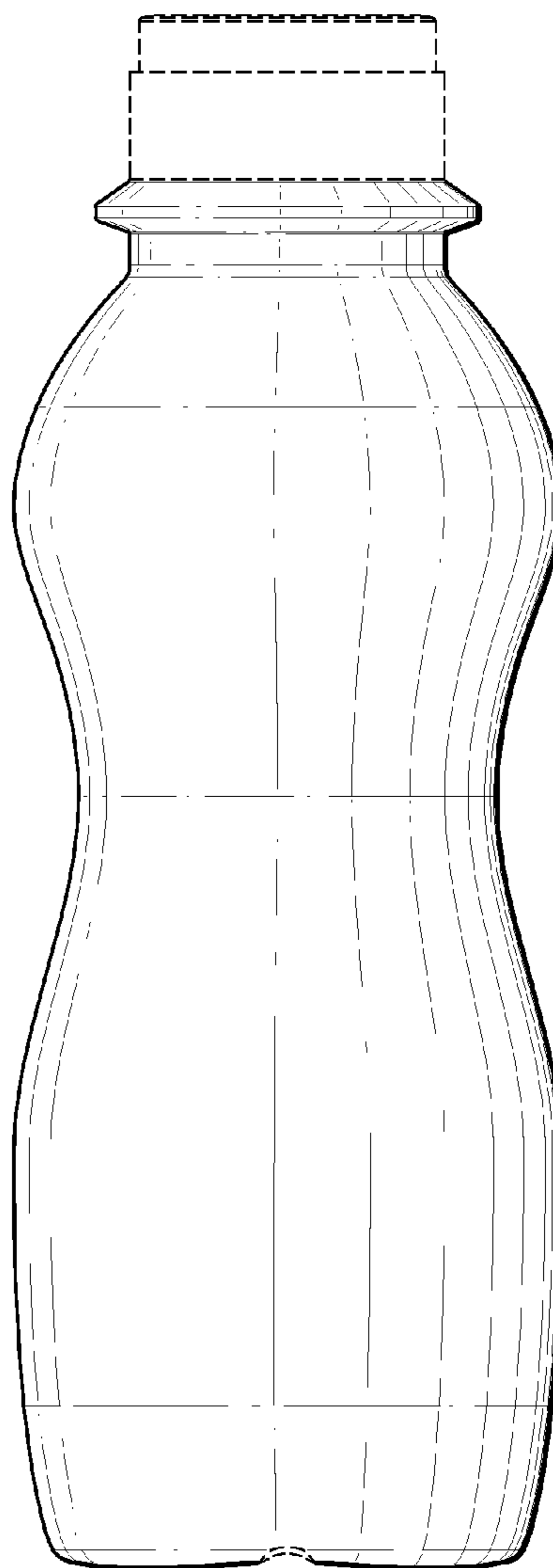

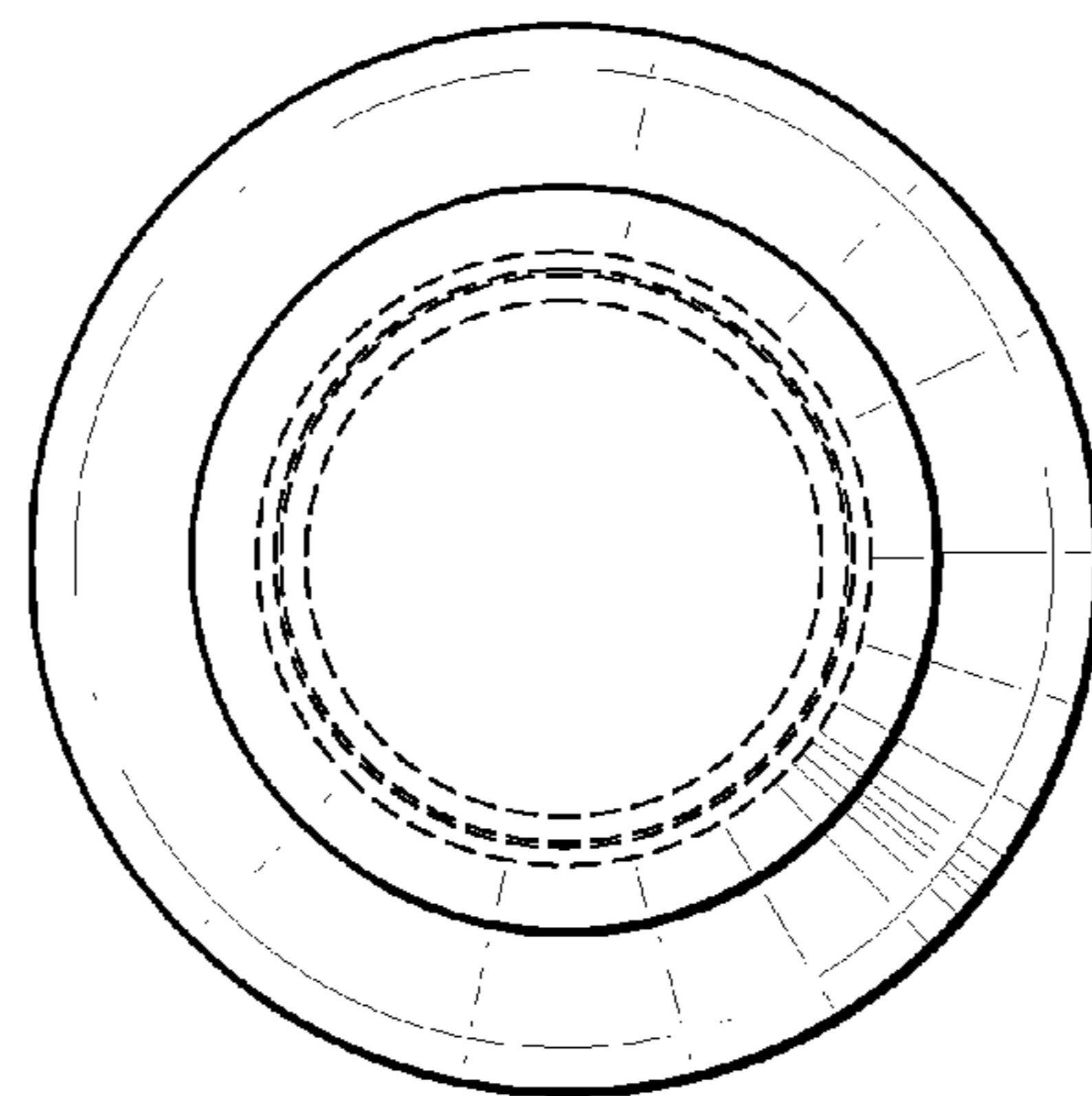

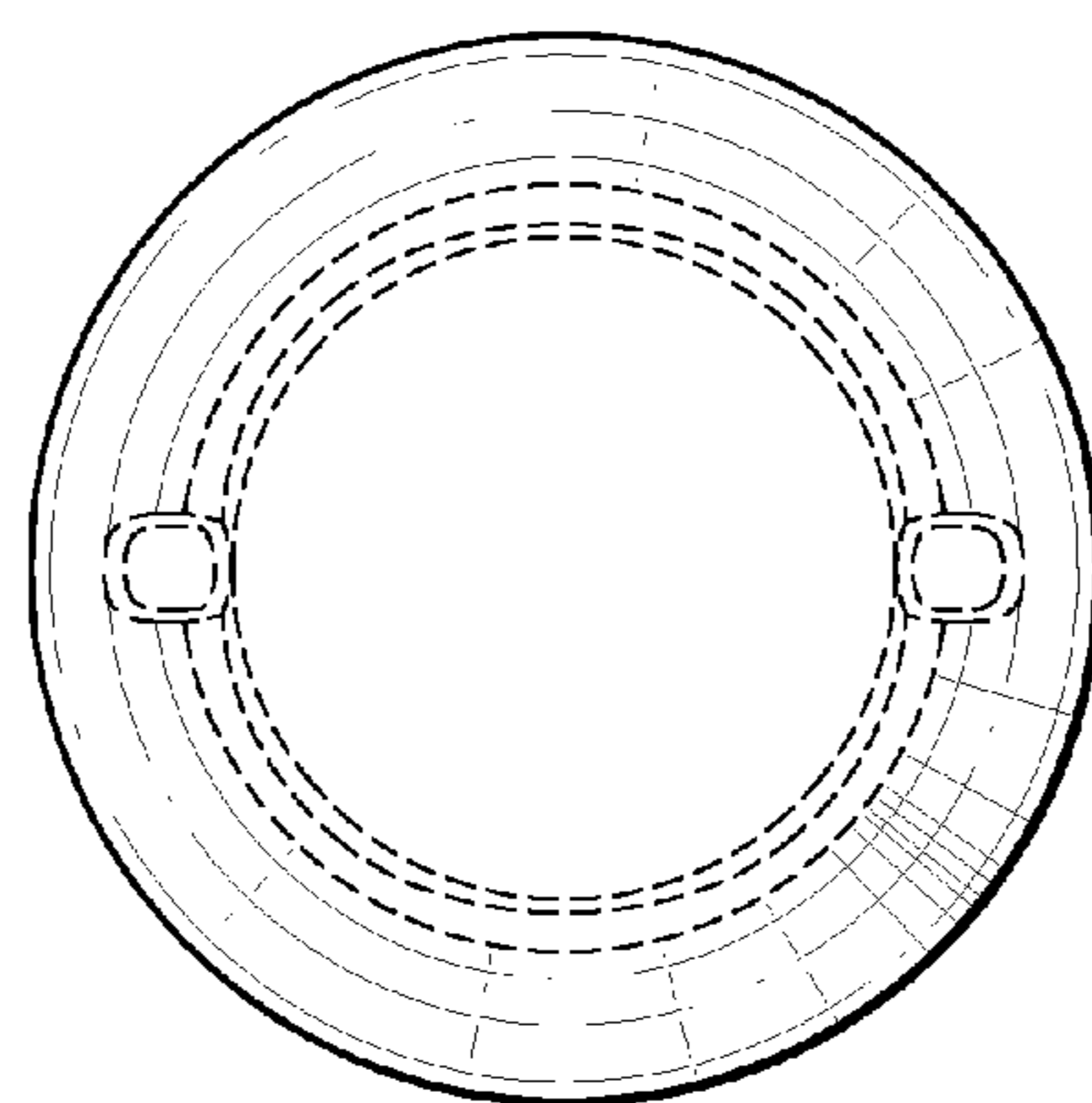
