FIG. 2 is a rear elevational view thereof; and

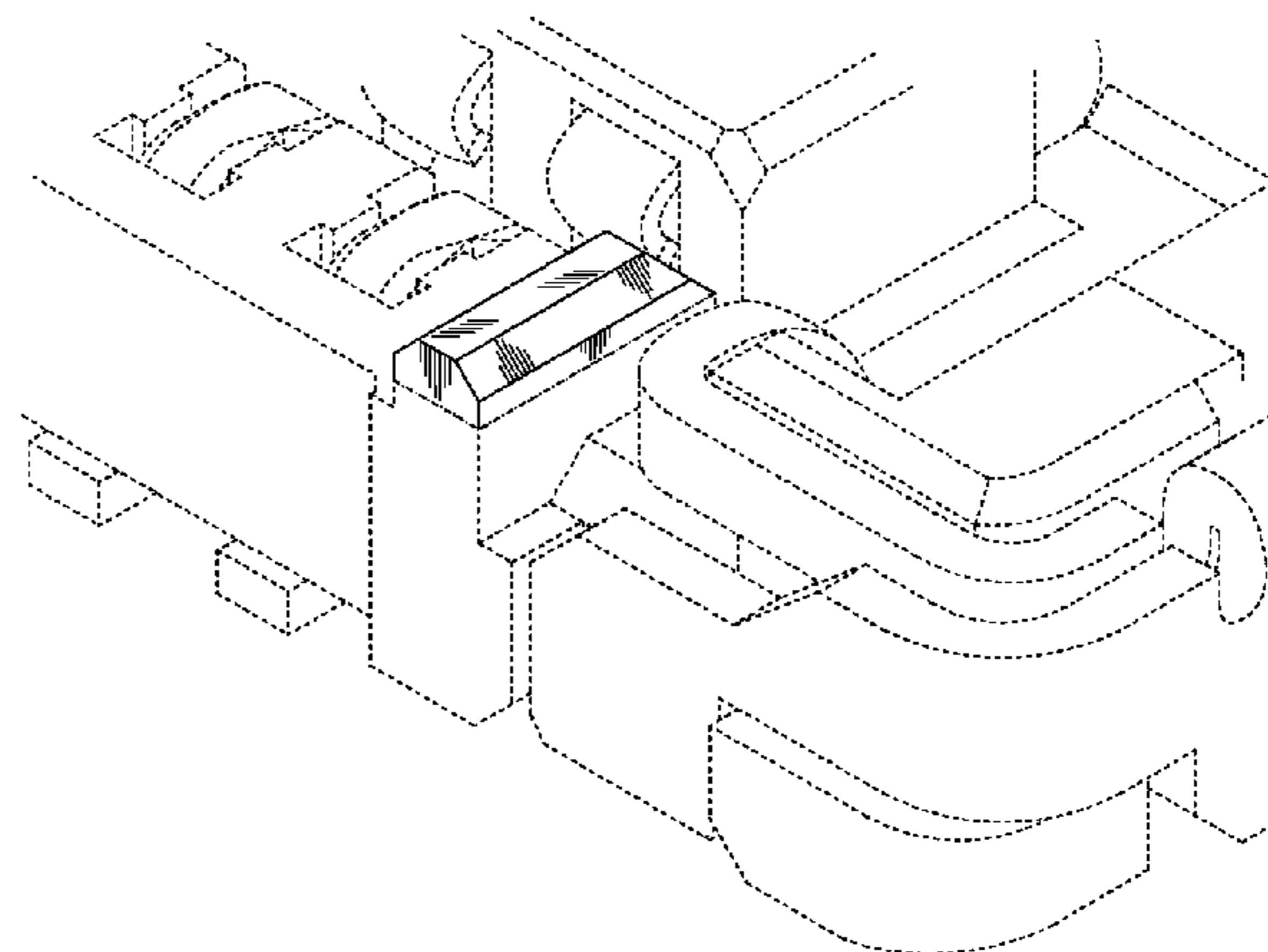
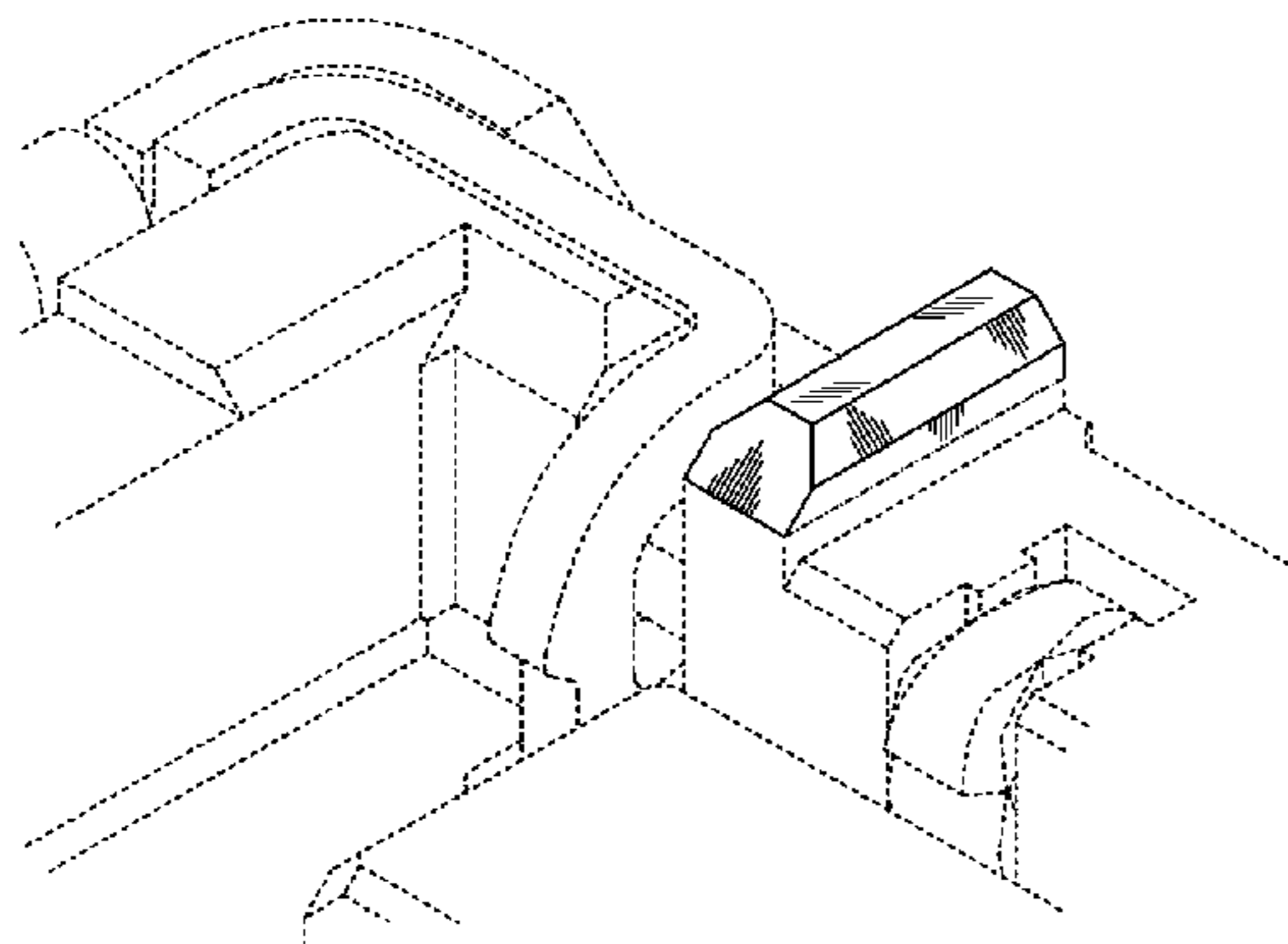
FIG. 3 is a left side elevational view thereof.

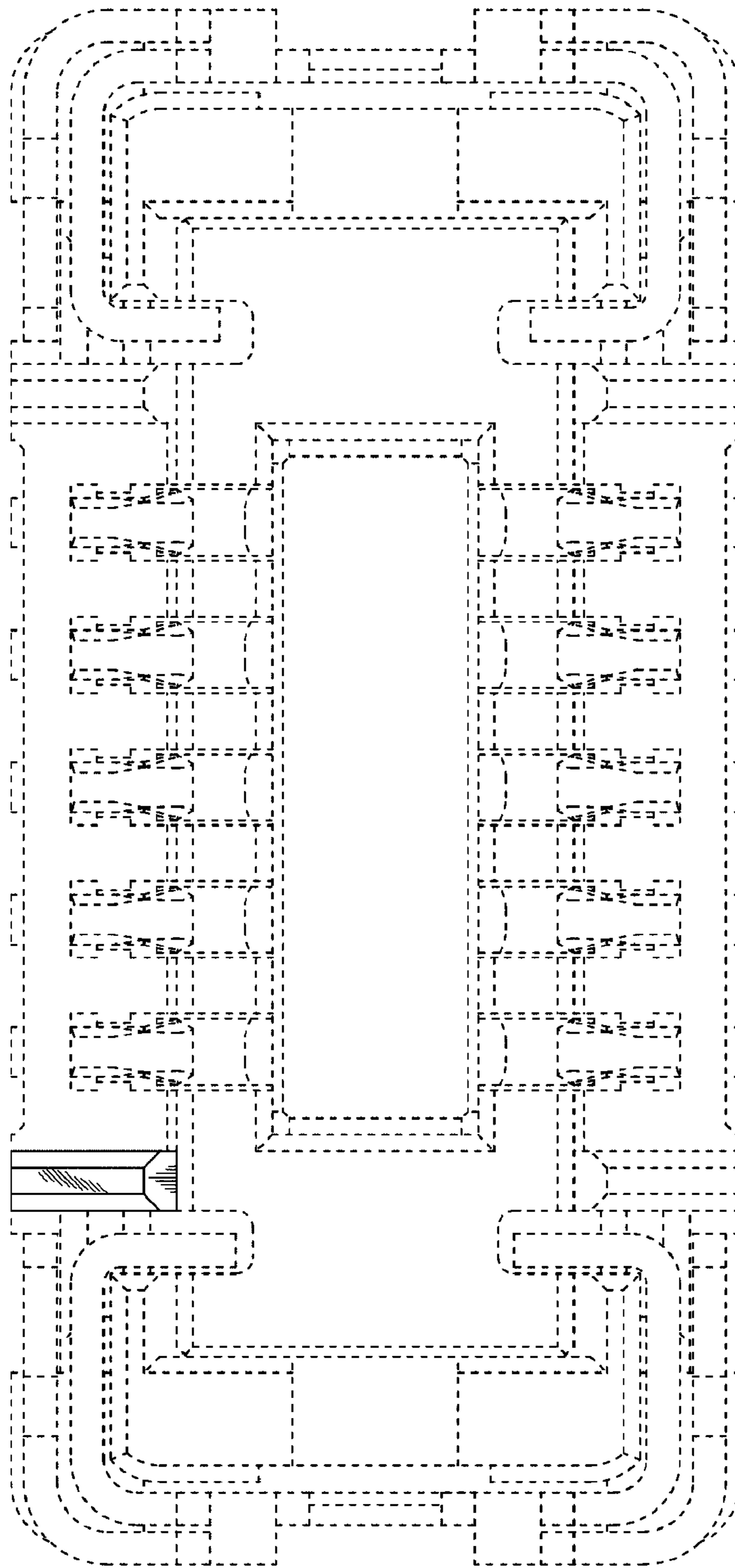

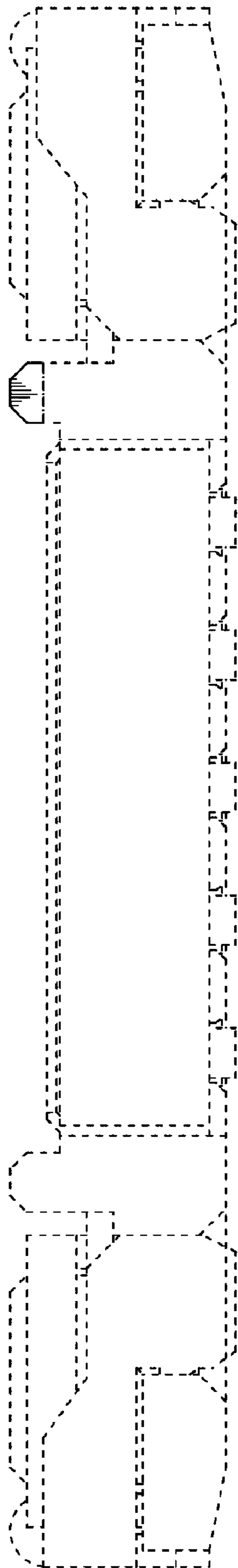

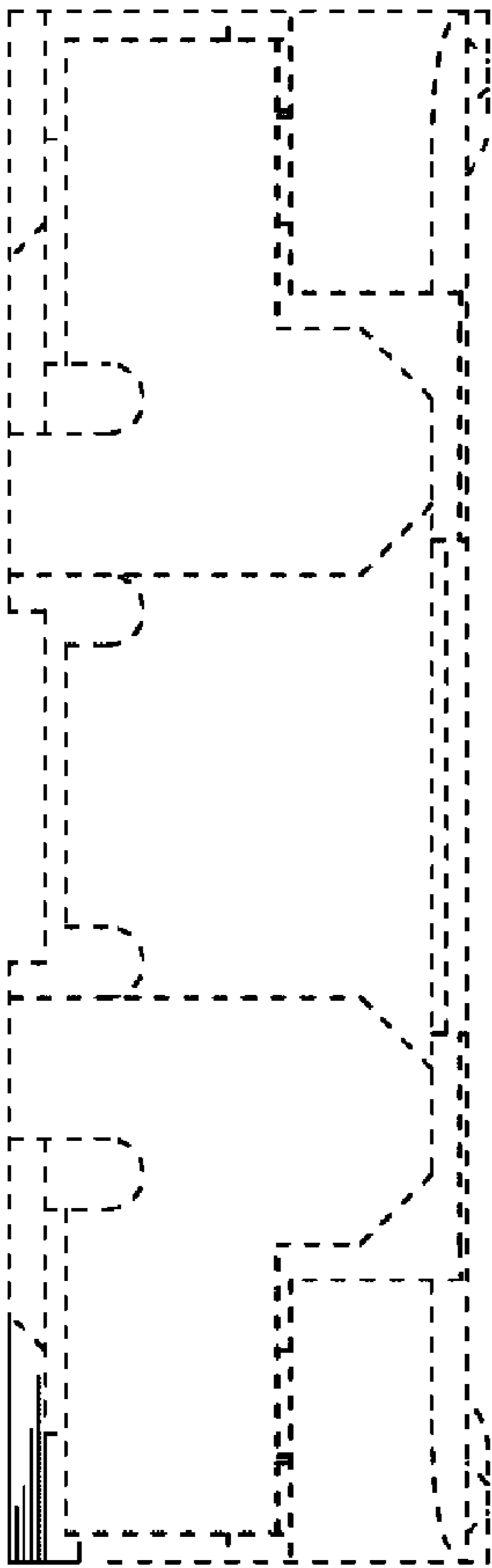

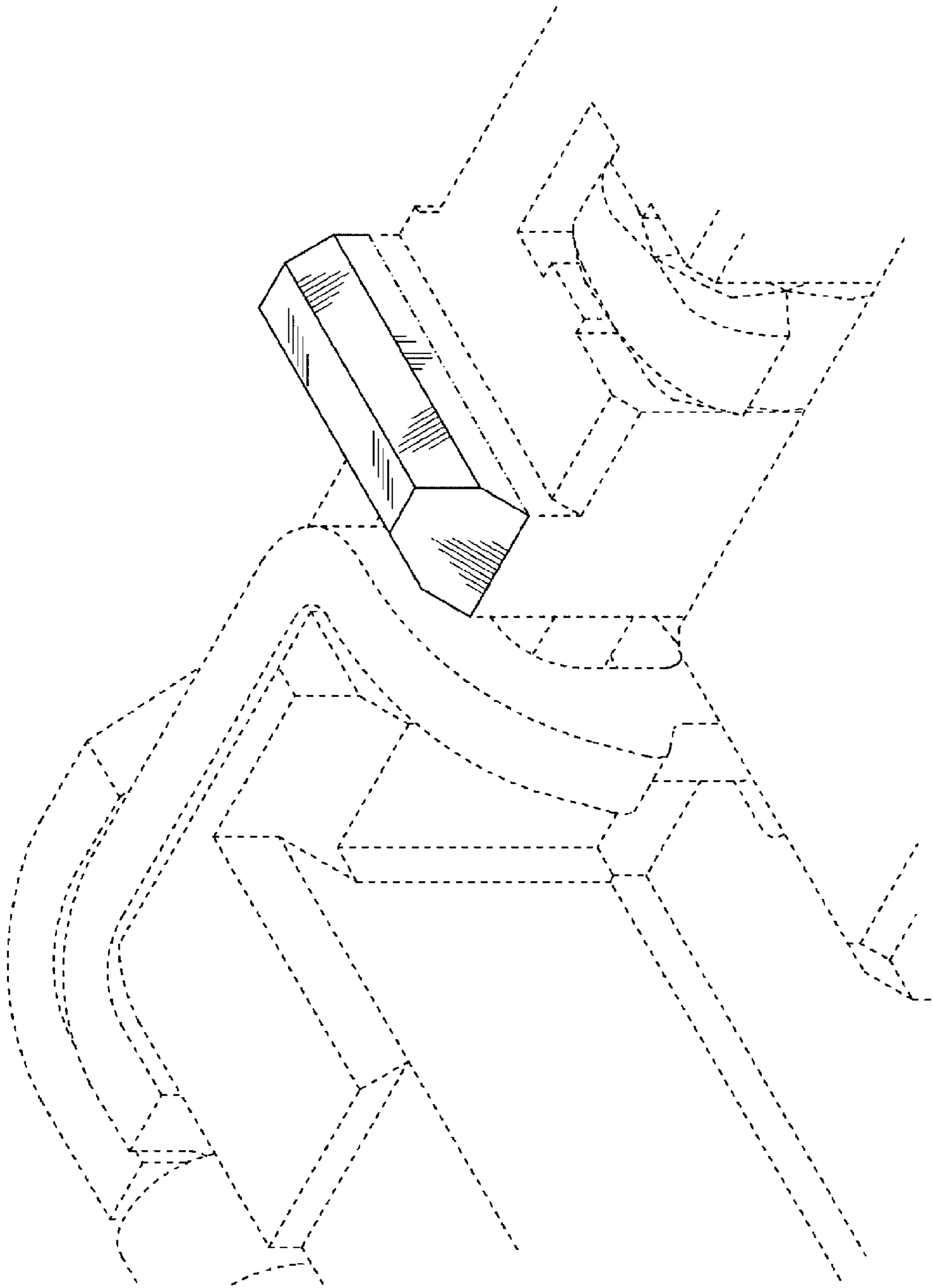

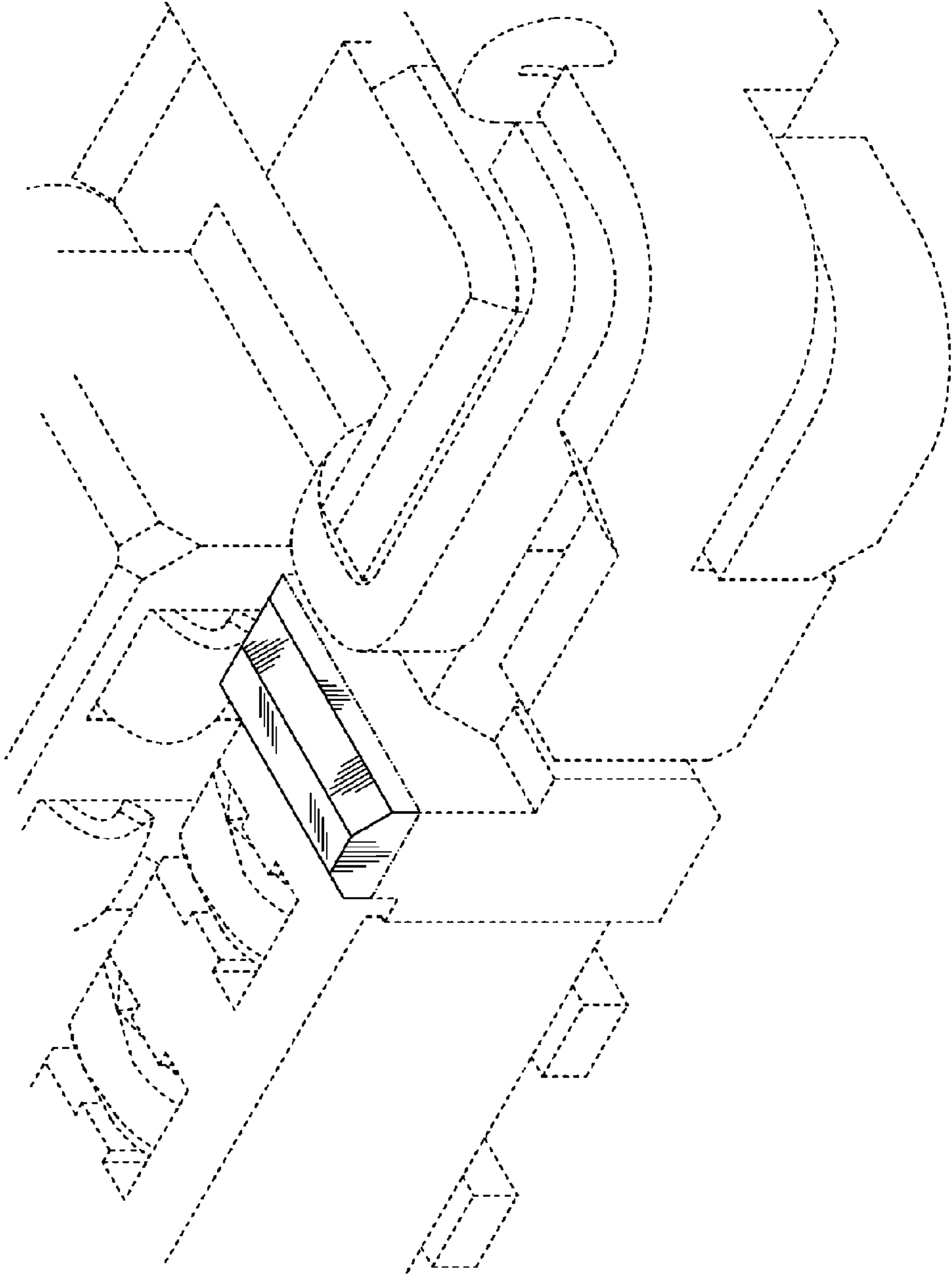
