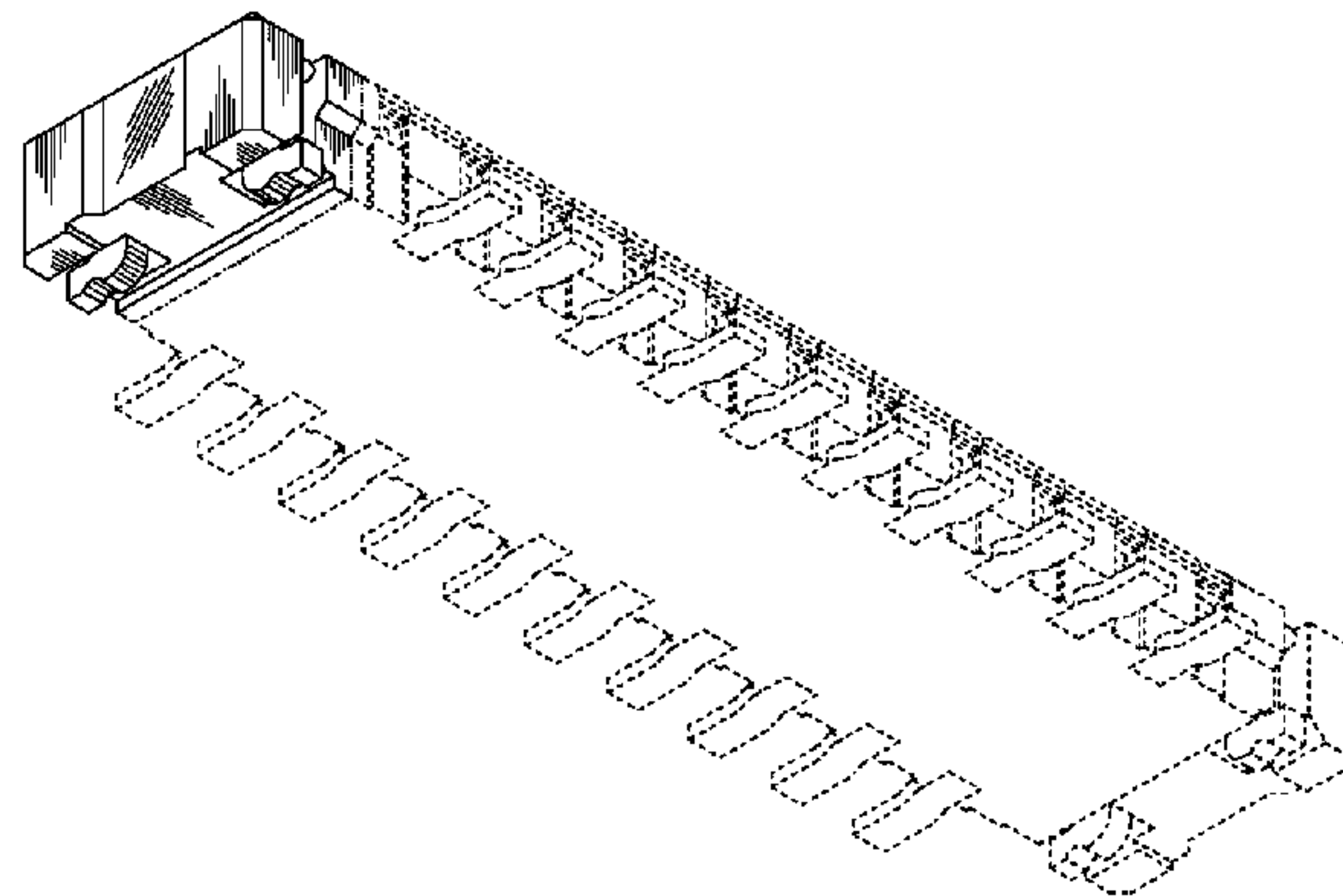
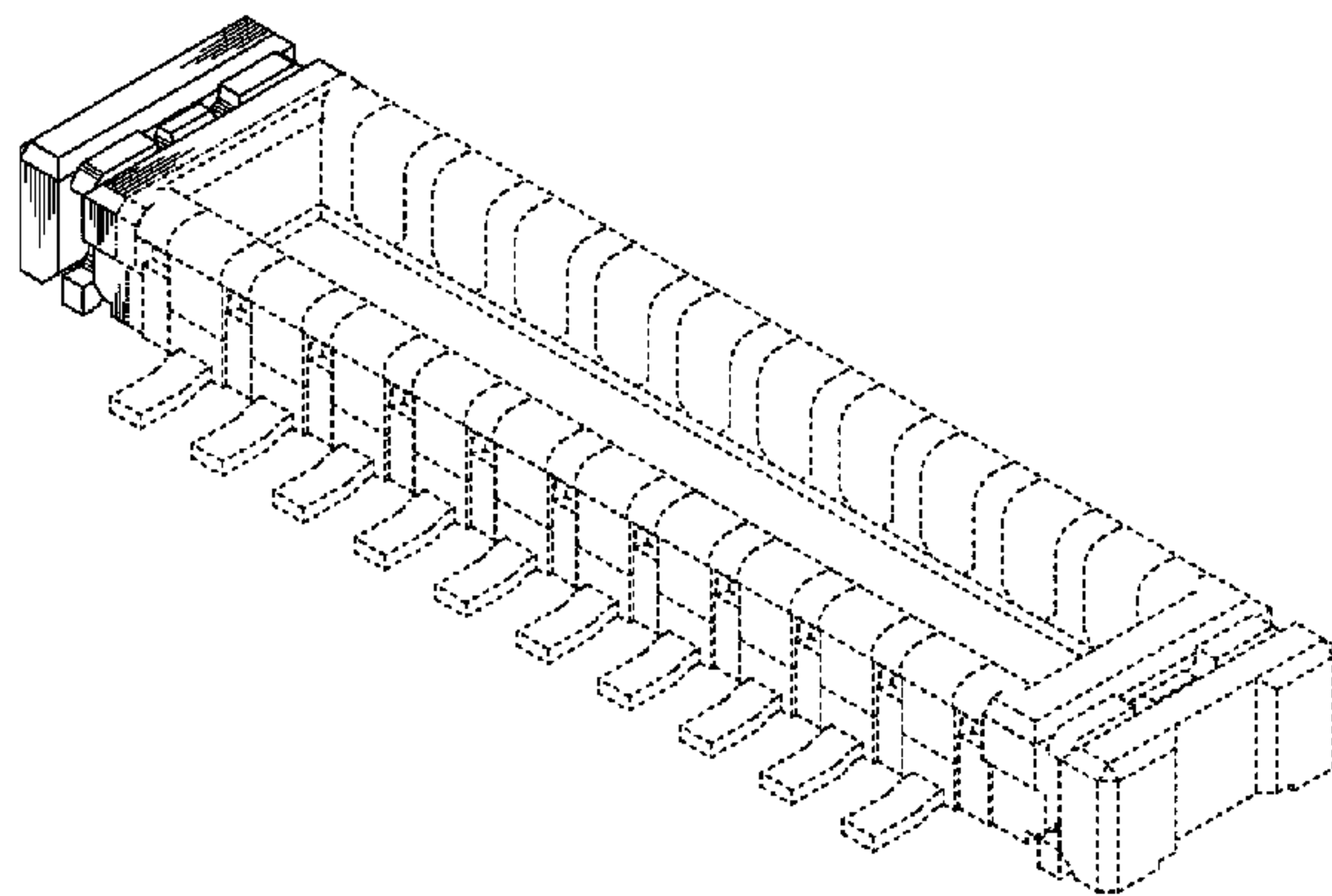
The ornamental design for an electrical connector part, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an electrical connector part showing our new design thereof; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a top perspective view thereof; and, FIG. 7 is a bottom perspective view thereof.

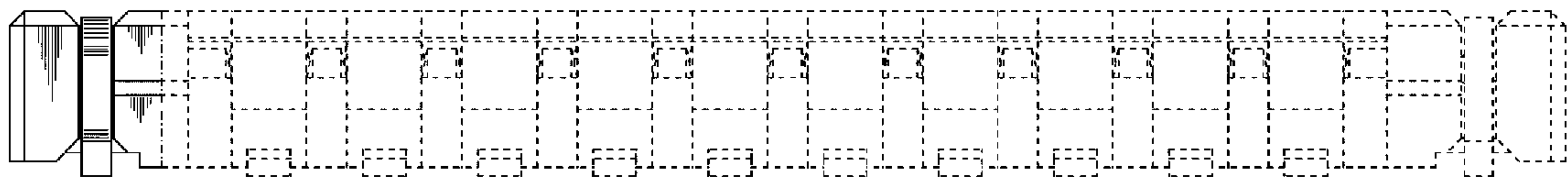

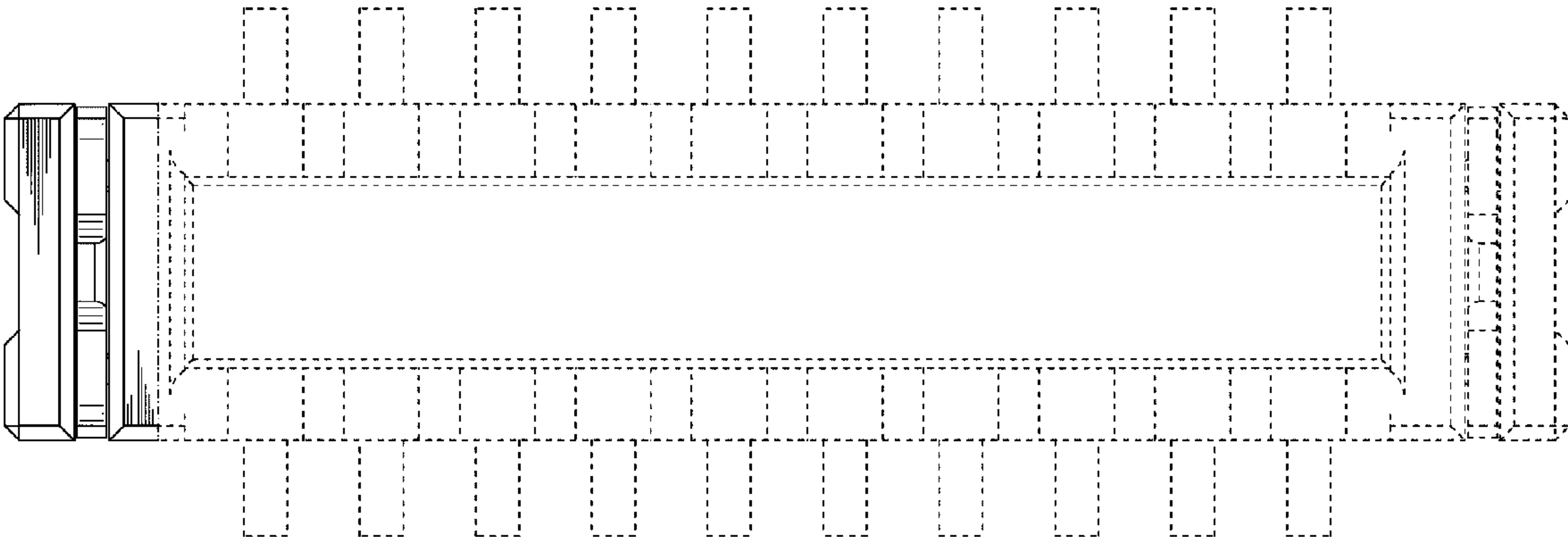

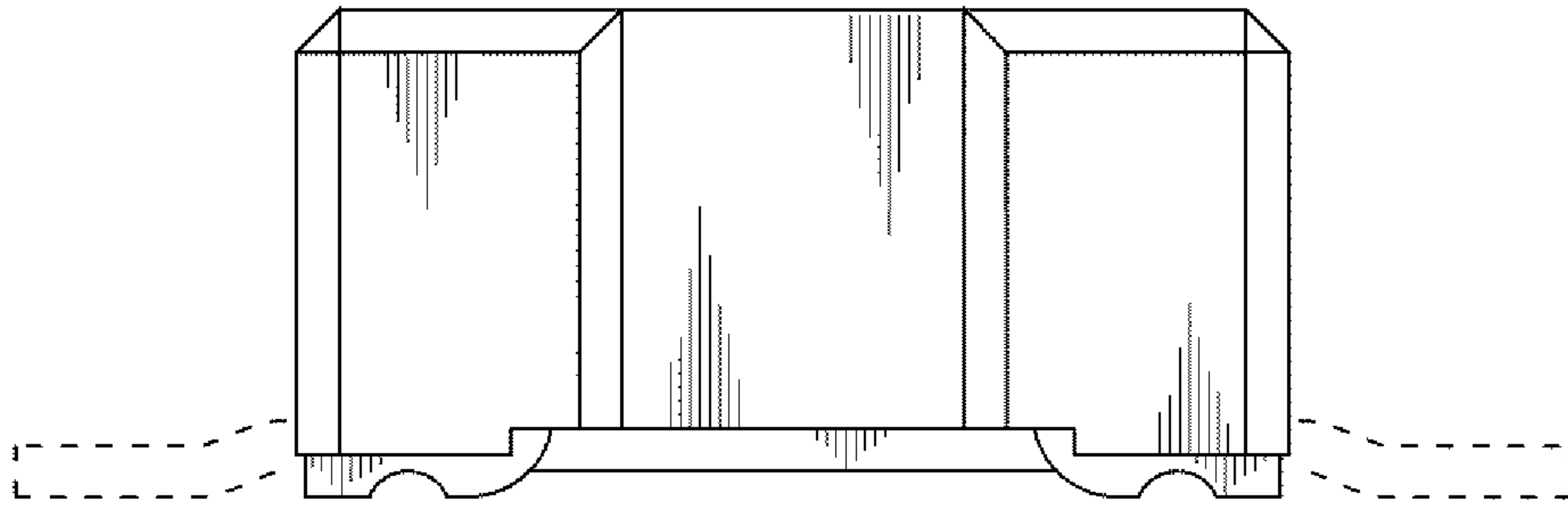

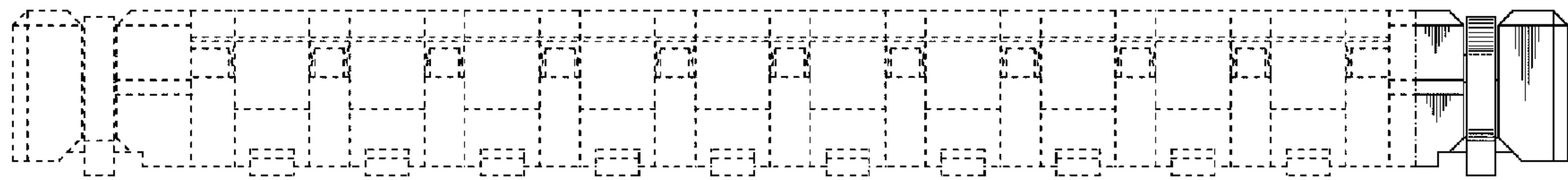

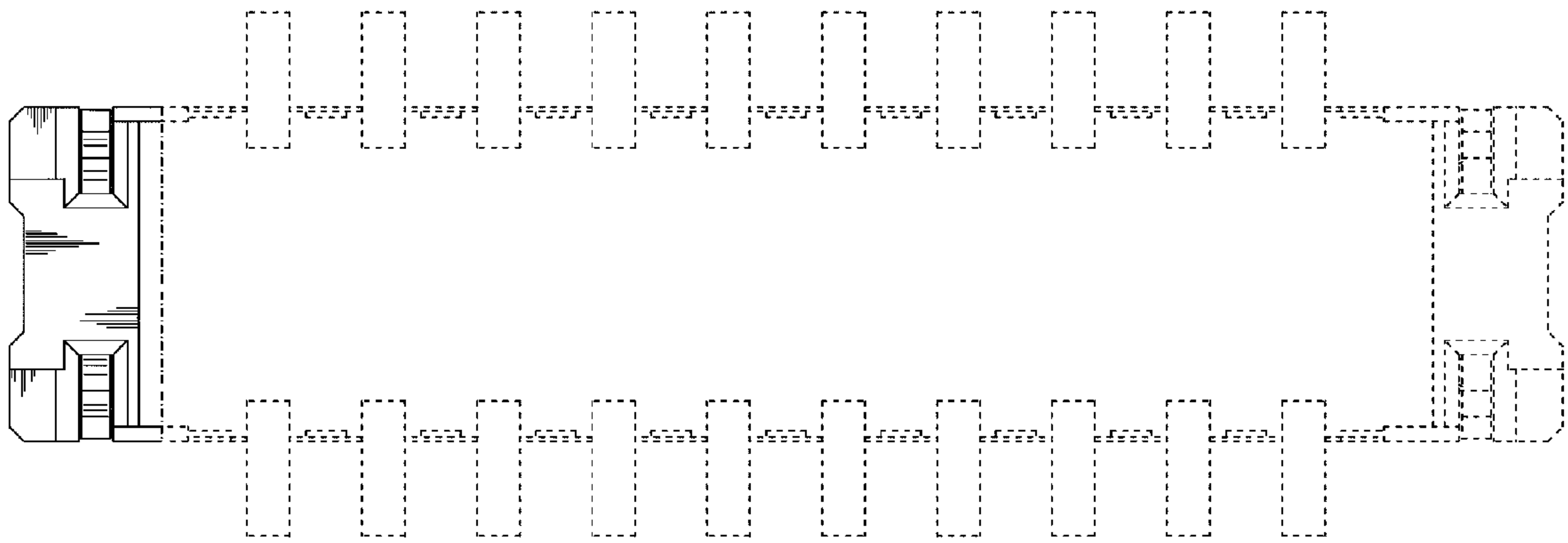

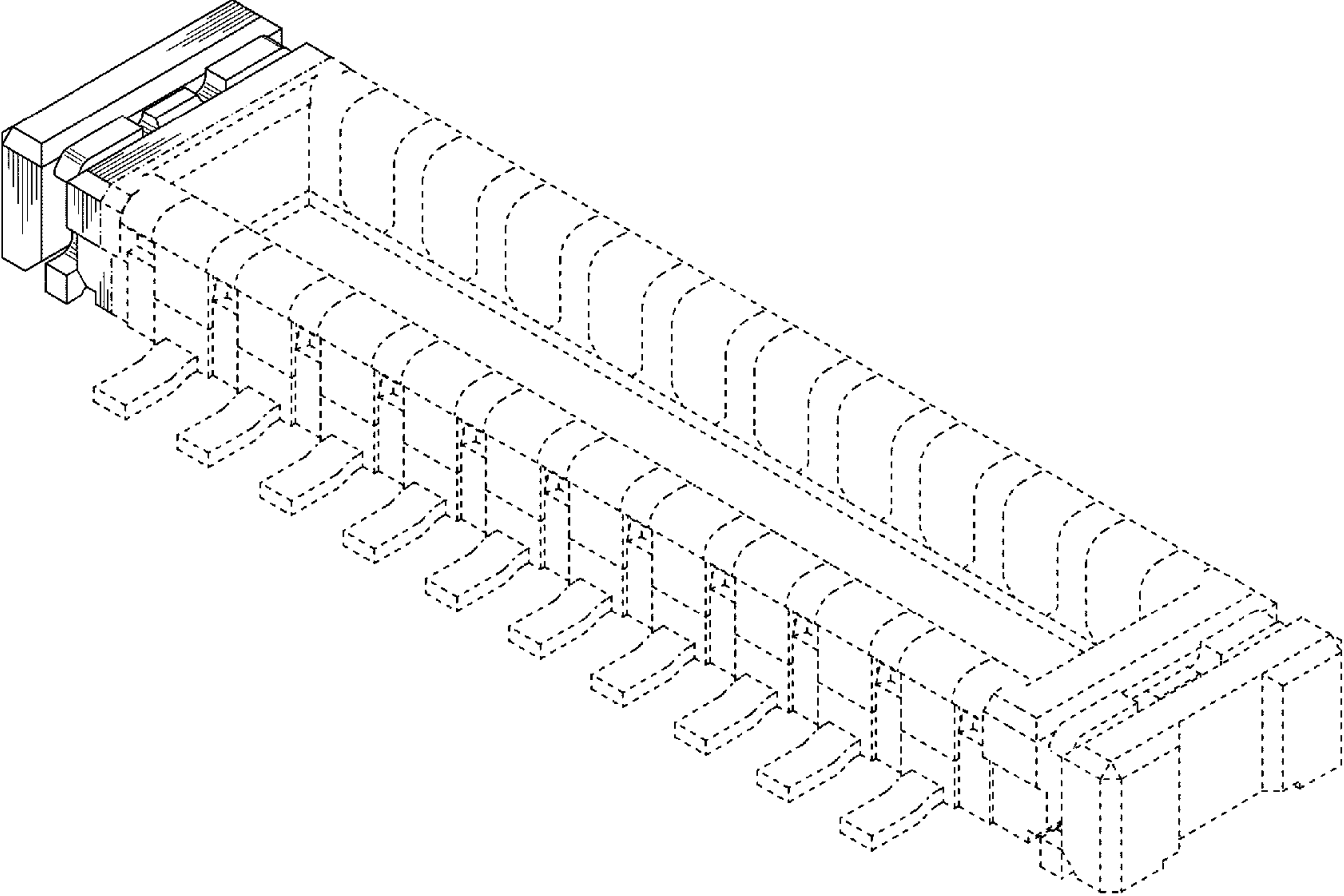

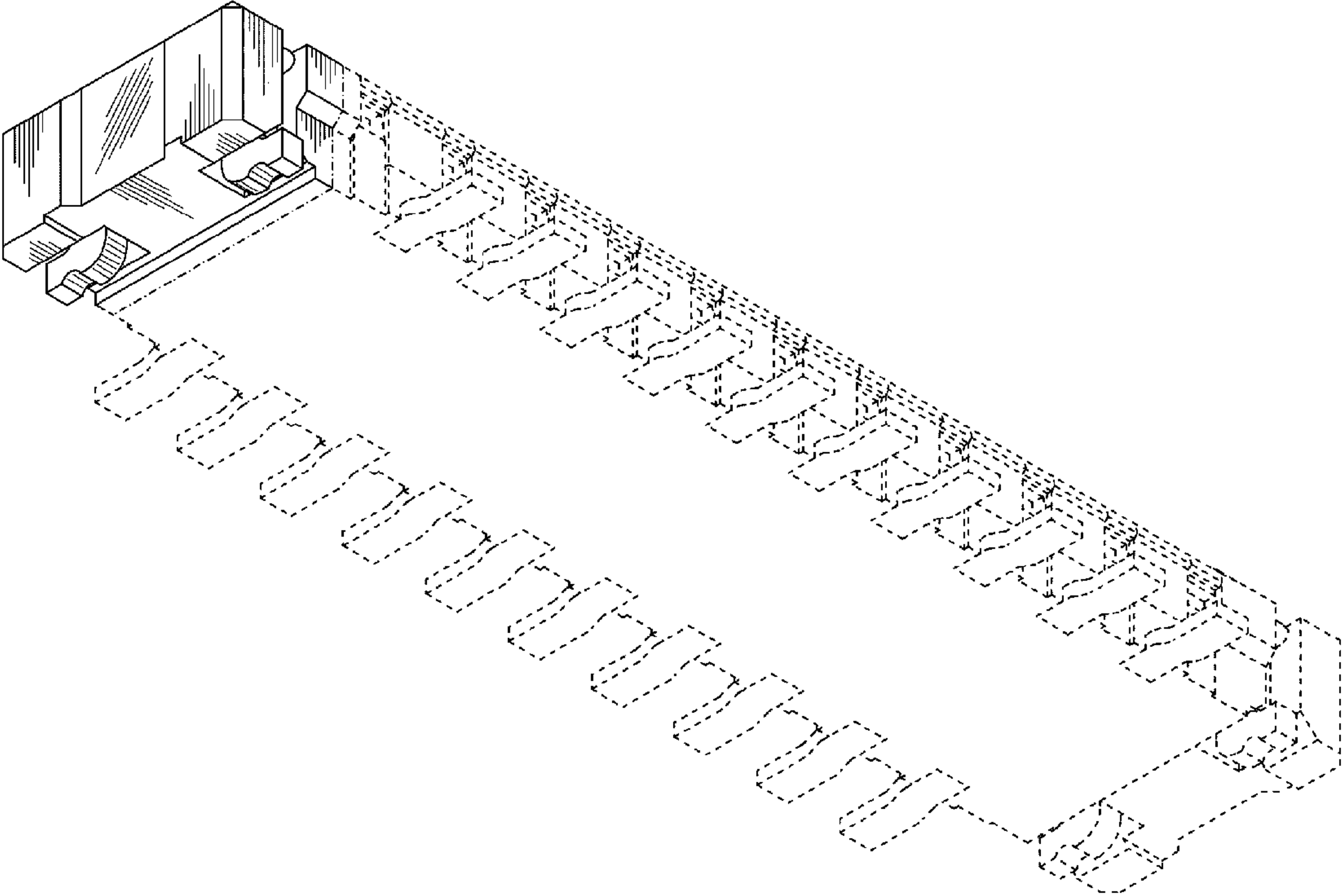
