(57) **CLAIM**

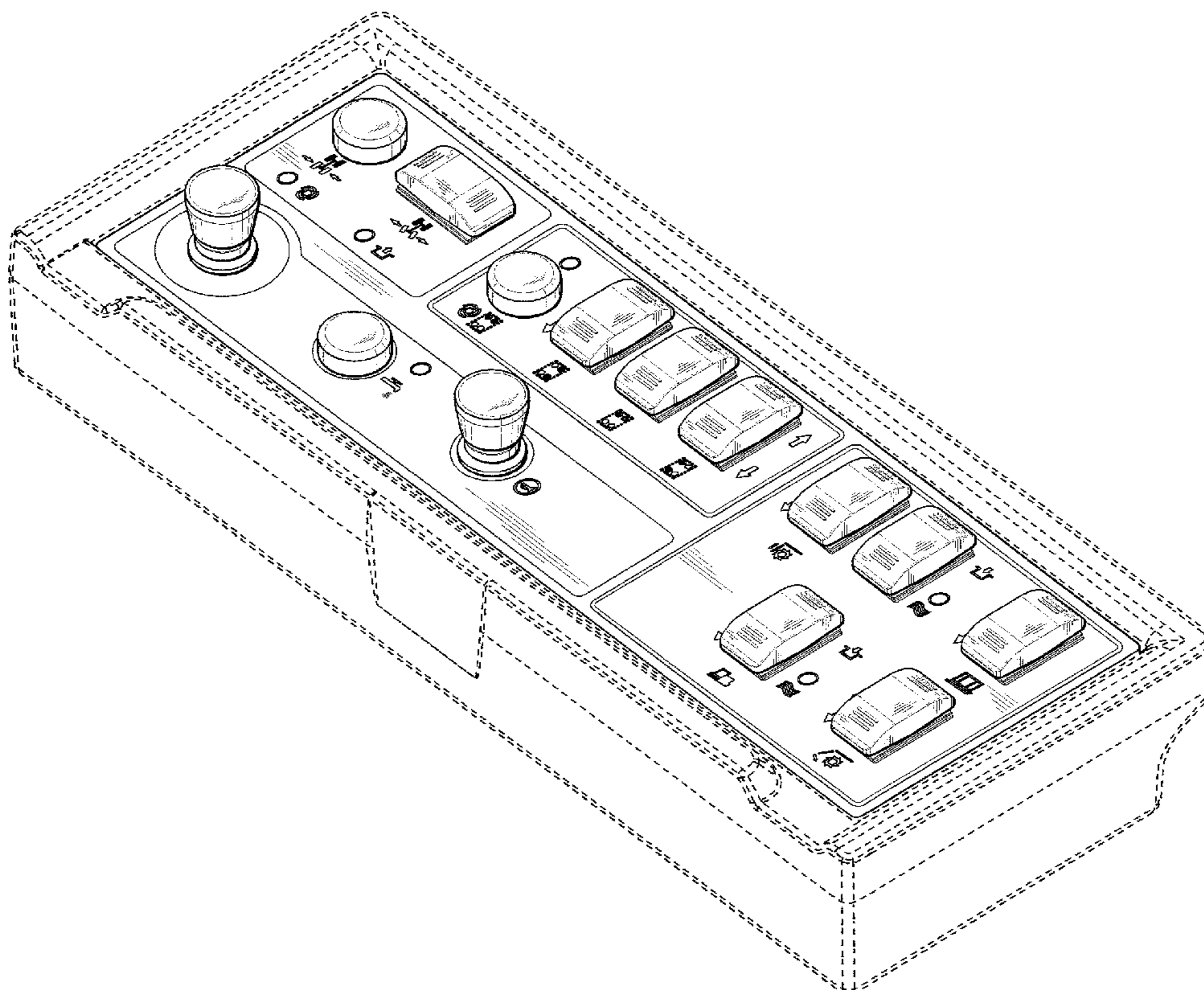
What is claimed is the ornamental design for a control panel for a construction machine, as shown and described.

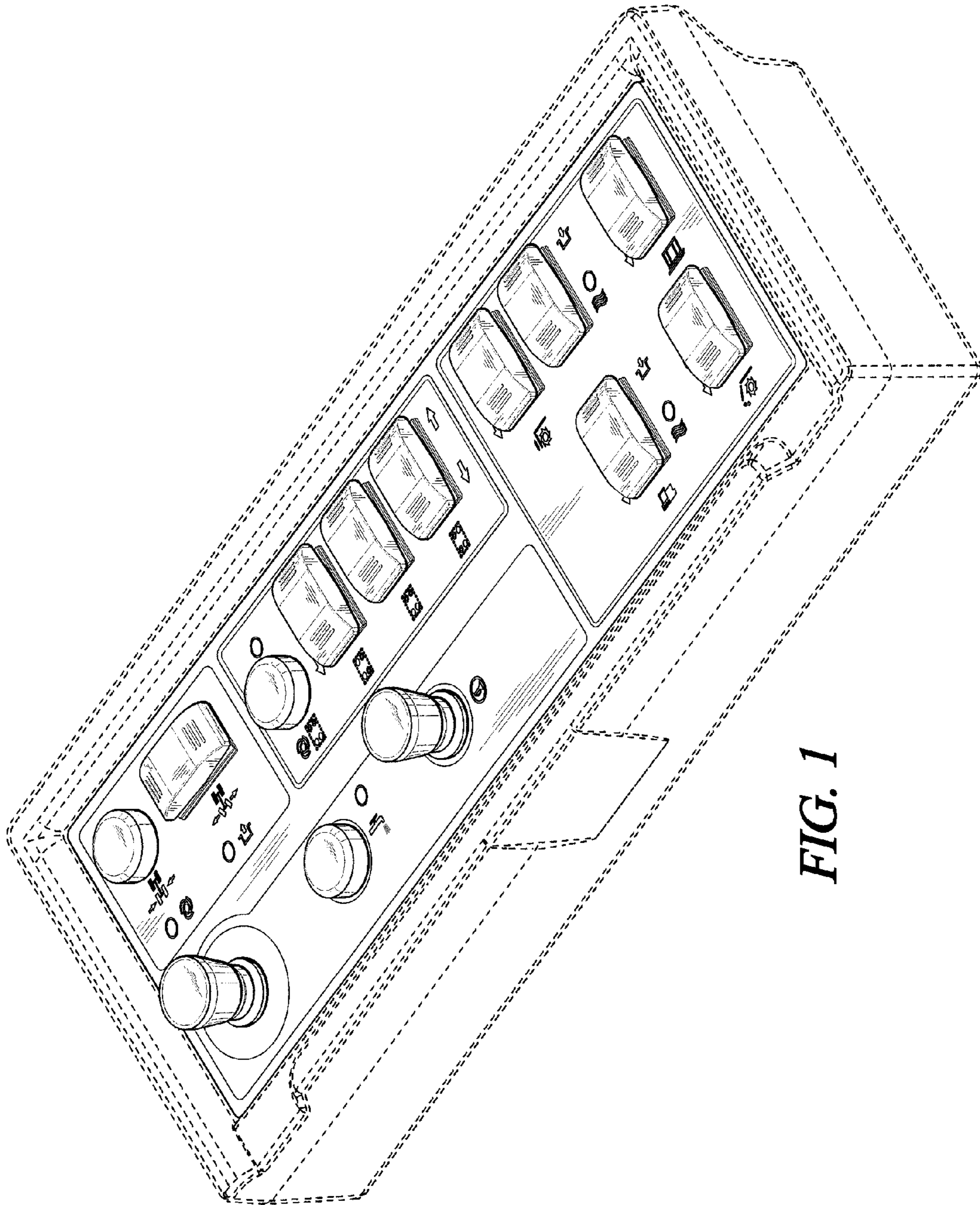

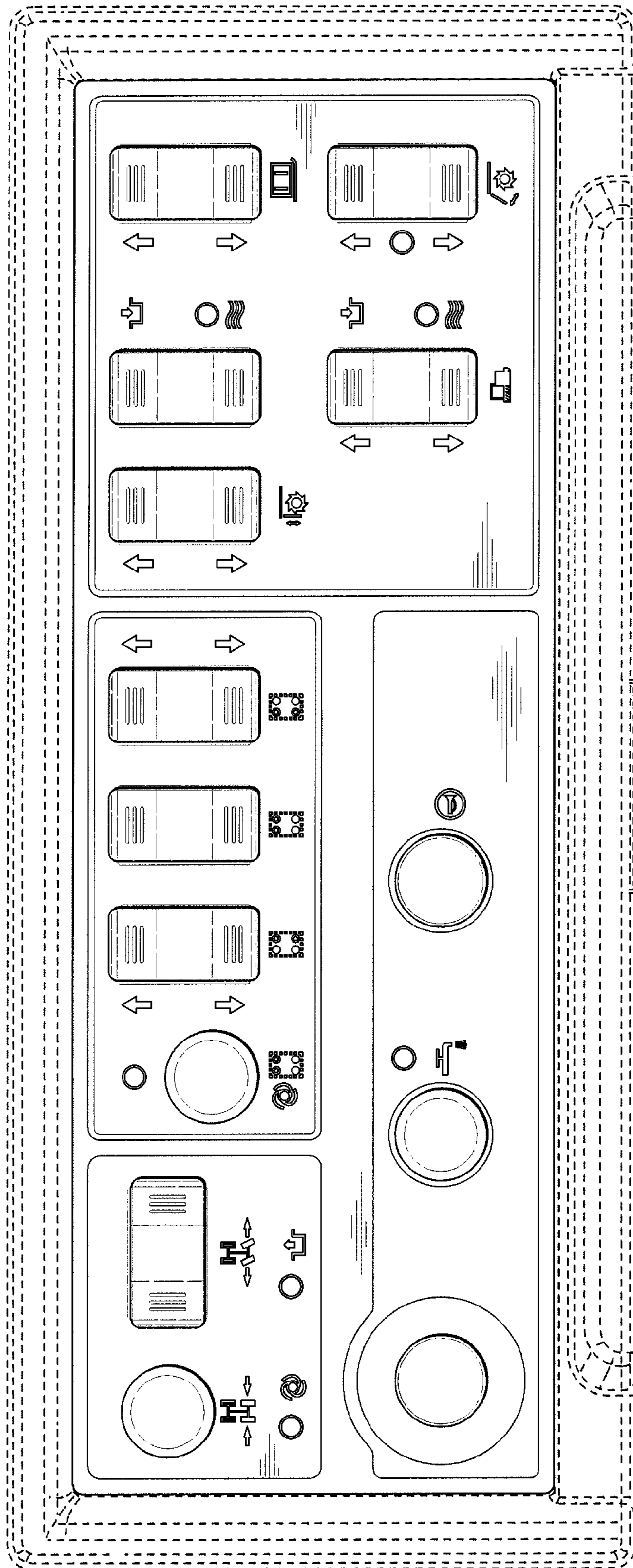
