DESCRIPTION

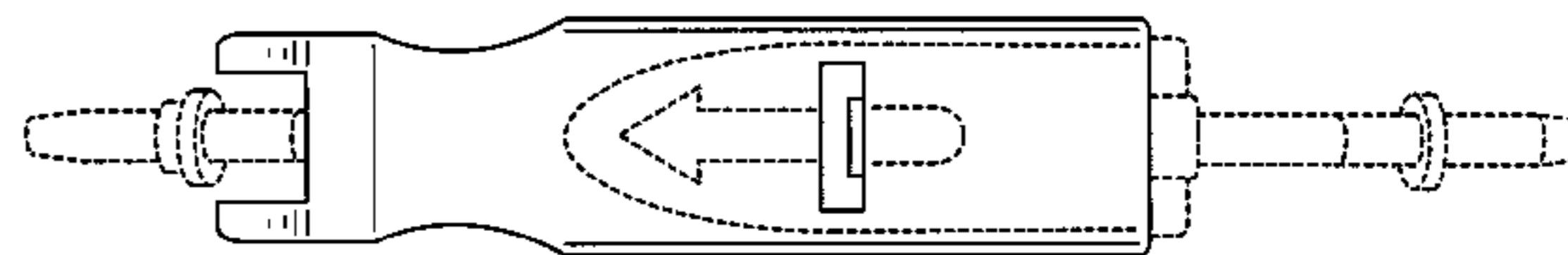
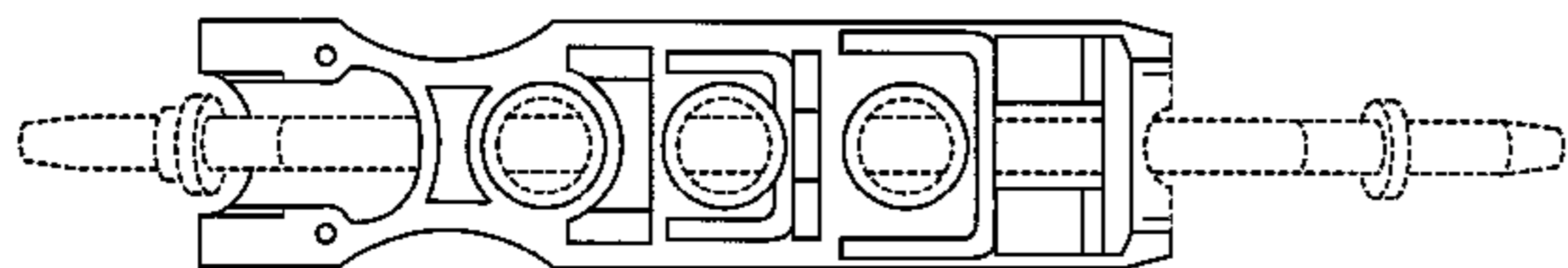
FIG. 1 is a front view of a passive mechanical interface for peristaltic pump, showing my new design;

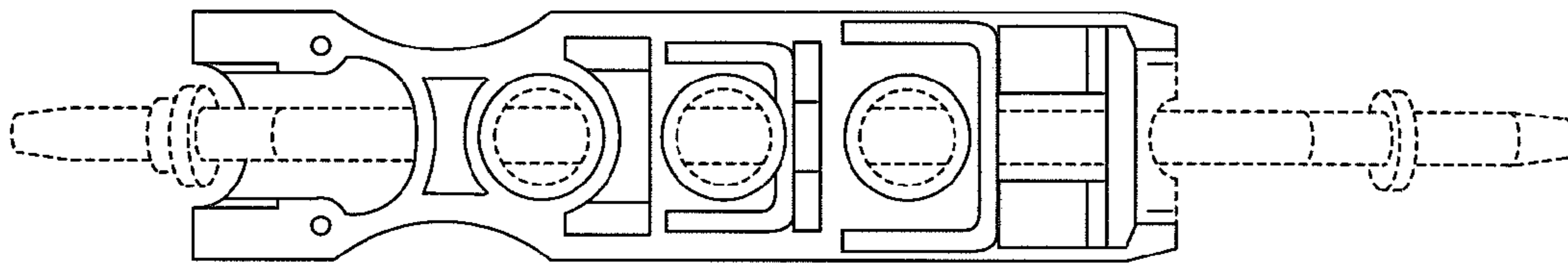

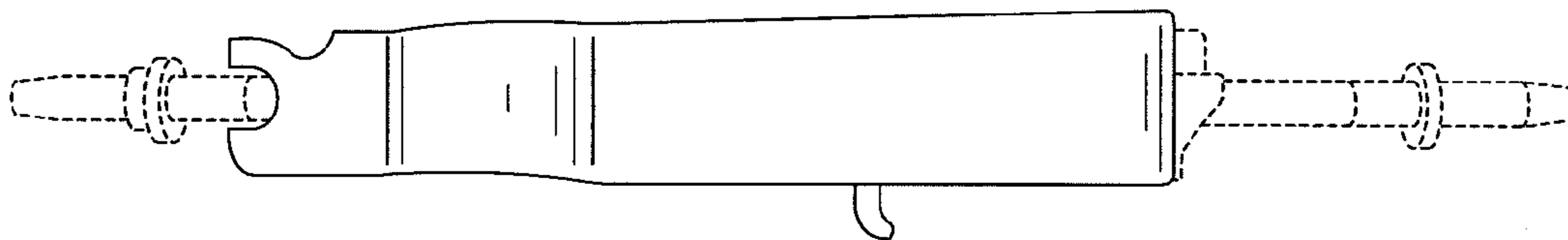

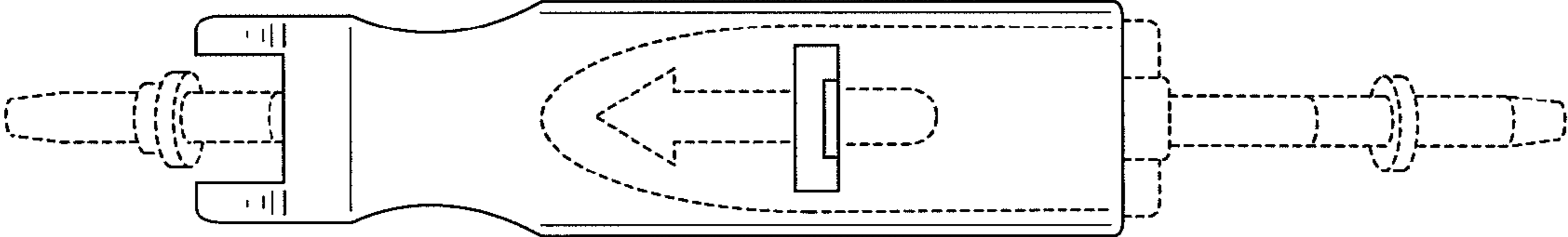
