(57) **CLAIM**

The ornamental design for a surgical retractor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical retractor;

FIG. 2 is a top plan view of the surgical retractor illustrated in FIG. 1;

FIG. 3 is a left side elevational view of the surgical retractor illustrated in FIG. 1, the right side elevational view being a mirror image;

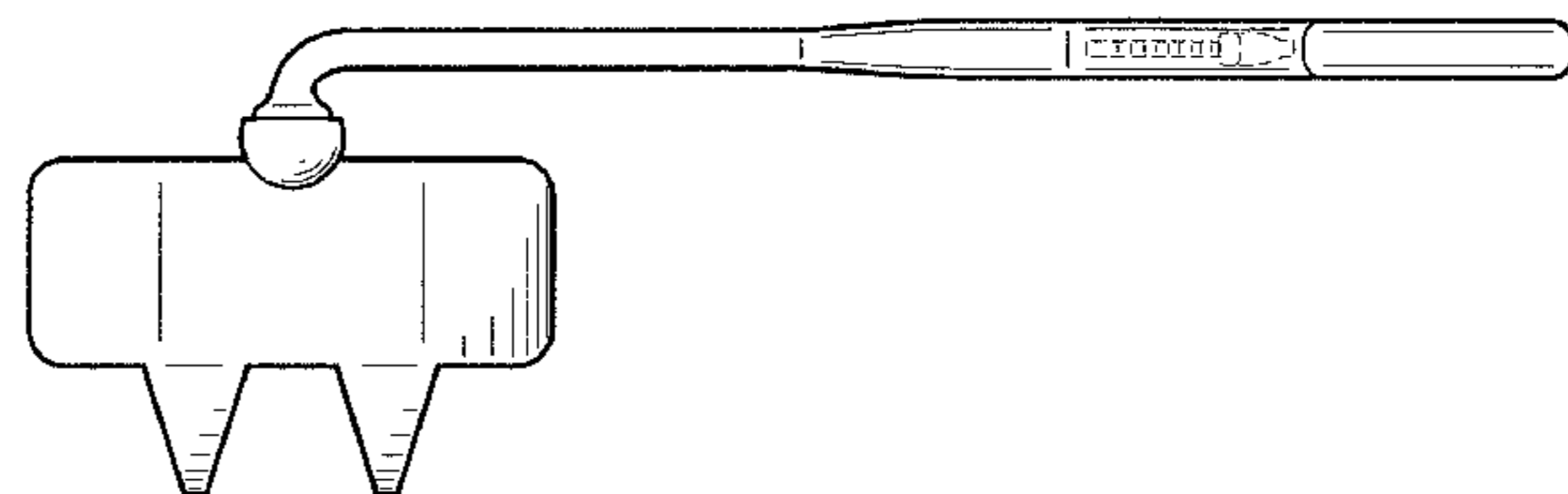
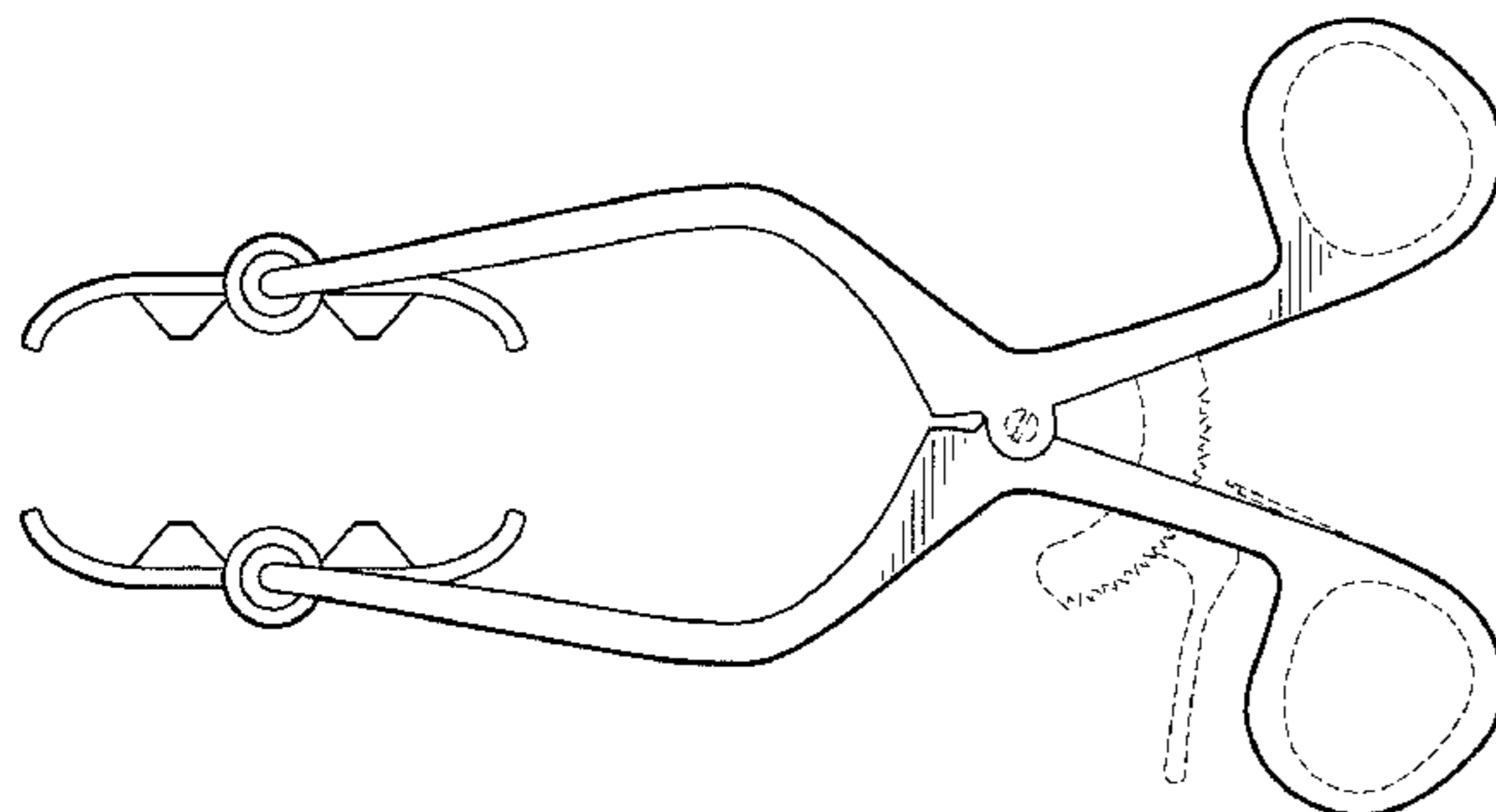
FIG. 4 is a magnified top plan view of a part of the surgical retractor illustrated in FIG. 1;

FIG. 5 is a magnified front elevational view of the part illustrated in FIG. 4, the rear elevational view of the part being a mirror image; and,

FIG. 6 is a magnified left side elevational view of the part illustrated in FIG. 4.

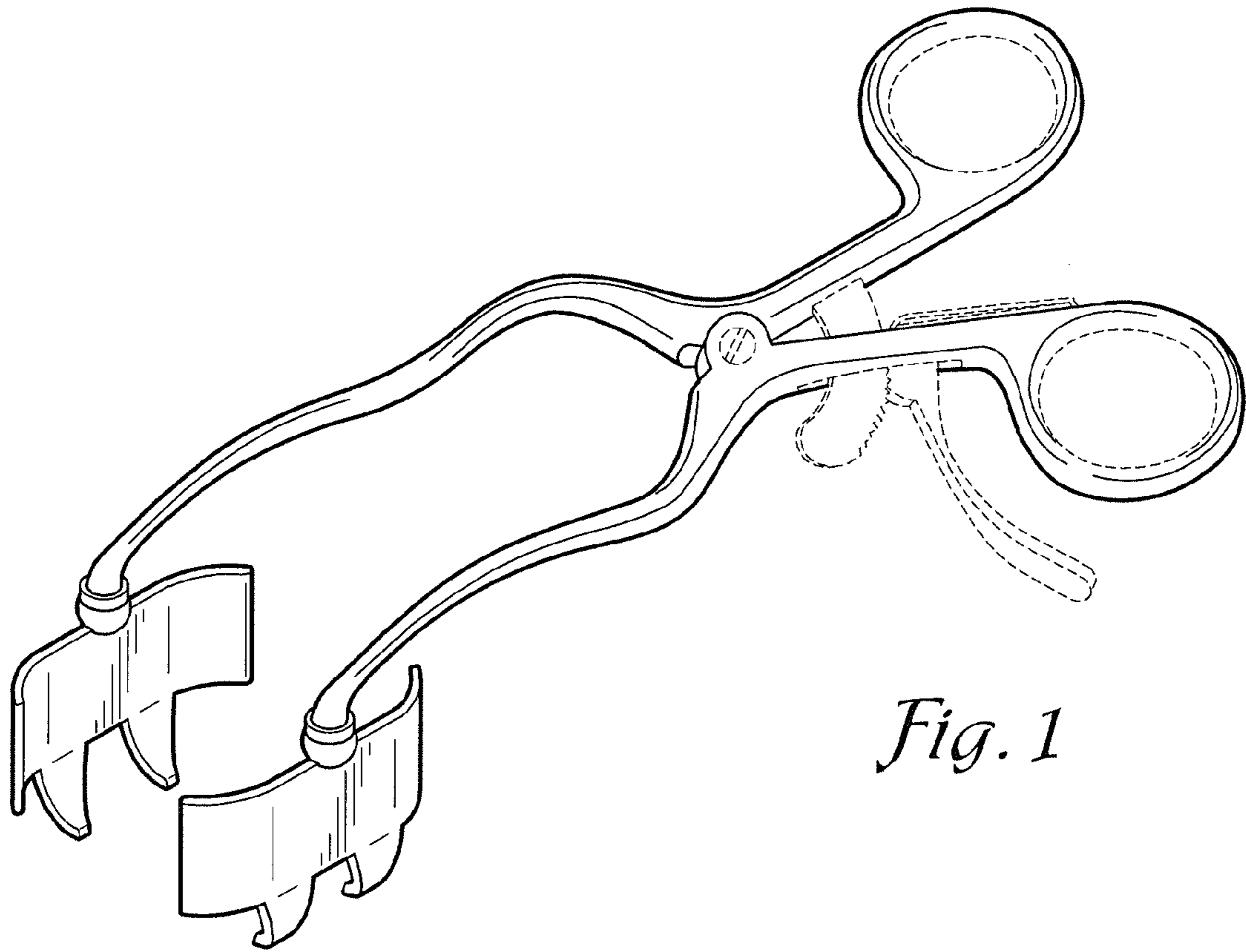

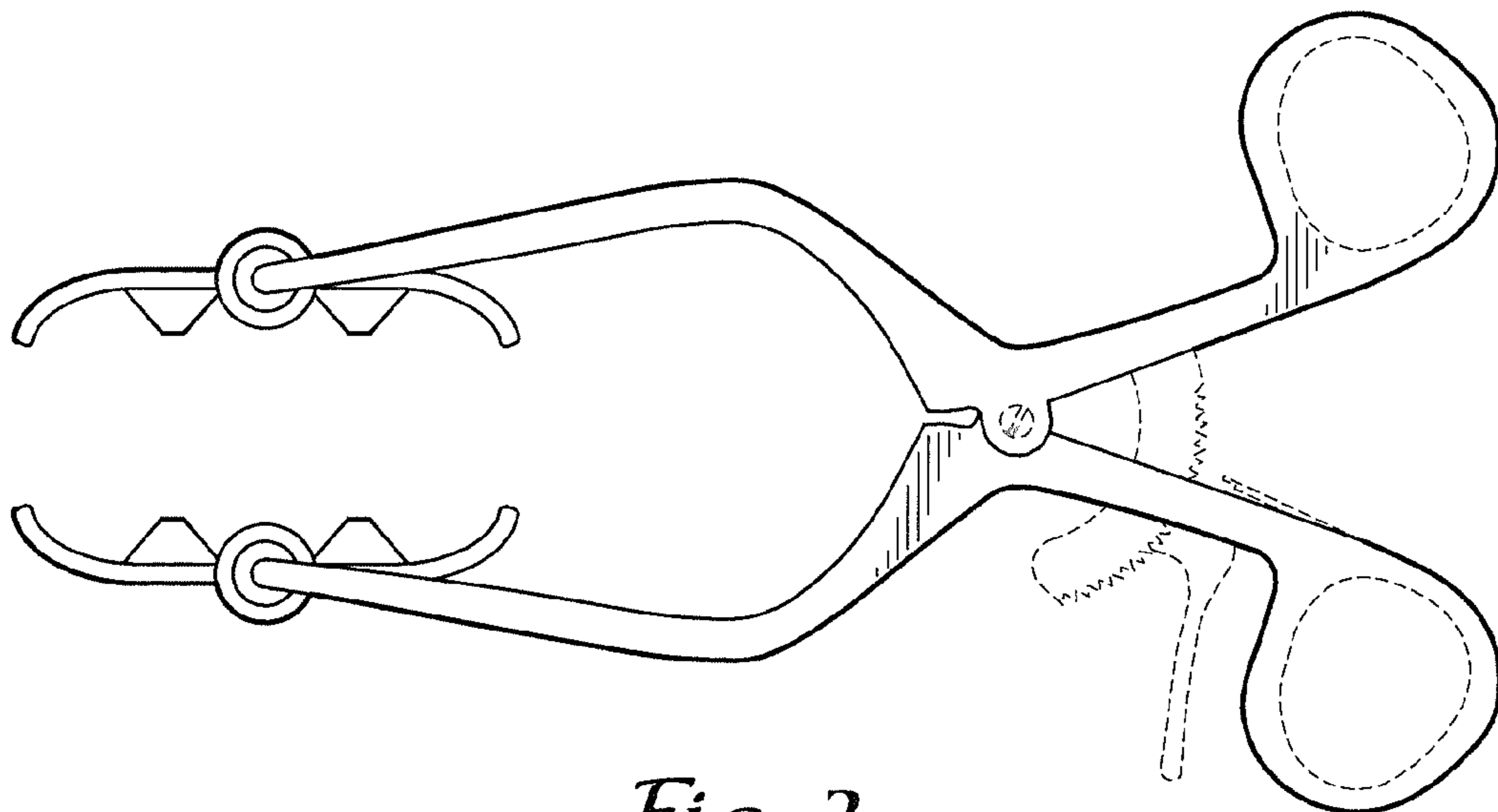

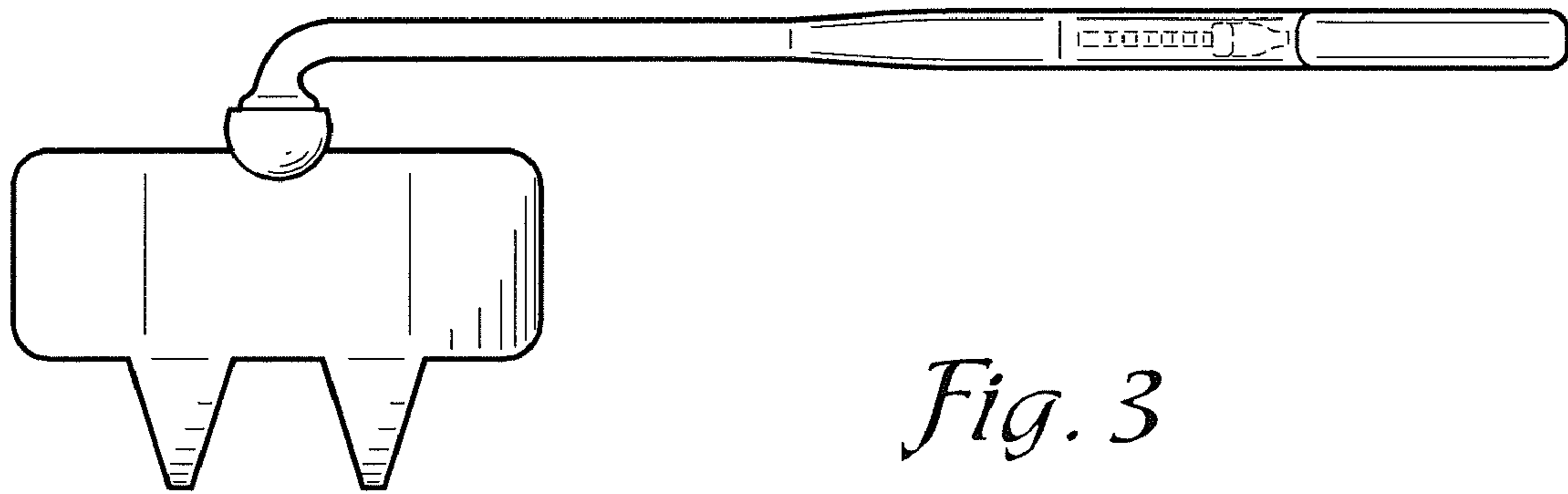

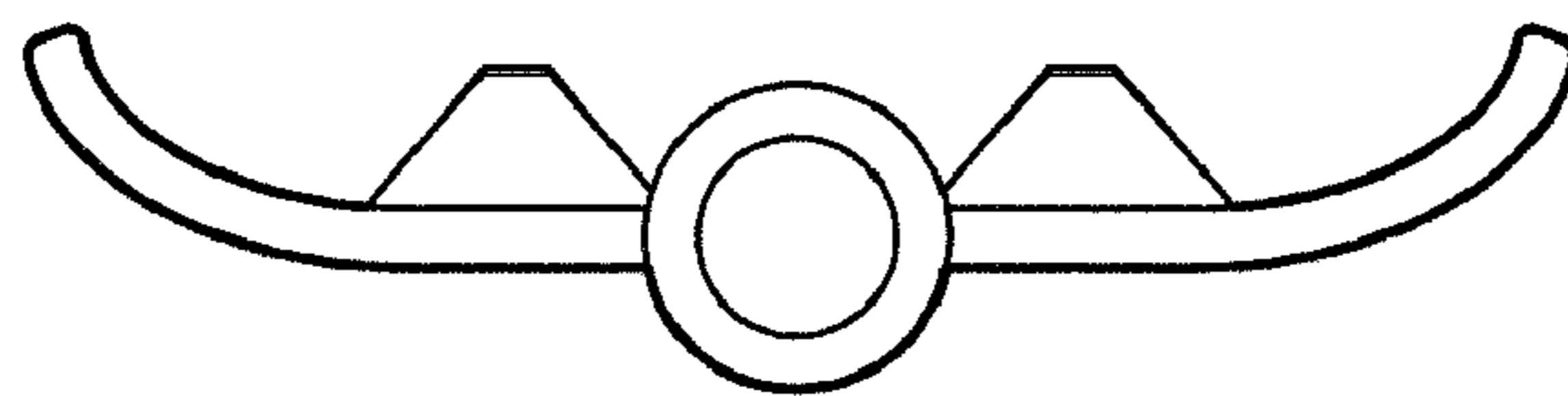

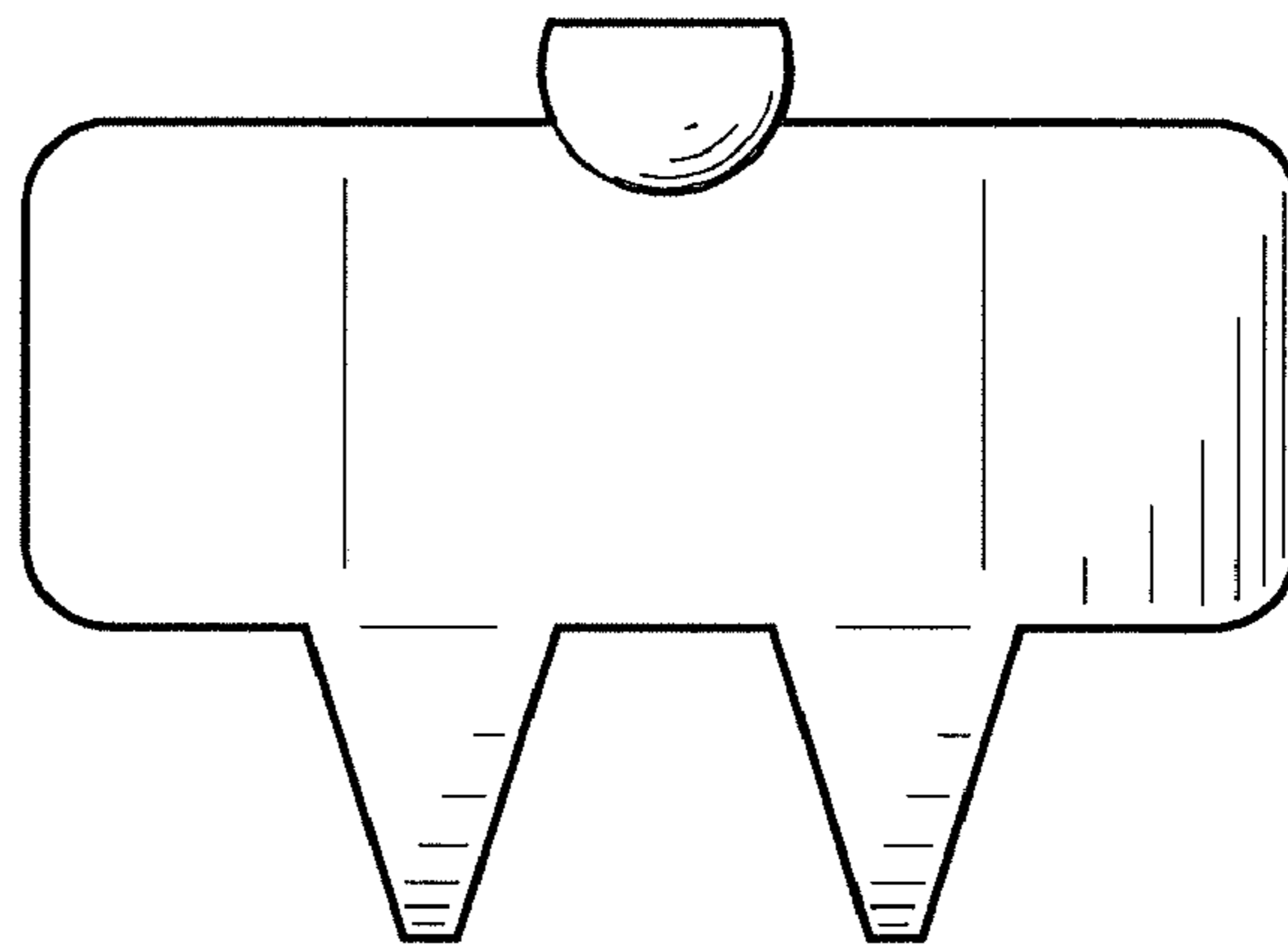
