(57) **CLAIM**

The ornamental design for a tree-like observation blind, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view showing our new design for an observation blind.

FIG. 2 is a right side elevational view thereof;

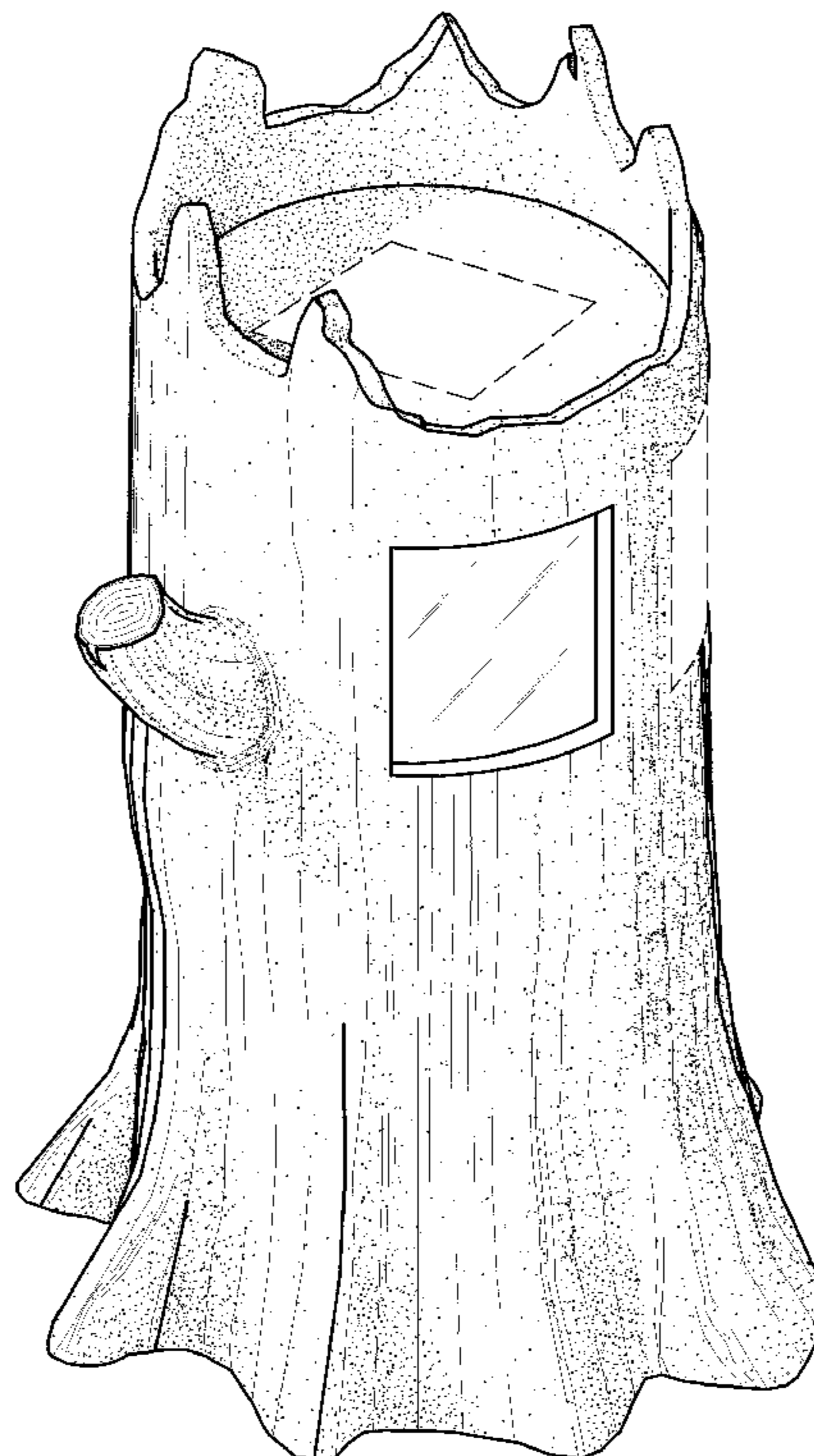
FIG. 3 is a left side elevational view thereof;

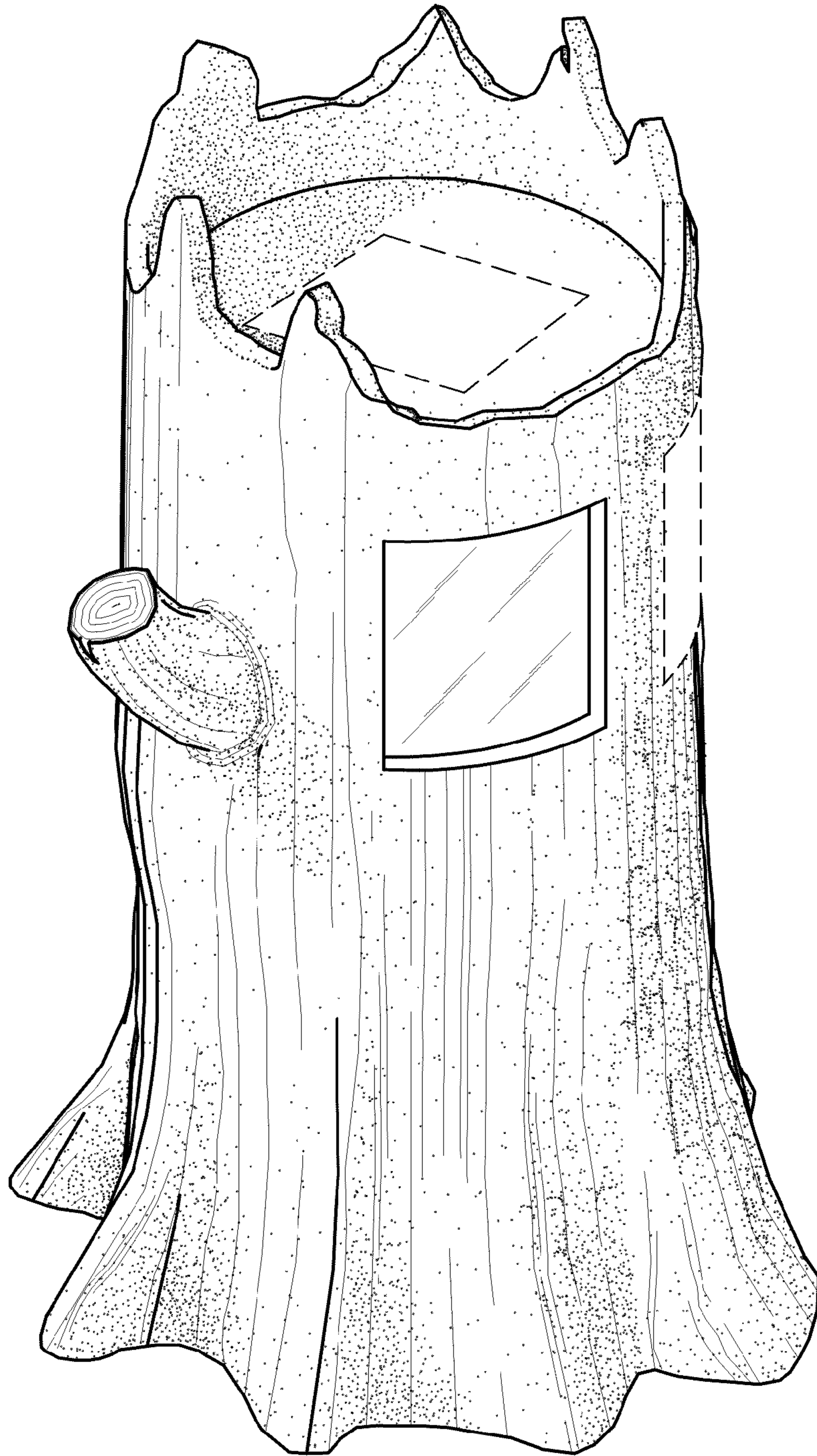

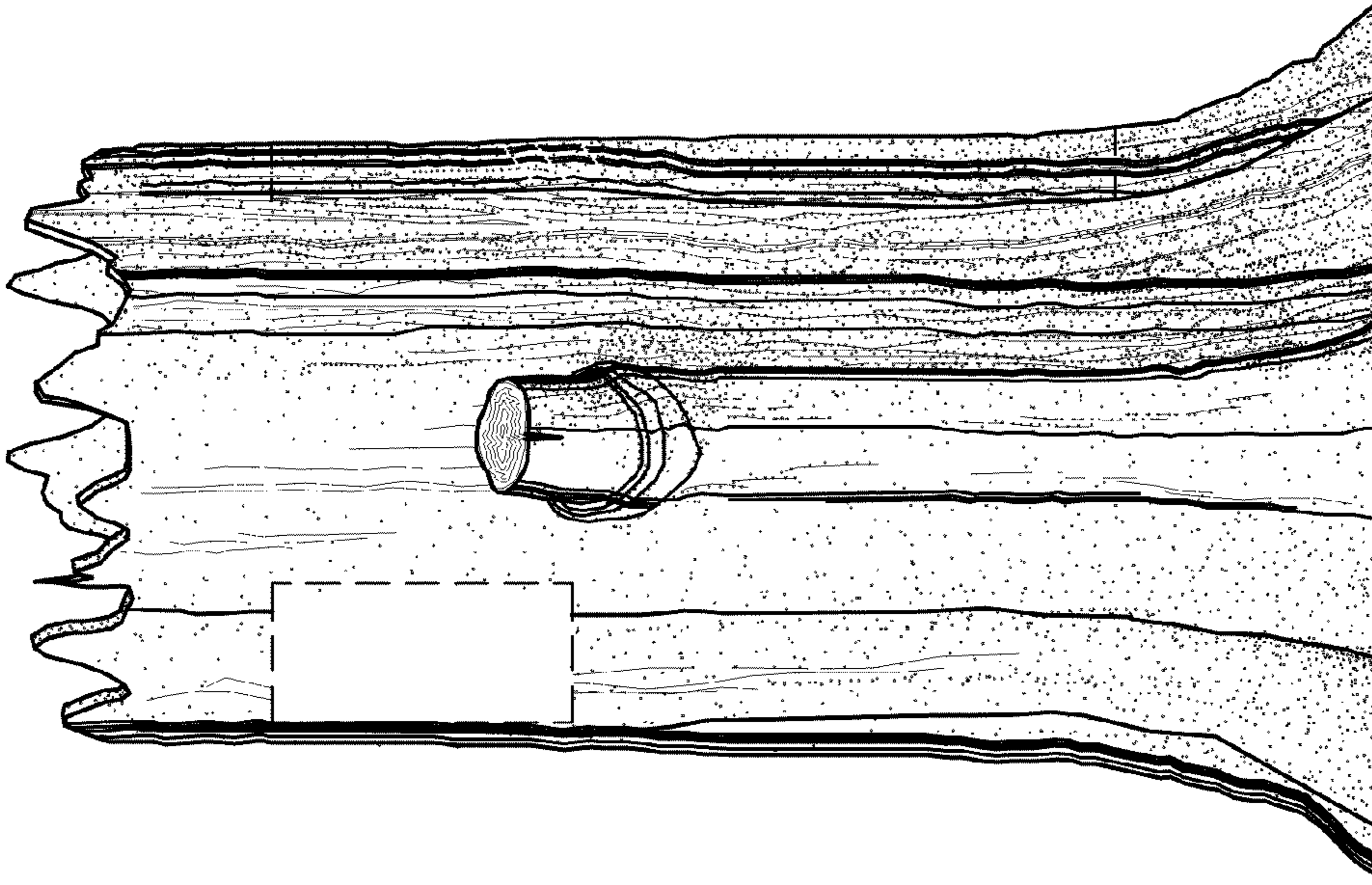

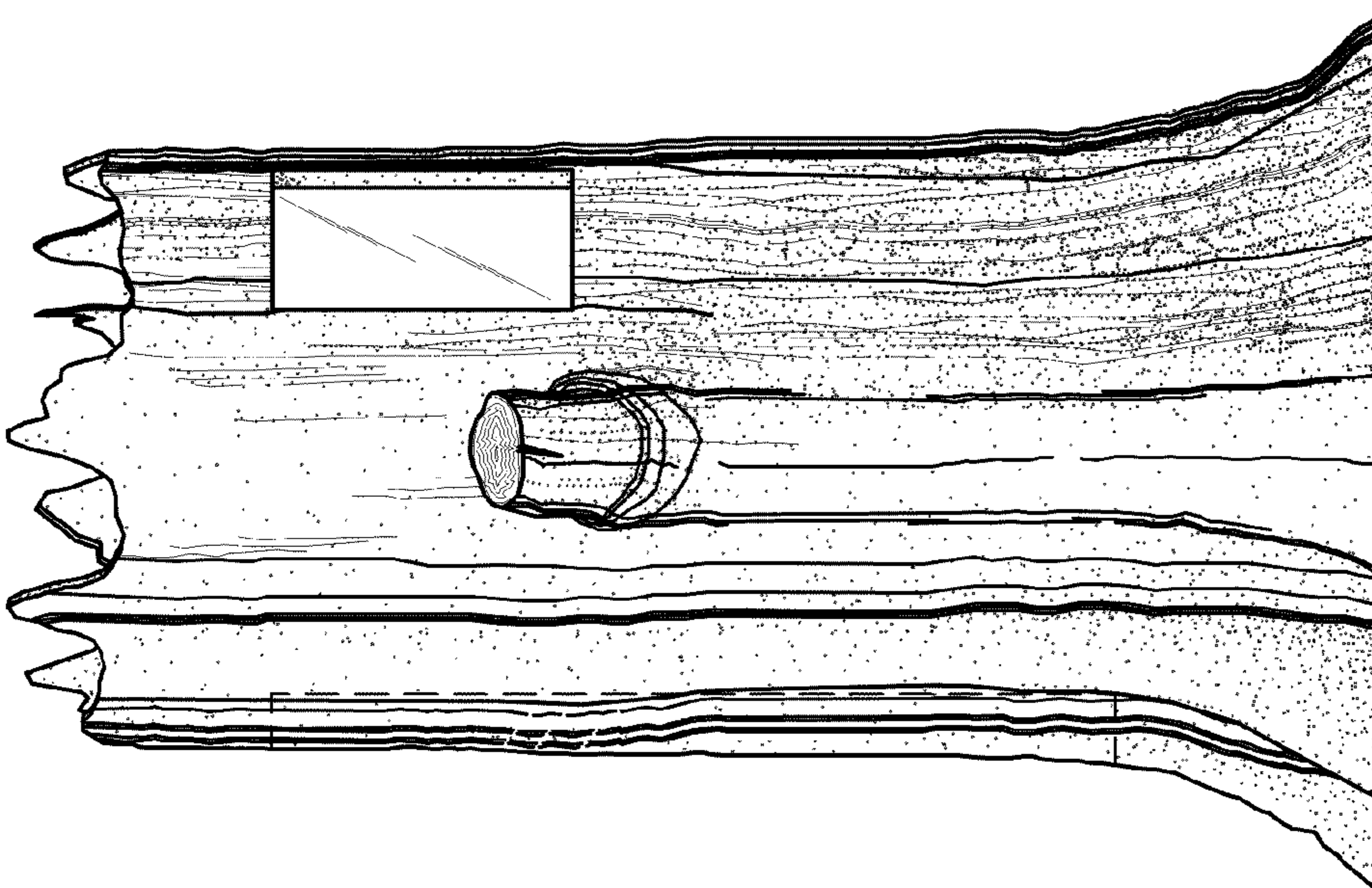

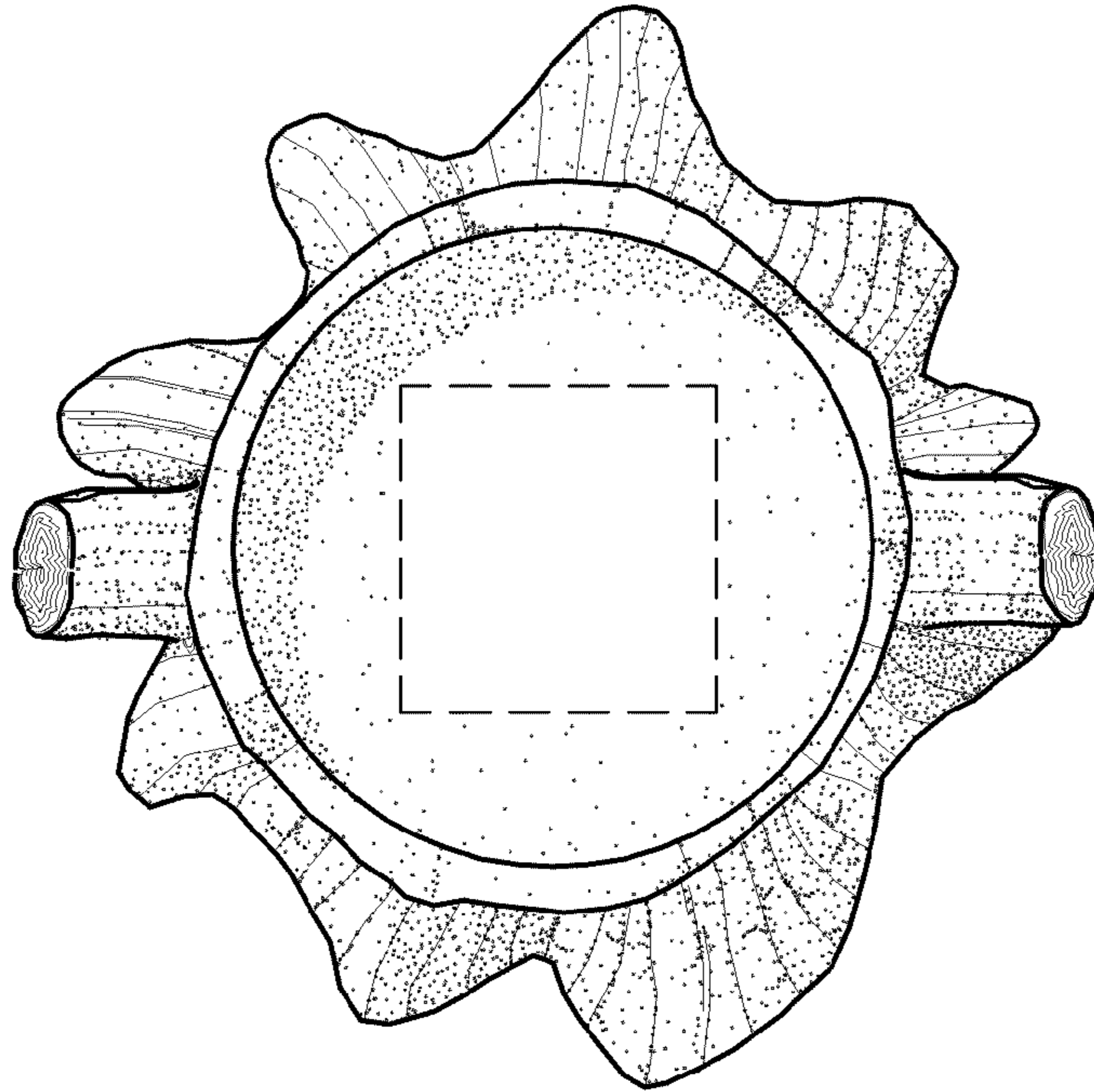

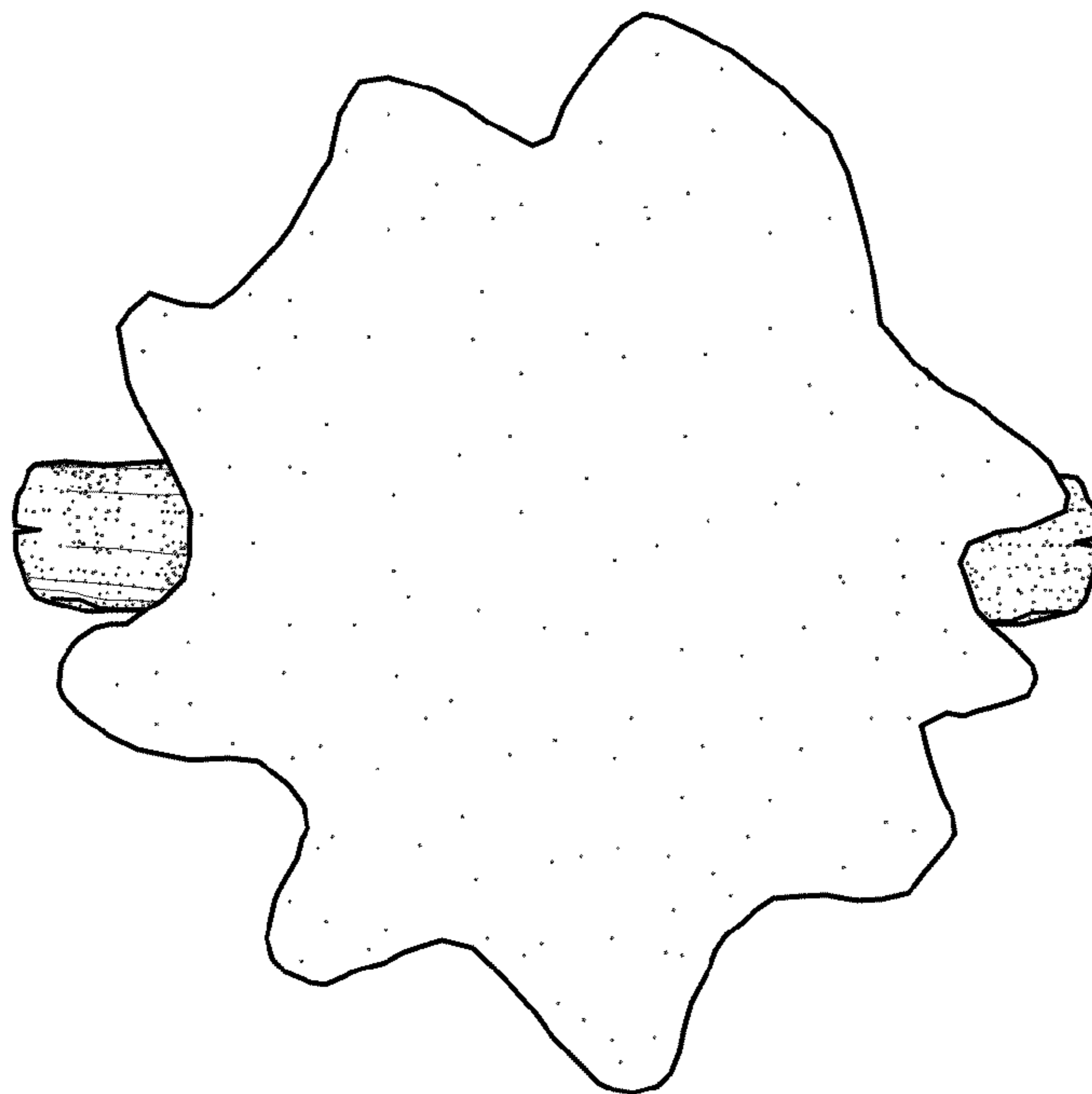
