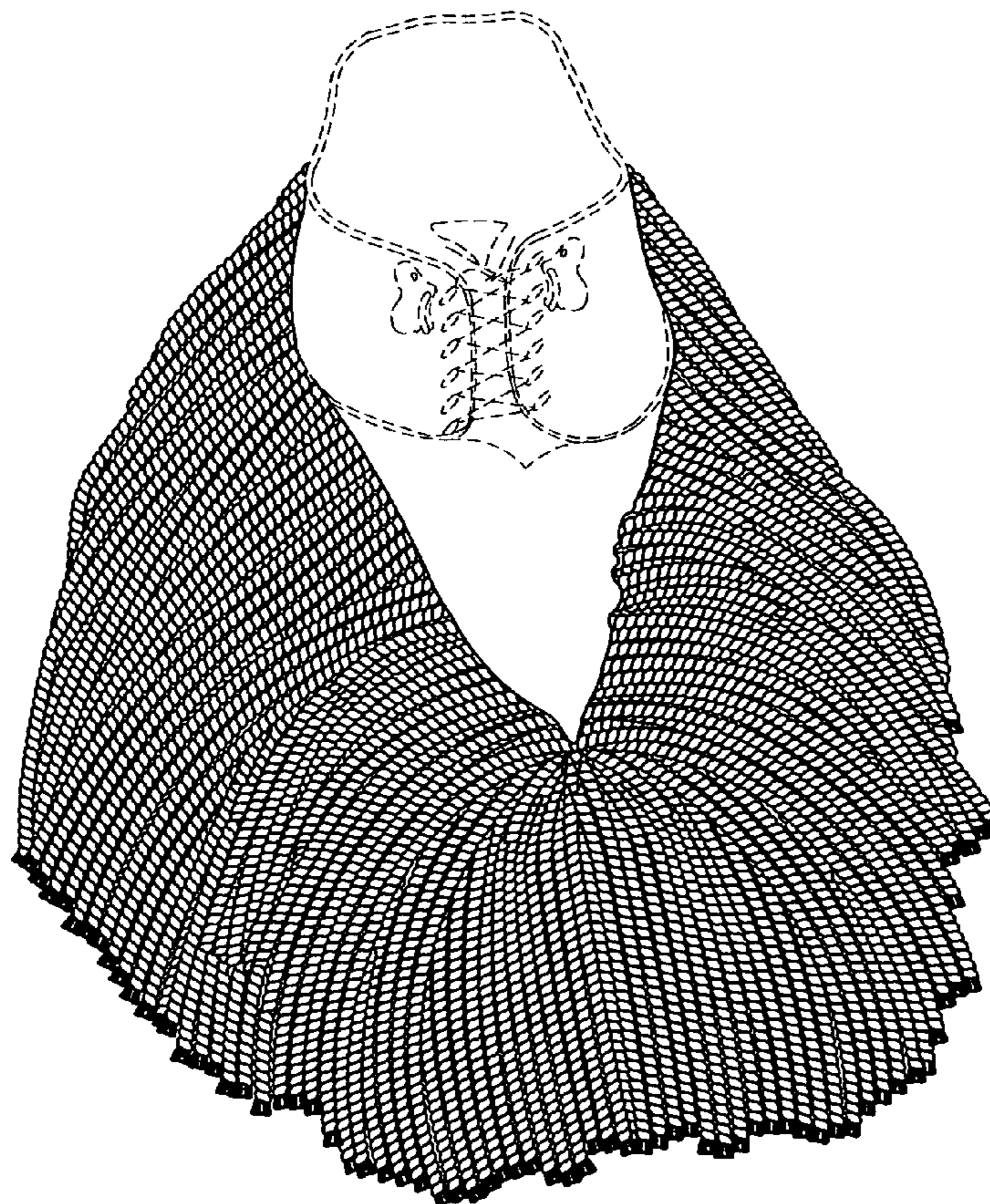

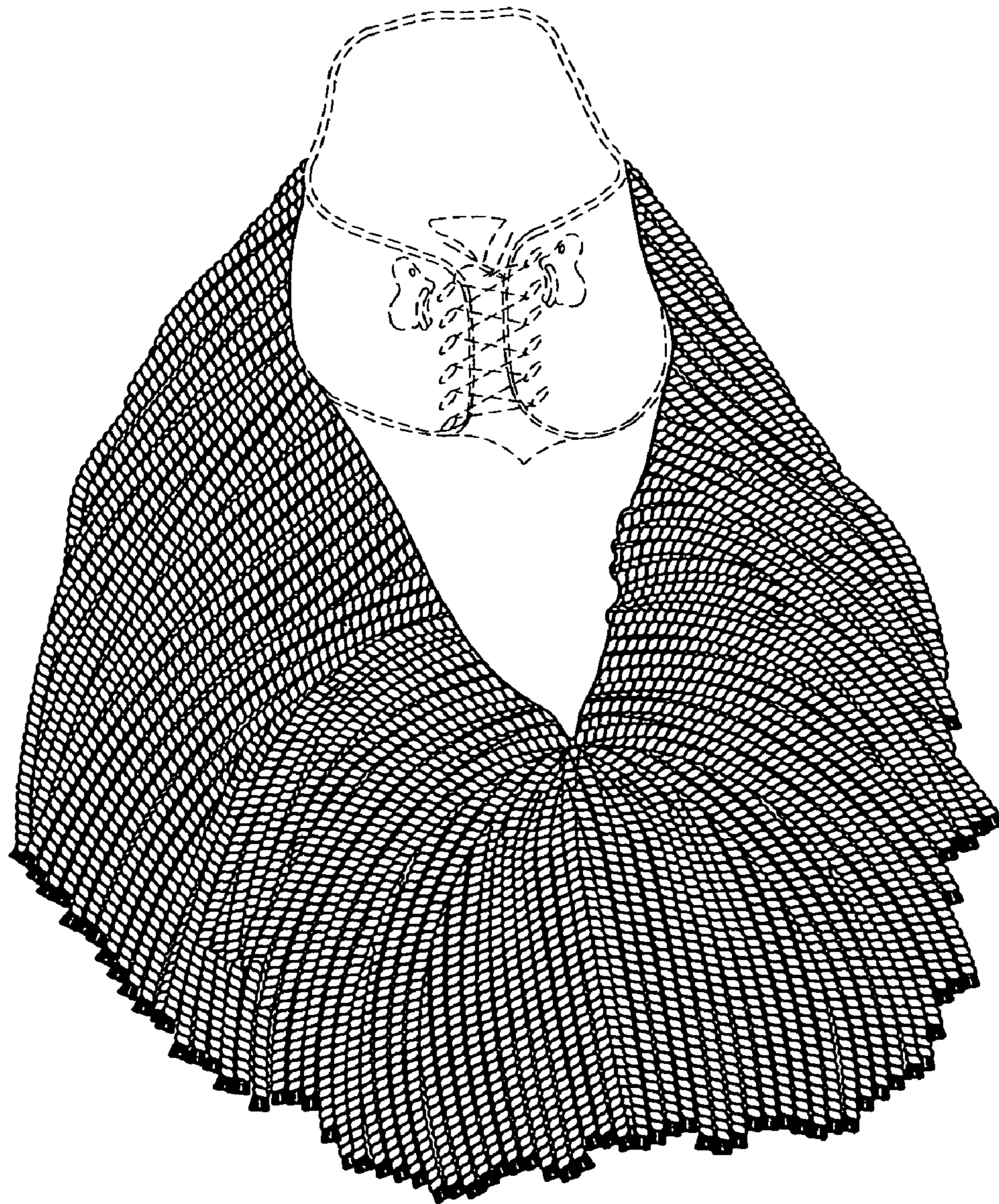

**DESCRIPTION**

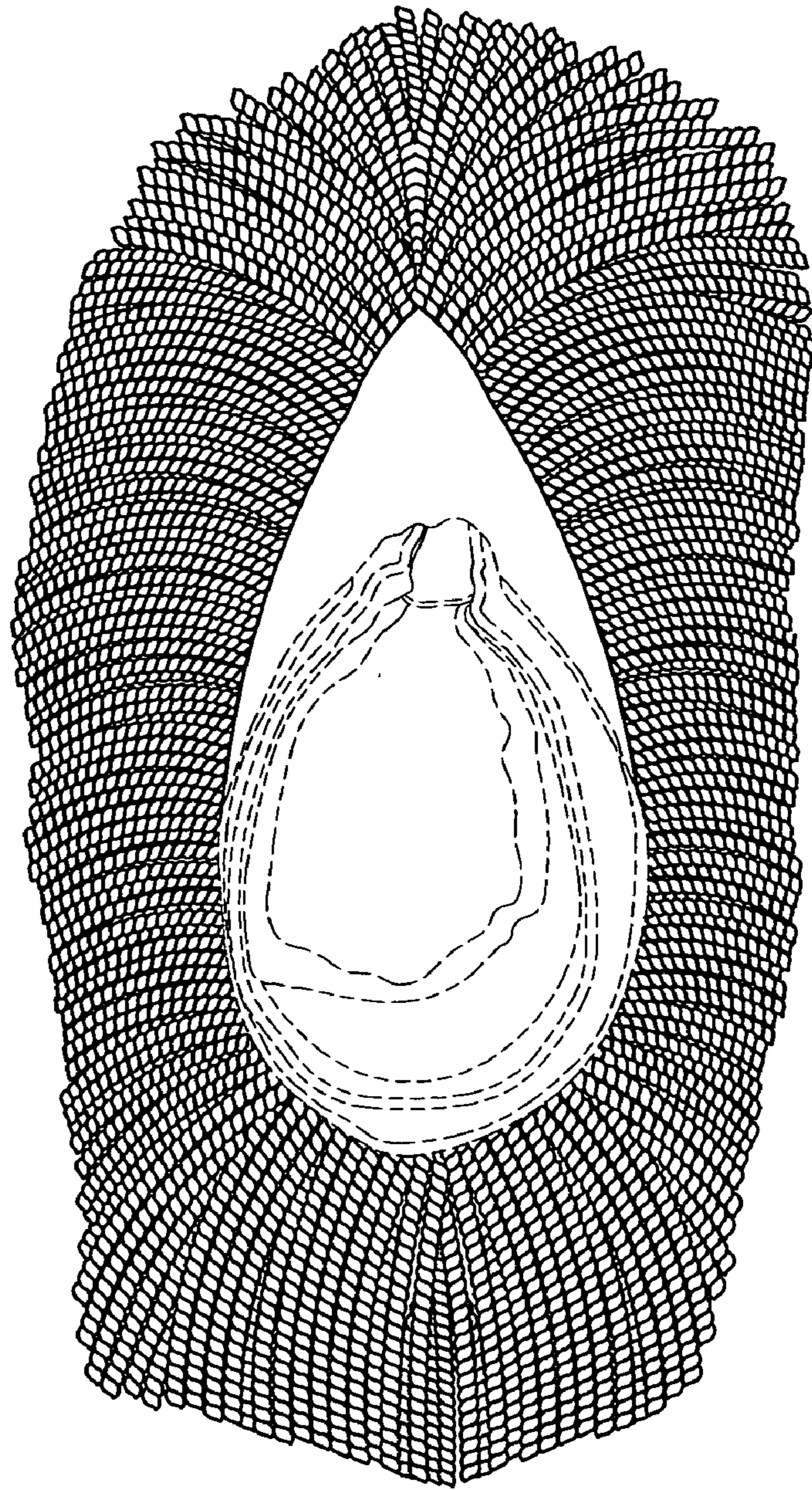
FIG. 1 is a perspective view of a noise dampener for shoes showing my new design;

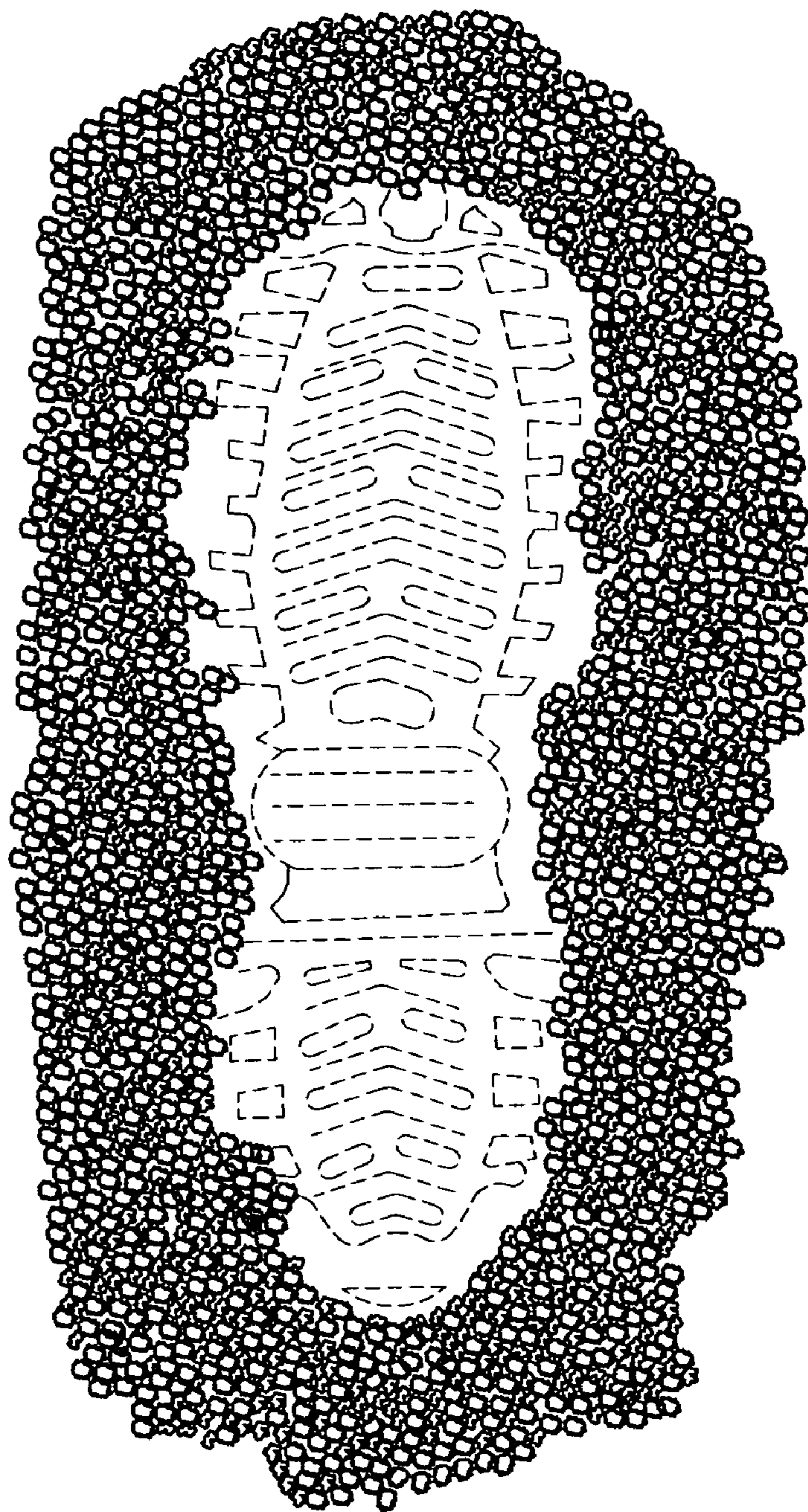




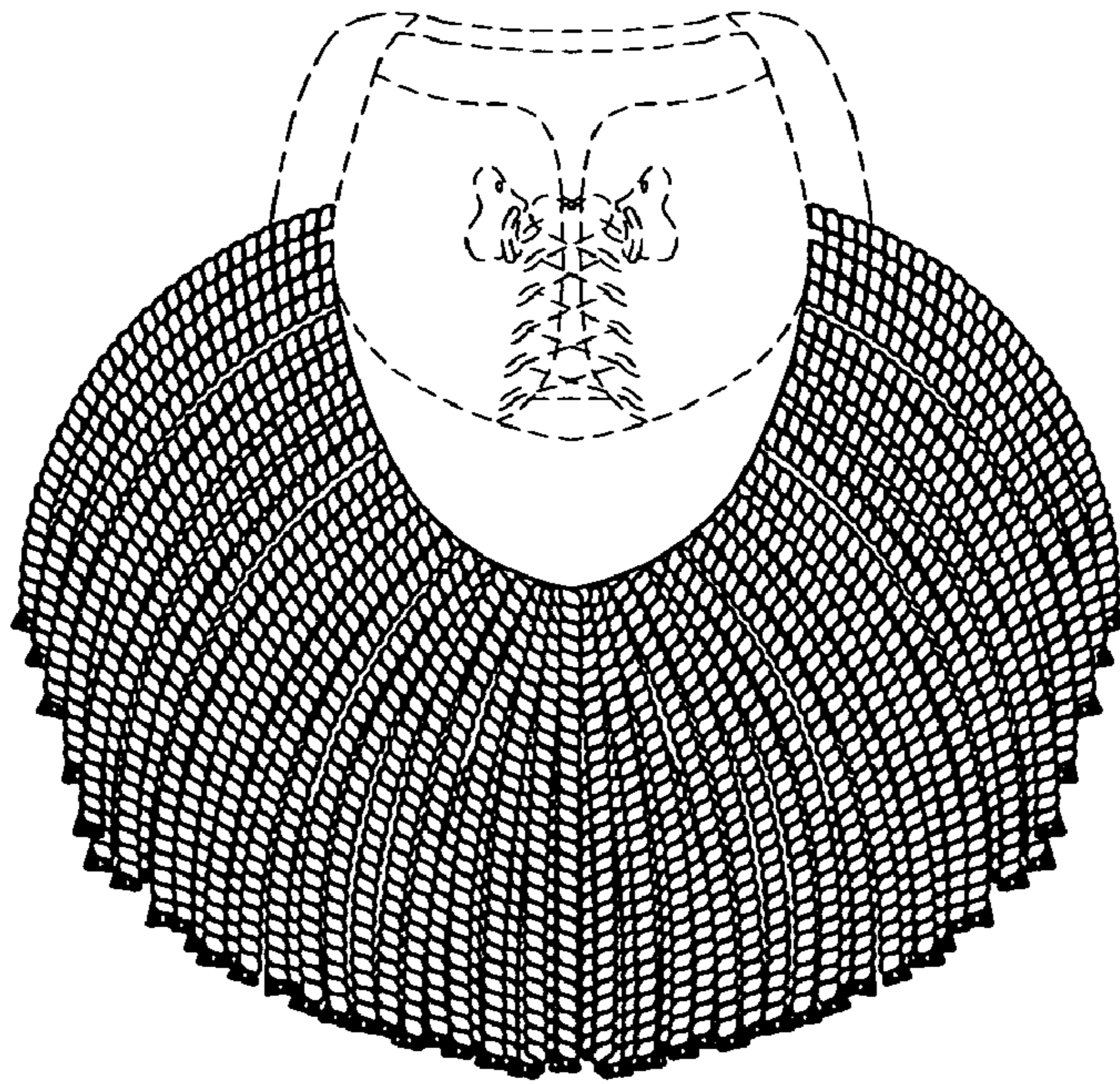

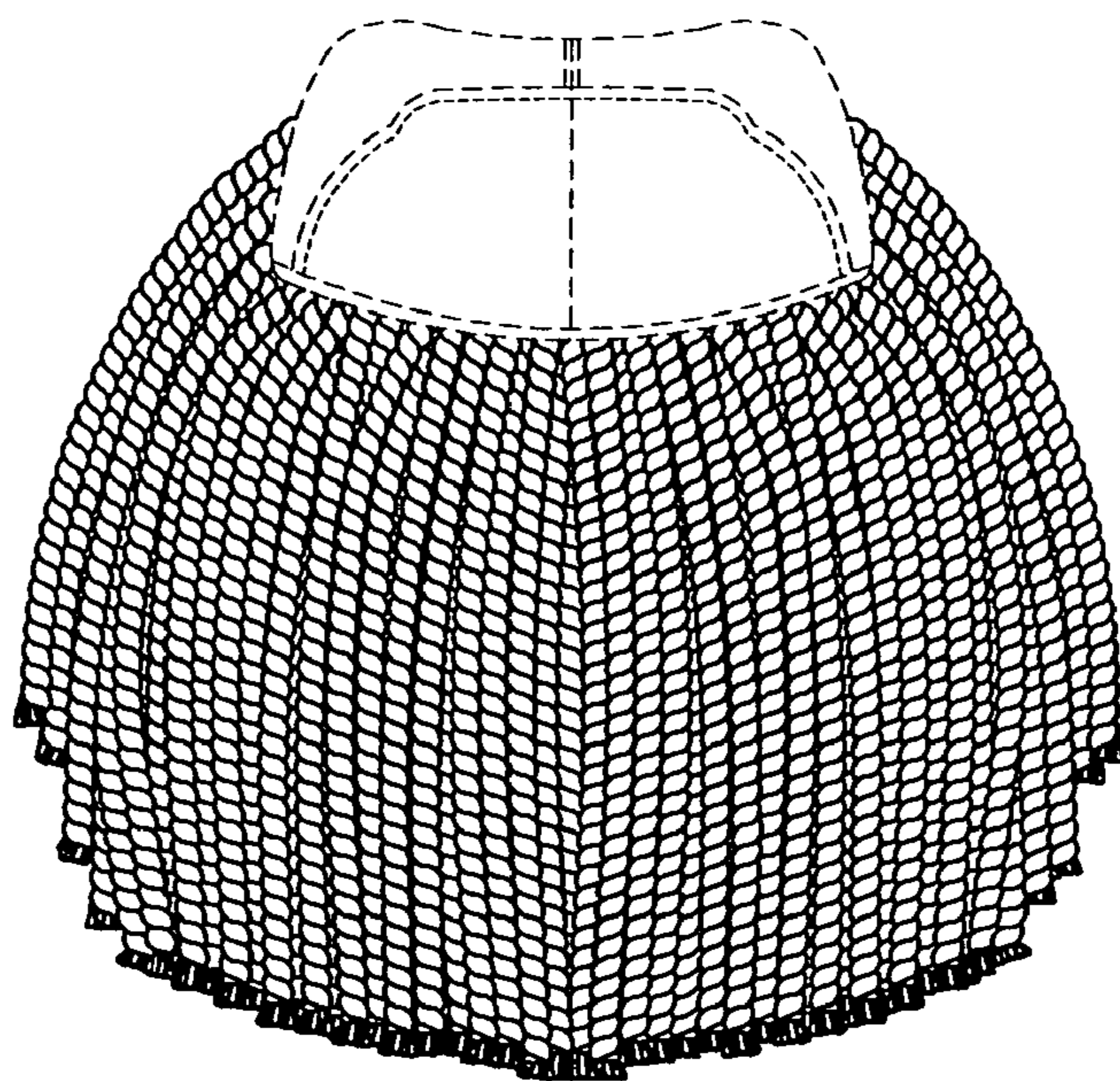

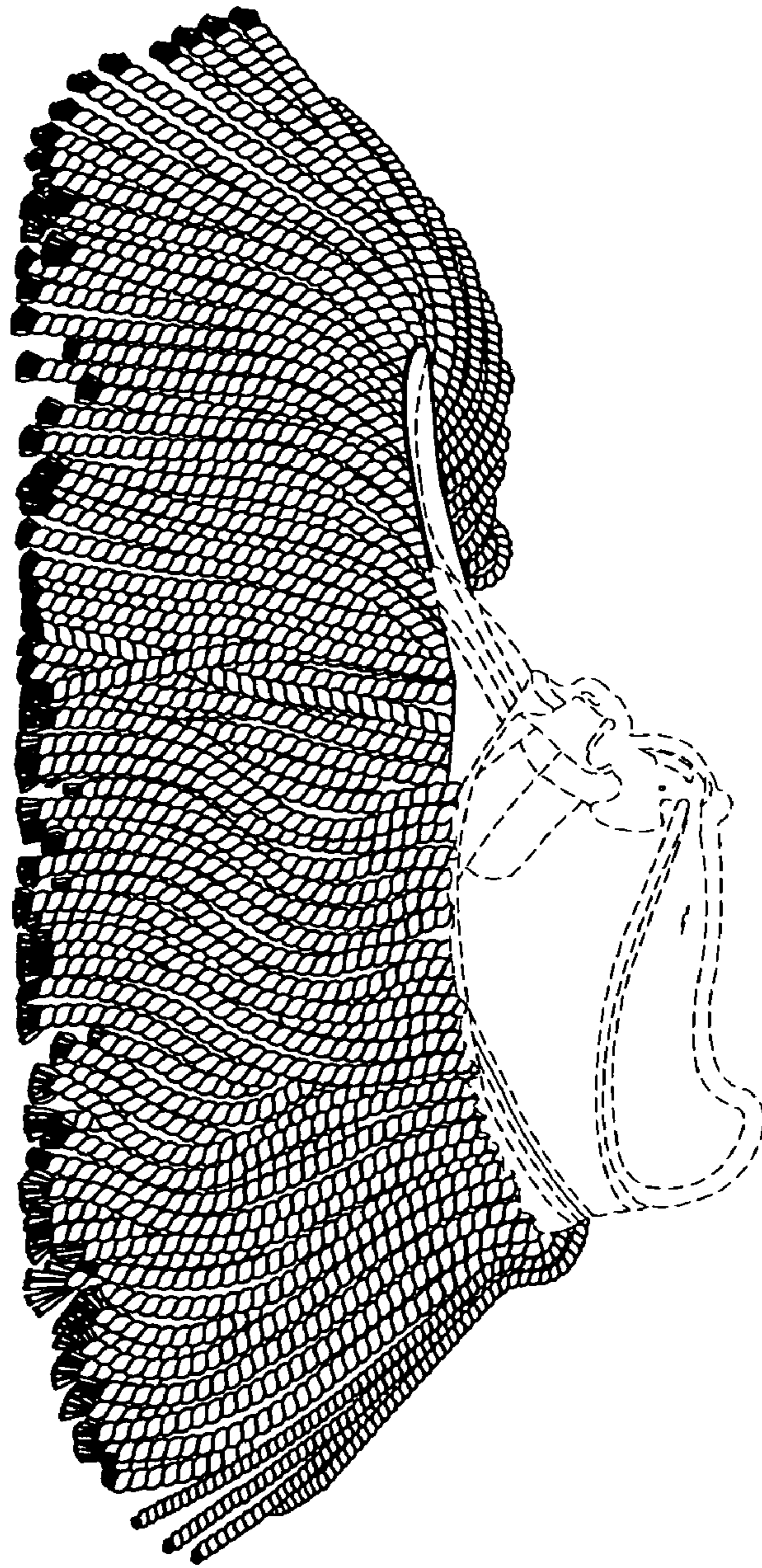

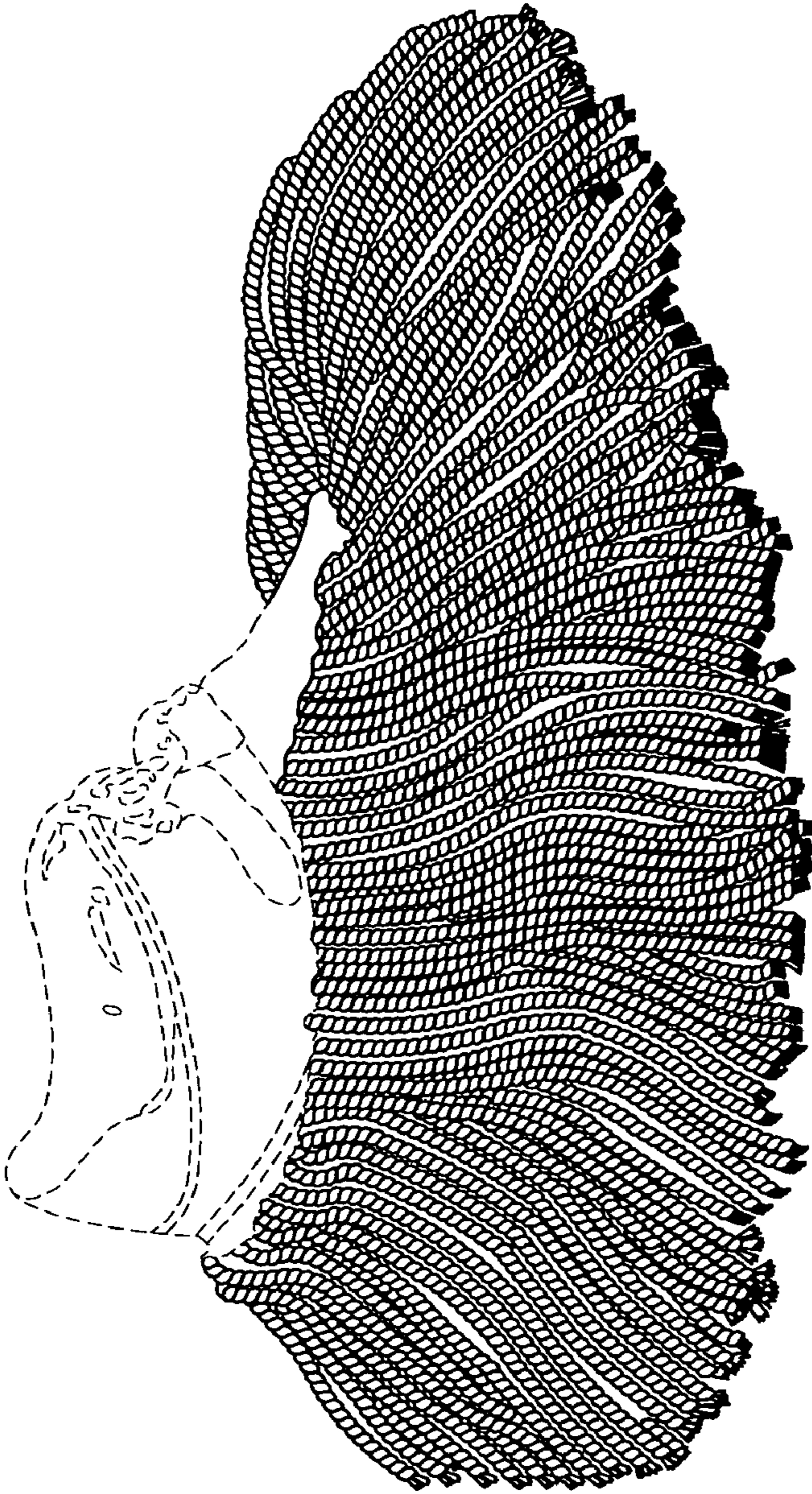
