DESCRIPTION

FIG. 1 is a rear perspective view of a footwear upper showing my new design;

FIG. 4 is a front elevational view thereof;

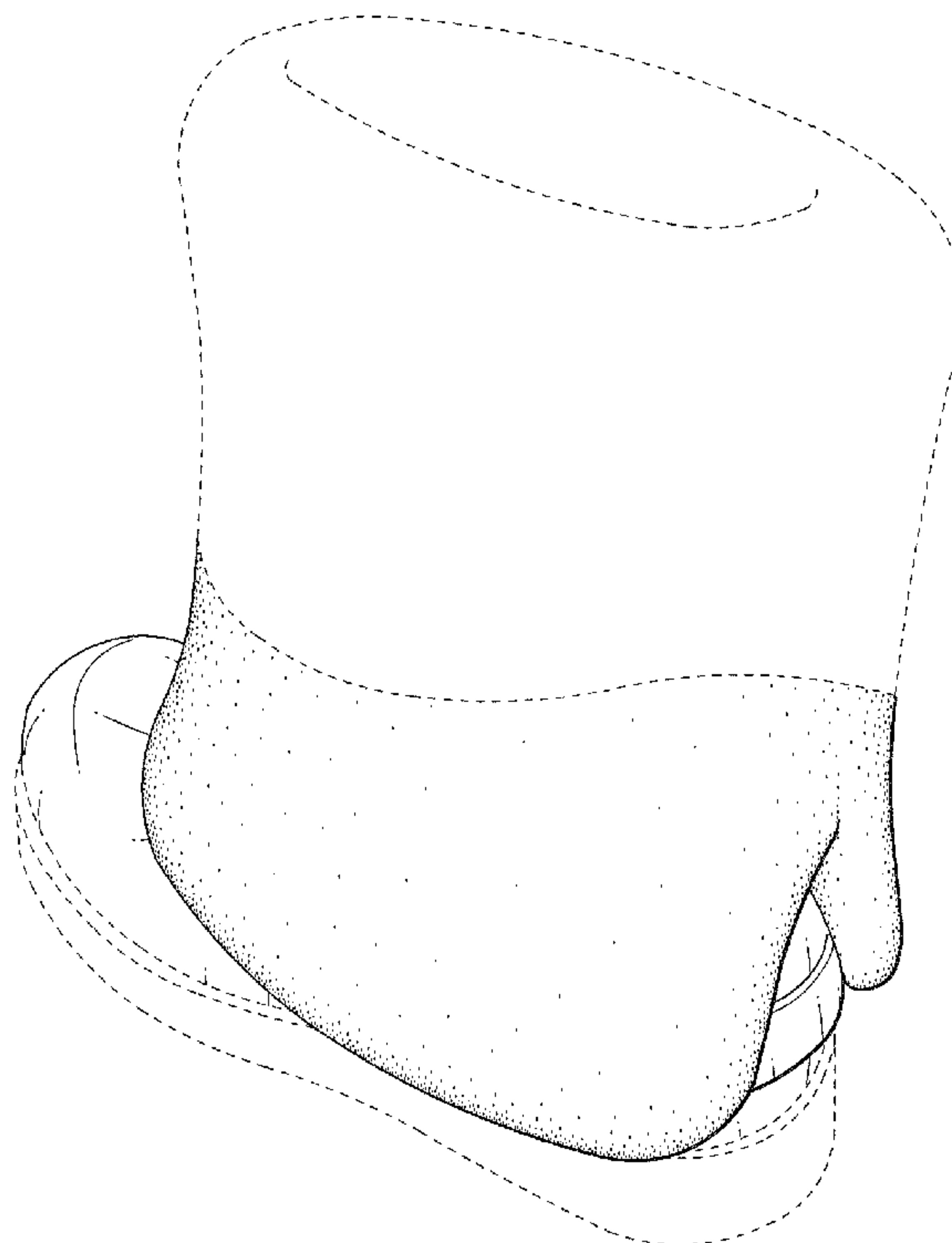
FIG. 5 is a rear elevational view thereof; and

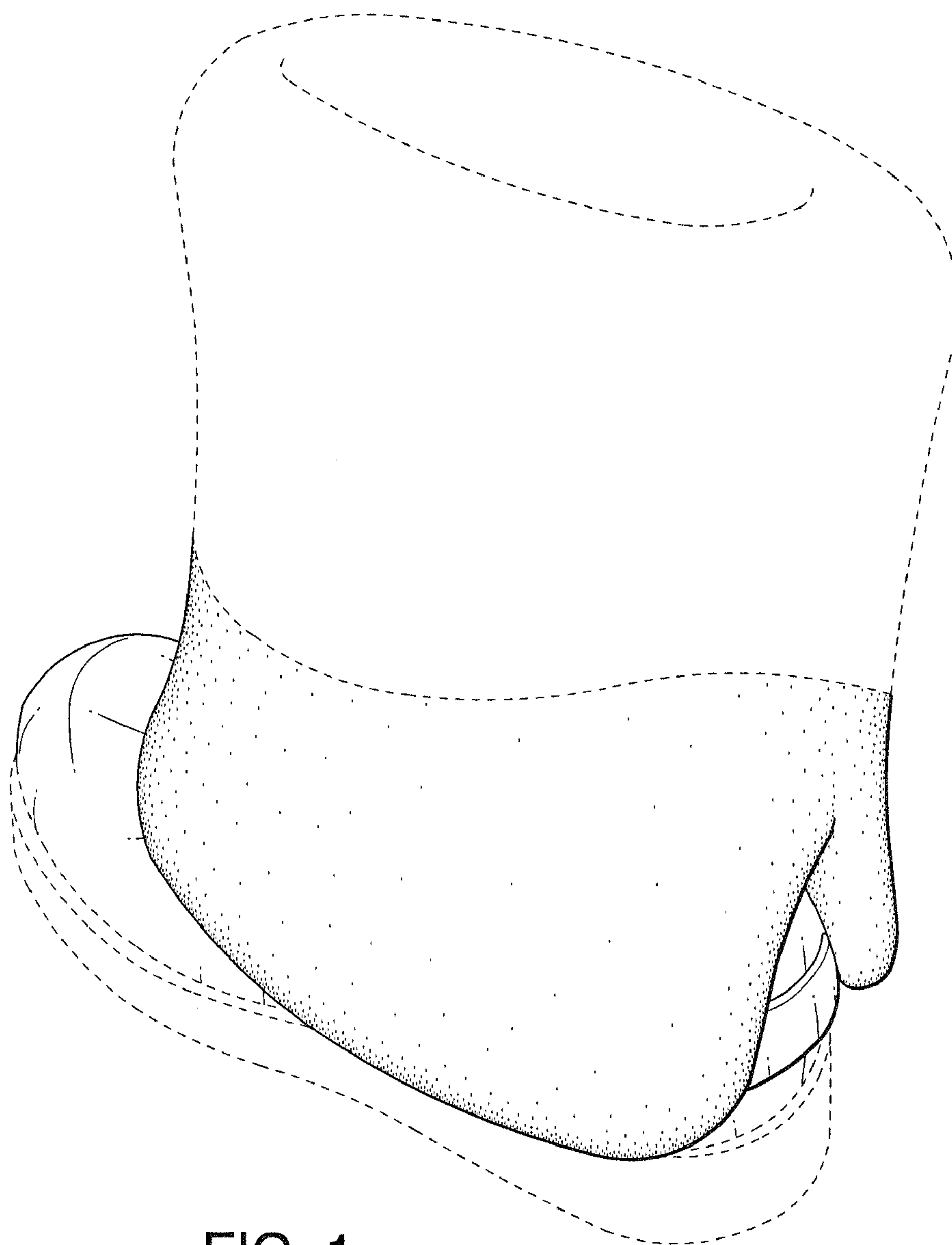

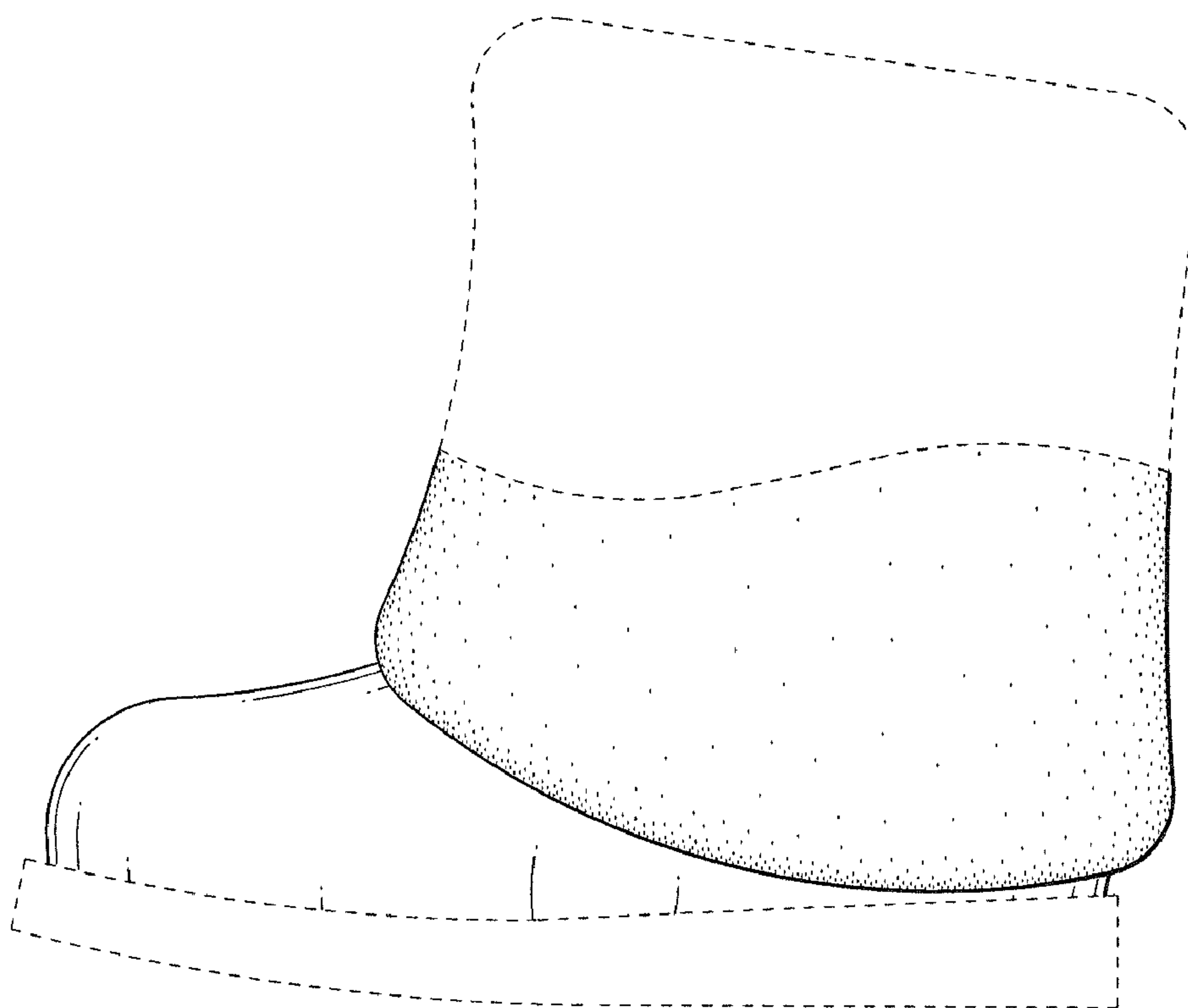

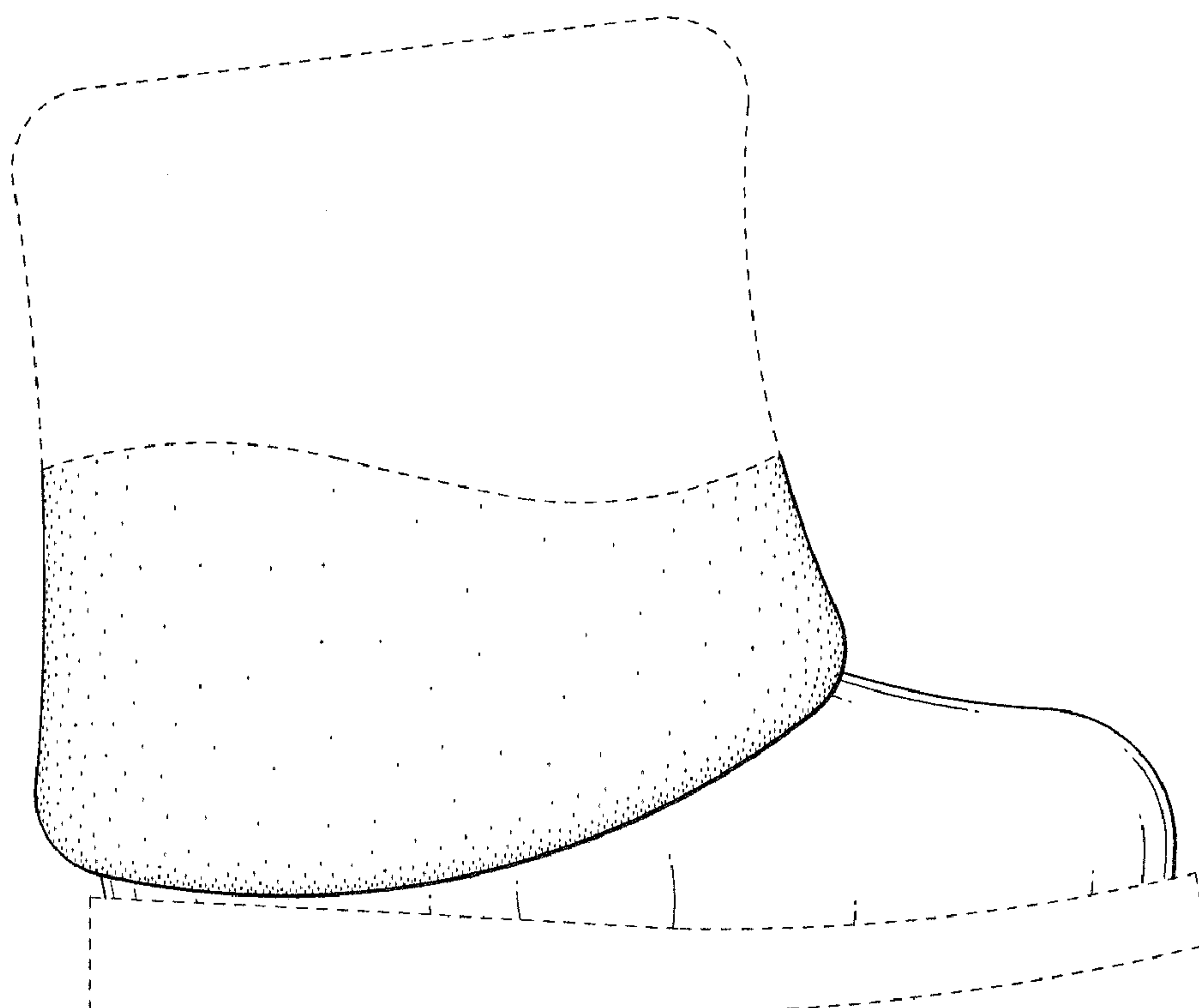

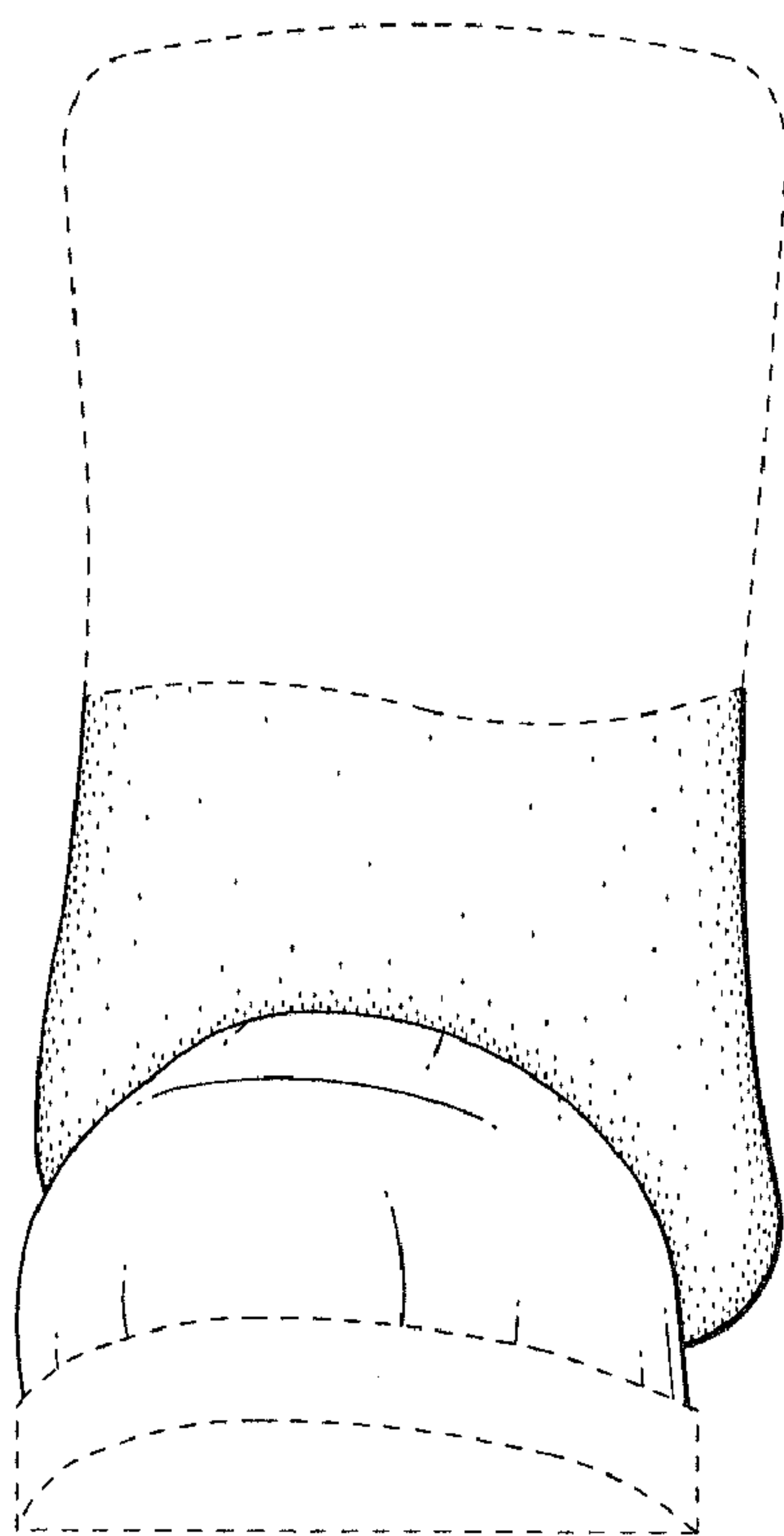

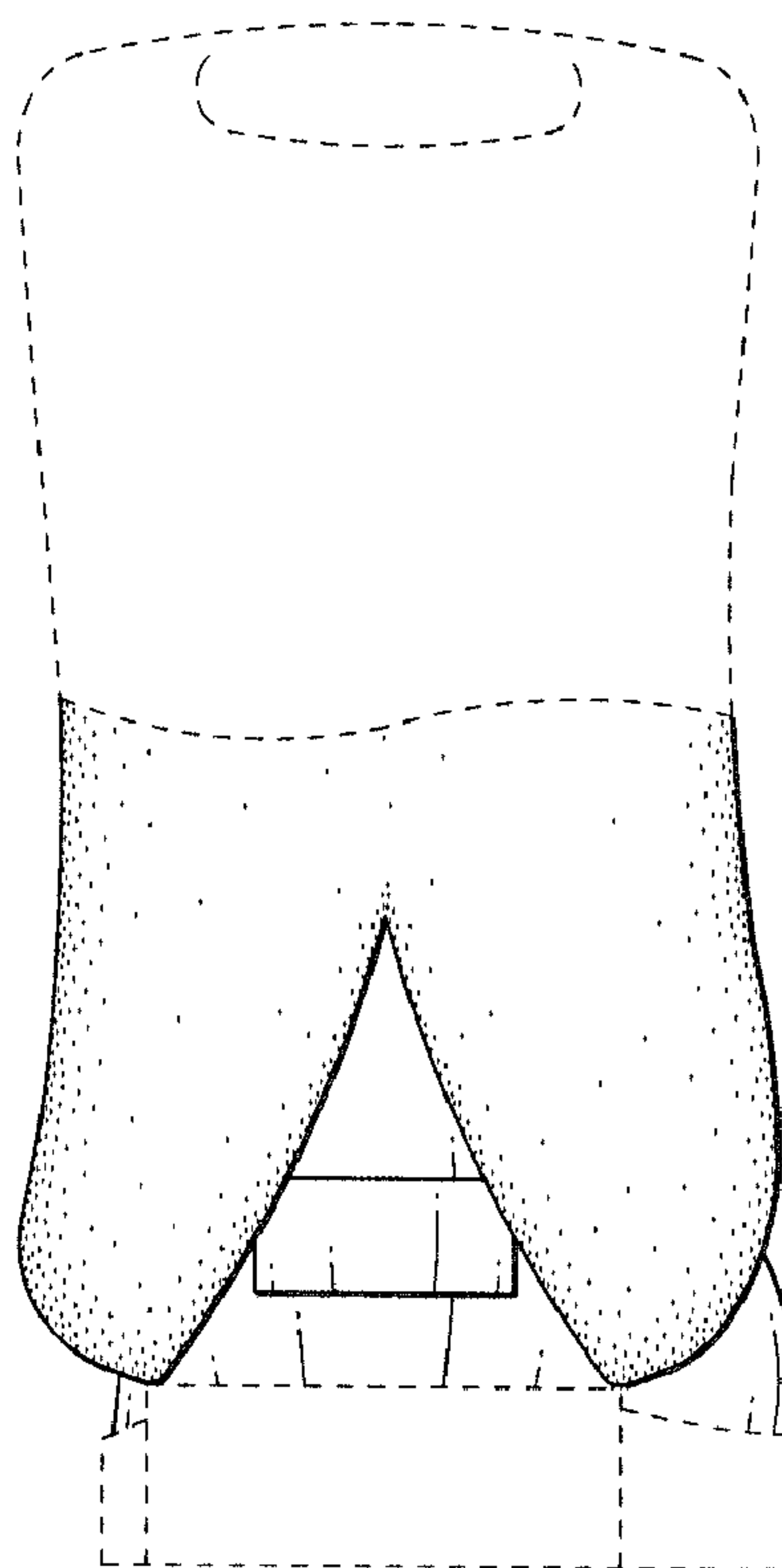

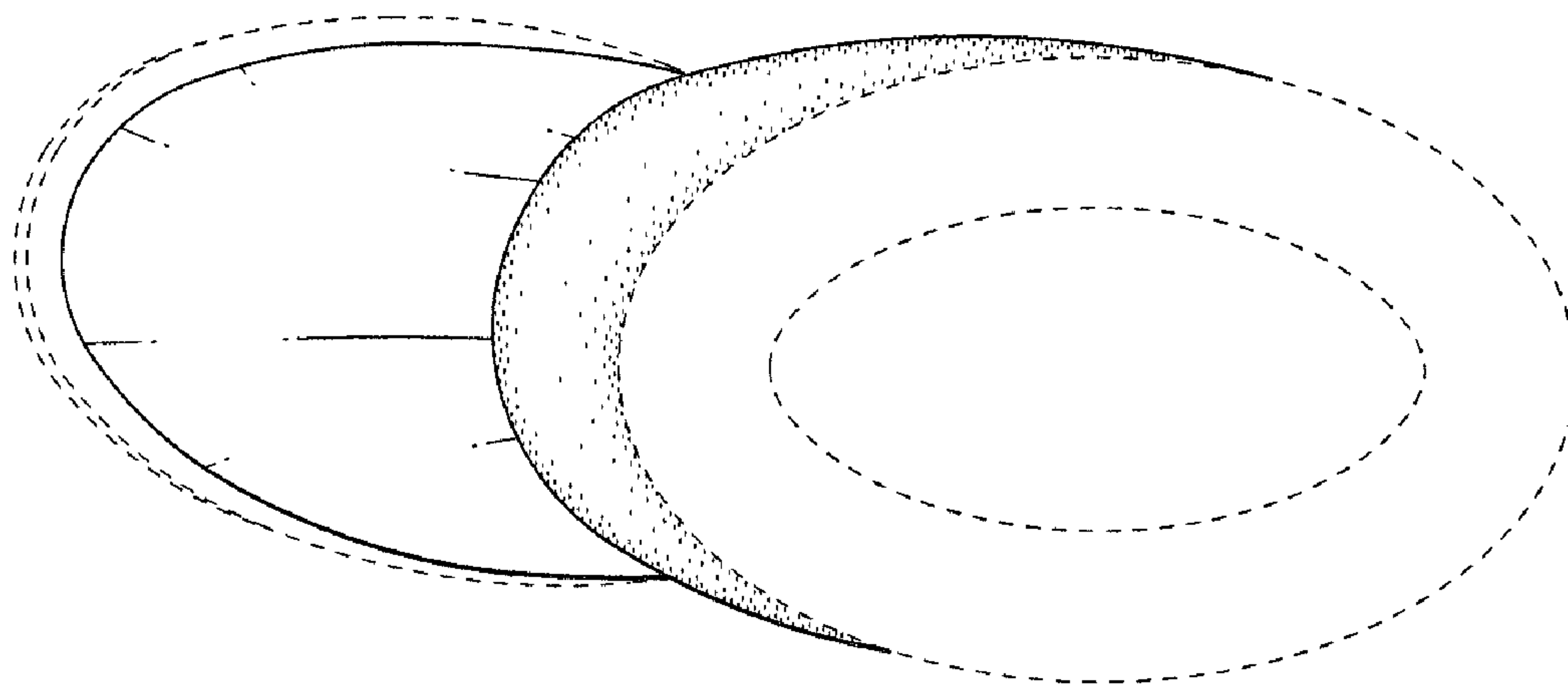

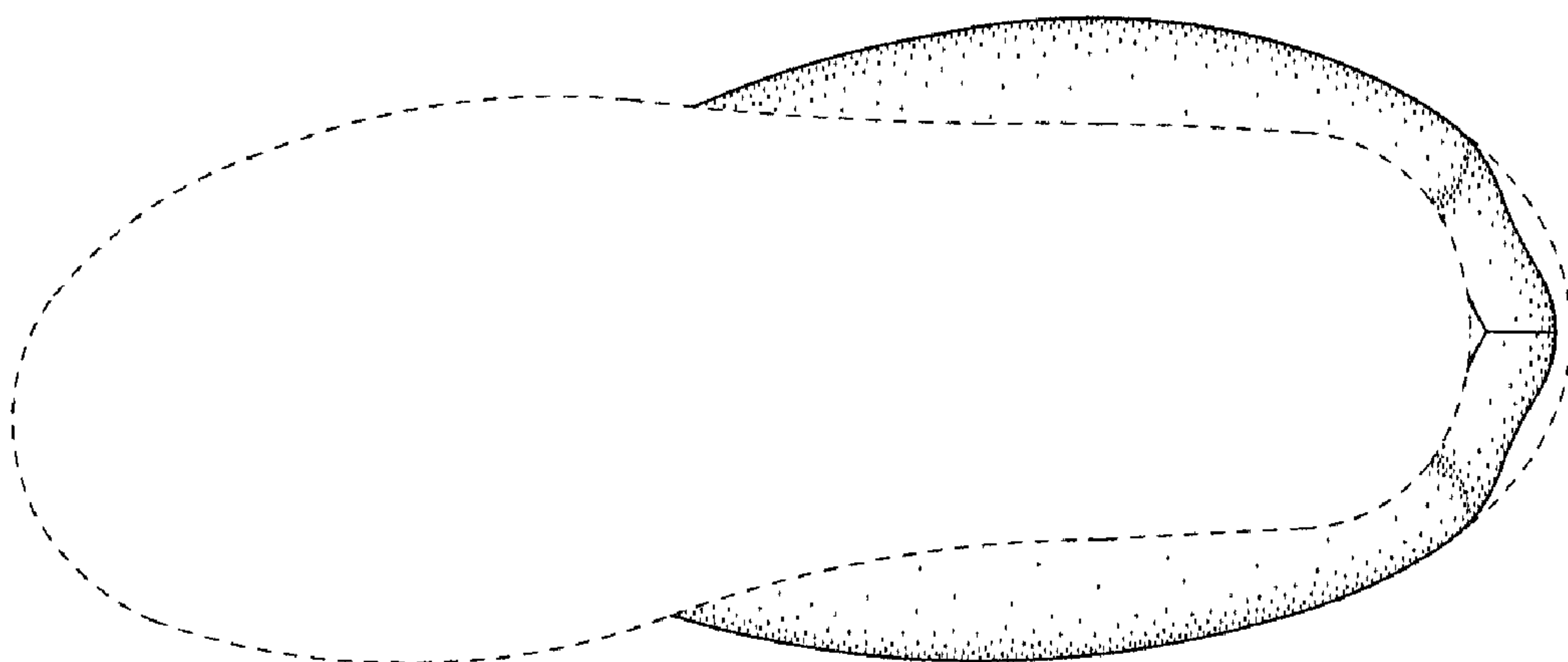
