DESCRIPTION

FIG. 1 is a top elevational view of the key ring tool of the present design;

FIG. 2 is an elevational plan view of the key ring tool of the present design as seen from the bottom of FIG. 1;

FIG. 3 is an elevational view of the key ring tool of the present design as seen from the bottom of FIG. 2;

FIG. 4 is a side elevational view of the key ring tool of the present design as seen from left side of FIG. 2;

FIG. 5 is a side elevational view of the key ring tool of the present design as seen from the right side of FIG. 2; and,

FIG. 6 is an elevational plan view of the key ring tool of the present design as seen from the right side of FIG. 5.

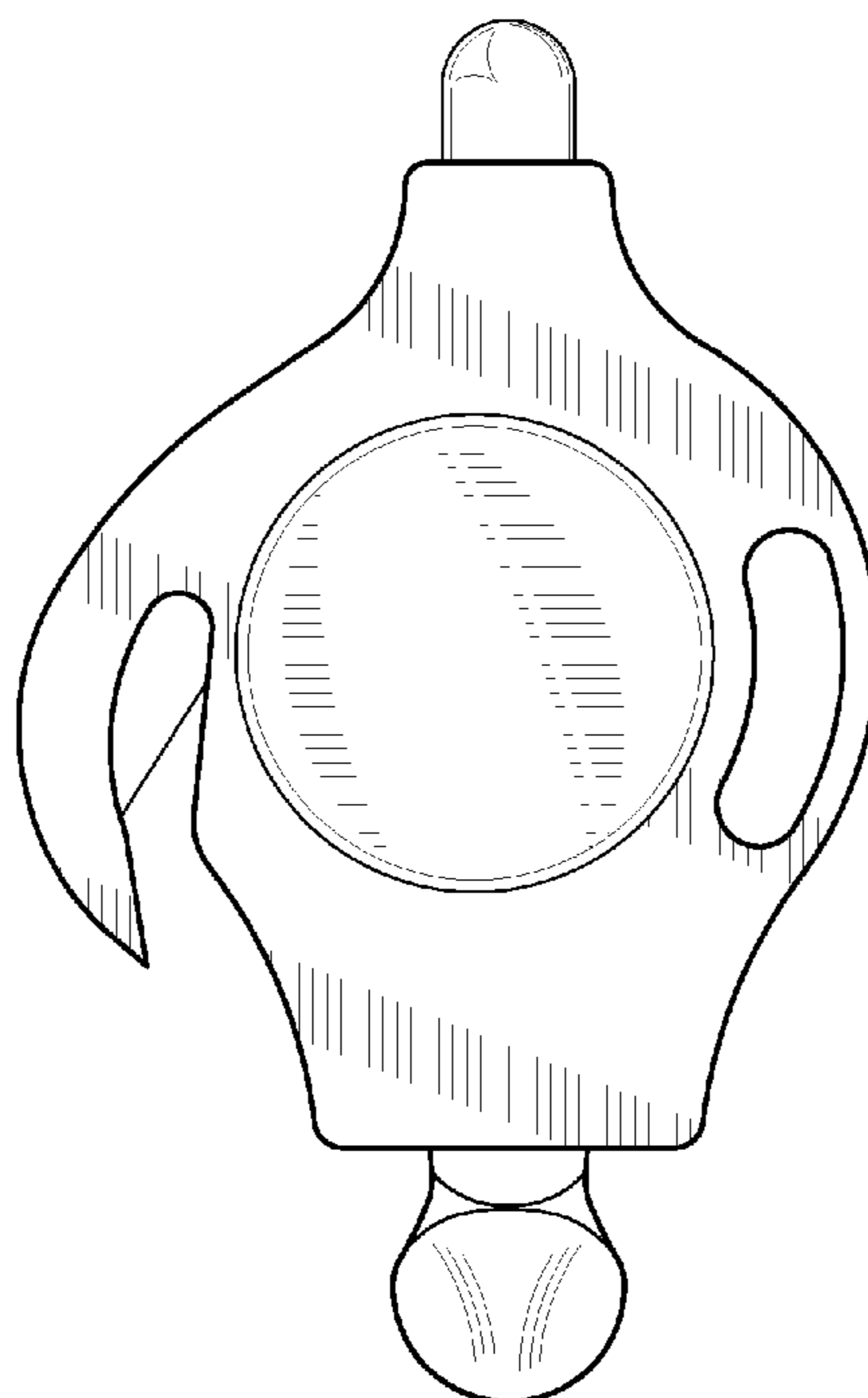

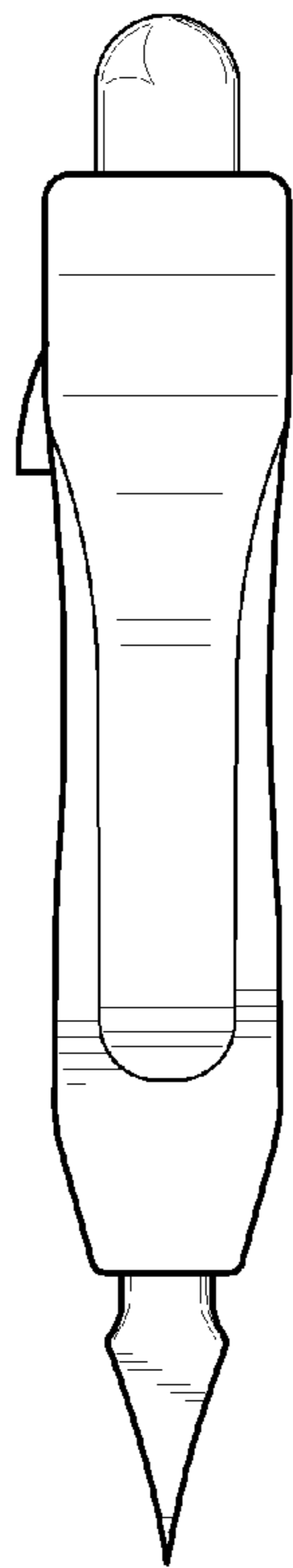
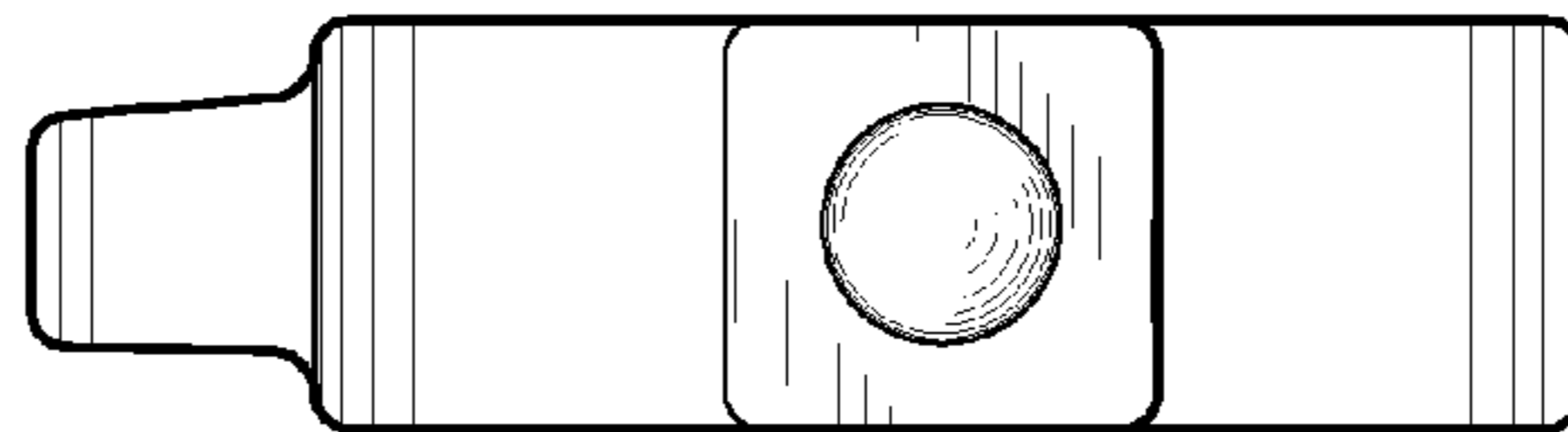

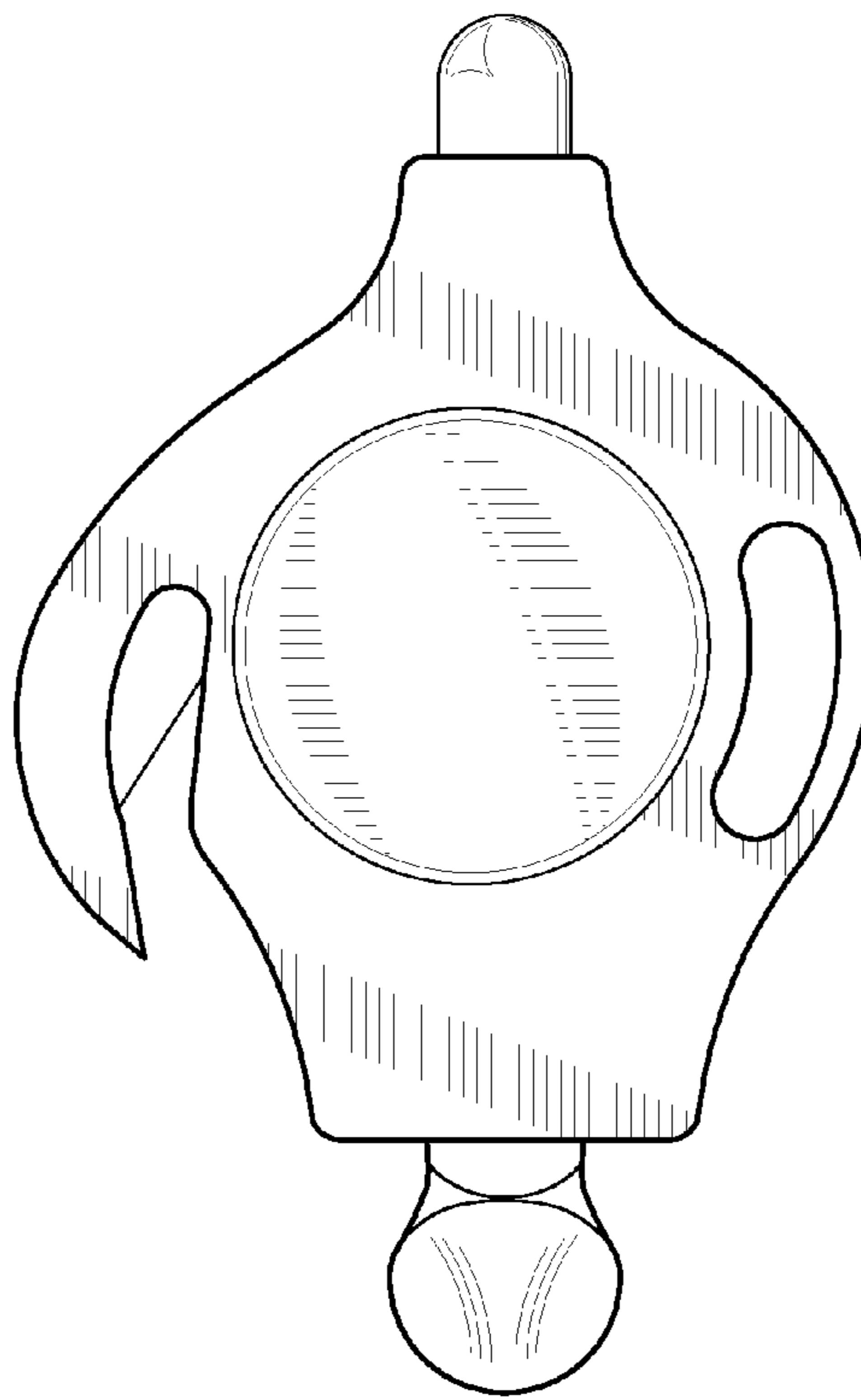

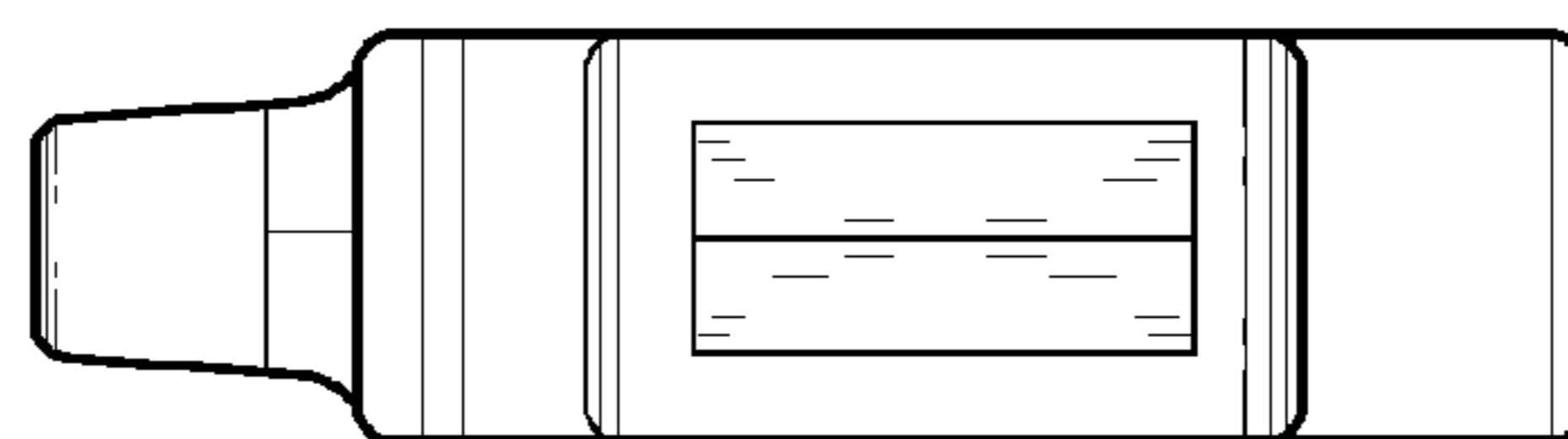

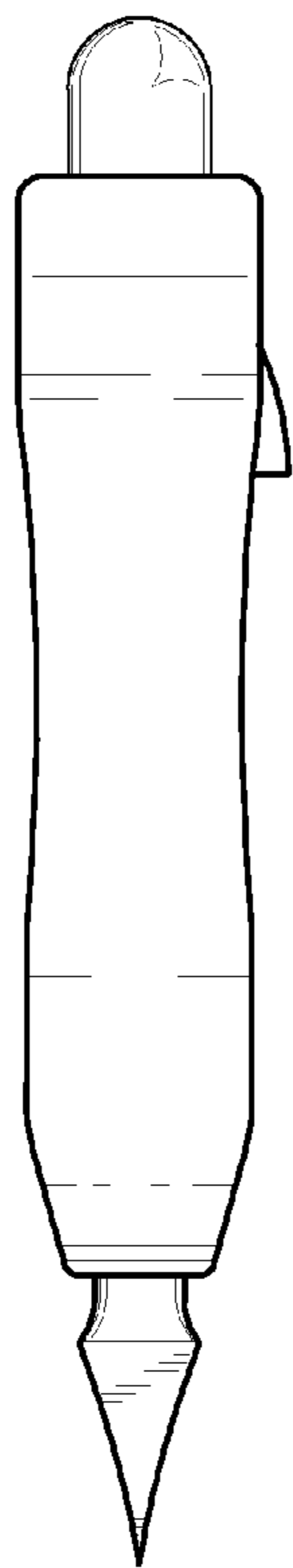

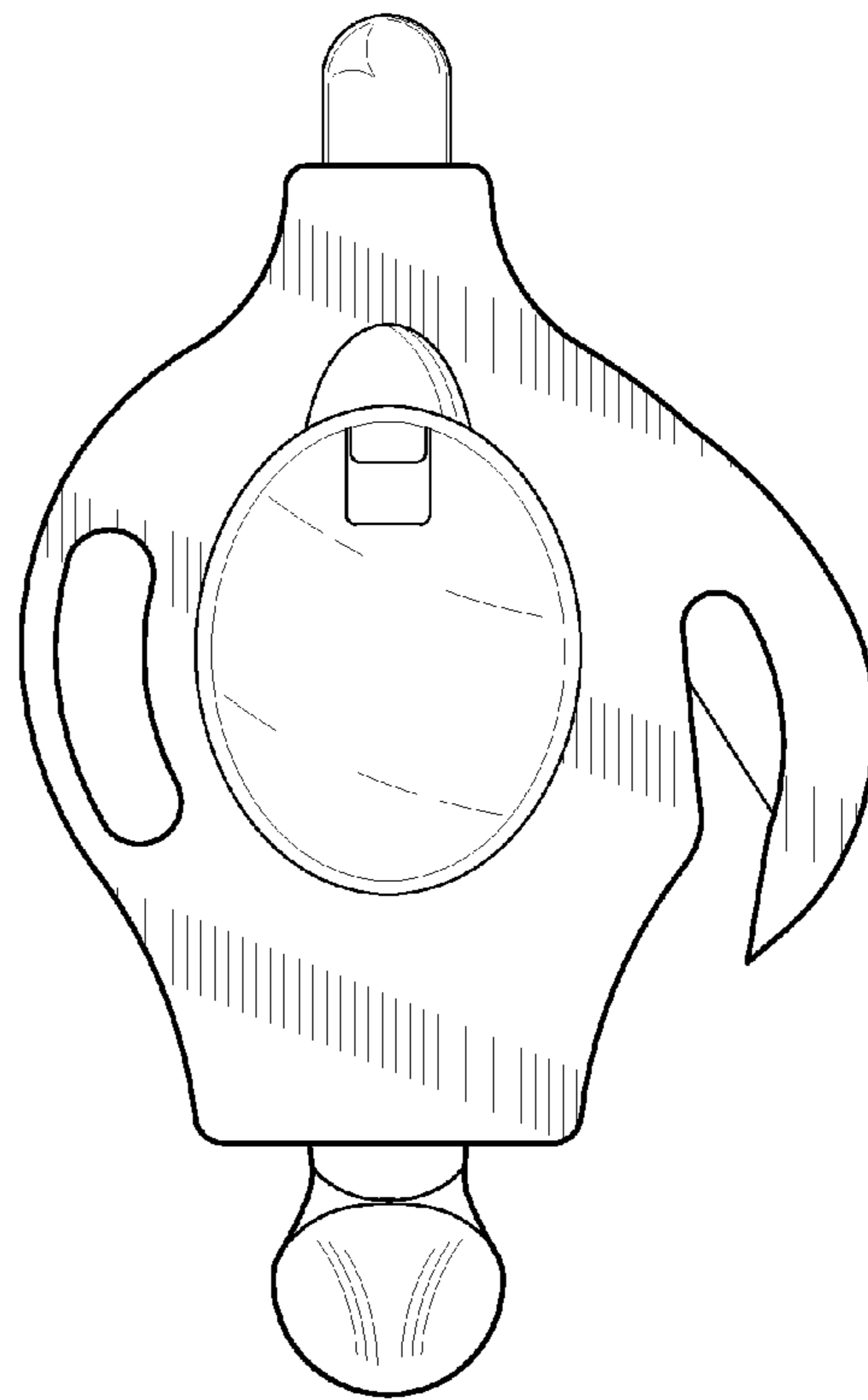
