(57) **CLAIM**

What is claimed is the ornamental design for a garter cell phone holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a garter cell phone holder, showing a first embodiment of the new design in a worn configuration;

FIG. 2 is a perspective view thereof in a flat configuration;

FIG. 3 is a front elevational view of FIG. 2;

FIG. 4 is a rear elevational view of FIG. 2;

FIG. 5 is a right-side elevational view of FIG. 2;

FIG. 6 is a left-side elevational view of FIG. 2;

FIG. 7 is a top plan view of FIG. 2;

FIG. 8 is a bottom plan view of FIG. 2;

FIG. 9 is a perspective view of a second embodiment of the design, illustrated in the flat configuration; and

FIG. 10 is a front elevational view of FIG. 9, the rear elevational view being identical to FIG. 4.

FIG. 11 is a right-side elevational view of FIG. 9;

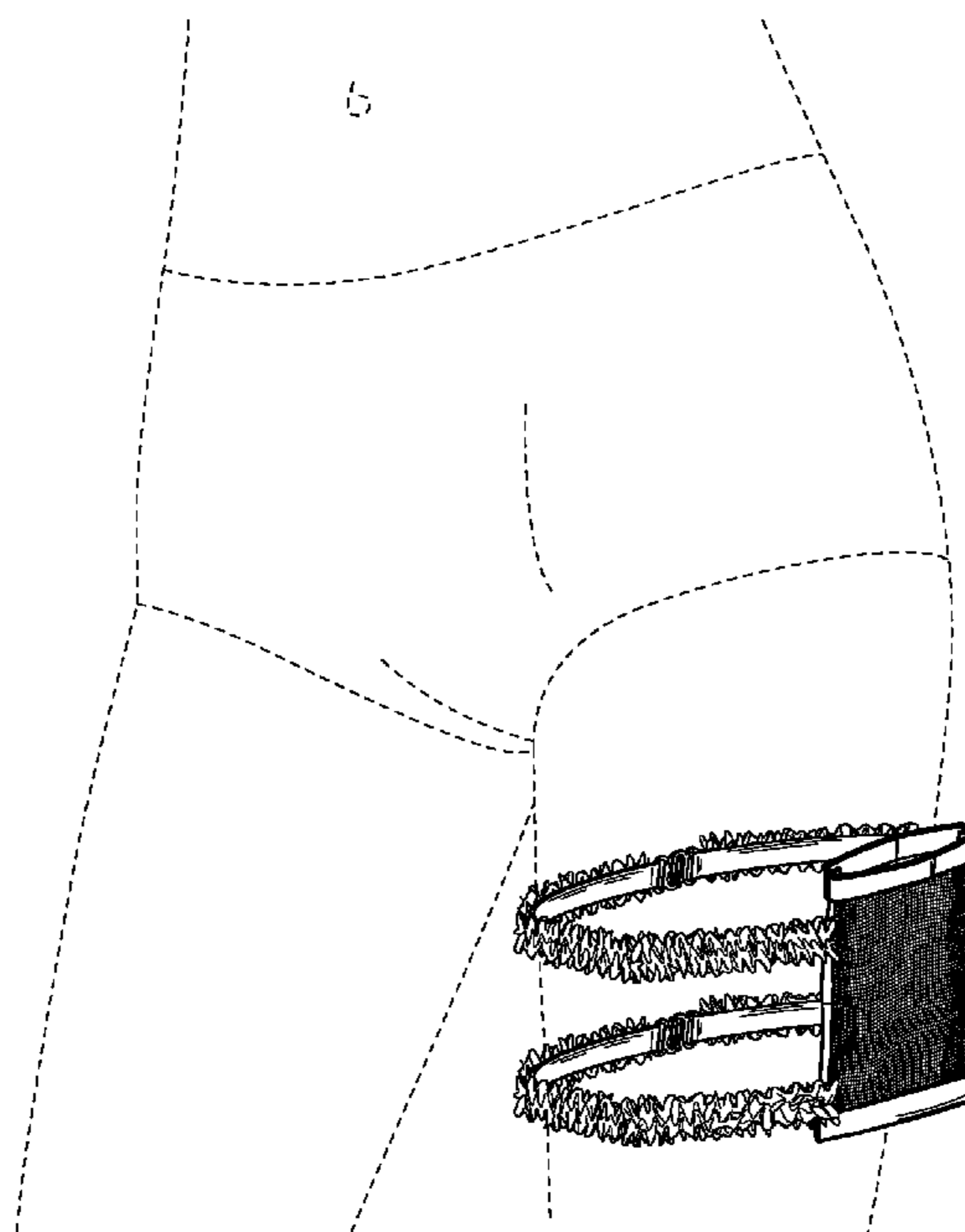
FIG. 12 is a left-side elevational view of FIG. 9;

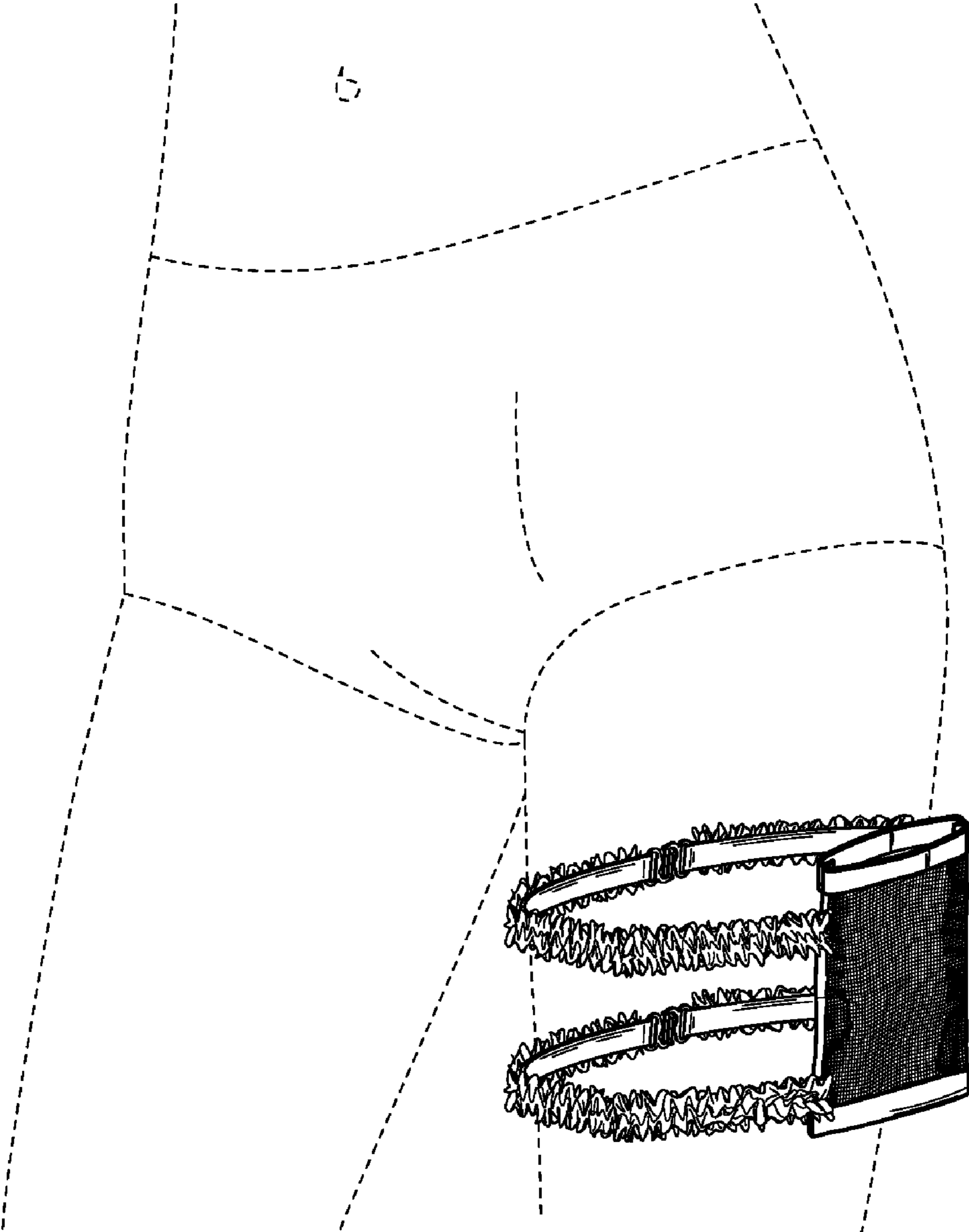

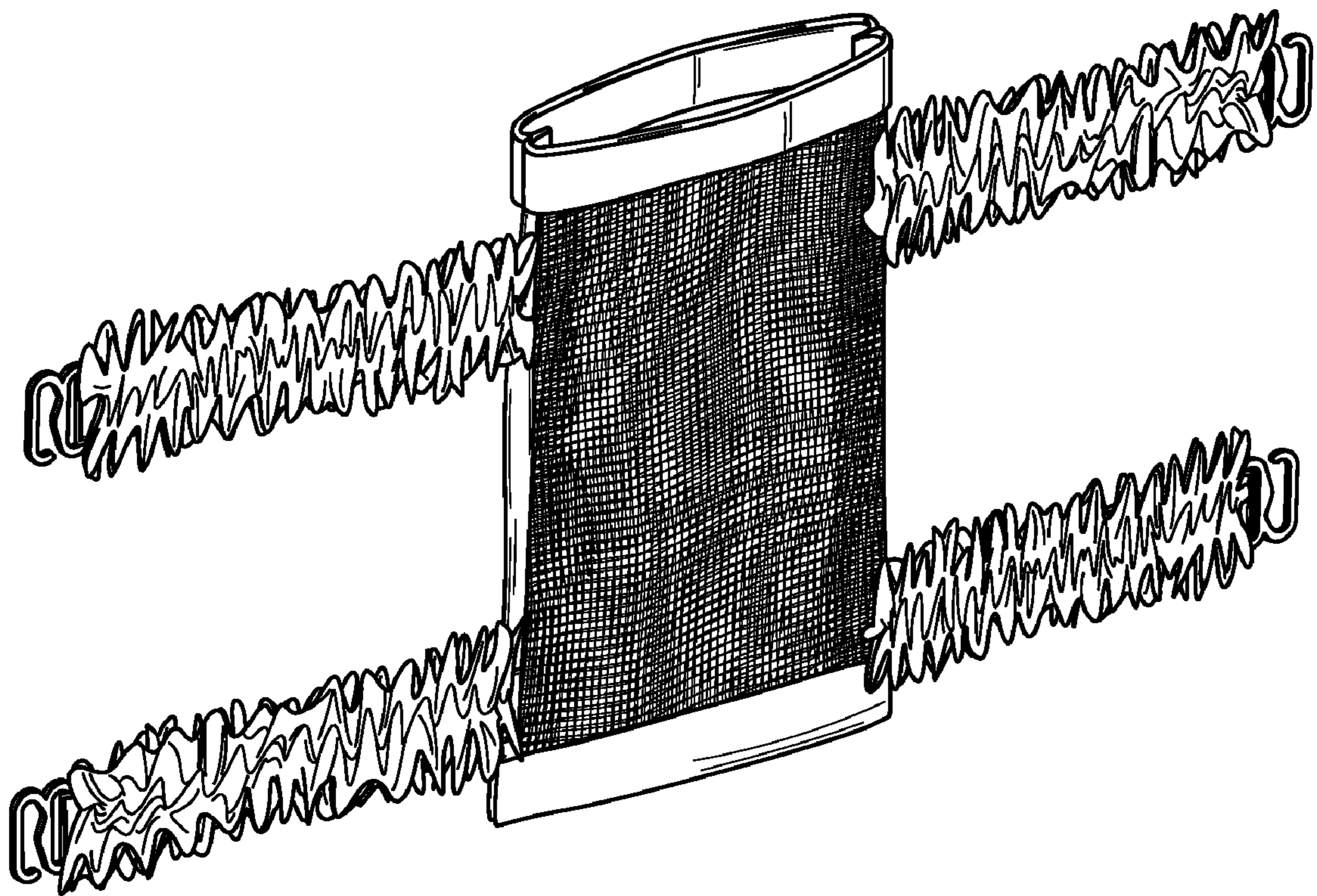

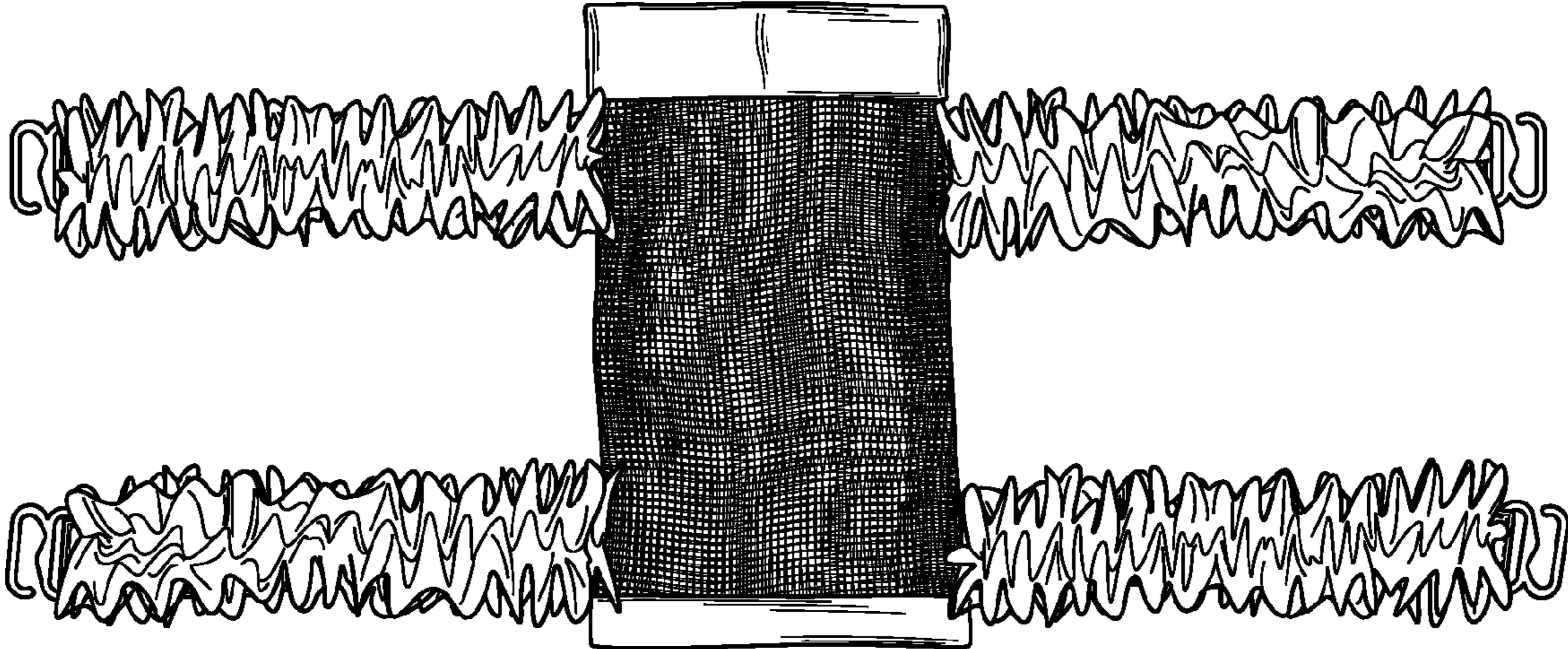

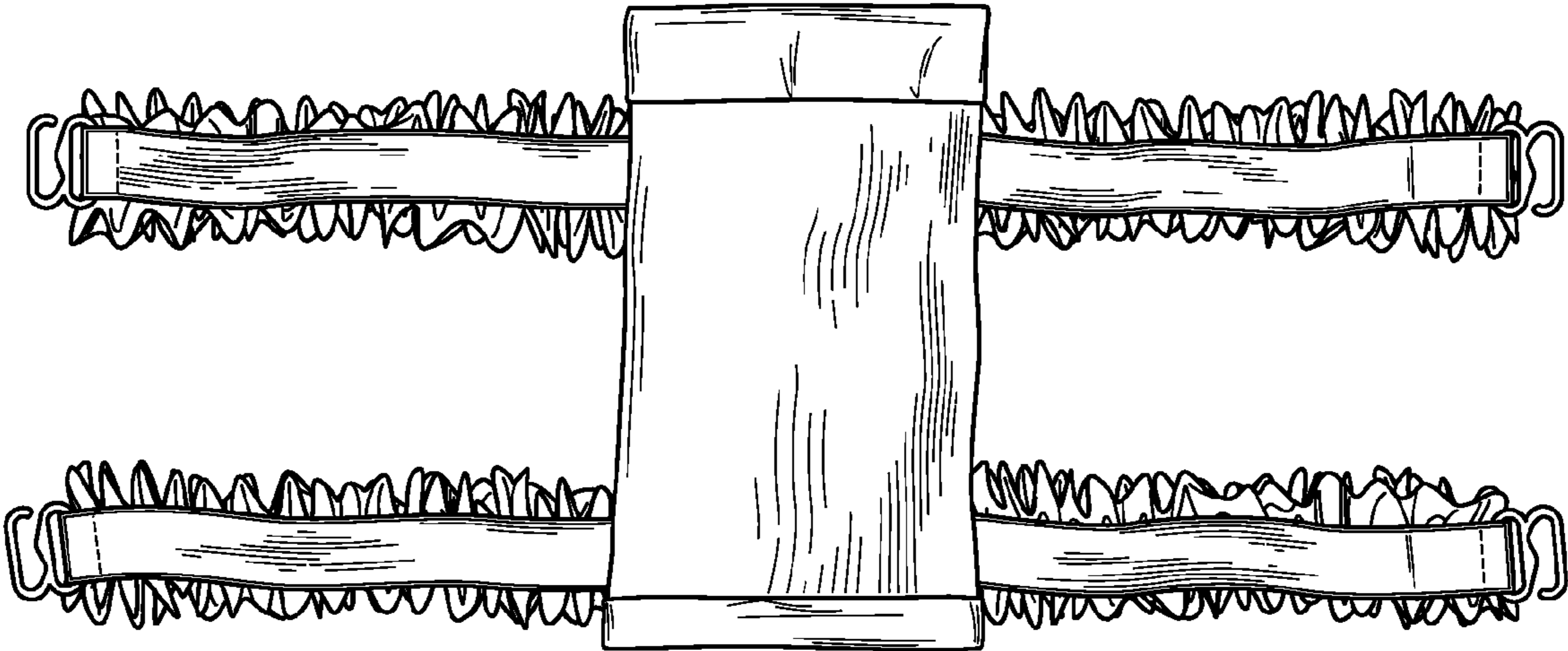

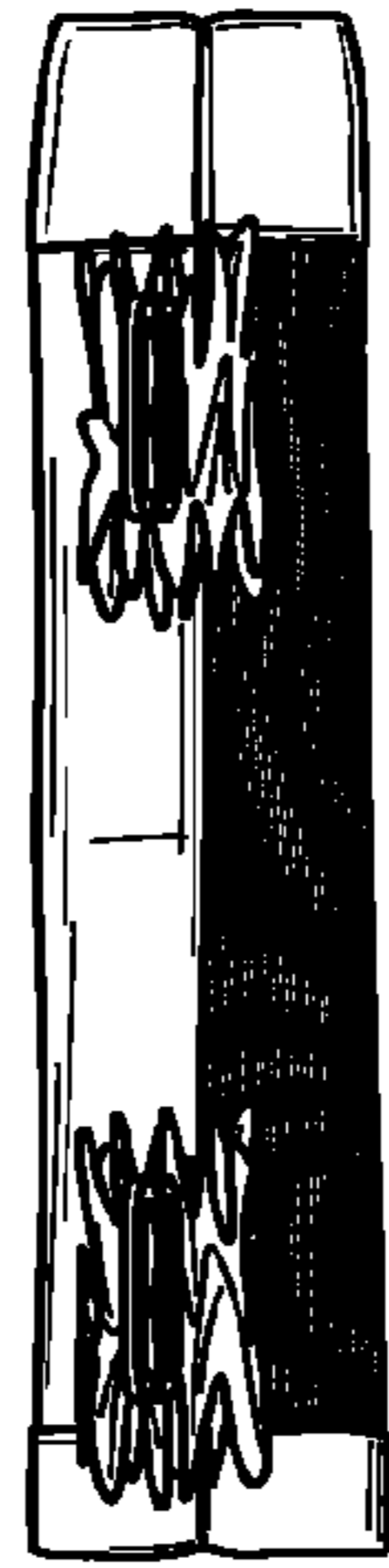

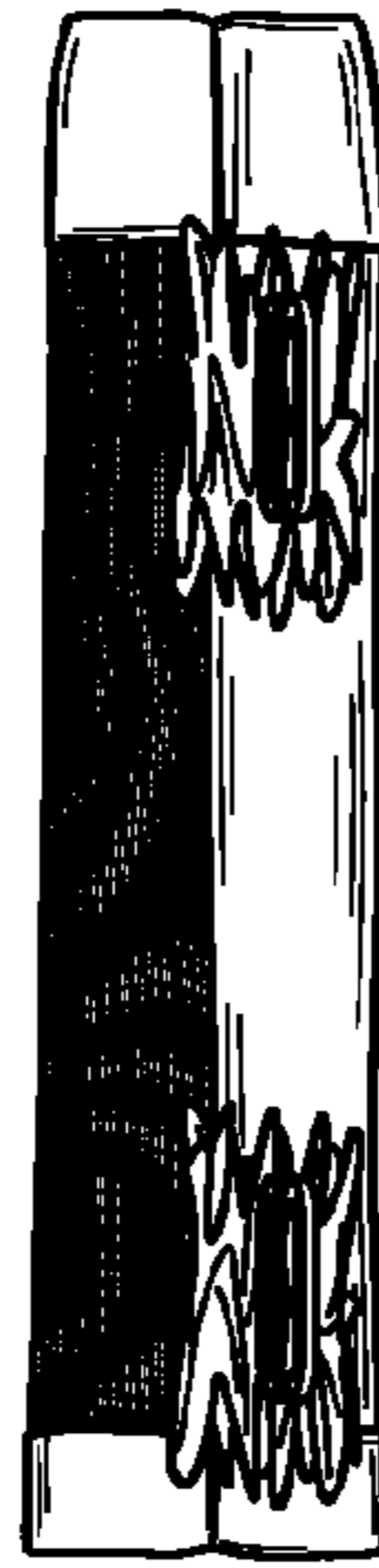

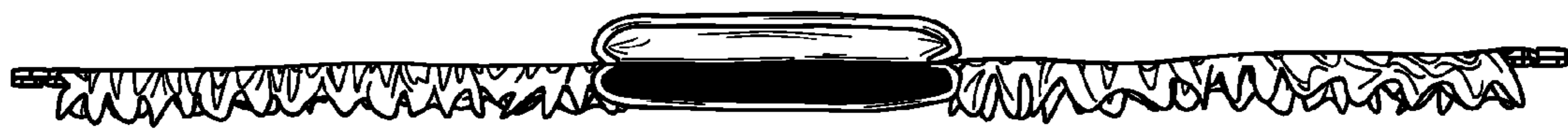

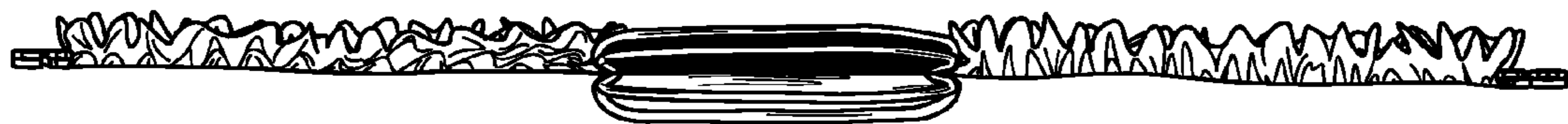

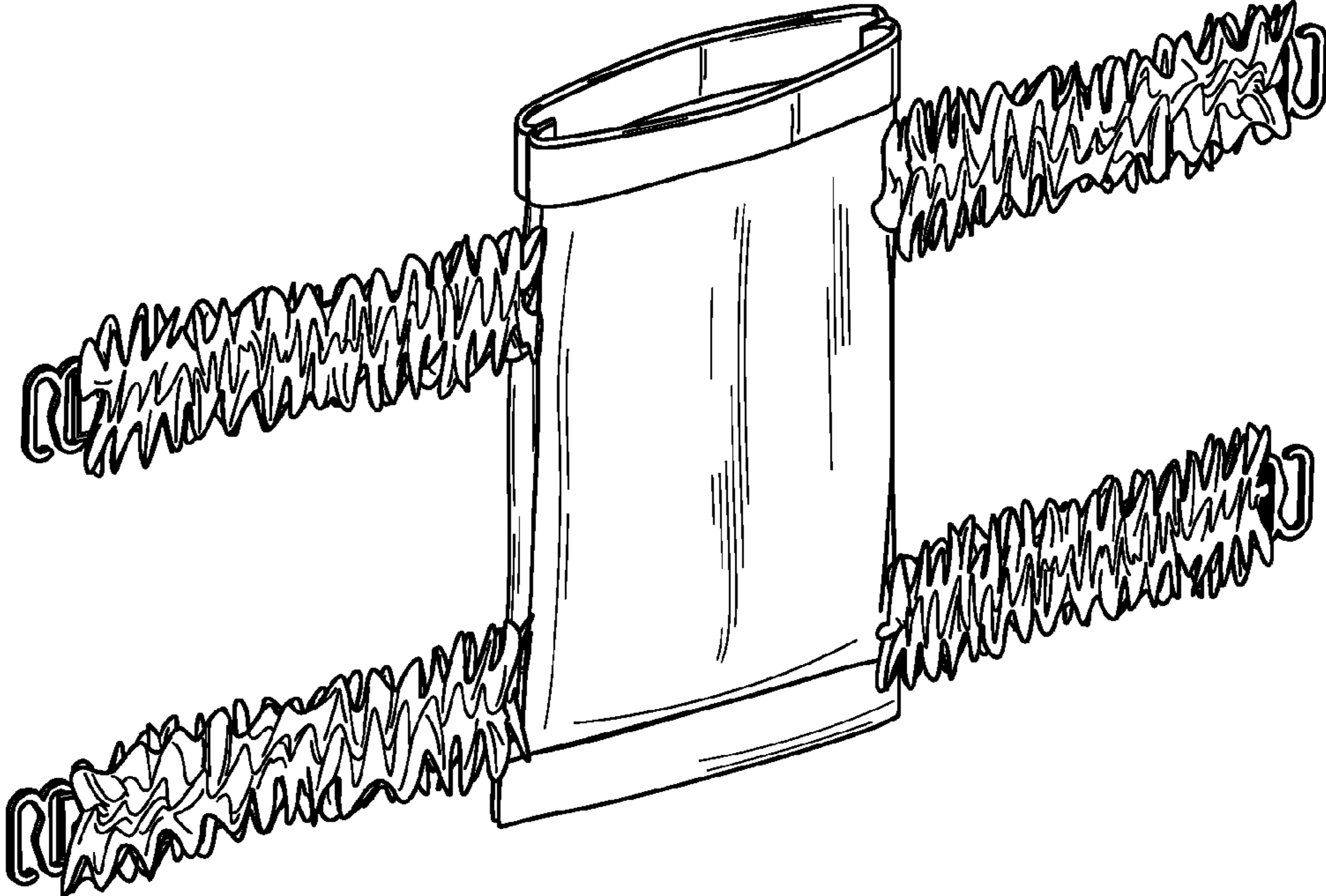

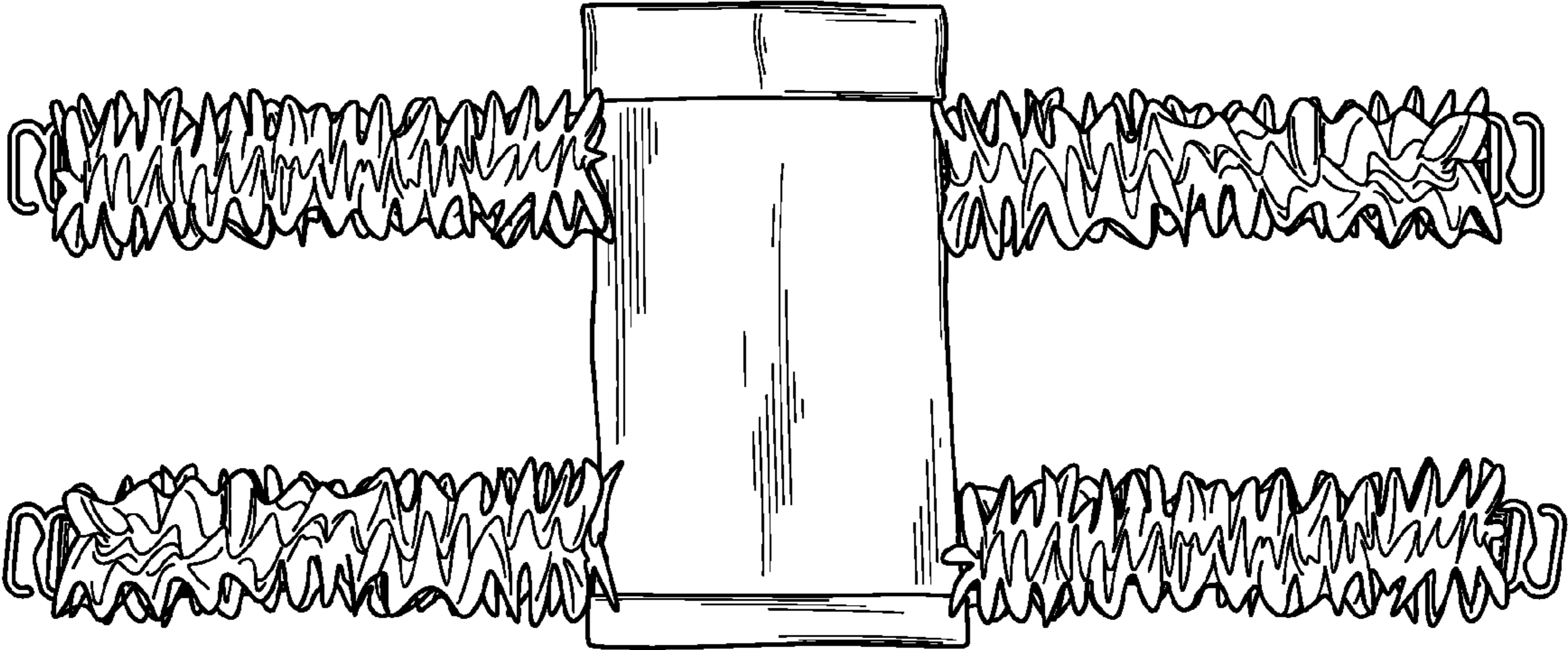

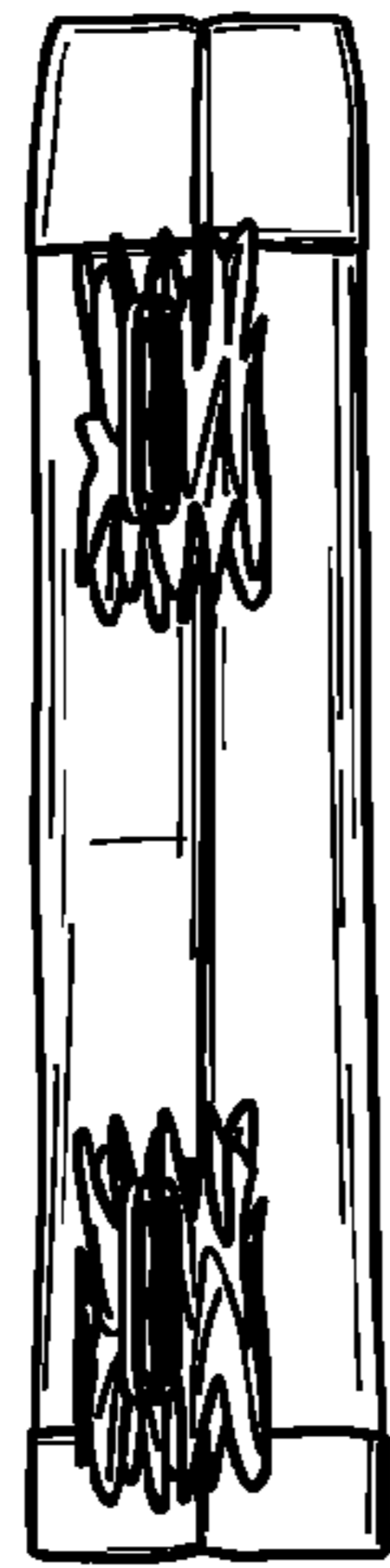

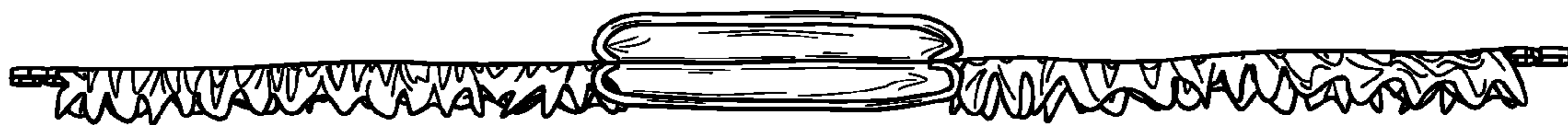

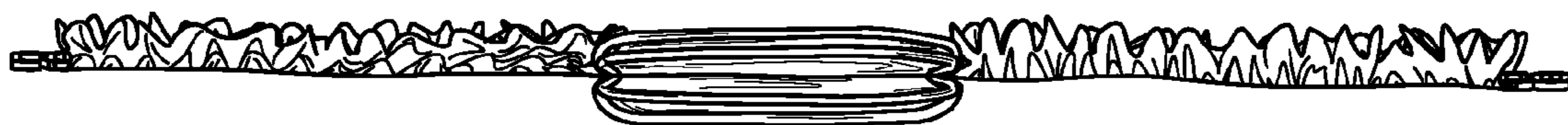
