FIG. 7 is a right perspective view thereof;

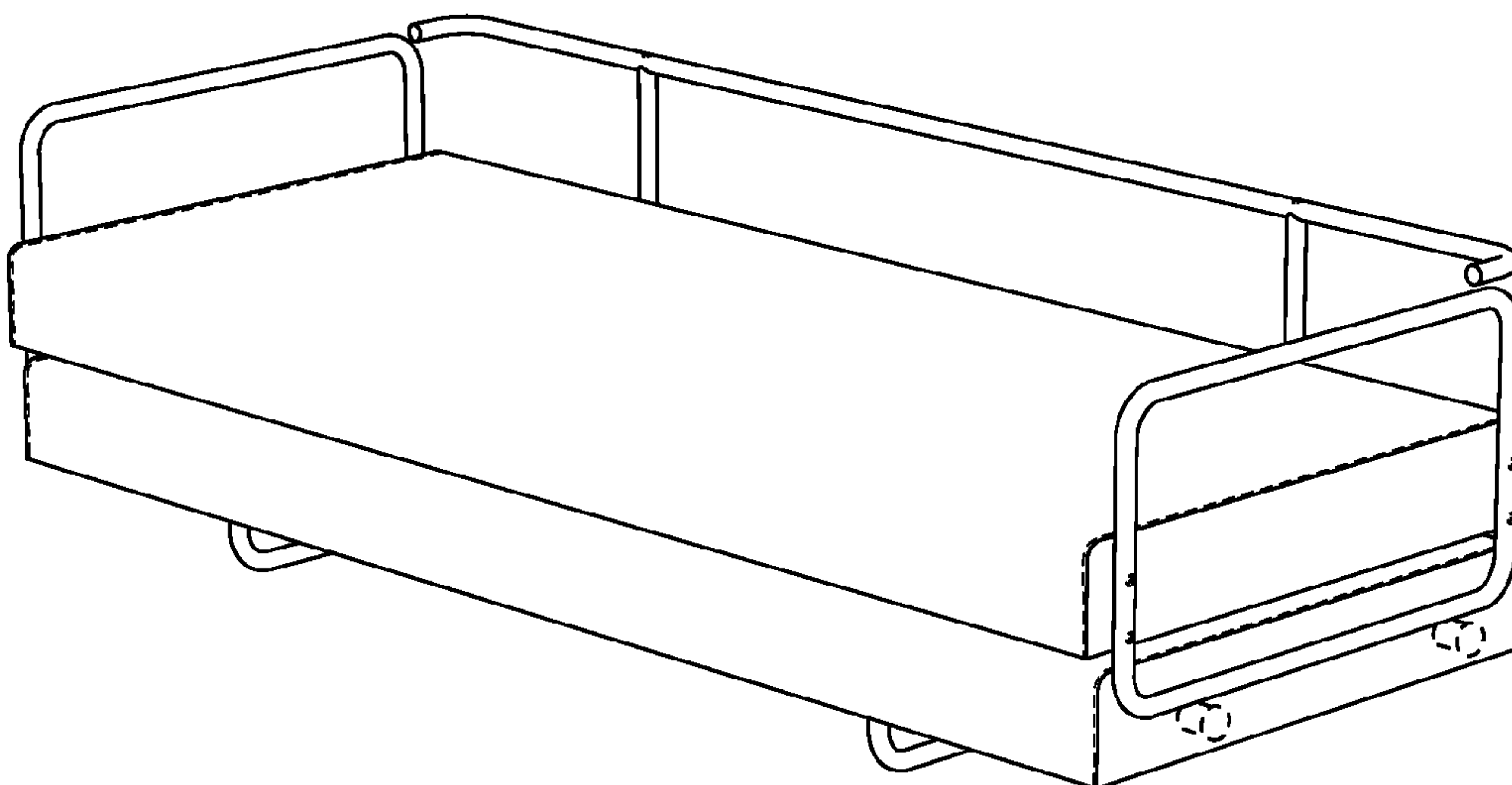
FIG. 8 is a left perspective view thereof;

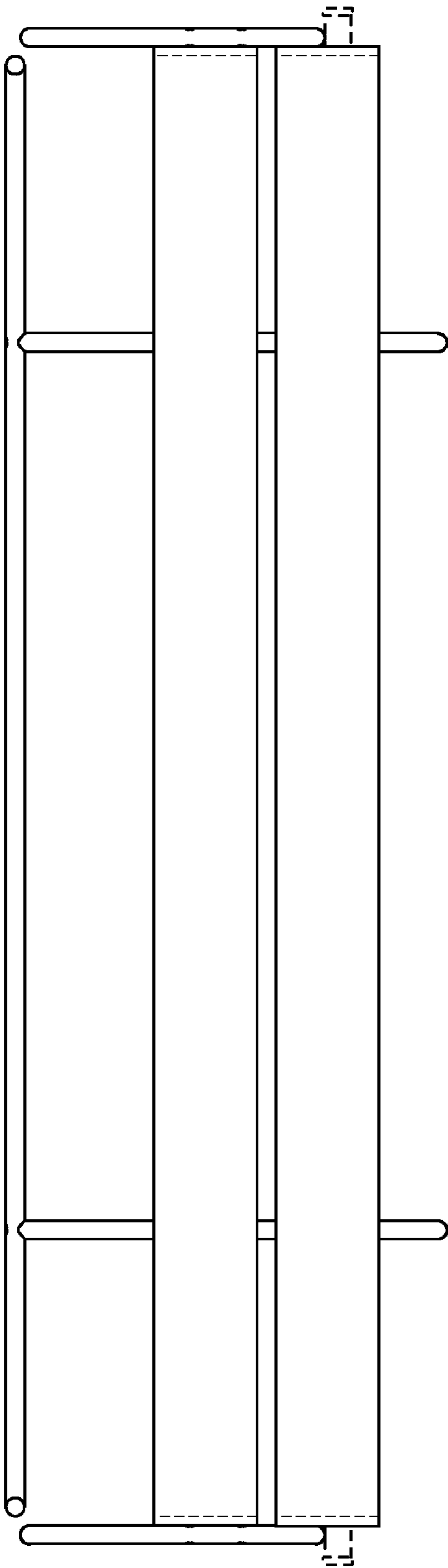

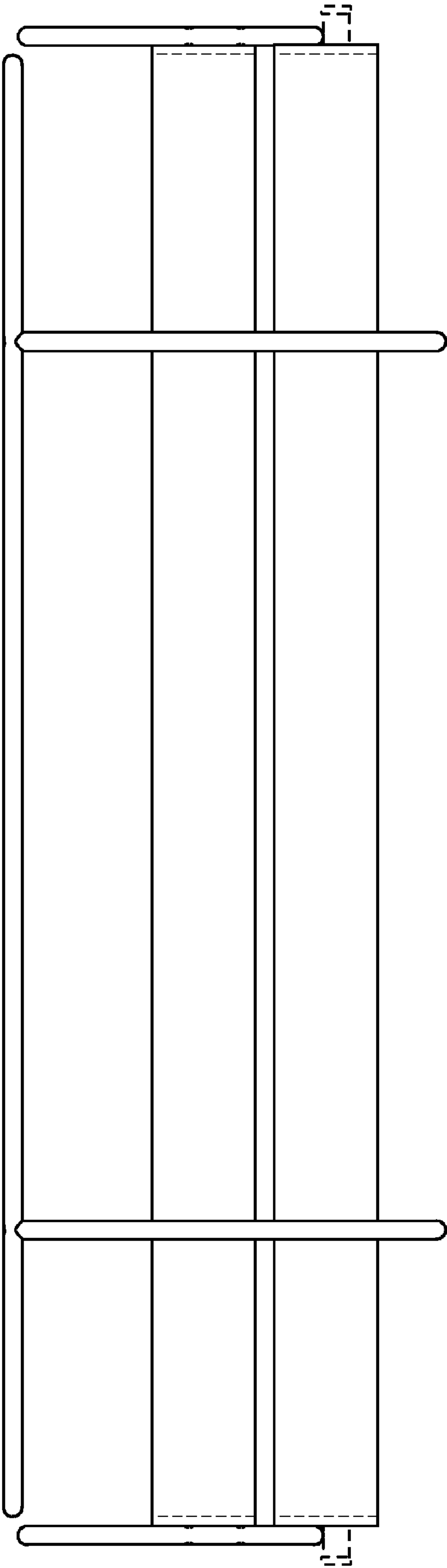

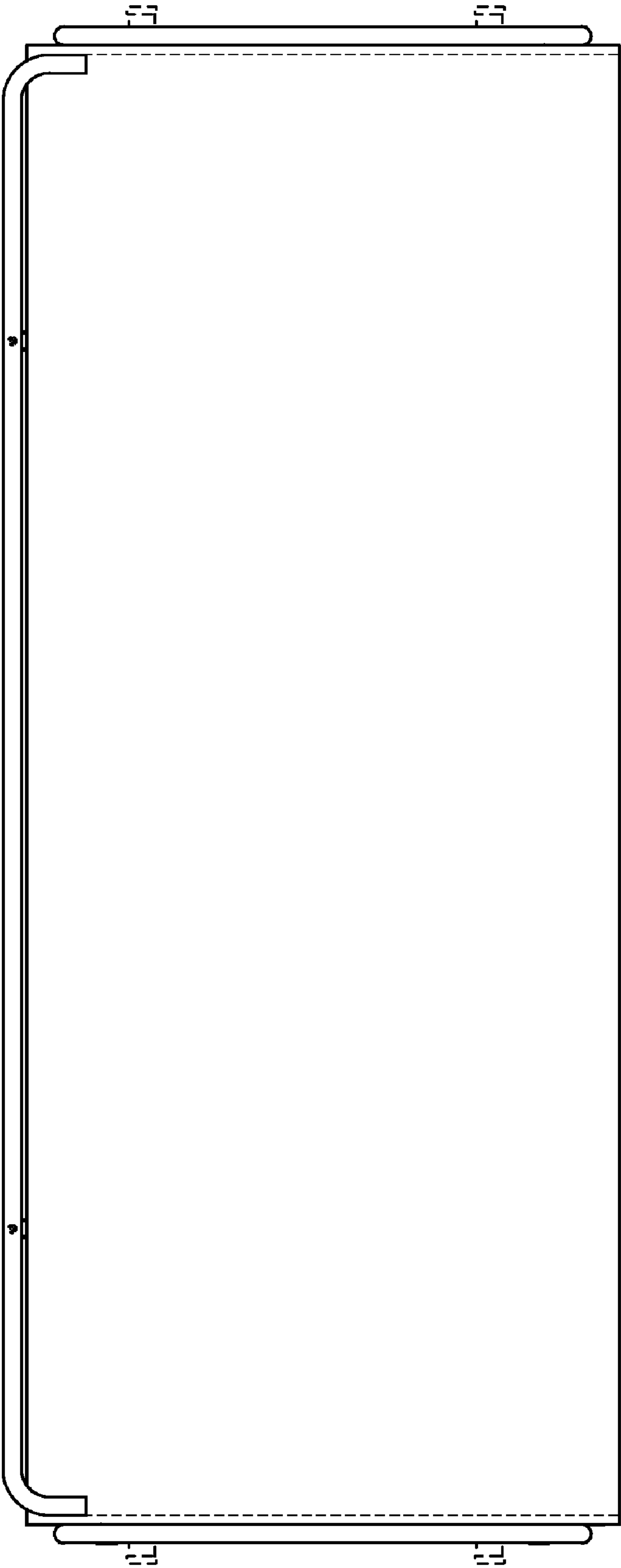

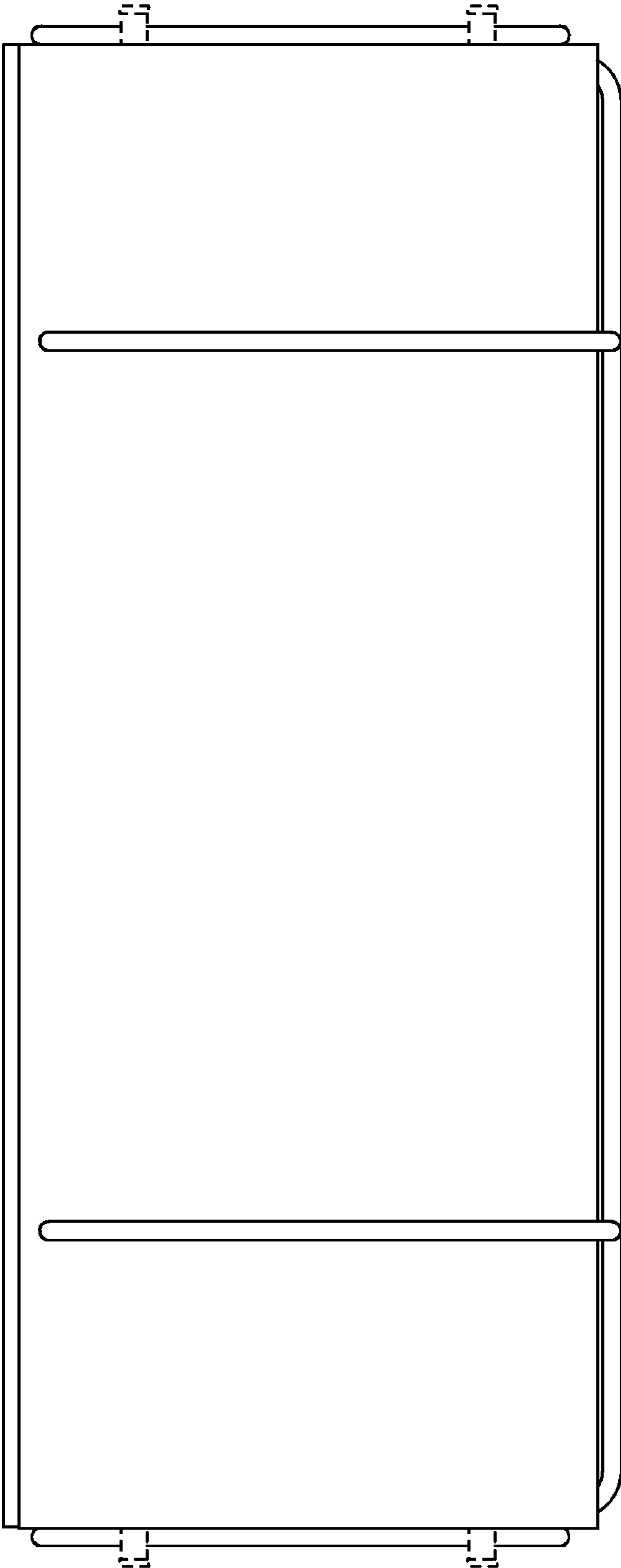

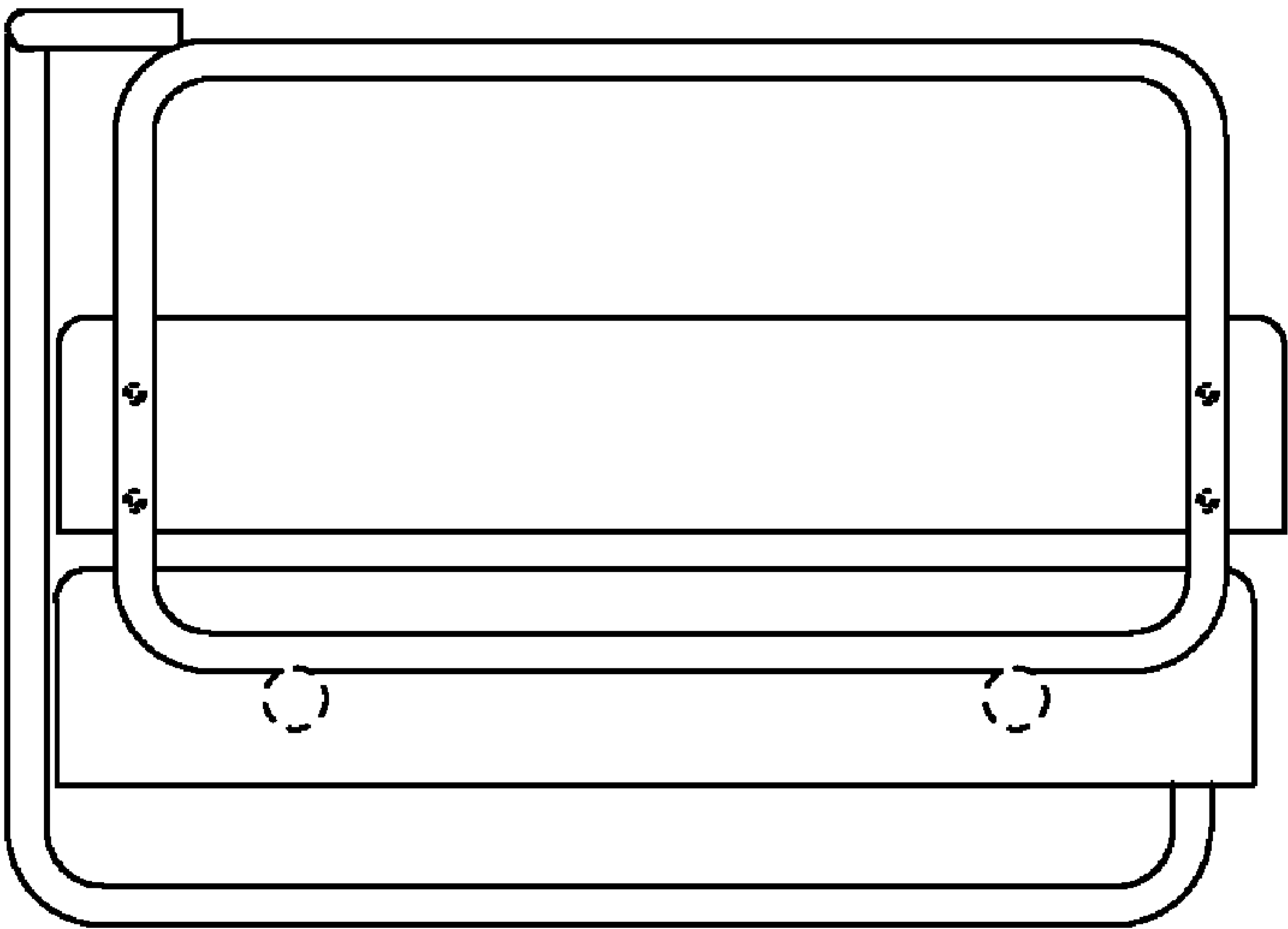

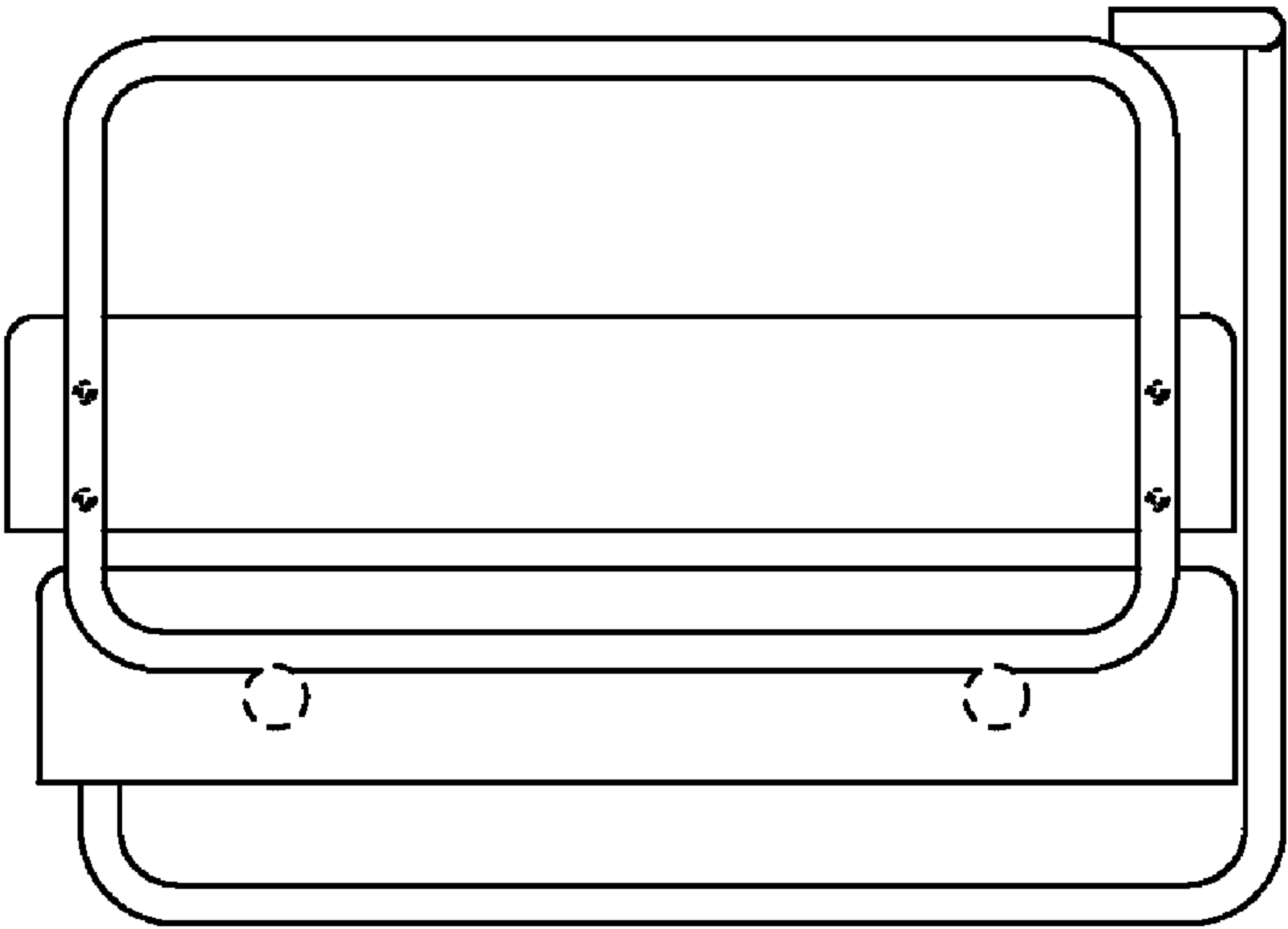

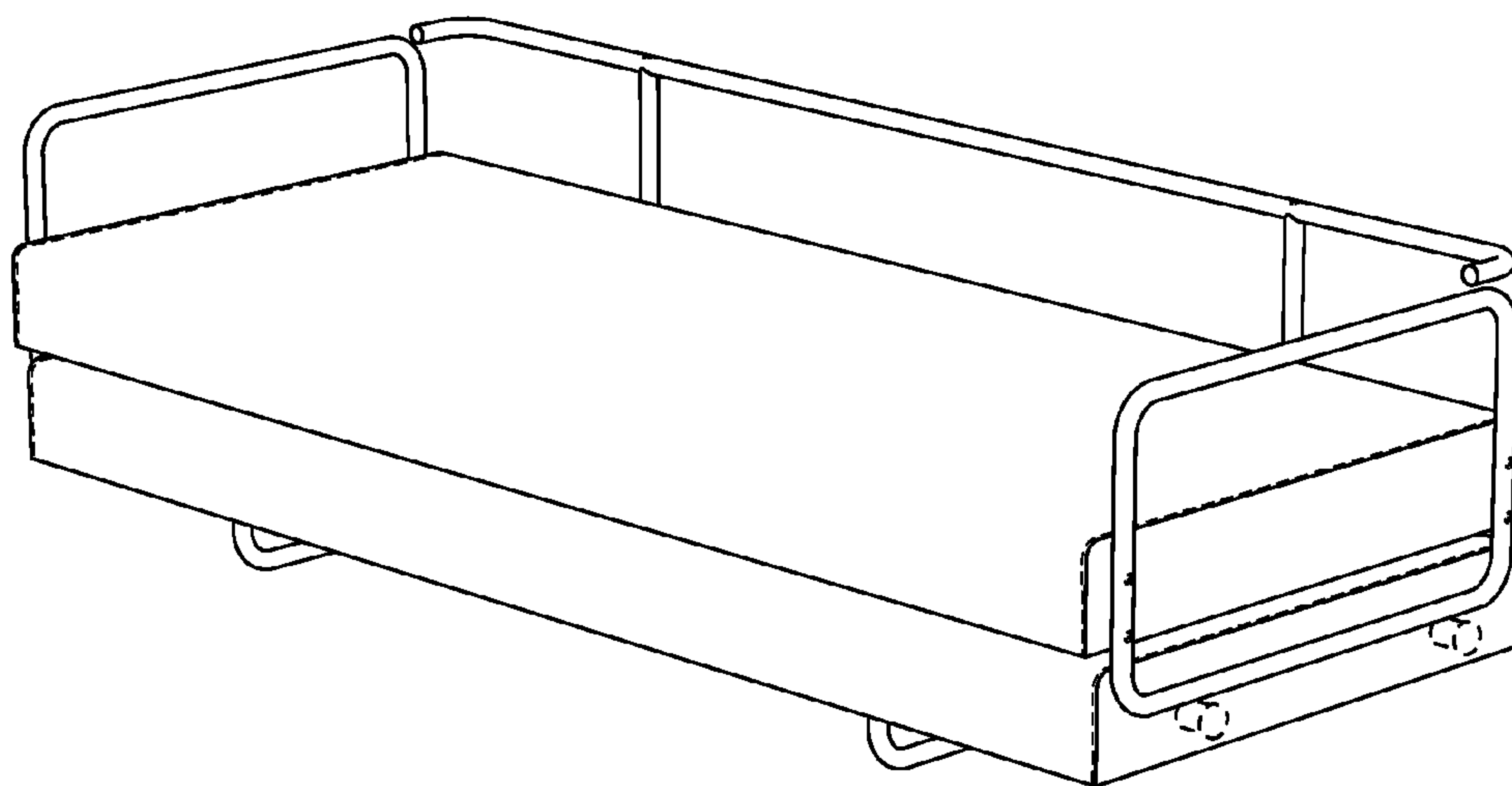

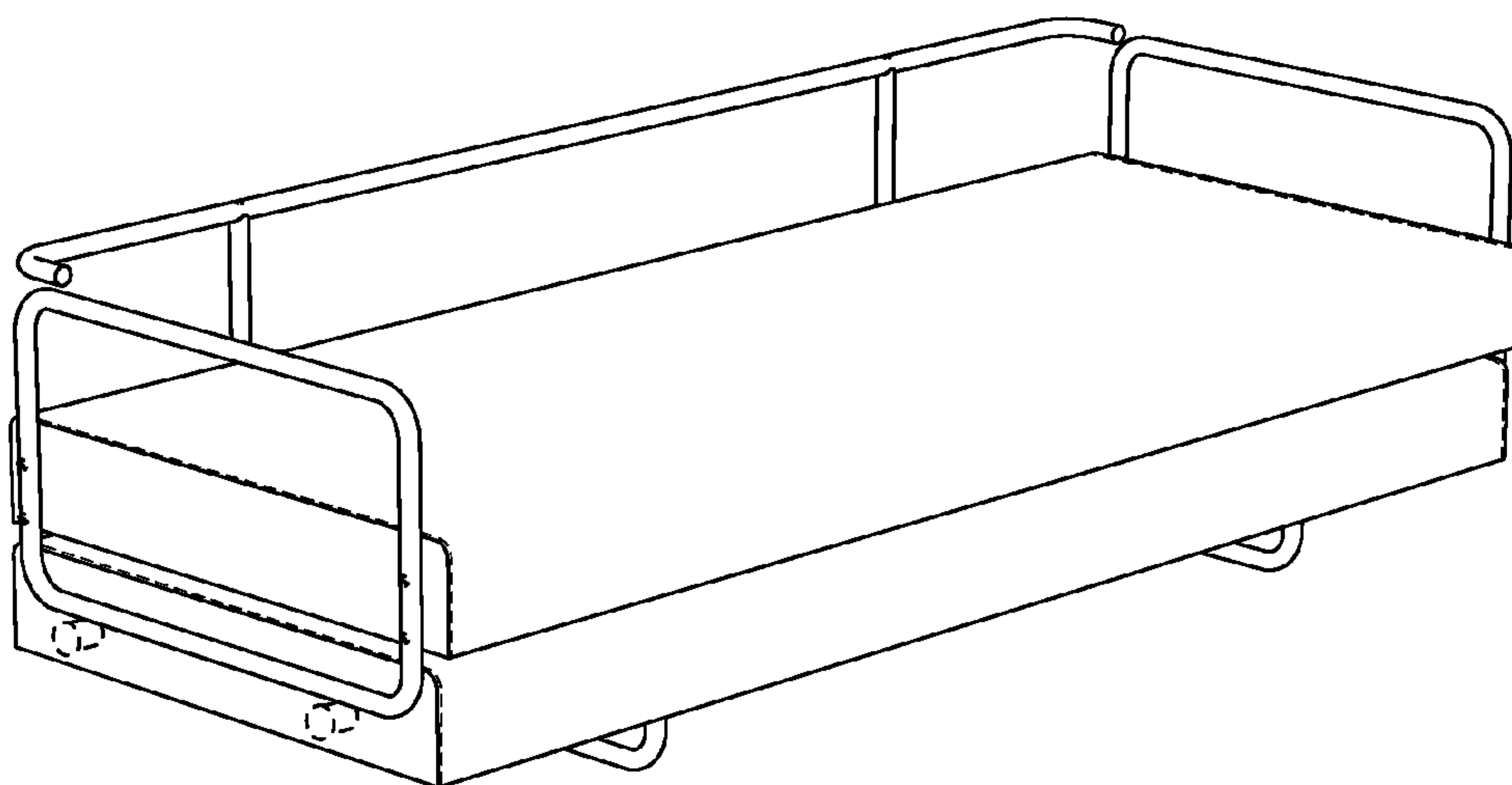

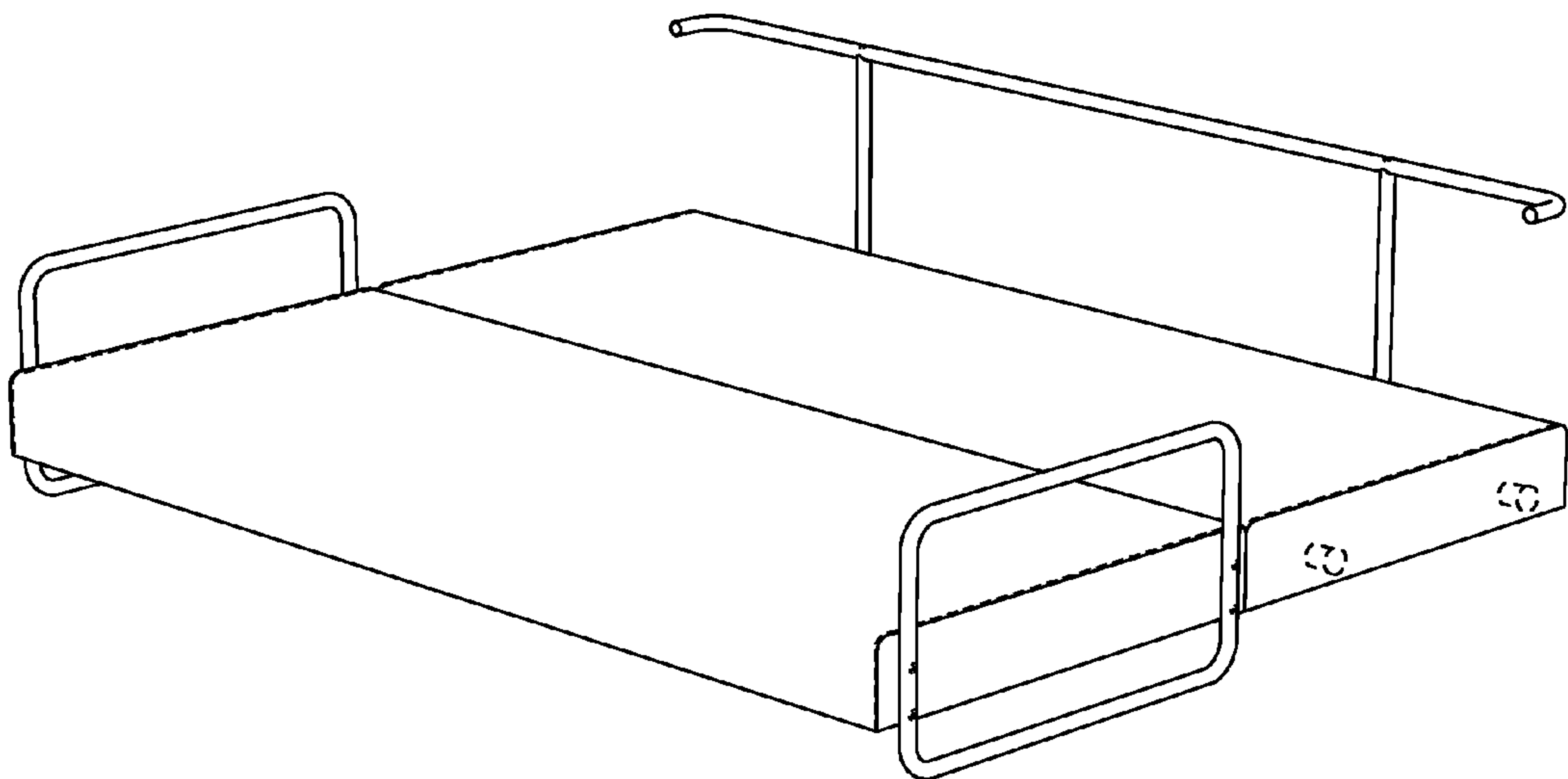

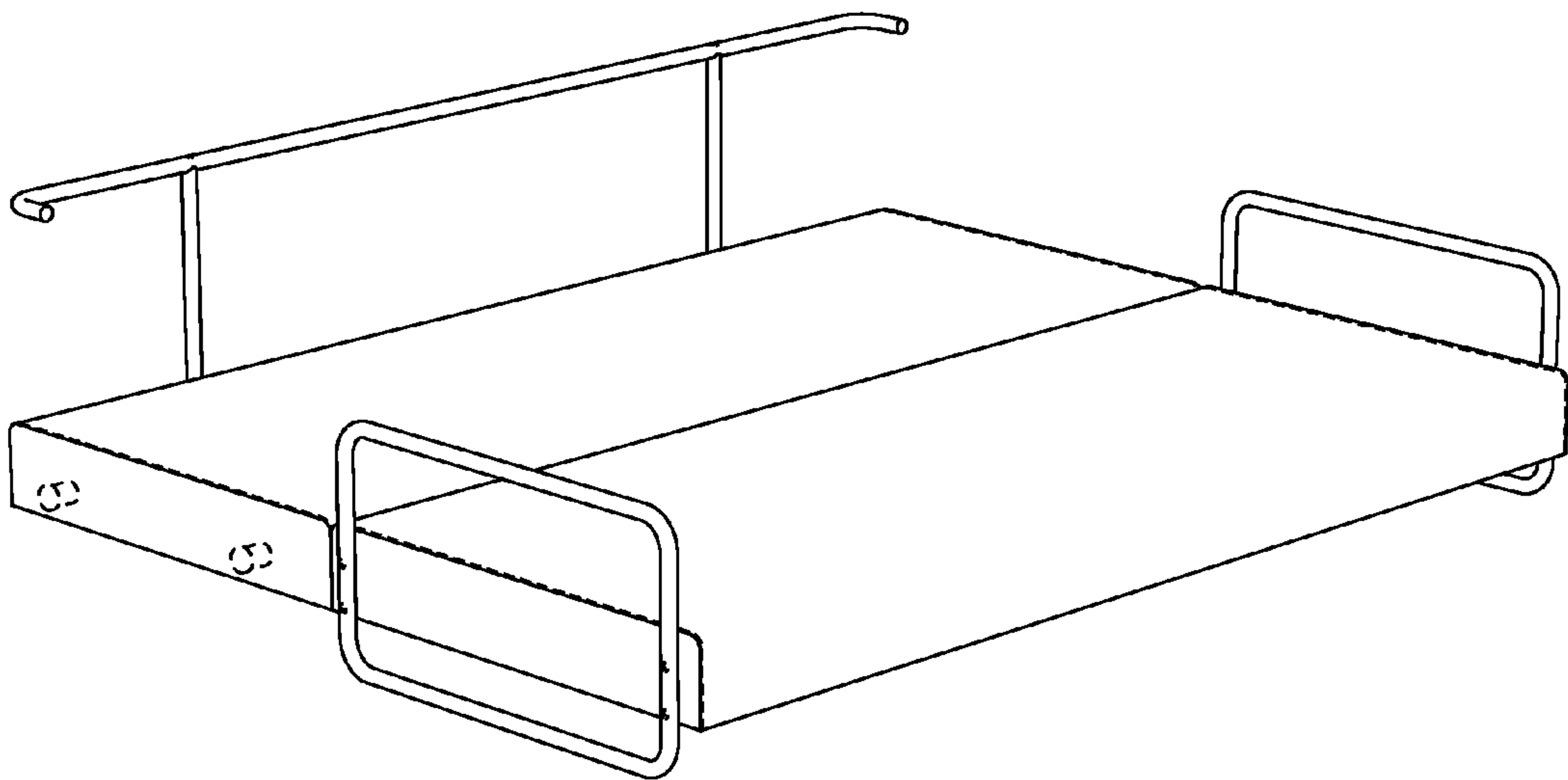
