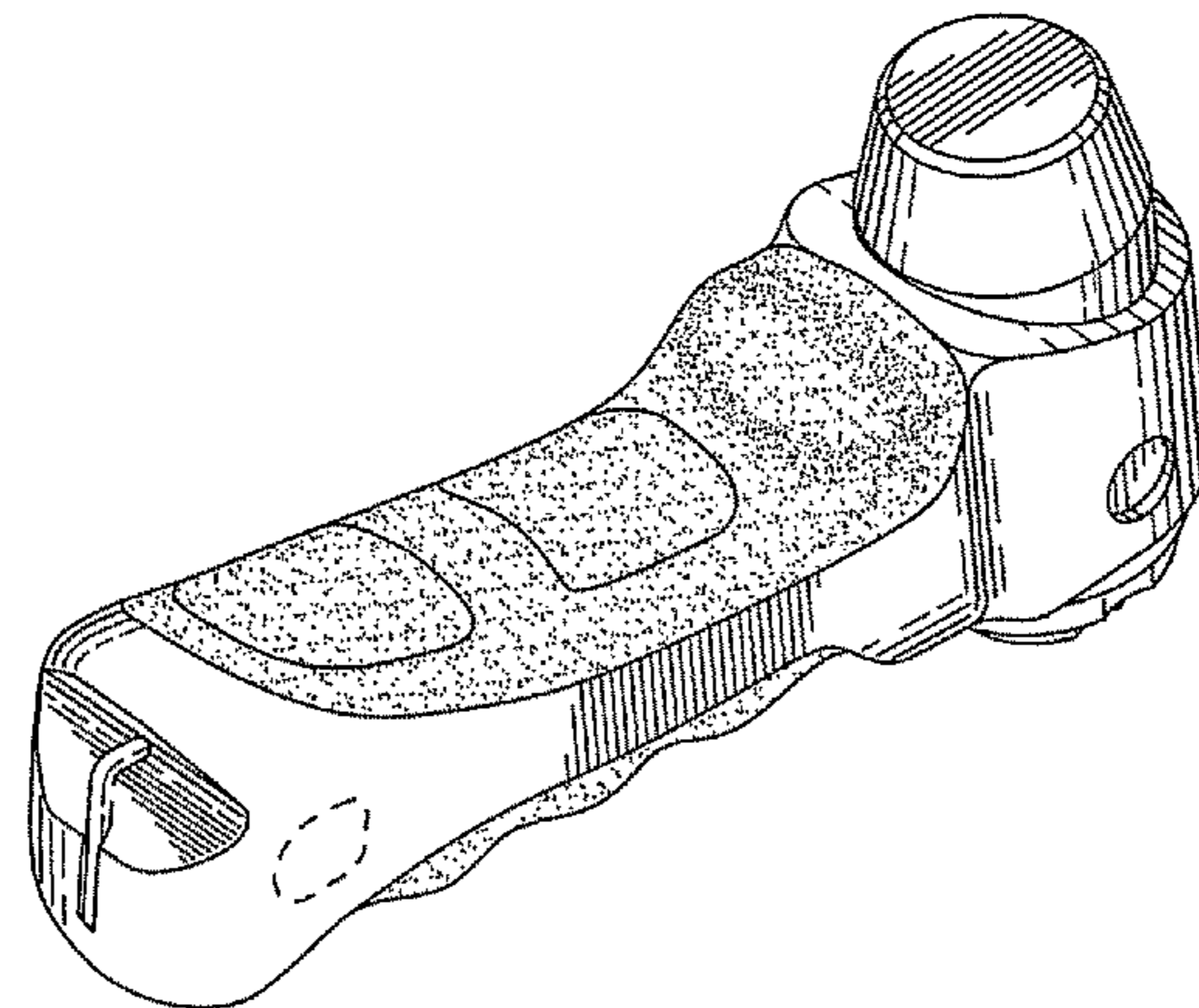
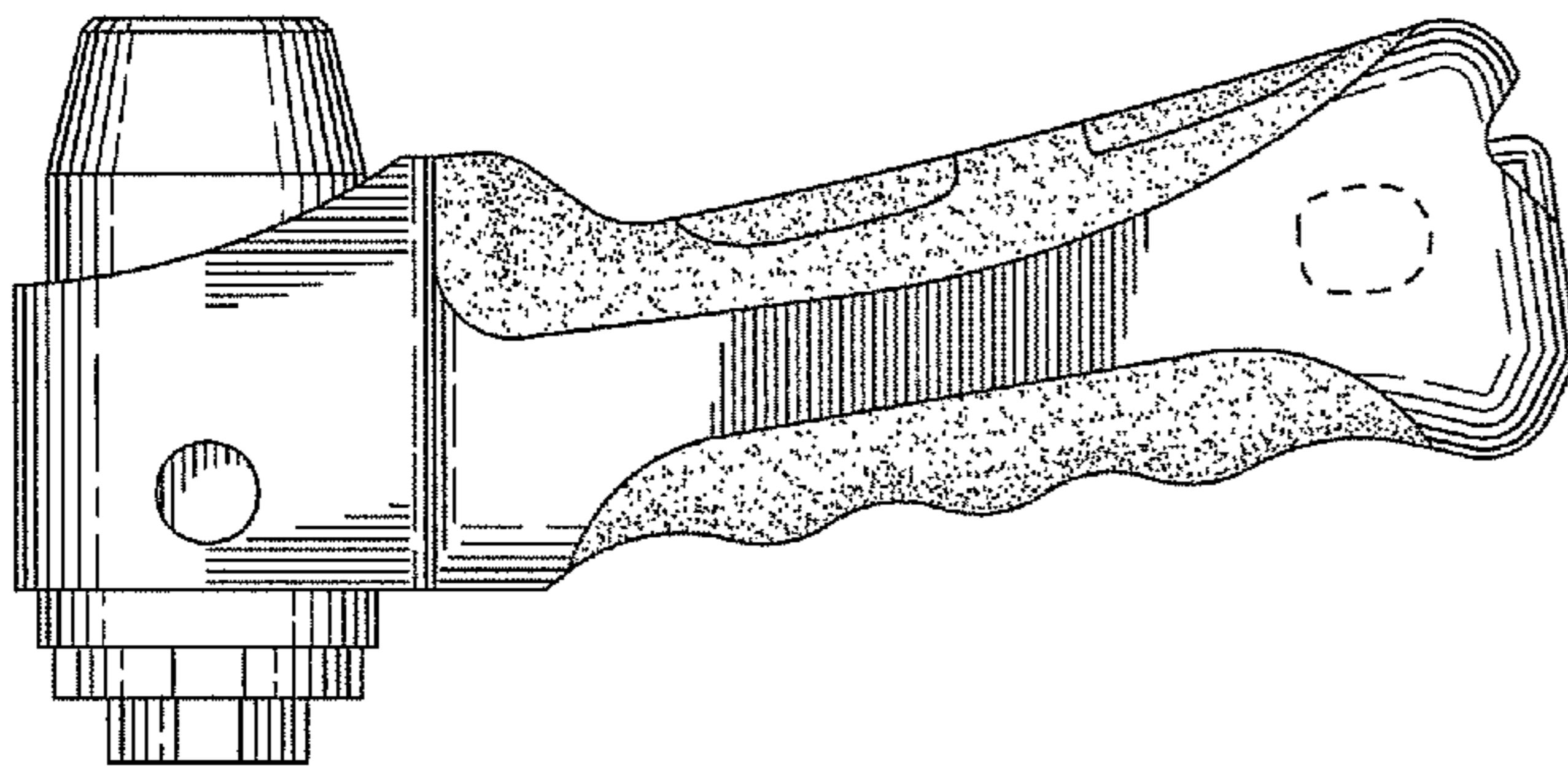
(57) **CLAIM**

The ornamental design for a handle for tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side view of a handle for tool illustrating our new design, the right side view being a mirror image; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is an upper right side perspective view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a lower left side perspective view thereof. The broken lines form no part of the claimed design.

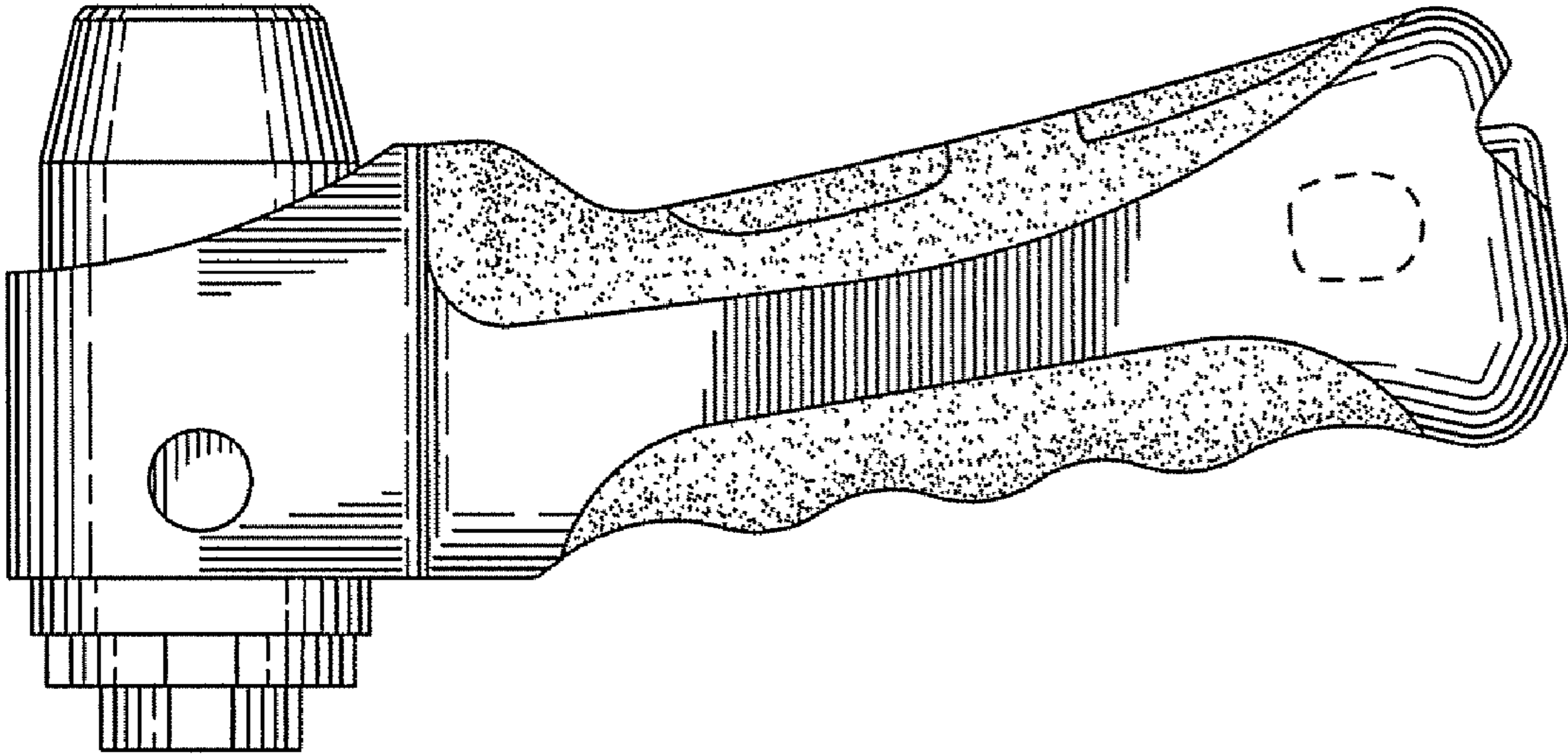

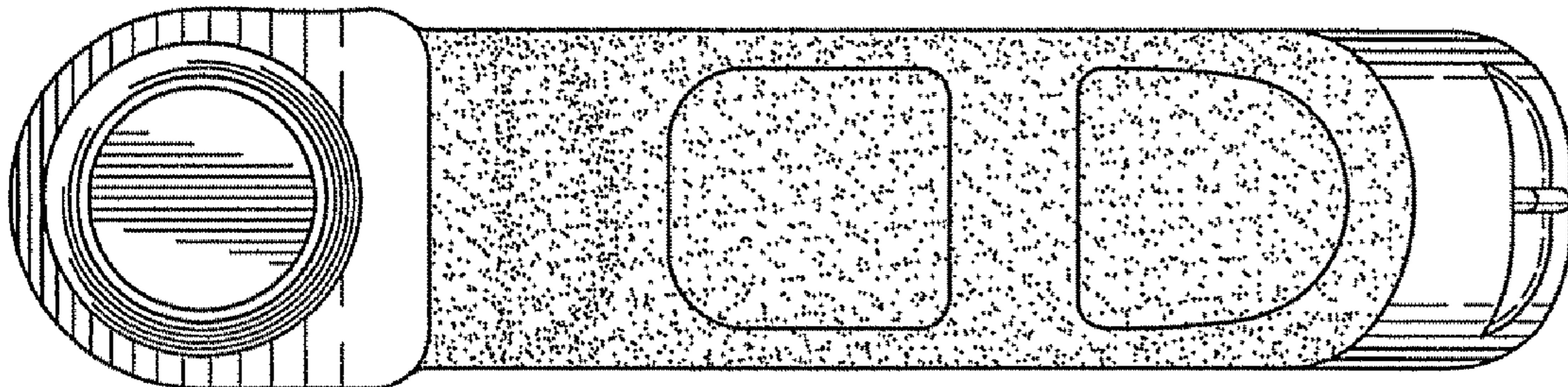

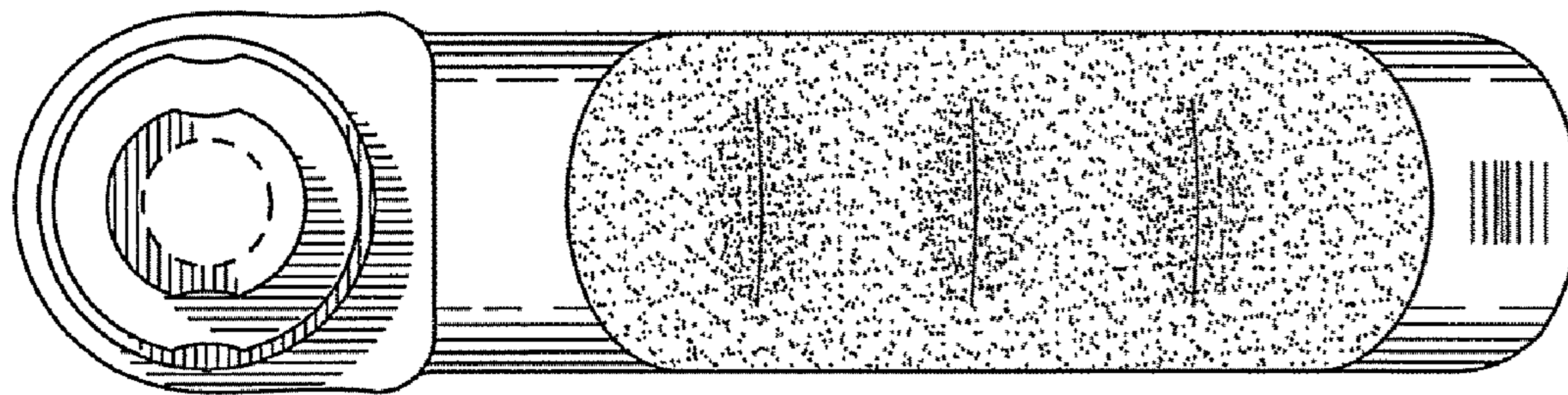

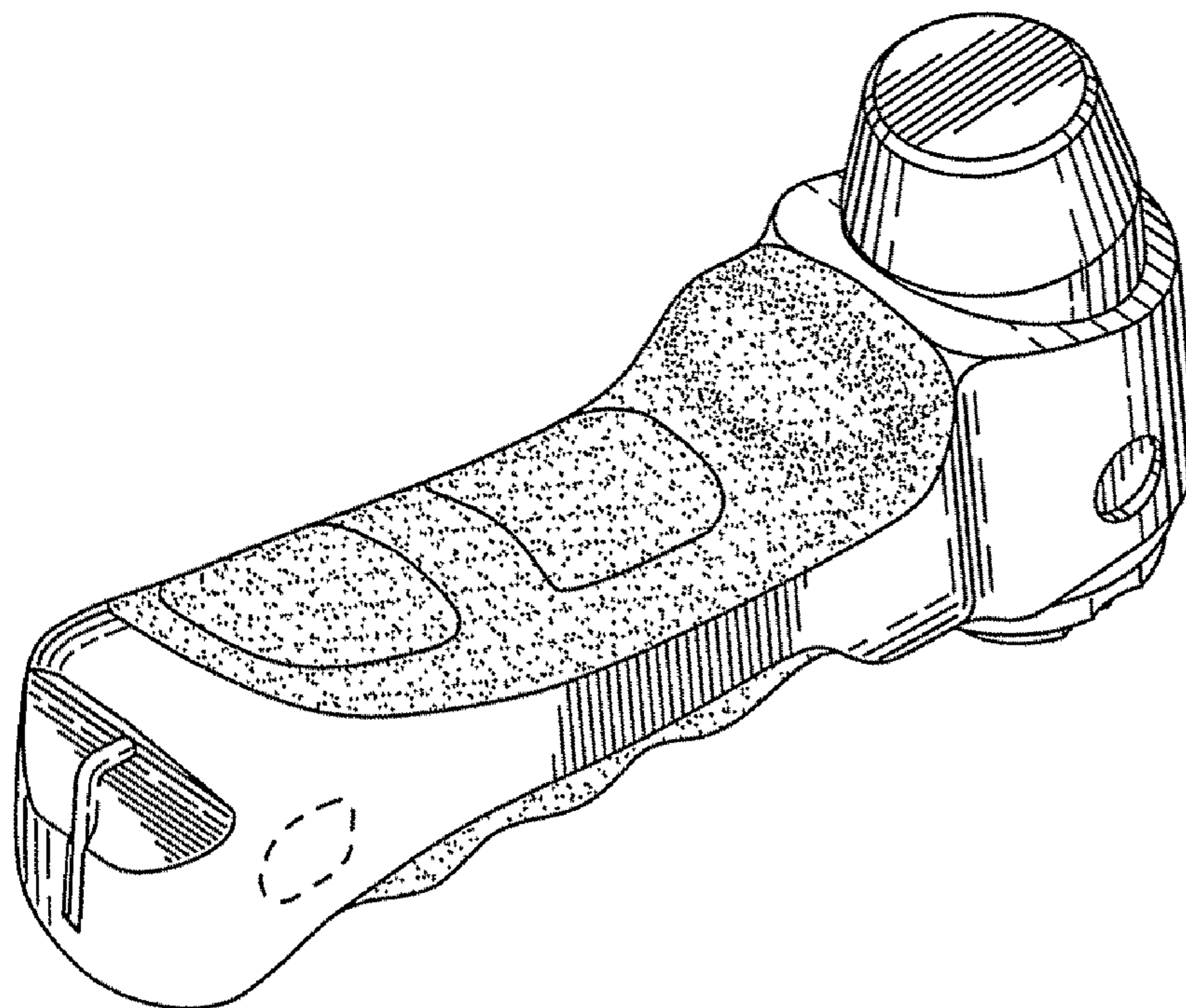

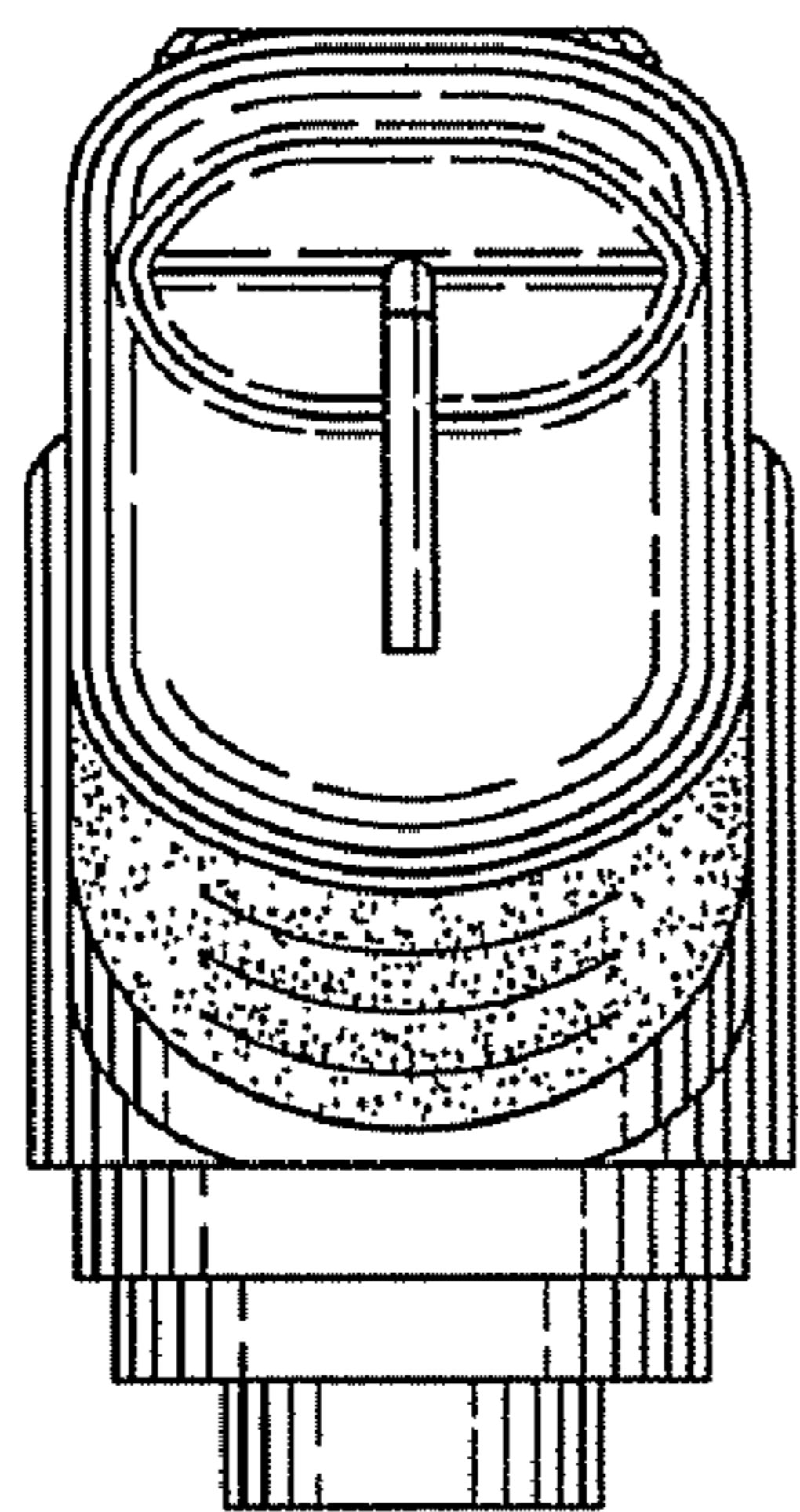

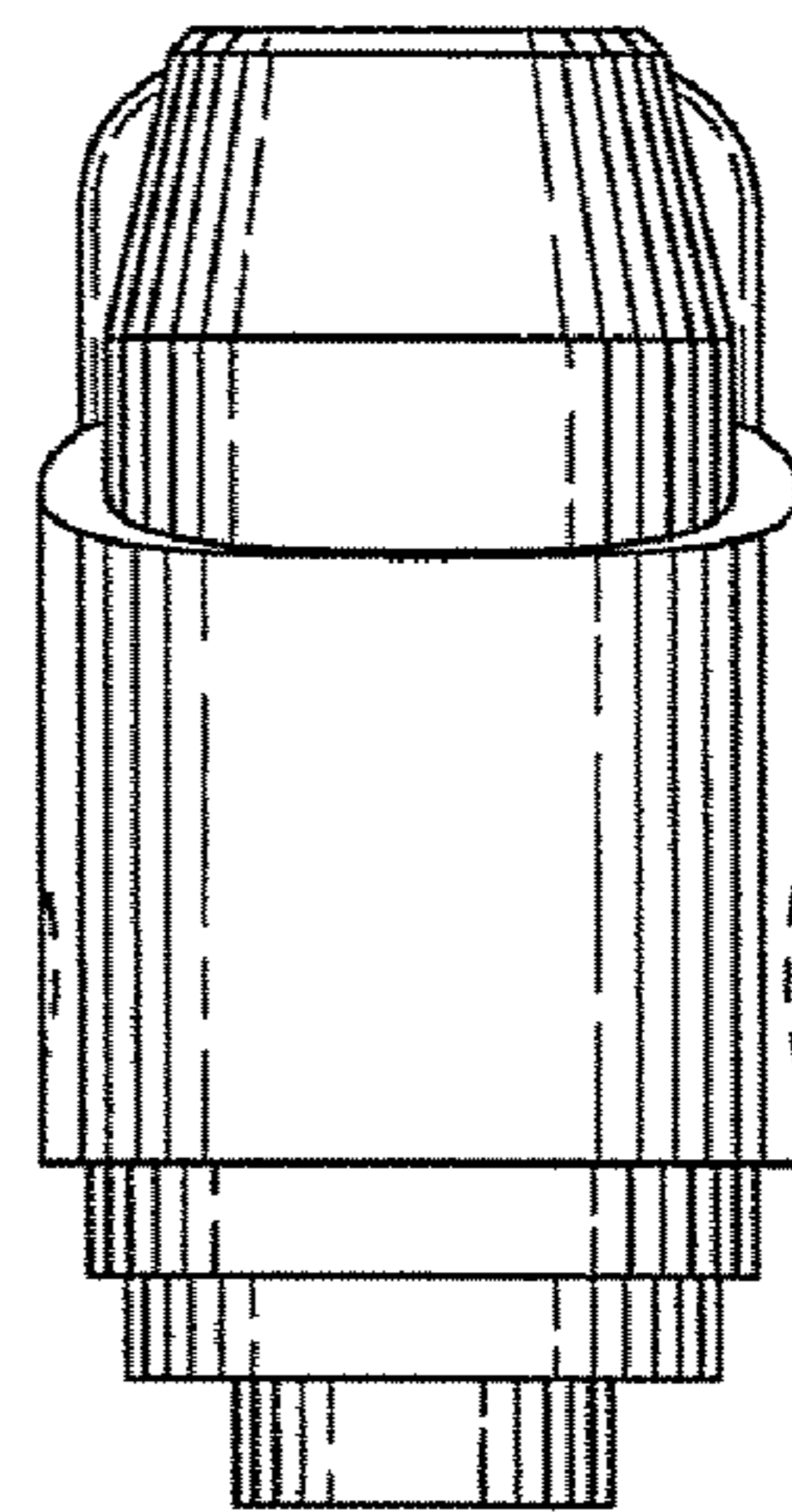

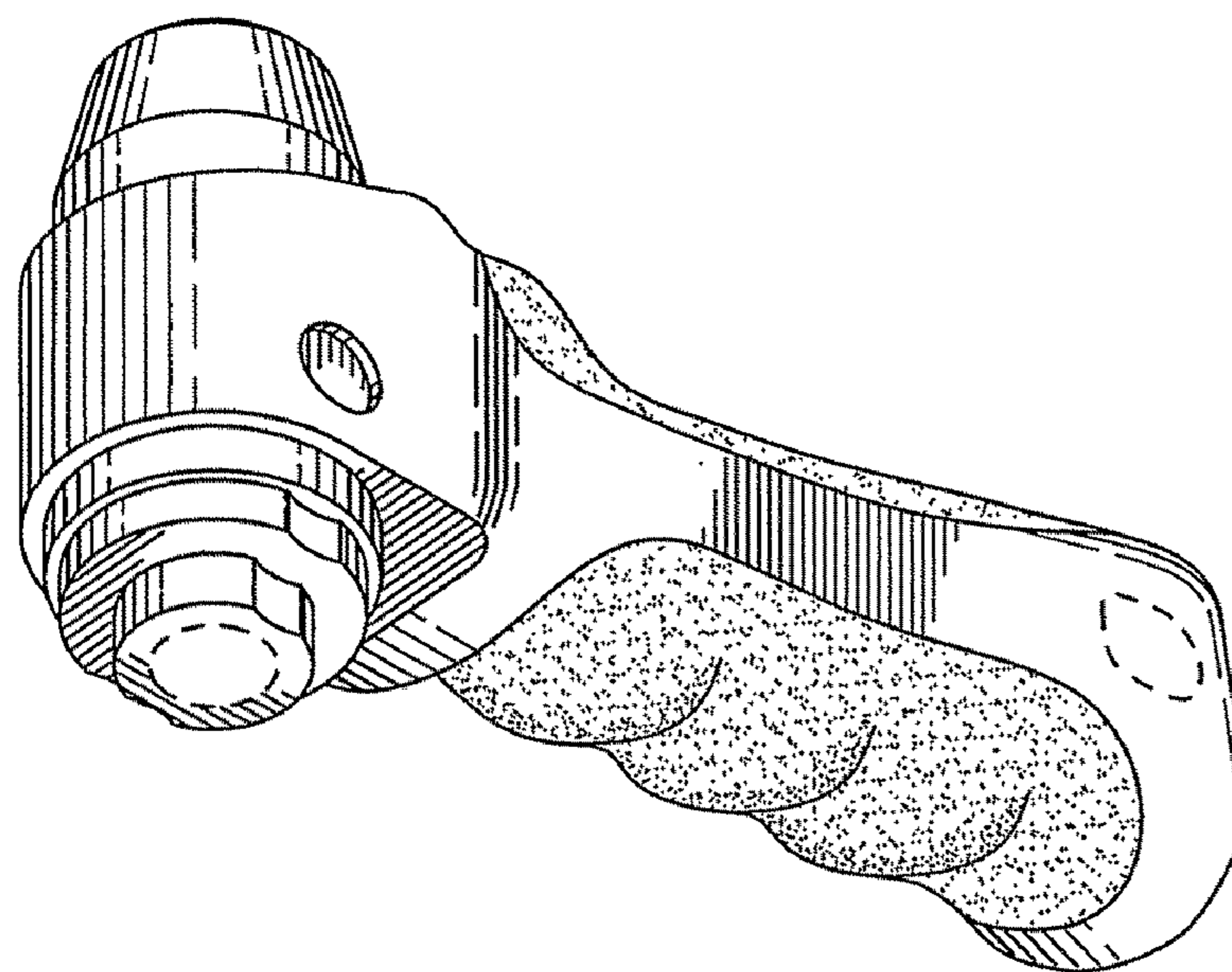
