The ornamental design for a twist lock plug, as shown and described.

DESCRIPTION

FIG. 1 is a rear and top perspective view of a twist lock plug showing my new design;

FIG. 2 is a front and bottom perspective view thereof;

FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image thereof;

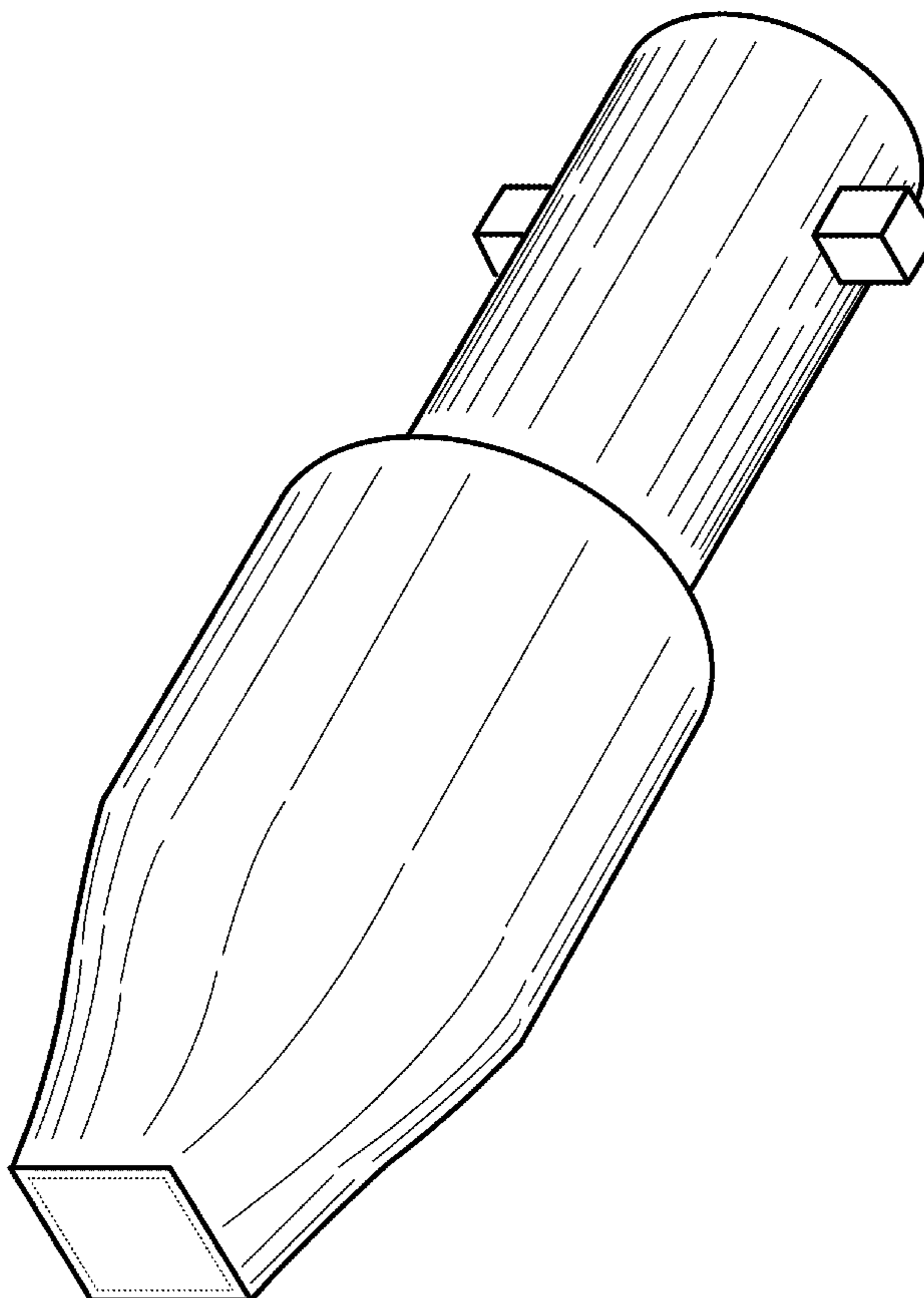
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

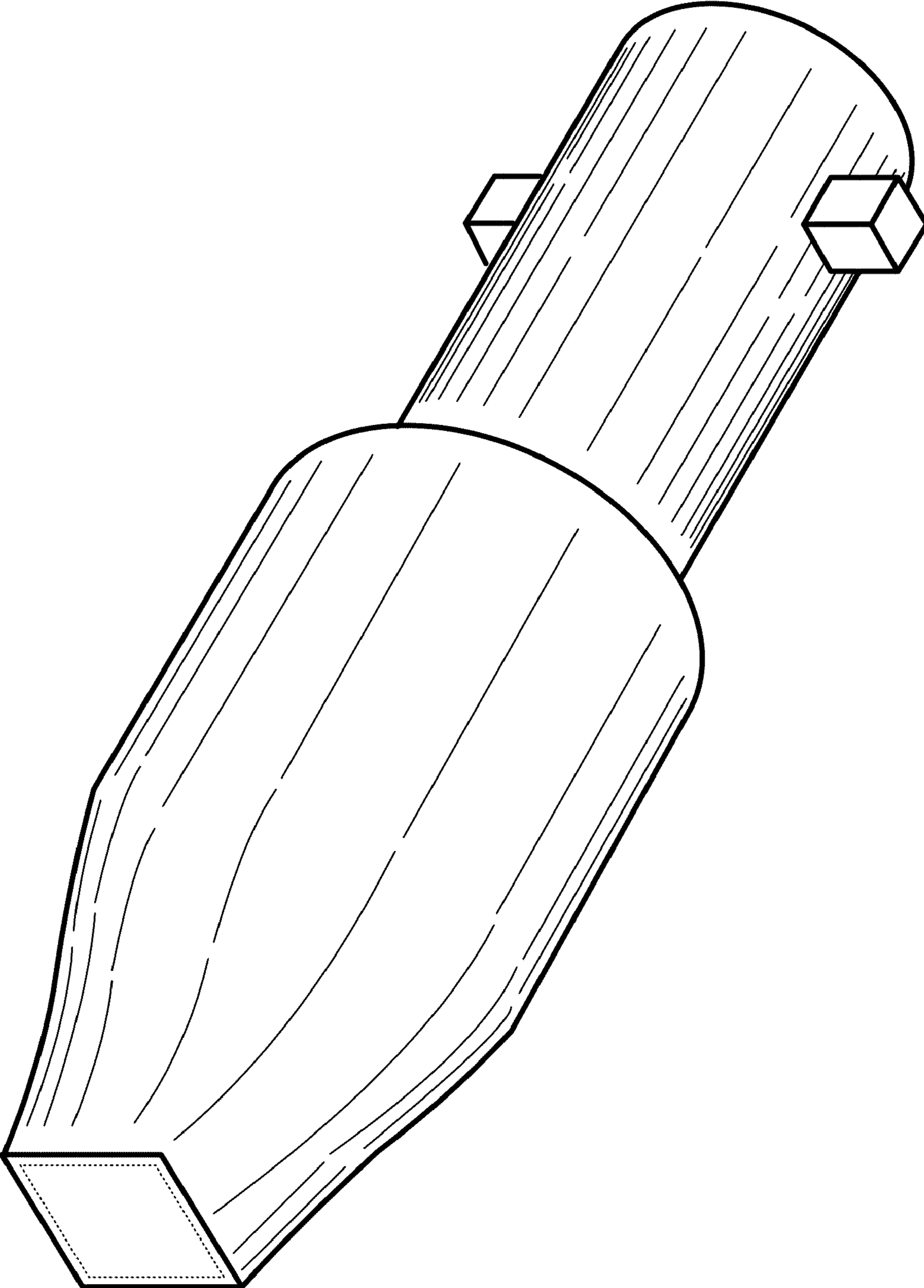

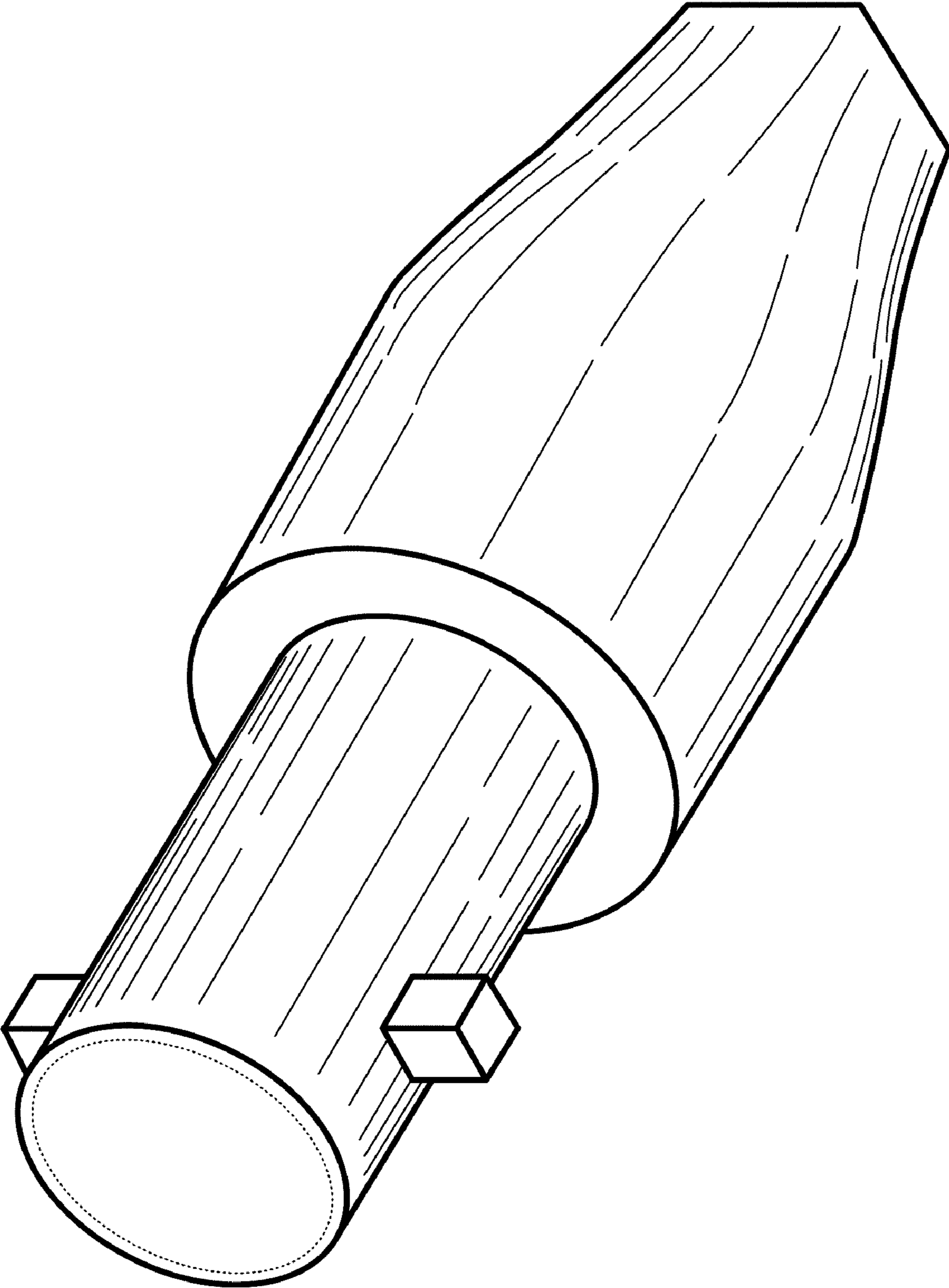

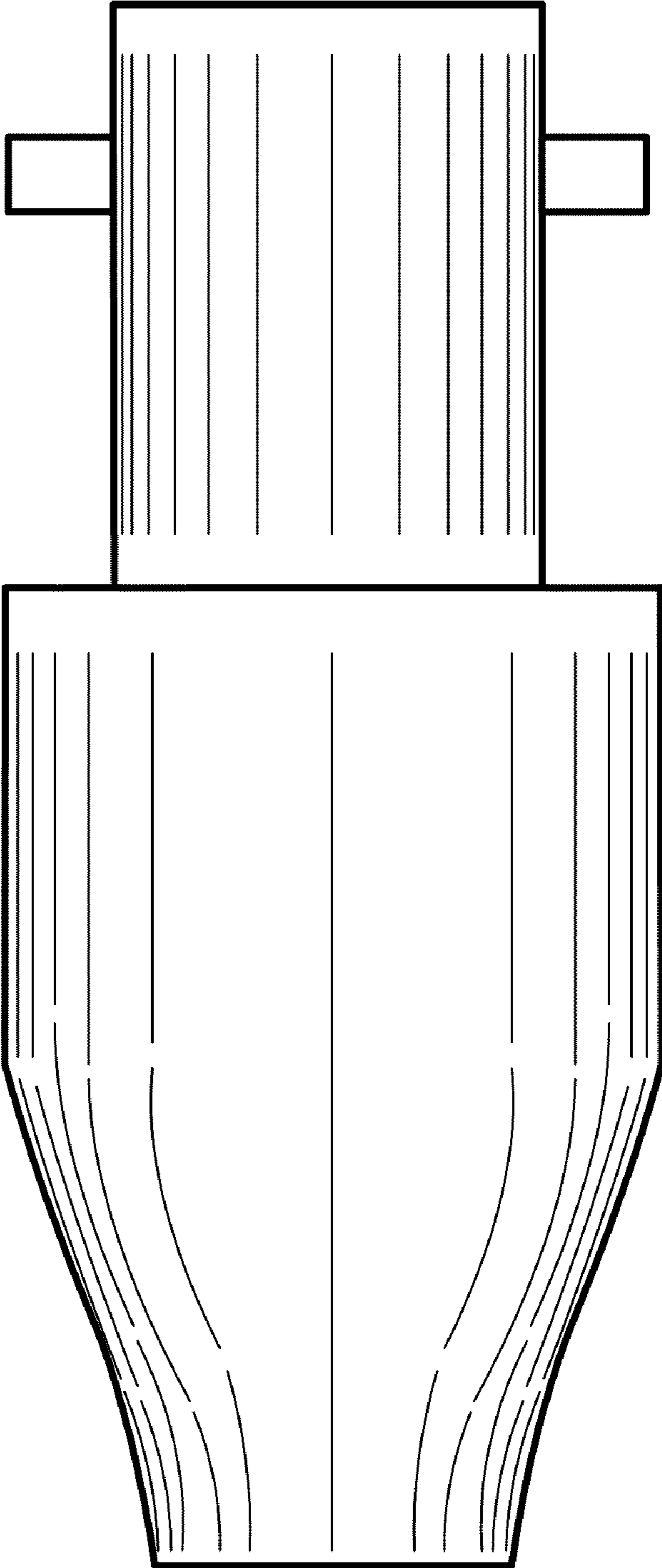

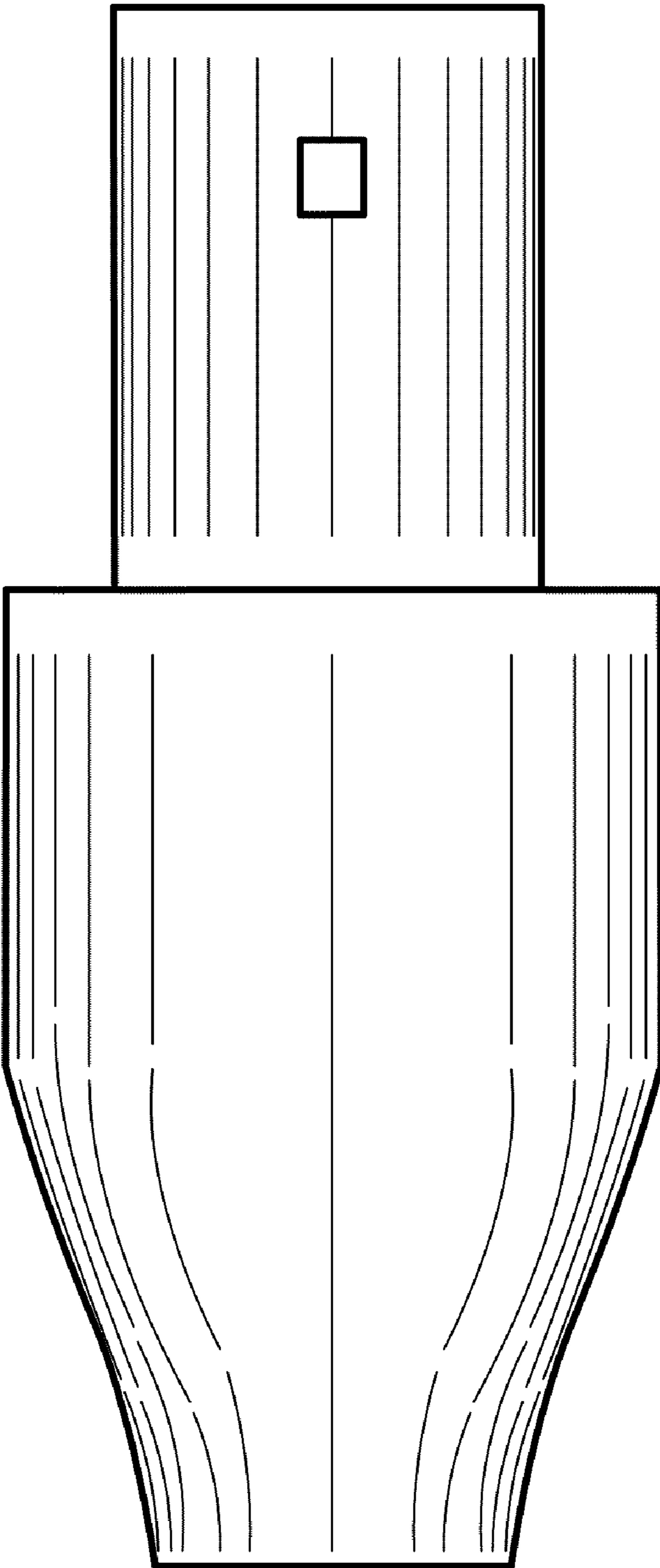

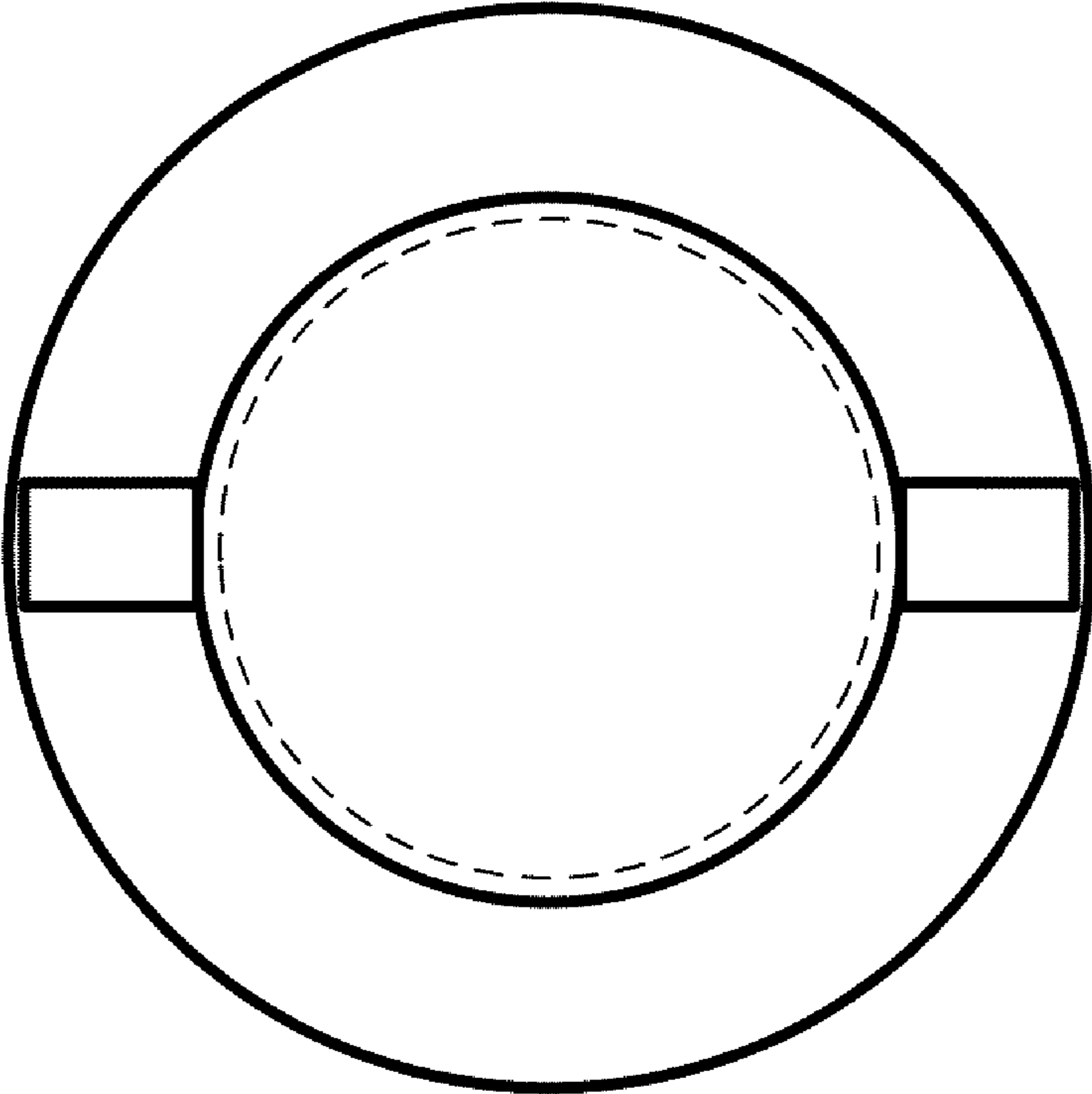

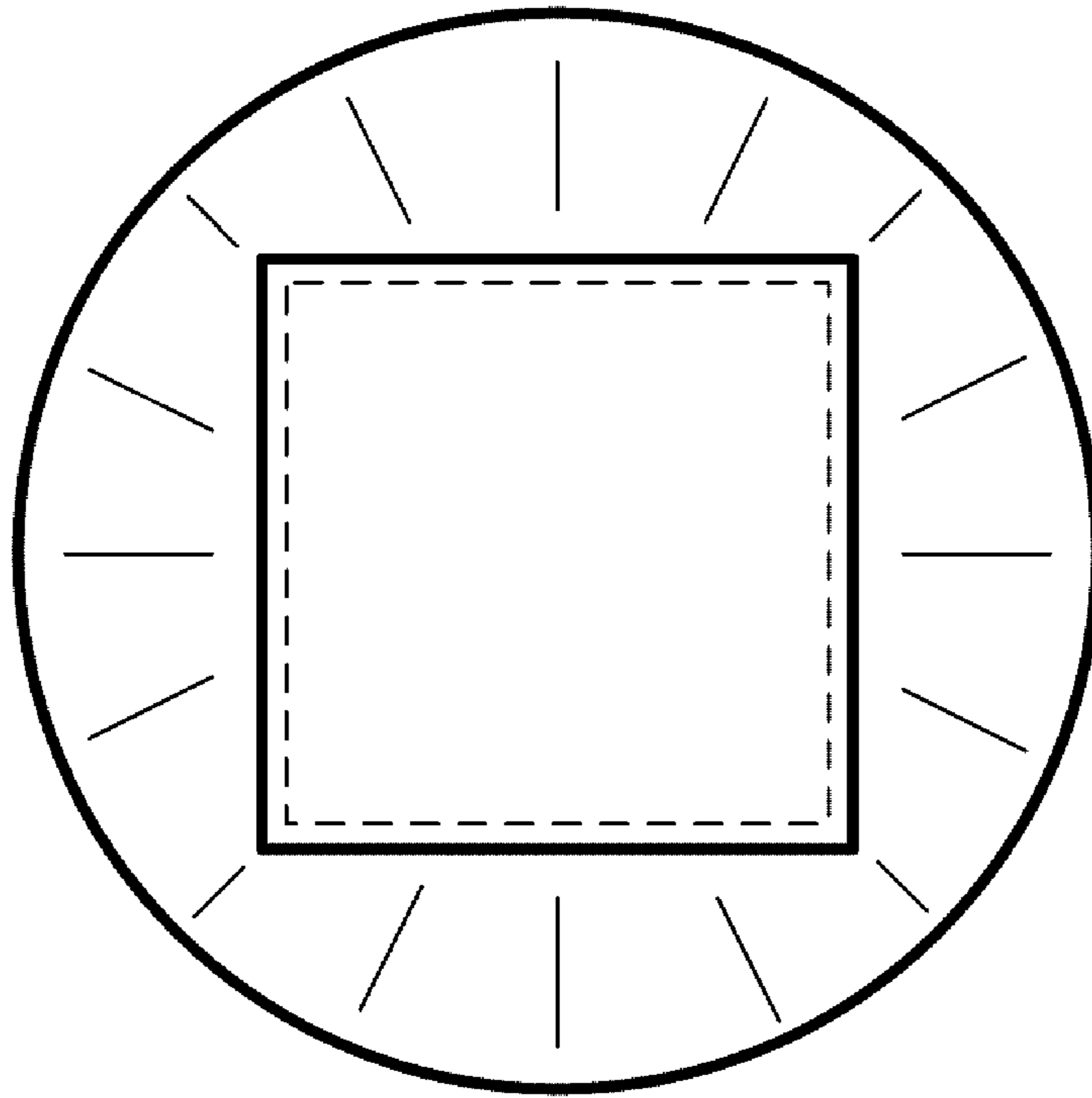
