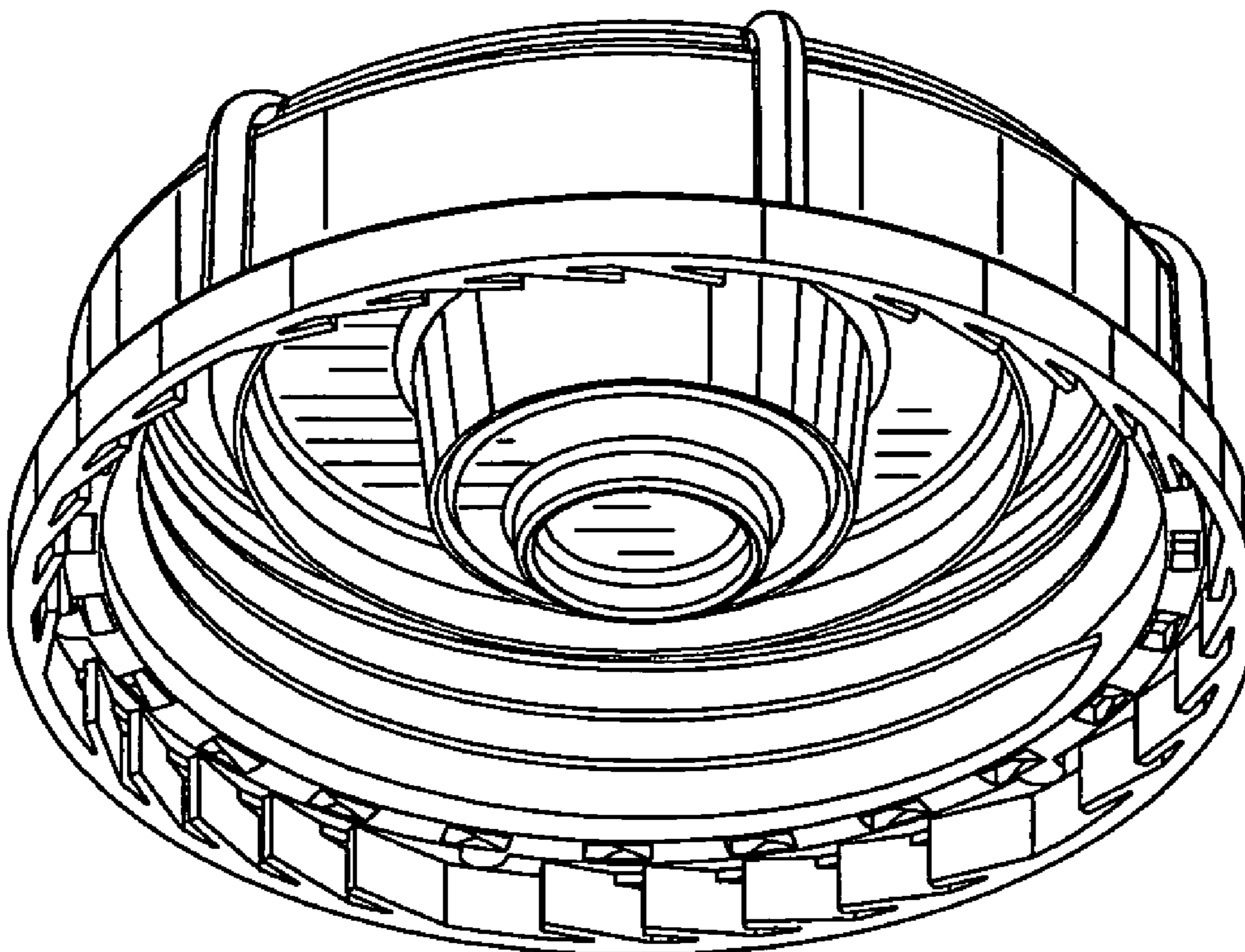
(57) **CLAIM**

The ornamental design for the tamper evident polymer screw cap with reducer and integral vent protector ring, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a tamper evident polymer screw cap with reducer and integral vent protector ring in accordance with my design; FIG. 2 is a top perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front elevation view thereof; the rear elevation view being the same; FIG. 6 is a right side view thereof; the left side view being the same; and, FIG. 7 is a sectional view thereof, taken on line 7-7 of FIG. 3.

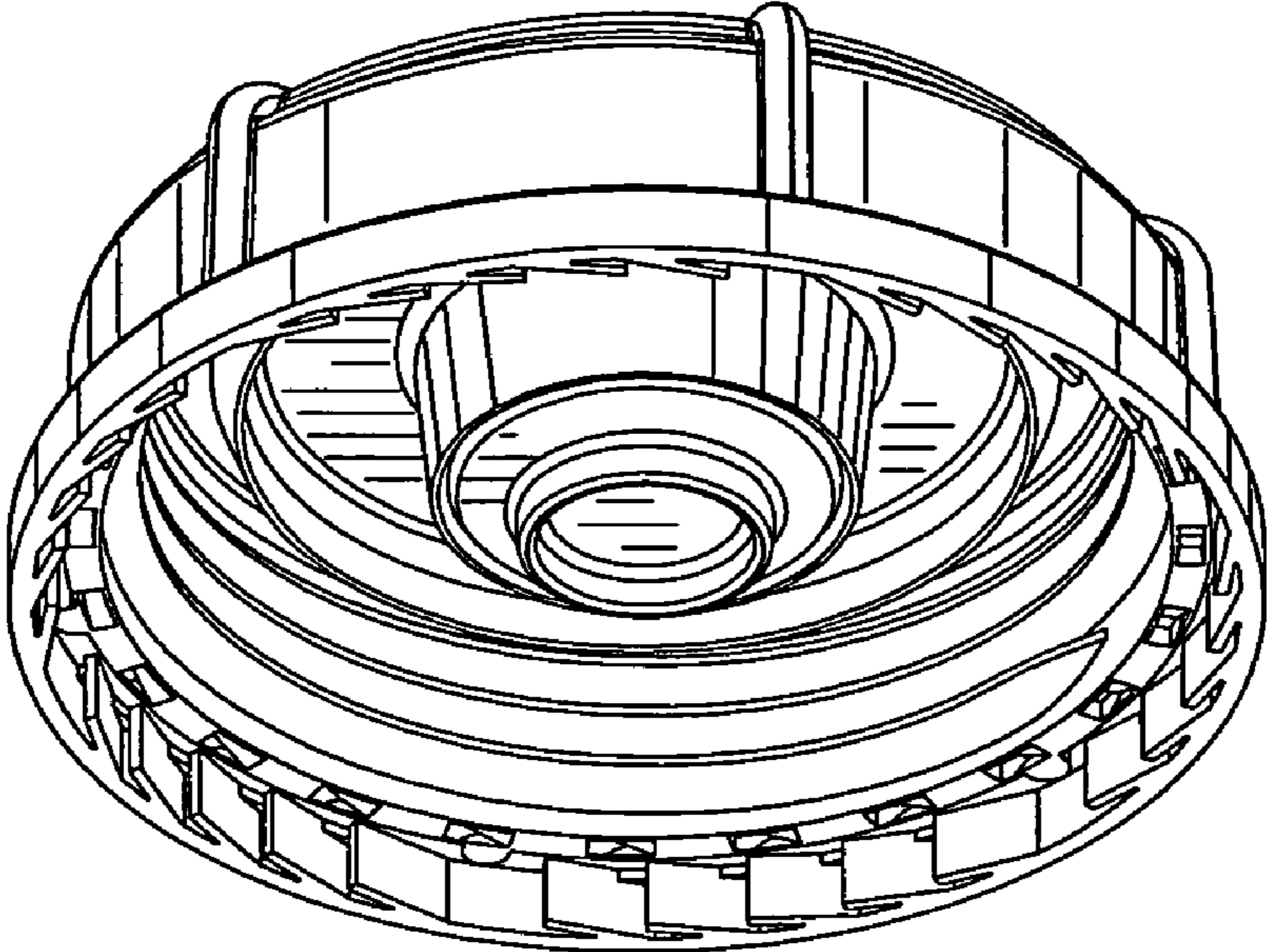

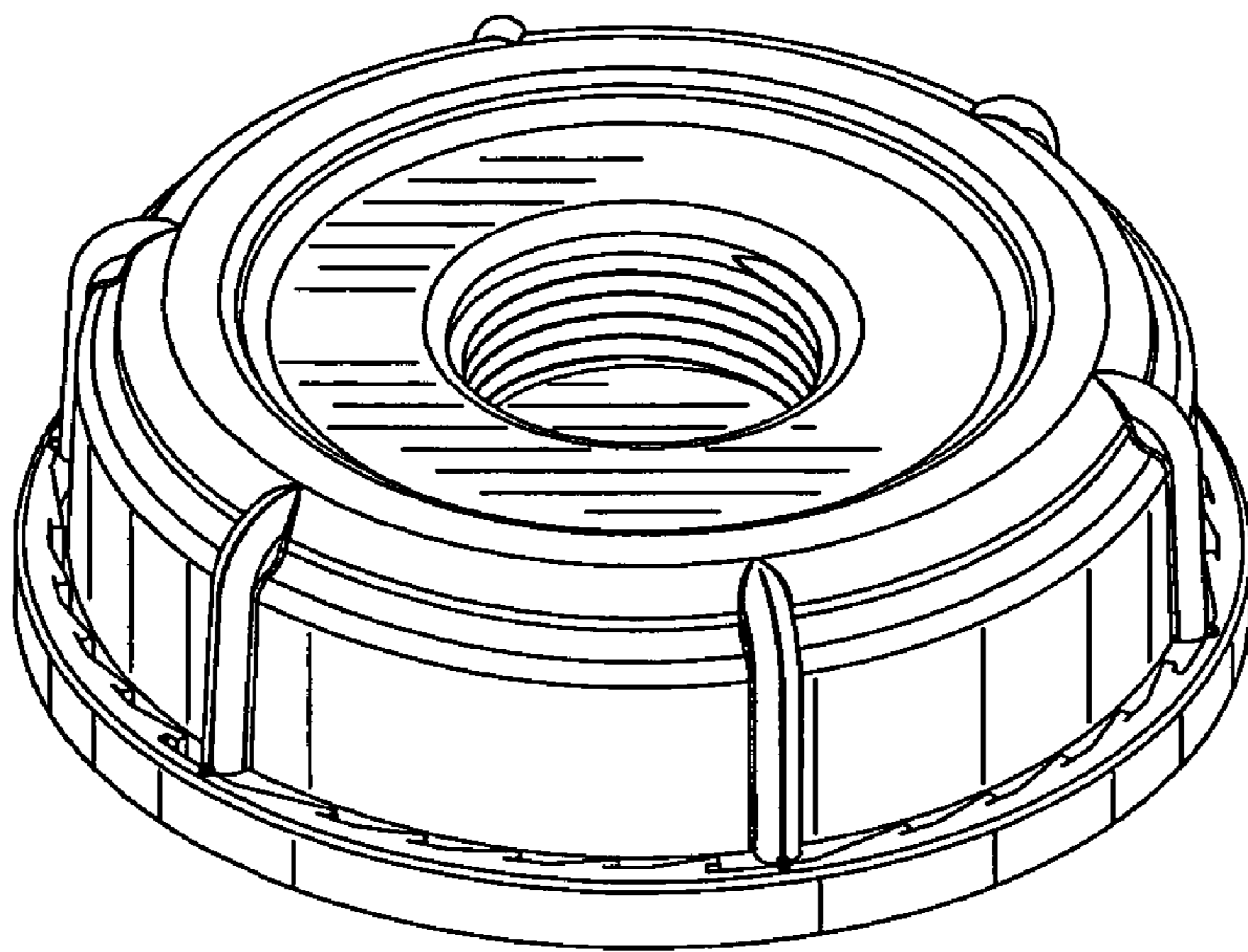

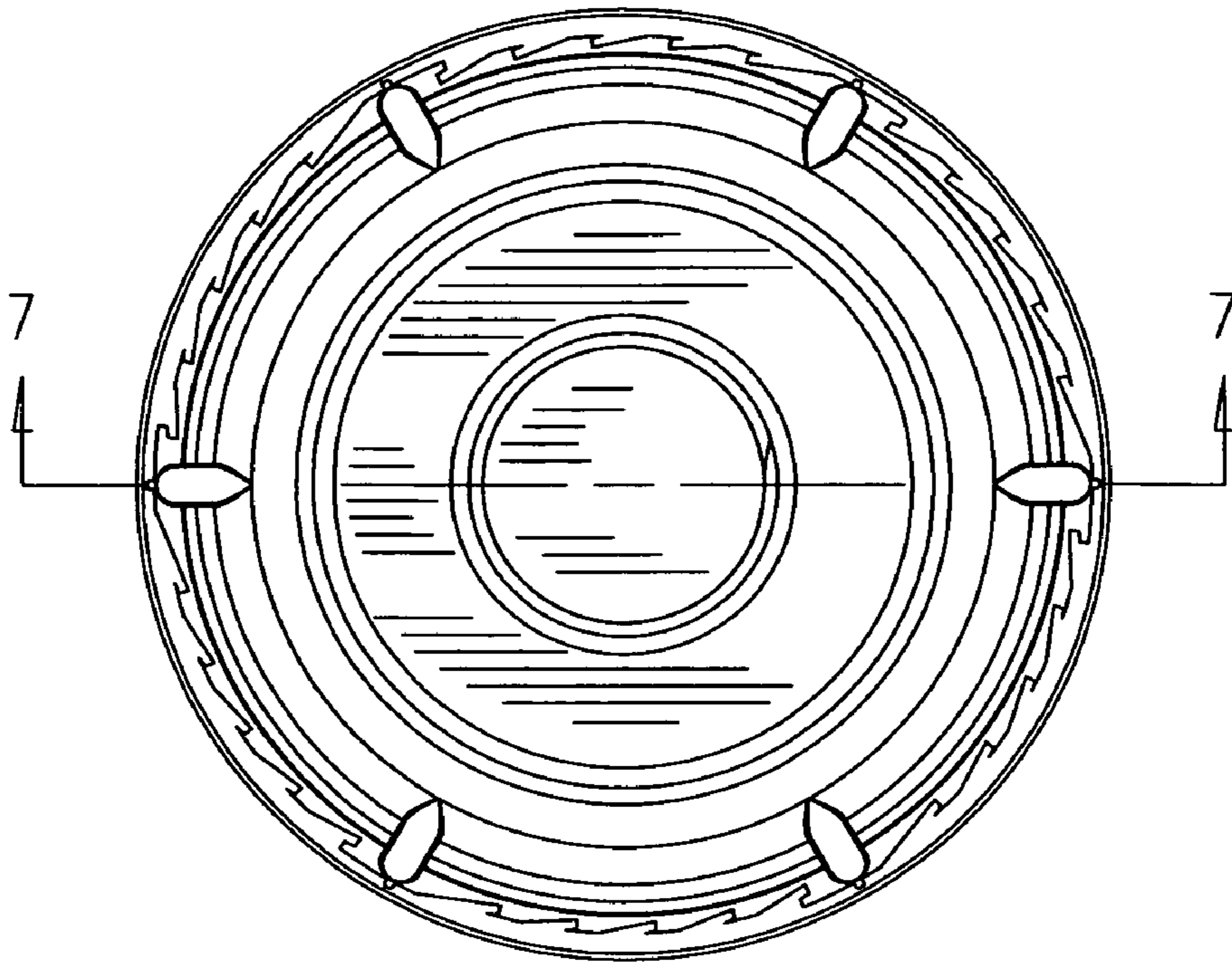

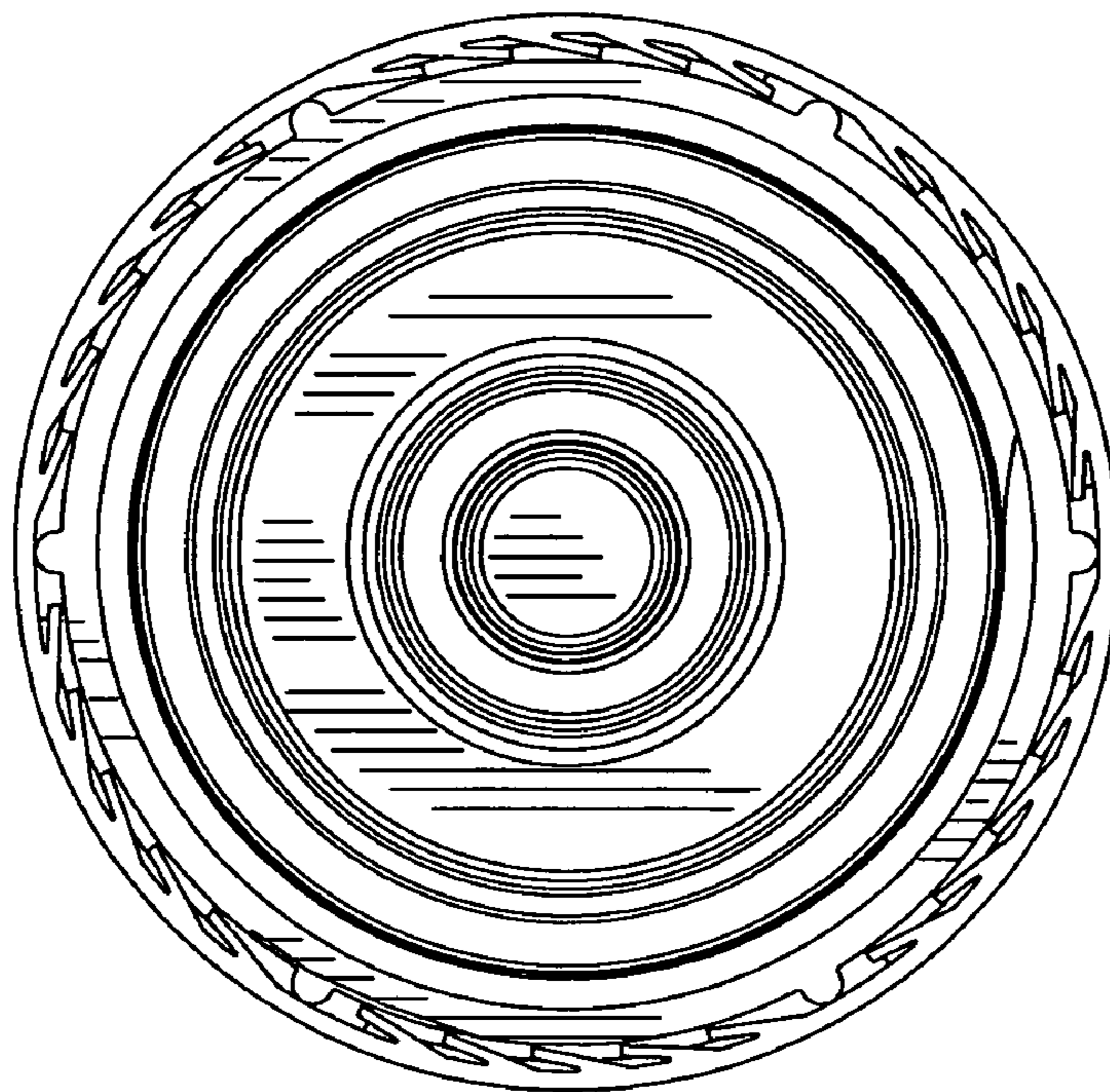

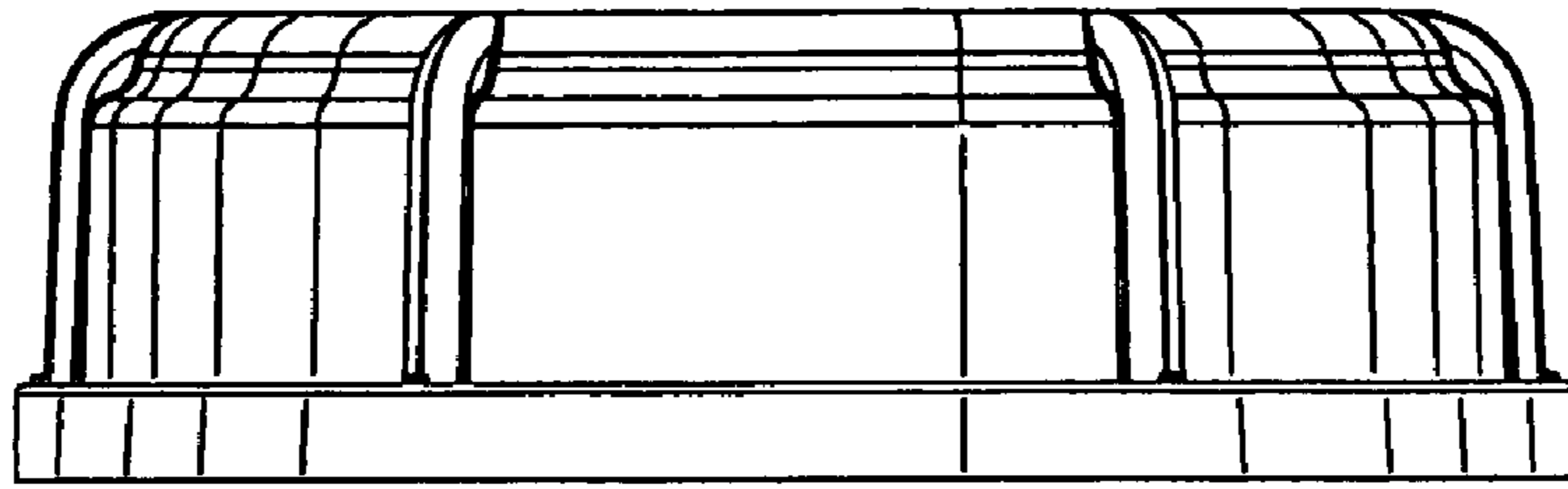

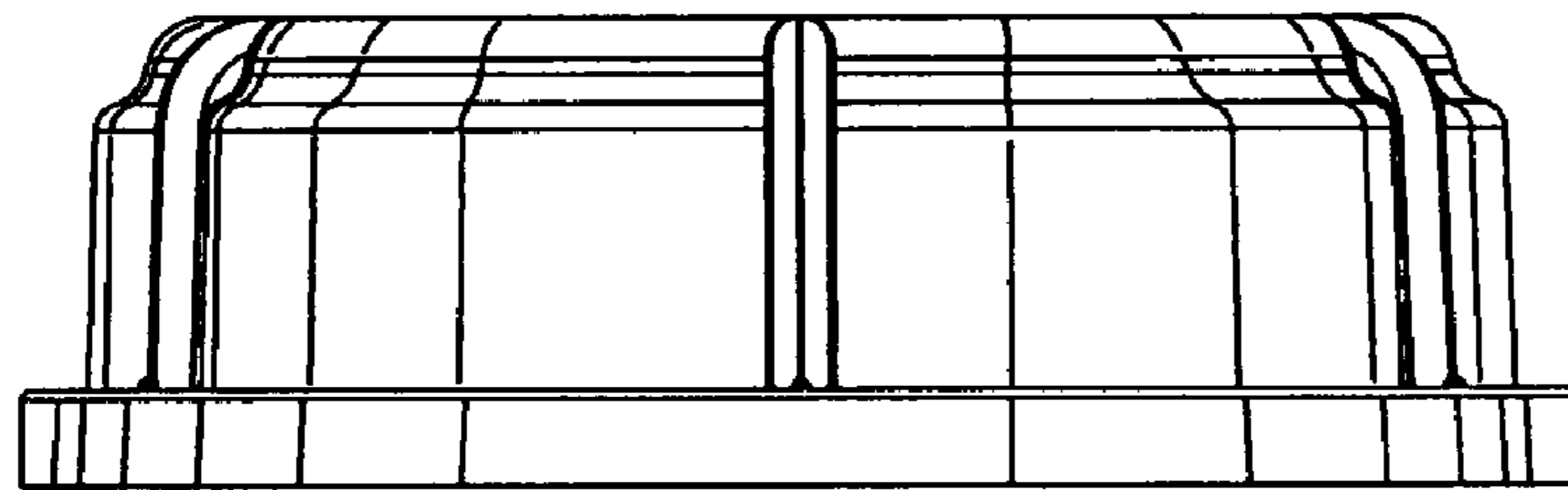

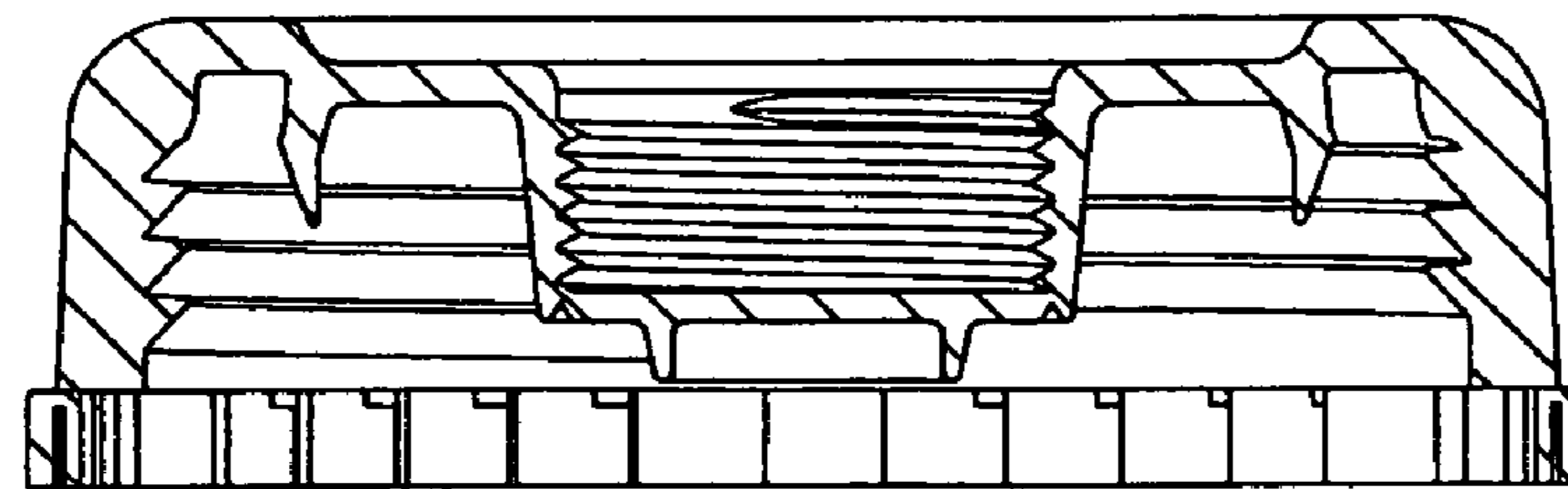
