FIG. 2 is front view thereof.

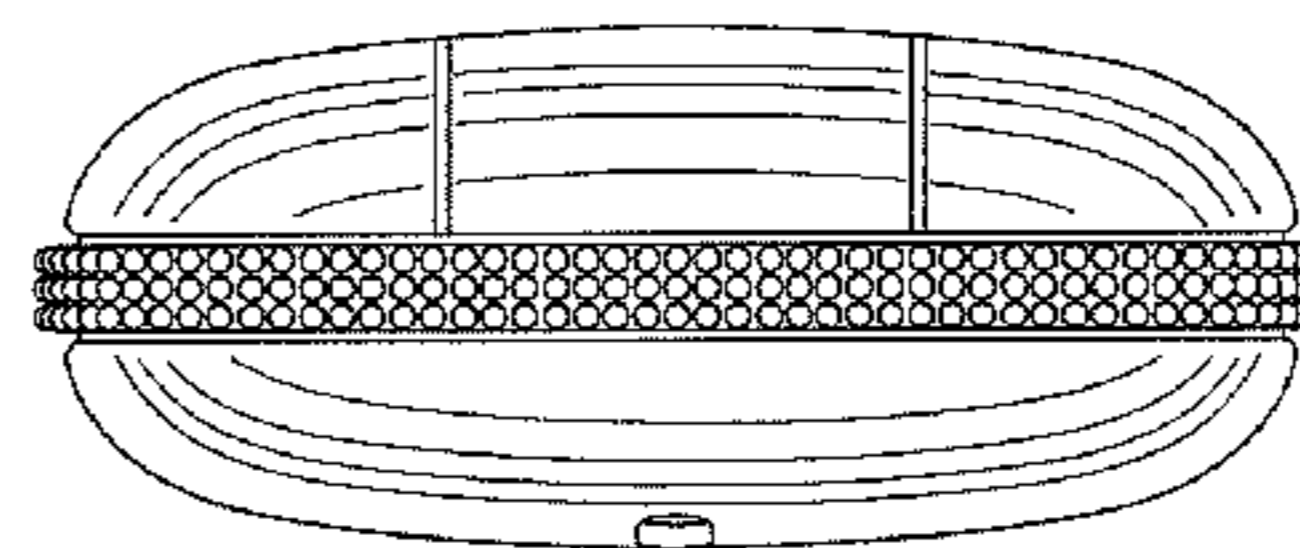
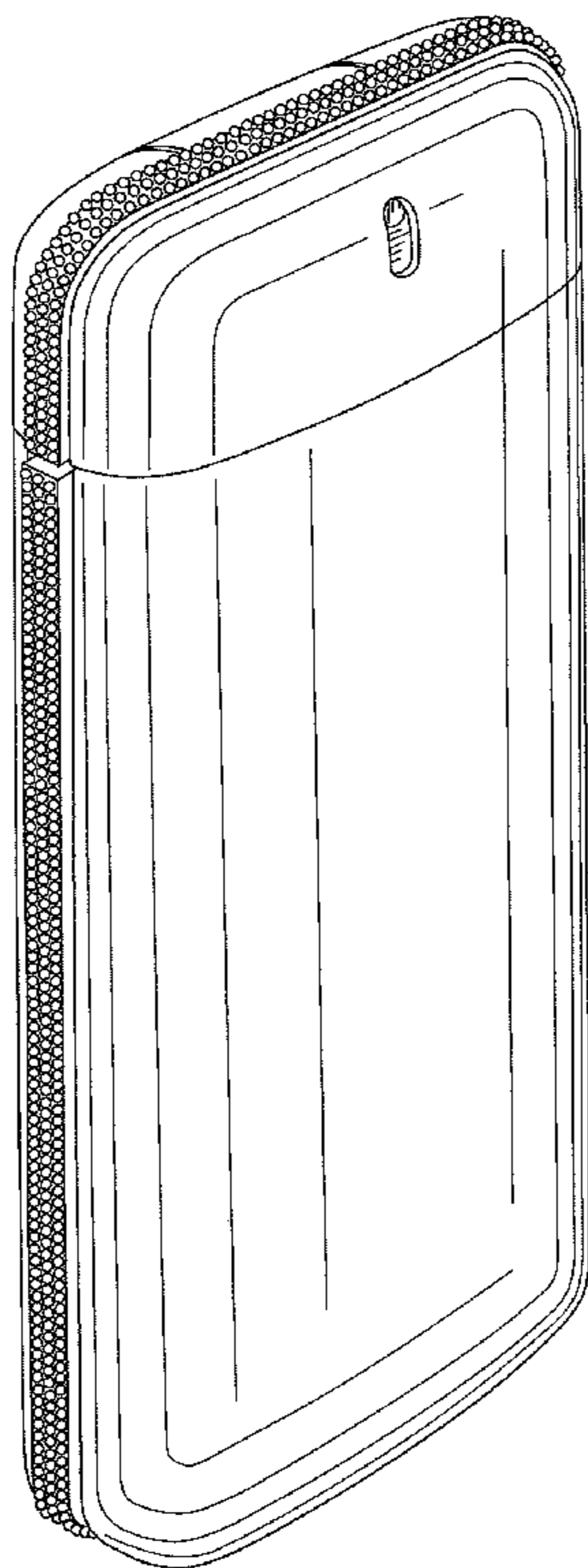
FIG. 3 is rear view thereof.

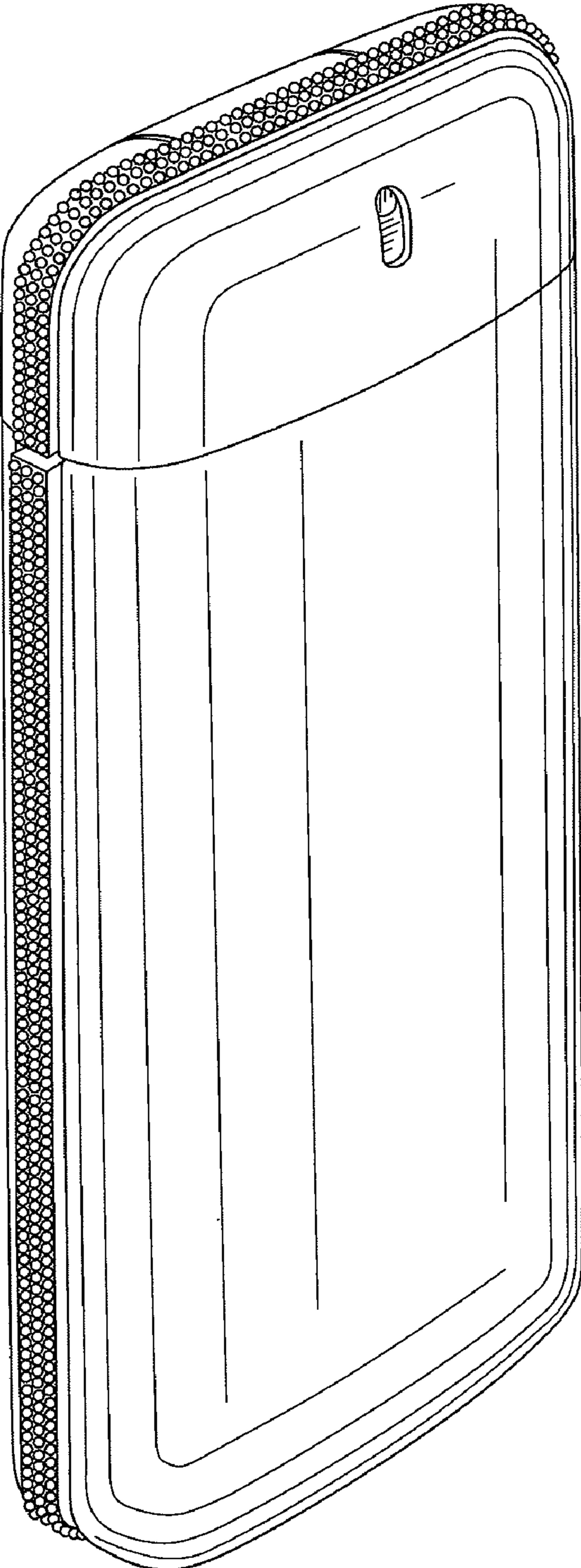

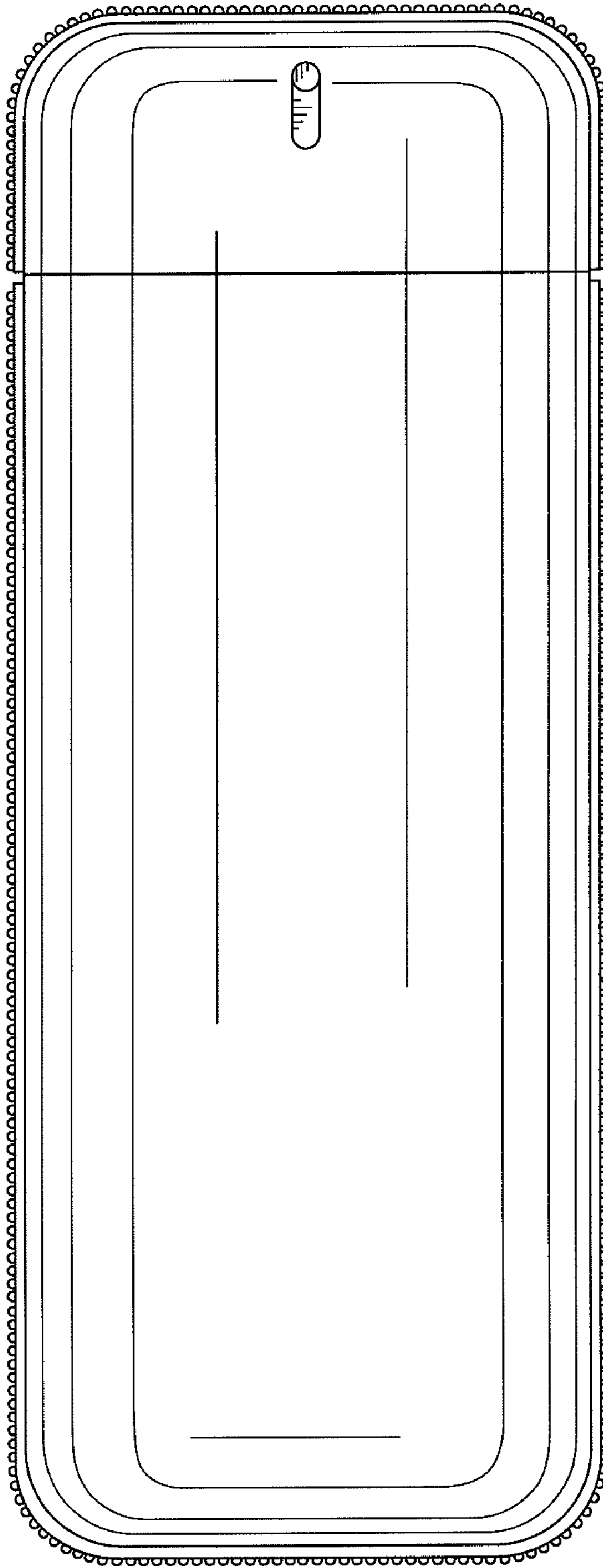

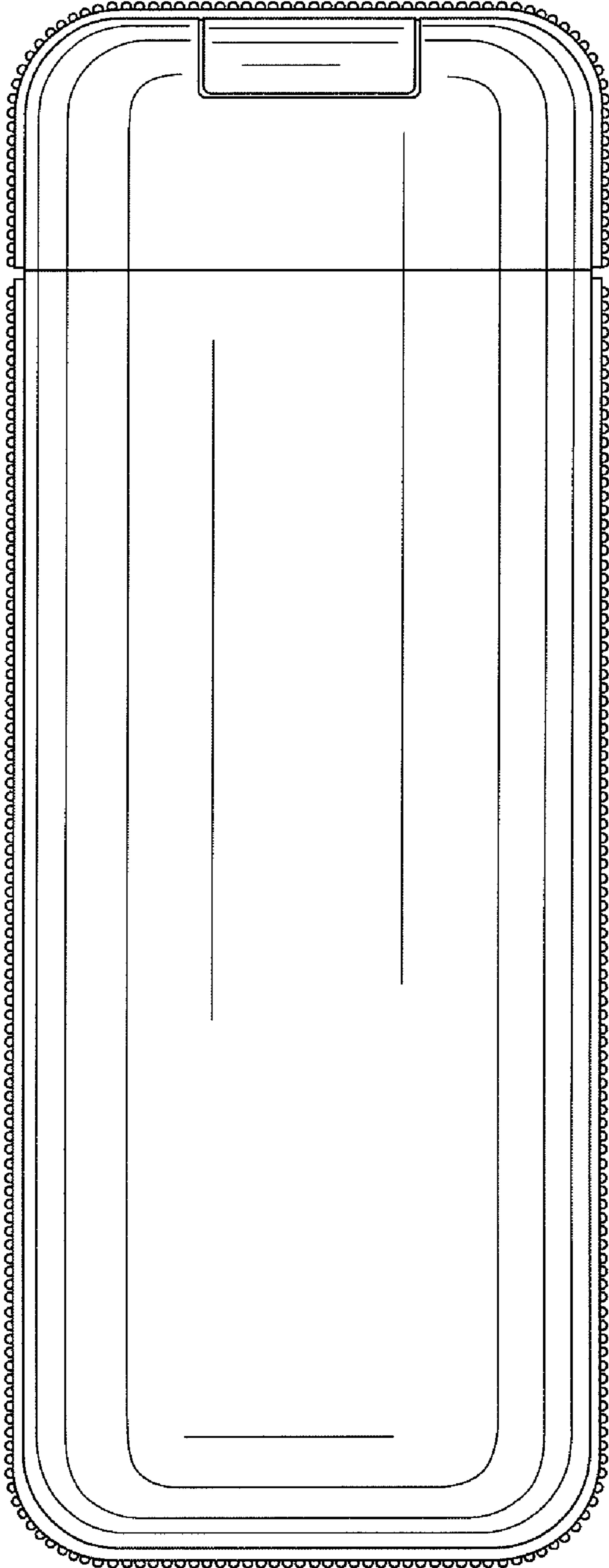

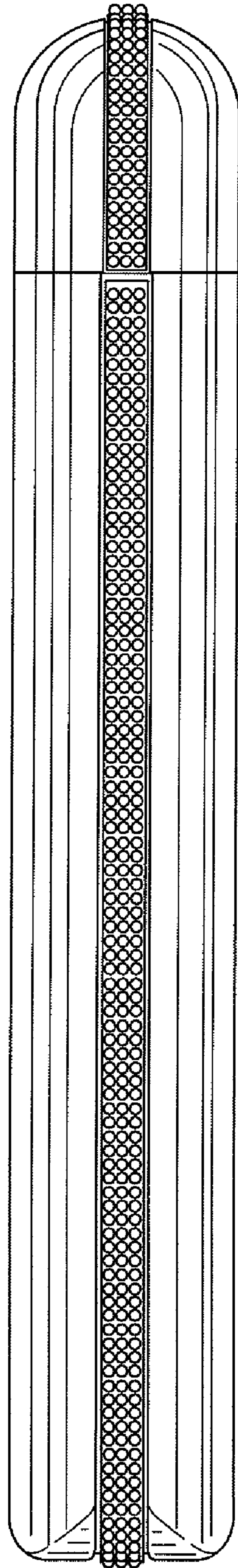

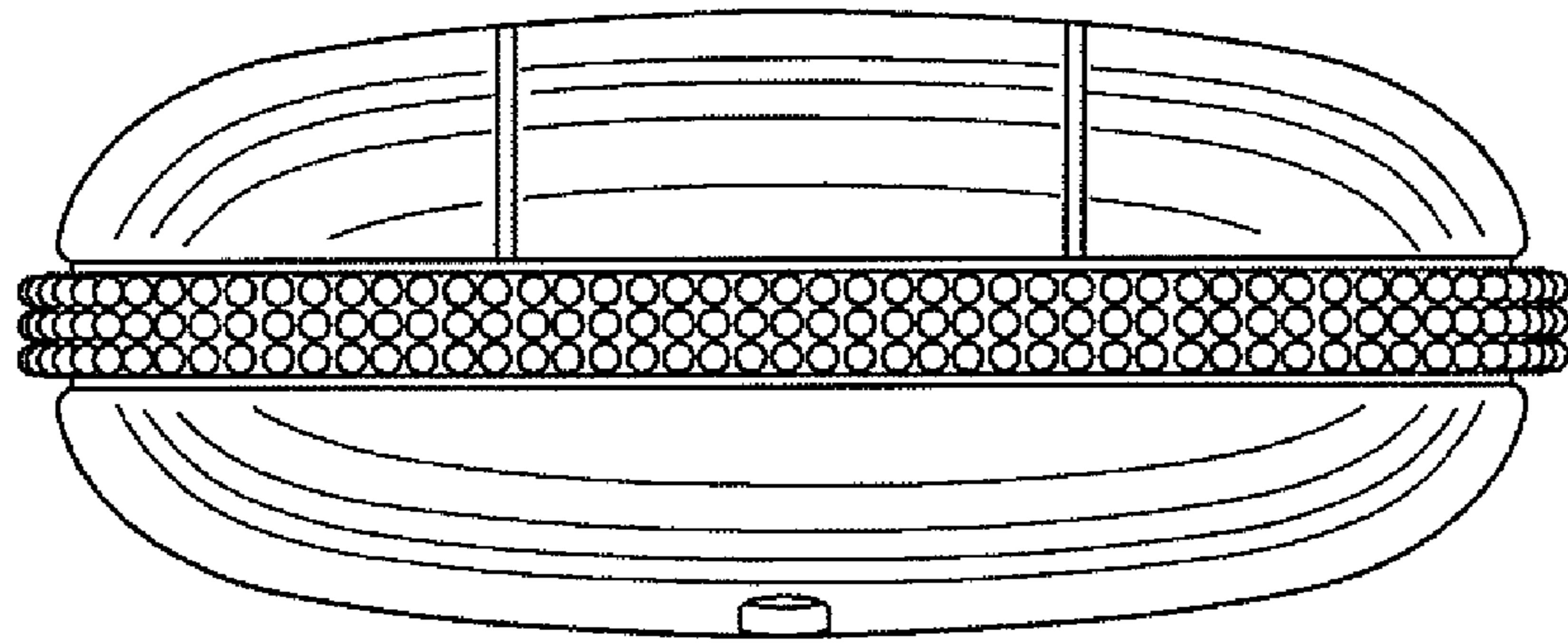

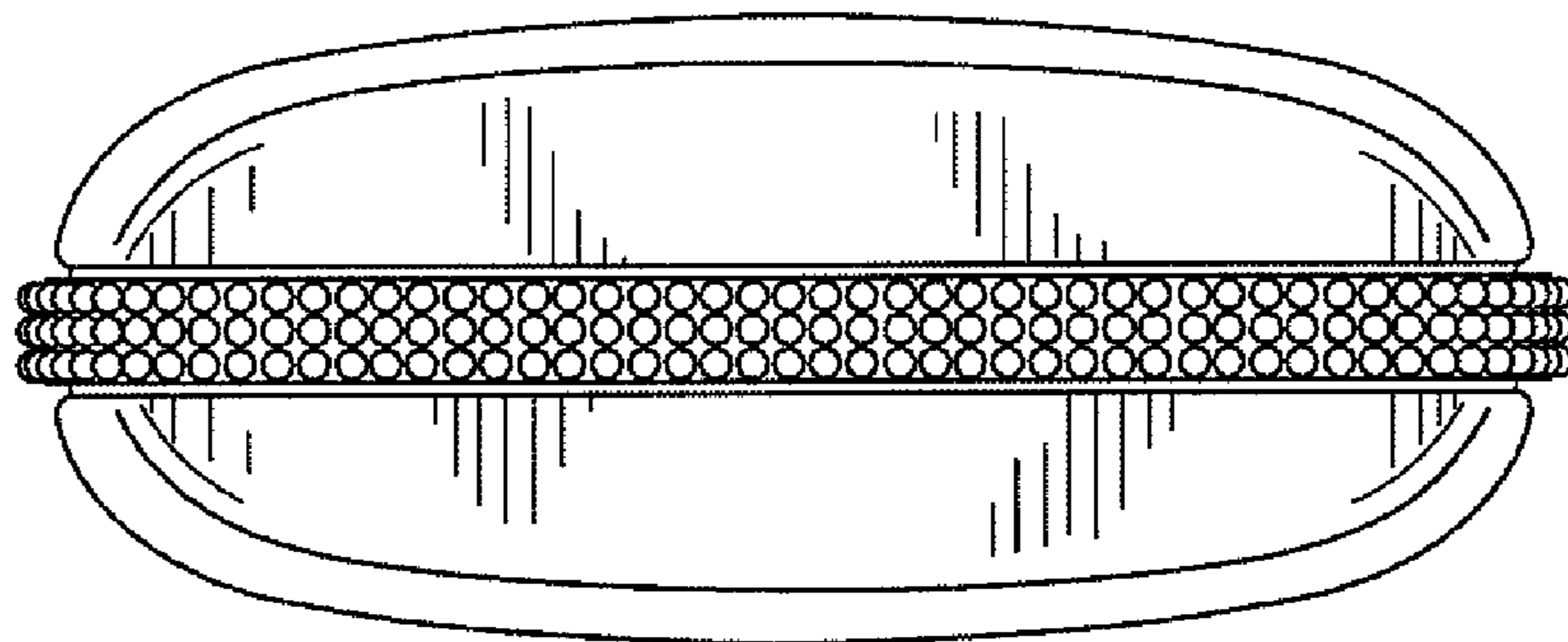
