We claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a container showing our new design;

FIG. 2 is a top plan view of the container of FIG. 1;

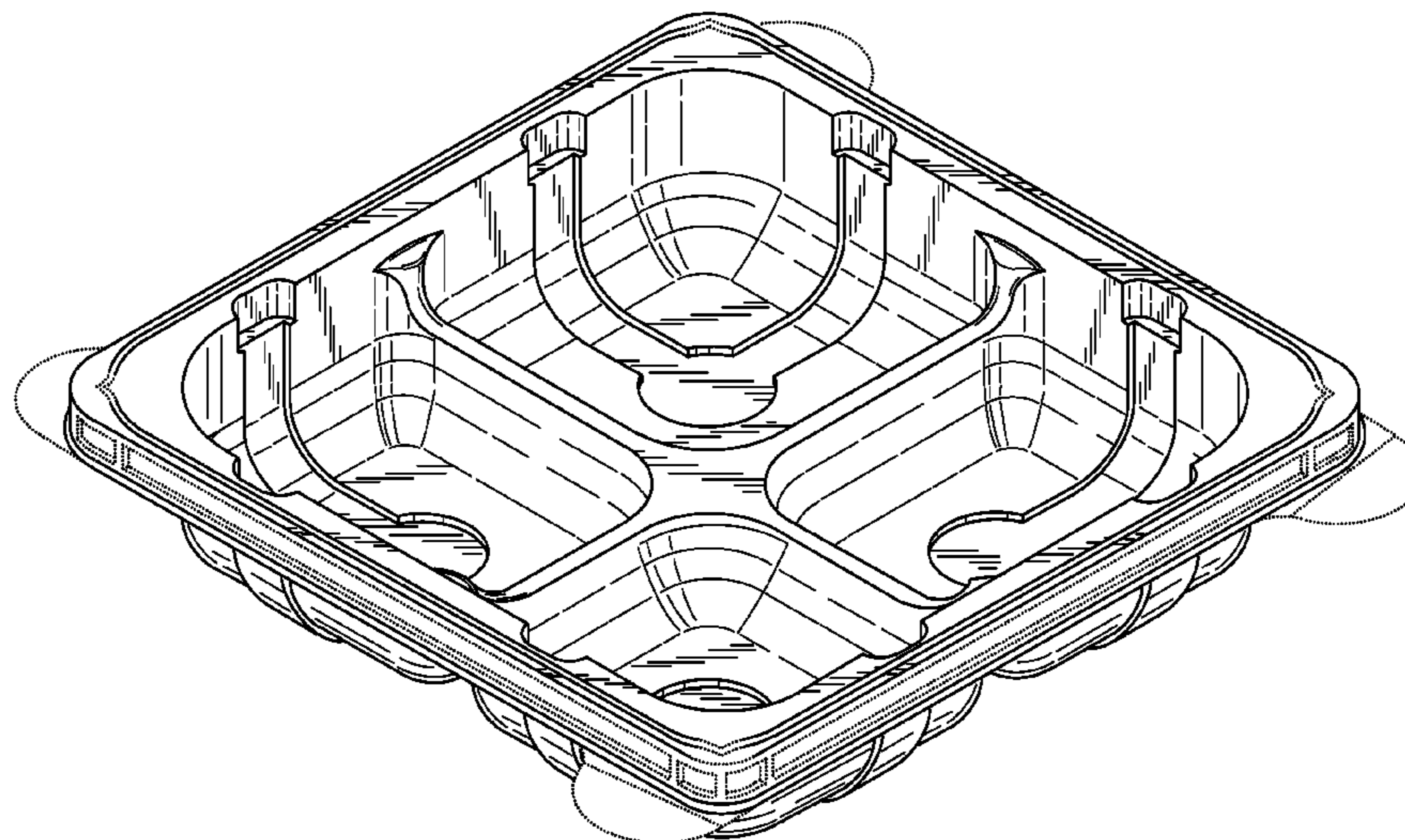
FIG. 3 is a bottom plan view of the container of FIG. 1;

FIG. 4 is a front elevational view of the container of FIG. 1, the back elevational view being identical thereto; and,

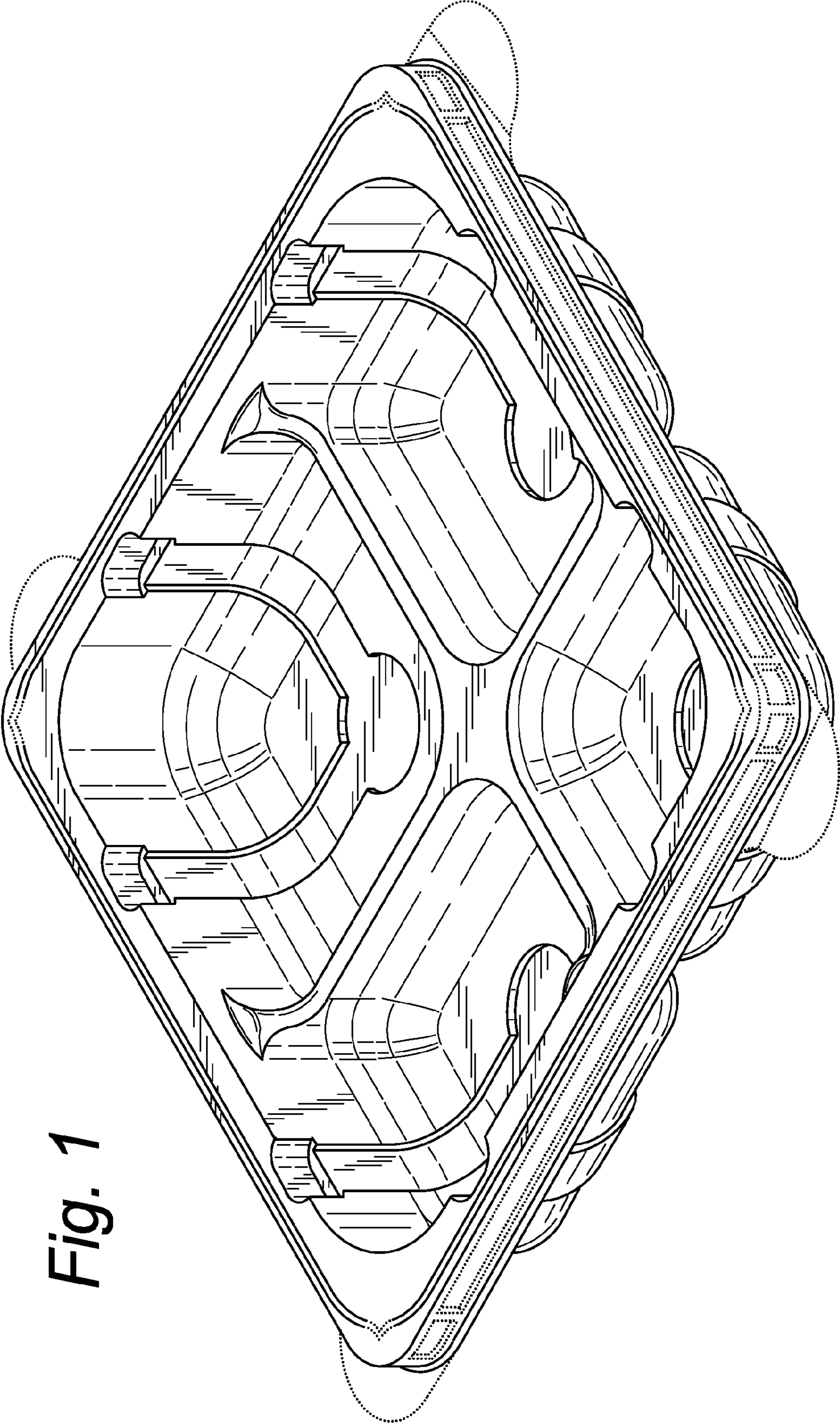
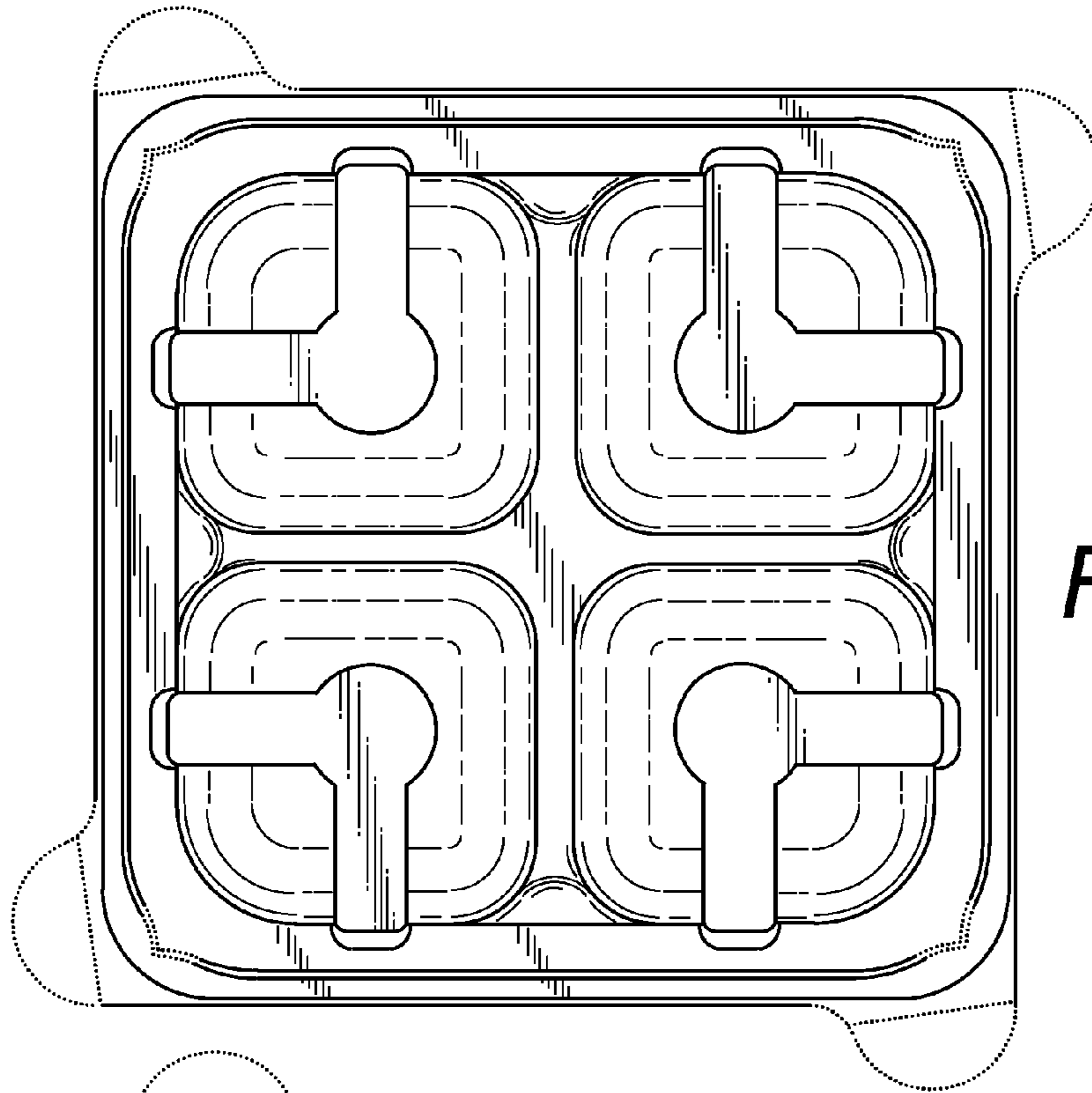
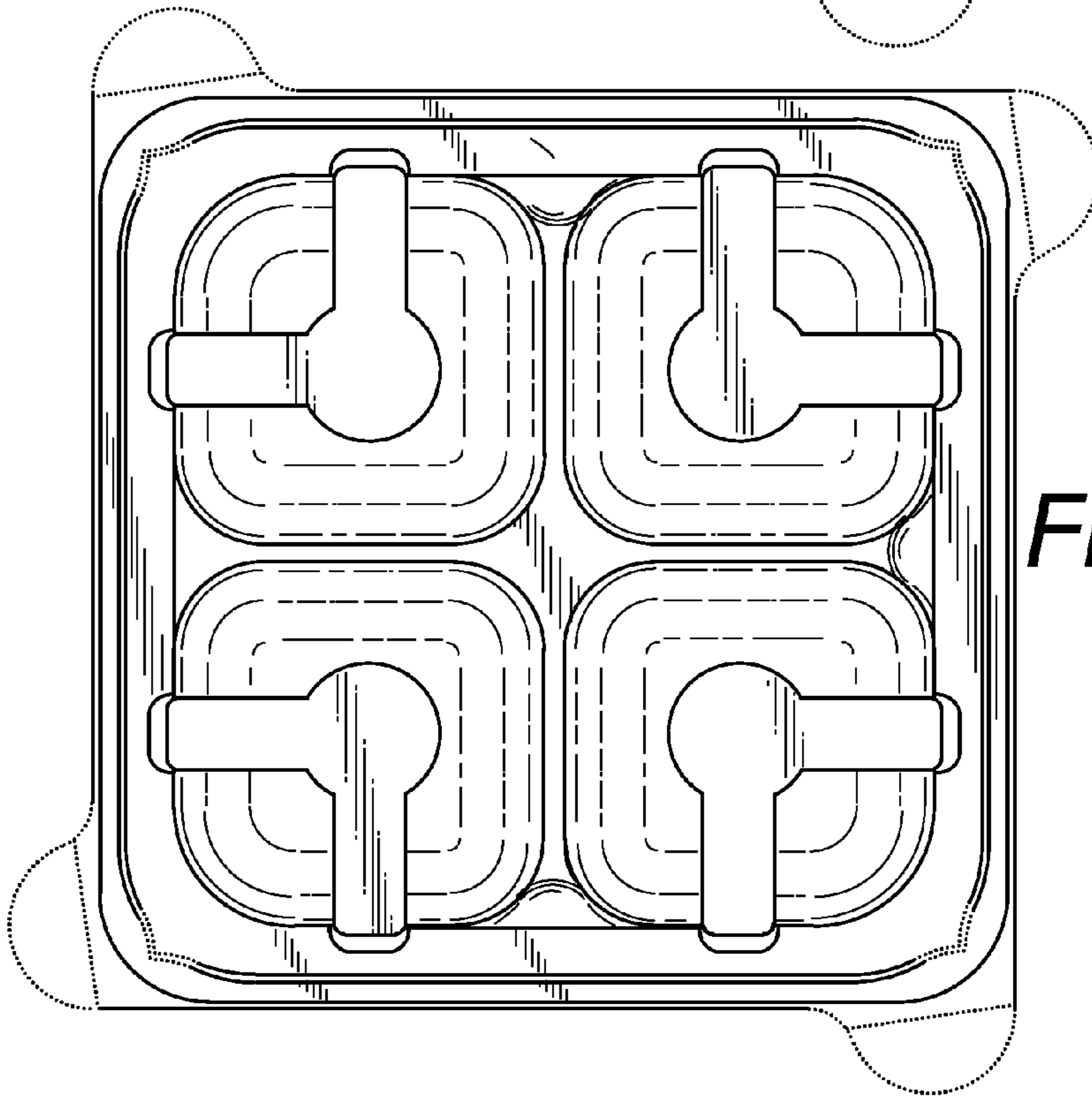


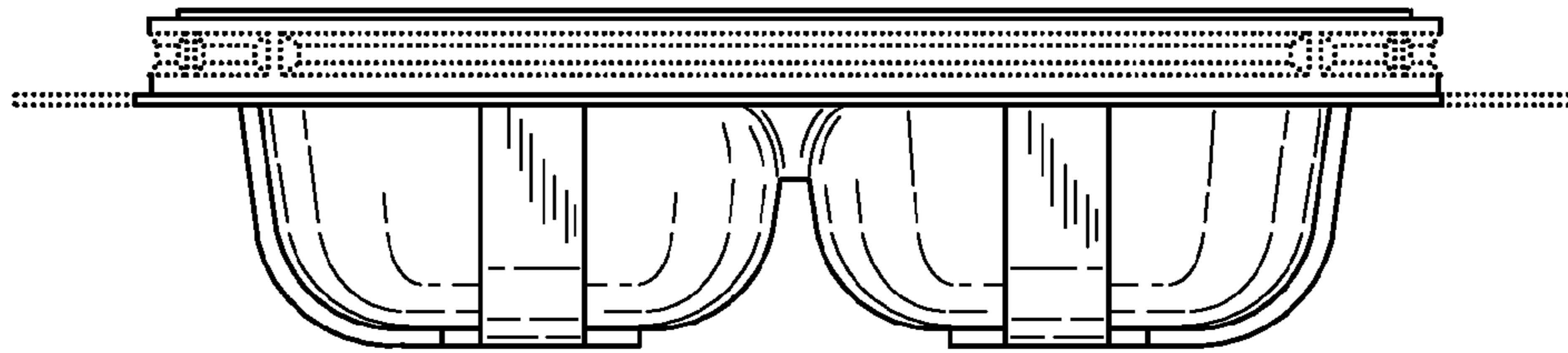

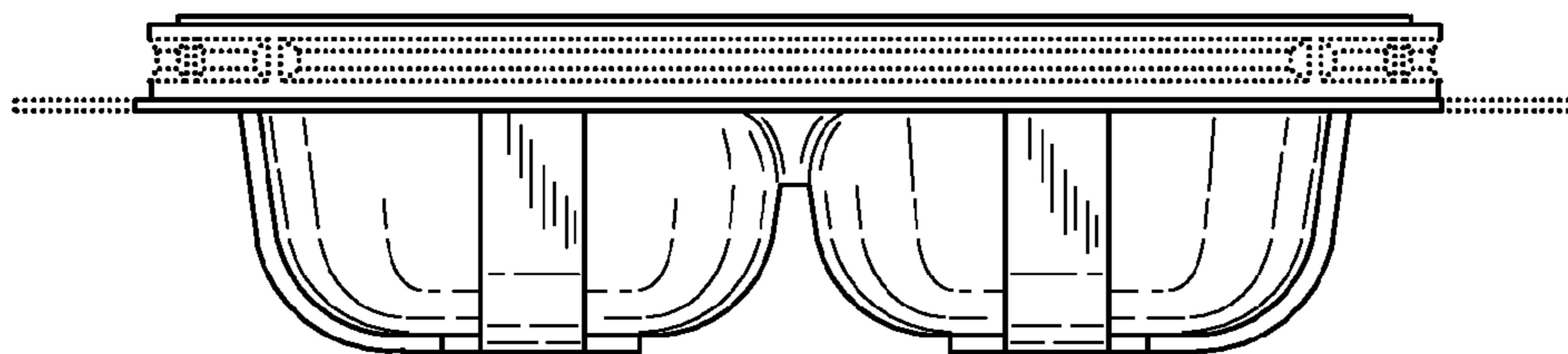
