DESCRIPTION

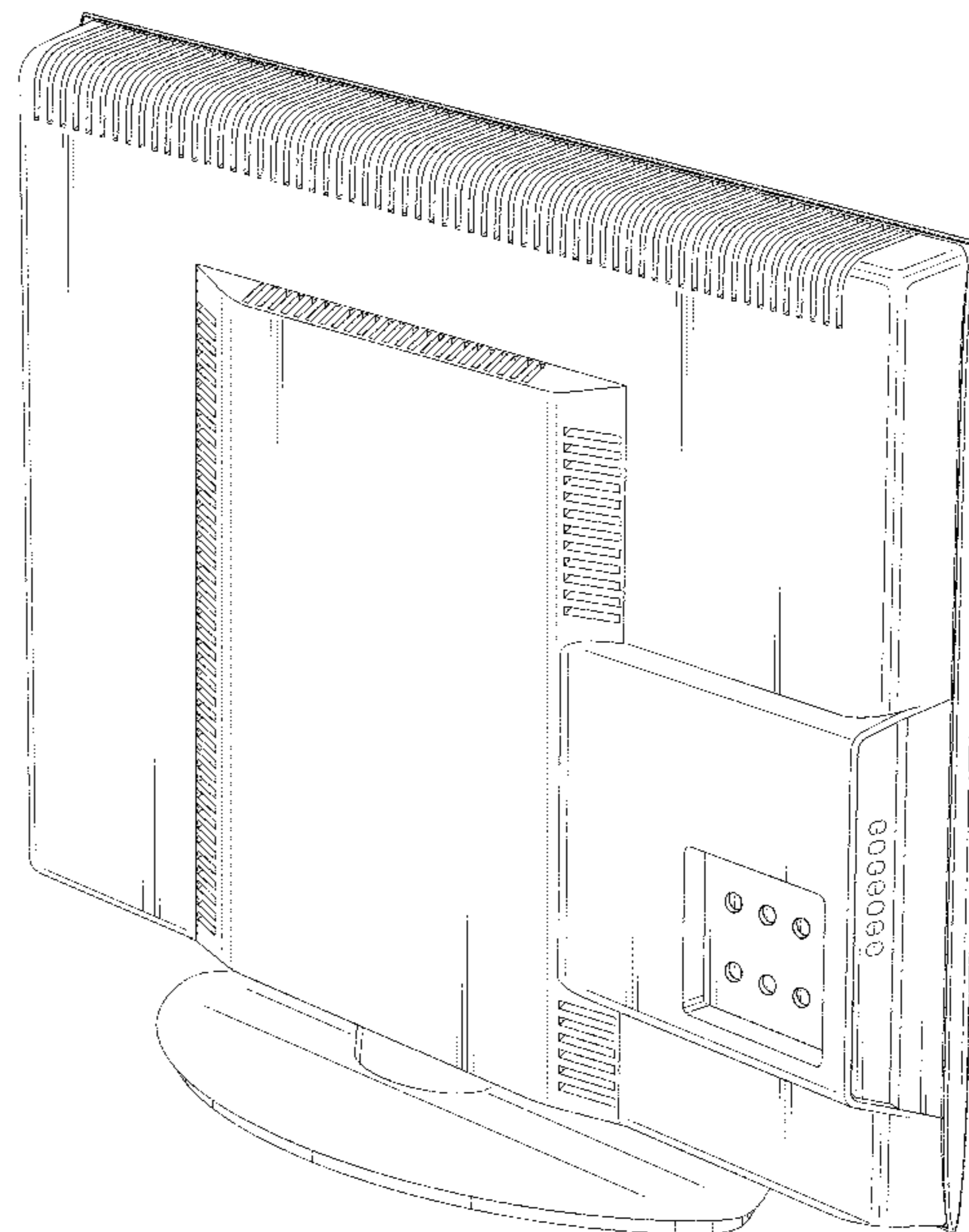
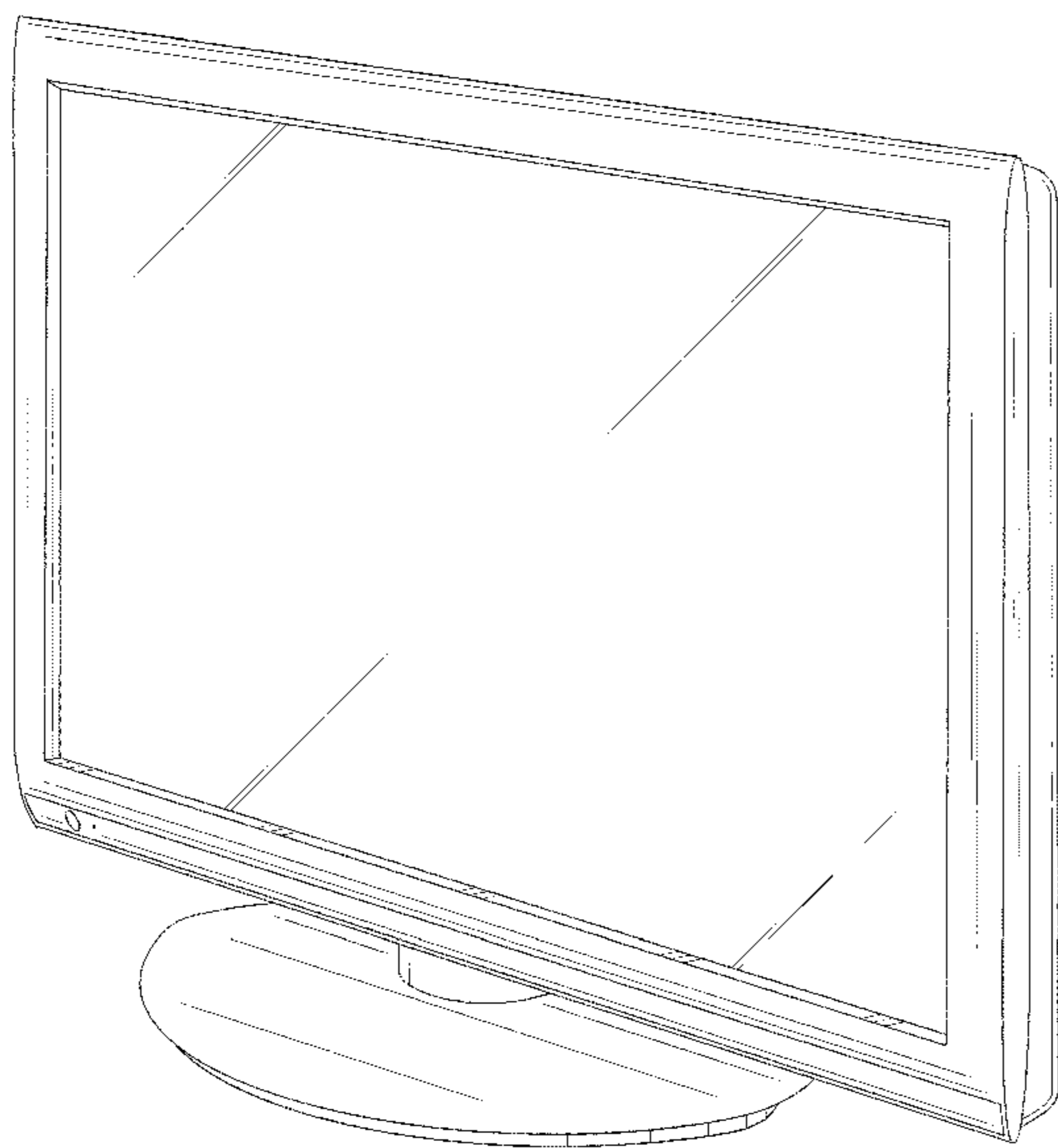

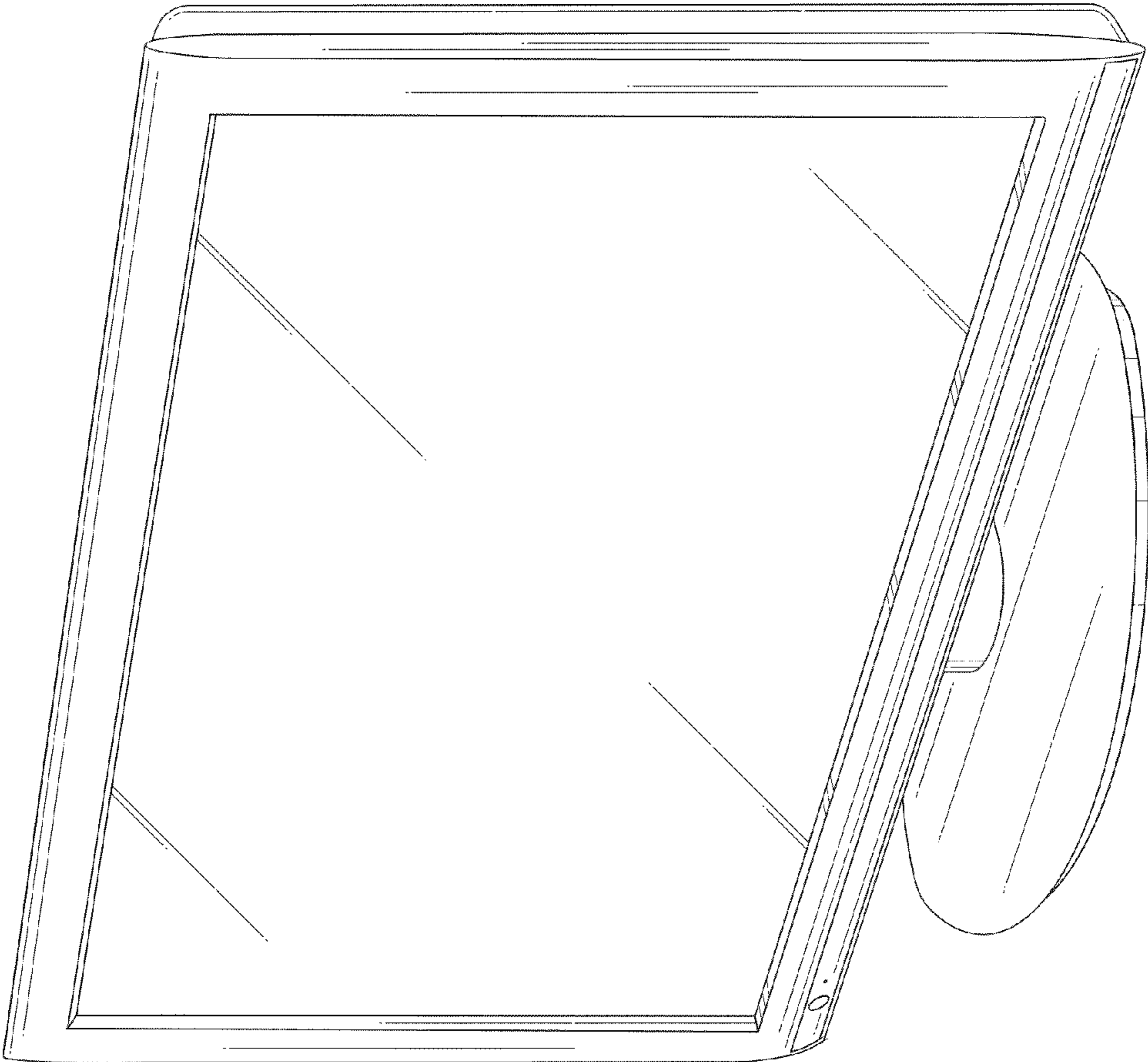

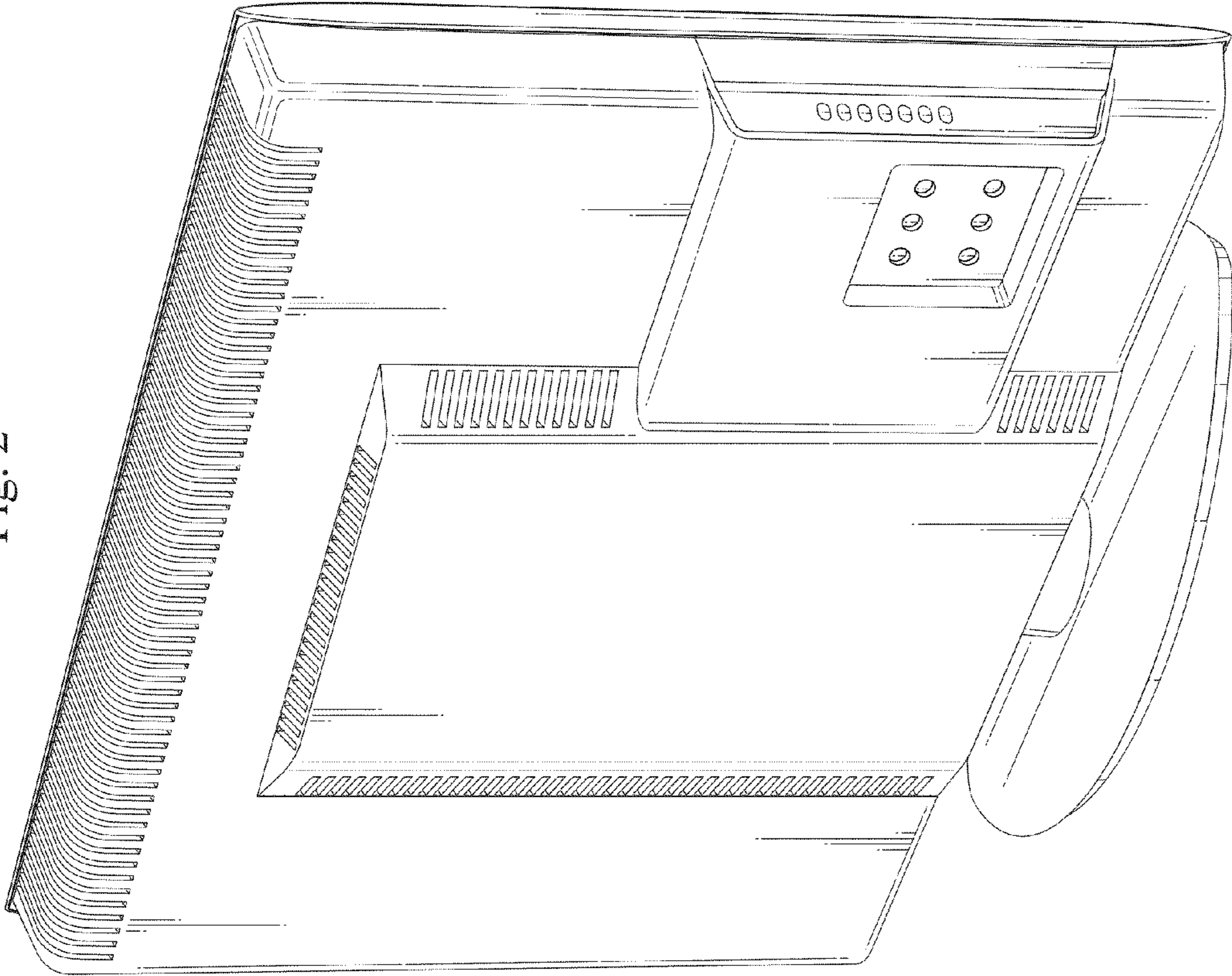

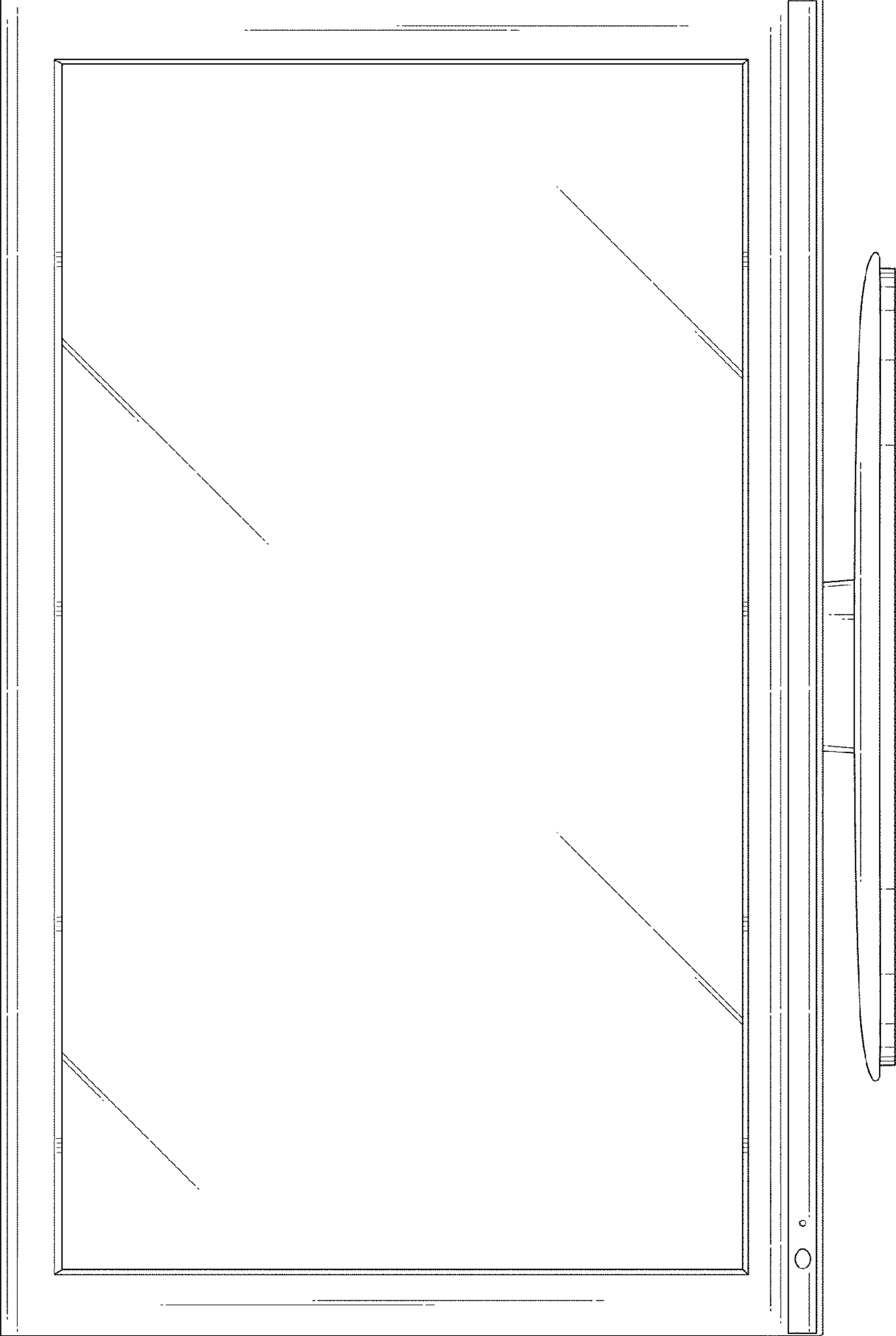

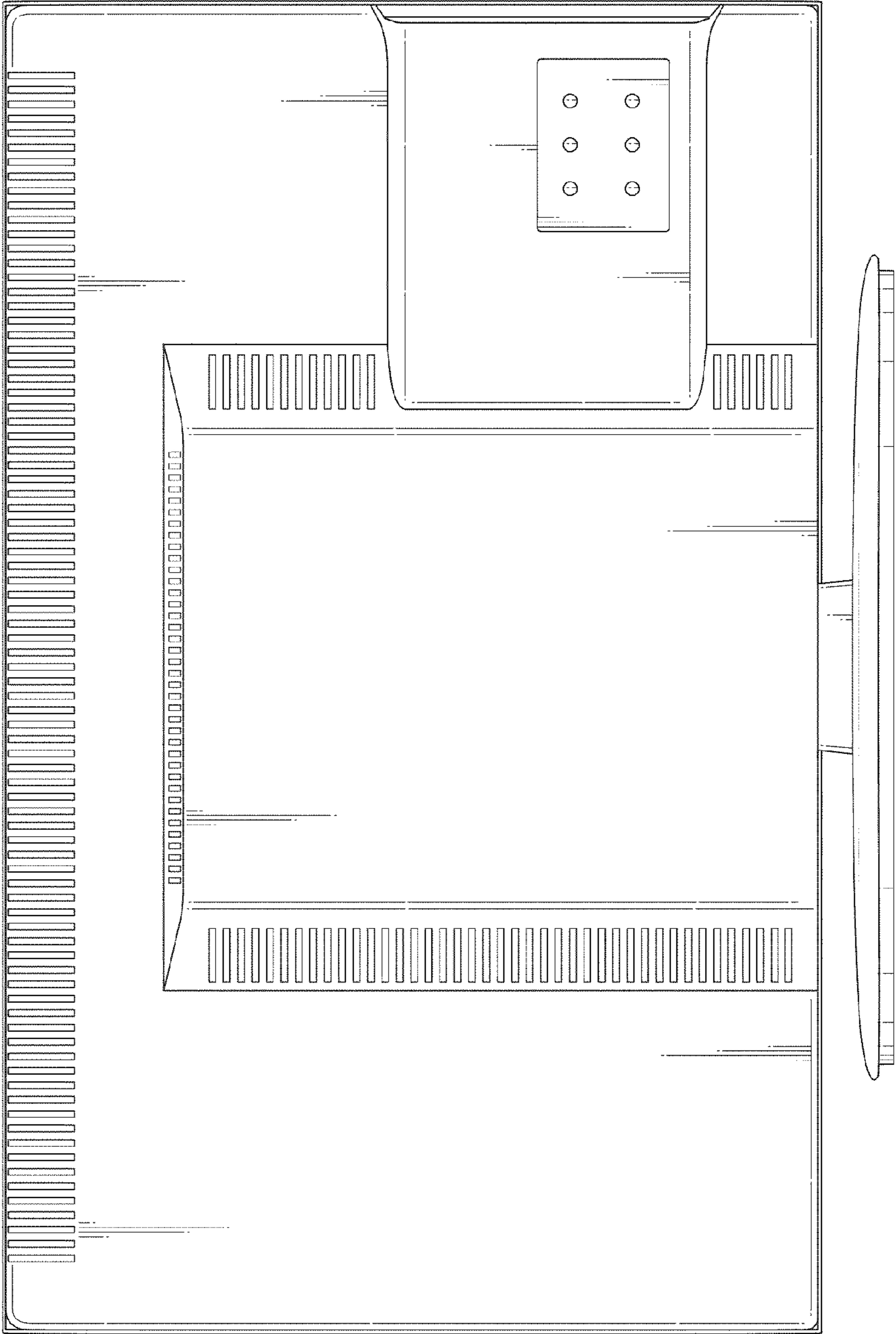

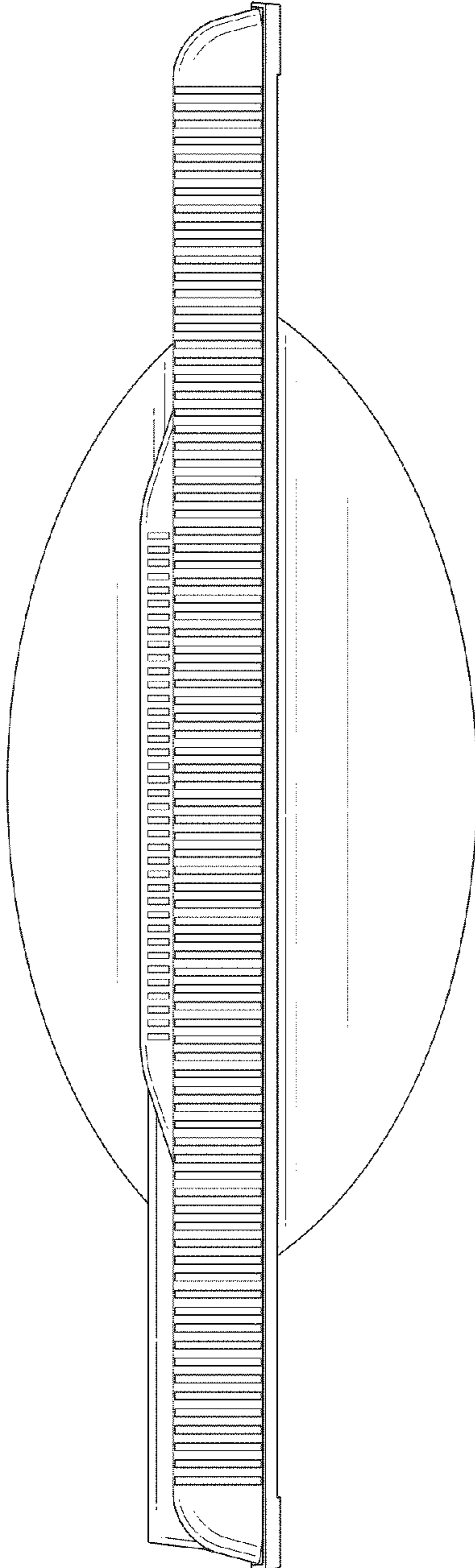

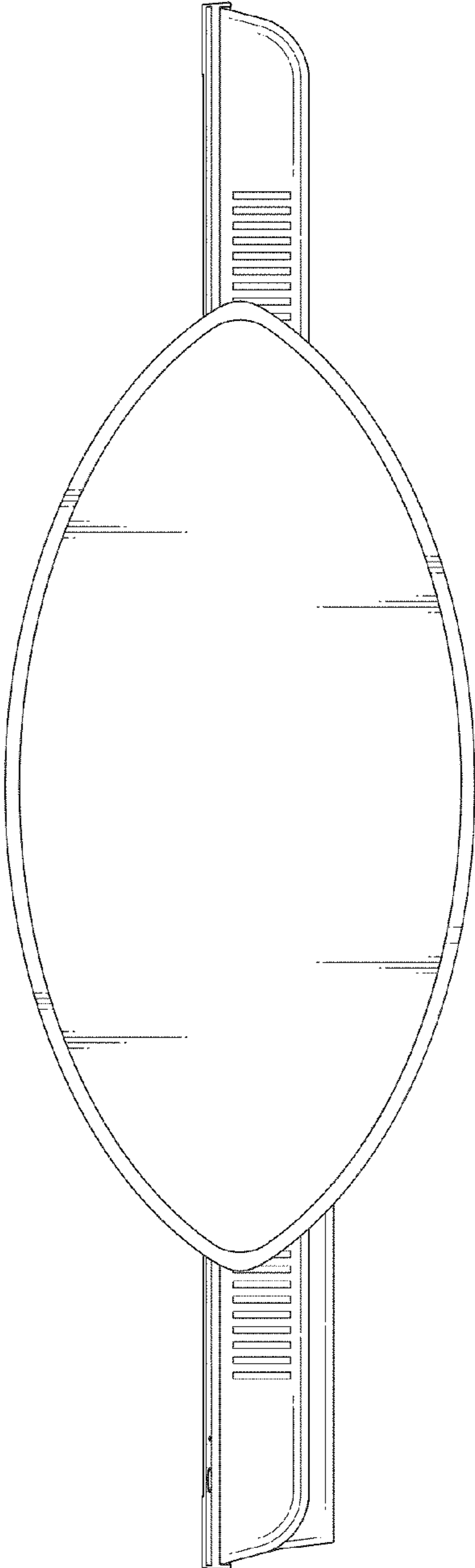

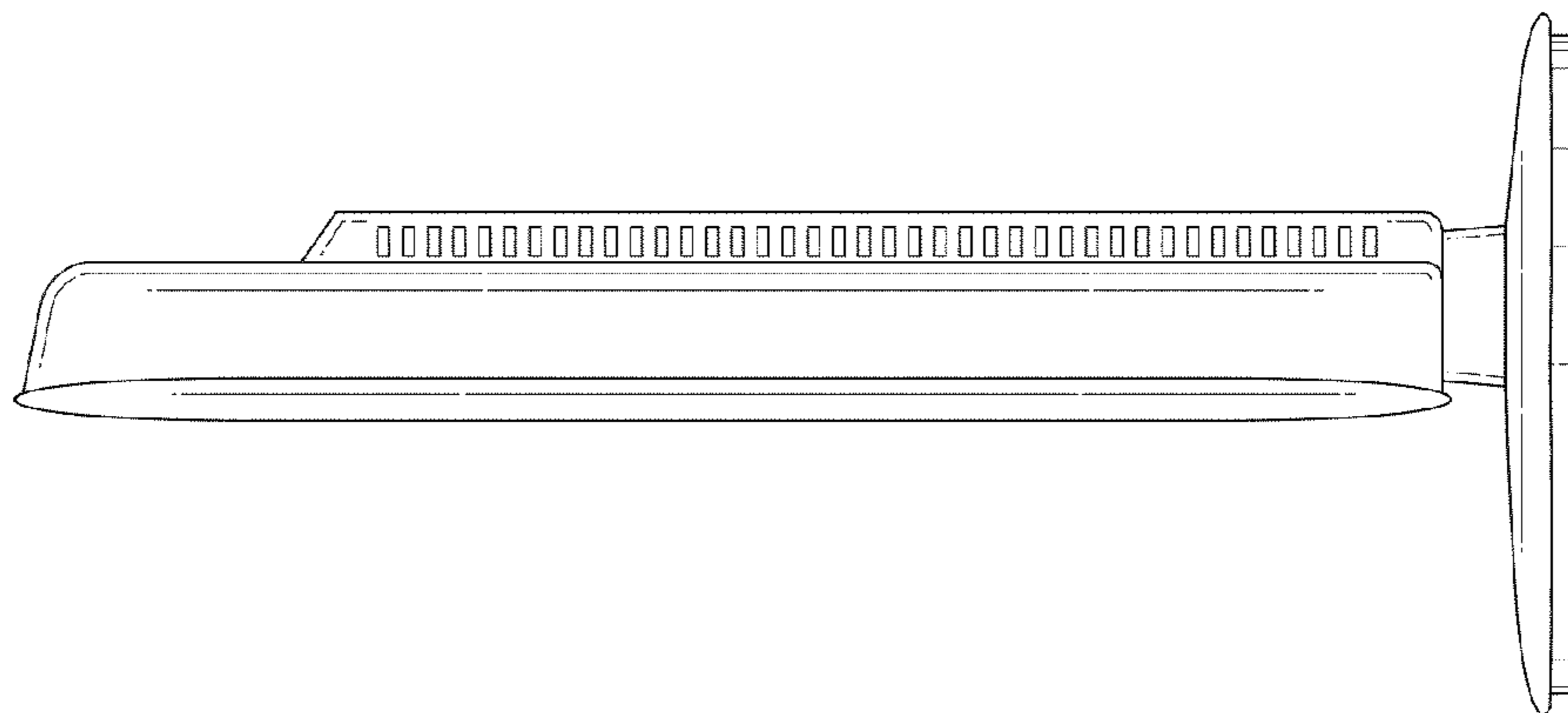
