FIG. 6 is a top plan view thereof.

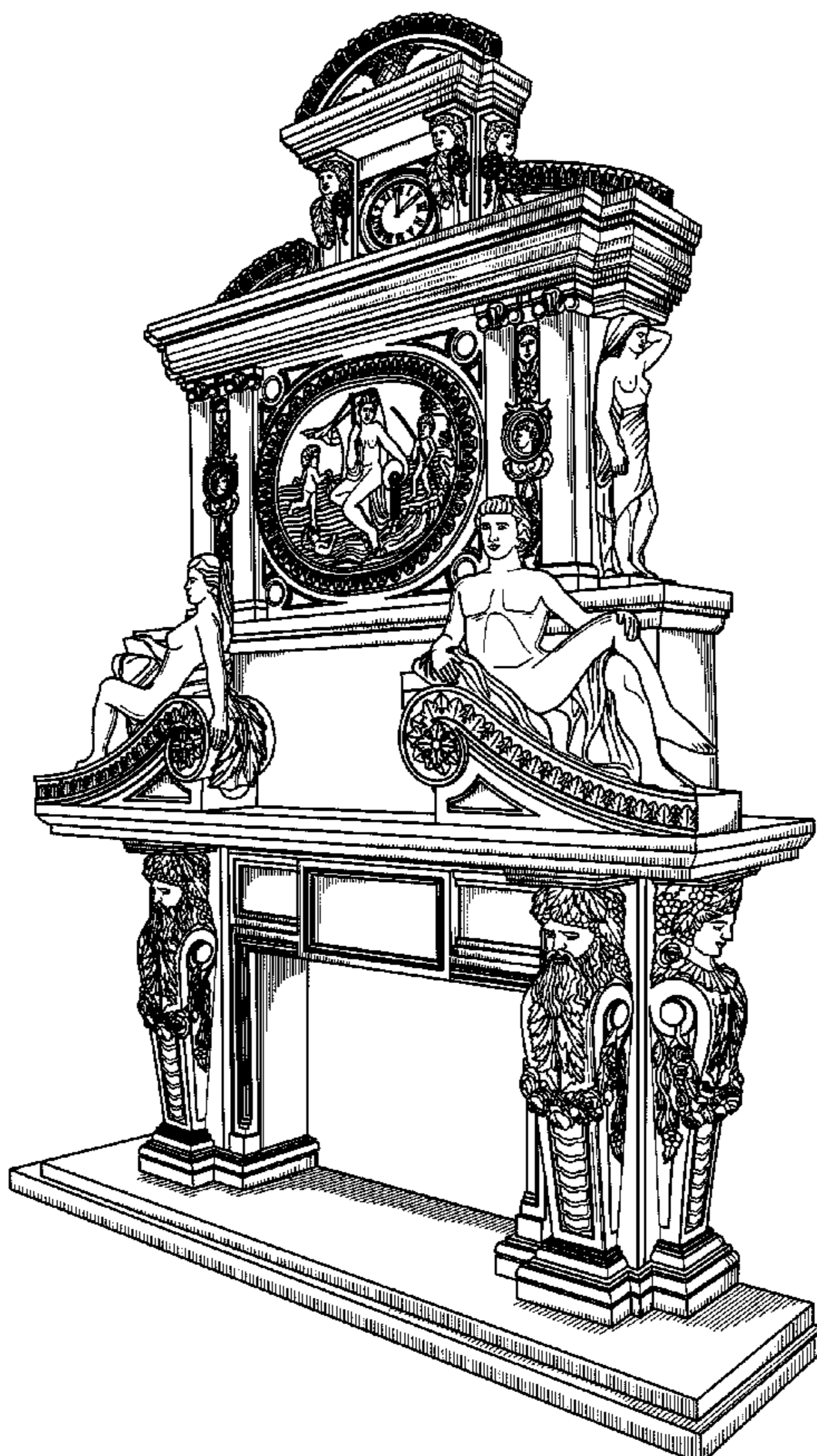
The bottom side of the fireplace forms no part of the claimed design.

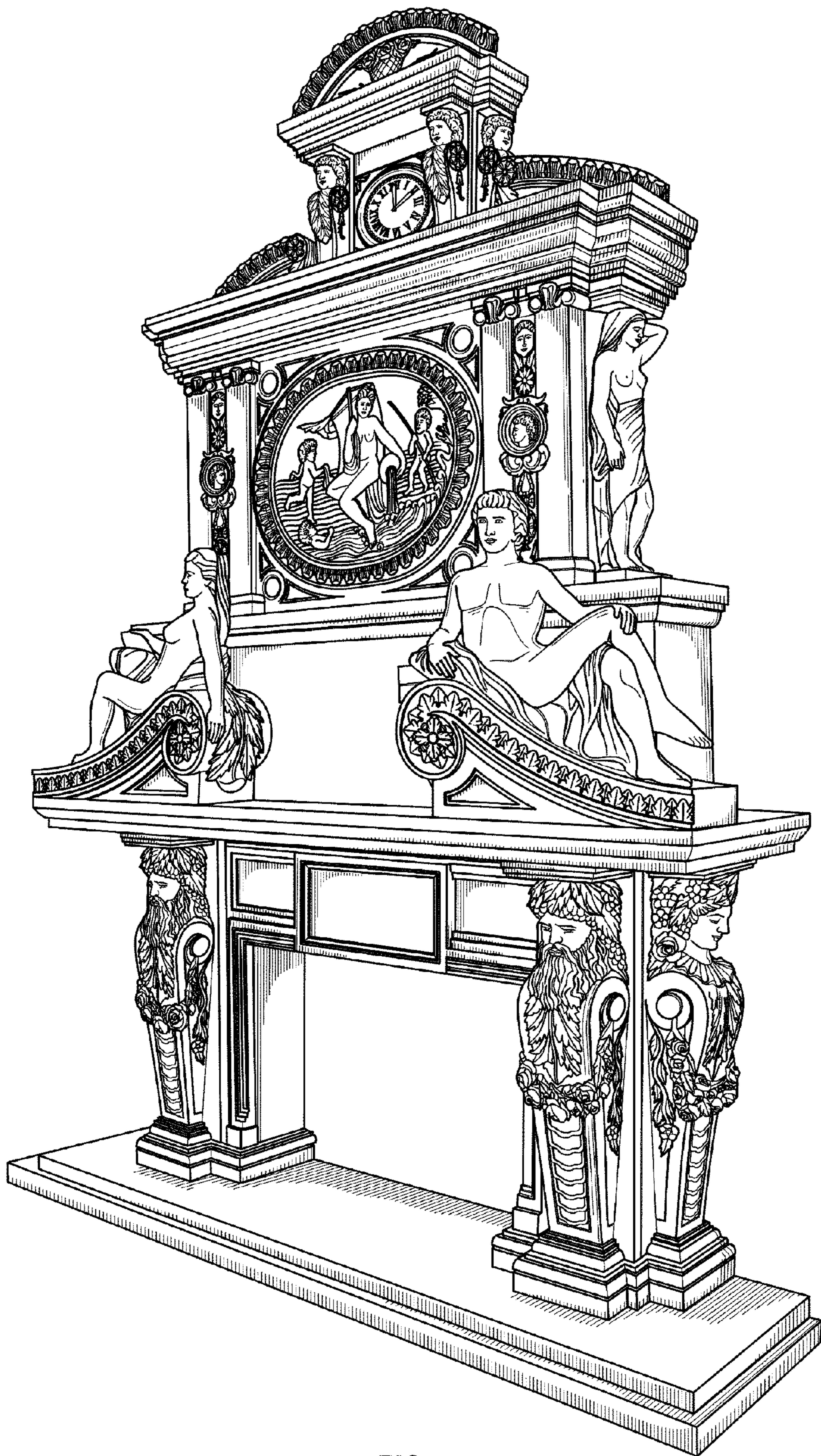

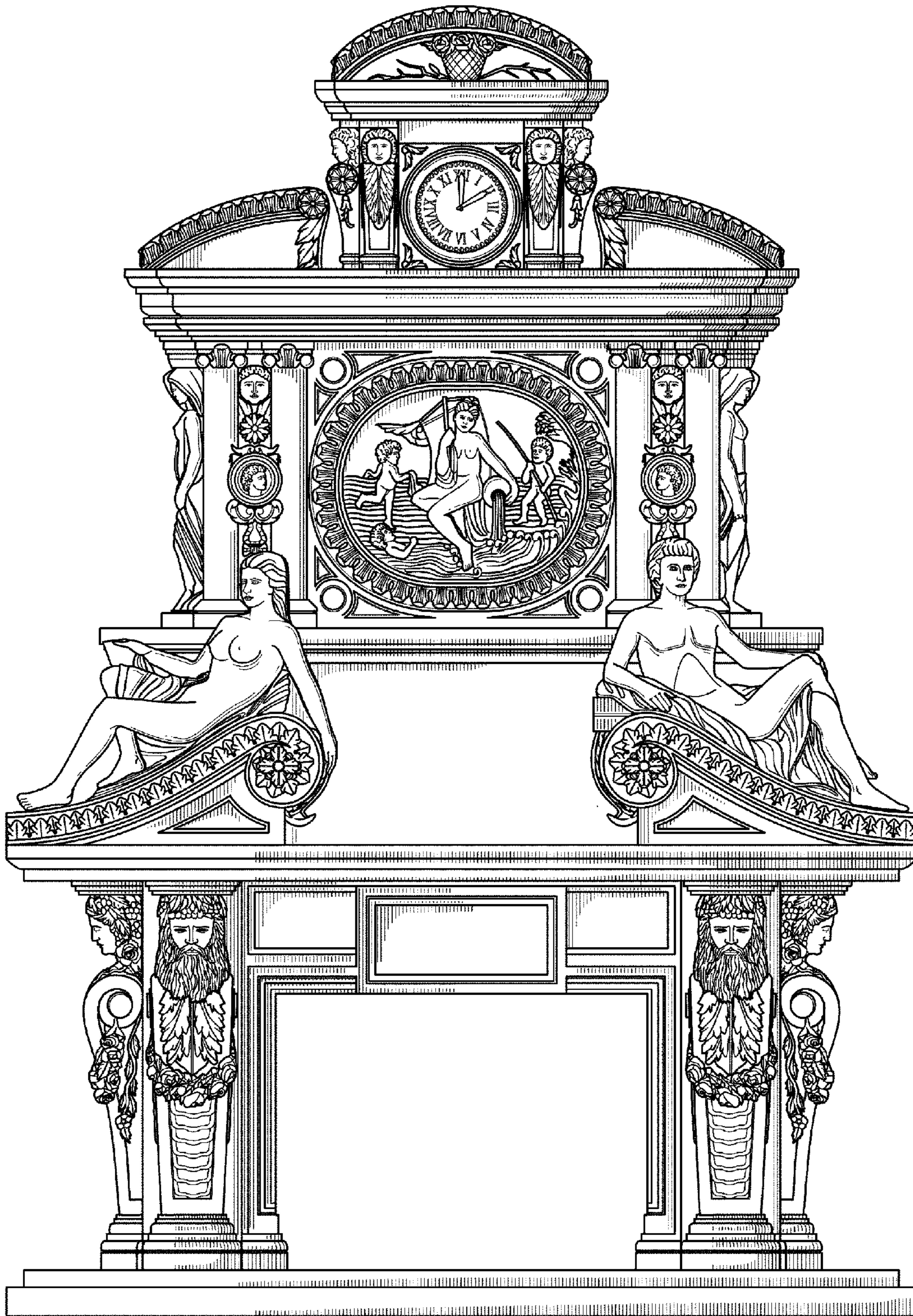

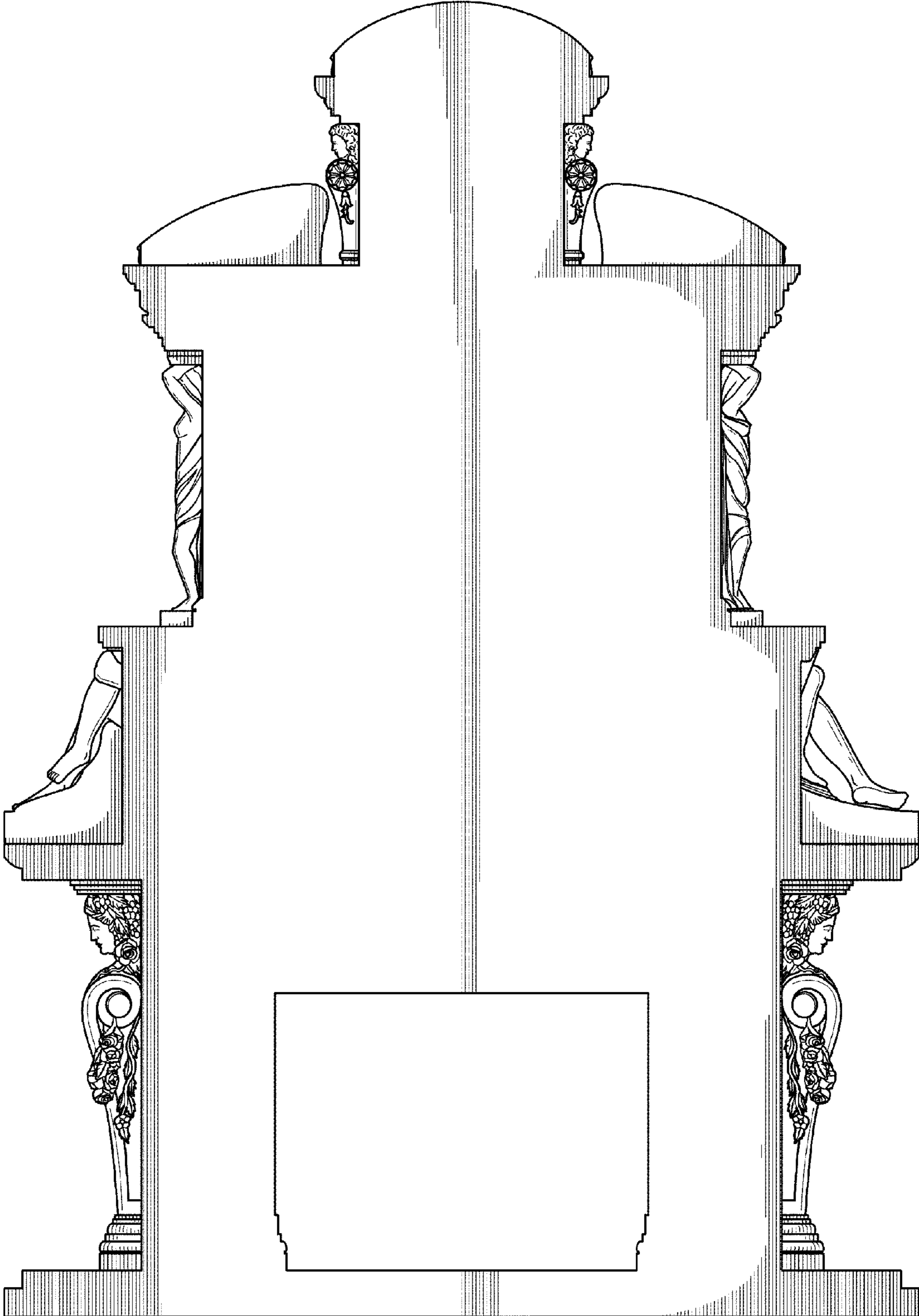

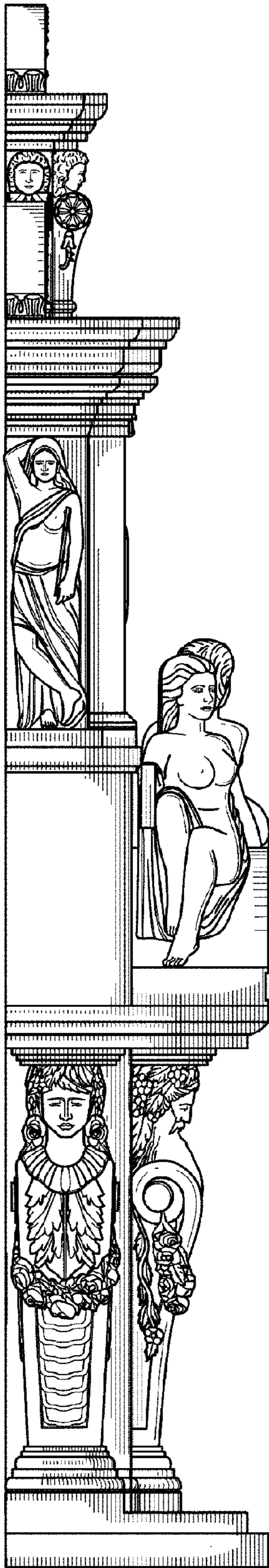

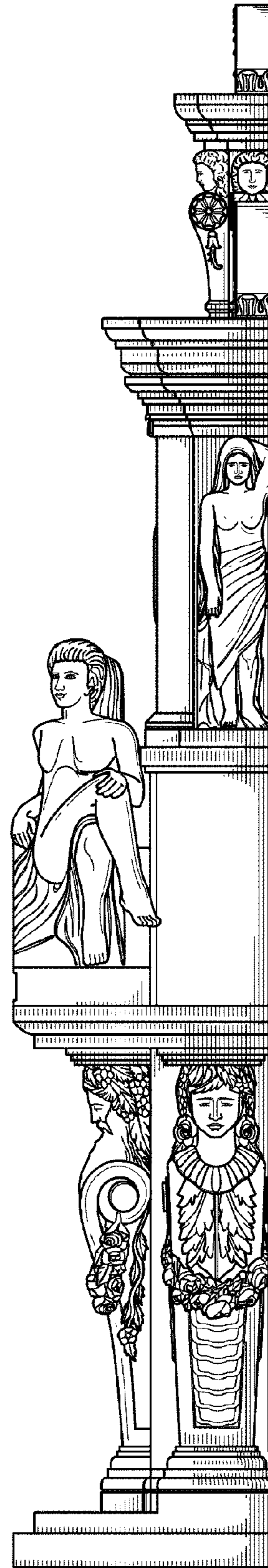
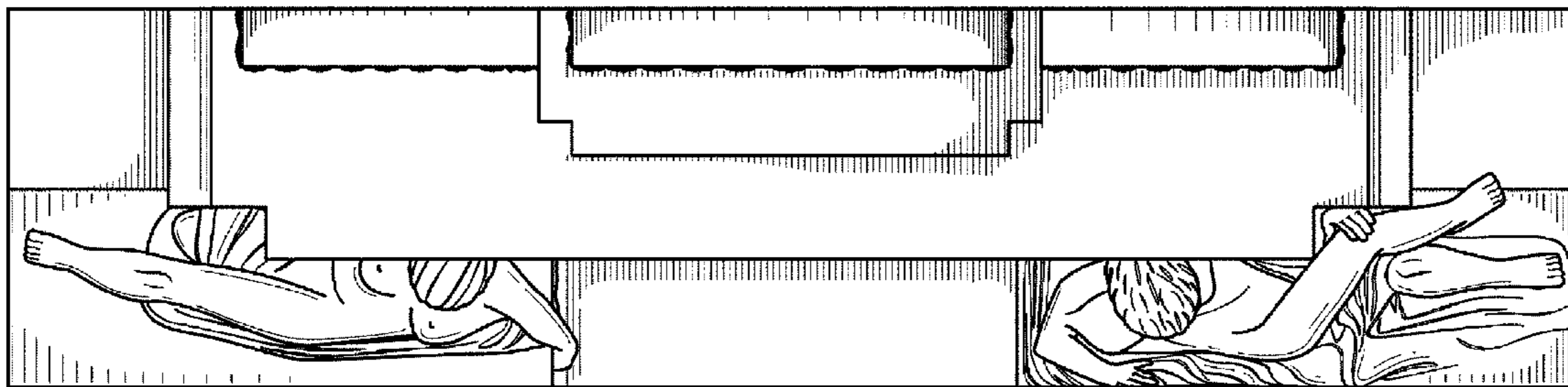
