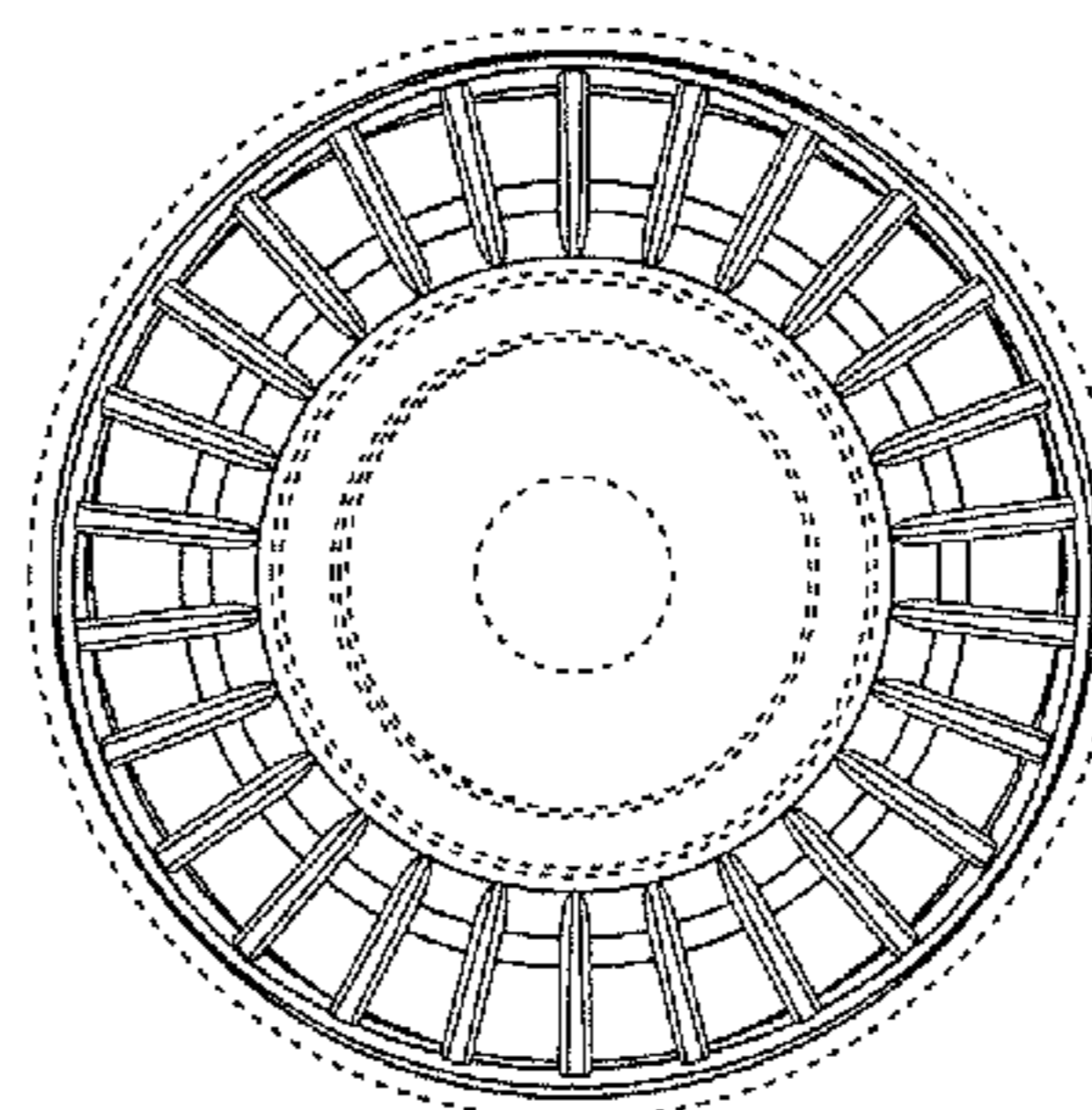
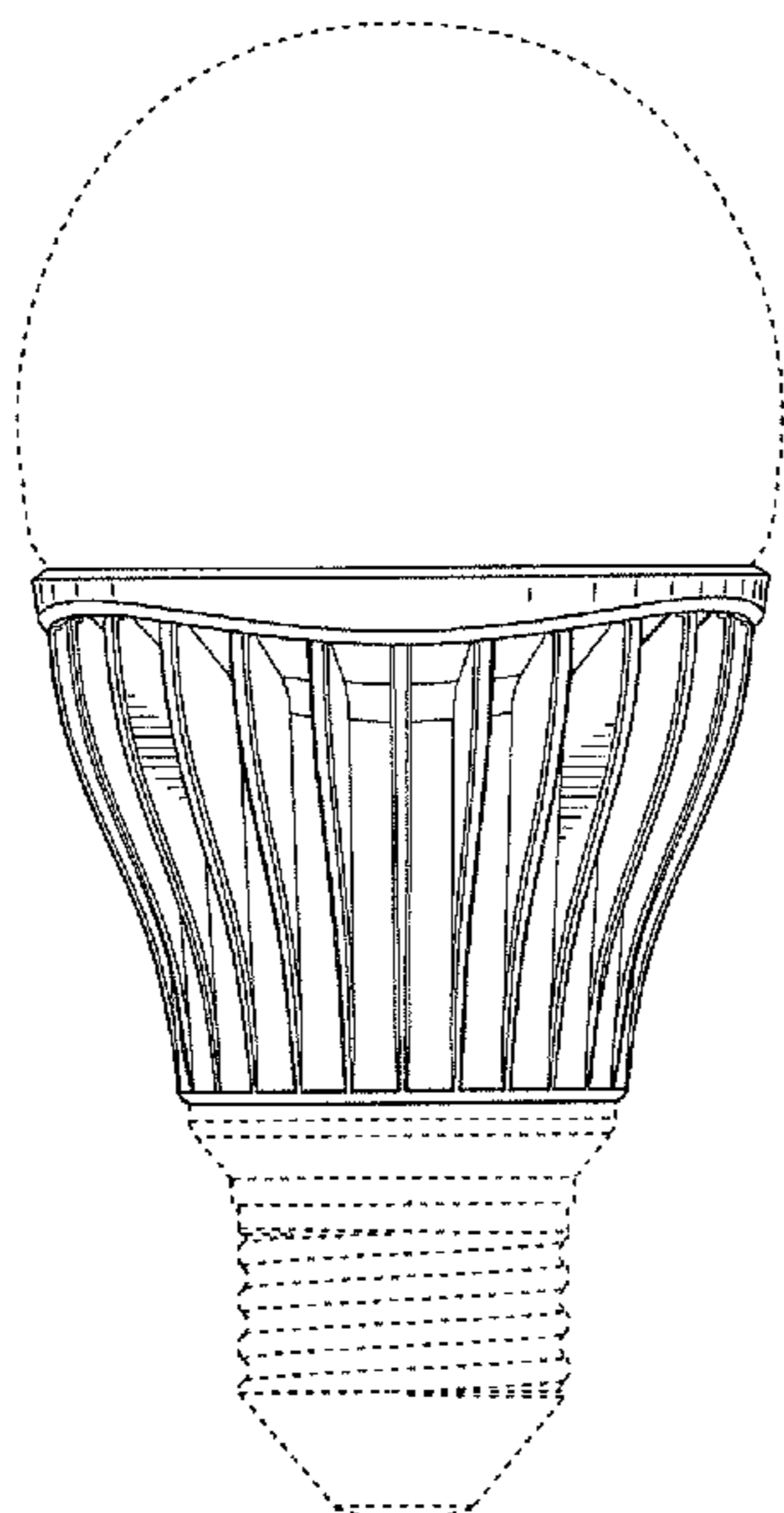
(57) **CLAIM**

The ornamental design for a light bulb, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light bulb showing our new design;
FIG. 2 is a front view of the light bulb shown in FIG. 1;
FIG. 3 is a left side view of the light bulb shown in FIG. 1;
FIG. 4 is a right side view of the light bulb shown in FIG. 1;
FIG. 5 is a rear view of the light bulb shown in FIG. 1; and,
FIG. 6 is a bottom view of the light bulb shown in FIG. 1.

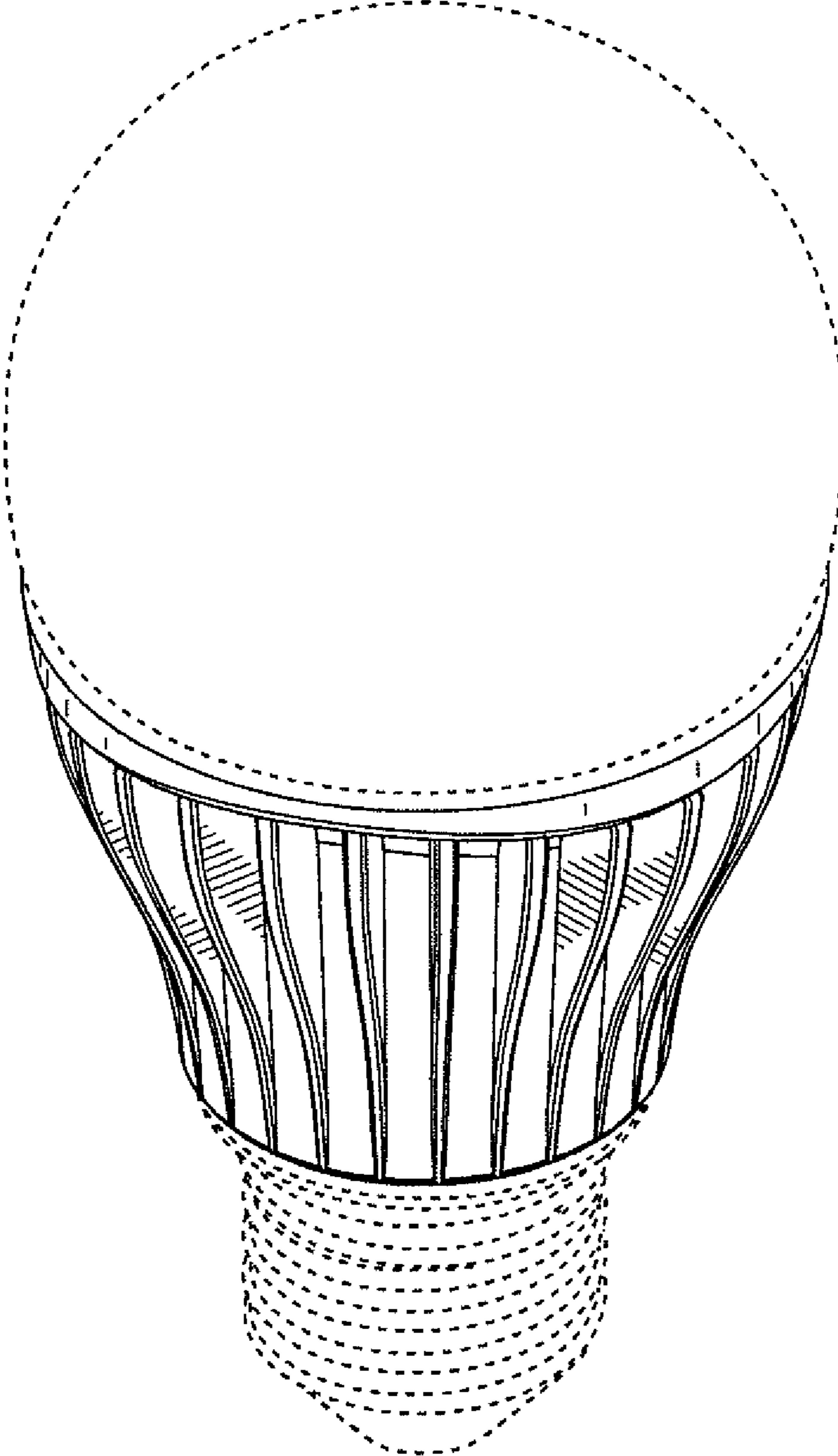

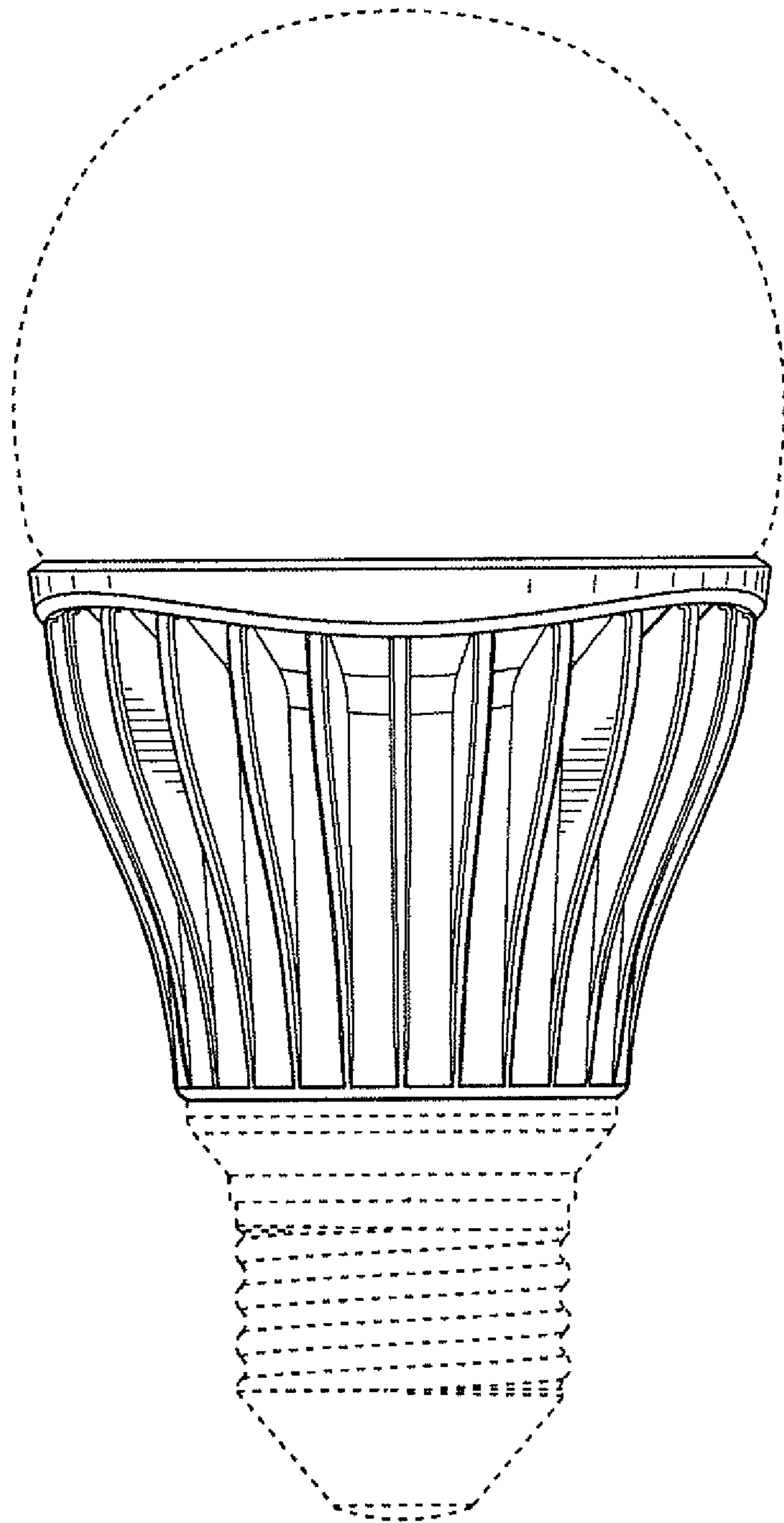

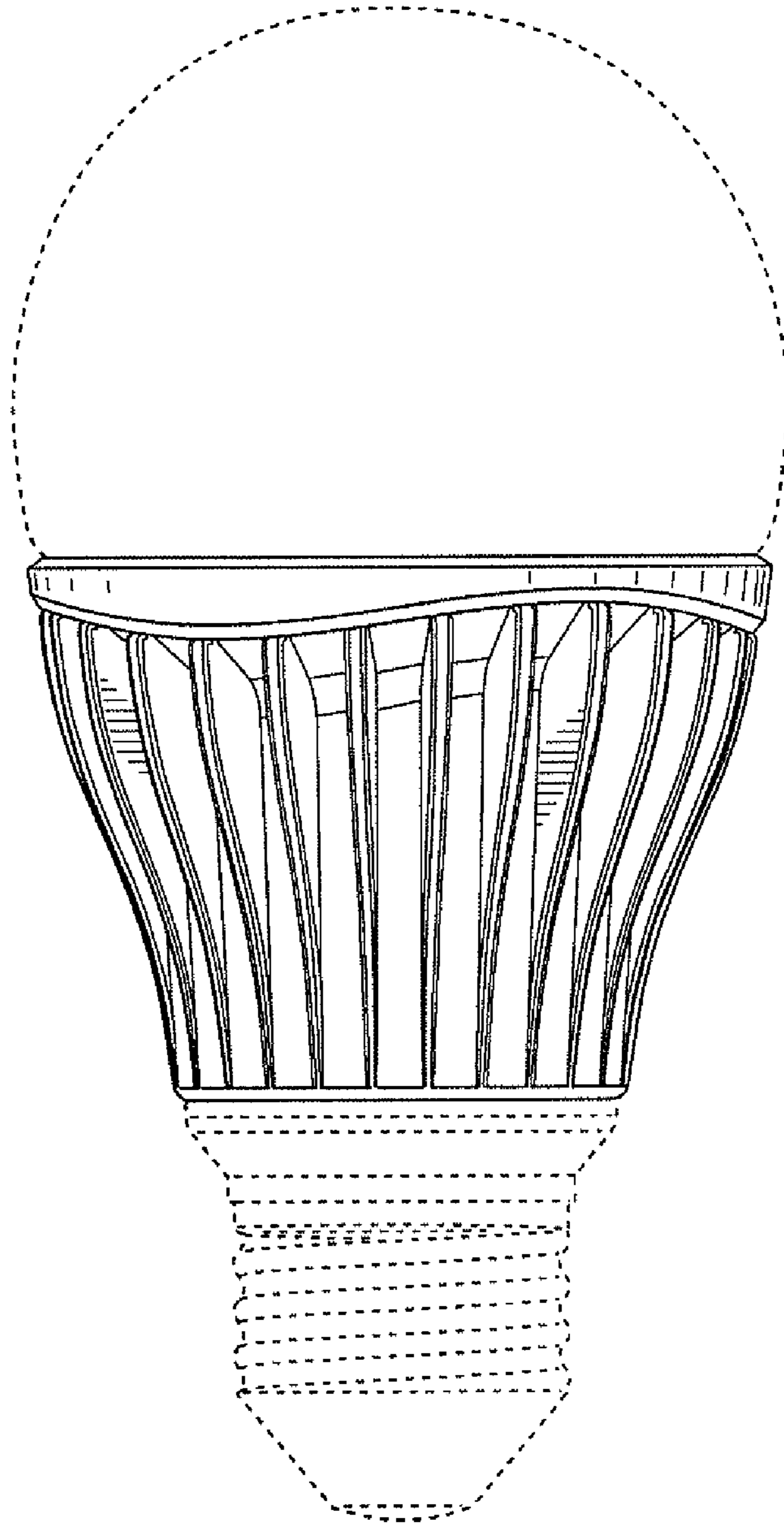

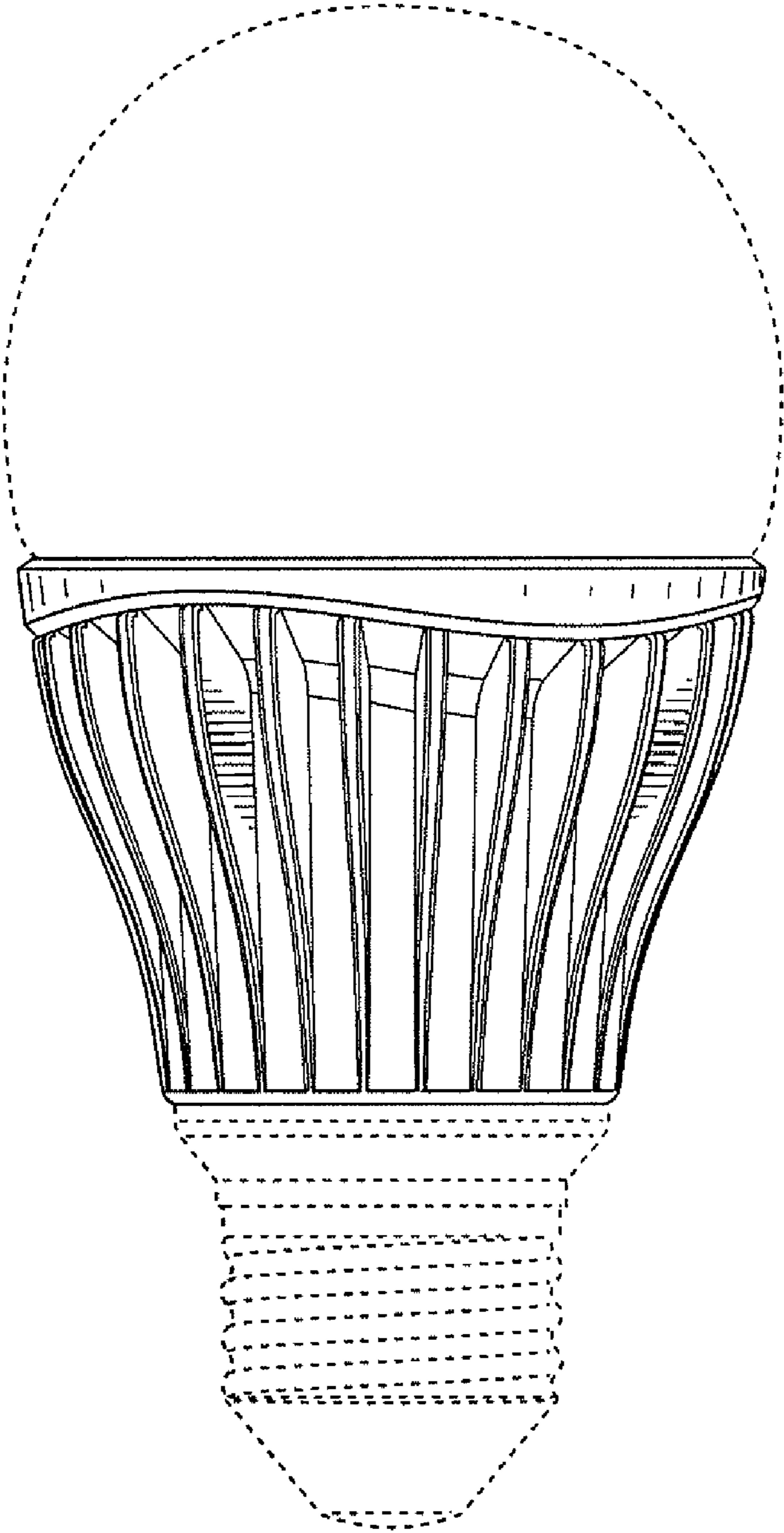

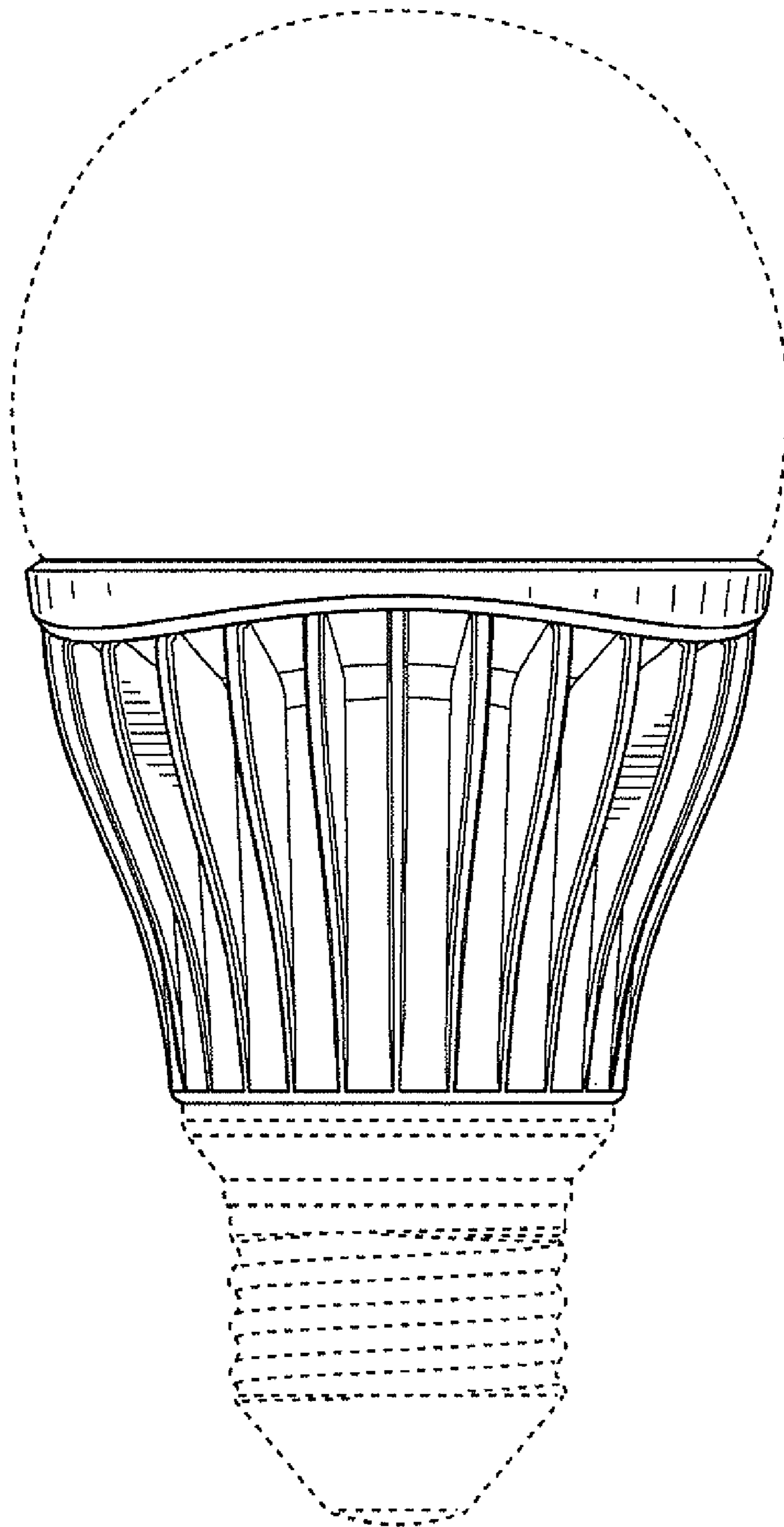

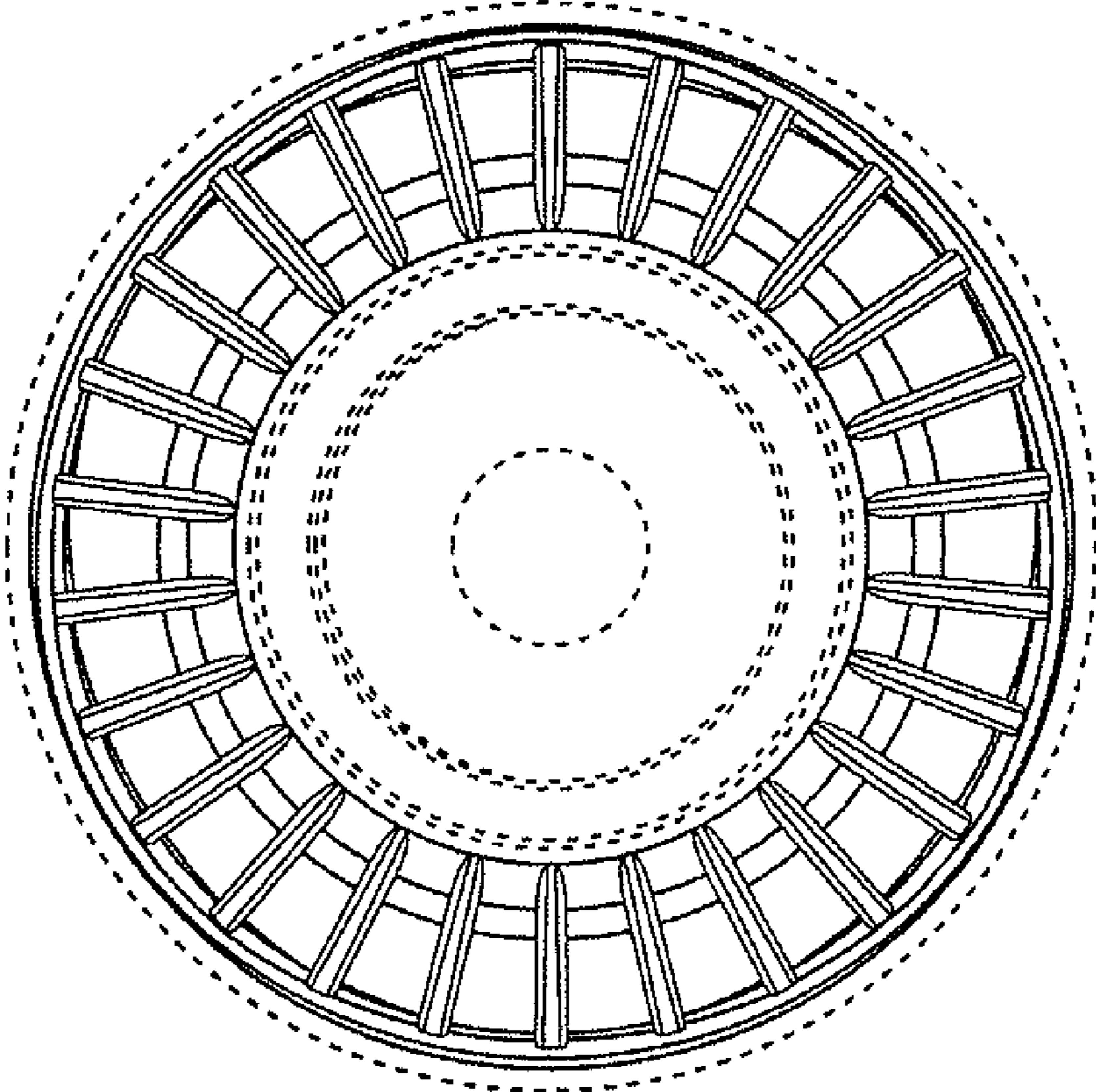
