The ornamental design for a backless bra, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a backless bra;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof, the right side being a mirror image thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

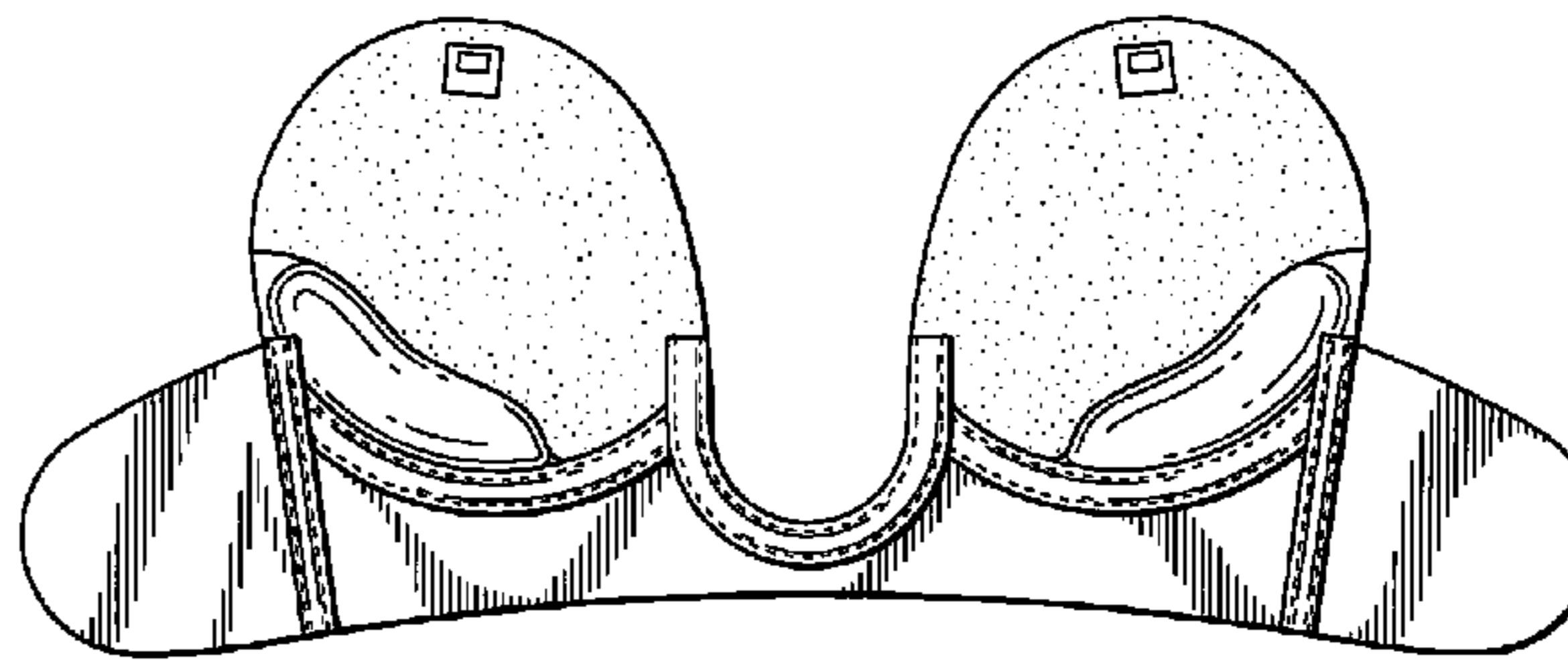
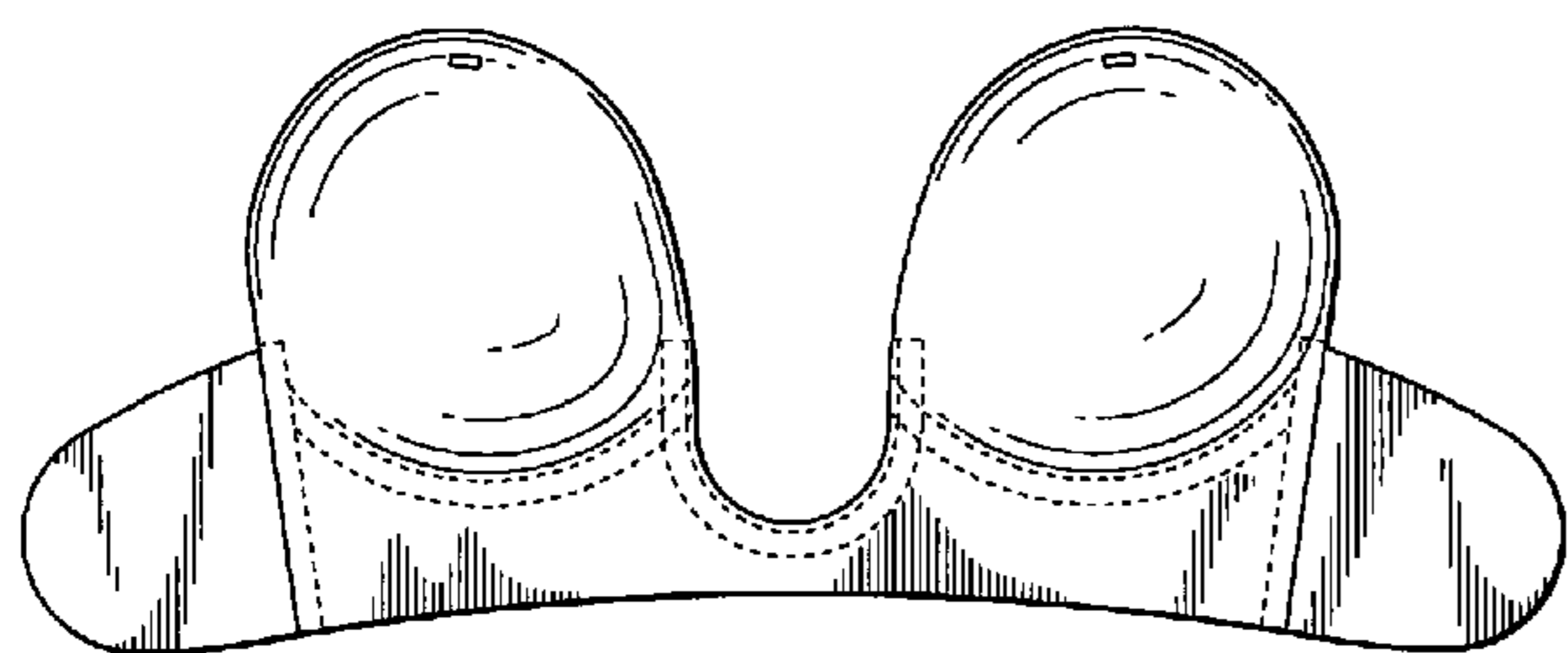

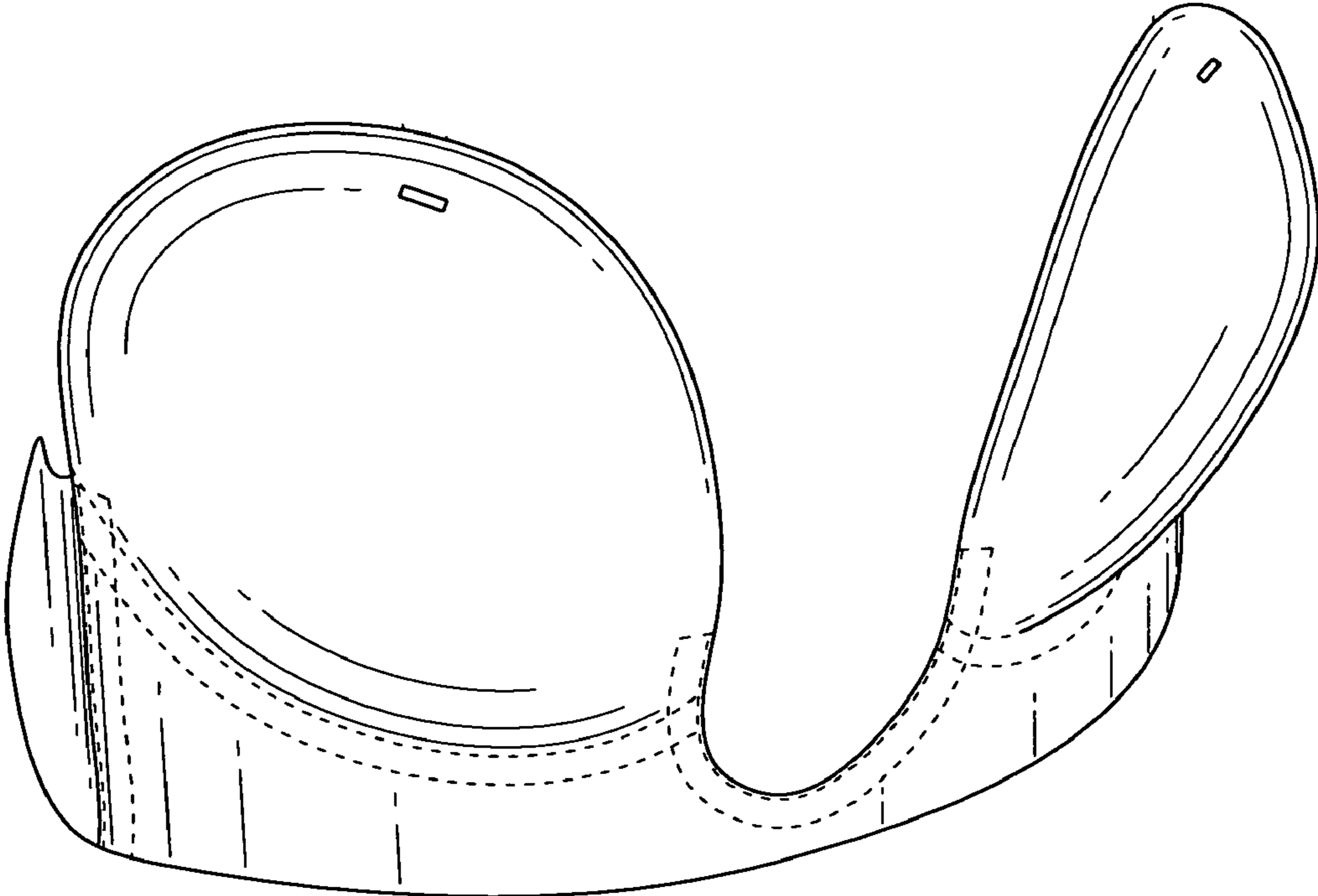

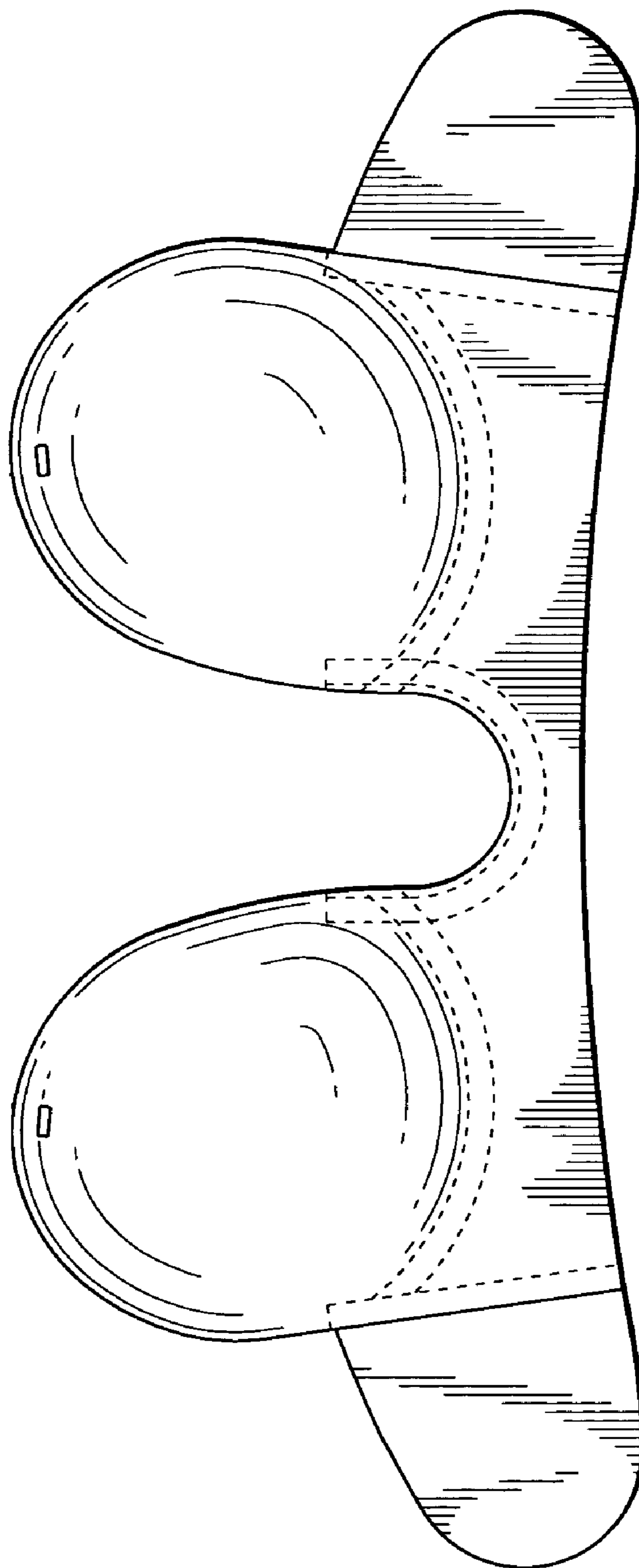

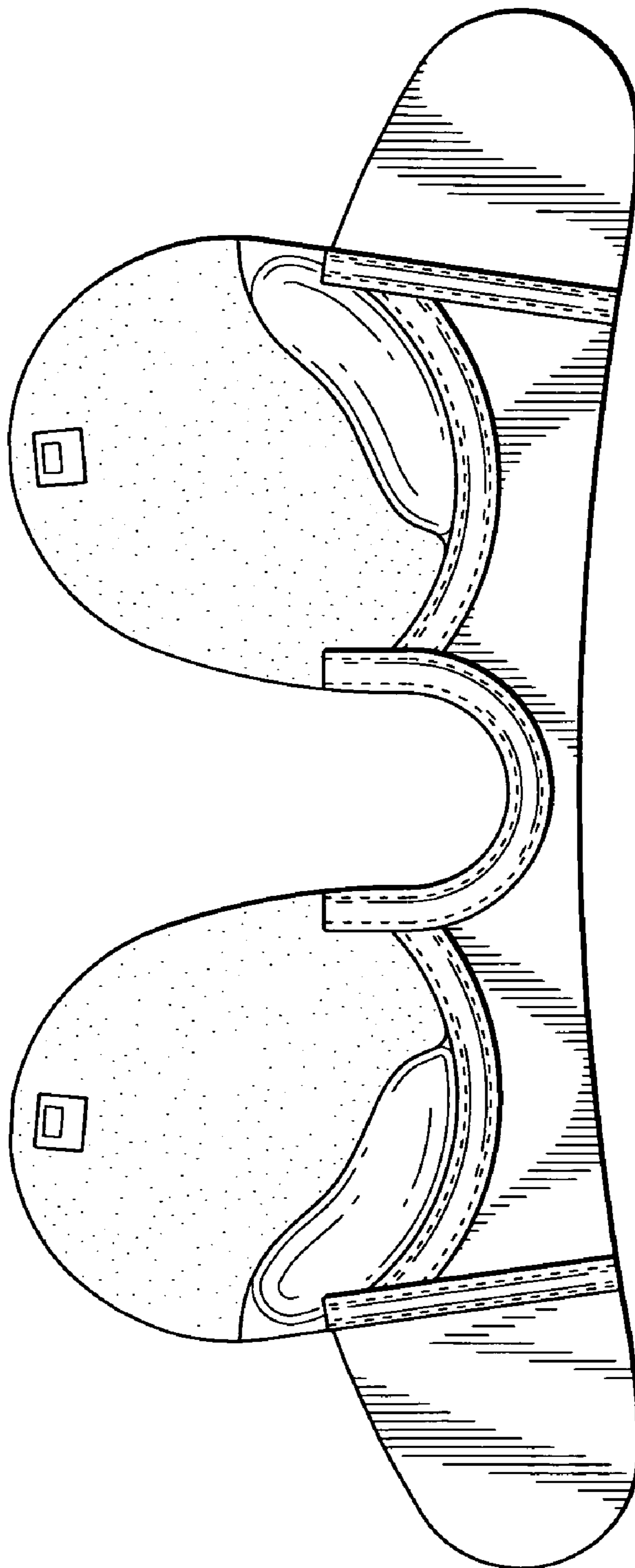

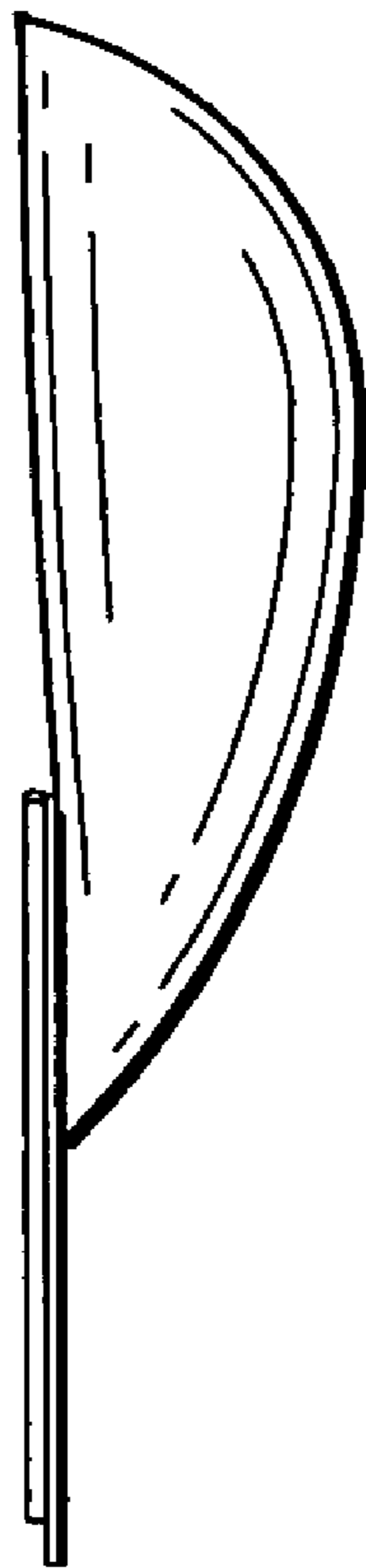

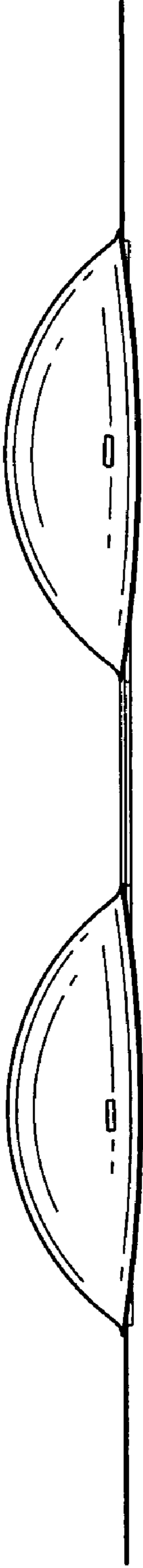
