(57) **CLAIM**

The ornamental design for a baby overall, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of the baby overall, with a portion of unclaimed environmental structure shown;

FIG. 2 is a front view of the baby overall, with a portion of unclaimed environmental structure shown; and,

FIG. 3 is a rear view of the baby overall, with a portion of unclaimed environmental structure shown.

The dashed broken lines, showing environmental structure, represent the portions of the design which form no part of the claim. The dot-dashed line in FIG. 3 represent the bounds of the claim.

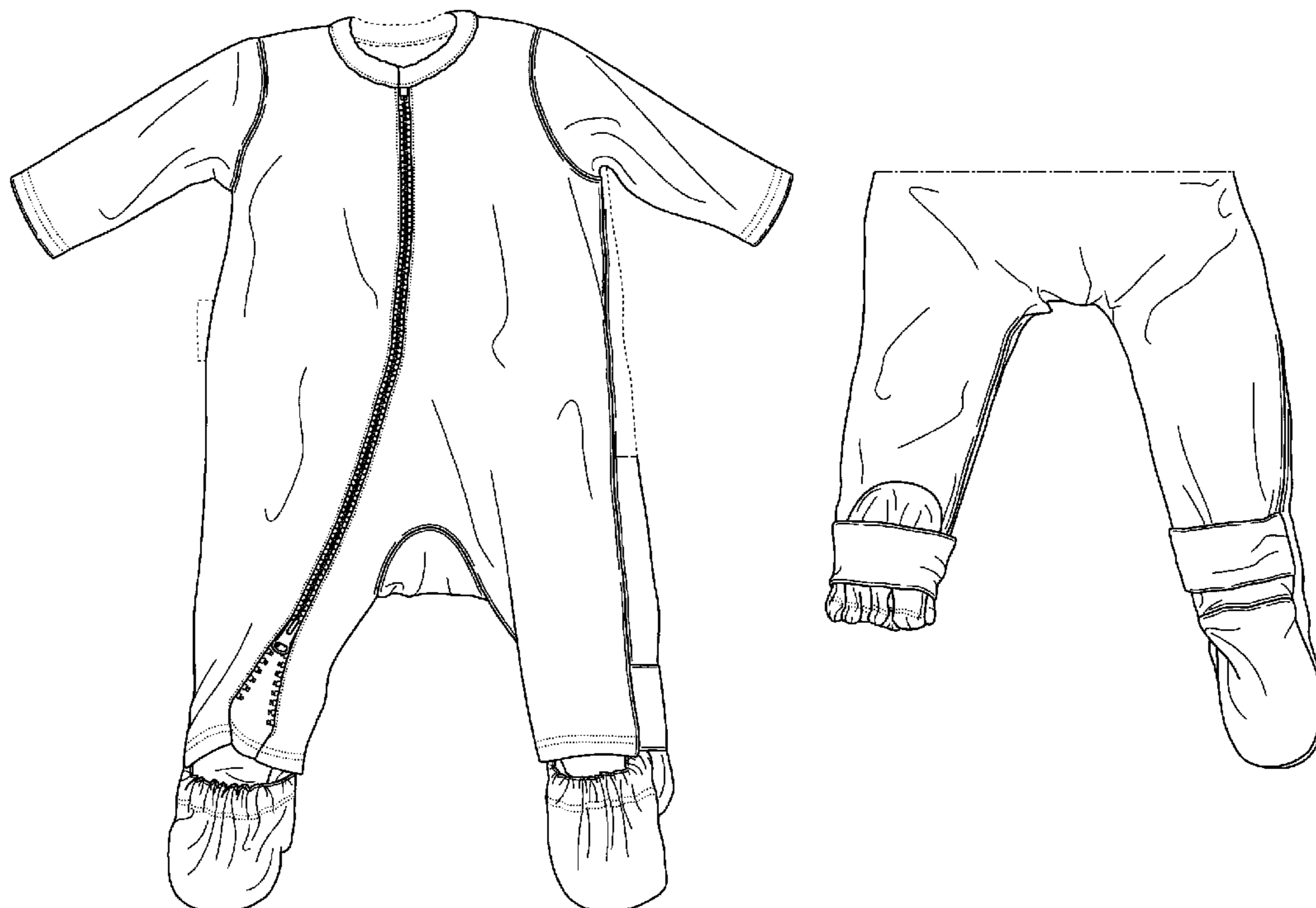

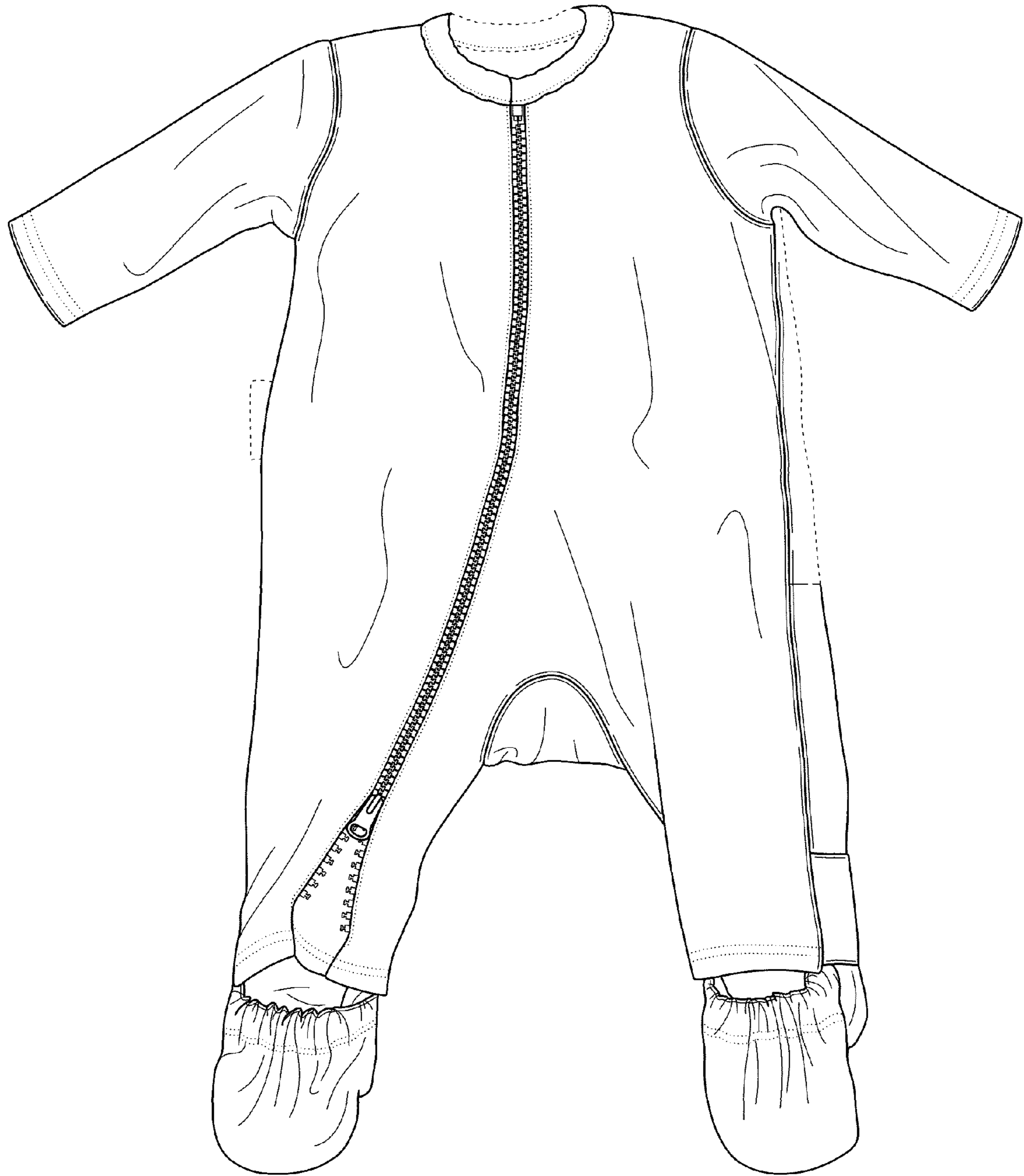
