(57) **CLAIM**

The ornamental design of a pocket for golf balls and accessories, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pocket for golf balls and accessories showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a top plan view thereof;

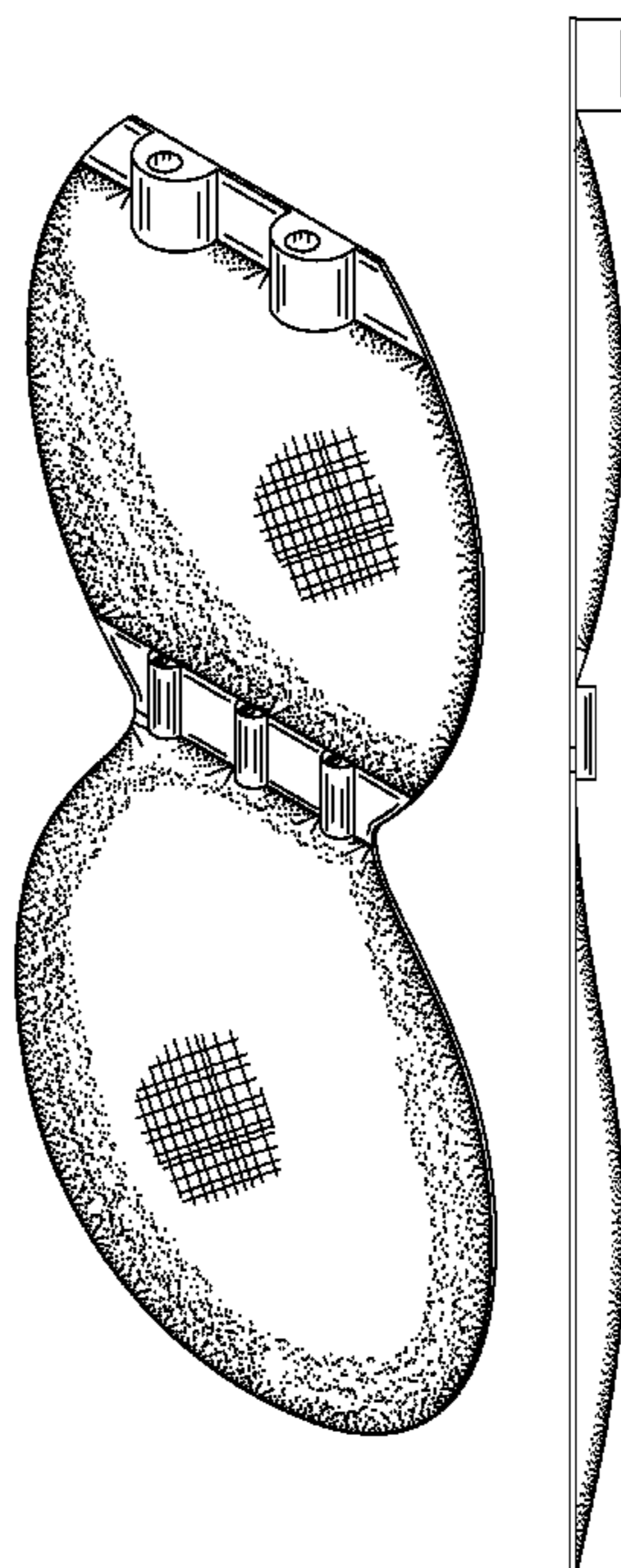
FIG. 8 is a perspective view, showing the pocket in use holding various accessories;

FIG. 9 is a perspective view, showing the pocket in use and placed on a pair of shorts; and,

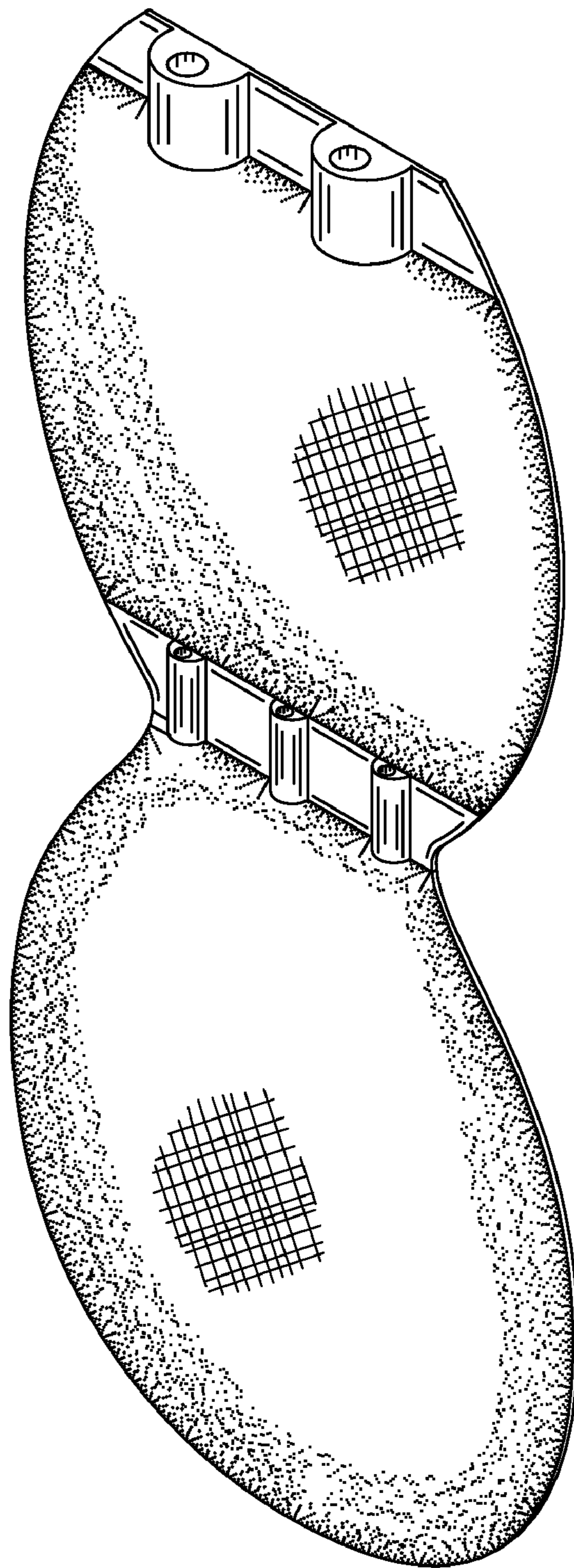

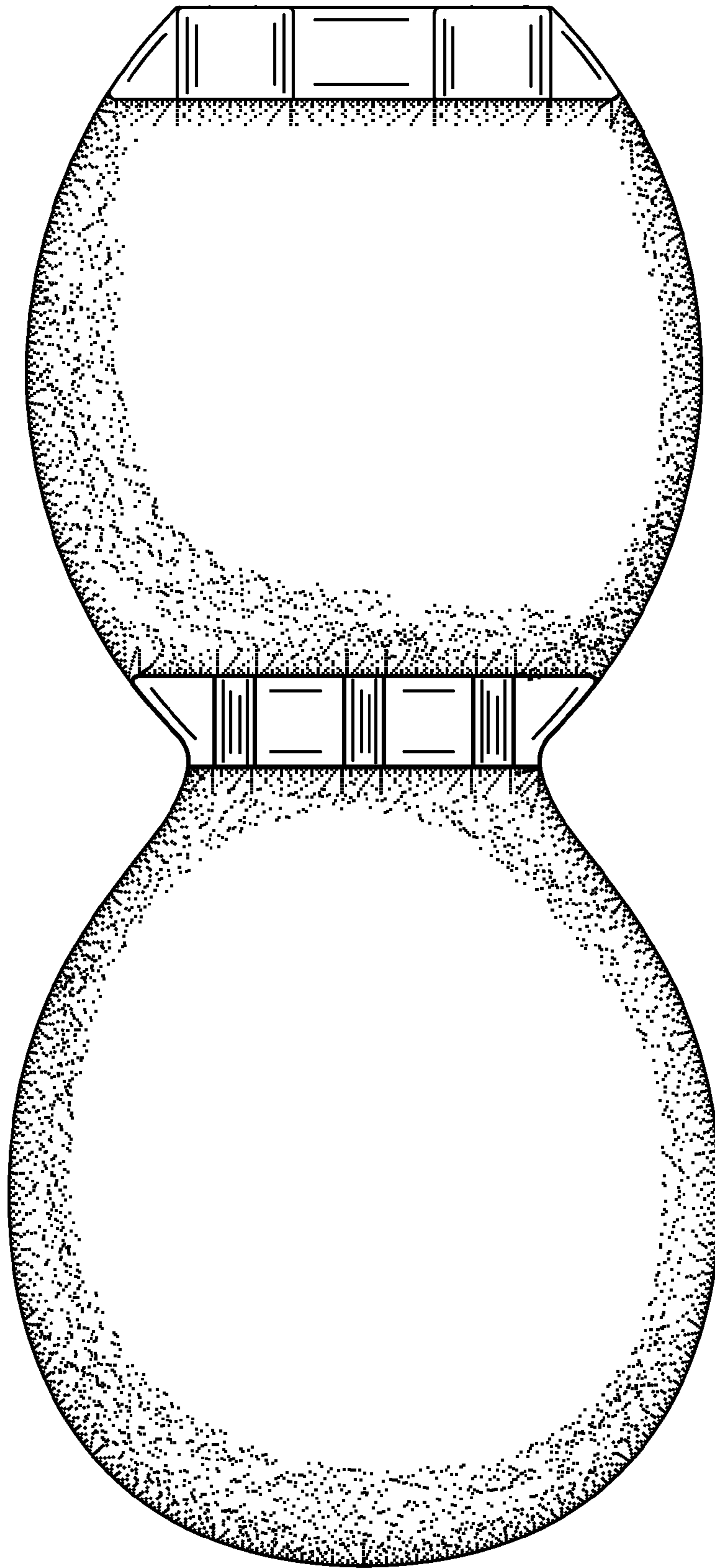

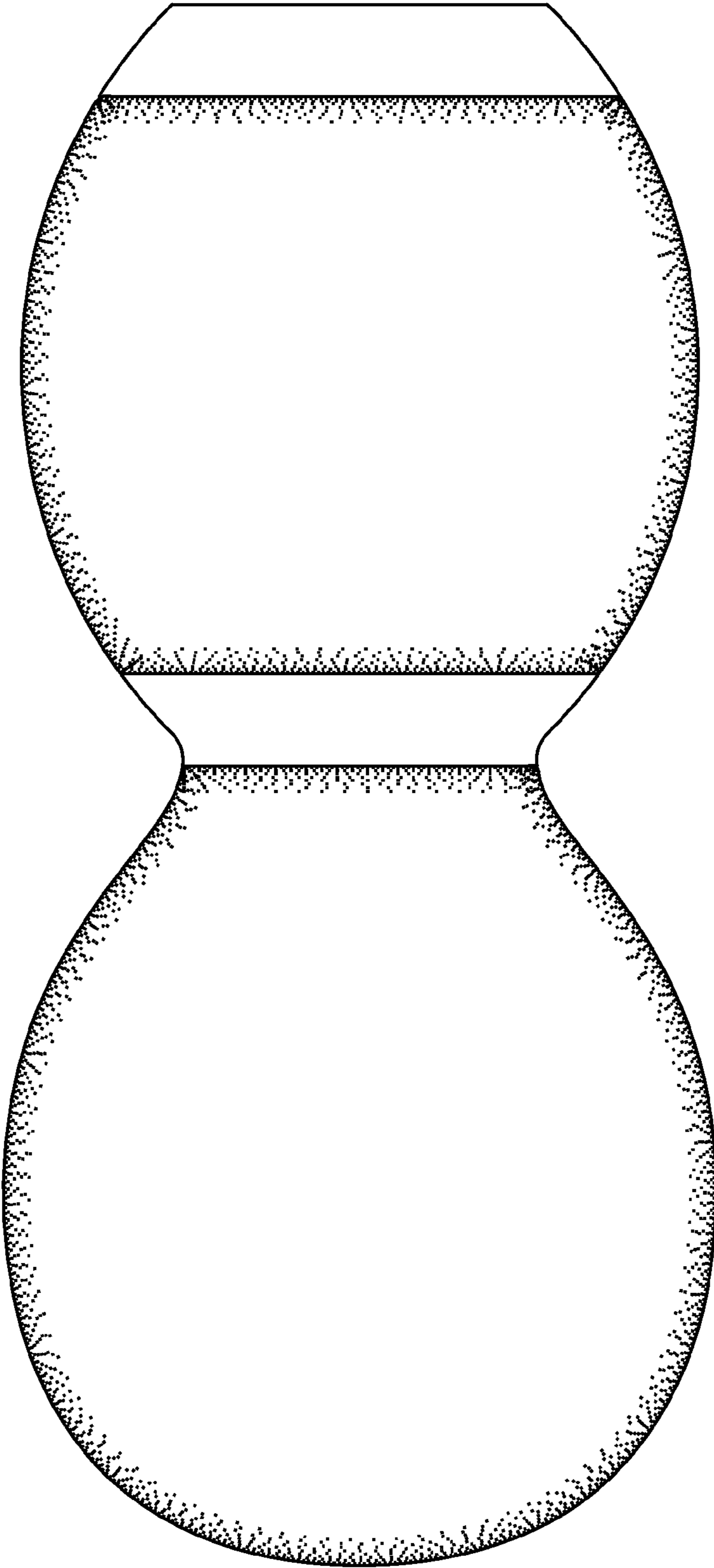

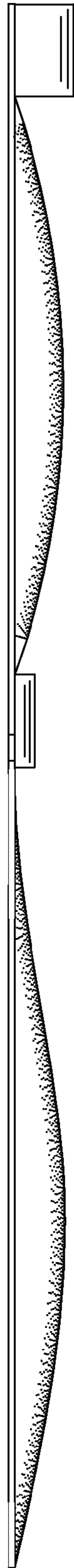

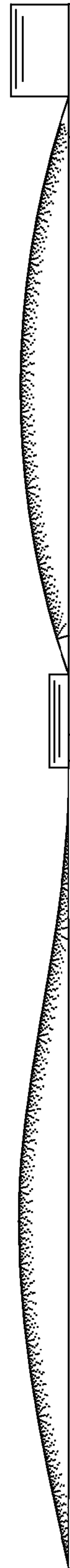

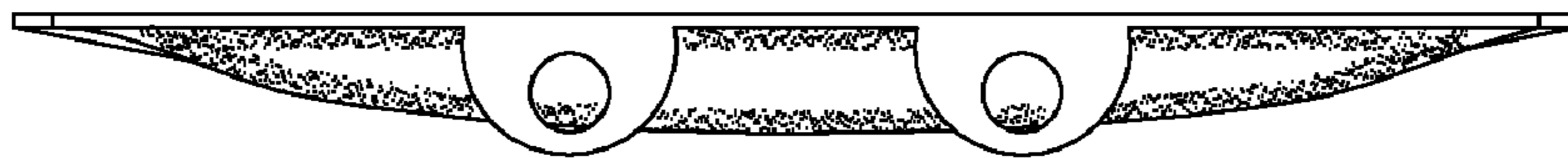

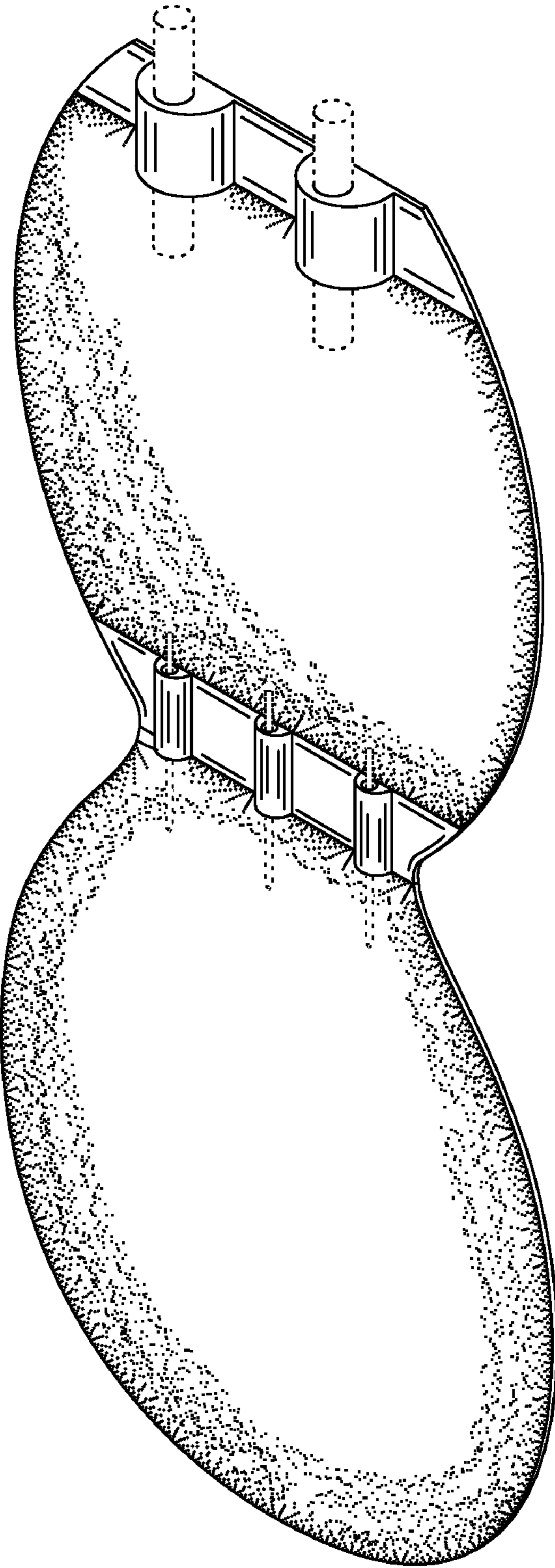

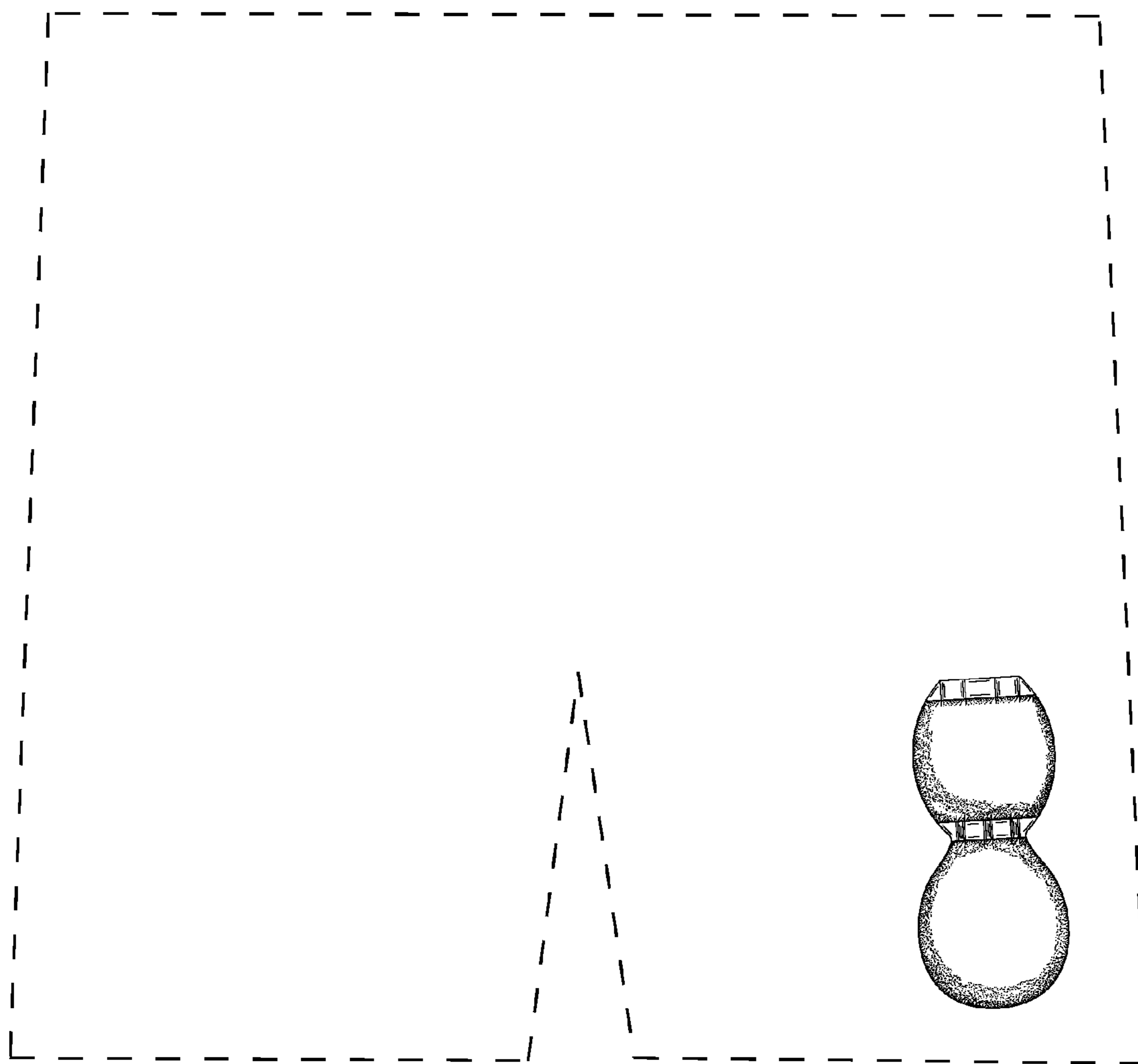

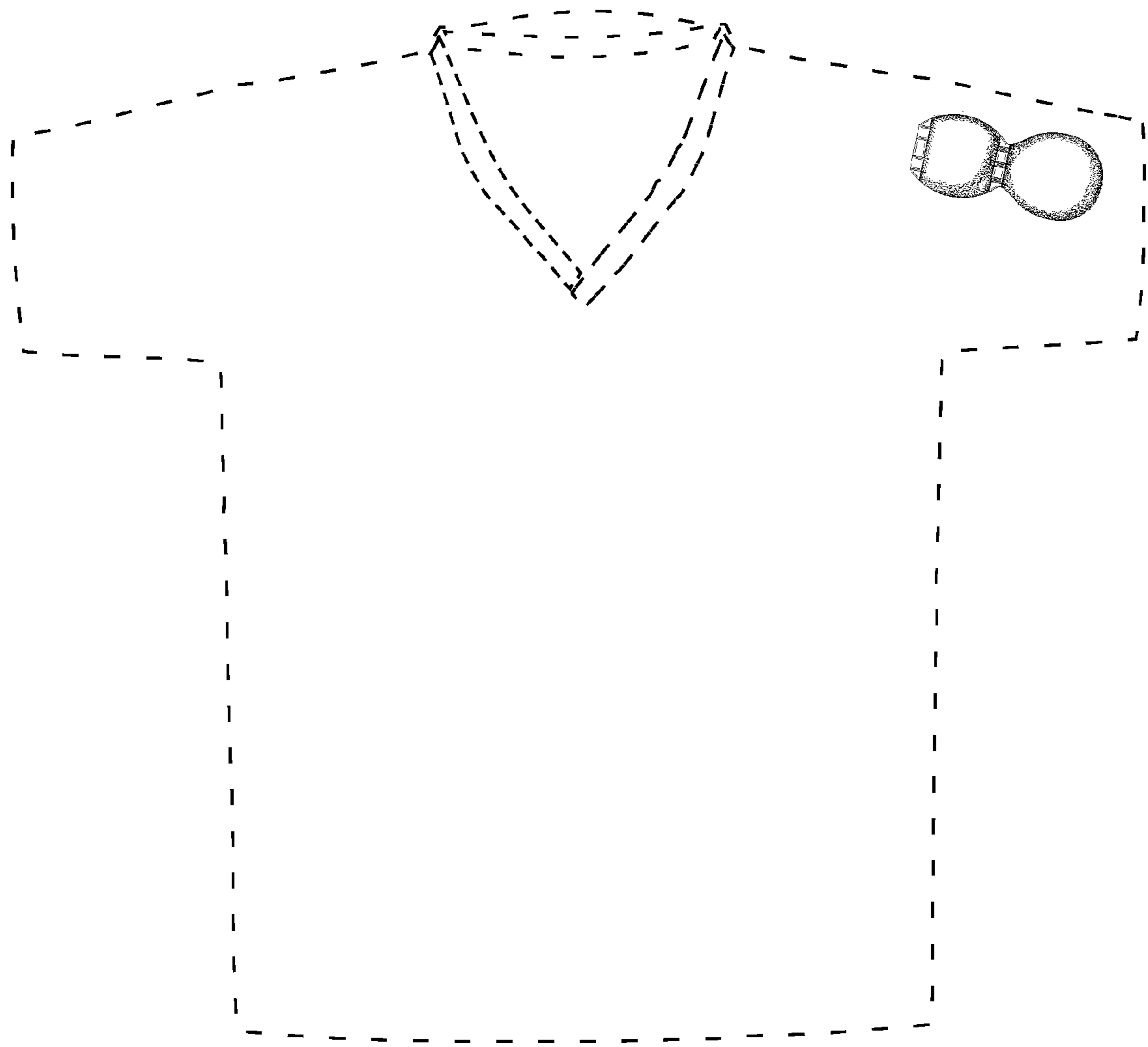
