(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top frontal perspective view of a shoe according to my new design;

FIG. 2 is a front view of the shoe shown in FIG. 1;

FIG. 3 is a rear view of the shoe shown in FIG. 1;

FIG. 4 is a left side view of the shoe shown in FIG. 1;

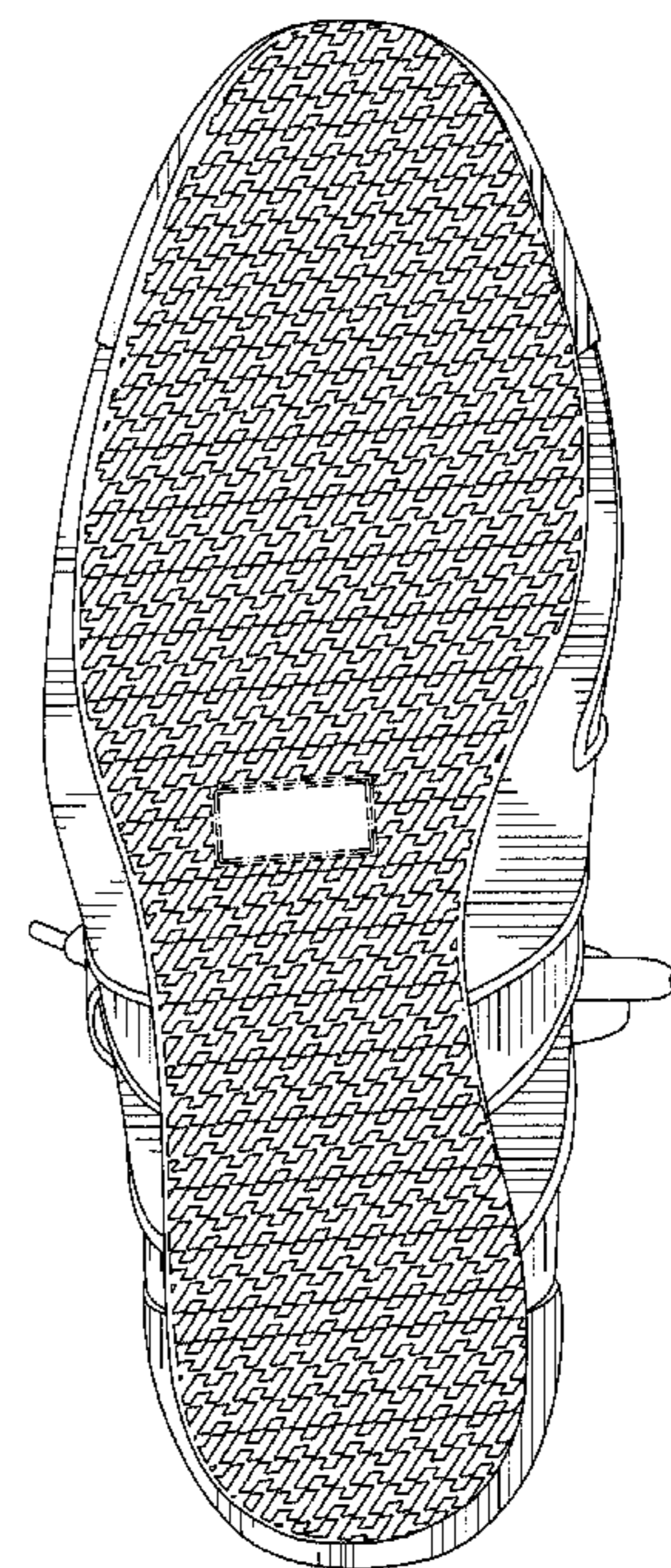
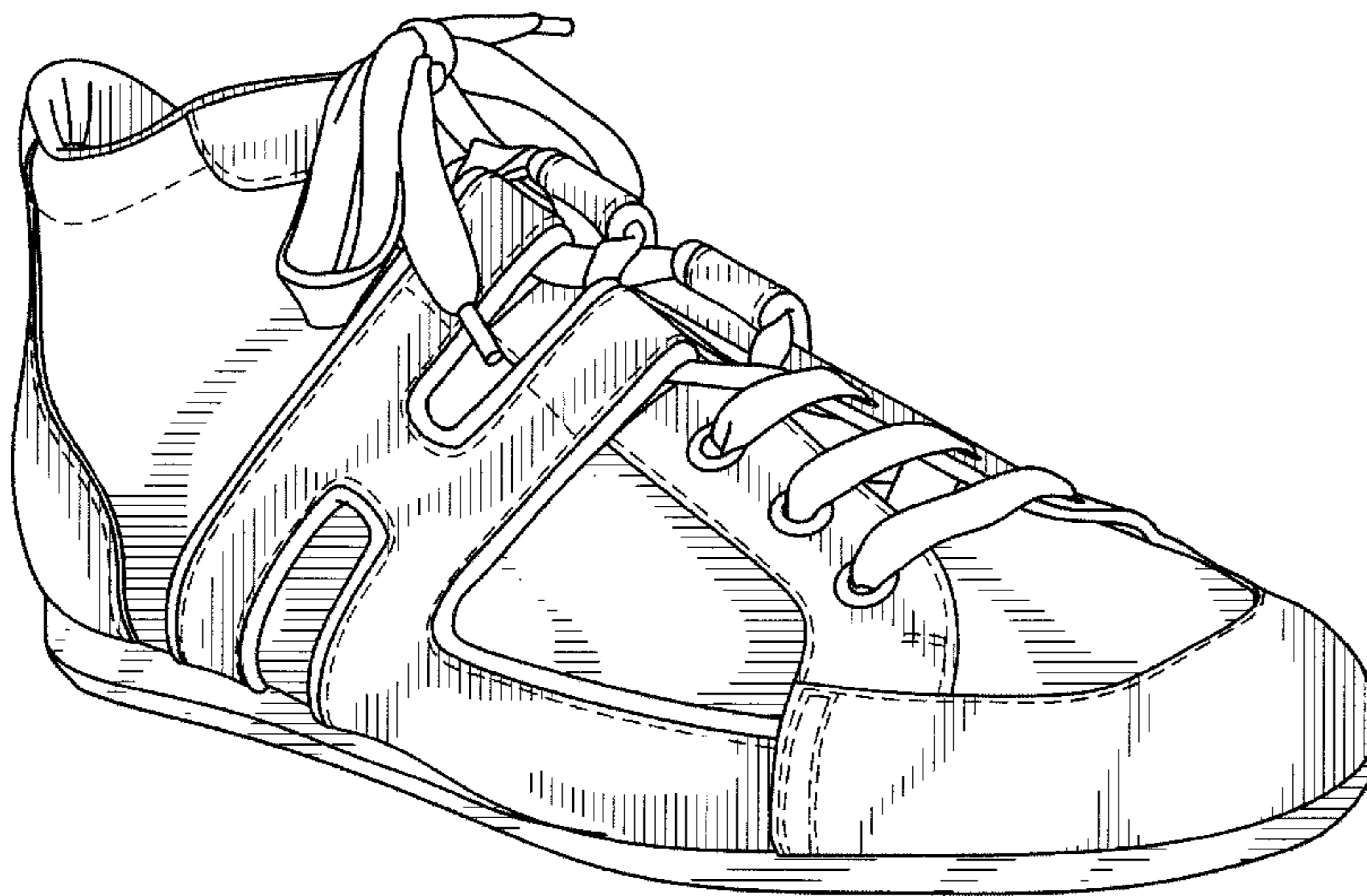
FIG. 5 is a right side view of the shoe shown in FIG. 1;

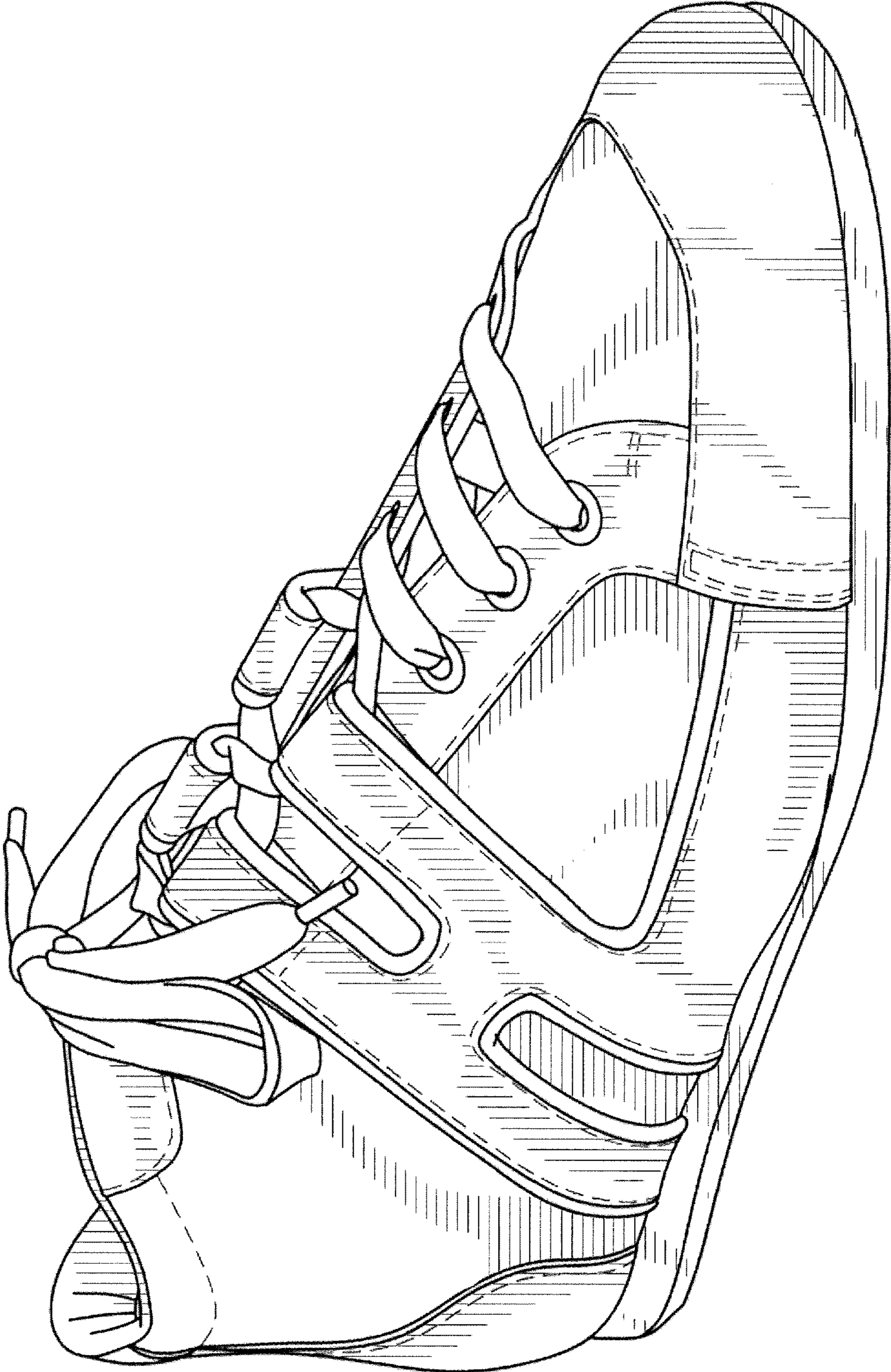

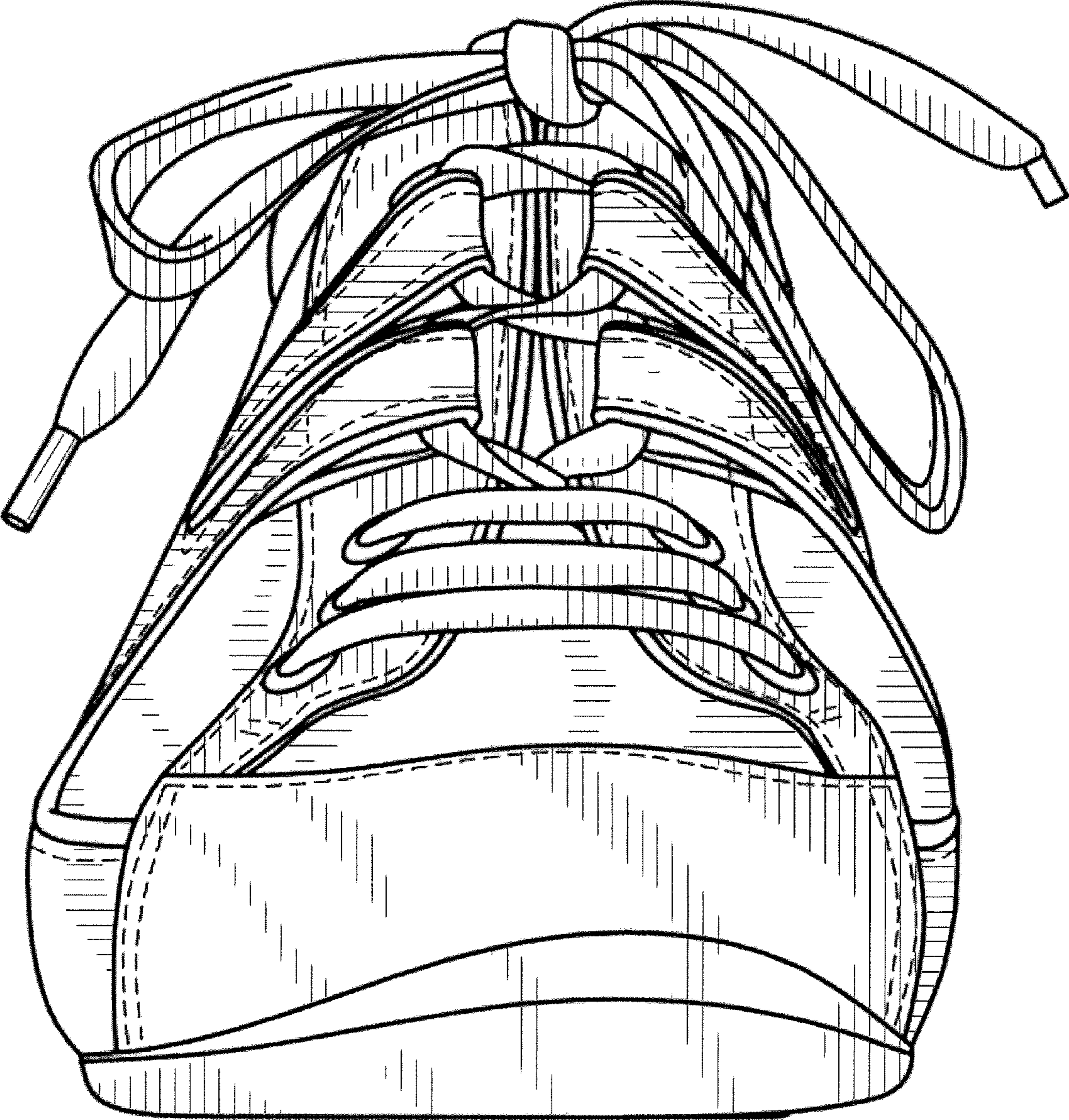

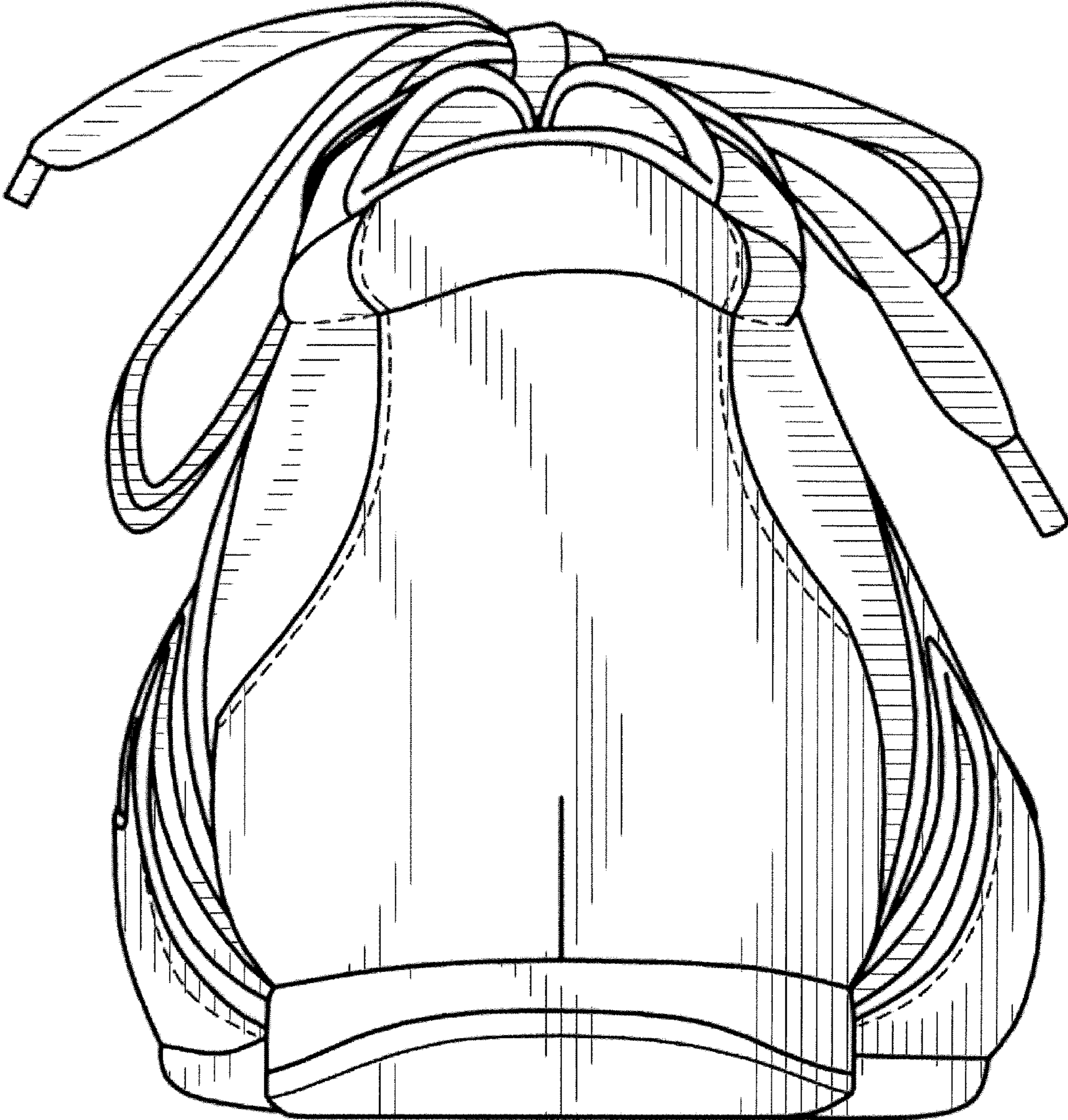

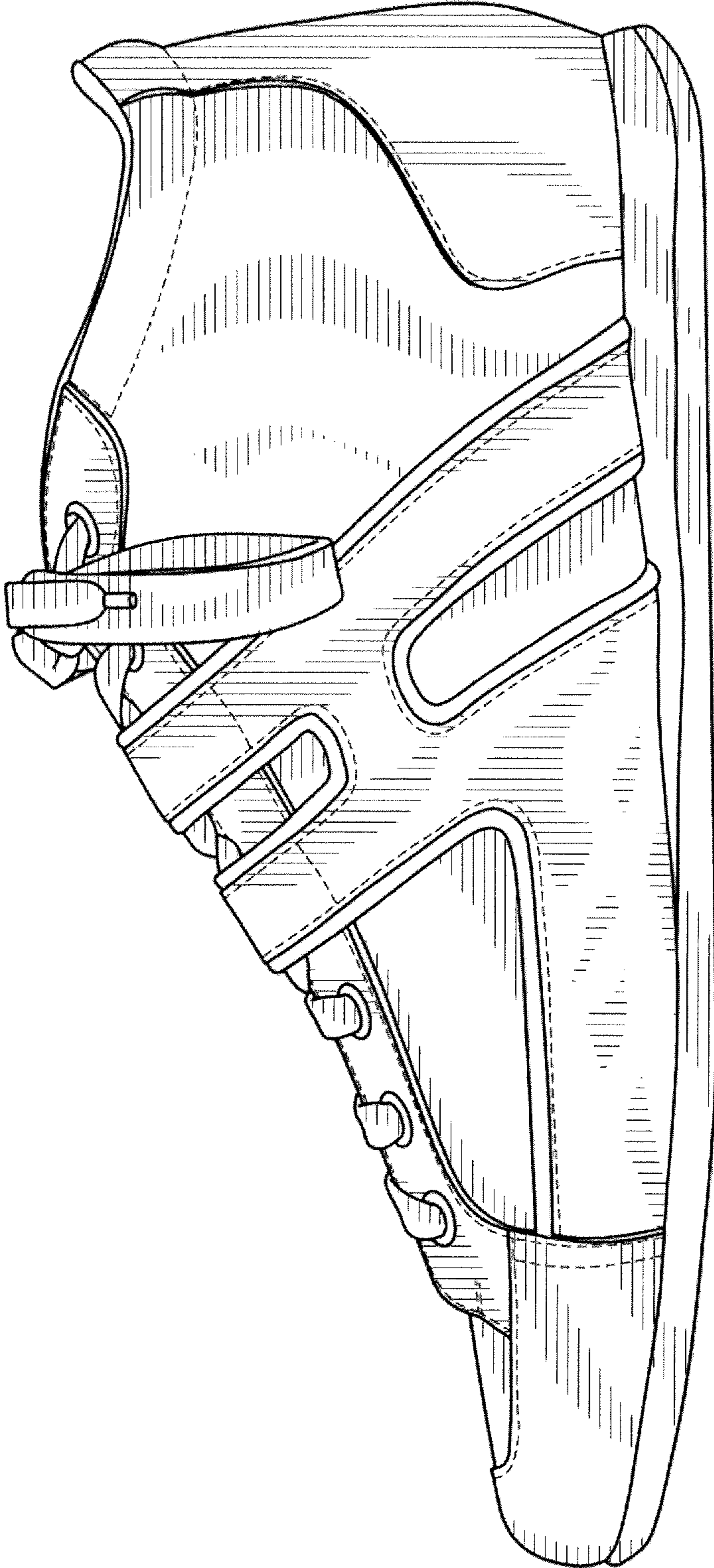

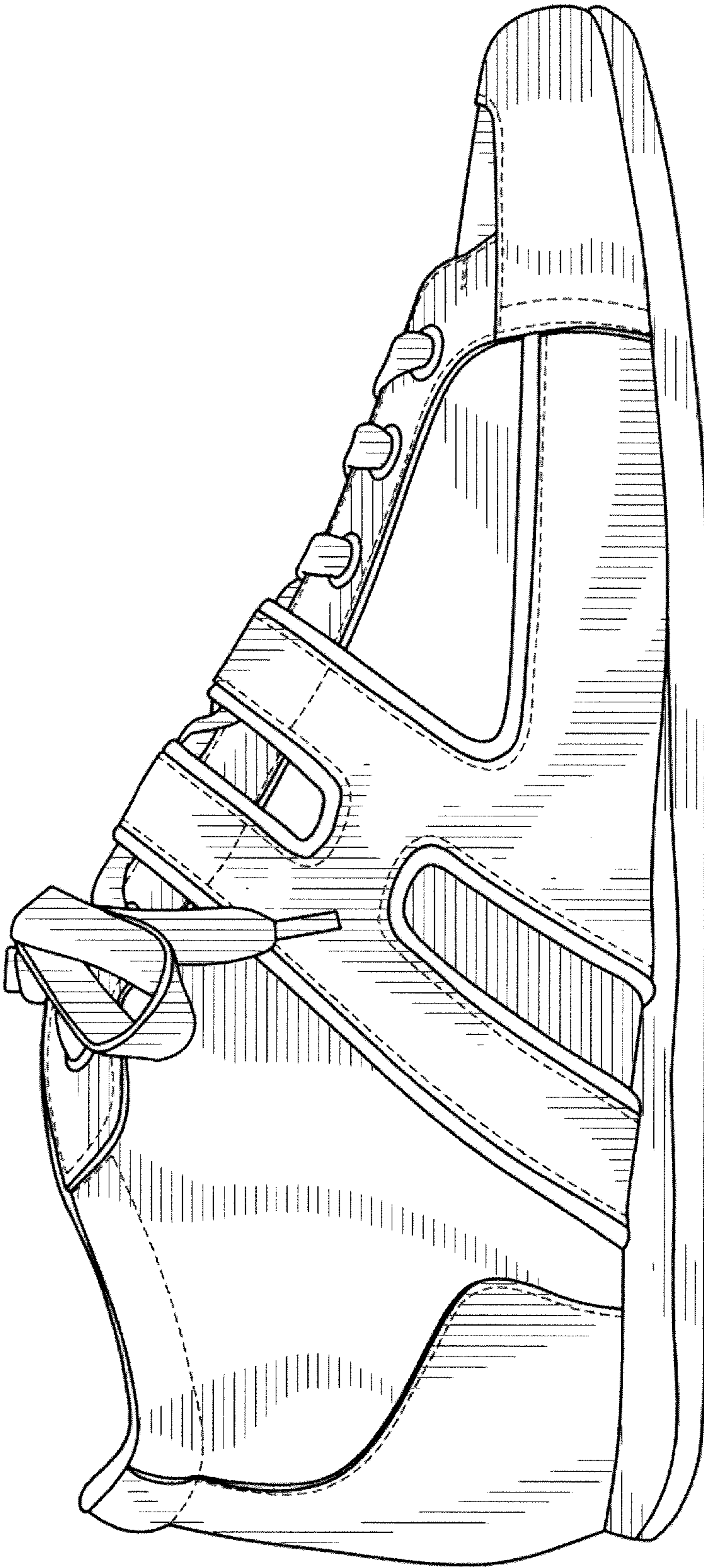

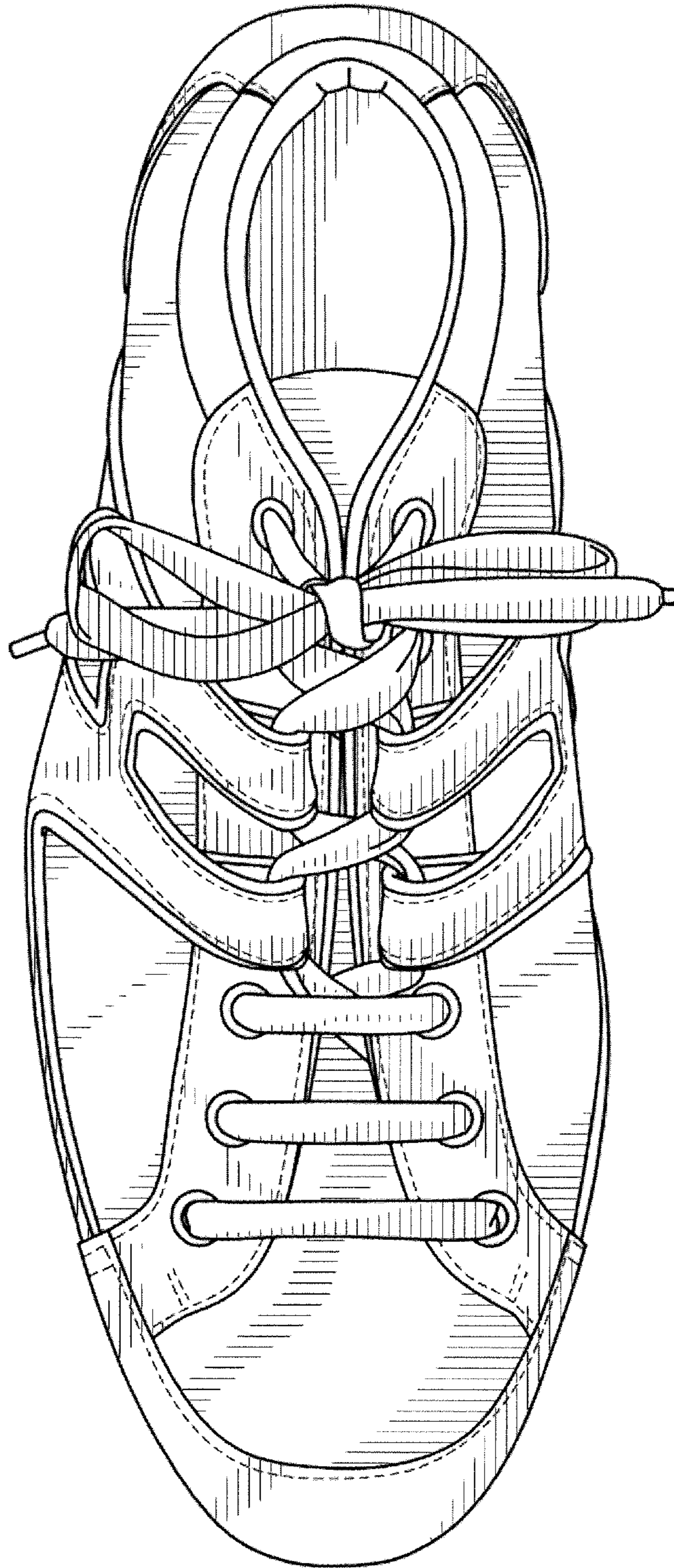

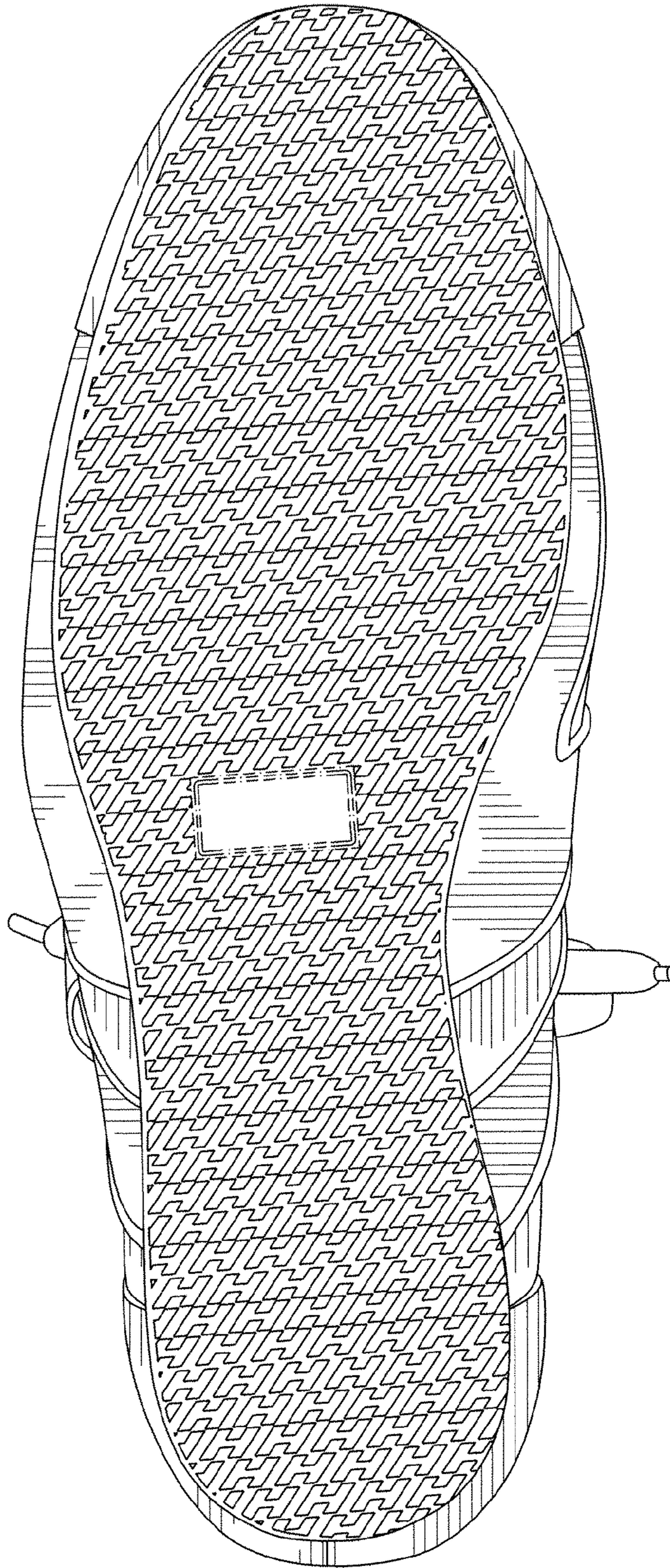
