(57) **CLAIM**

What is claimed is the ornamental design for a horizontal holster with strap pegs, as shown and described.

DESCRIPTION

FIG. 1 is a front view (flap closed) showing the horizontal holster with strap pegs of Applicant's invention.

FIG. 2 is a front view (flap open) of the horizontal holster with strap pegs of Applicant's invention.

FIG. 3 is a back view (flap closed) of the horizontal holster with strap pegs of Applicant's invention.

FIG. 4 is a back view (flap open) of the horizontal holster with strap pegs of Applicant's invention.

FIG. 5 is a top view (flap open) of the horizontal holster with strap pegs of Applicant's invention.

FIG. 6 is a top view (flap closed) of the horizontal holster with strap pegs of Applicant's invention.

FIG. 7 is a left side view (flap open) of the horizontal holster with strap pegs of Applicant's invention.

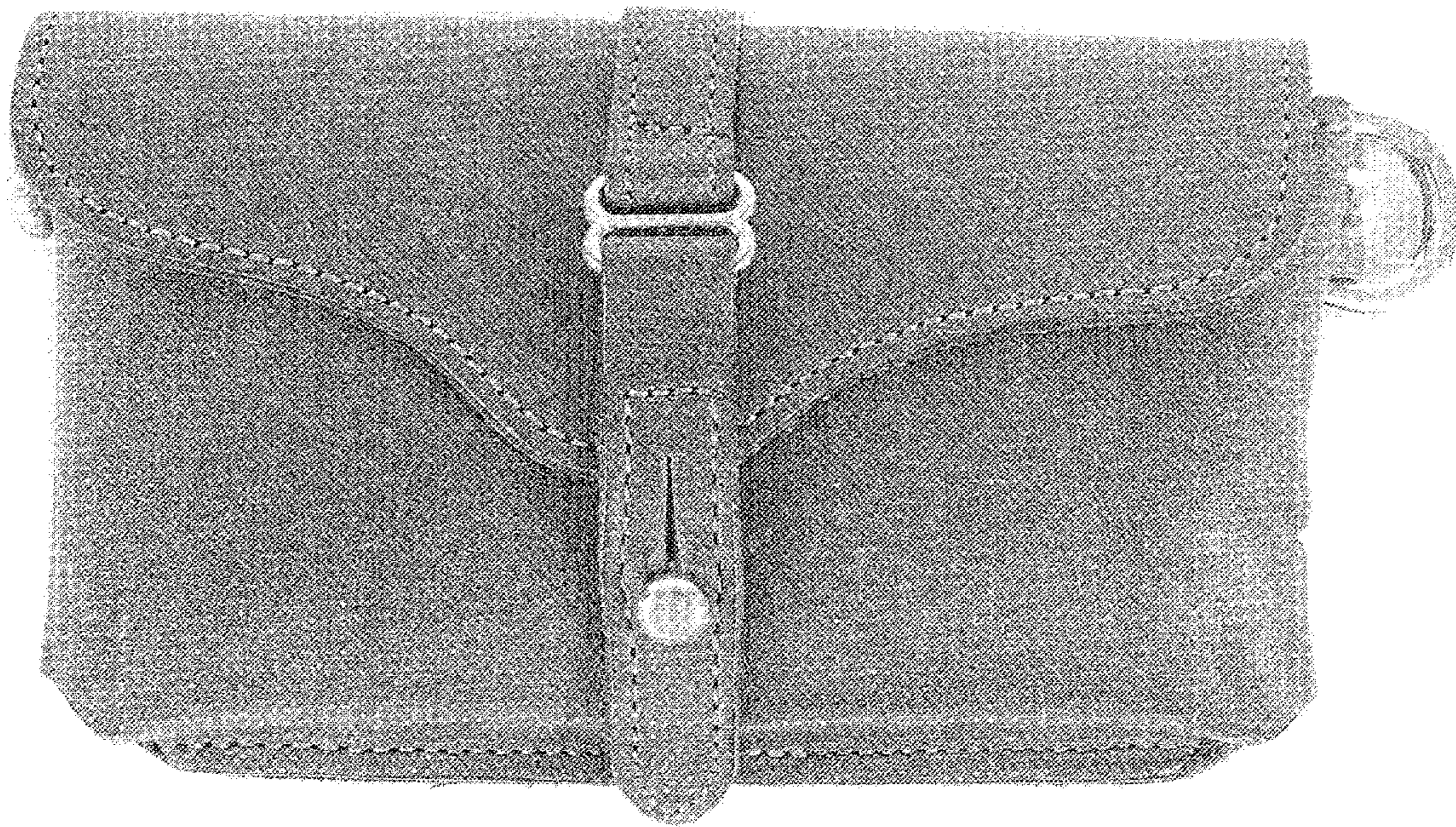
FIG. 8 is a left side view (flap closed) of the horizontal holster with strap pegs of Applicant's invention.

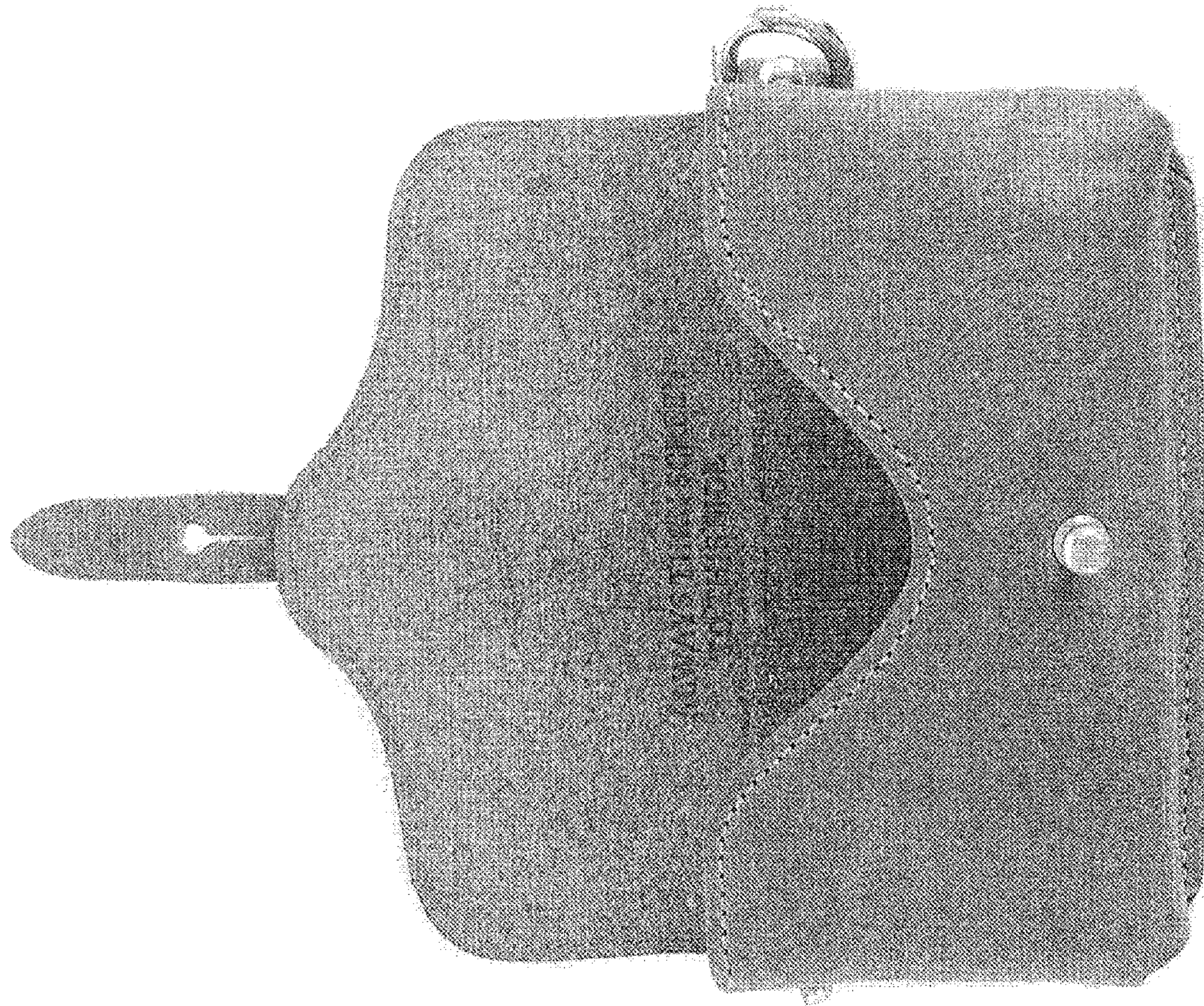


Fig. 2 - Front View/Flap

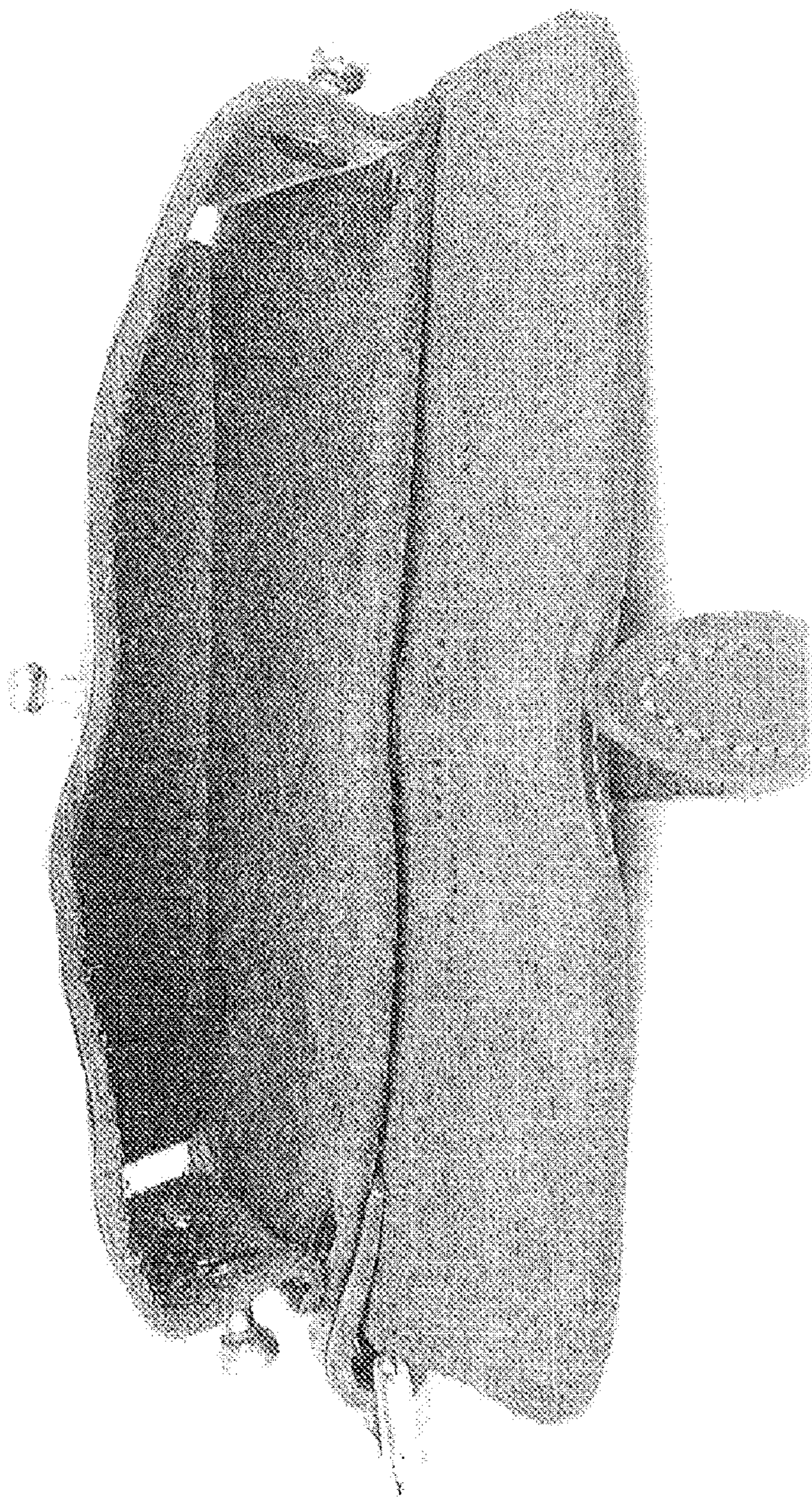


Fig. 5 - Top View/Flap
Open

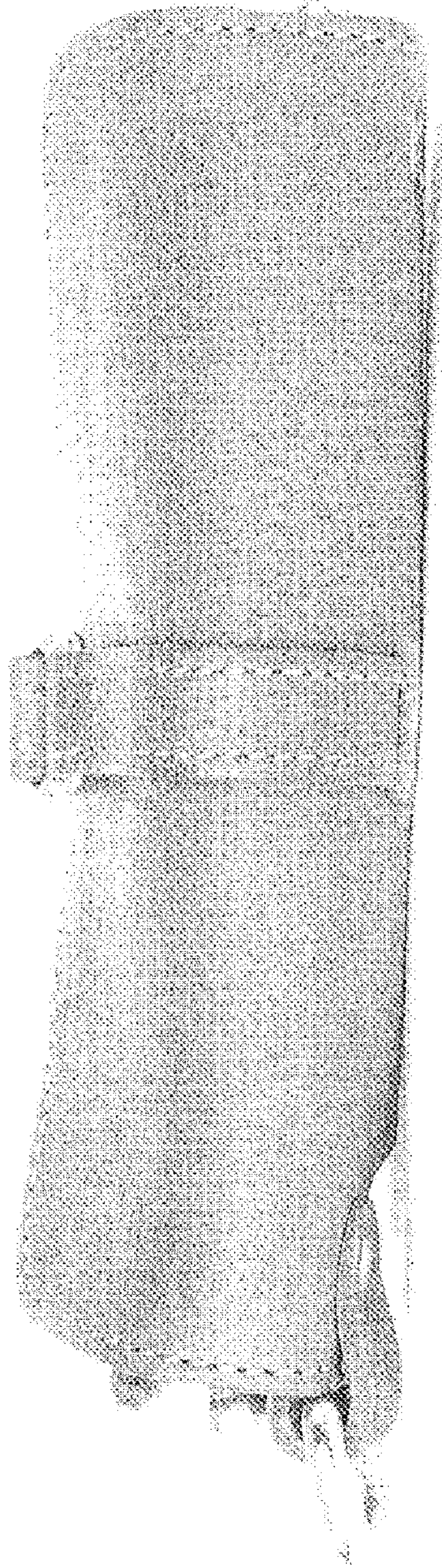


Fig. 6 -- Top View/Flap
Closed

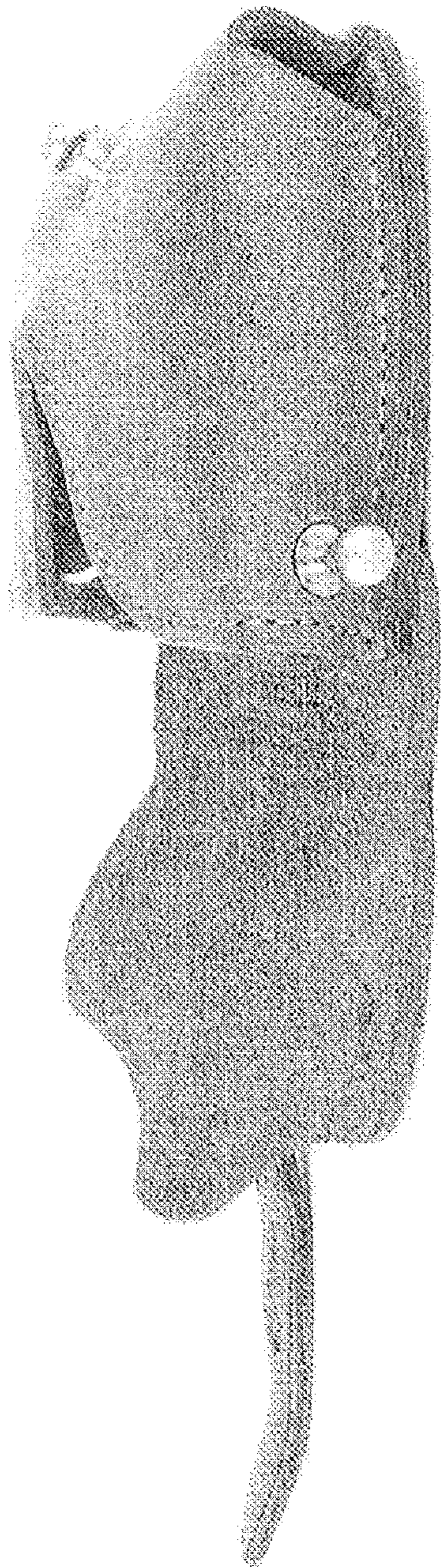


Fig. 7 — Left Side View/
Flap Open

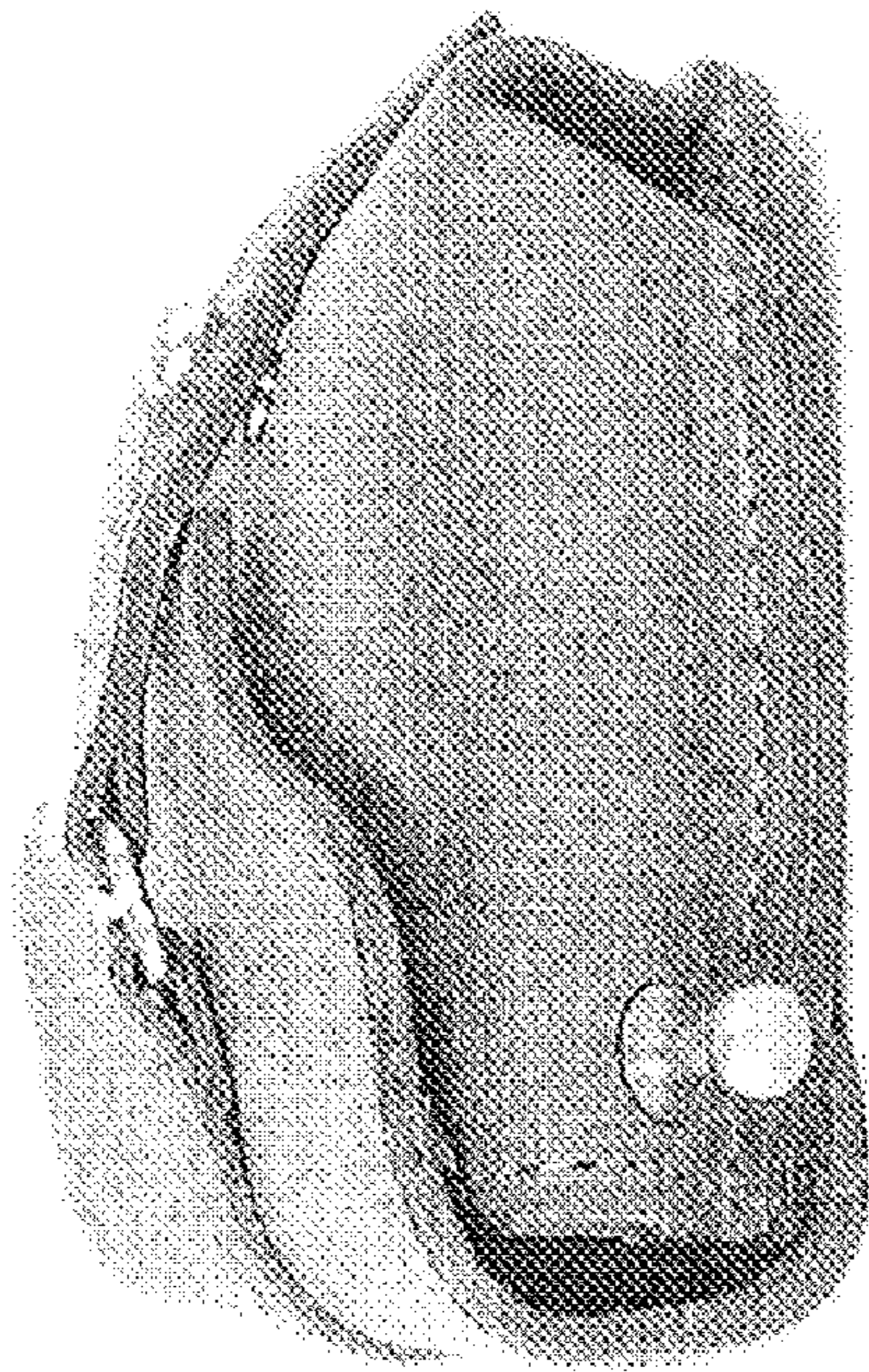


Fig. 8 - Left Side View/Flap
Closed

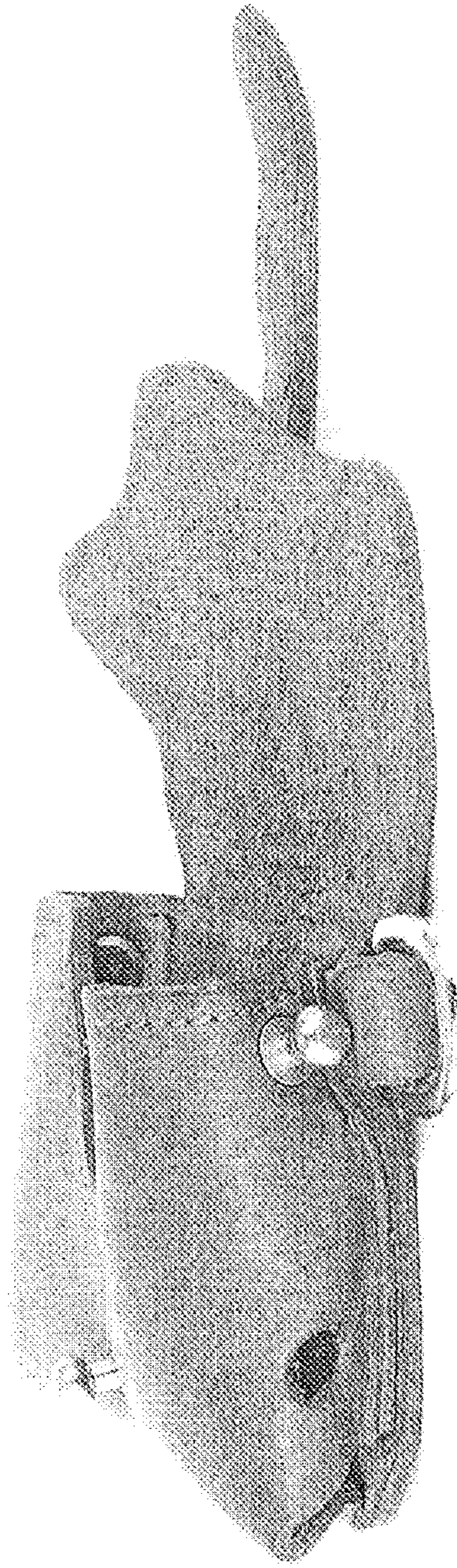


Fig. 9 -- Right Side View/Flap
Open

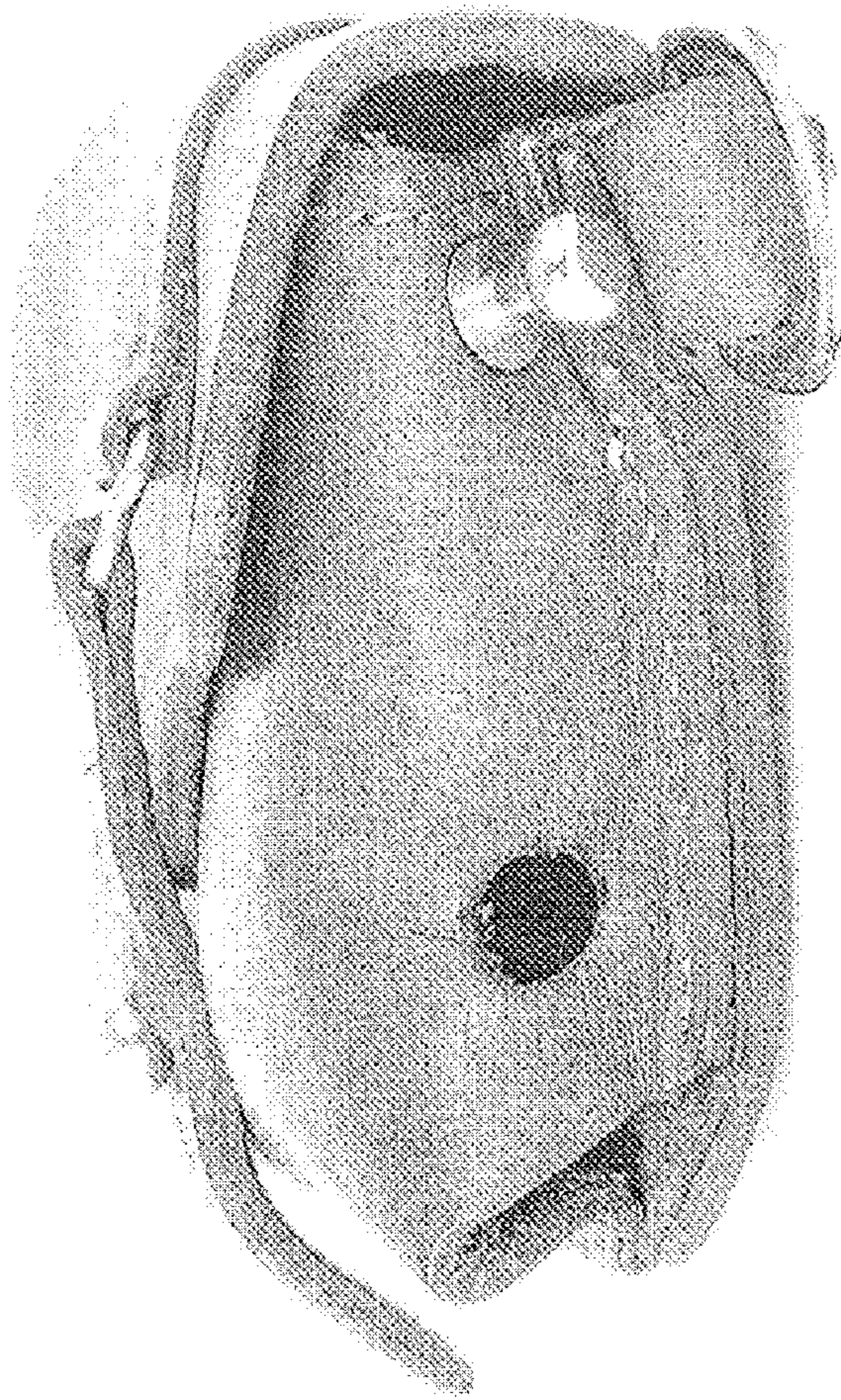


Fig. 10 - Right Side View/
