FIG. 4 is a rear view of the beverage container shown in FIG. 1;

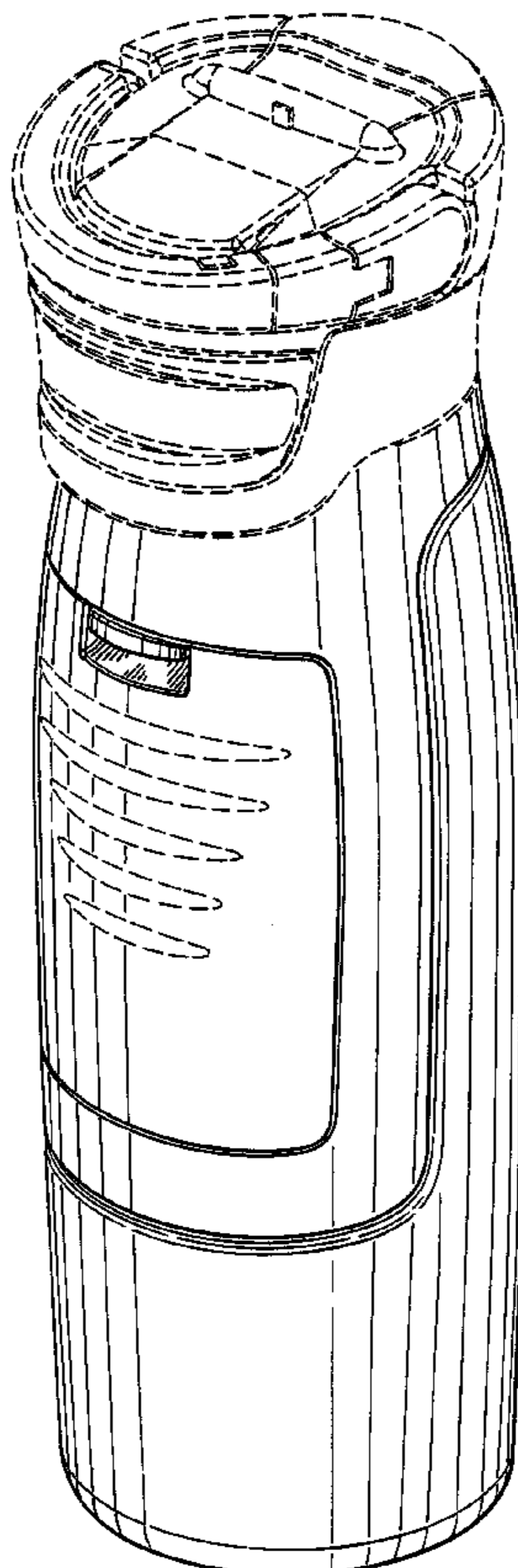
FIG. 5 is a left side view of the beverage container shown in FIG. 1;

FIG. 6 top view of the beverage container shown in FIG. 1; and,

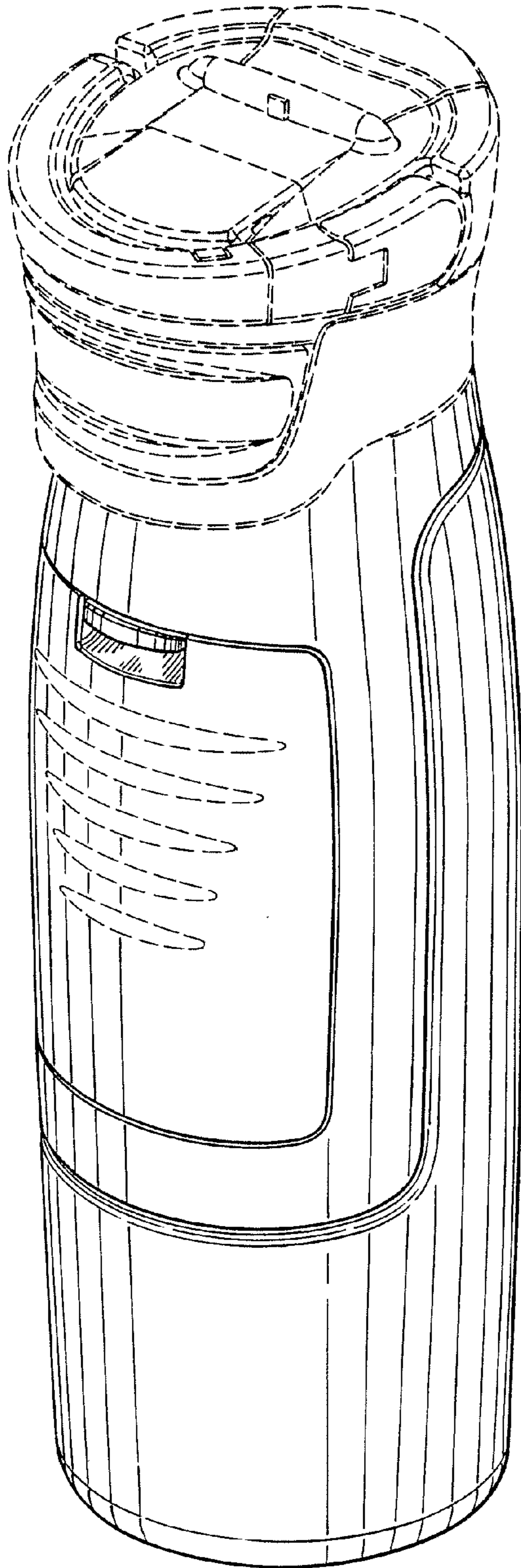
FIG. 7 is a bottom view of the beverage container shown in FIG. 1.

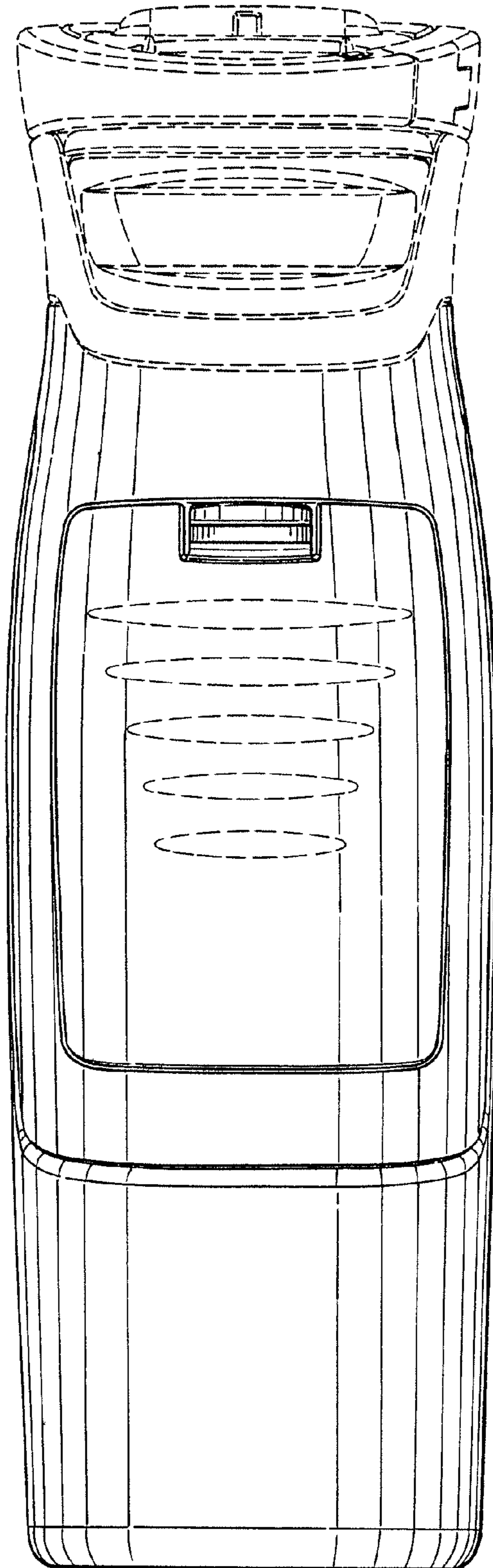

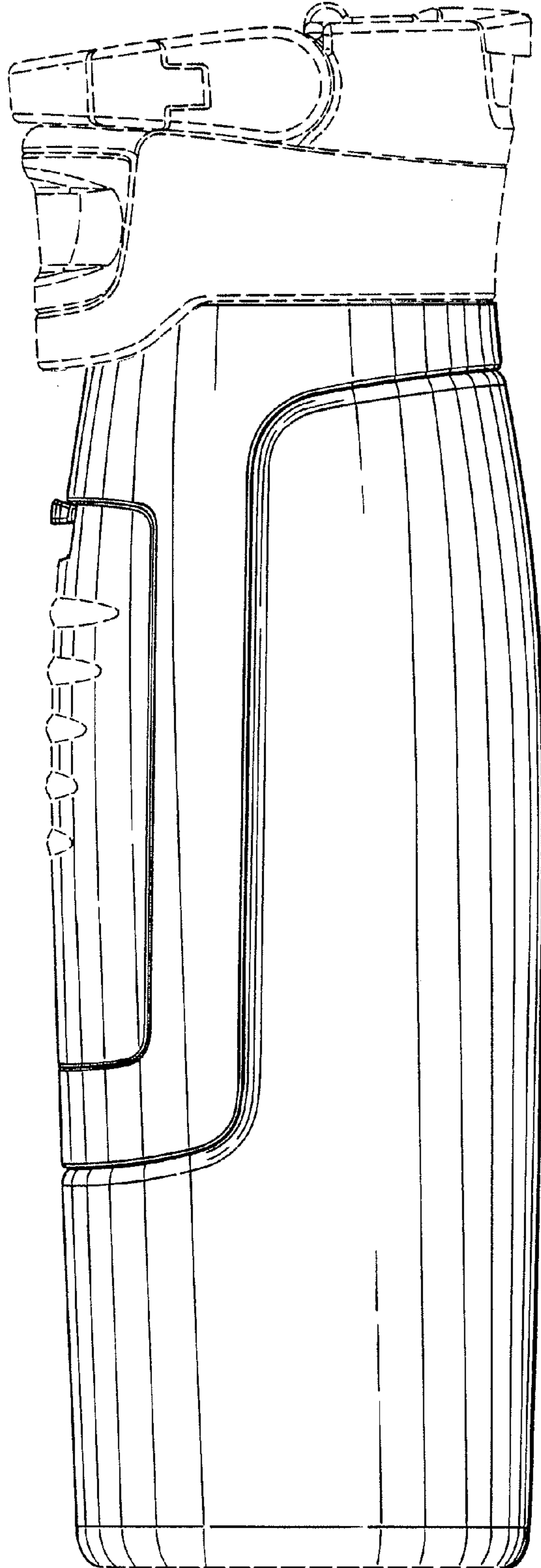

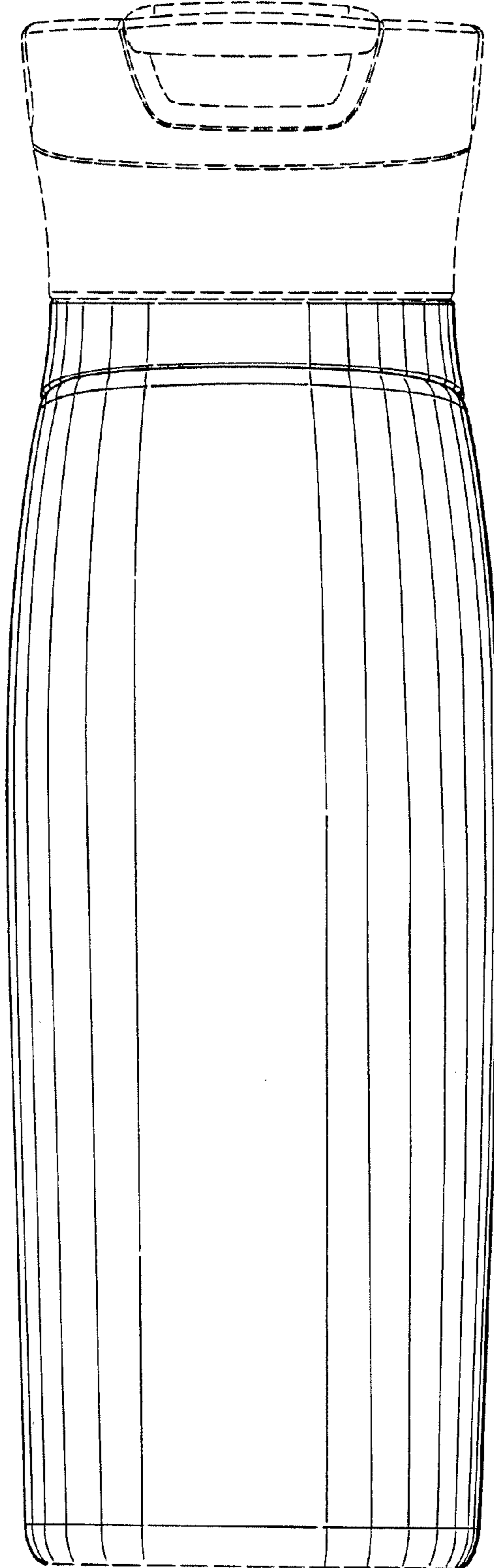

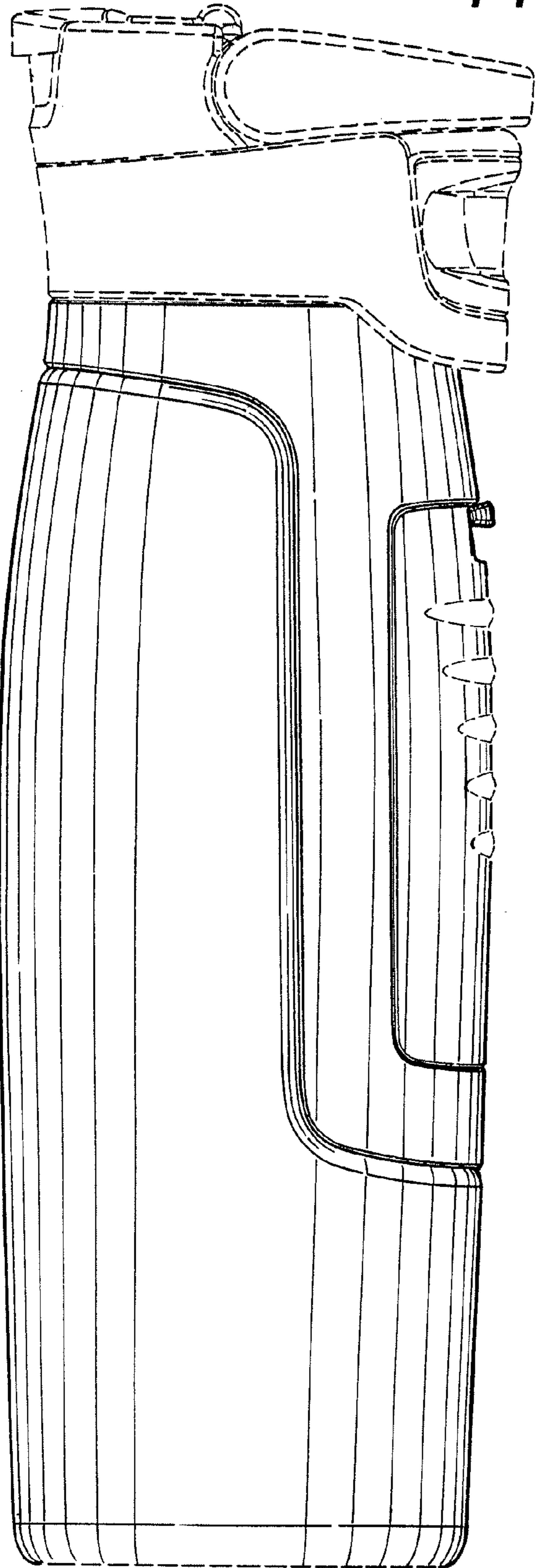

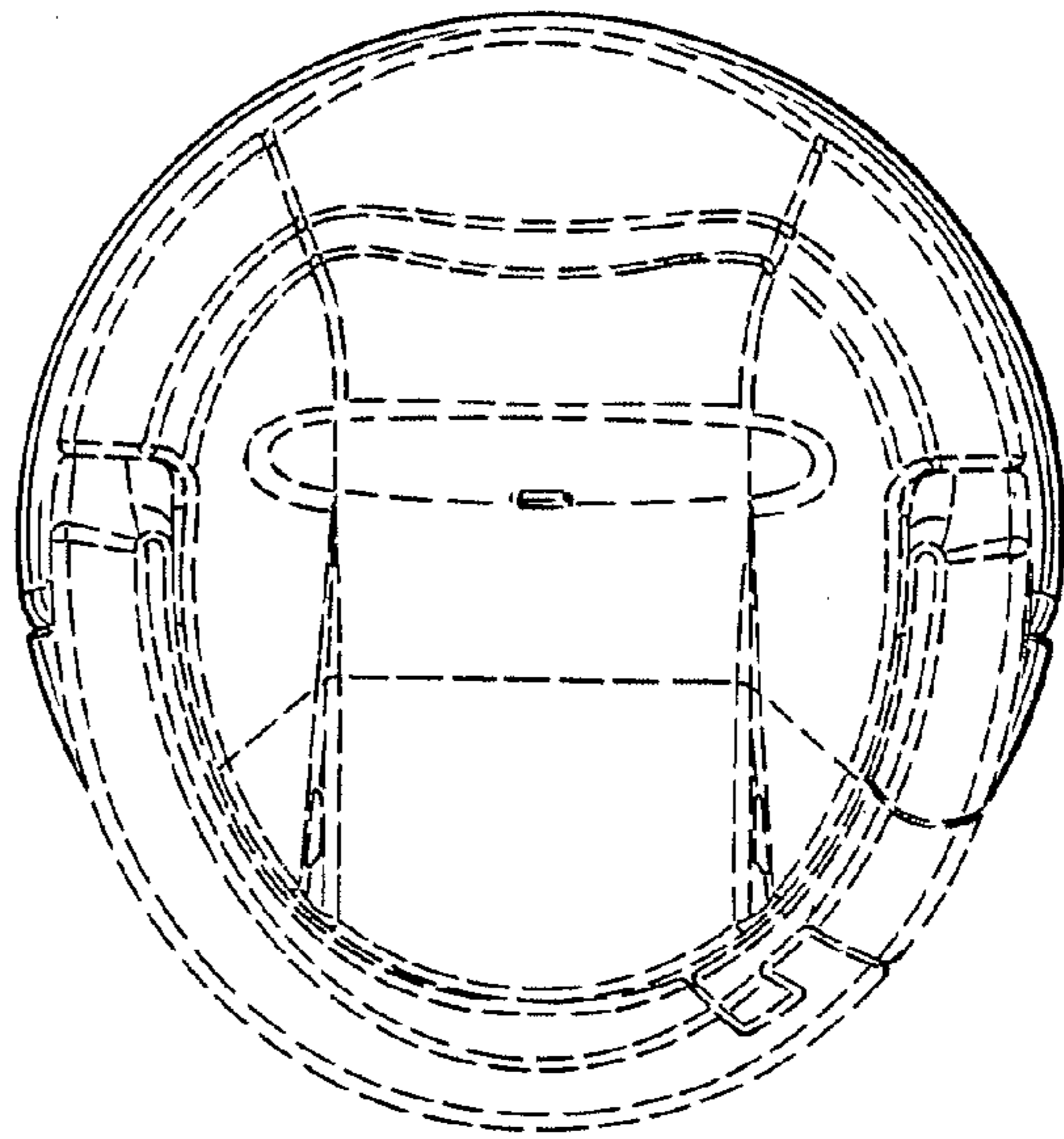
