FIG. 2 is a bottom plan view thereof;

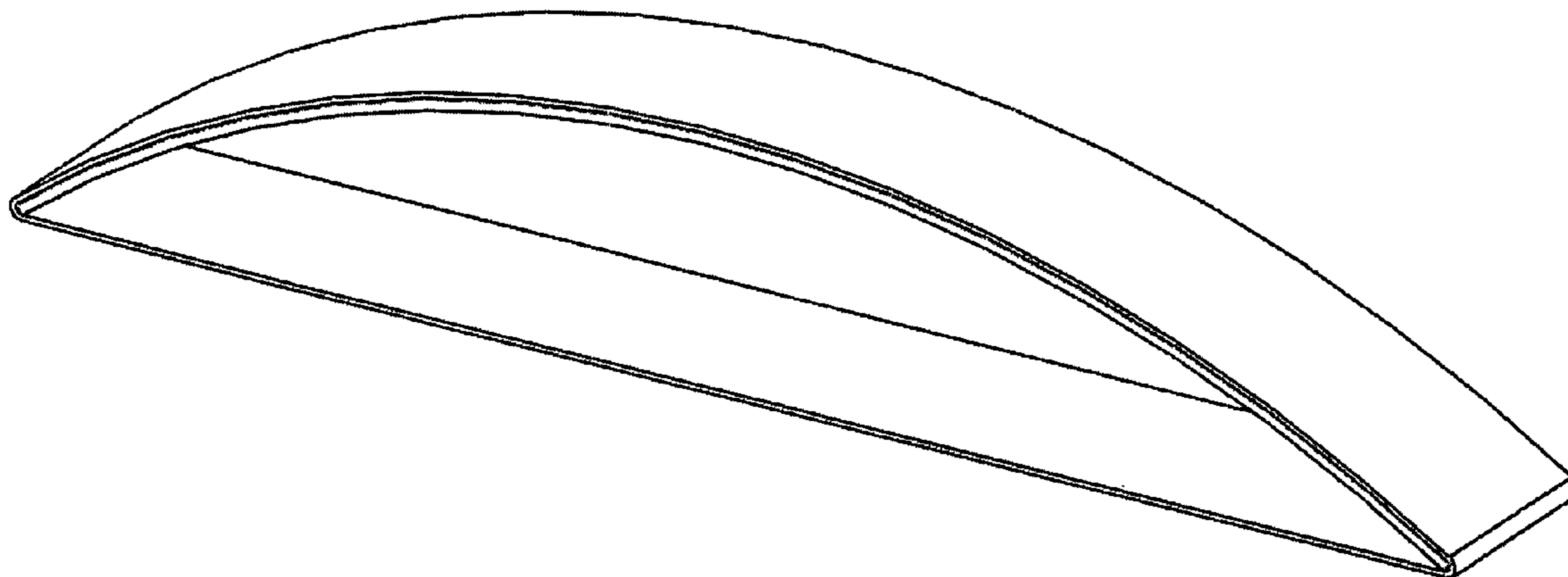
FIG. 3 is a front elevational view thereof, the rear elevational view being identical;

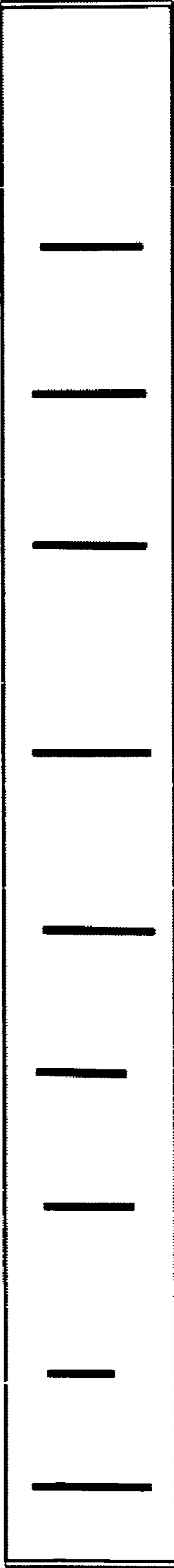
FIG. 4 is a right side elevational view thereof, the left side elevational view being identical; and,

FIG. 5 is a perspective view thereof.

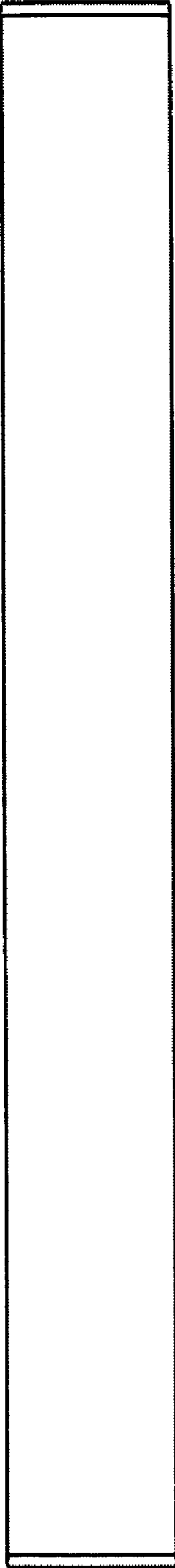
The handheld flexible sander, comprised of a flexible insert and a sandpaper belt, is shown in a bow configuration.

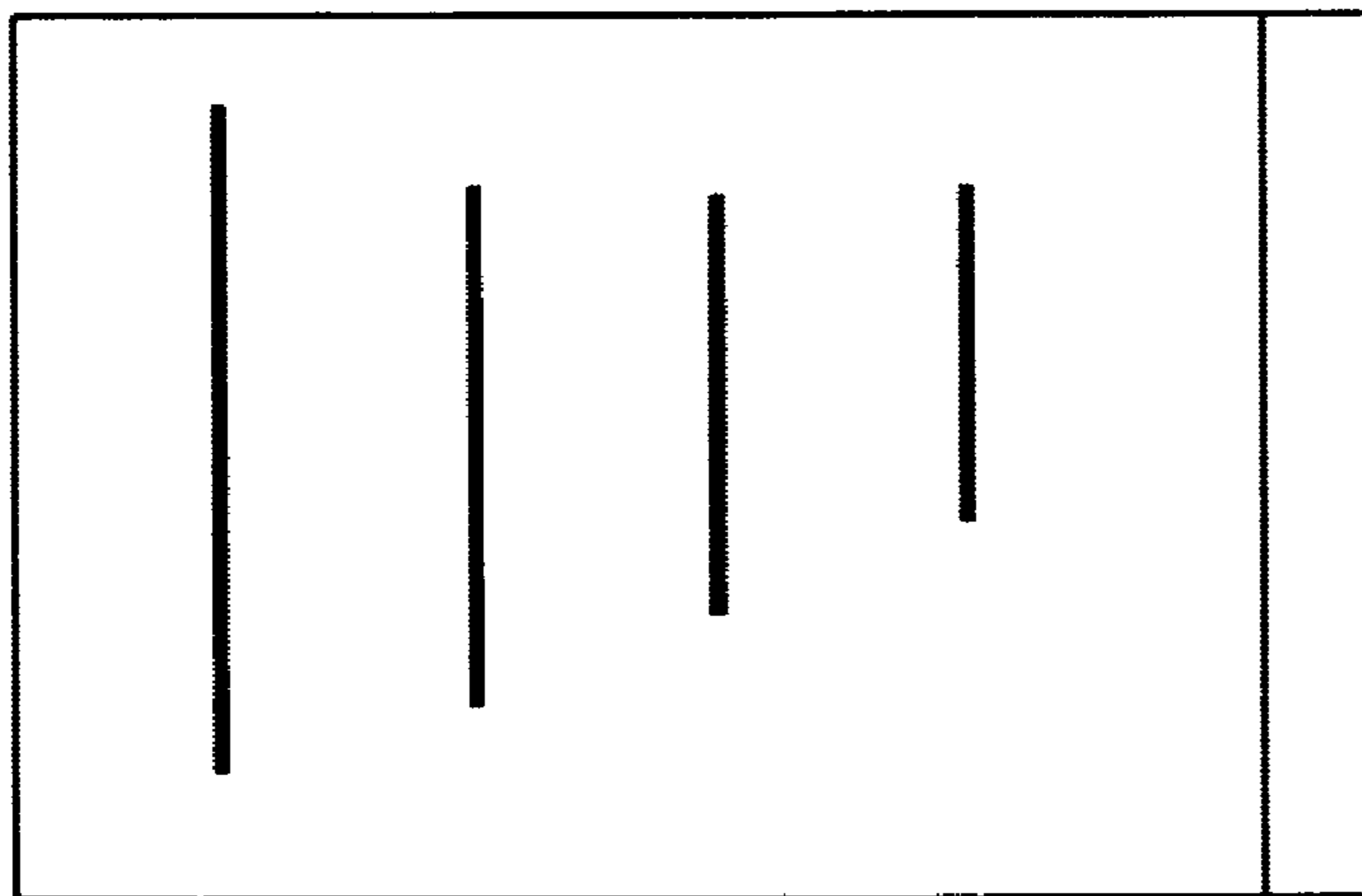




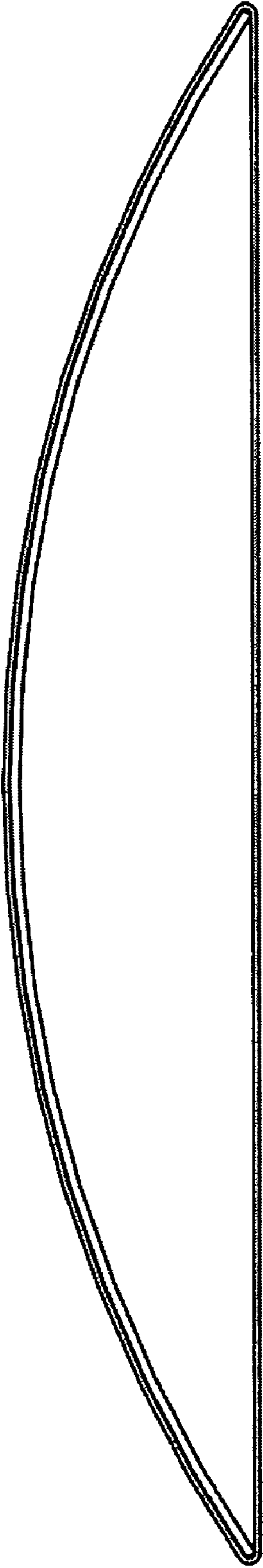

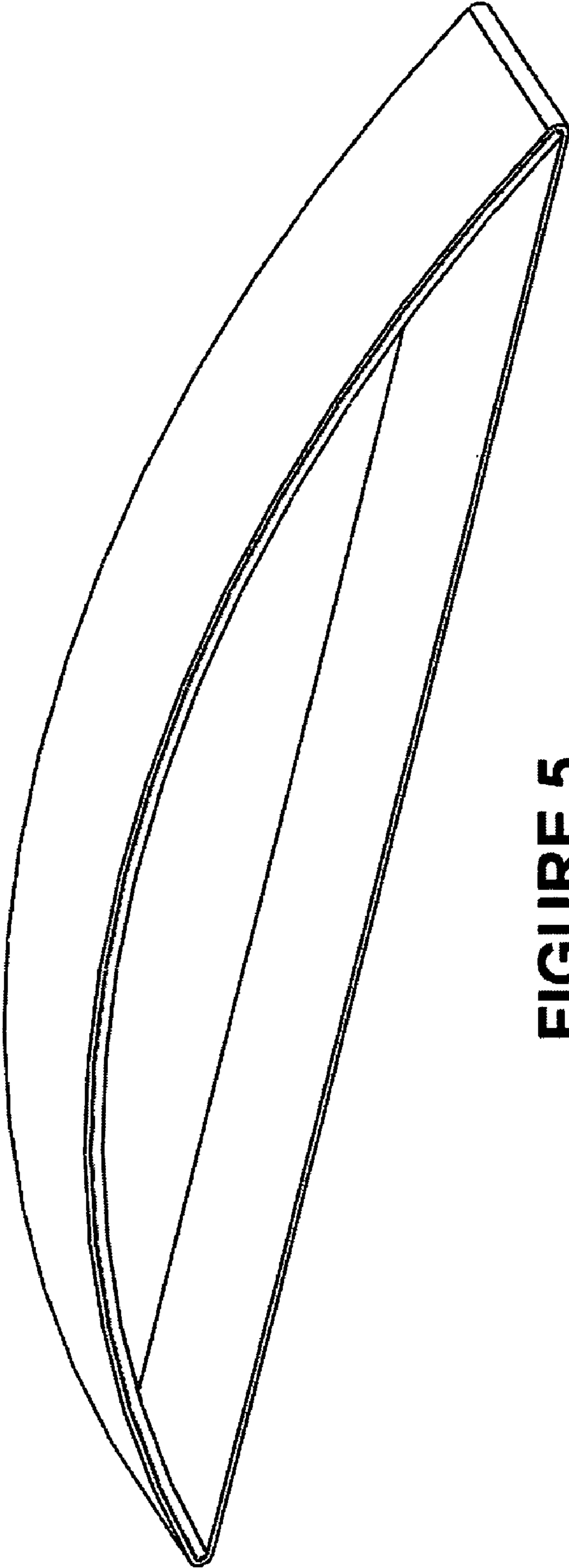
