The ornamental design for a box with logo cutout wraparound closing flap, as shown and described.

DESCRIPTION

FIG. 18 is a side view thereof from the right;

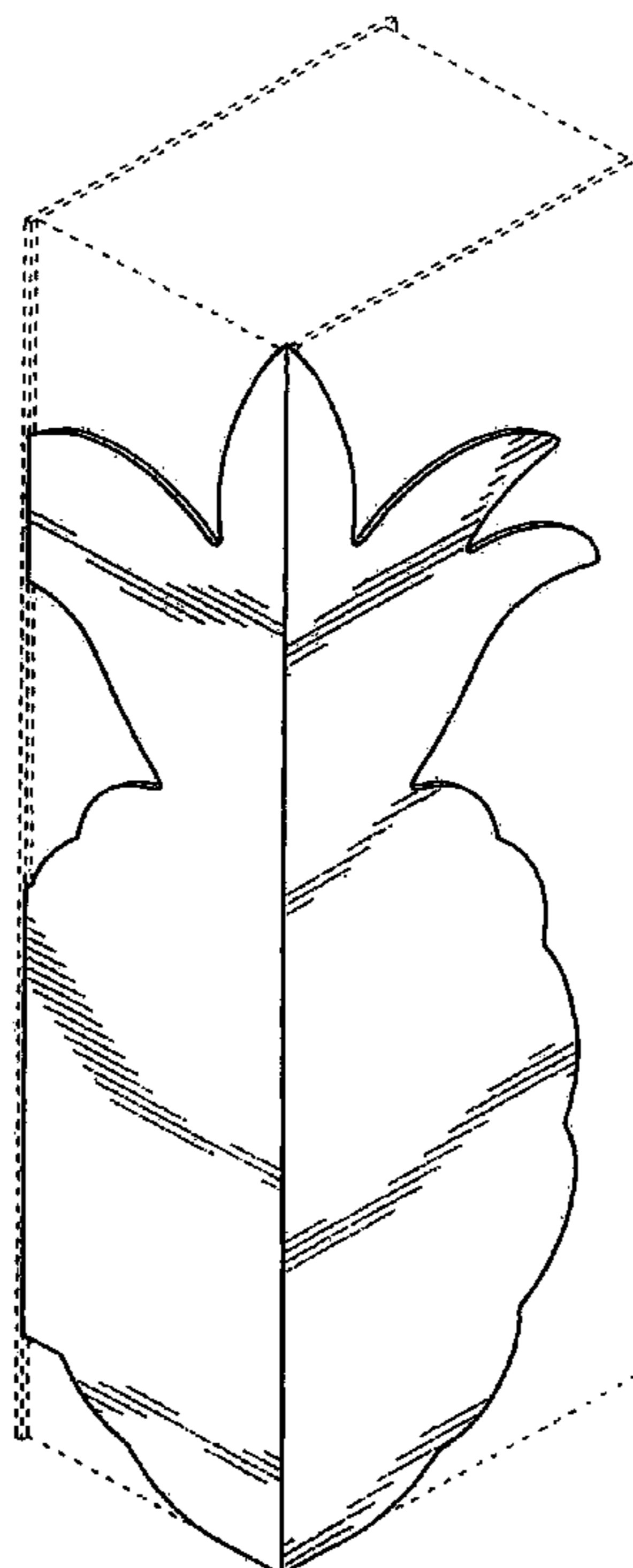
FIG. 19 is a side view thereof from the left;

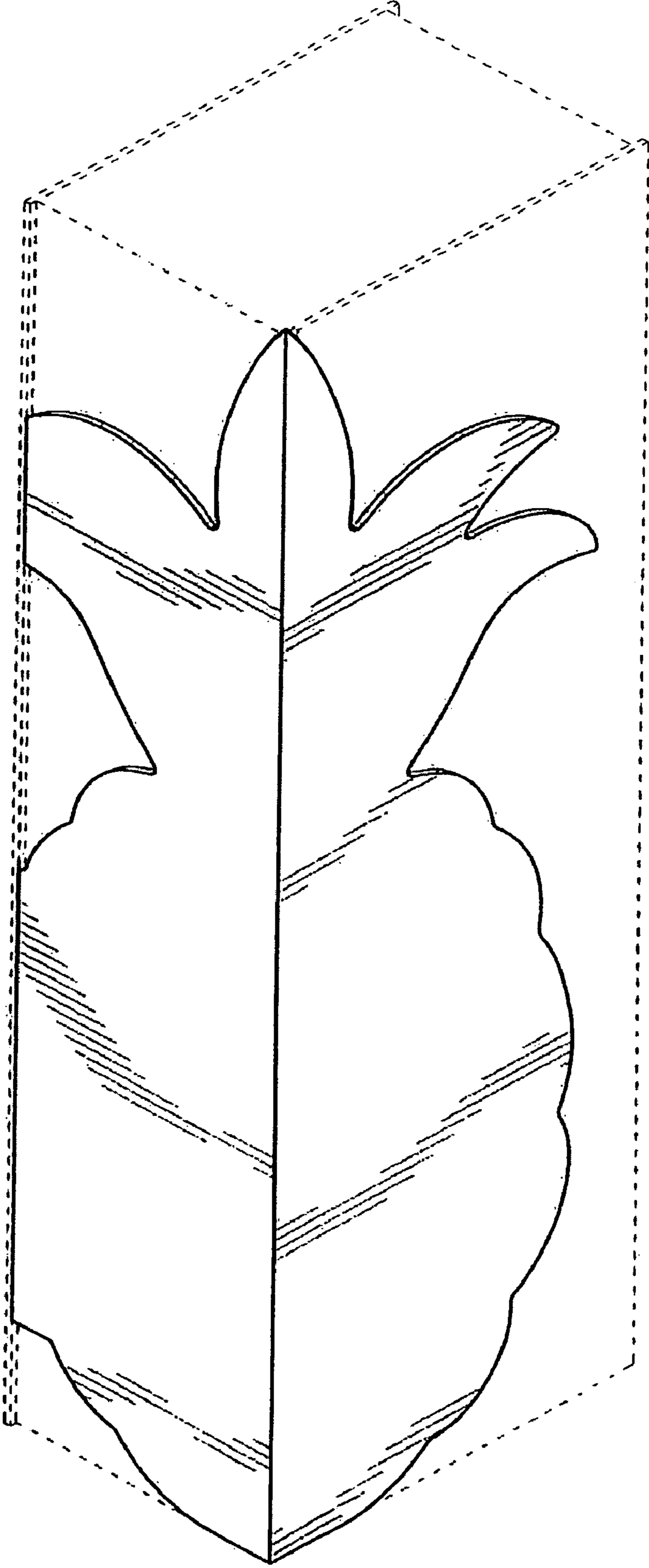

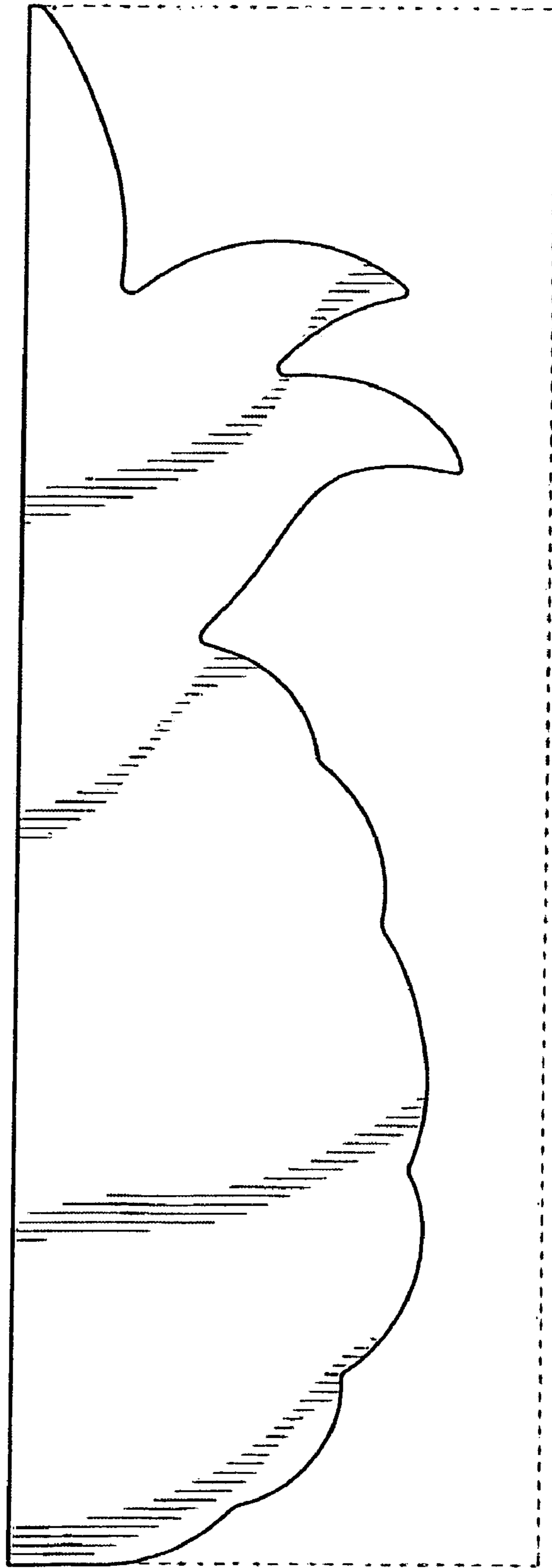

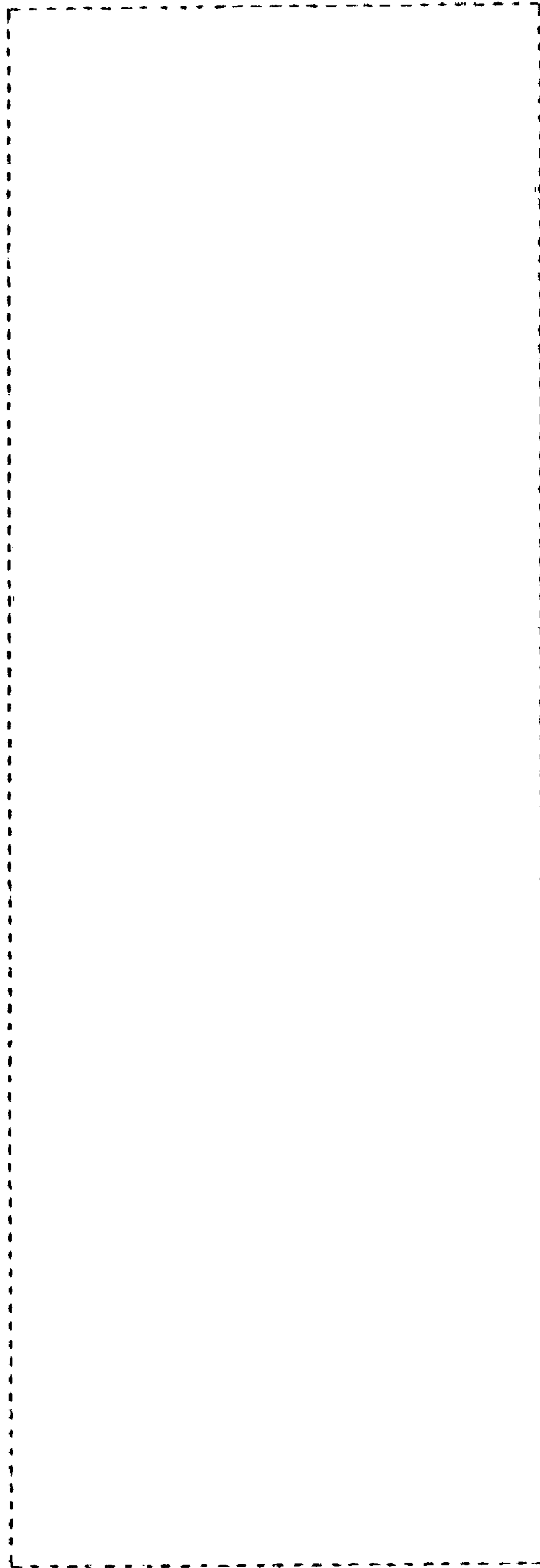

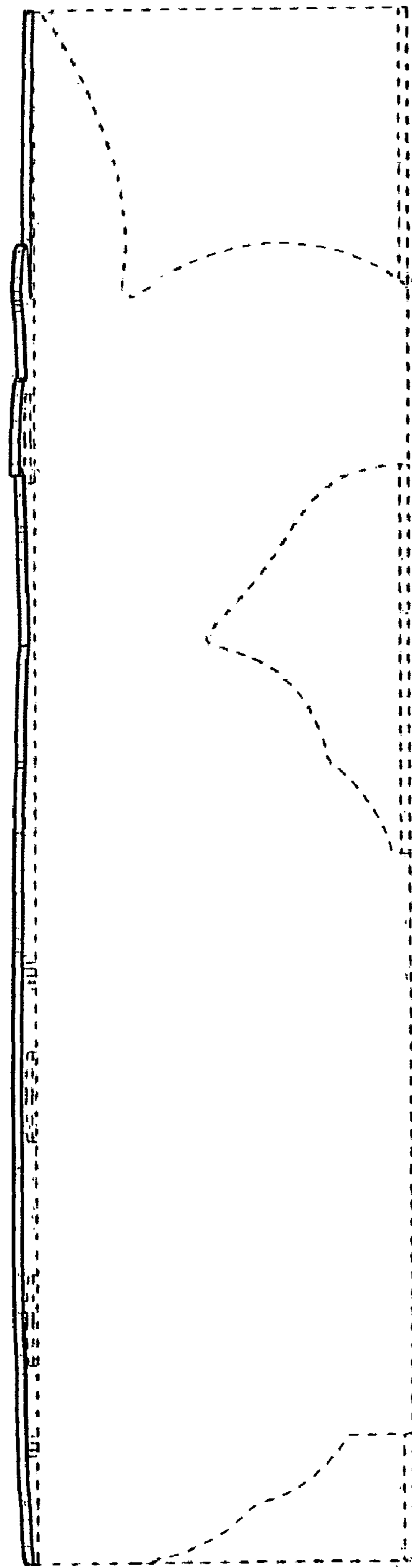

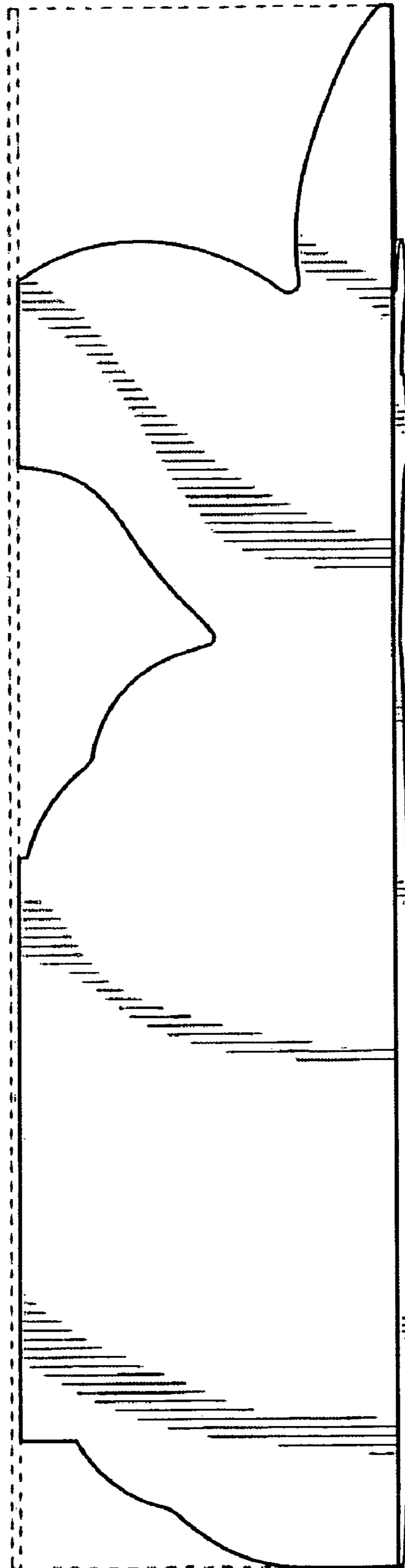

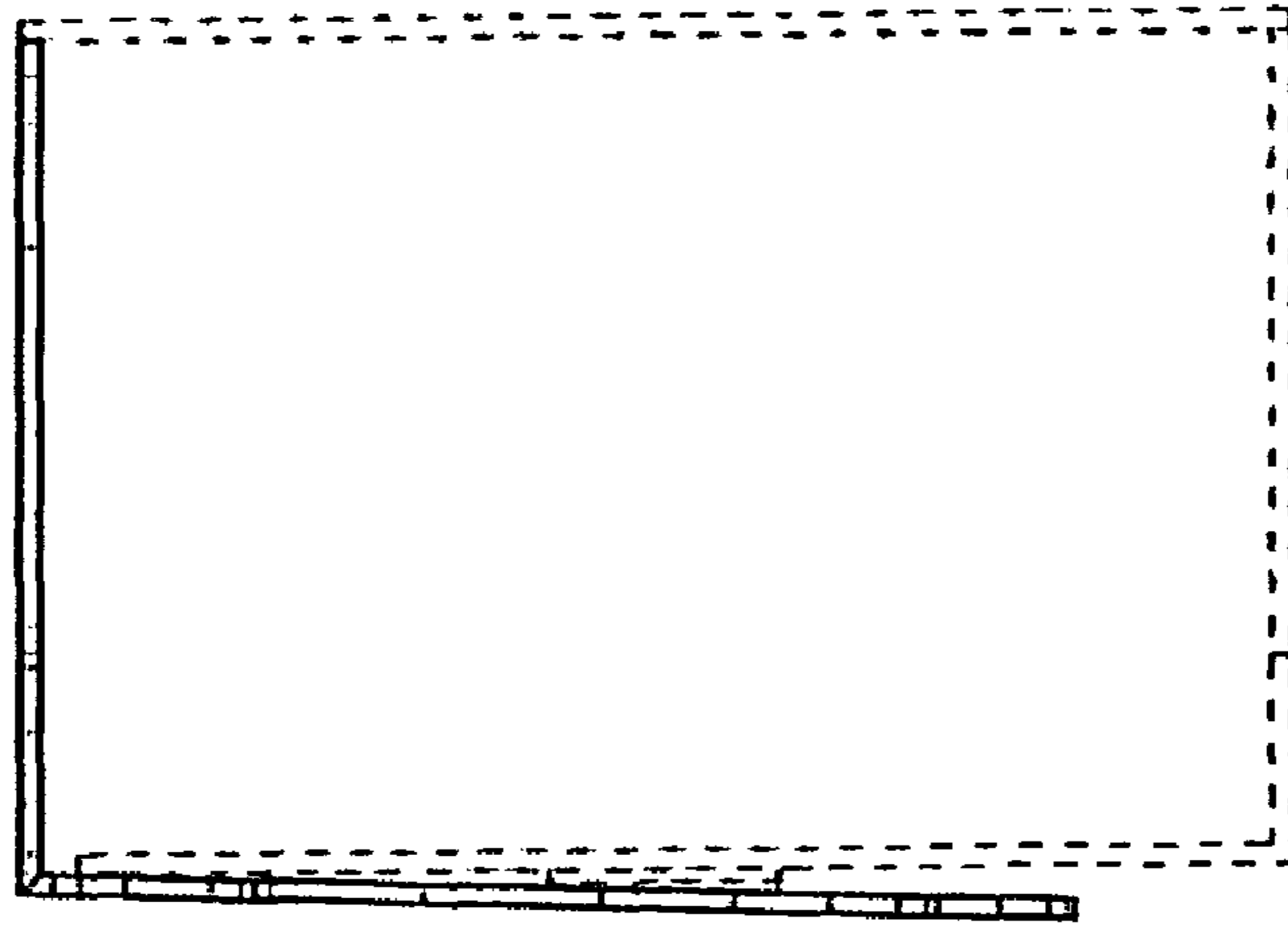

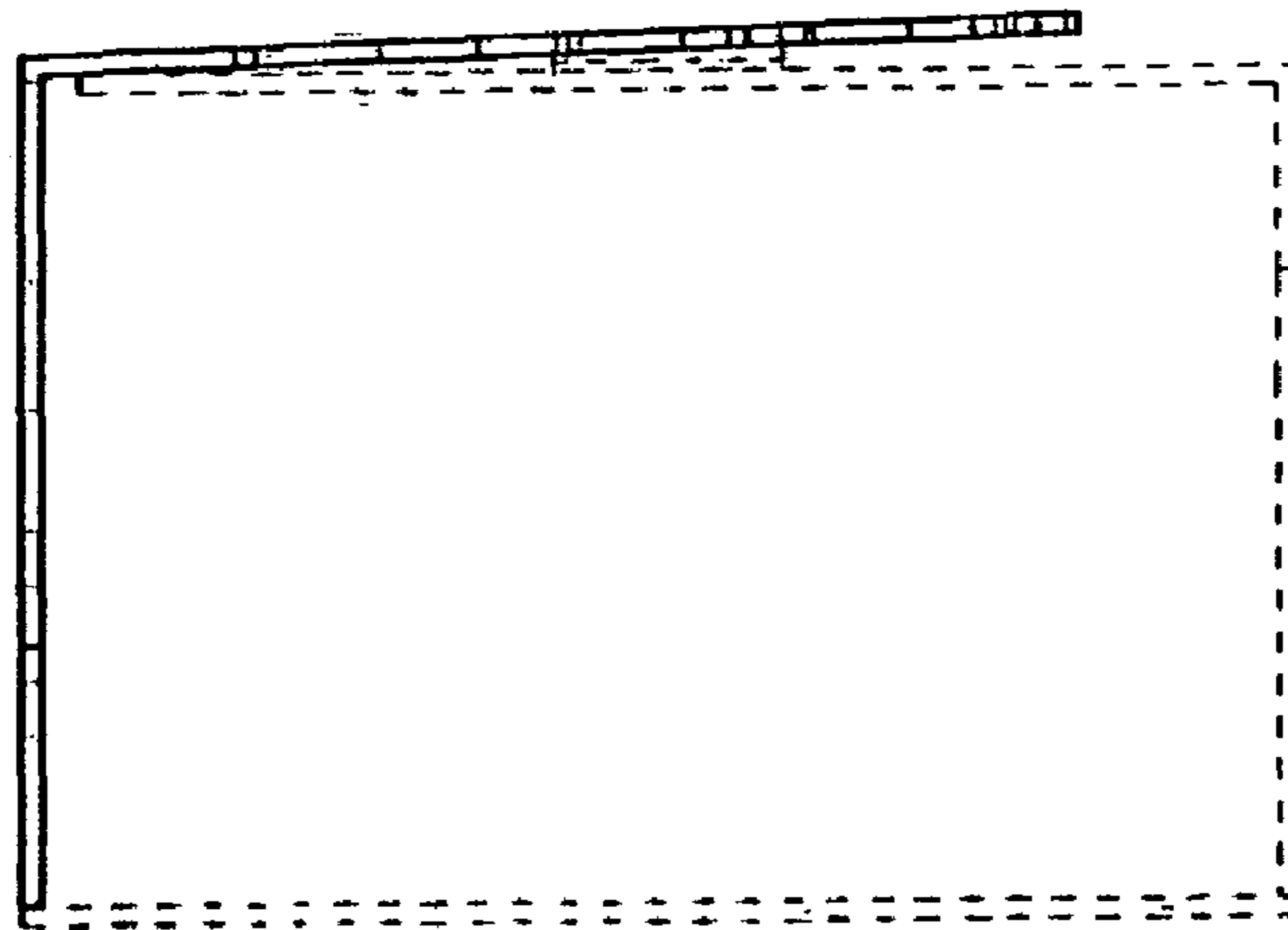

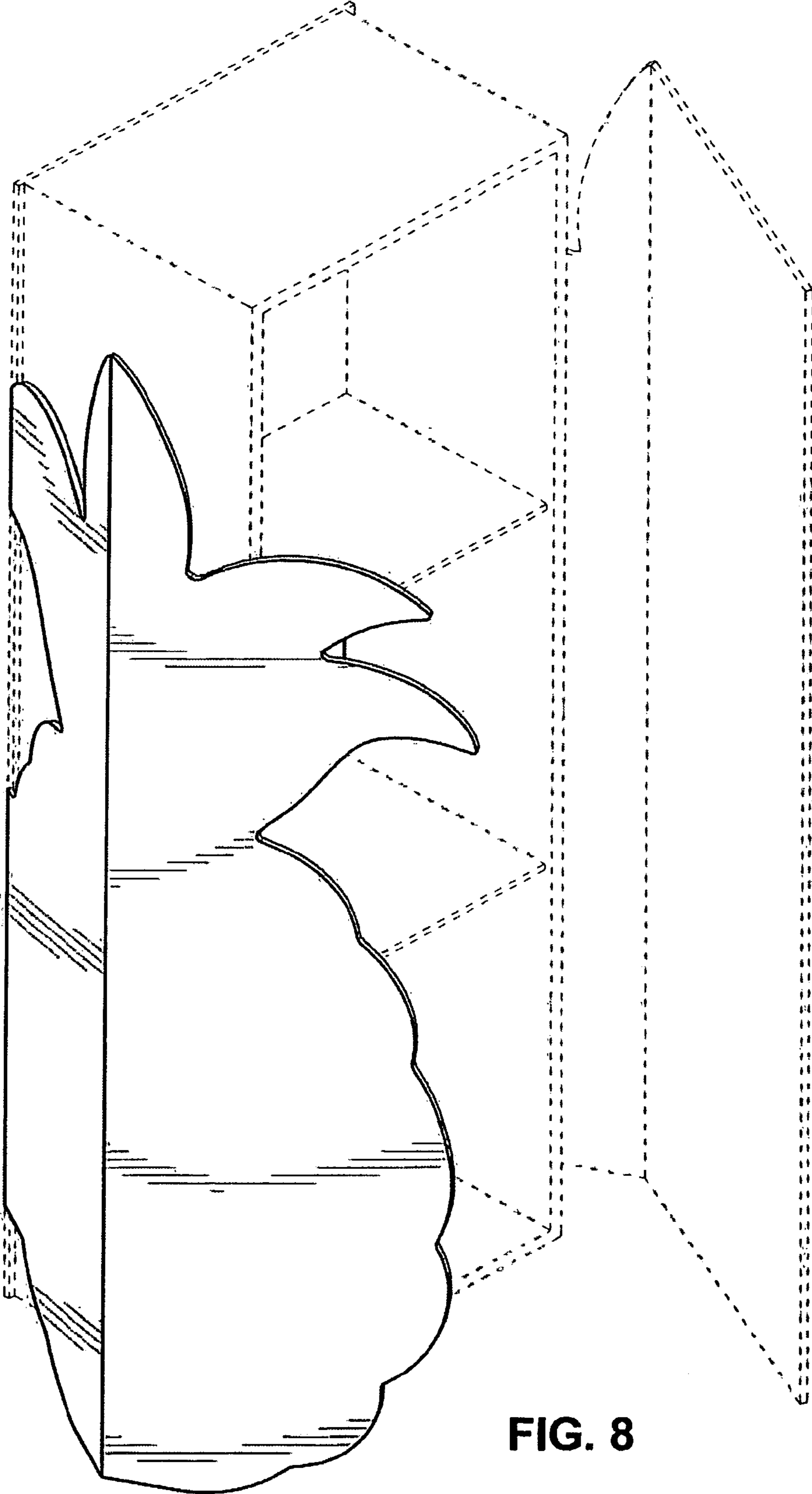

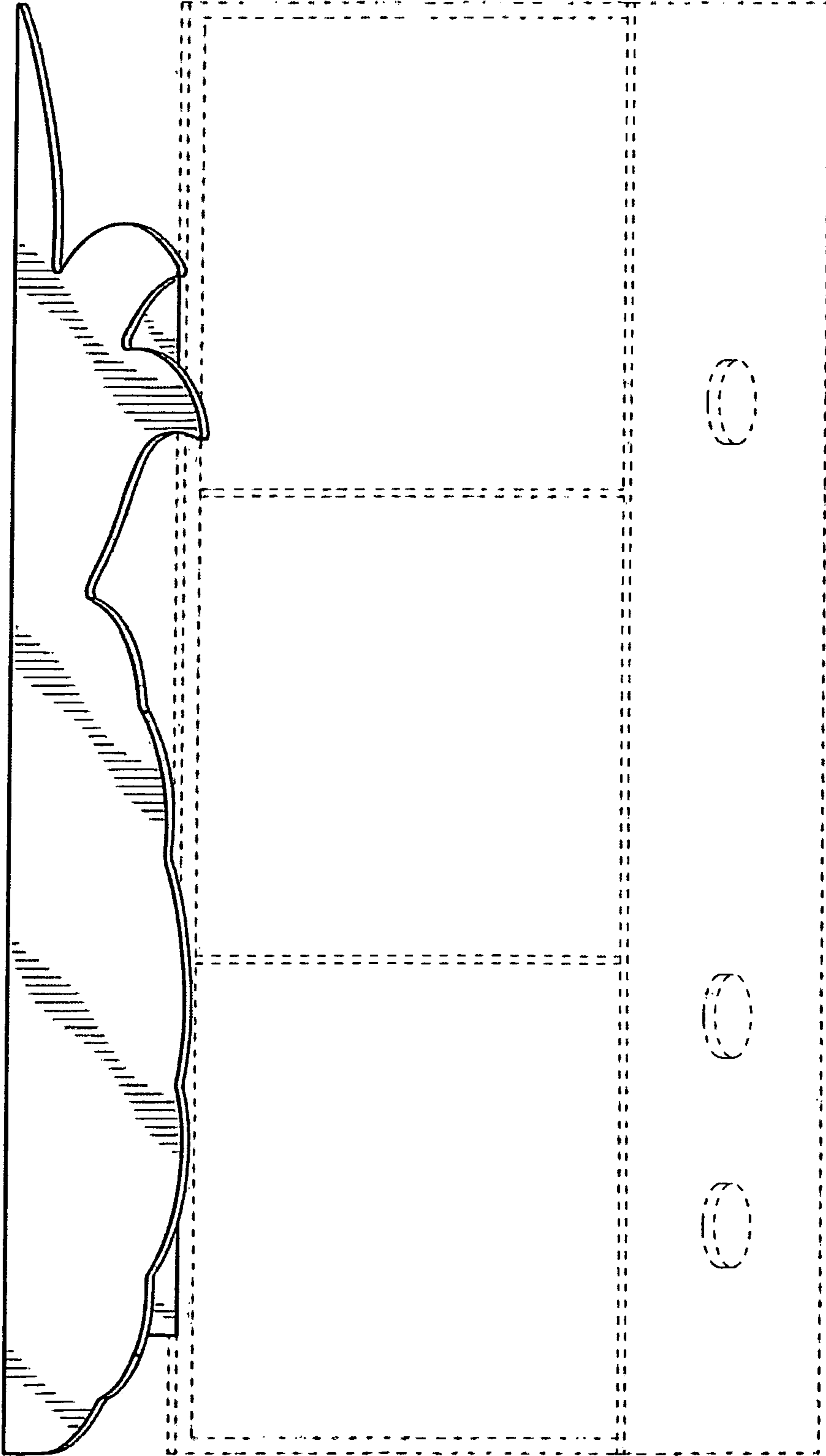

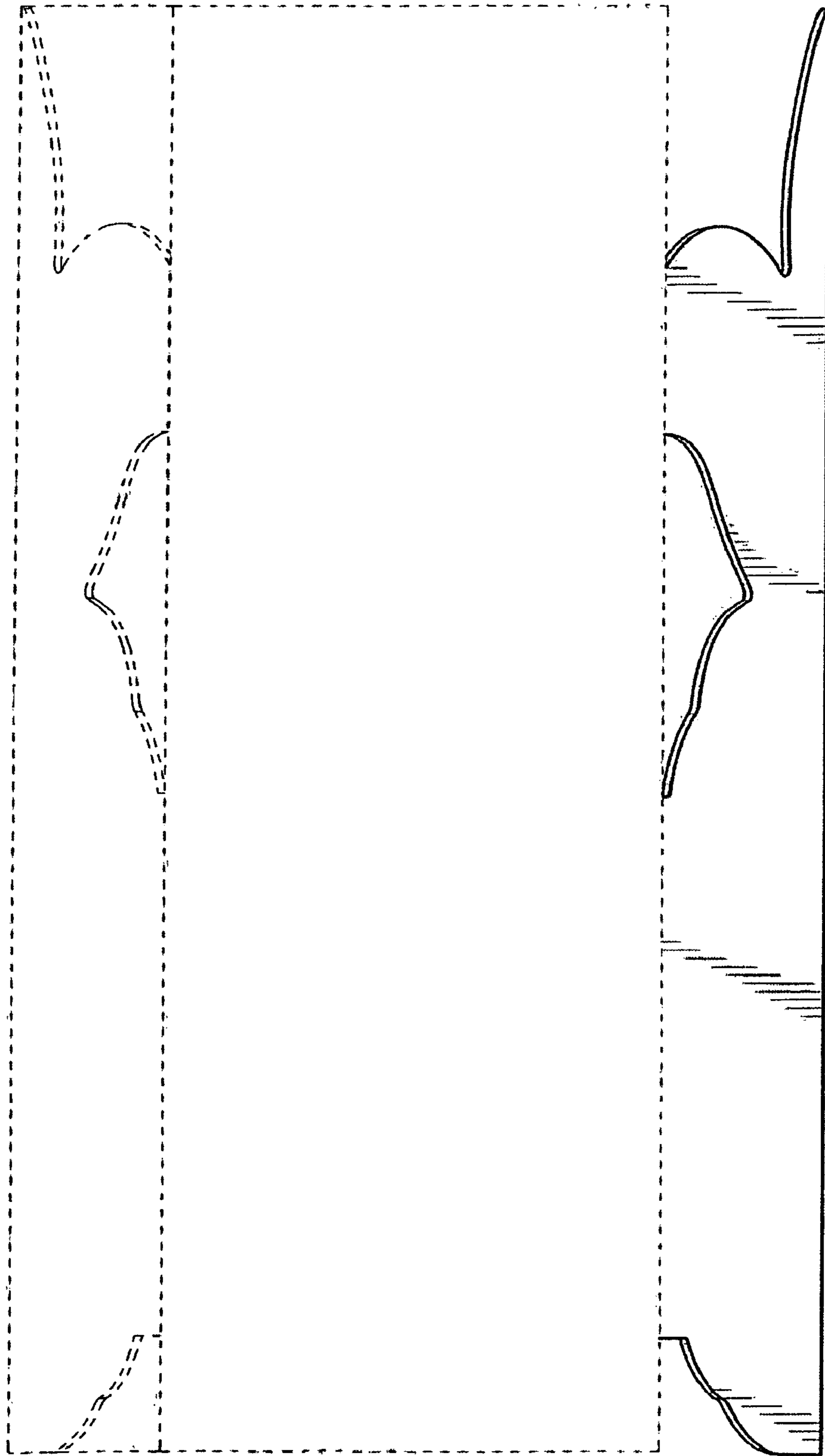

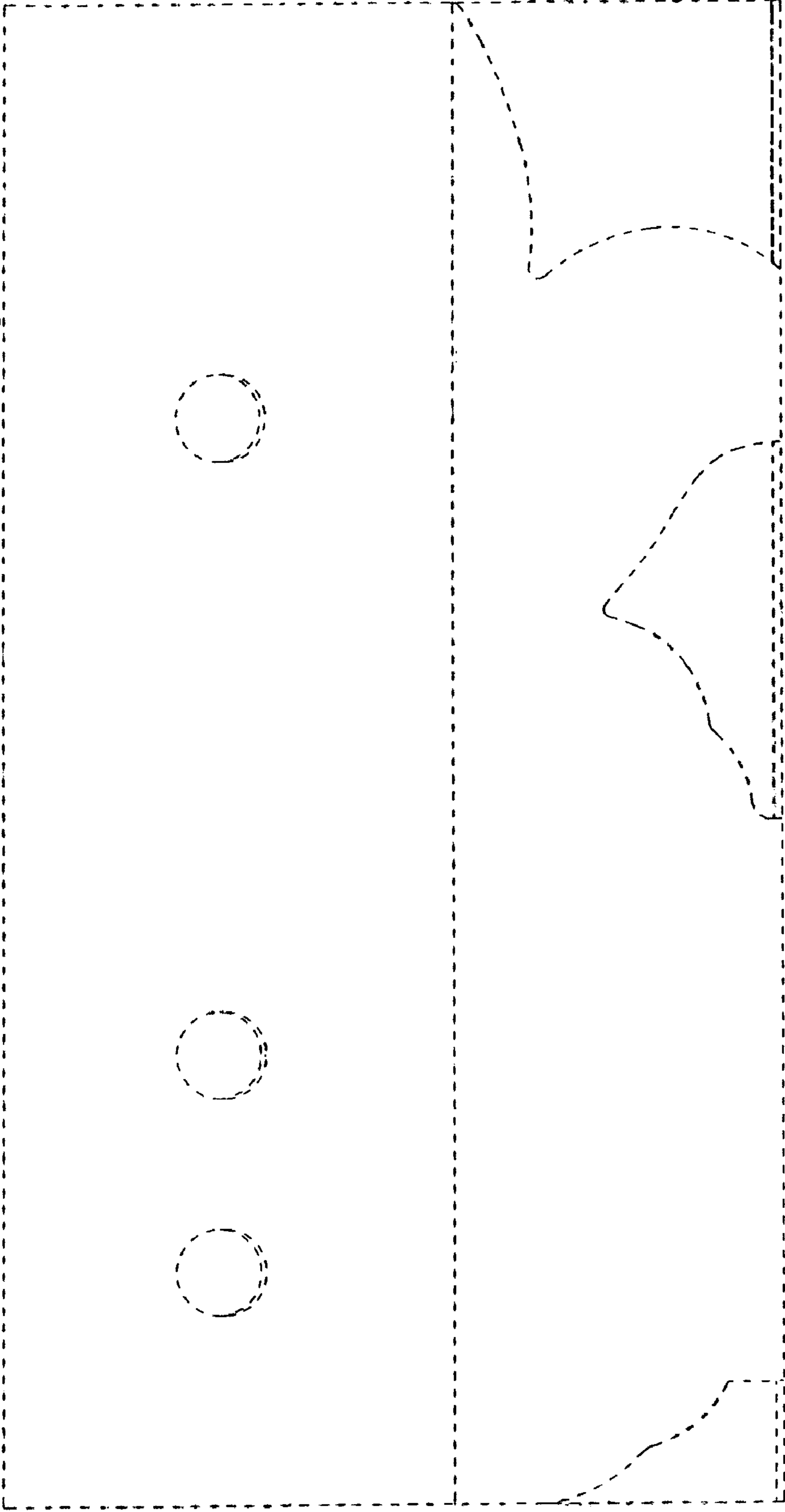

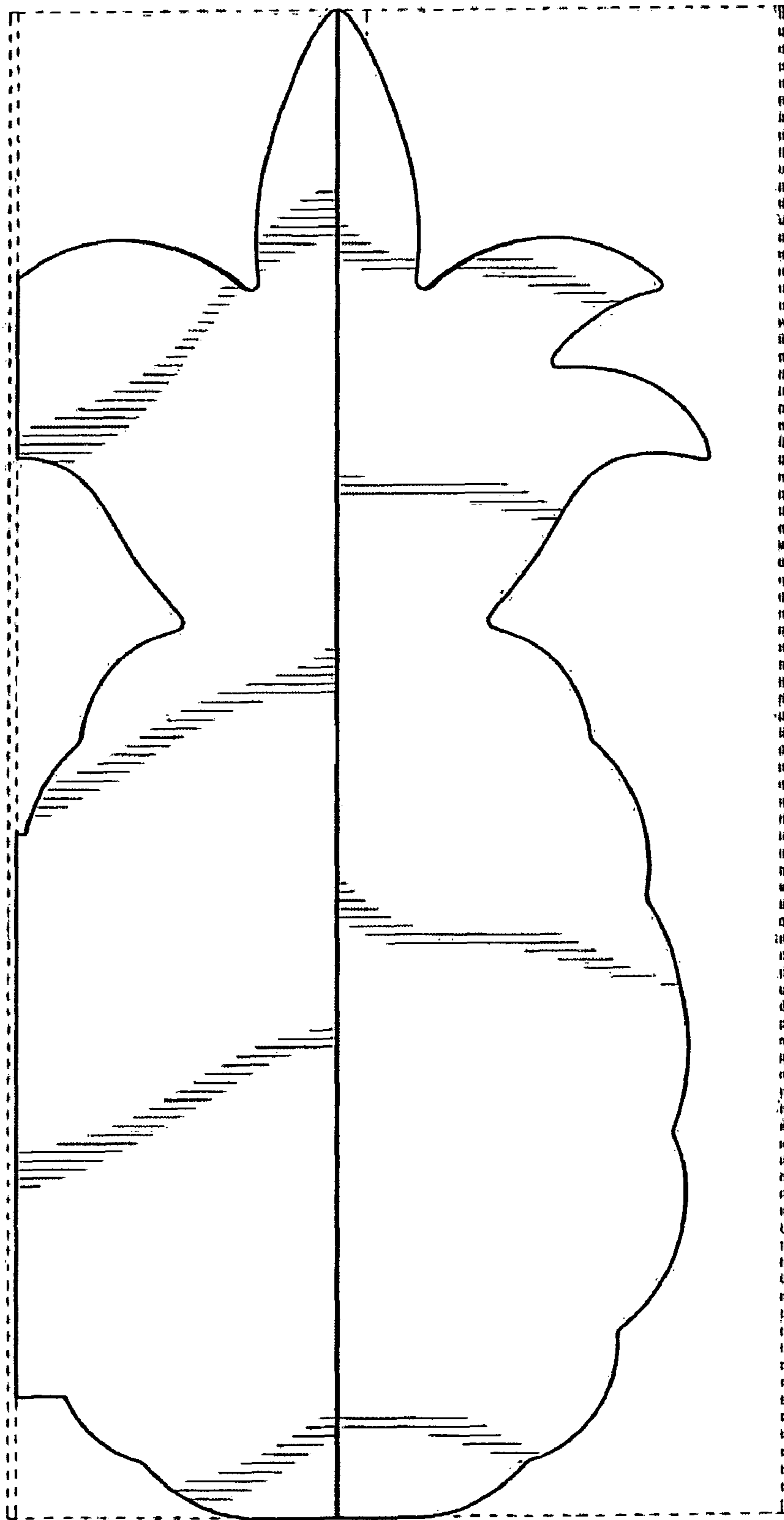

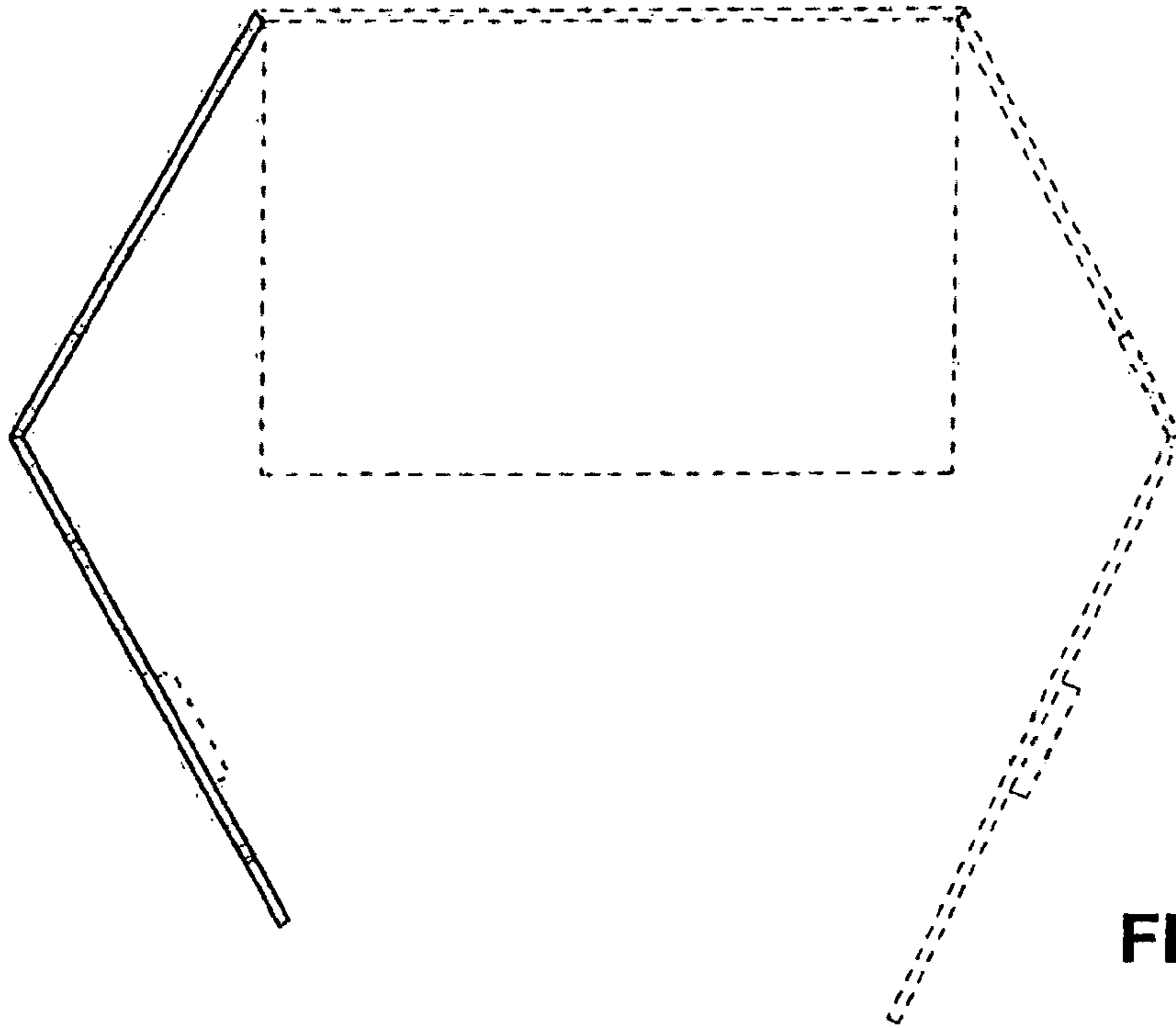

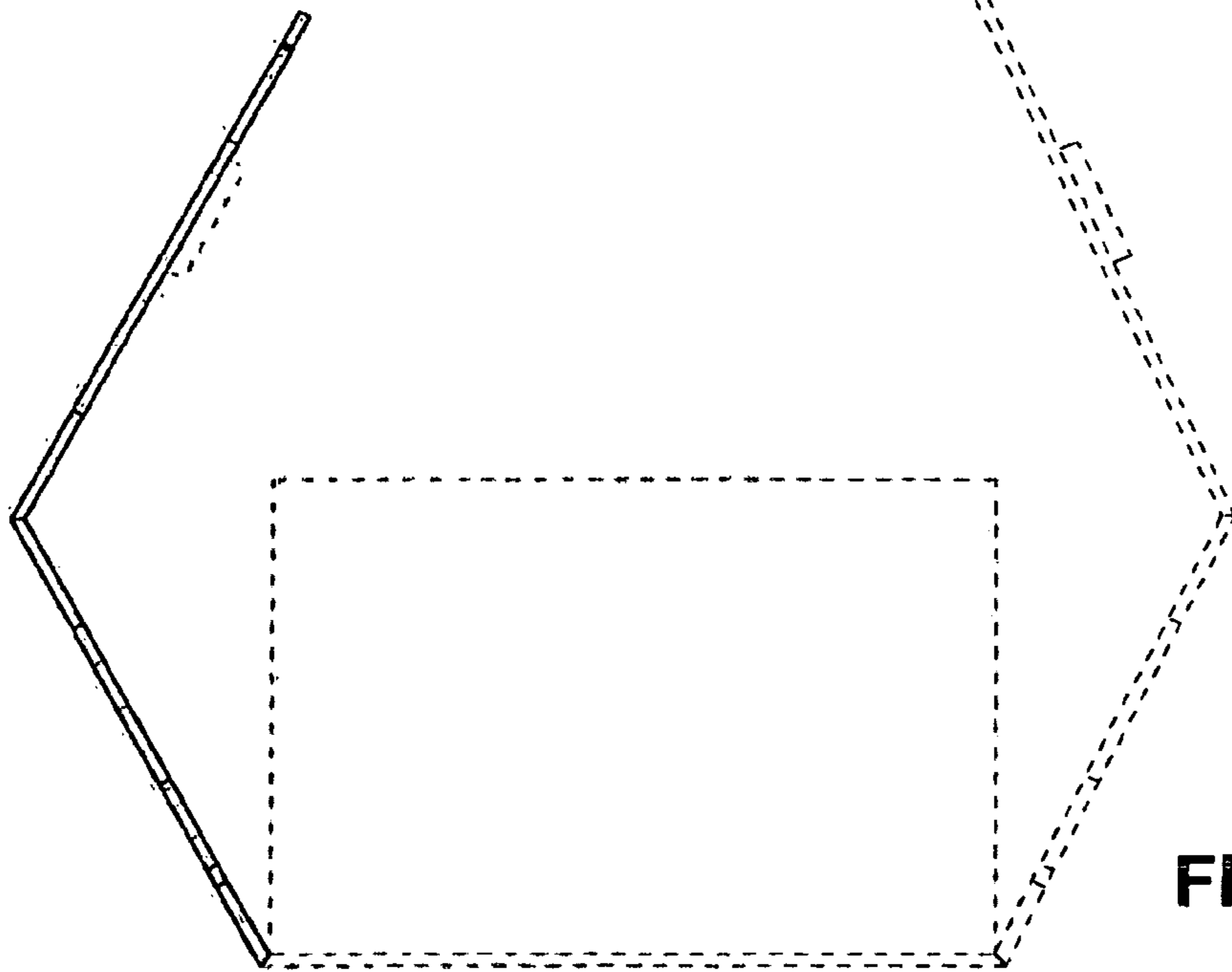

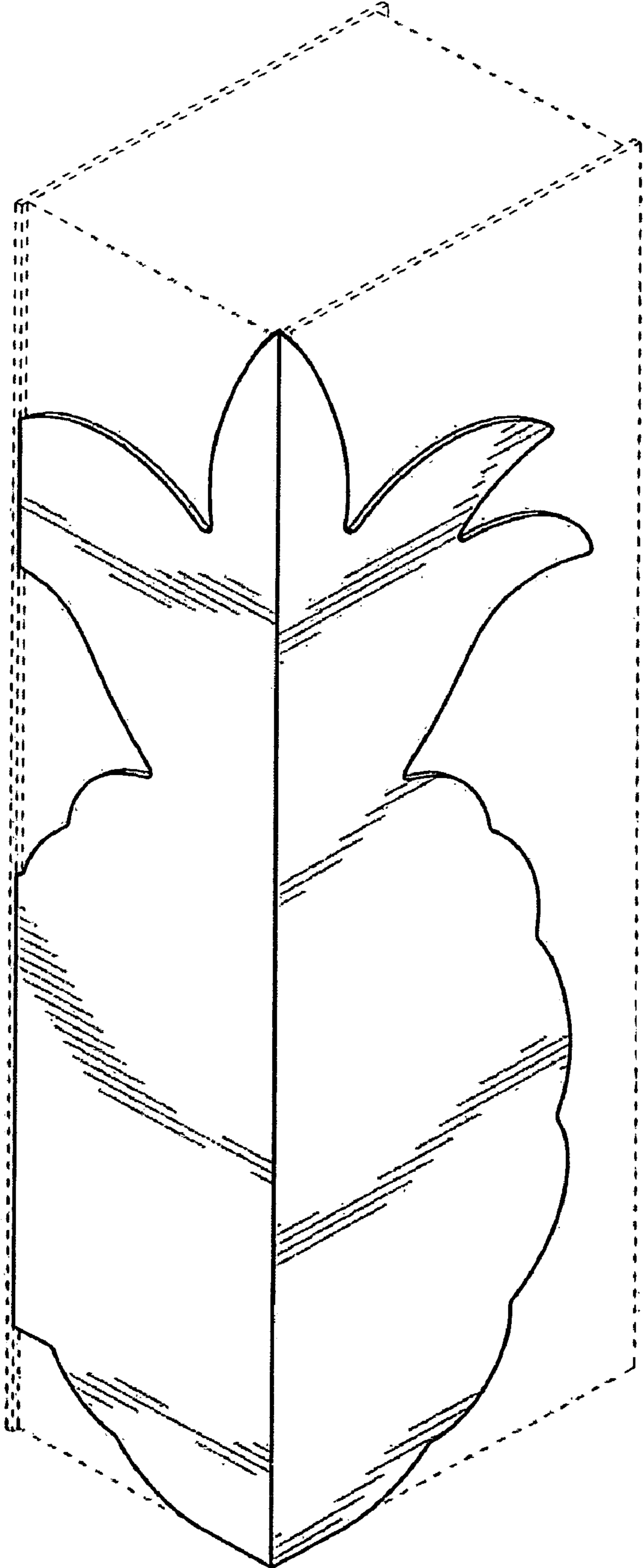

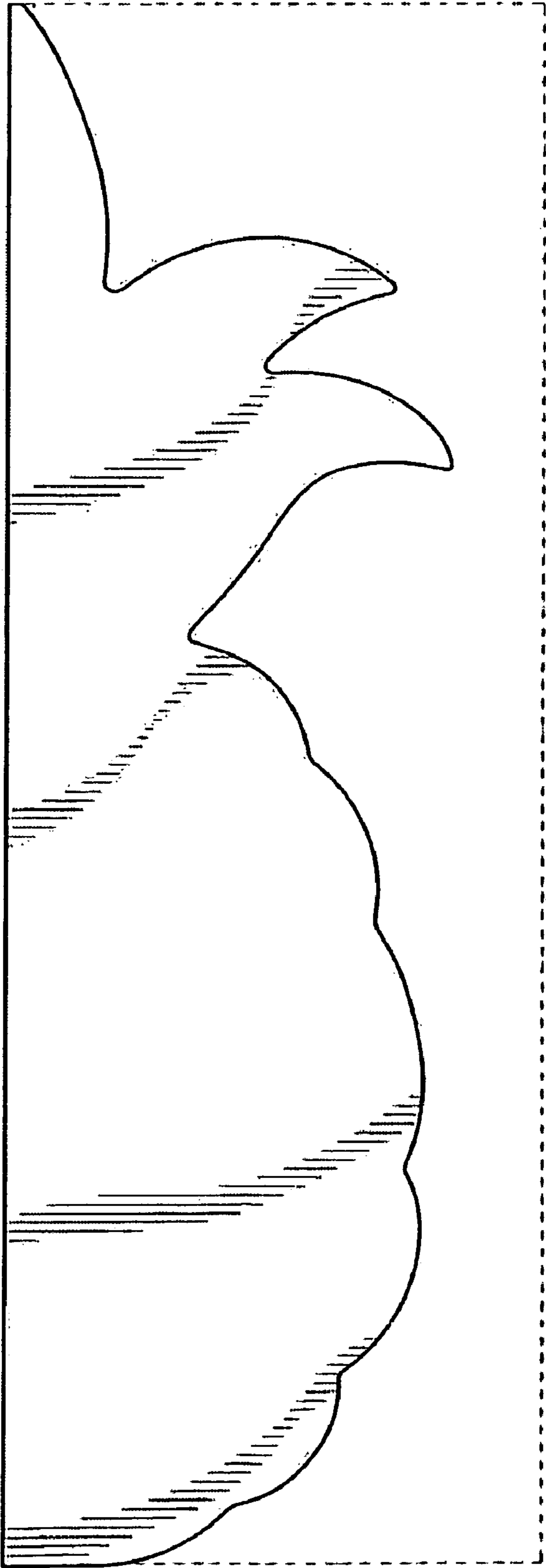

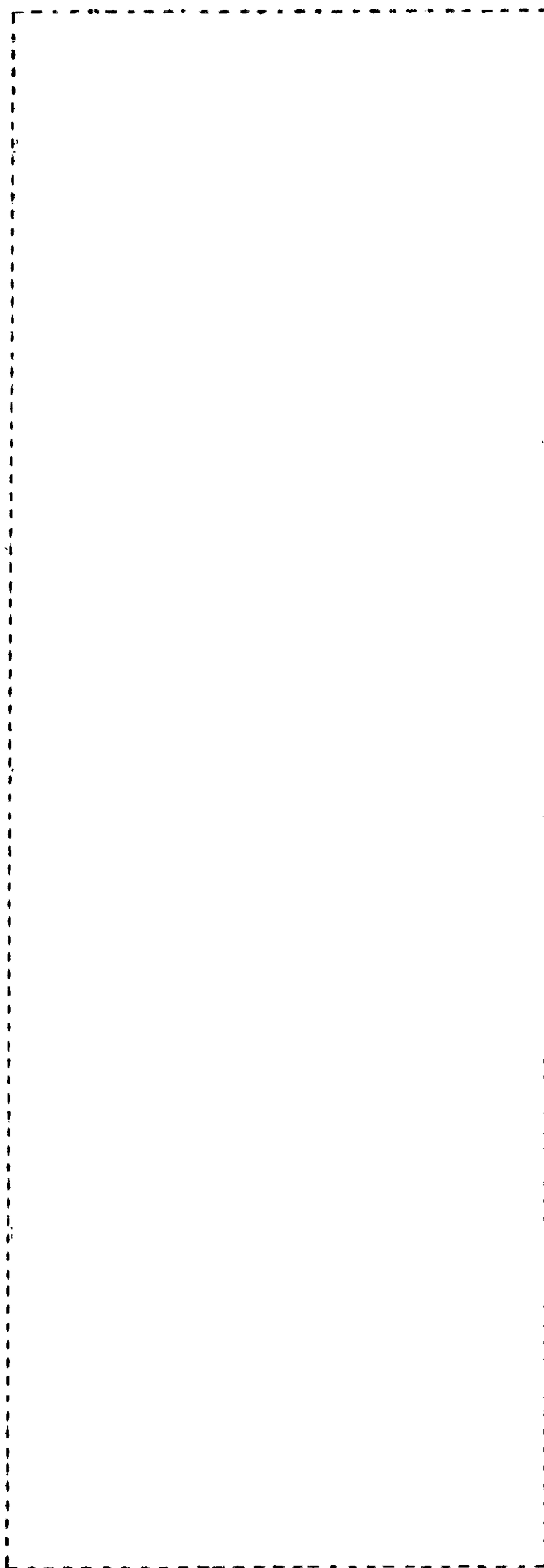

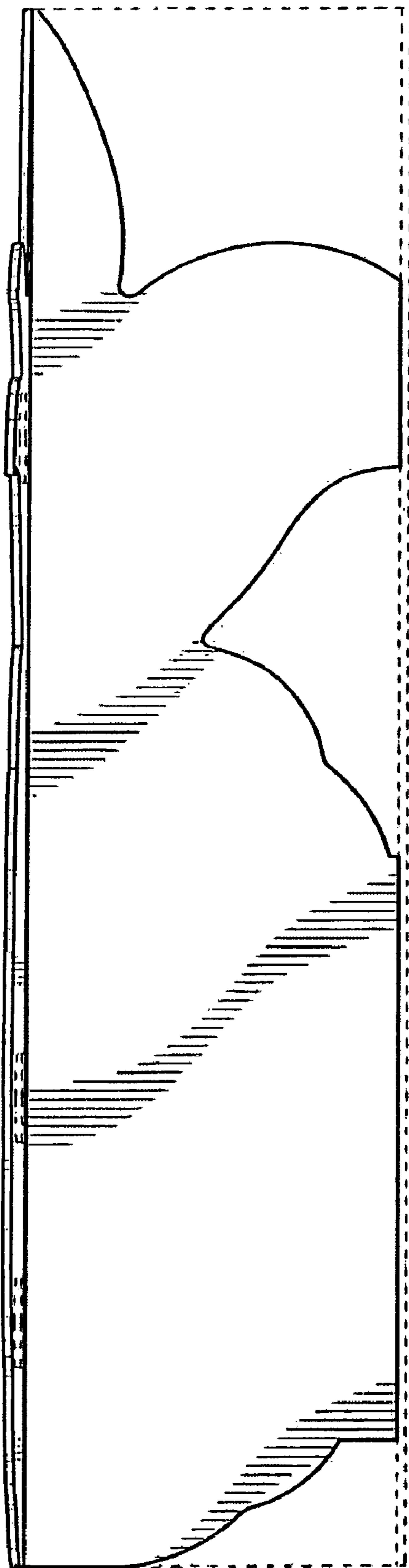

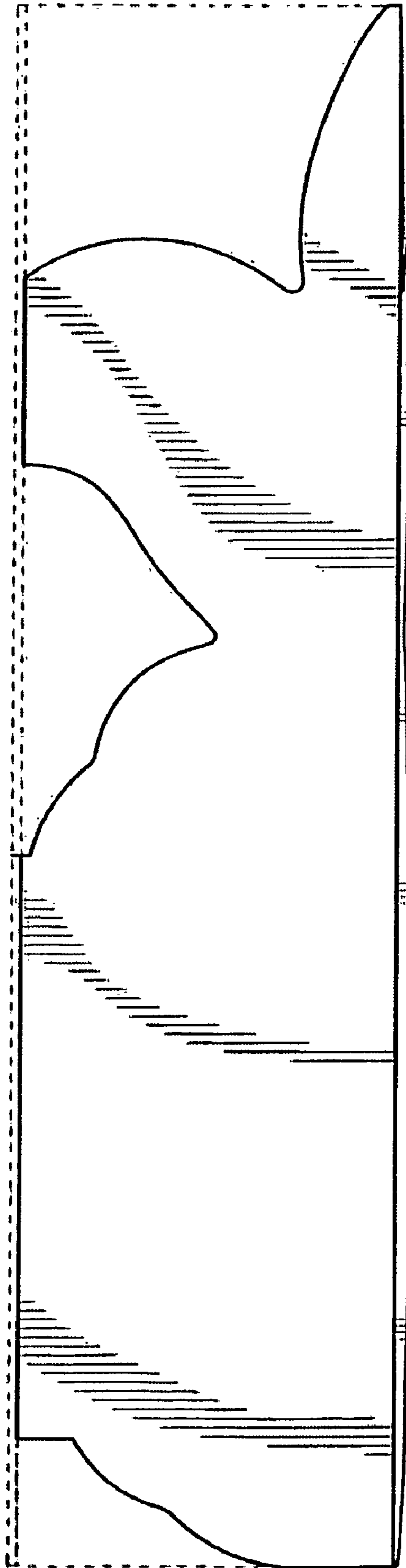

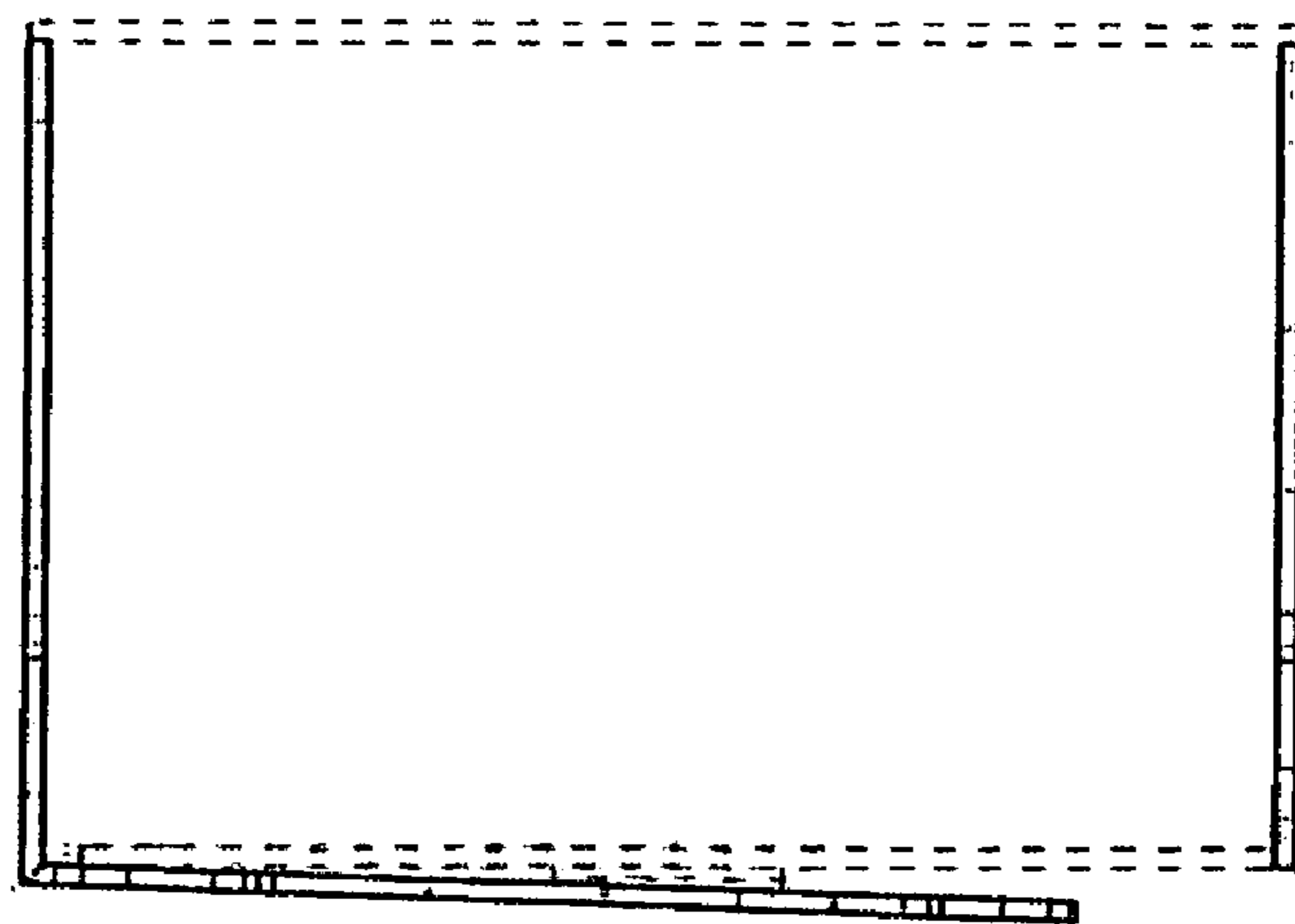

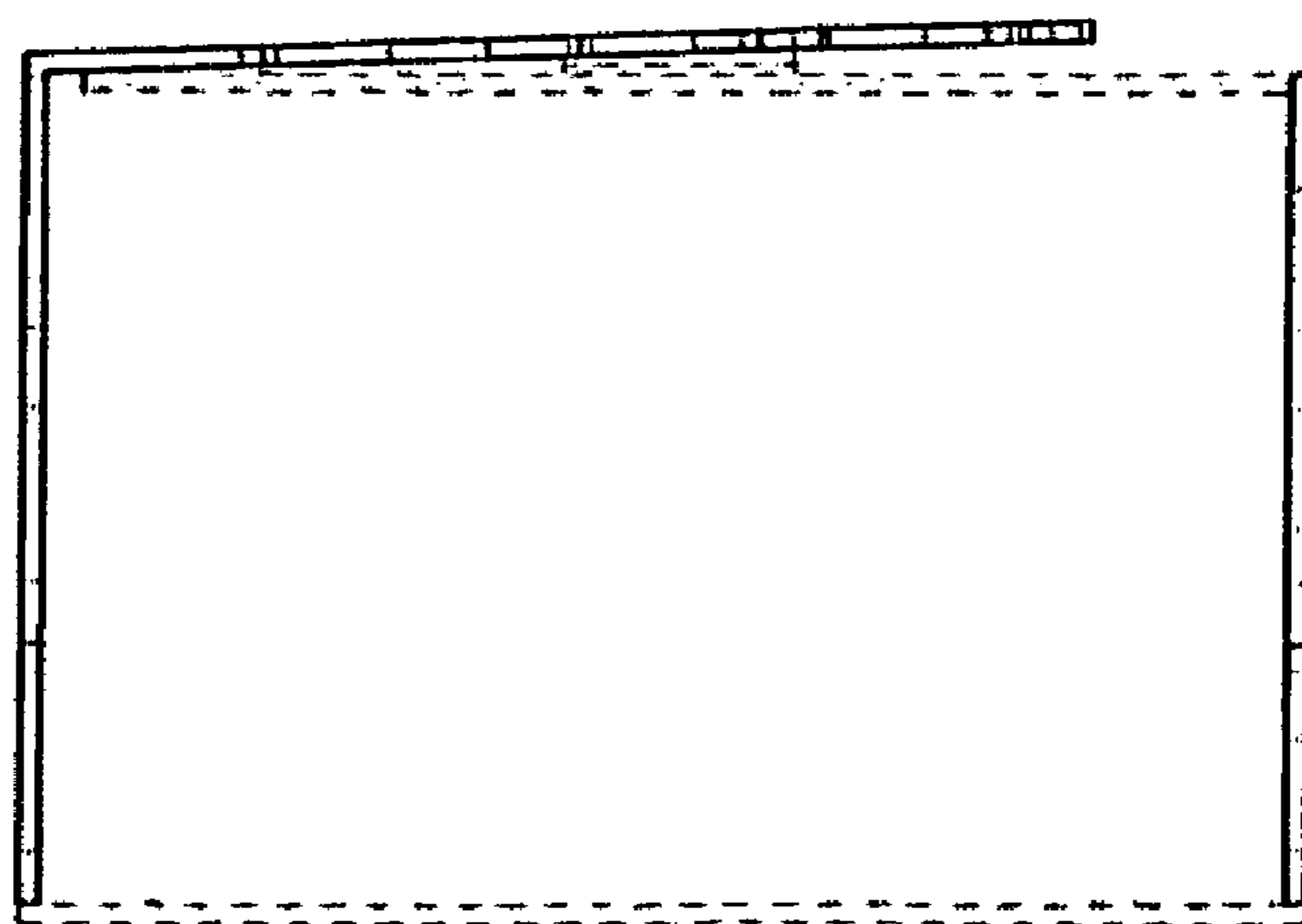
